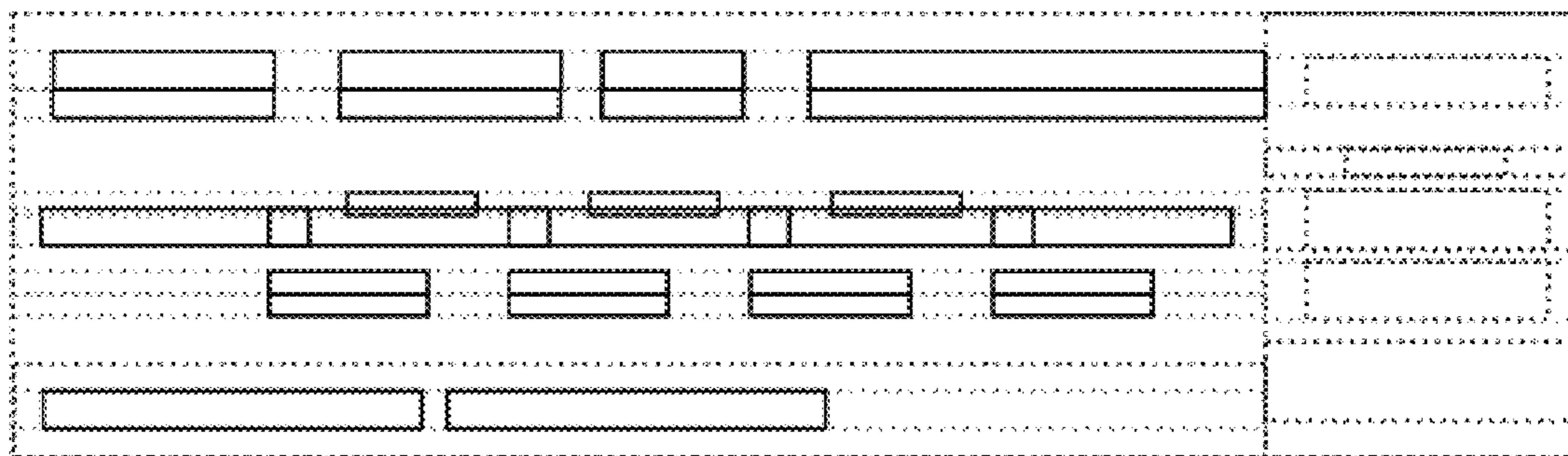
(57) **CLAIM**

The ornamental design for a display screen with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the display screen with graphical user interface. The outer edge of the portion of the display screen is understood to be congruent with the outer edge of the graphical user interface; and, FIG. 2 shows a portion of the design of FIG. 1 separately and enlarged for clarity of illustration. The features shown in broken lines in the Figures form no part of the claimed design.

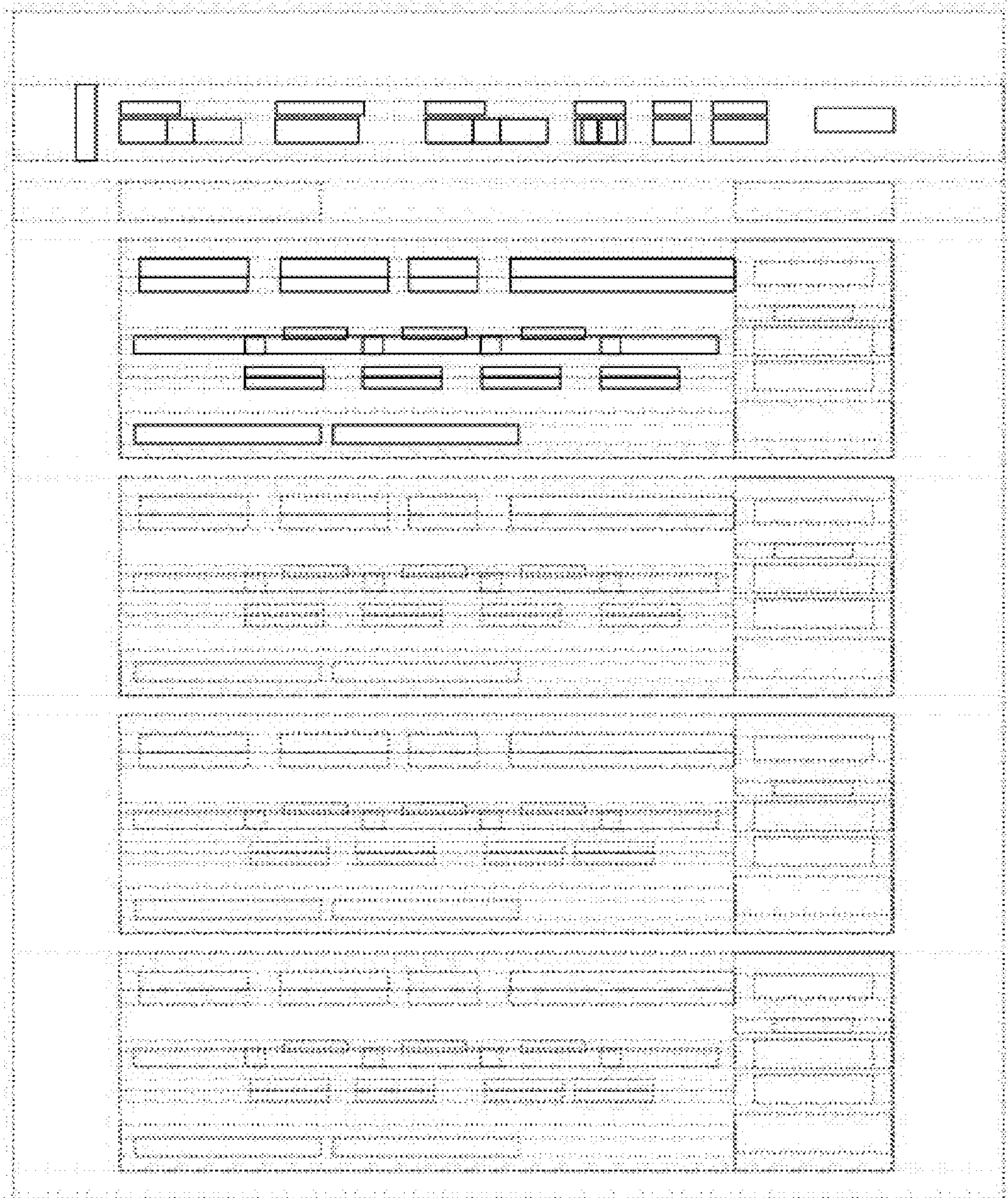
