(57) **CLAIM**

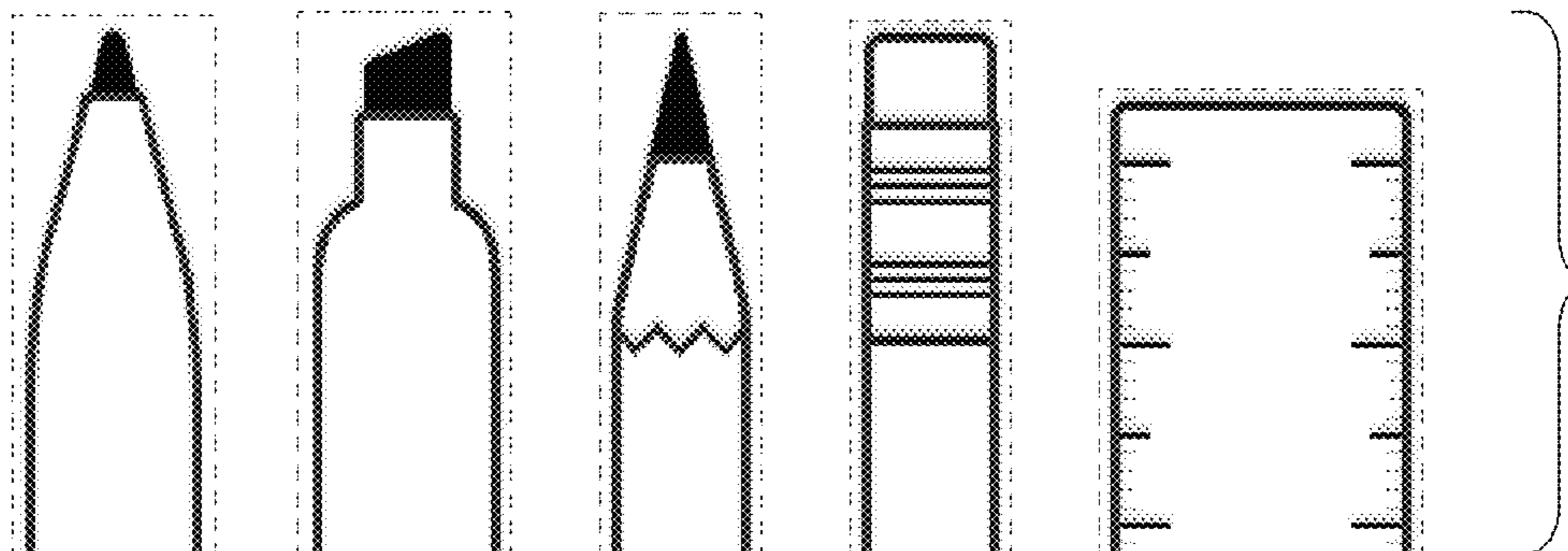
The ornamental design for a display screen of portion thereof with graphical user interface set, as shown and described.

DESCRIPTION

The sole FIGURE shows a display screen of portion thereof with graphical user interface showing our new design. The peripheral dashed broken lines illustrate a display screen of portion thereof and form no part of the claimed design.

The bracket shown in the sole FIGURE indicates a set. The graphical user interfaces of the set are arranged relatively on the drawing sheet for the convenience of illustration, and the placement of each graphical user interface relative to another, or to the drawing sheet, forms no part of the claimed design.
