DESCRIPTION

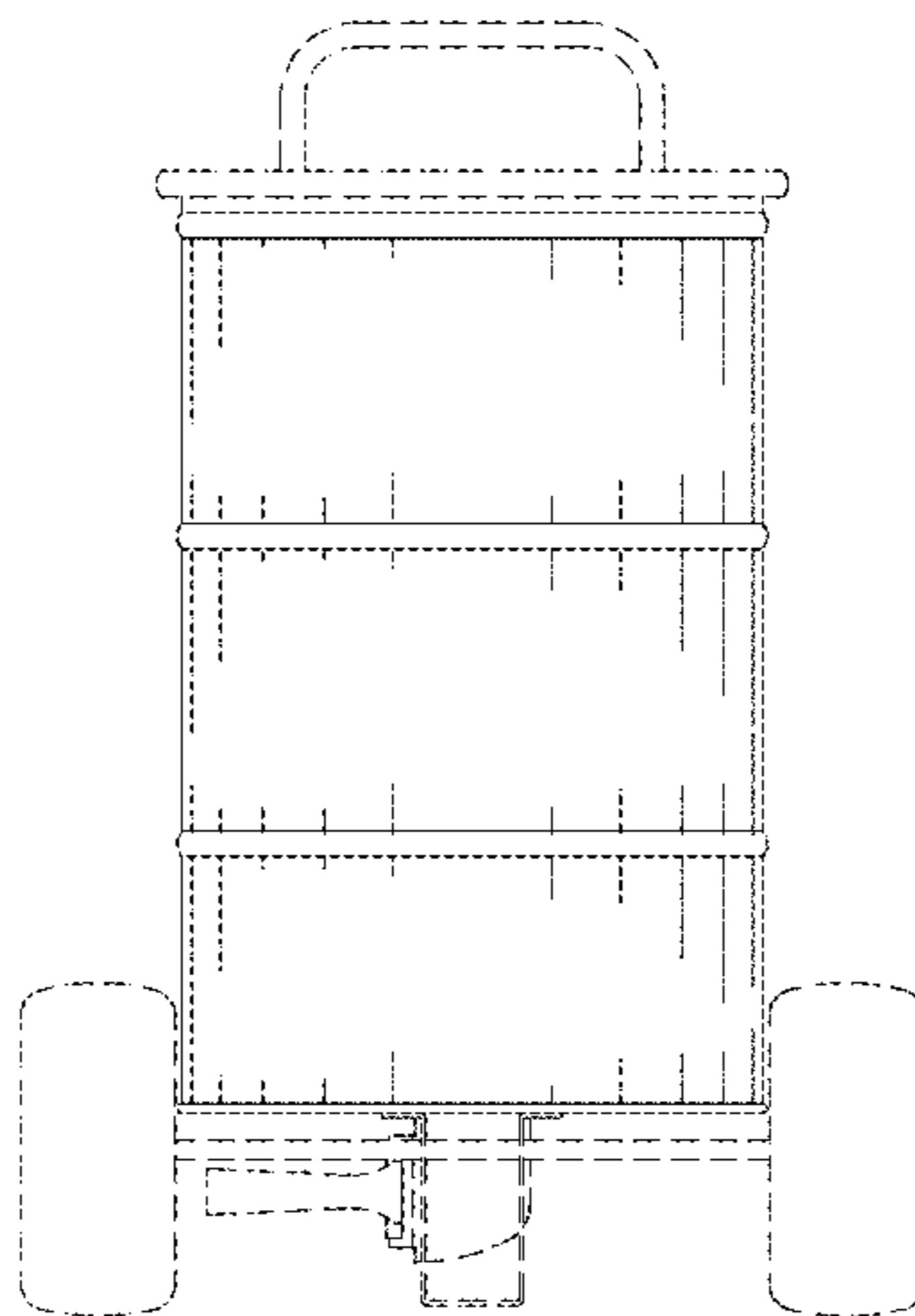
FIG. 1 is a front elevational view of a rock dust blower showing our new design;

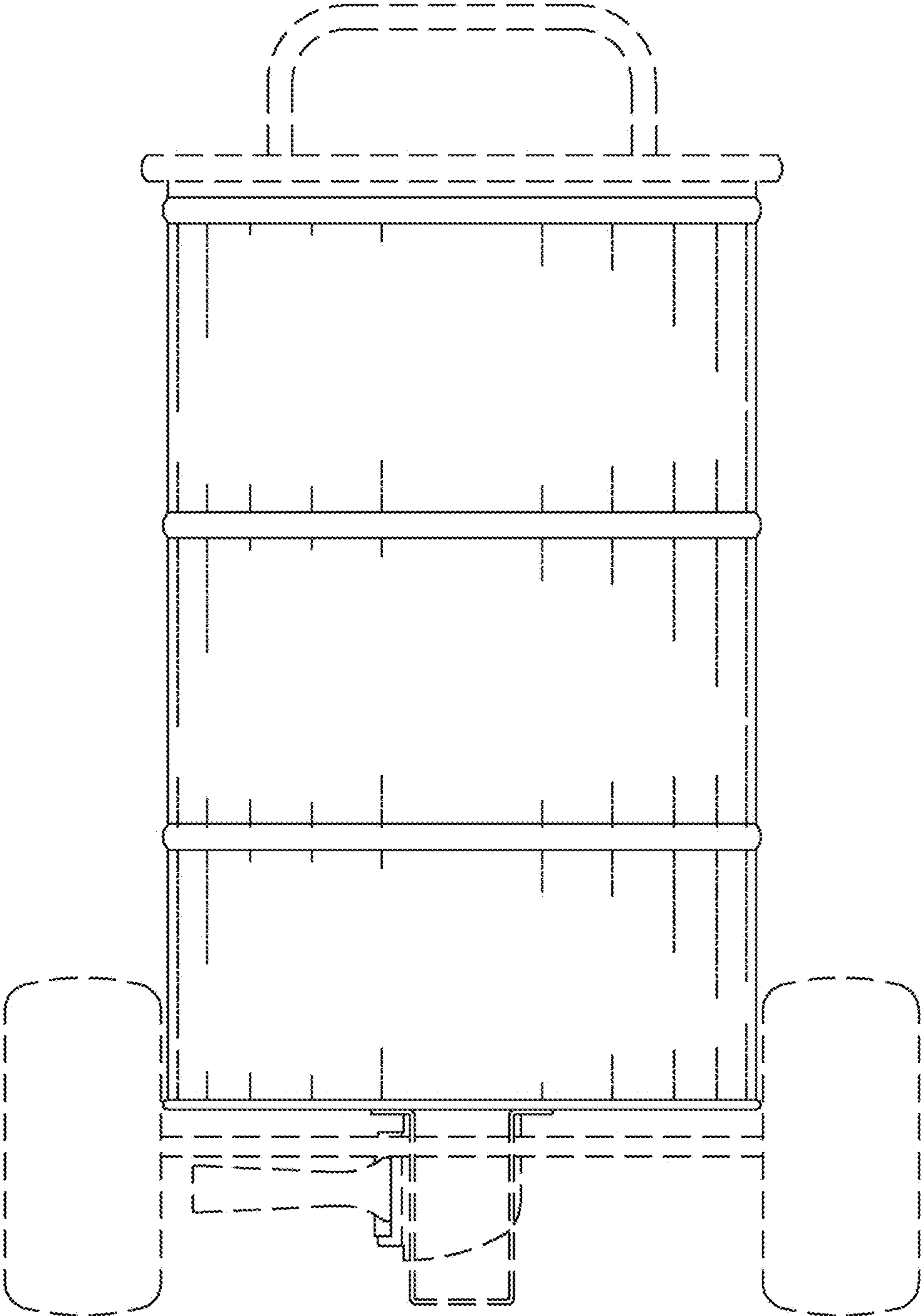

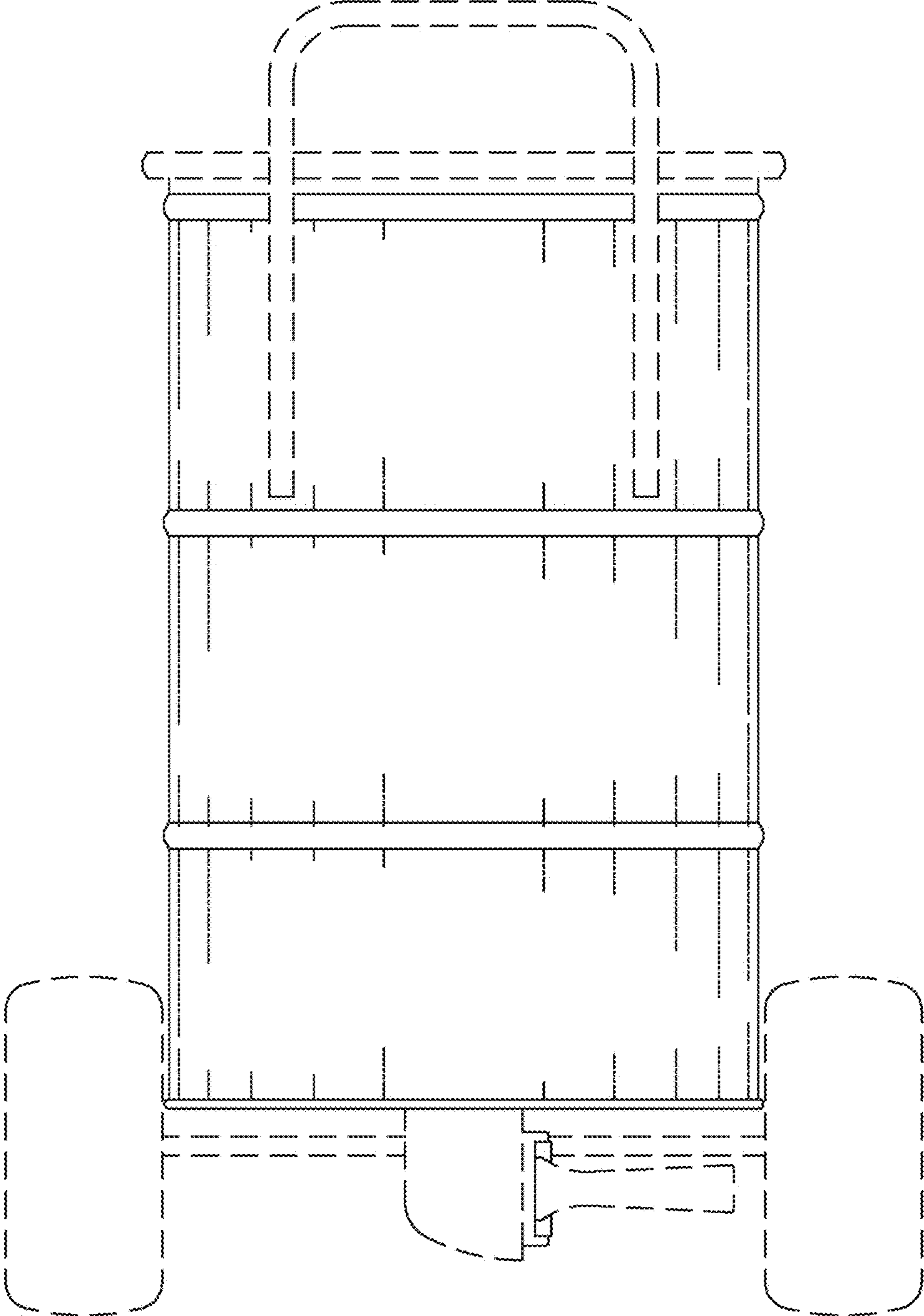

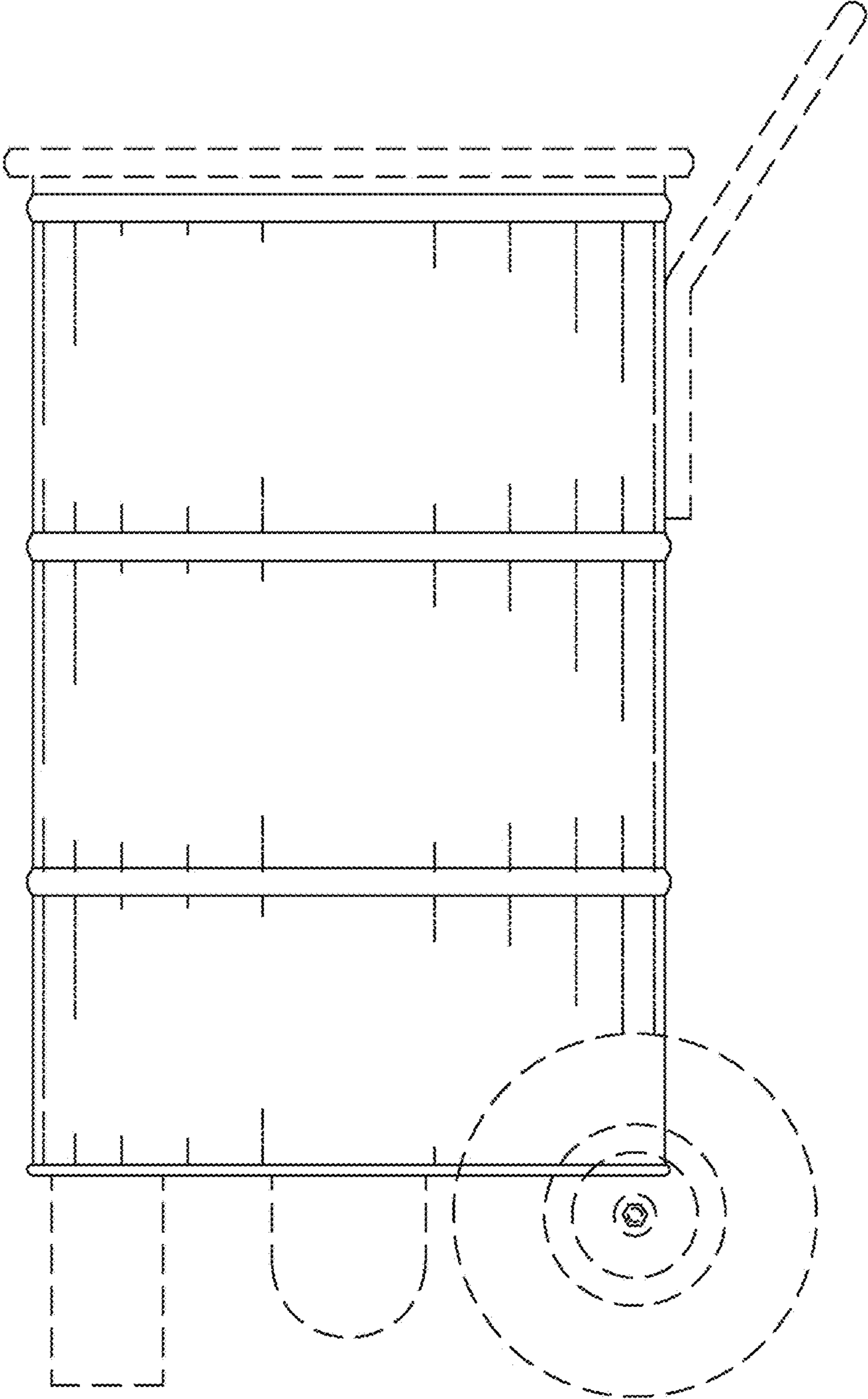

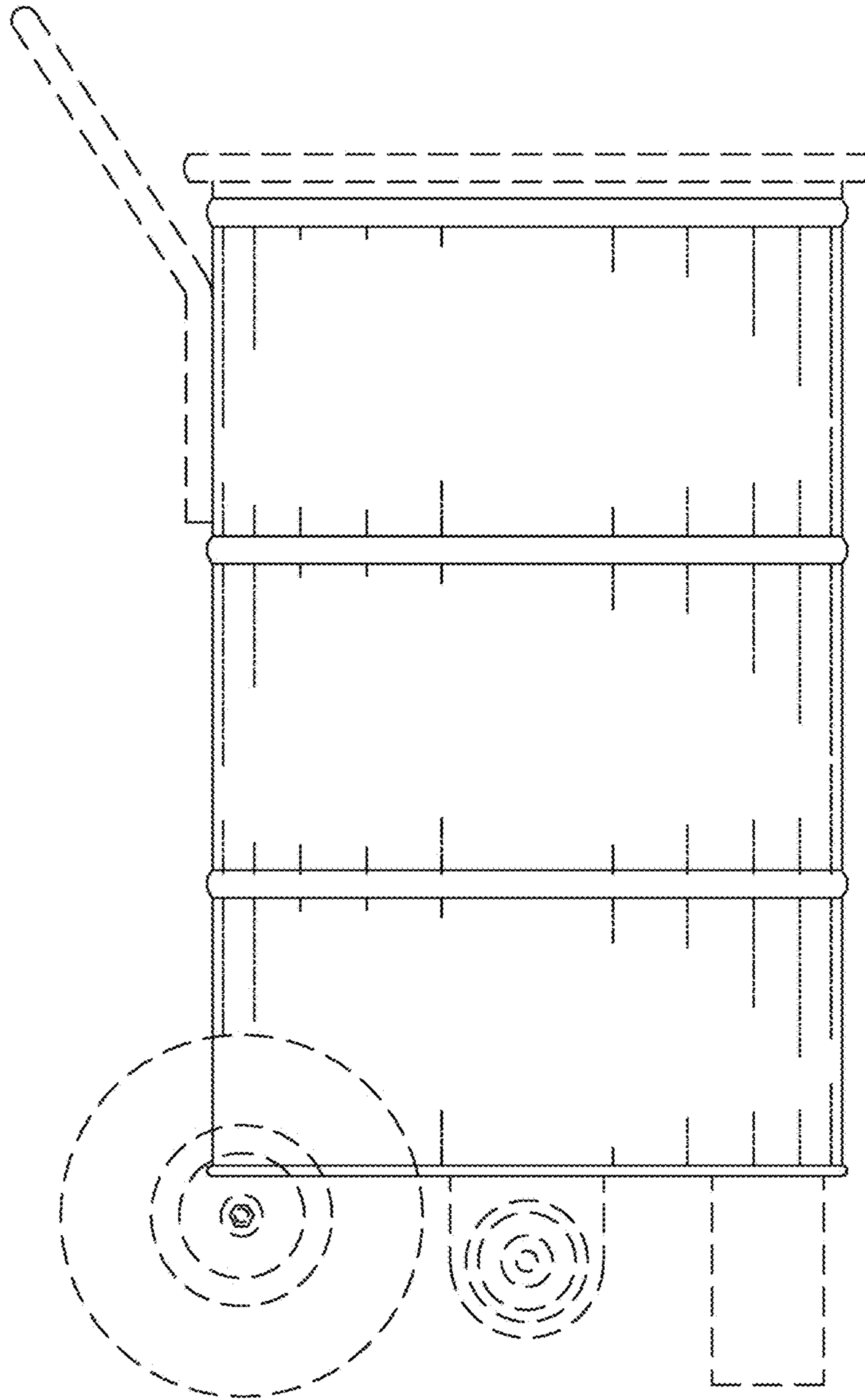

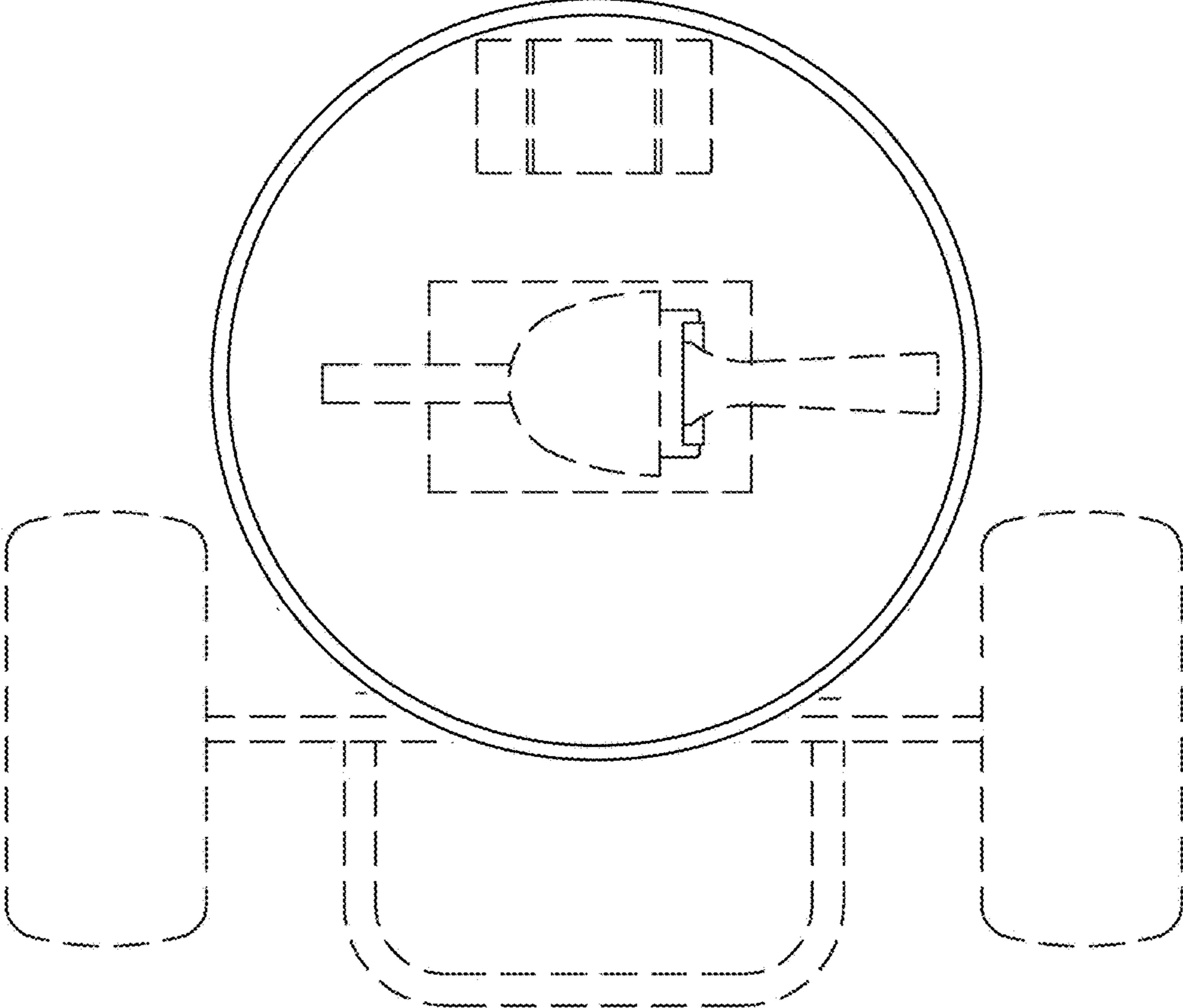

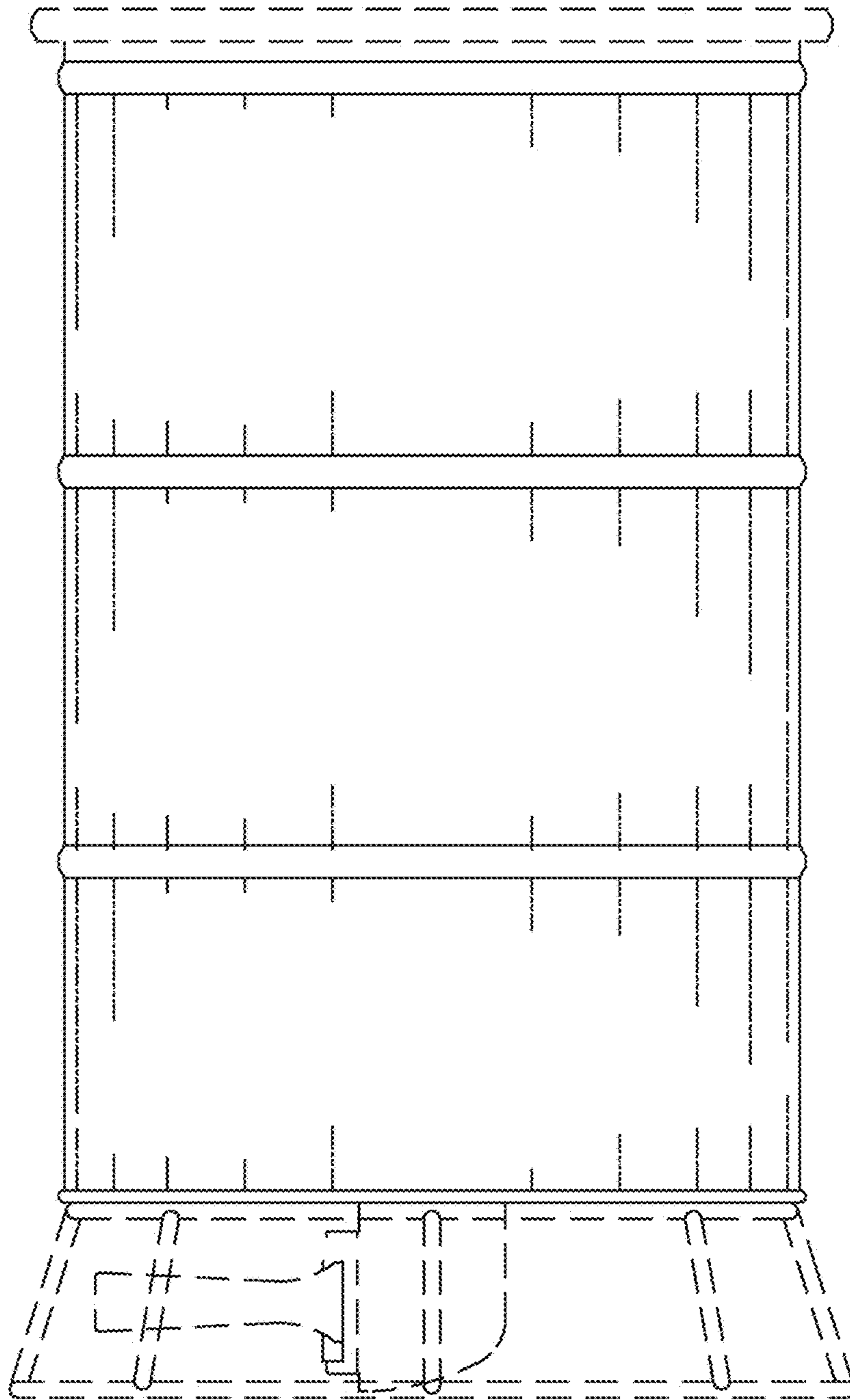

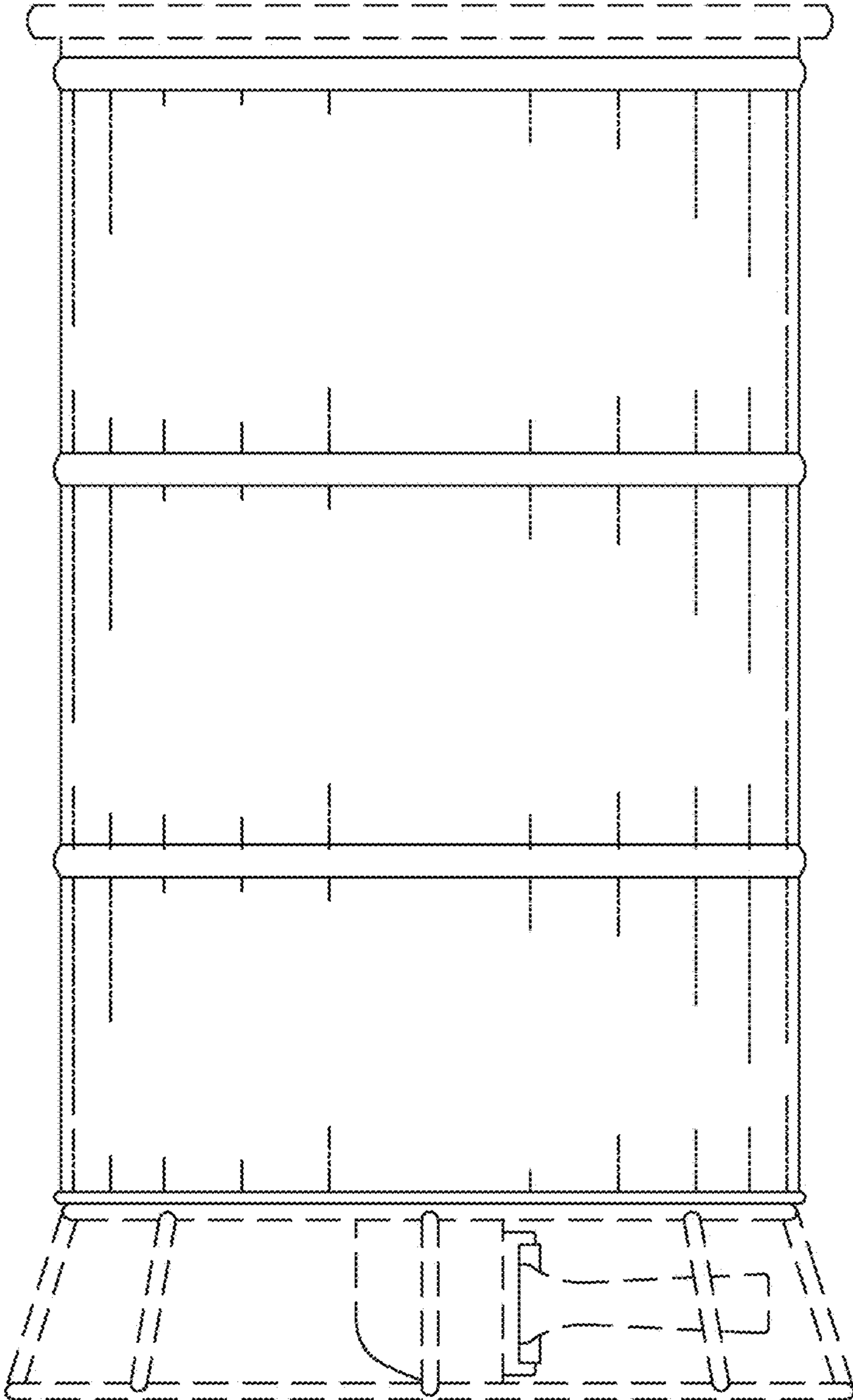

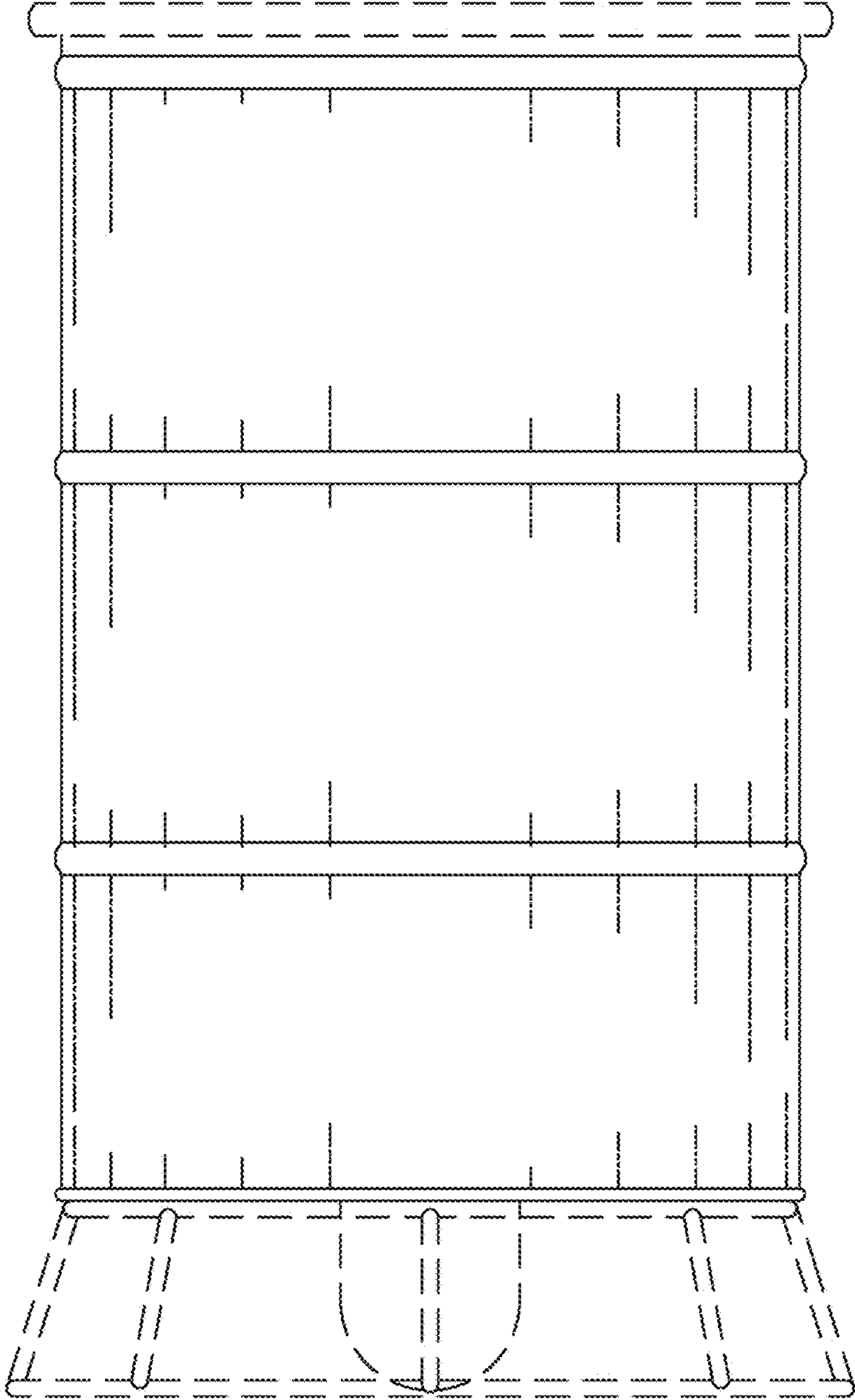

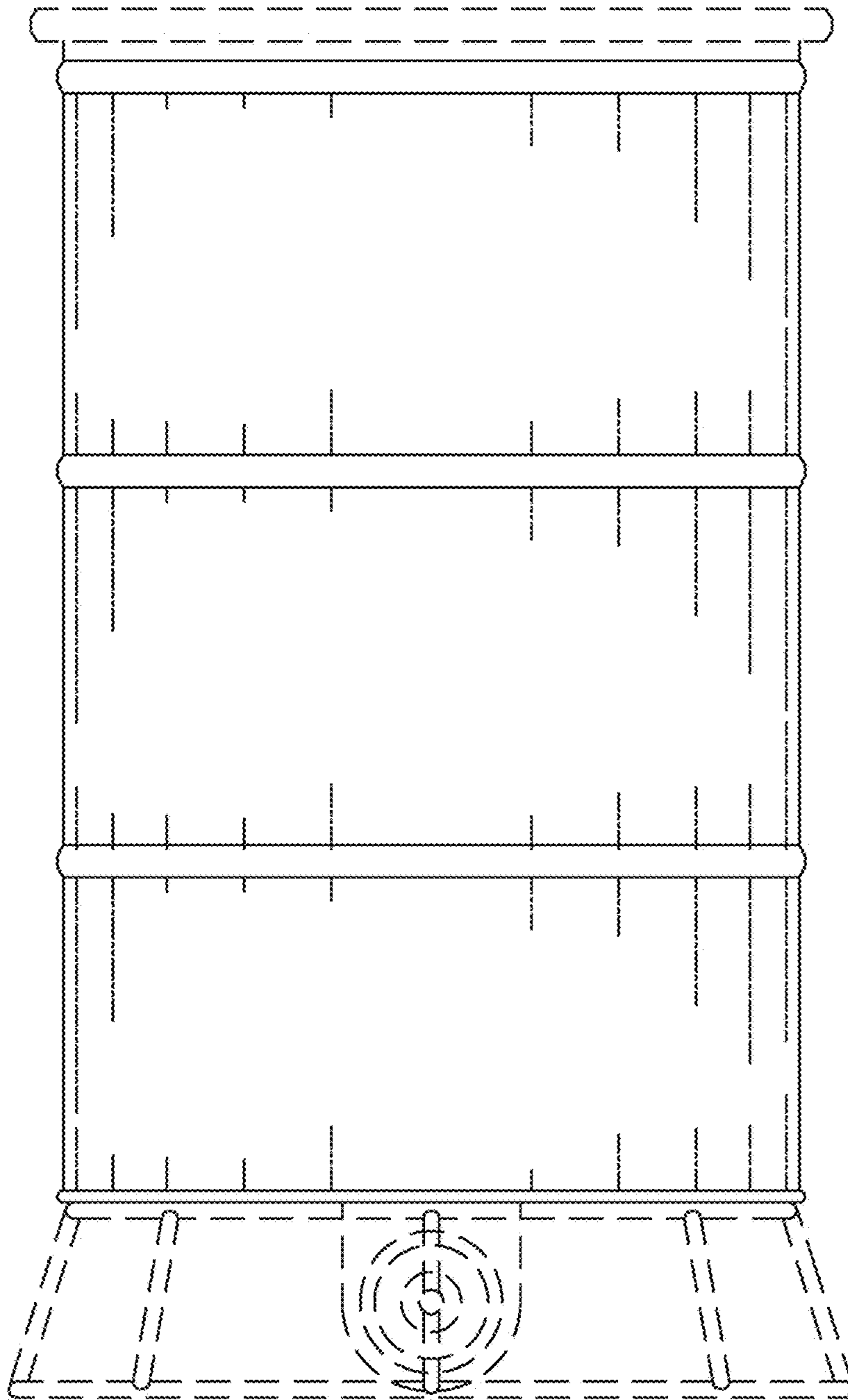

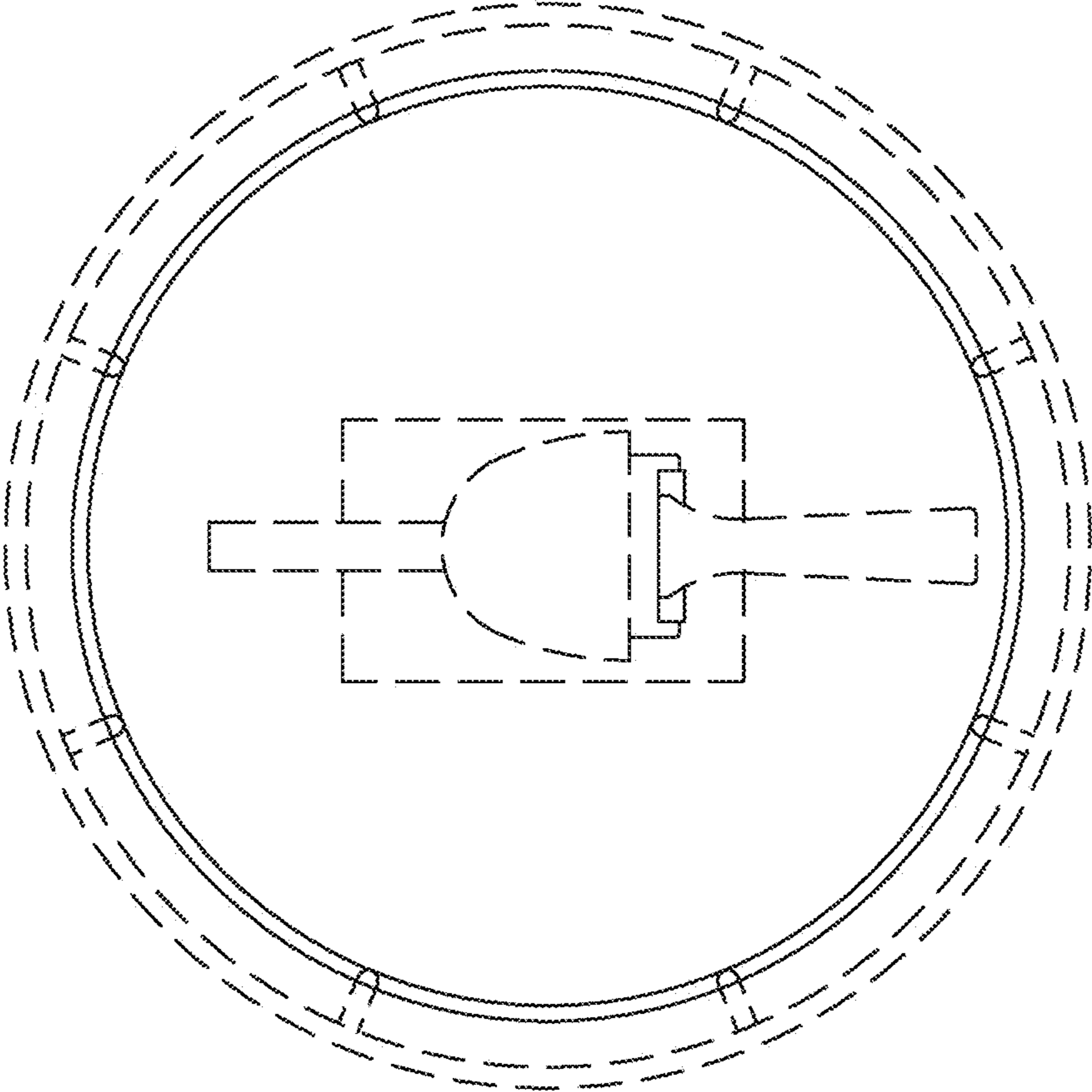
