FIG. 3 shows a left side elevation view of the stability and strength training ball of FIG. 1.

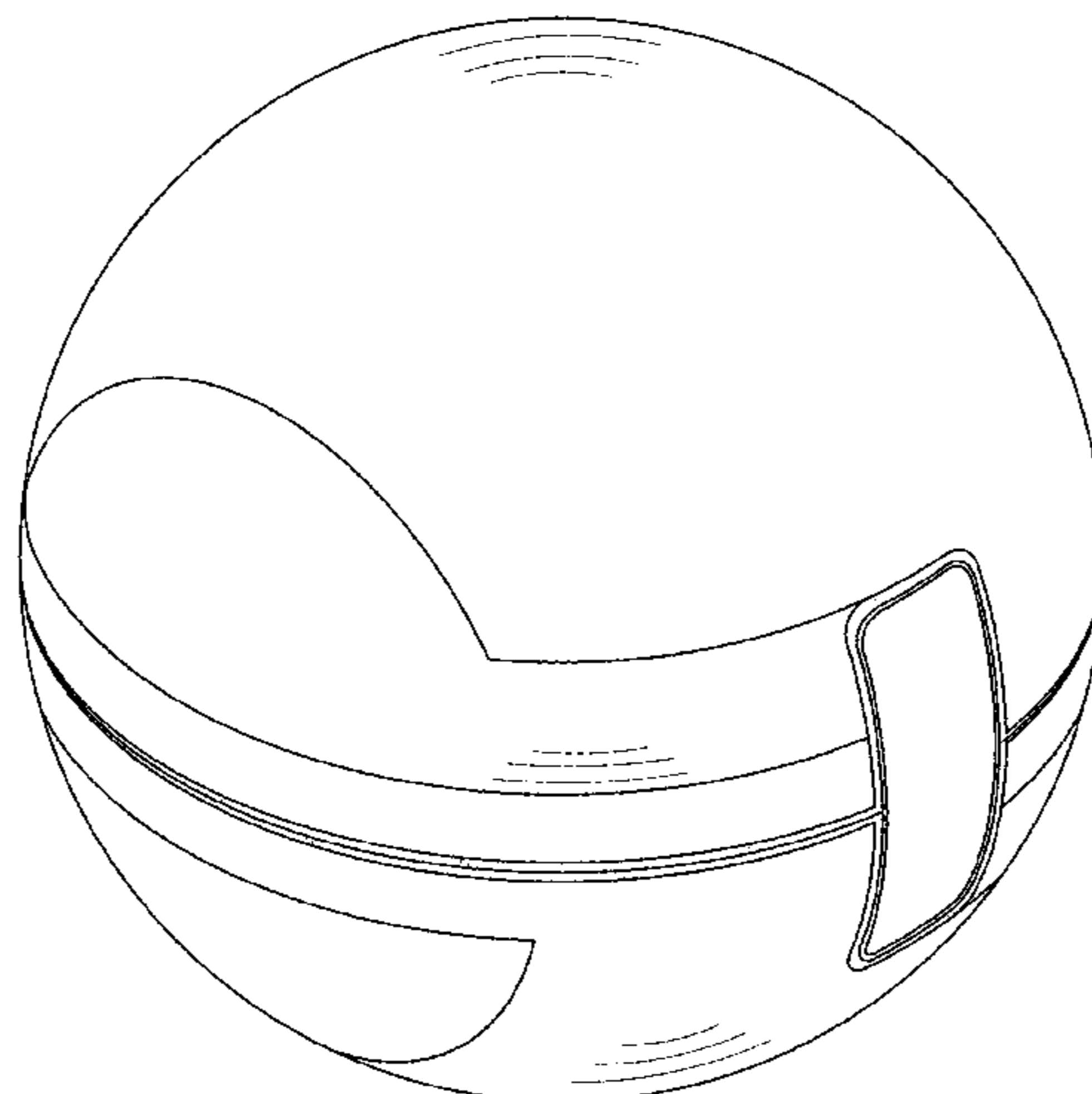
FIG. 4 shows a back elevation view of the stability and strength training ball of FIG. 1.

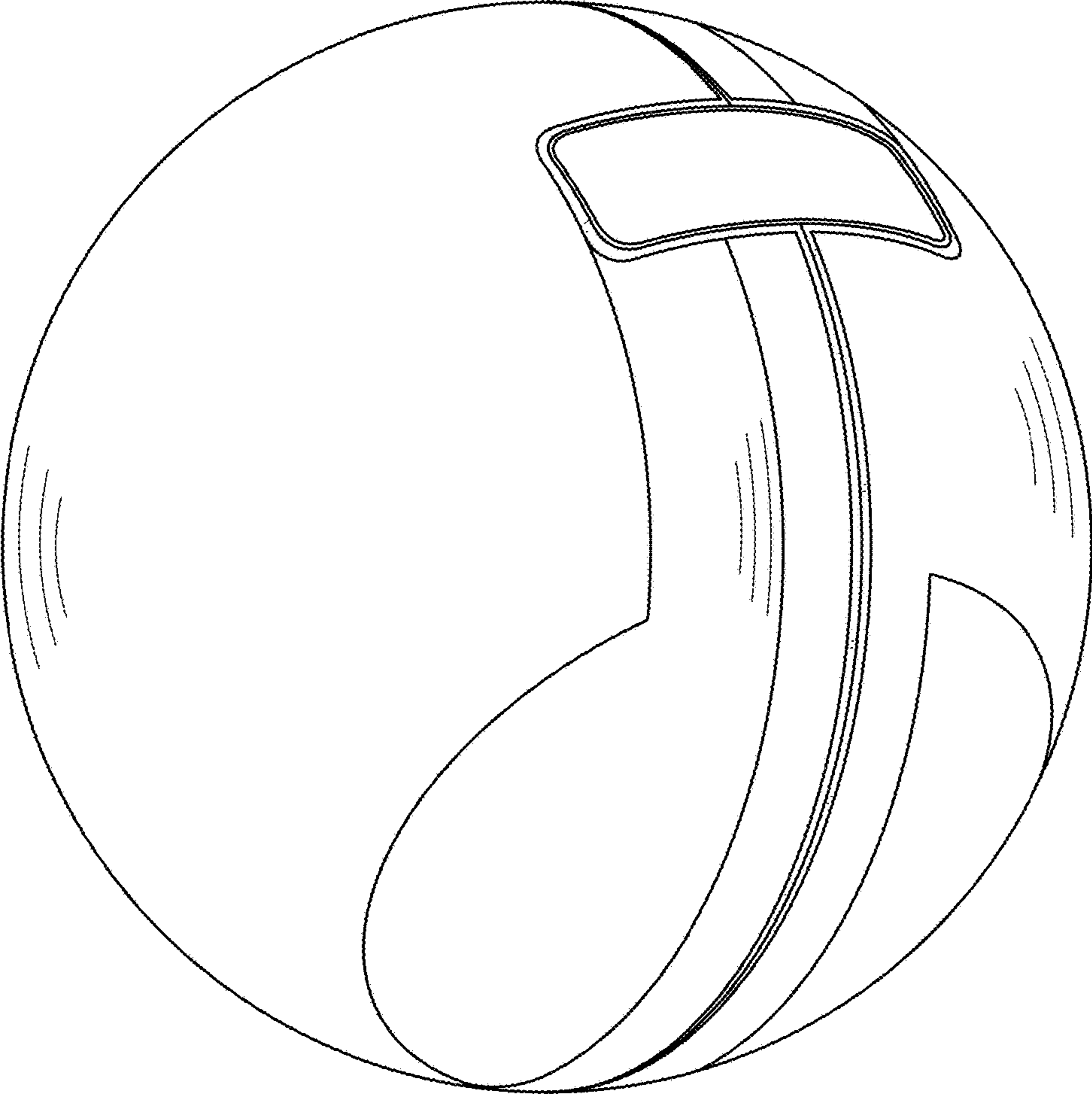

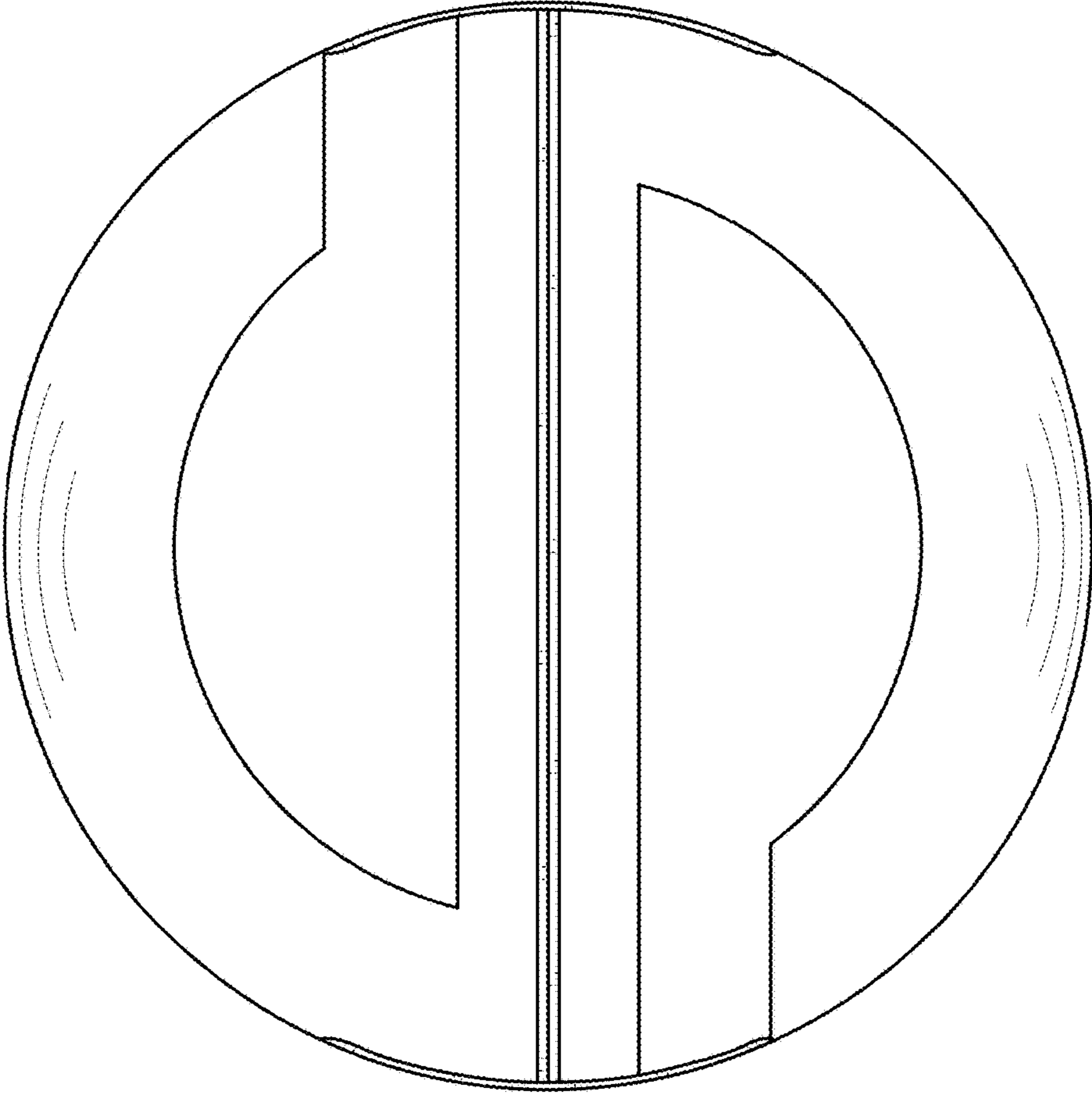

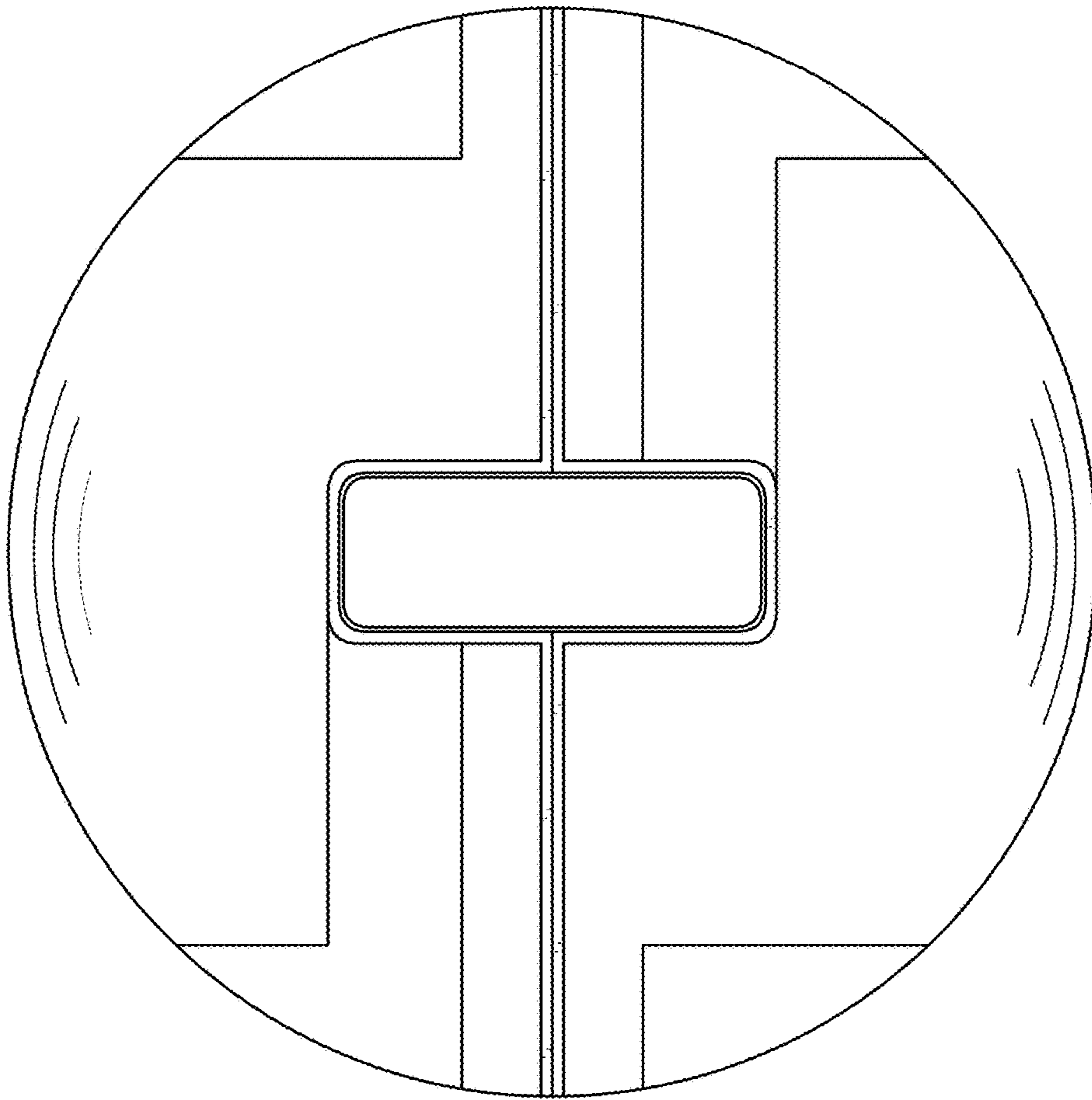

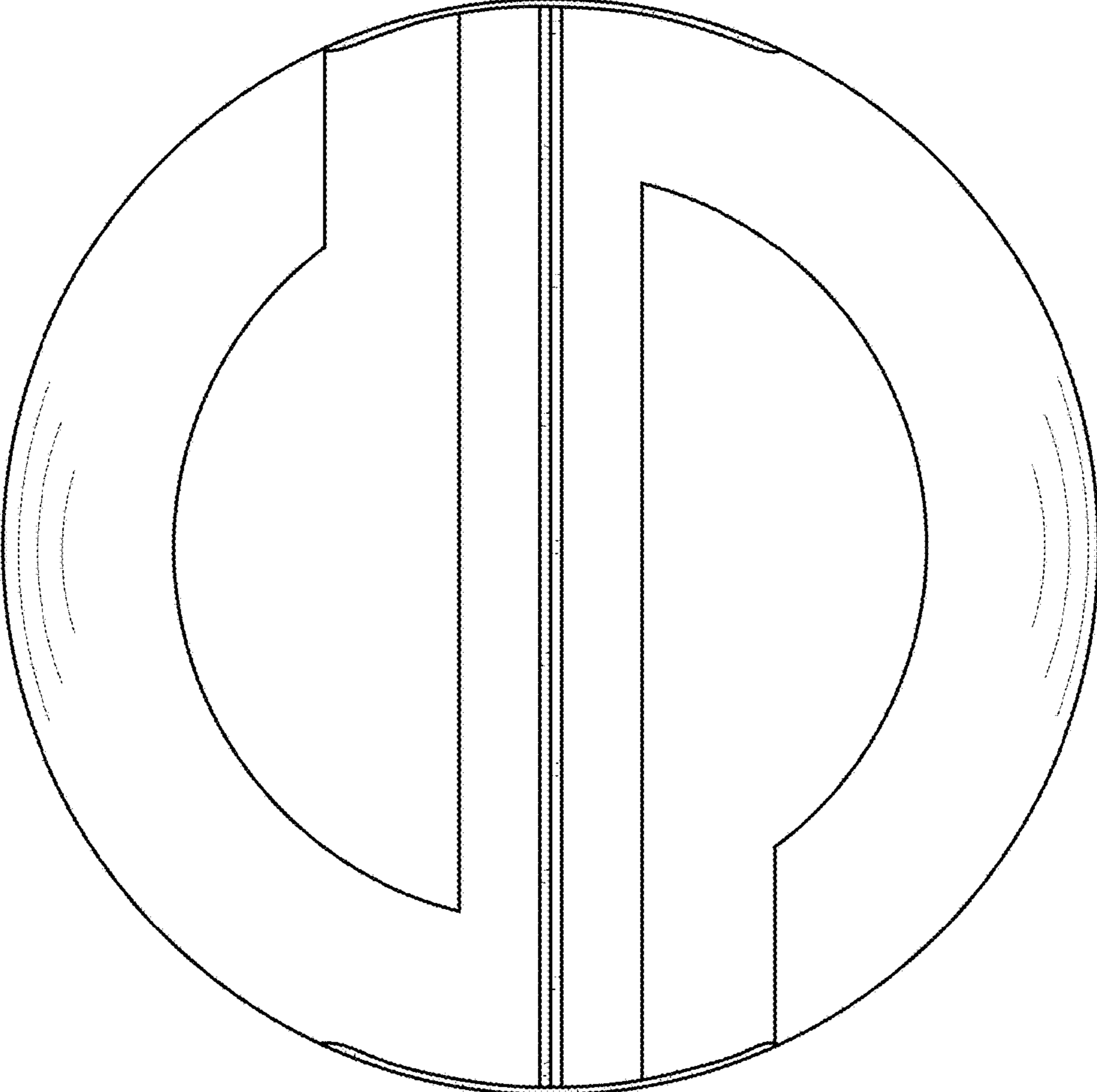

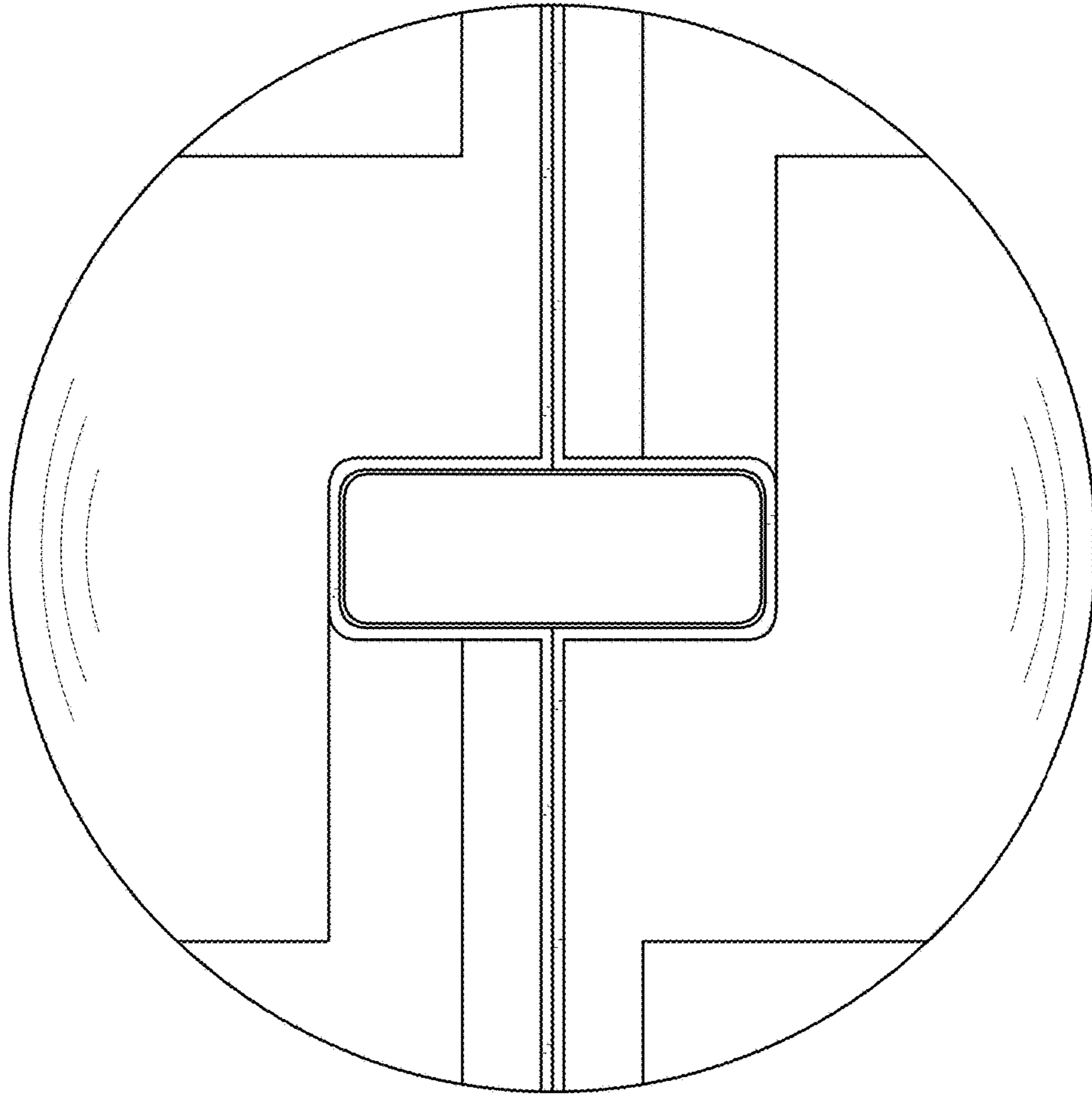

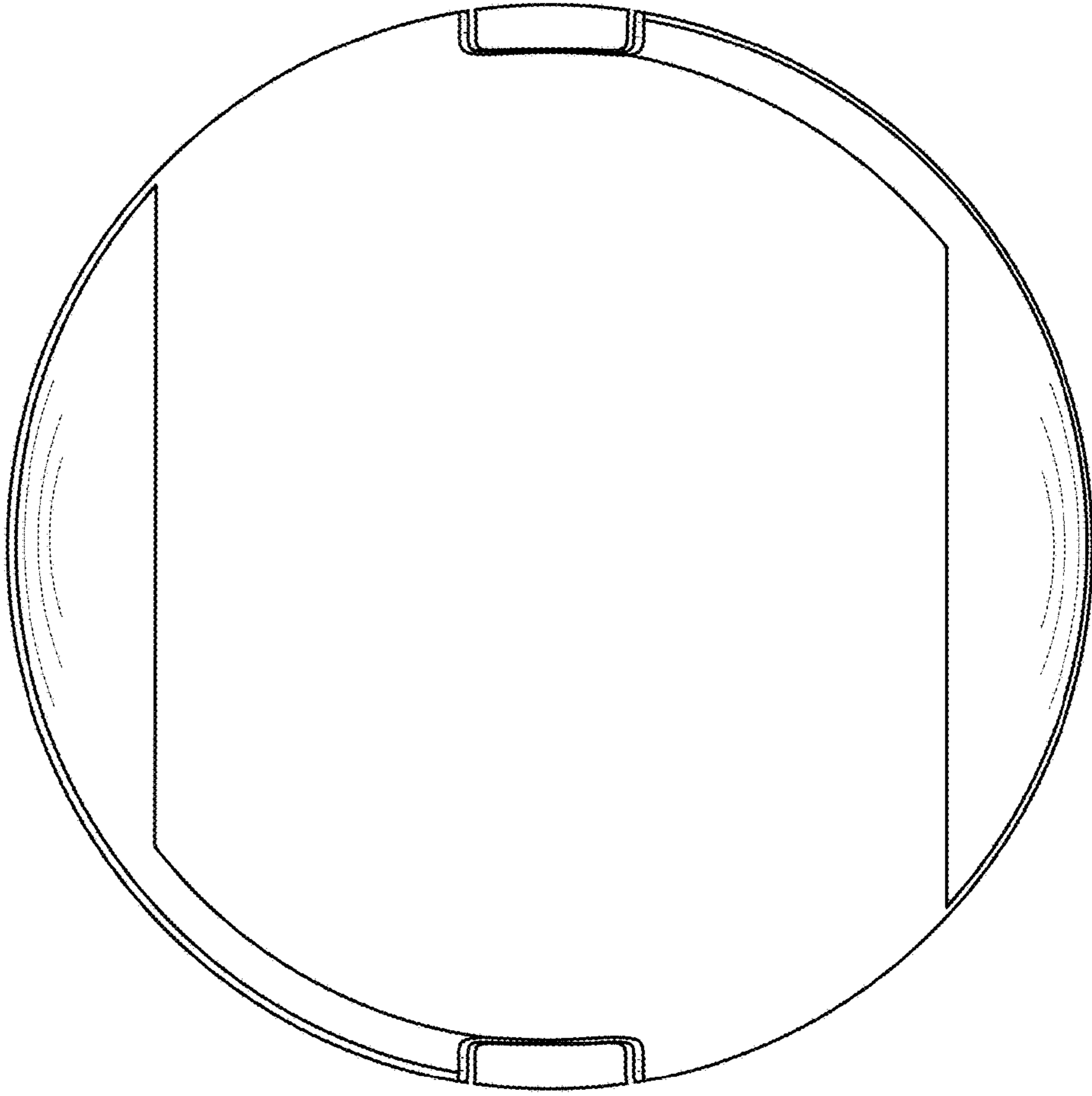

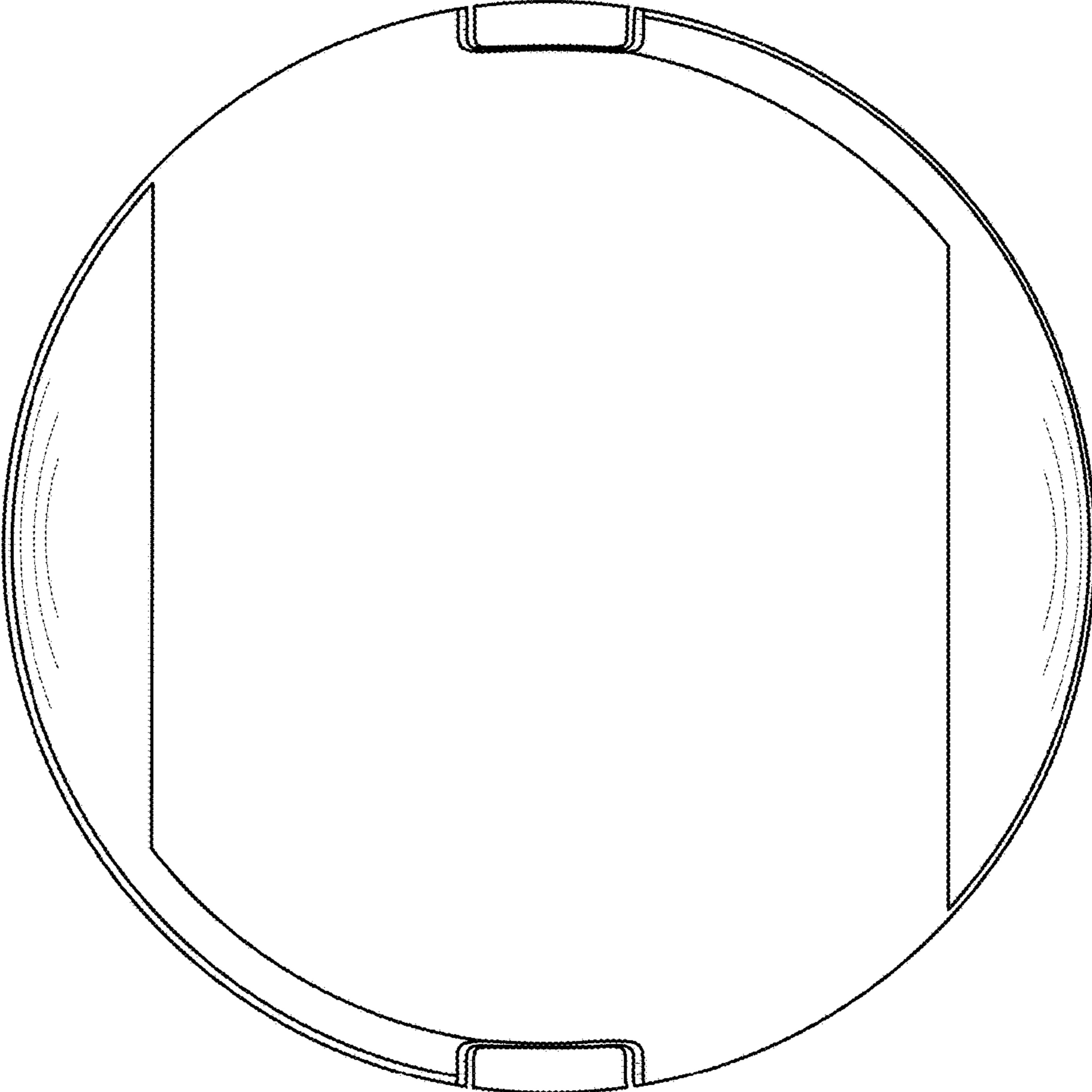
