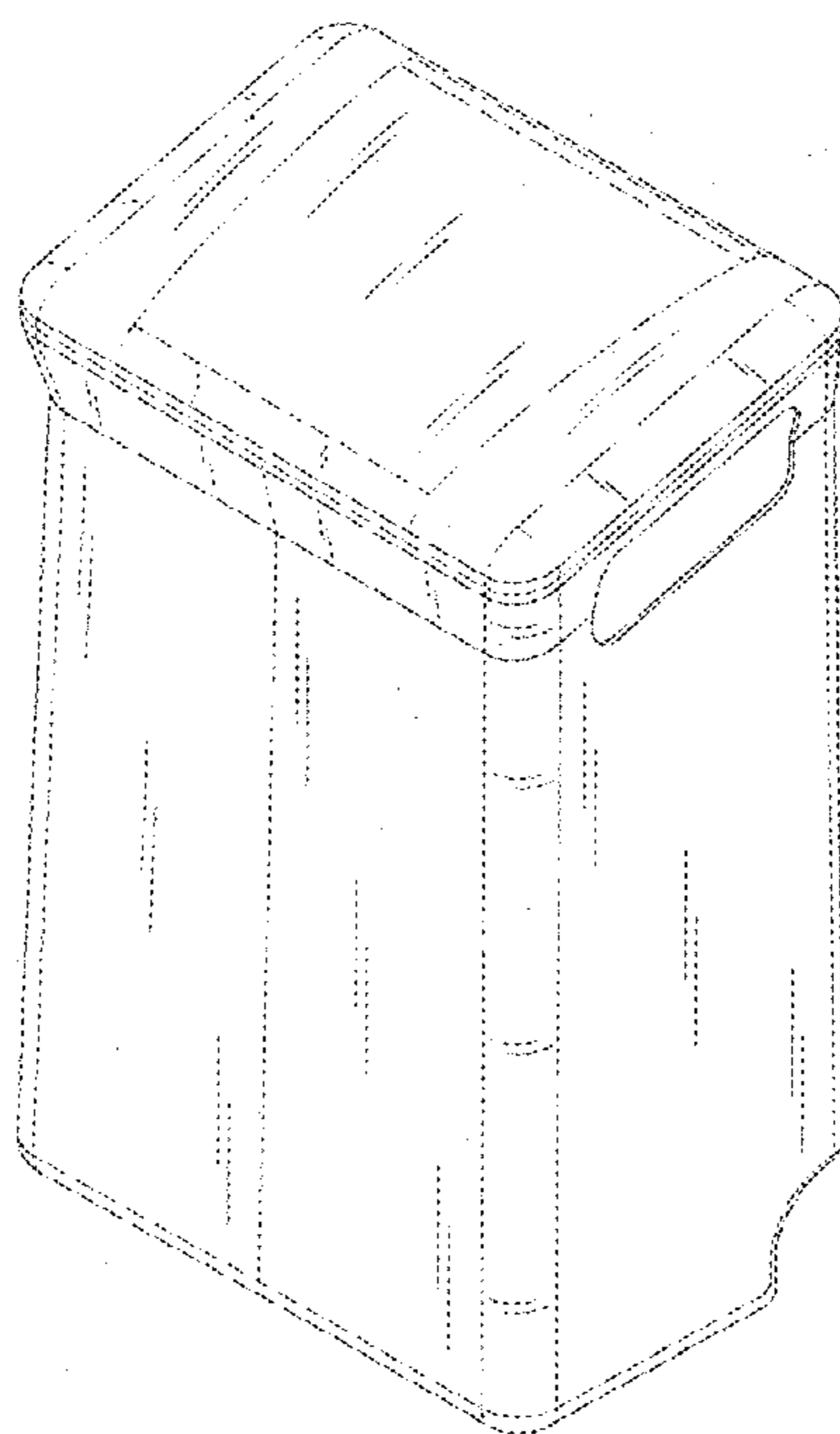
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the portable dialysis cabinet according to one embodiment;

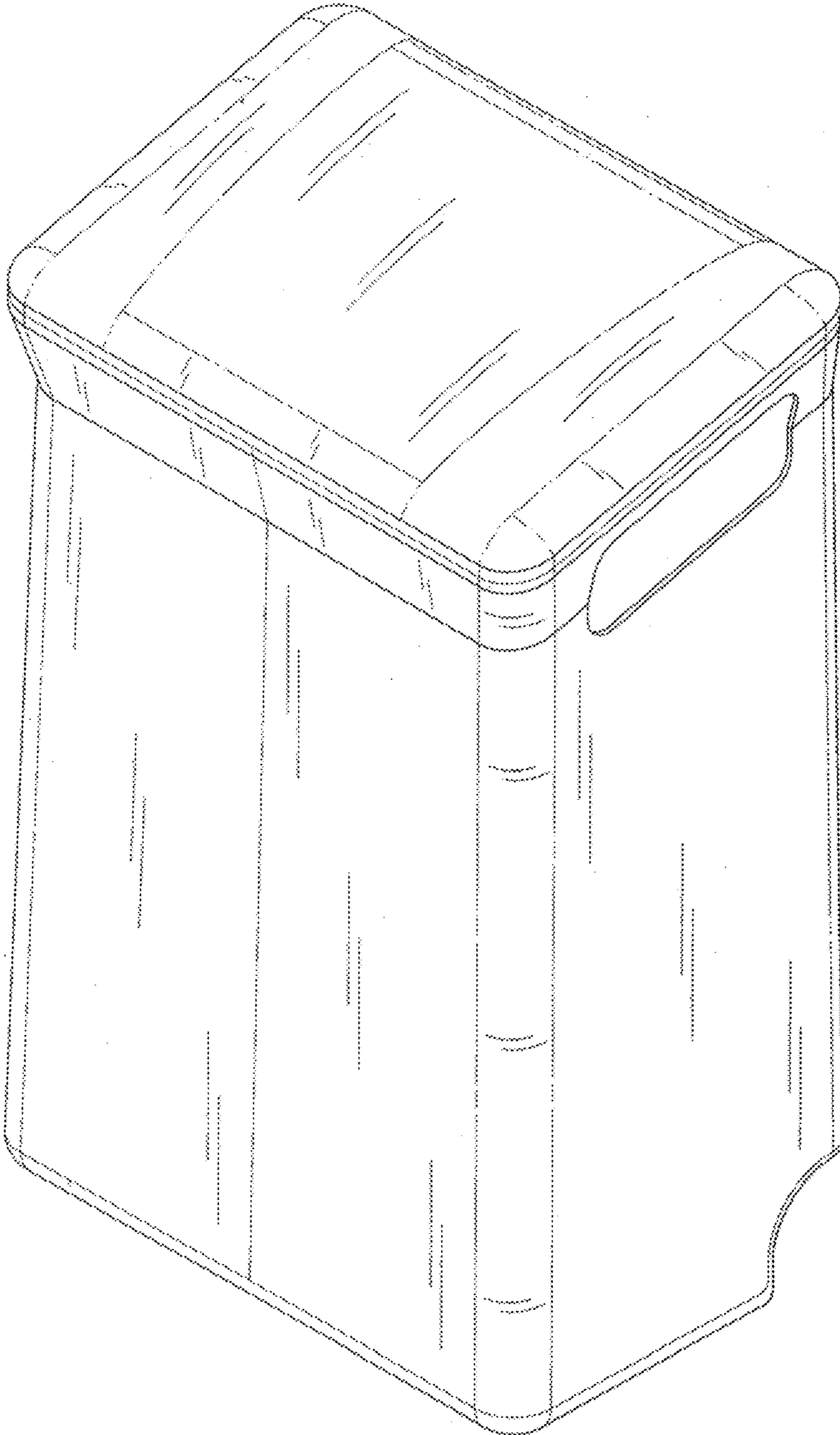

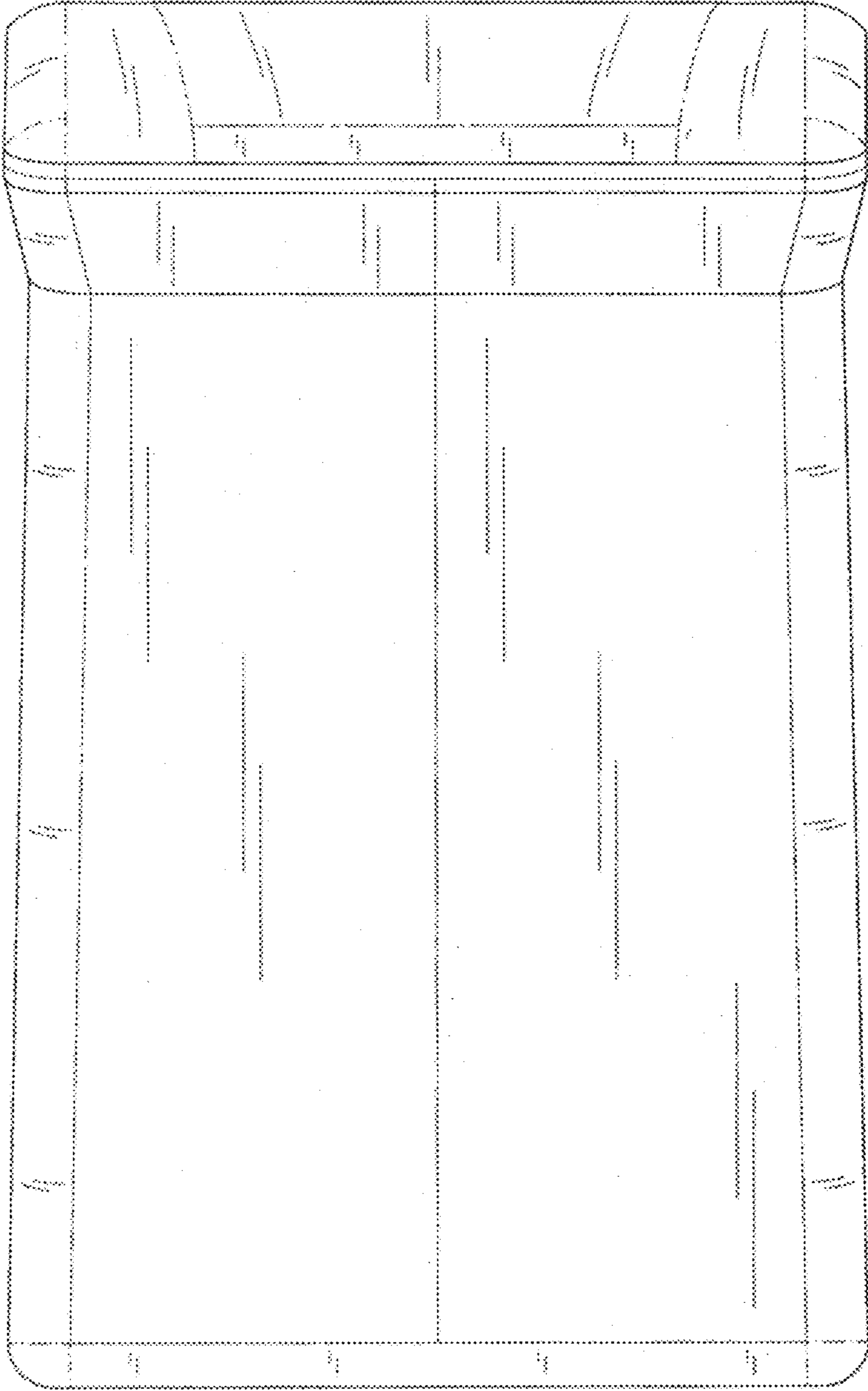

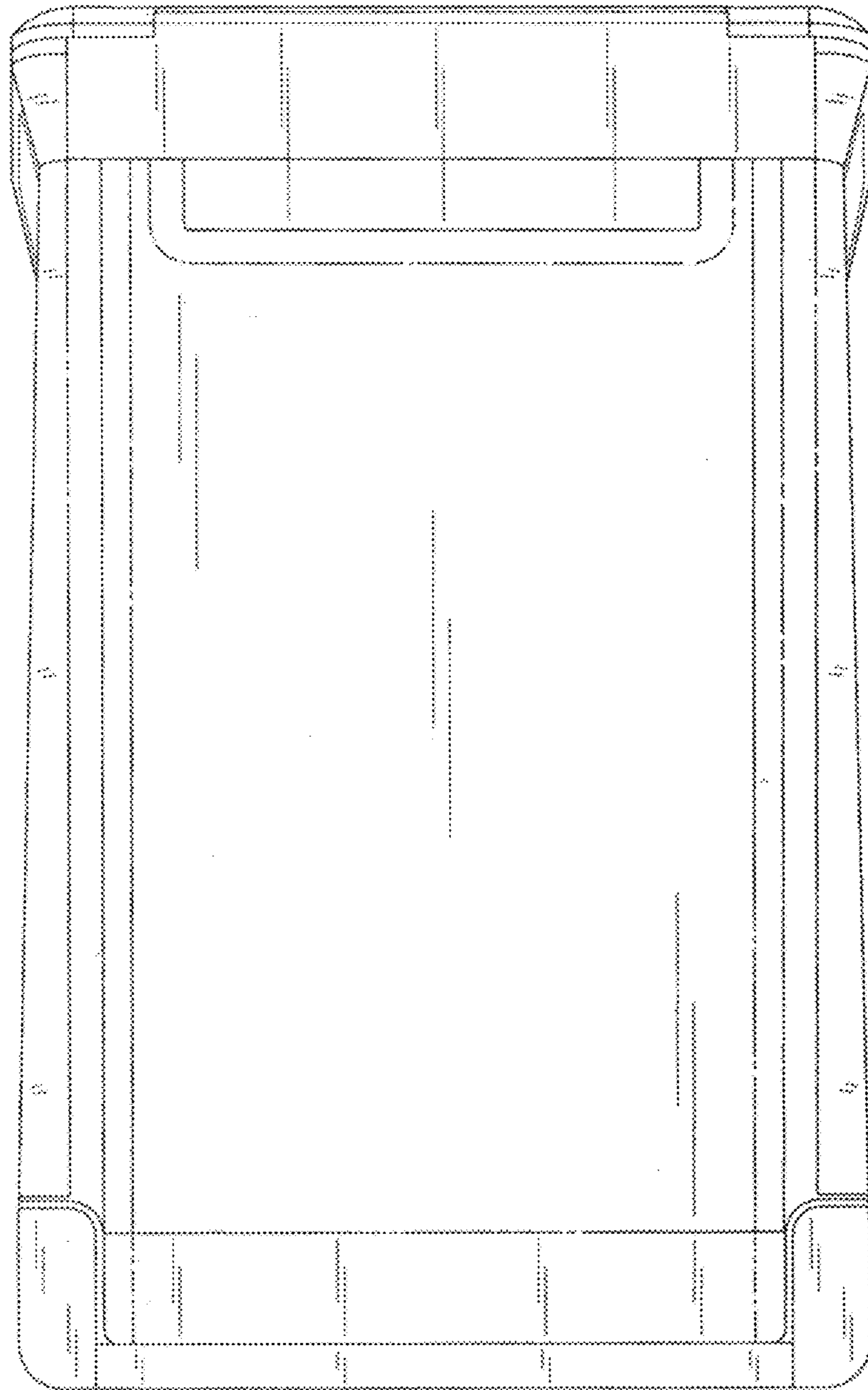

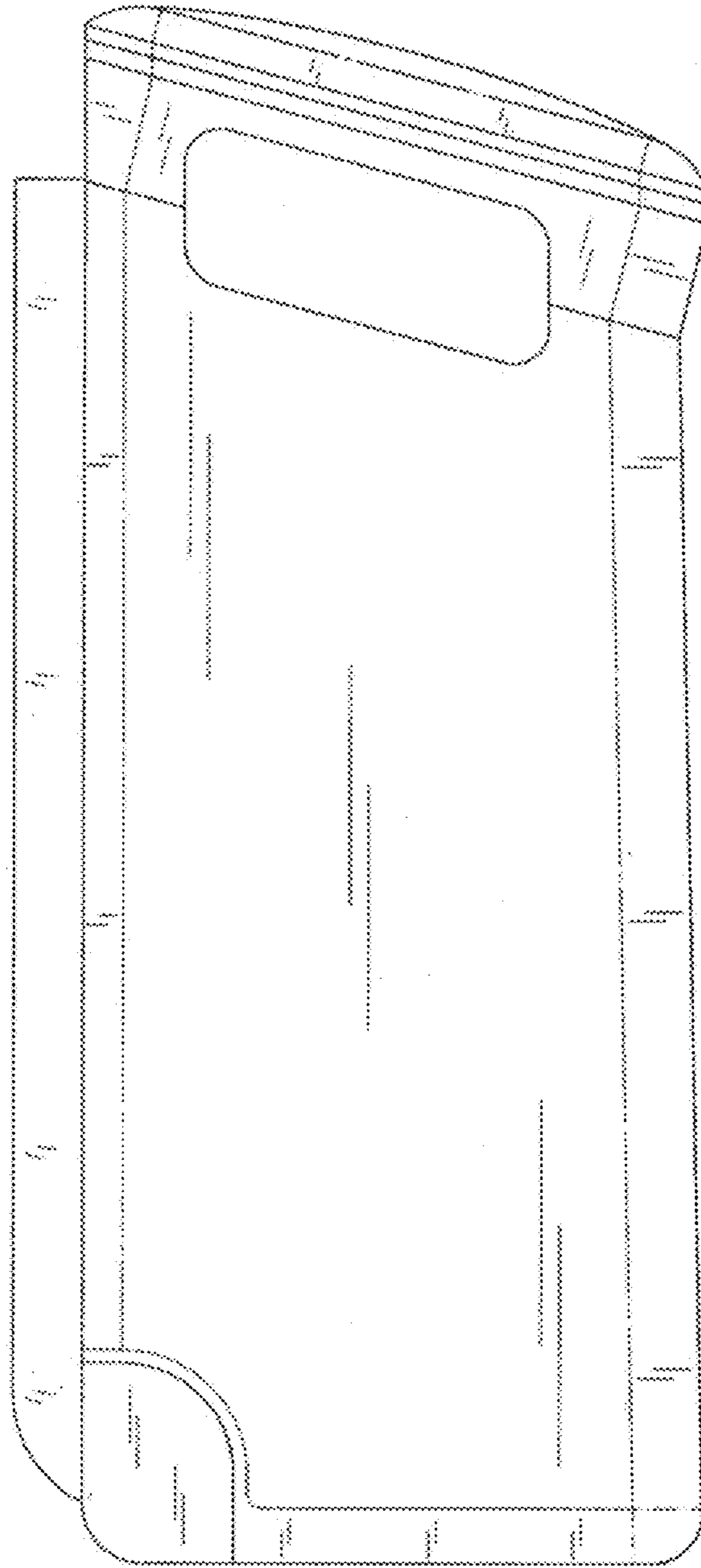

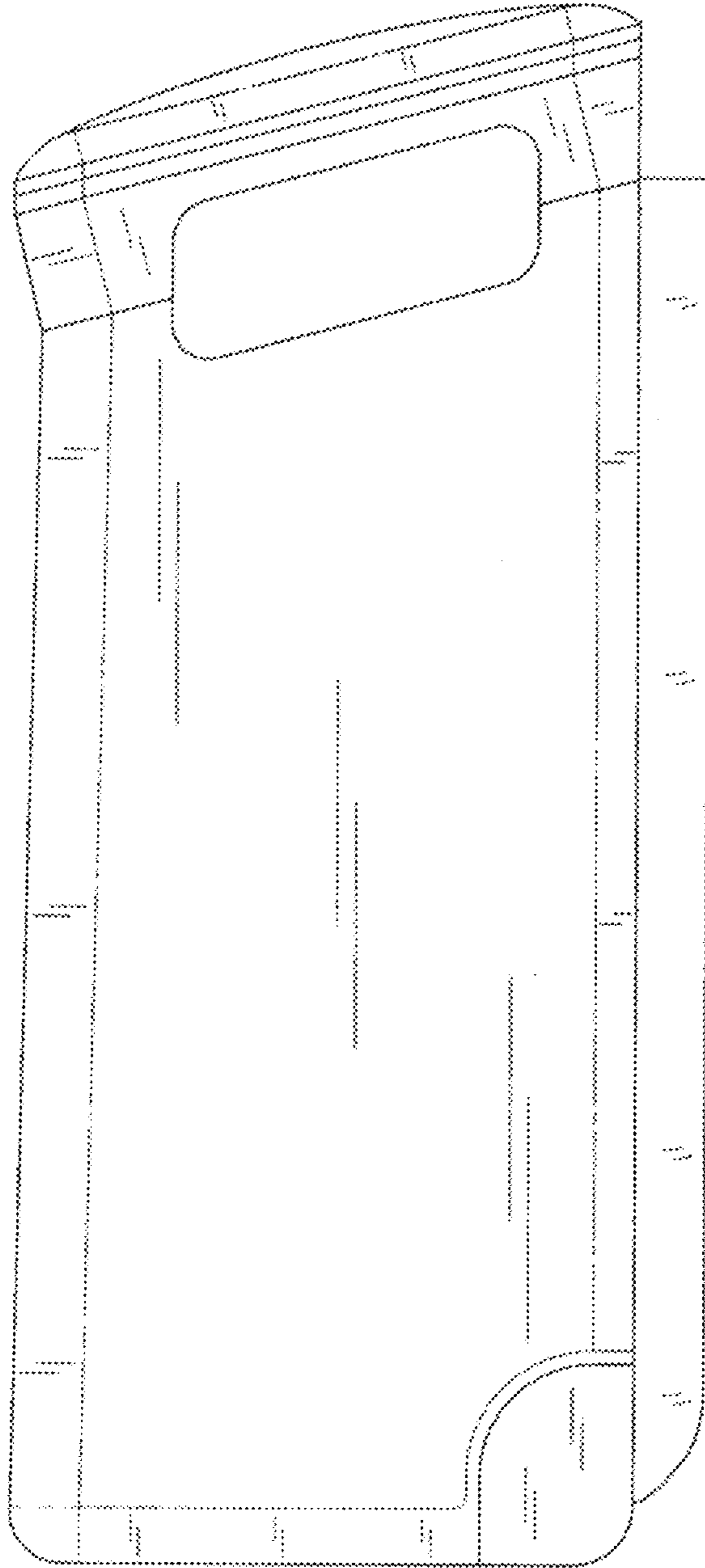

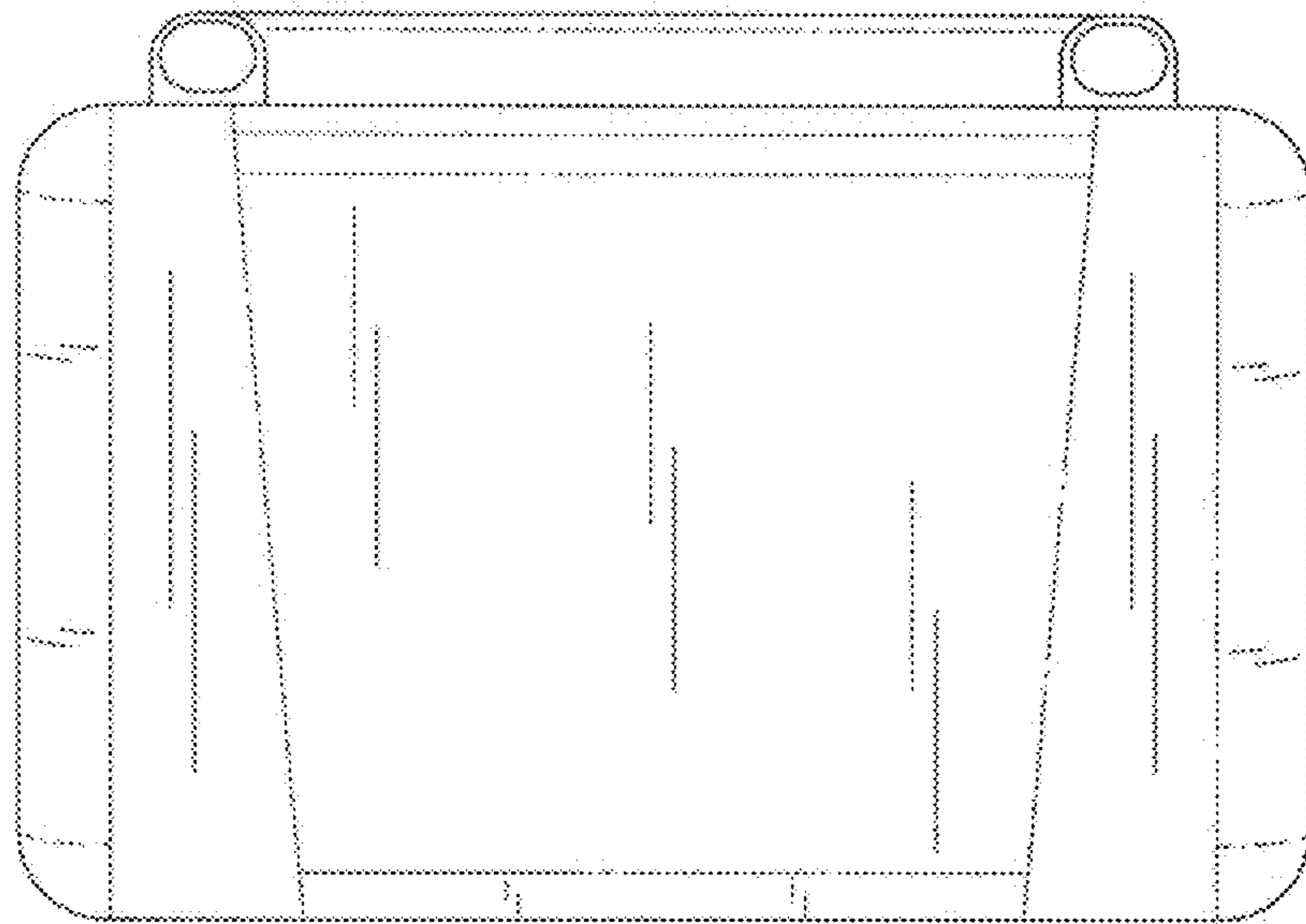

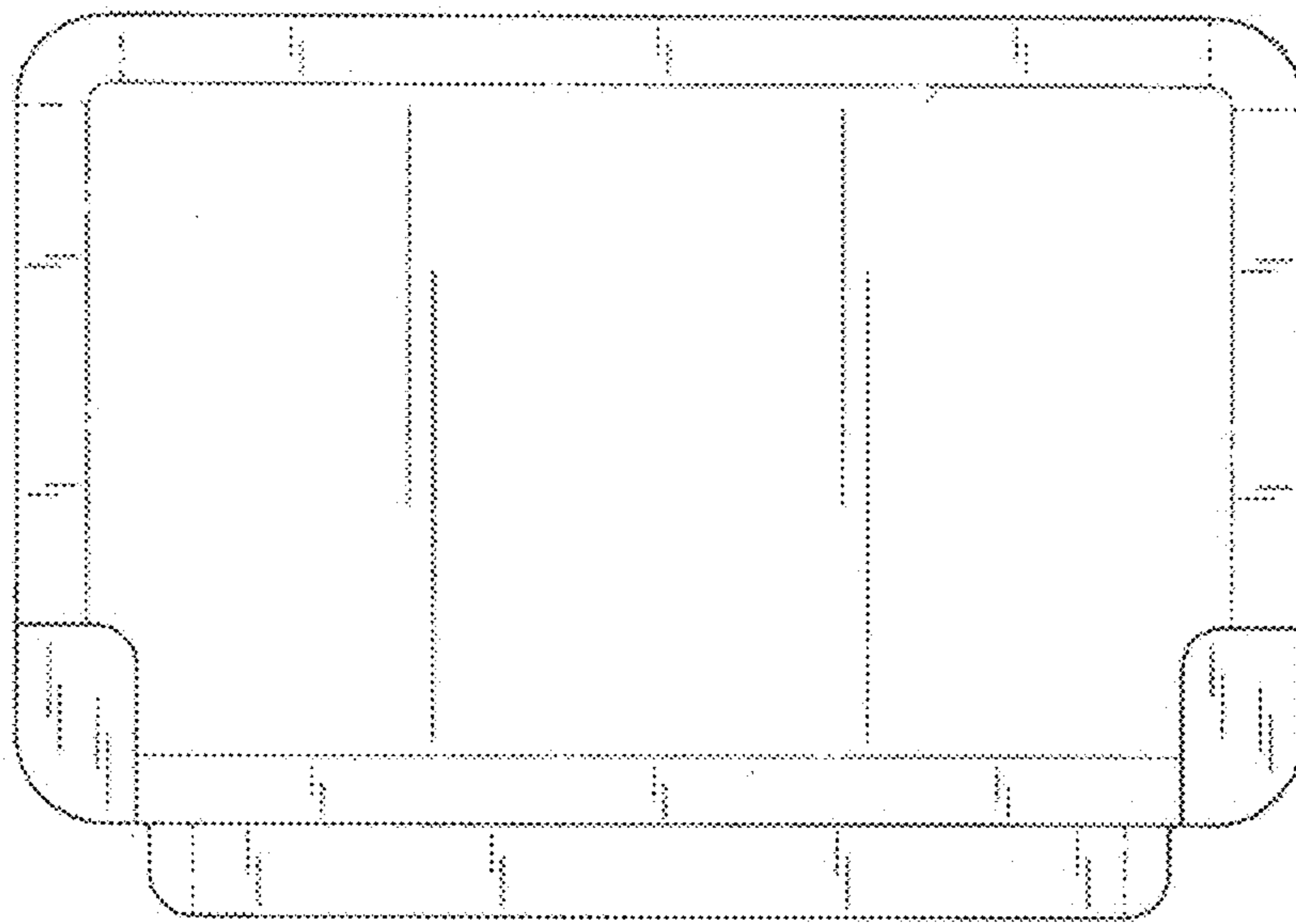
