(57) **CLAIM**

The ornamental design for a pair of orthopedic arch supports, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a pair of orthopedic arch supports for a left foot showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a right side view thereof;

FIG. 6 is a bottom view thereof;

FIG. 7 is a perspective view of a second embodiment of a pair of orthopedic arch supports for a right foot showing my new design;

FIG. 8 is a top plan view thereof;

FIG. 9 is a front view thereof;

FIG. 10 is a rear view thereof;

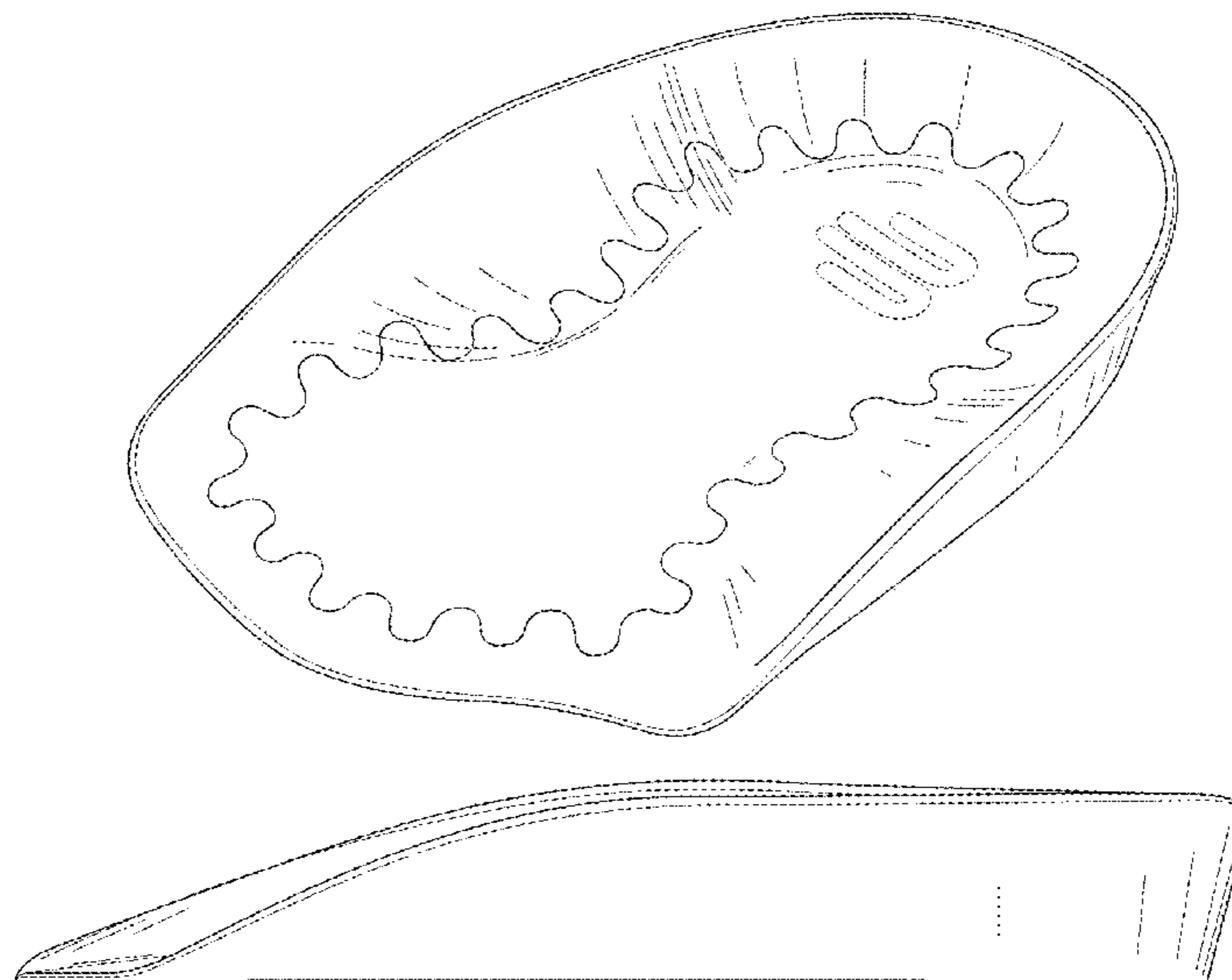
FIG. 11 is a left side view thereof; and,

FIG. 12 is a bottom view thereof.

The left side view of the orthopedic arch support of FIG. 1 is omitted as it is a mirror image of that shown in FIG. 11; and the right side view of the orthopedic arch support of FIG. 7 is omitted as it is a mirror image of that shown in FIG. 5.

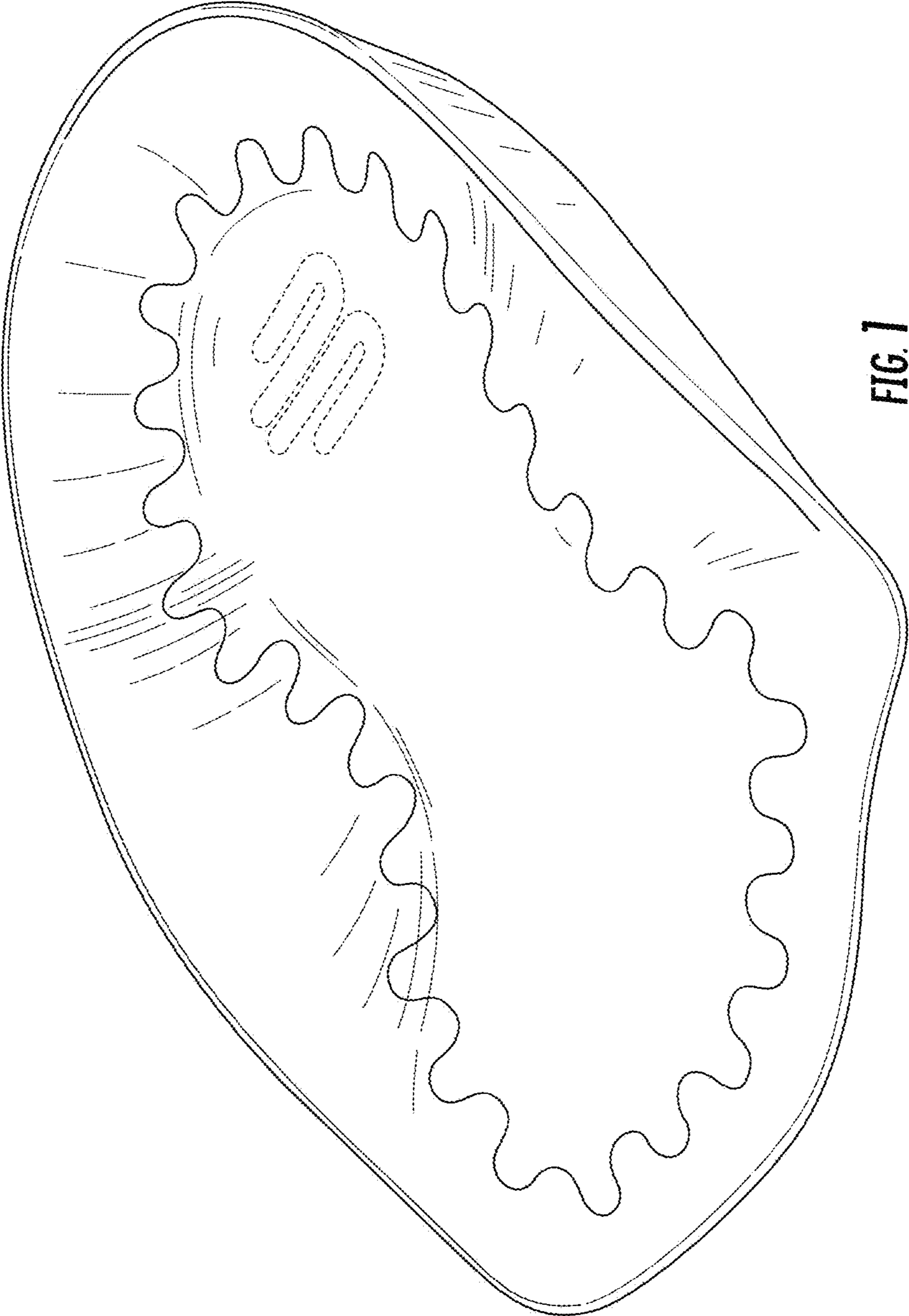

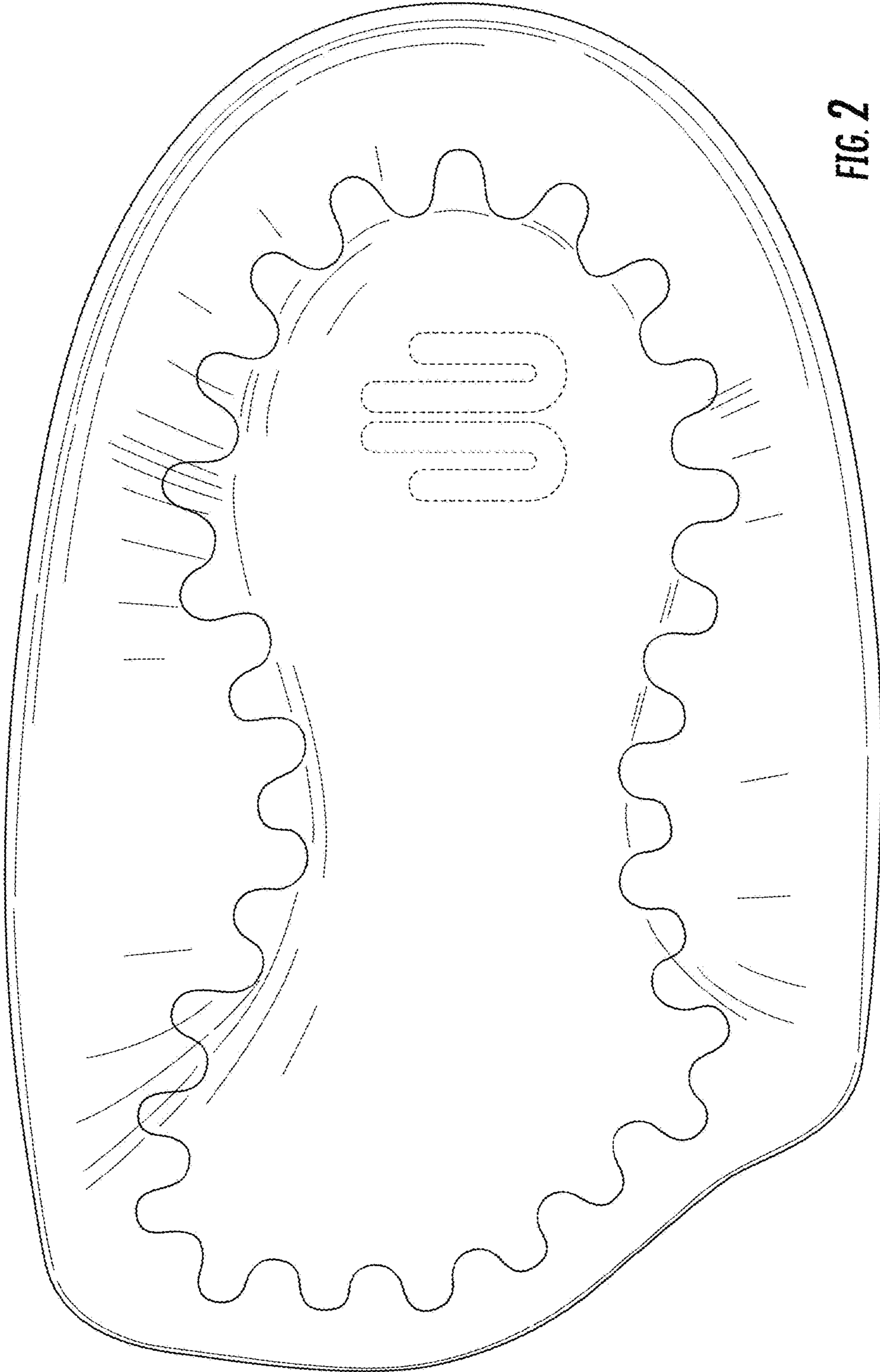

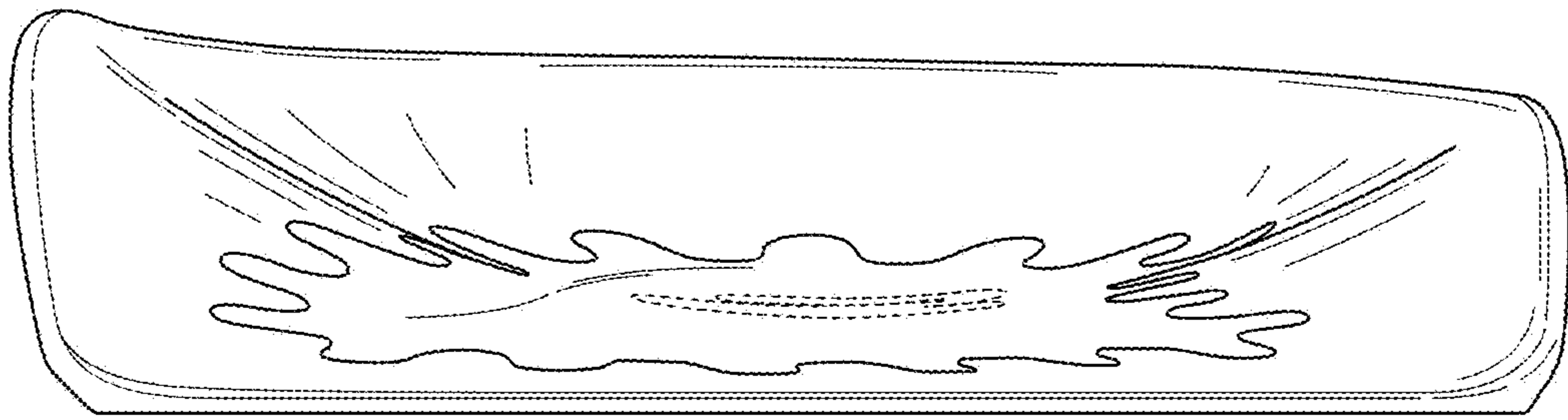

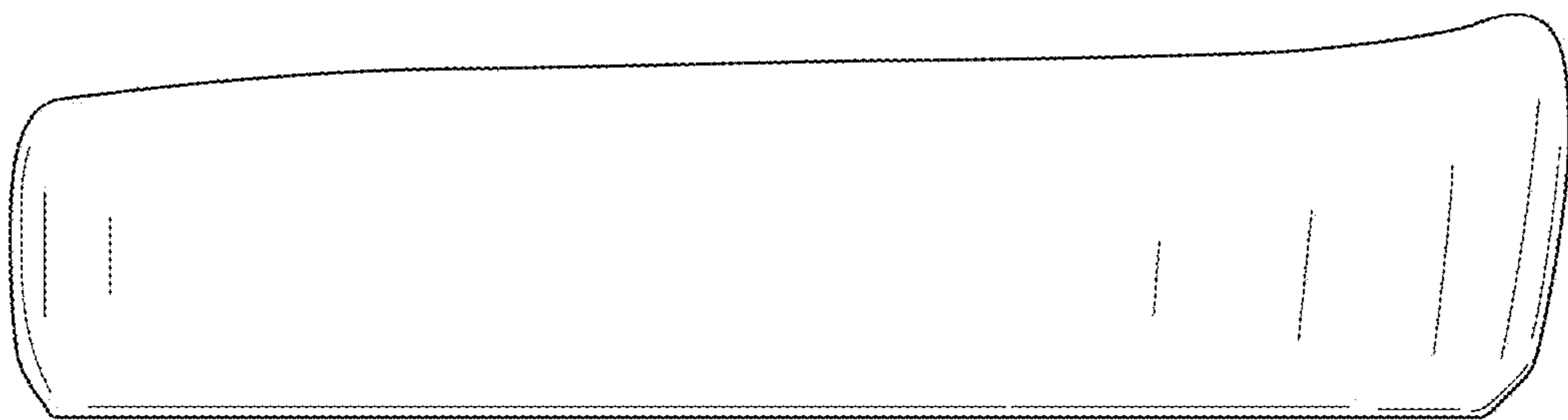

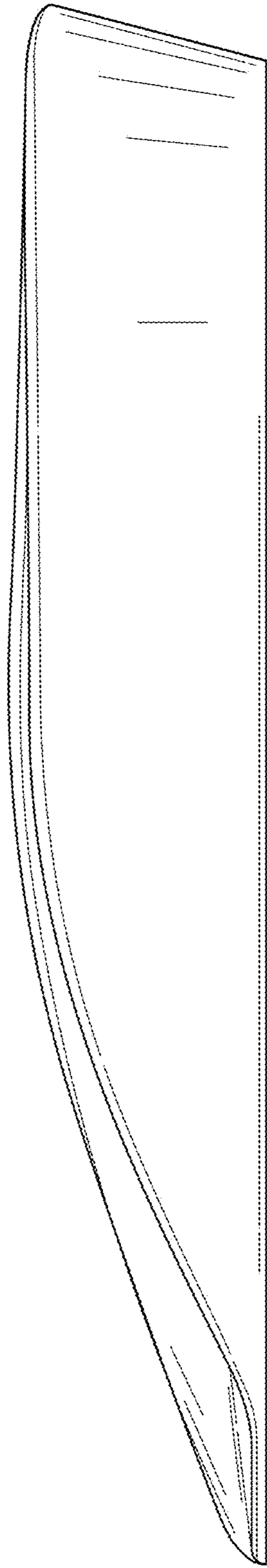

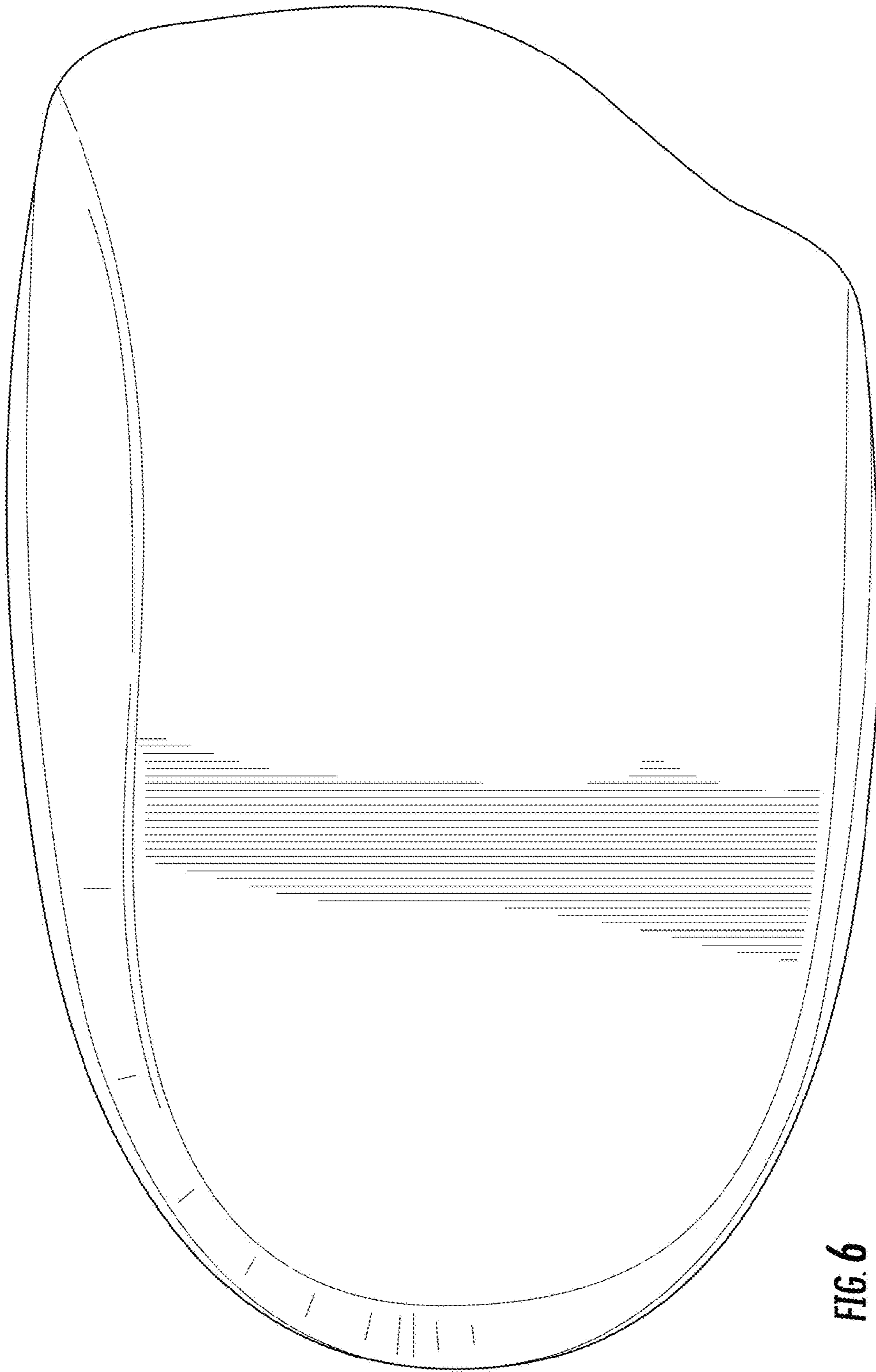

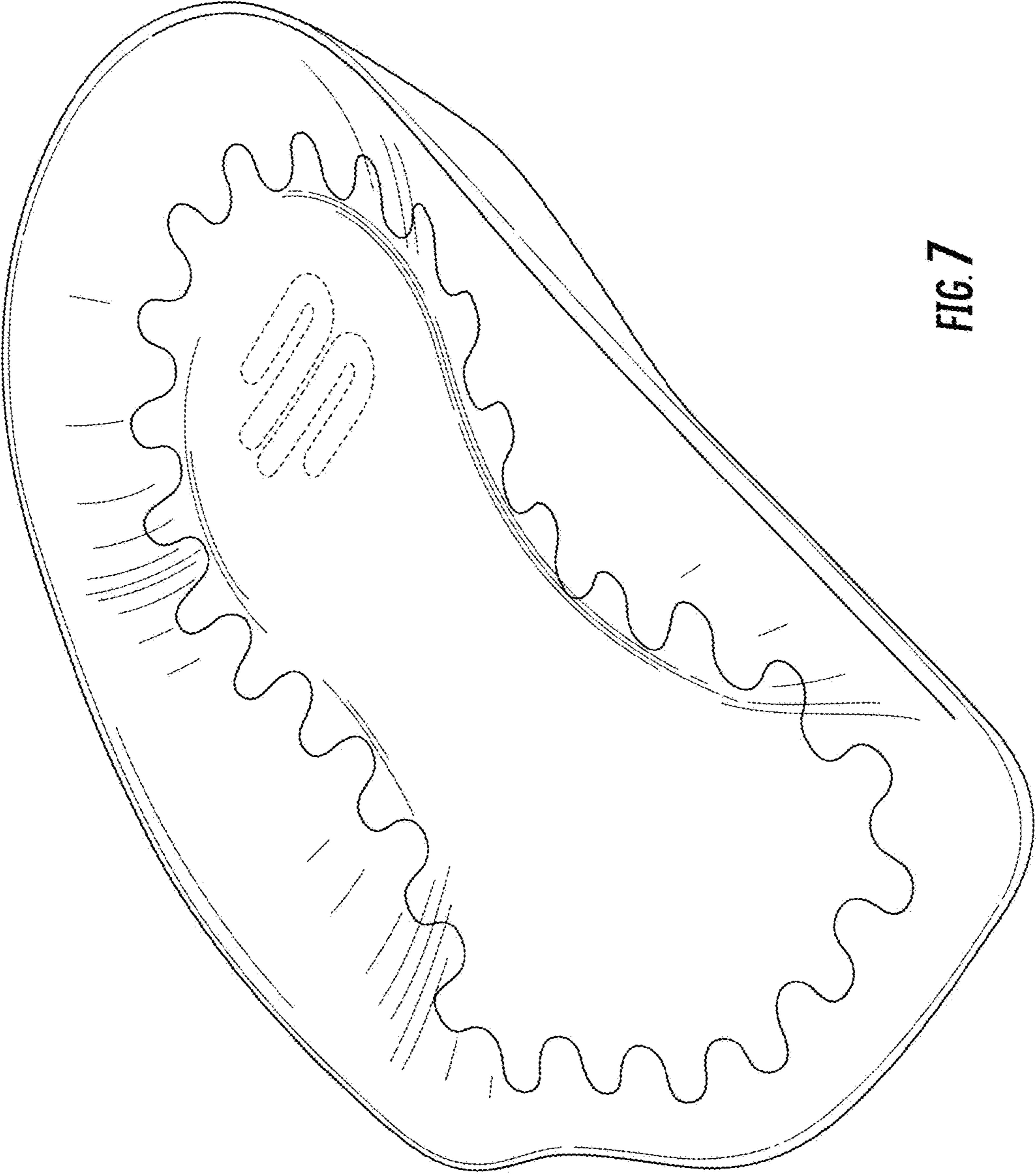

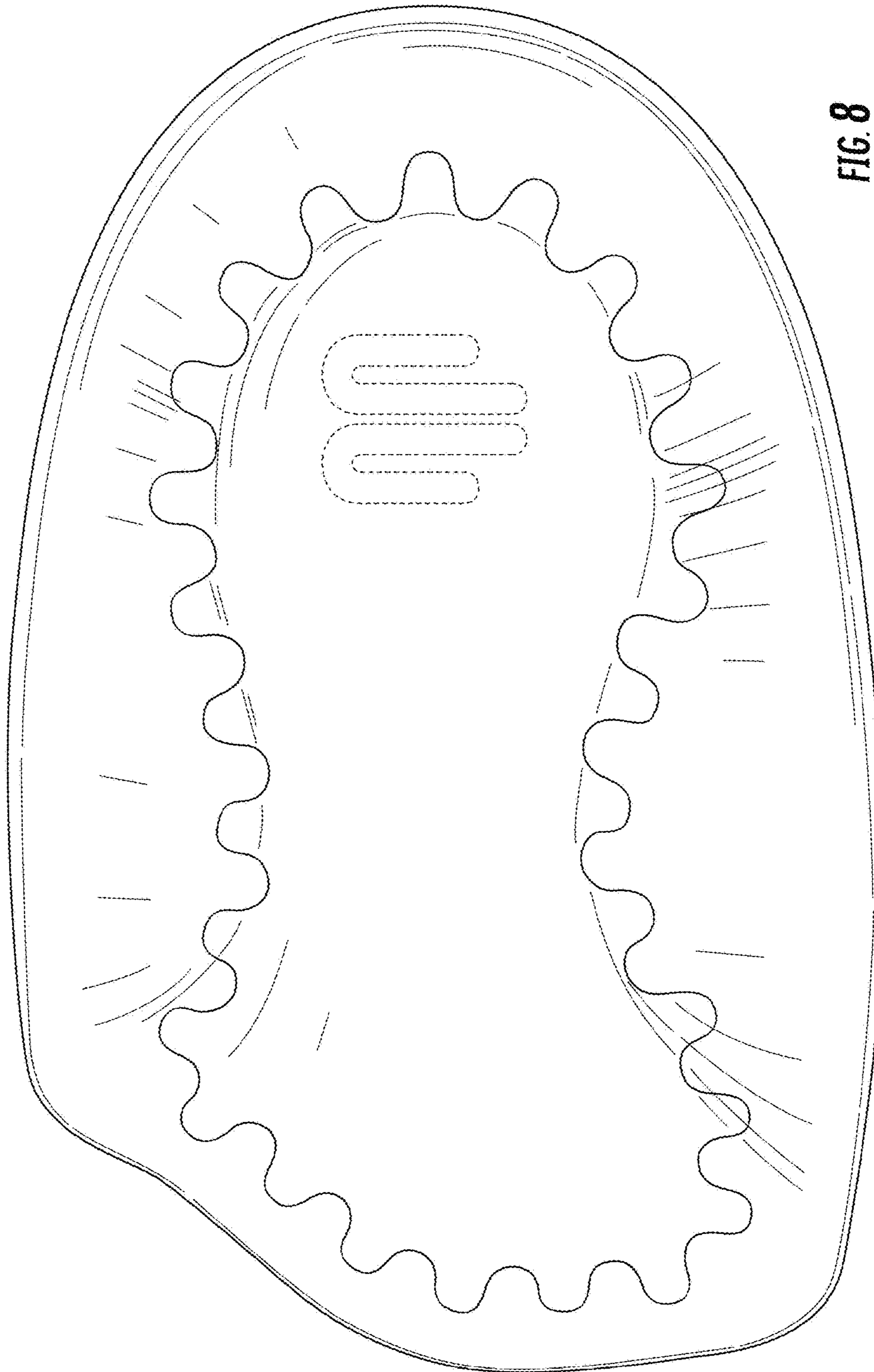

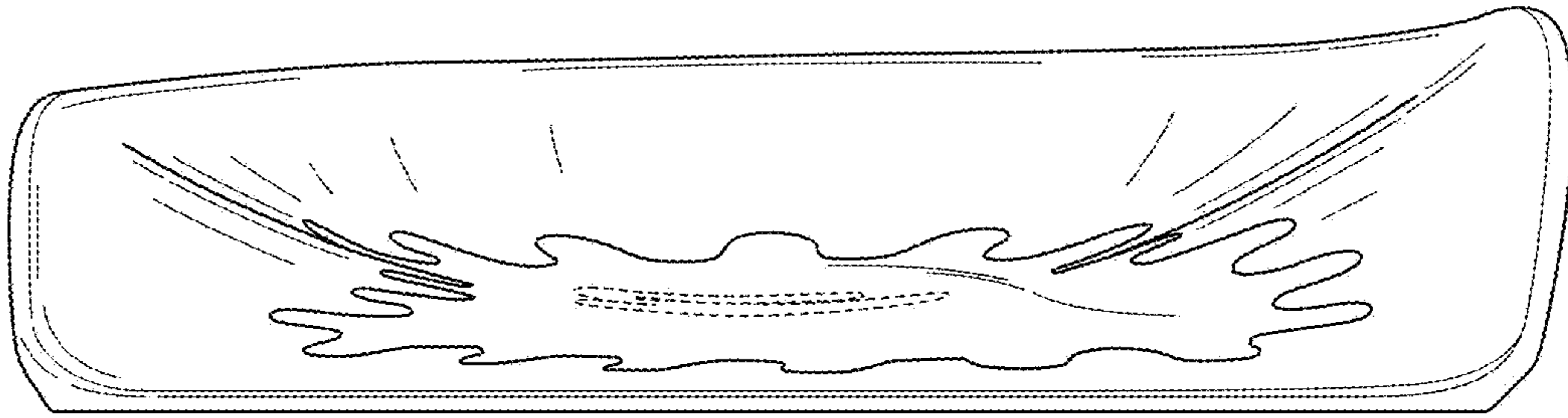

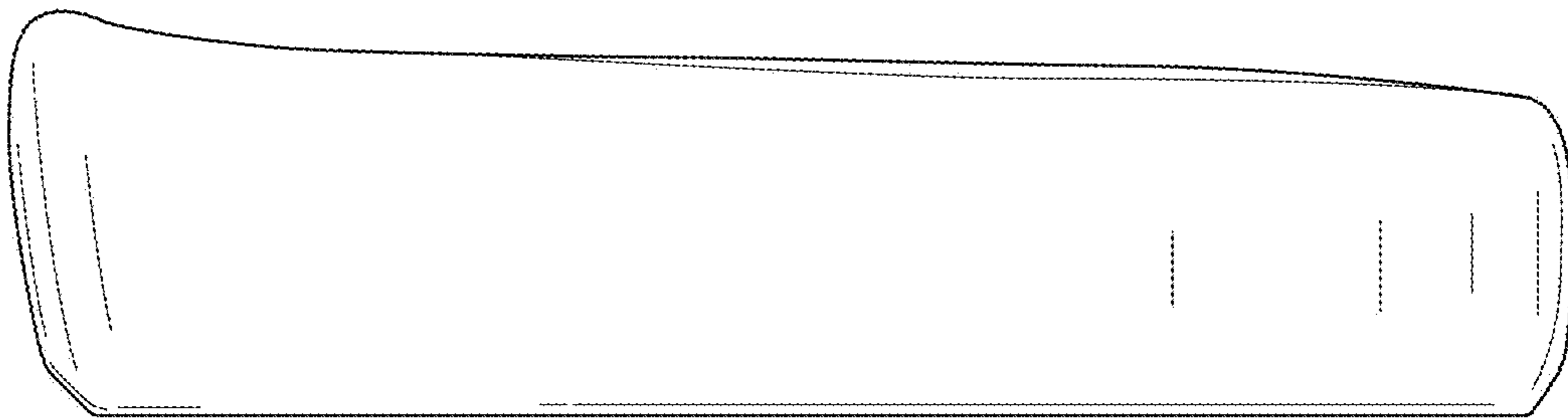

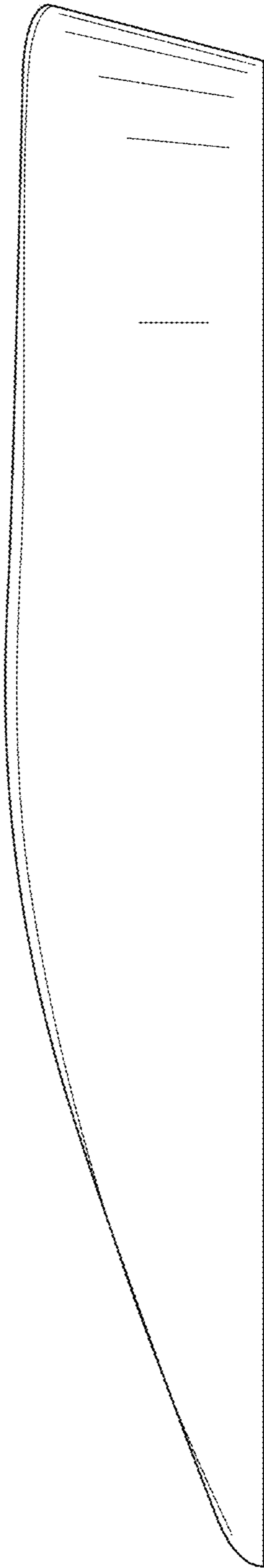

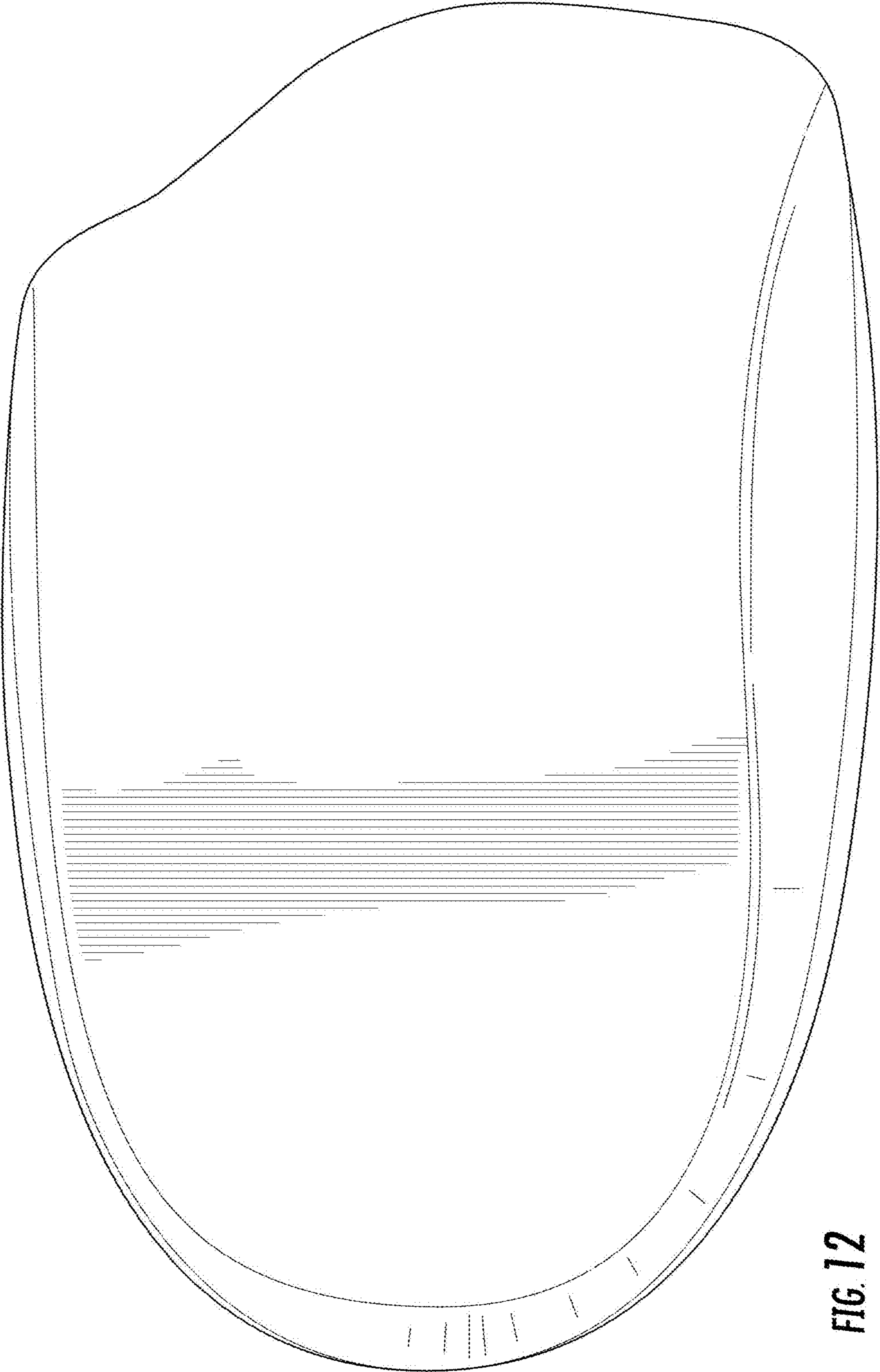
