DESCRIPTION

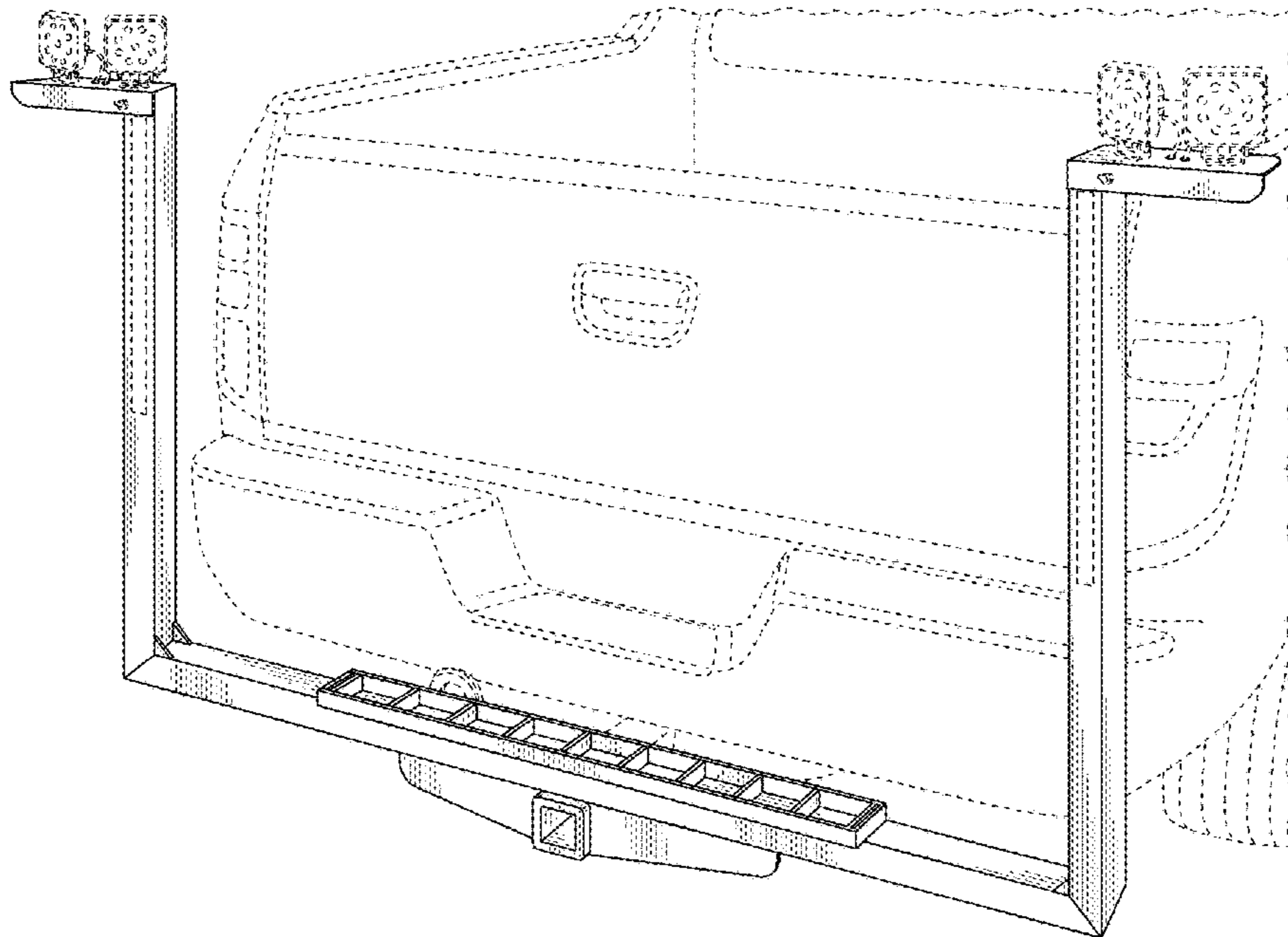

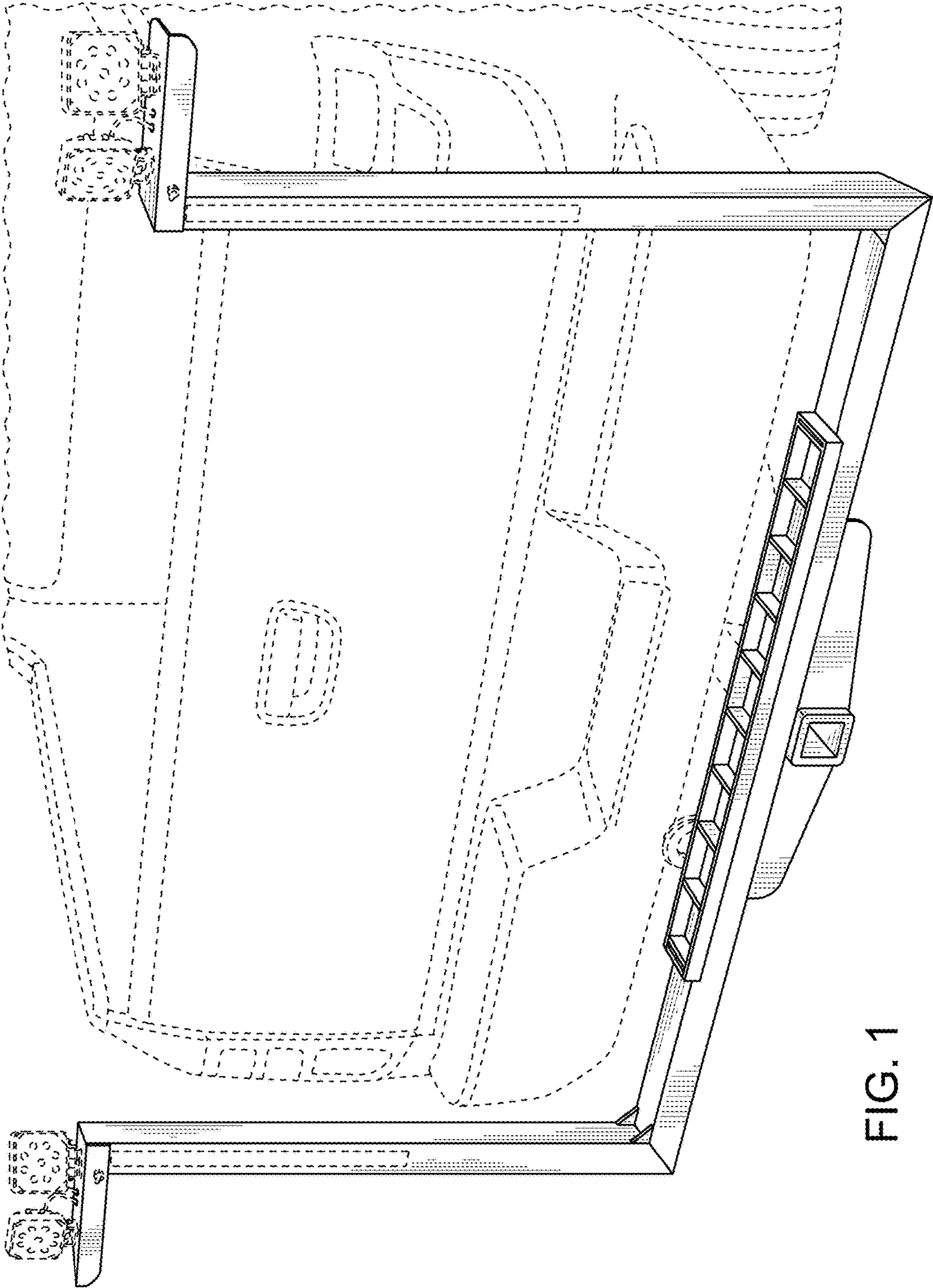
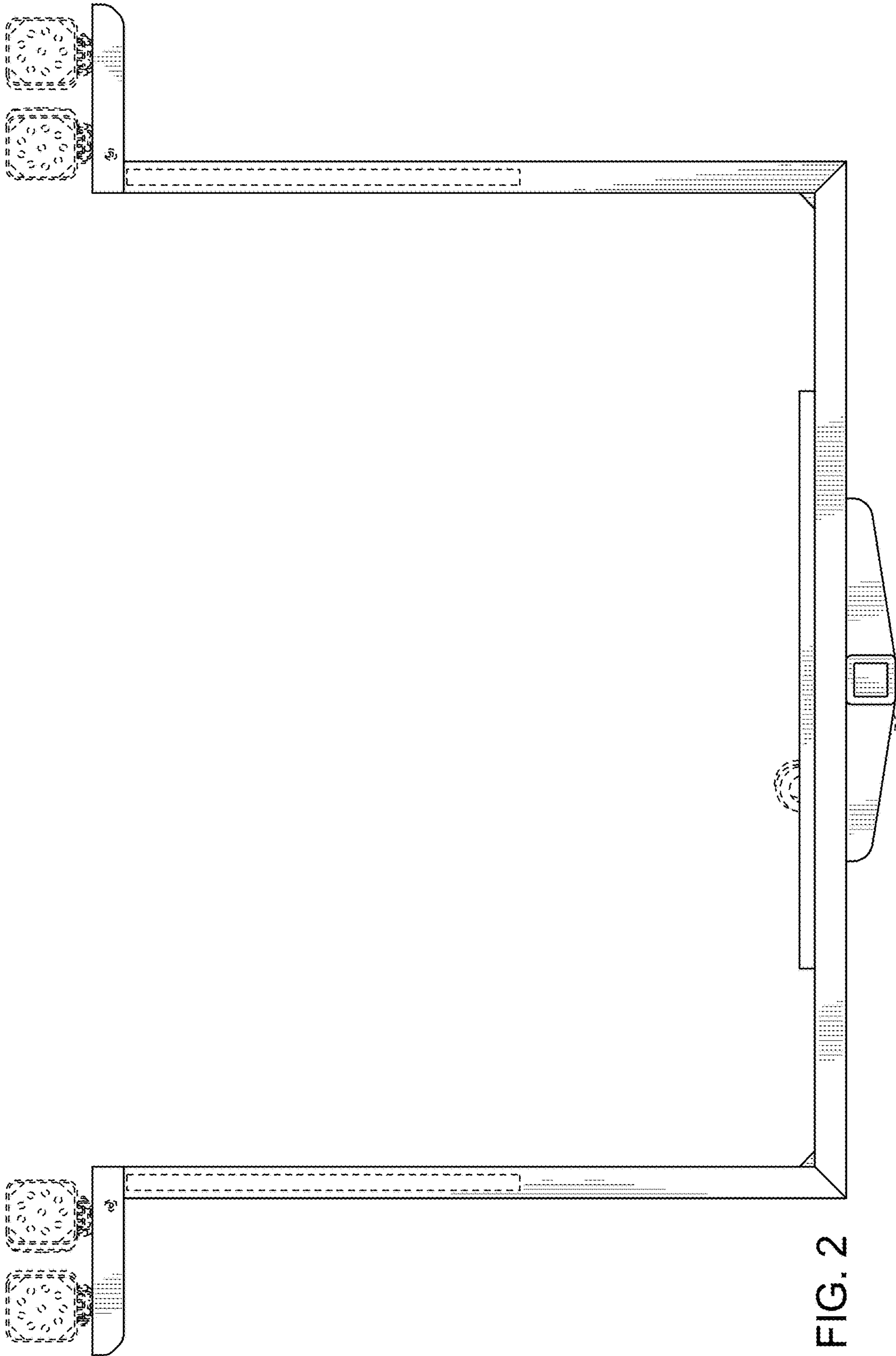

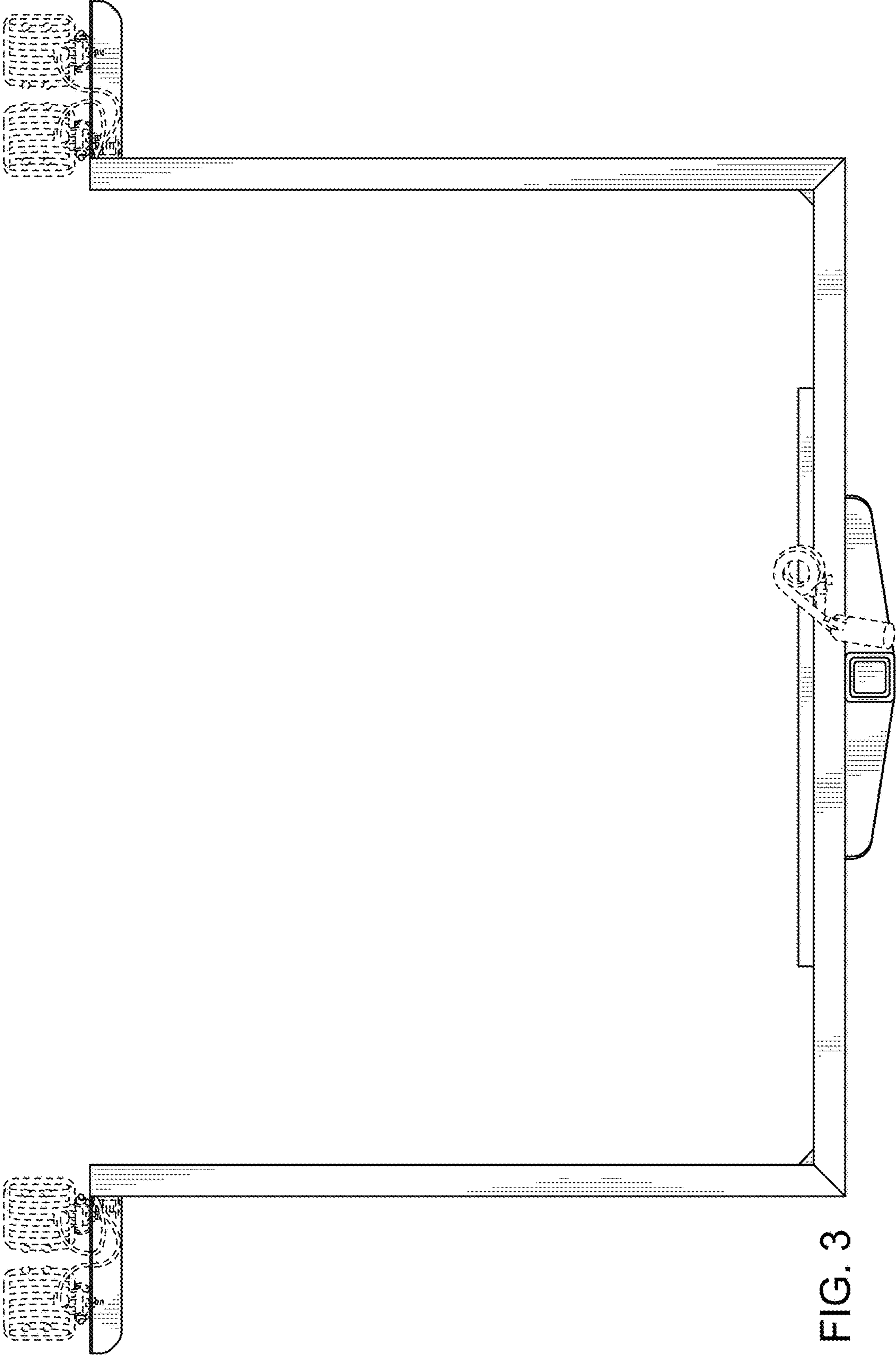

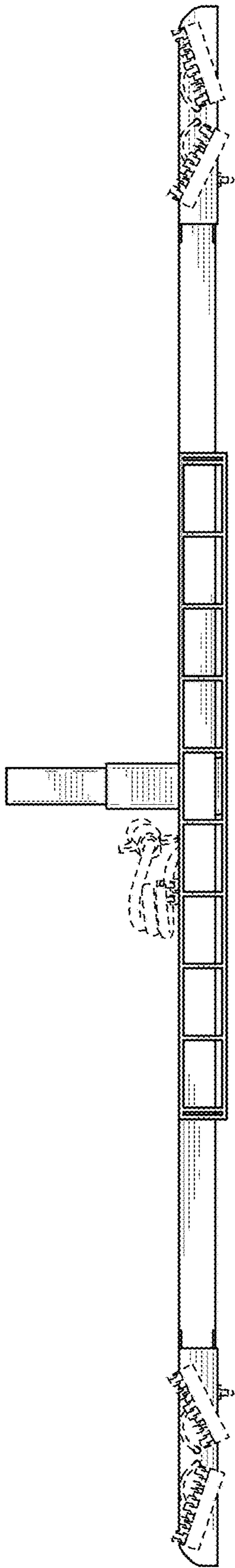

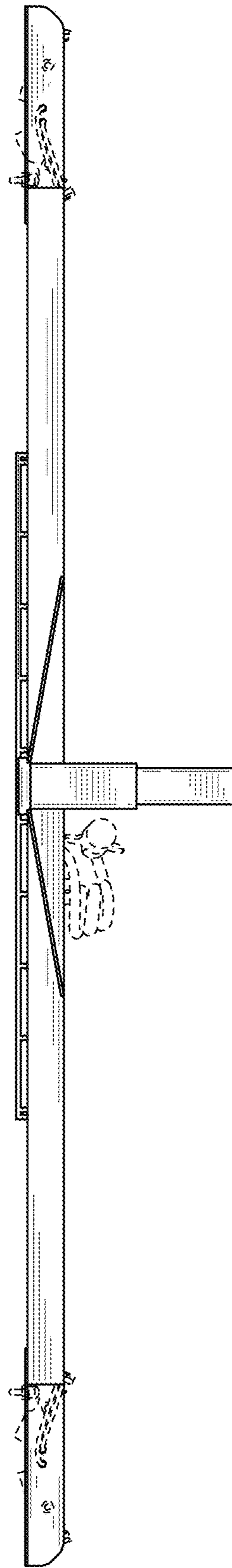

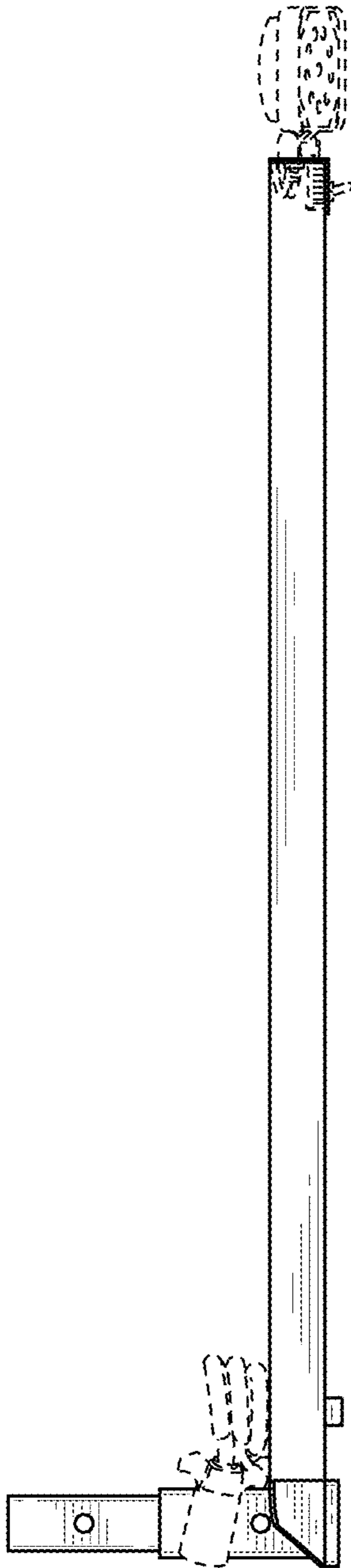

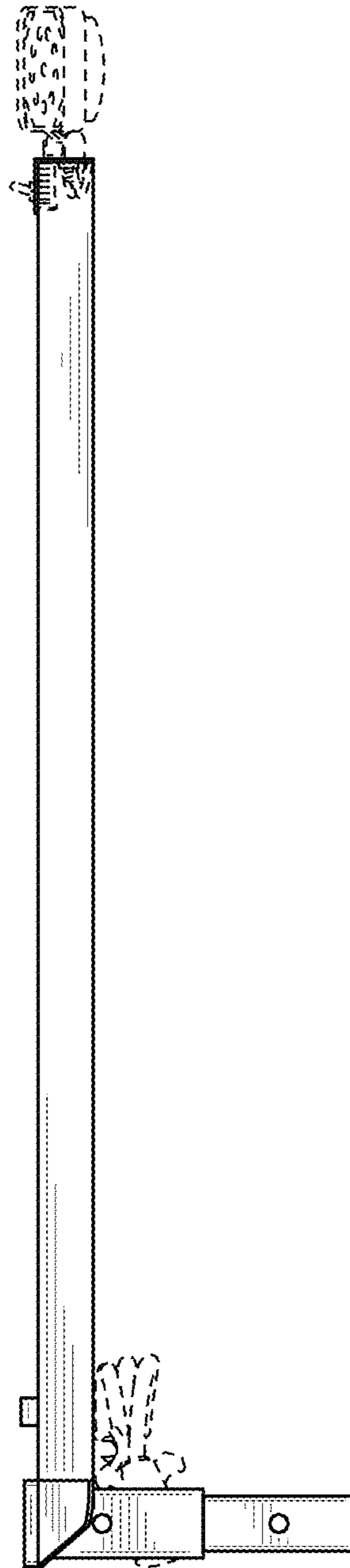
