(57) **CLAIM**

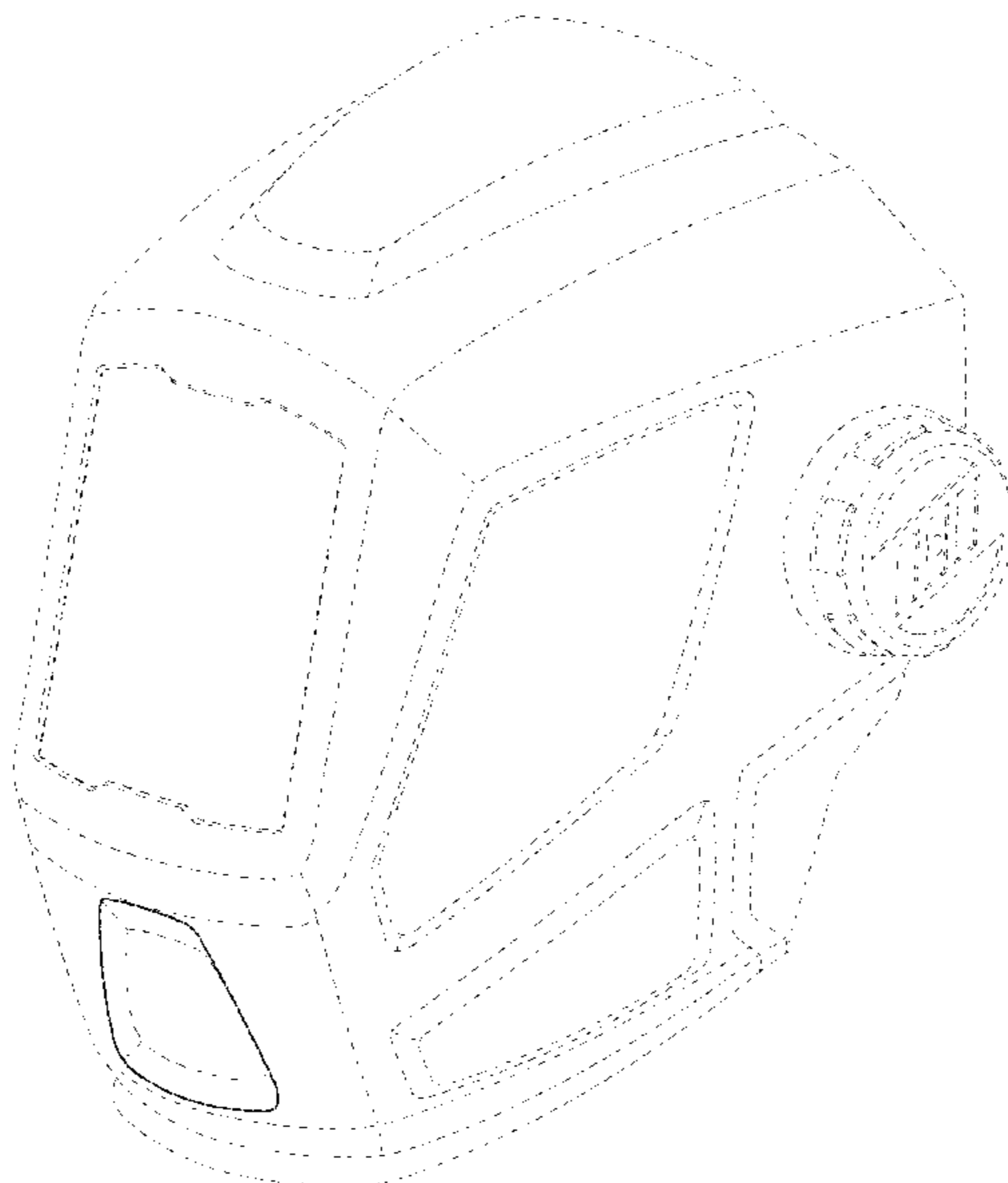
We claim the ornamental design for a protective helmet, as shown and described.

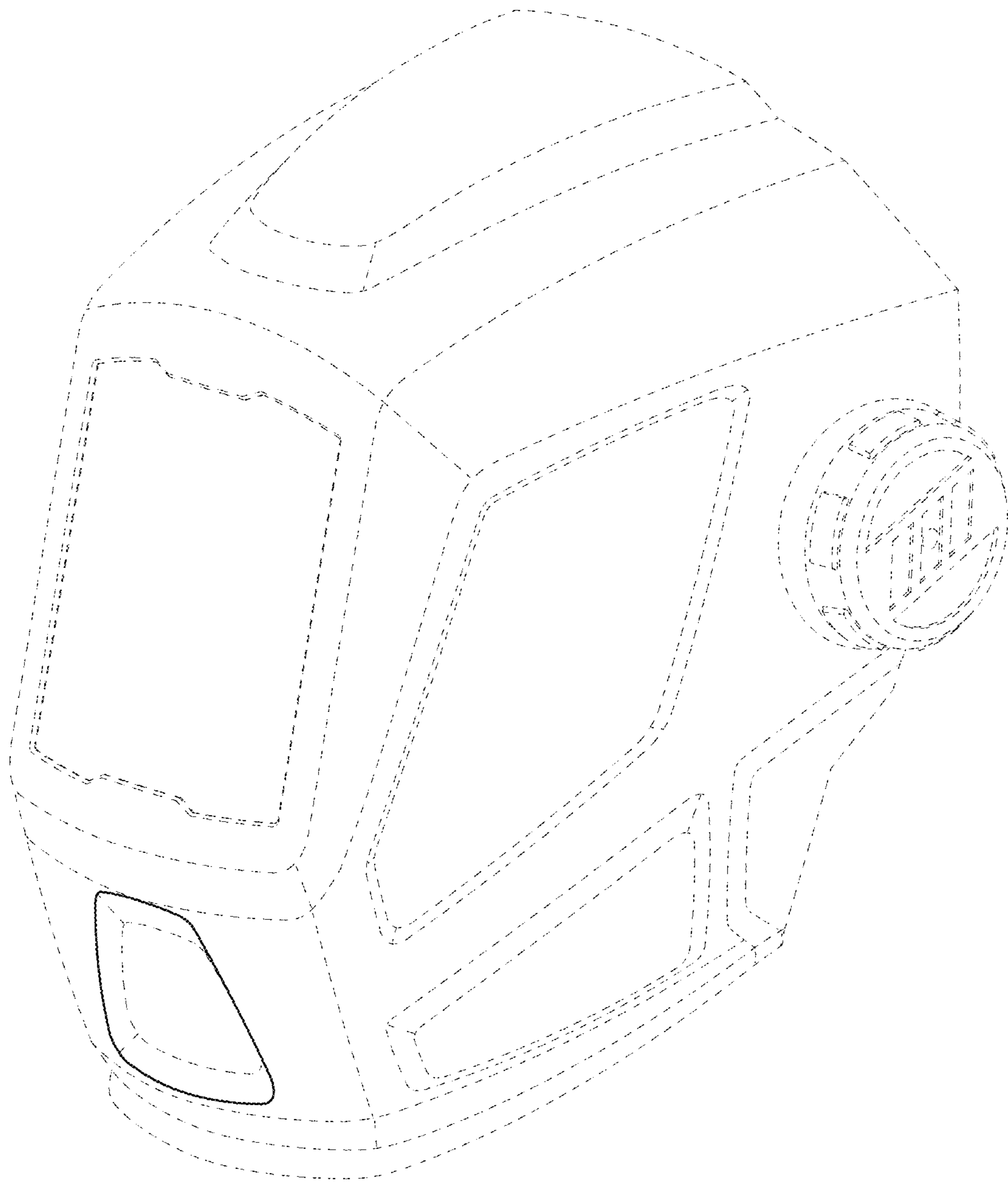

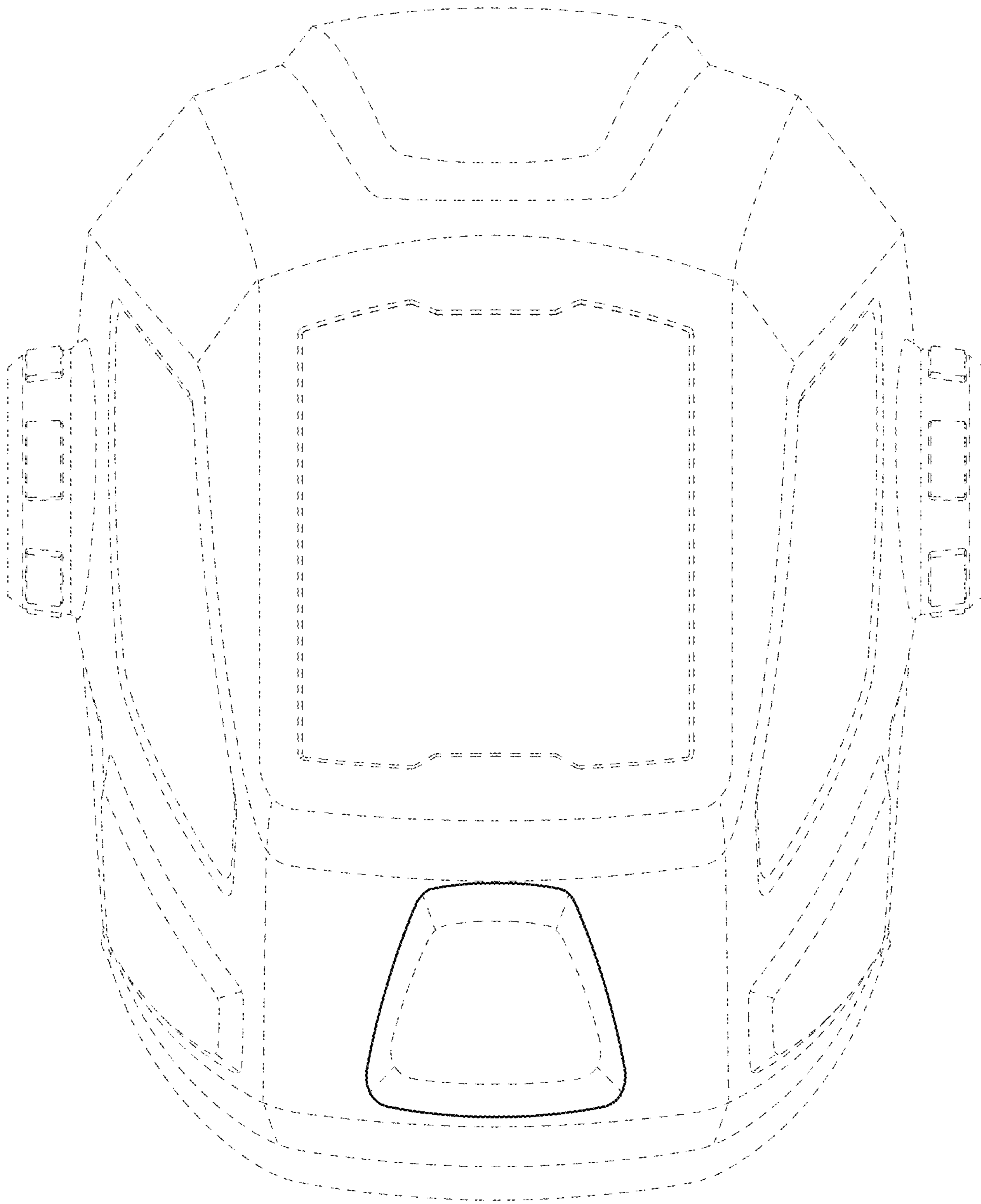

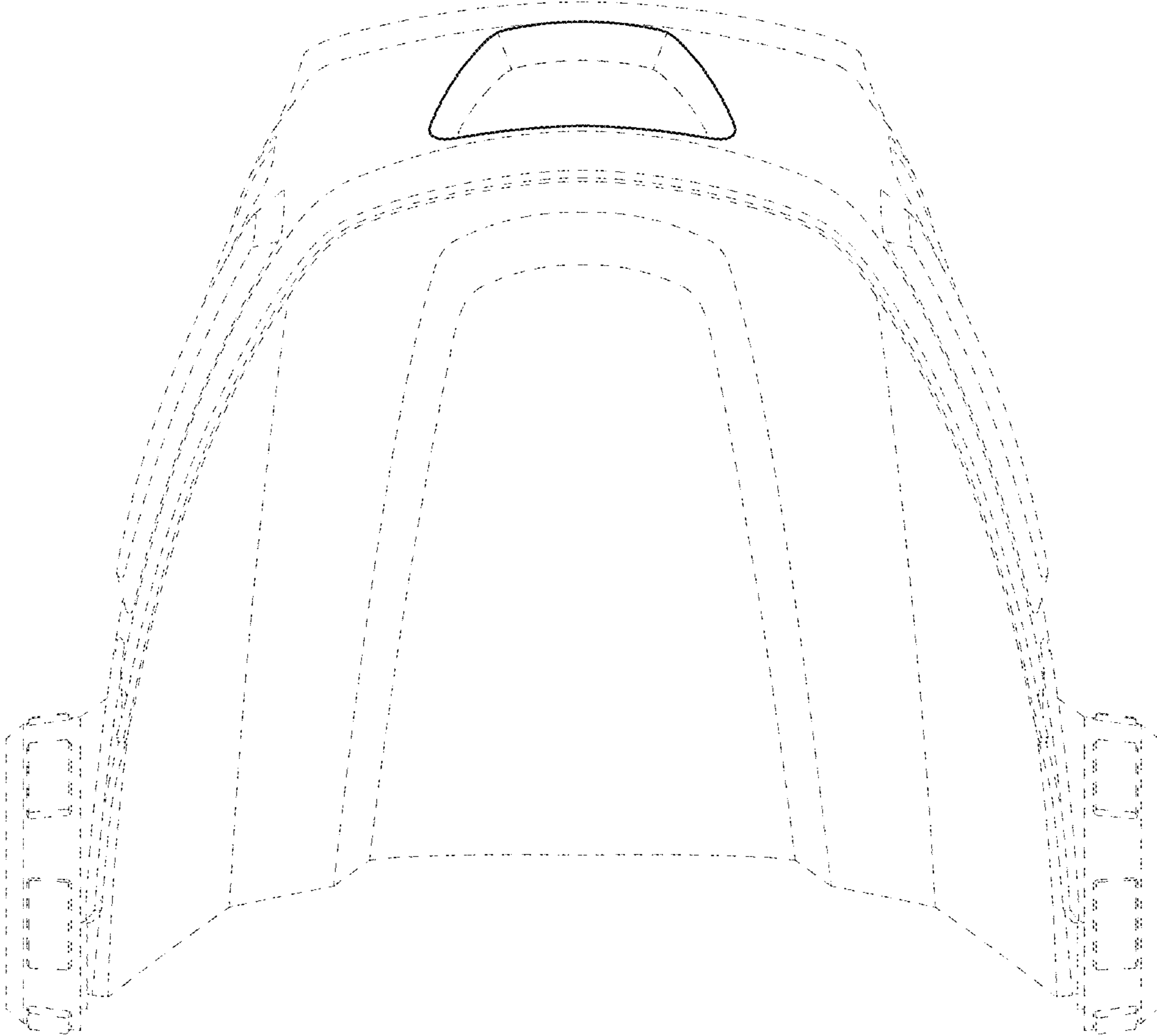
