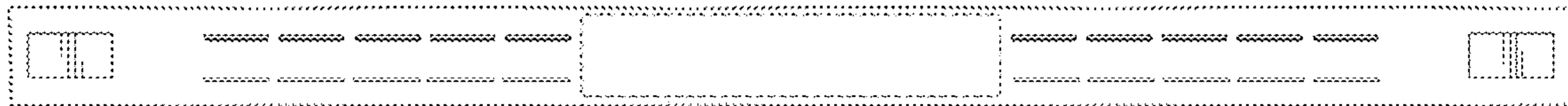
(57) **CLAIM**

The ornamental design for a dishwasher control panel, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a dishwasher control panel according to our new ornamental design; and, FIG. 2 is a front perspective view thereof. The broken lines of the dishwasher, dishwasher compartment and/or components thereof show surrounding structure or environment and do not form part of the claimed design. The bottom and rear parts of the dishwasher door, and the bottom, rear and top of the dishwasher compartment are unornamented and form no part of the claimed design.

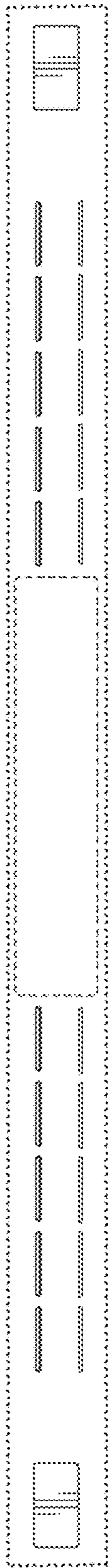

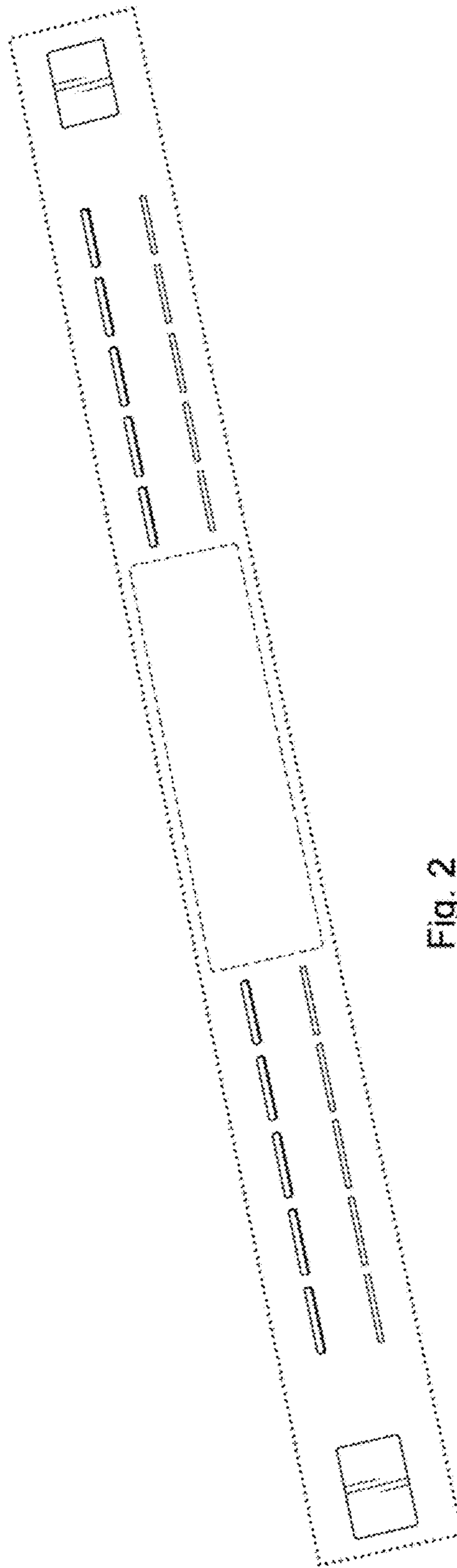
