The ornamental design for jeans, as shown.

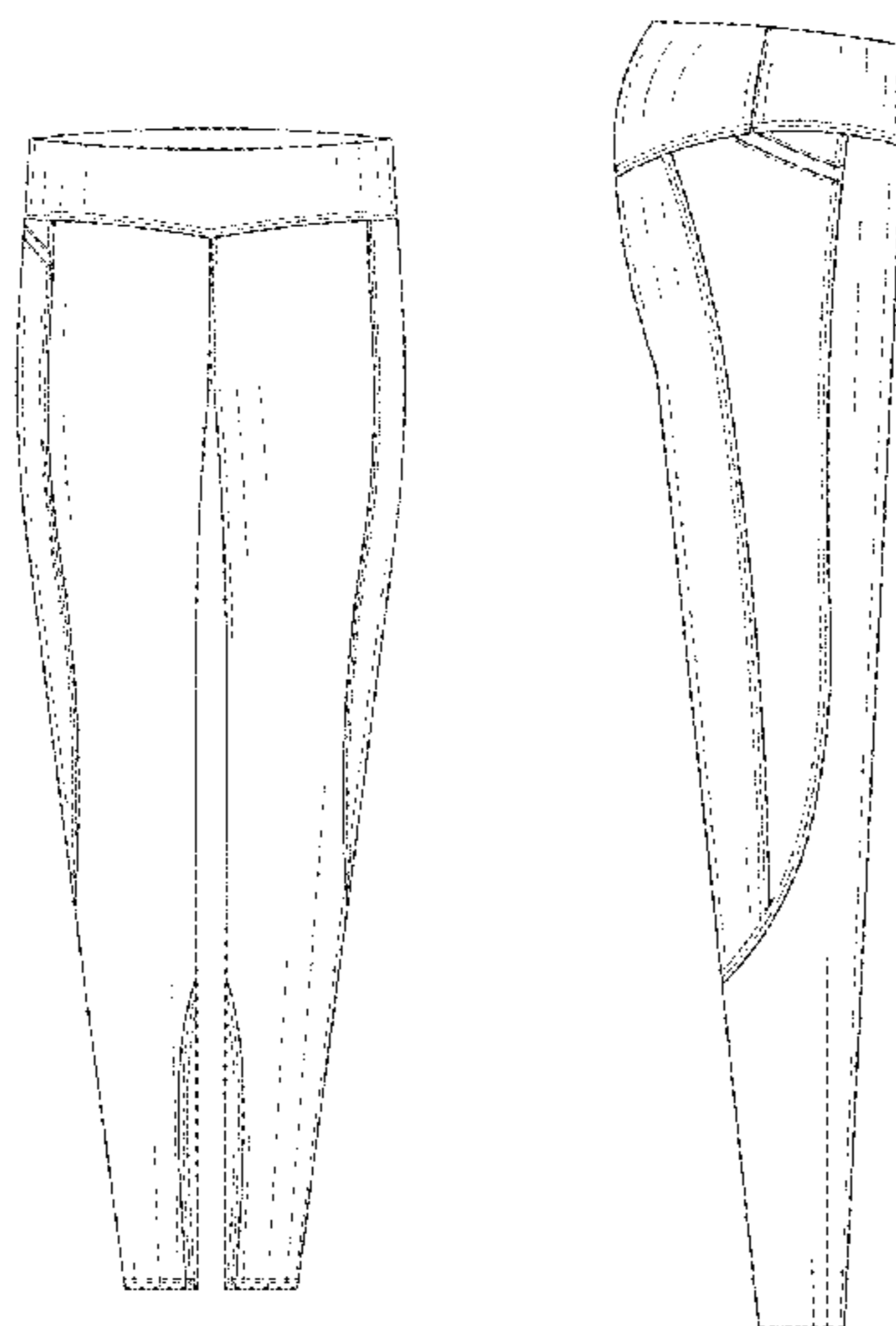
DESCRIPTION

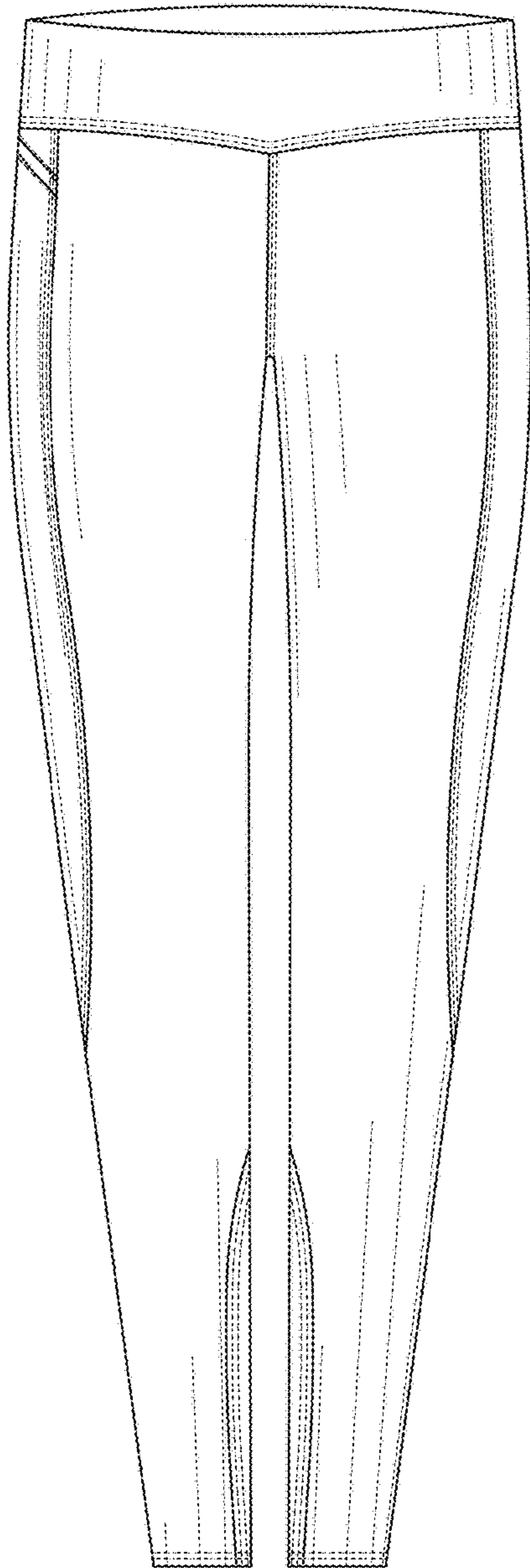

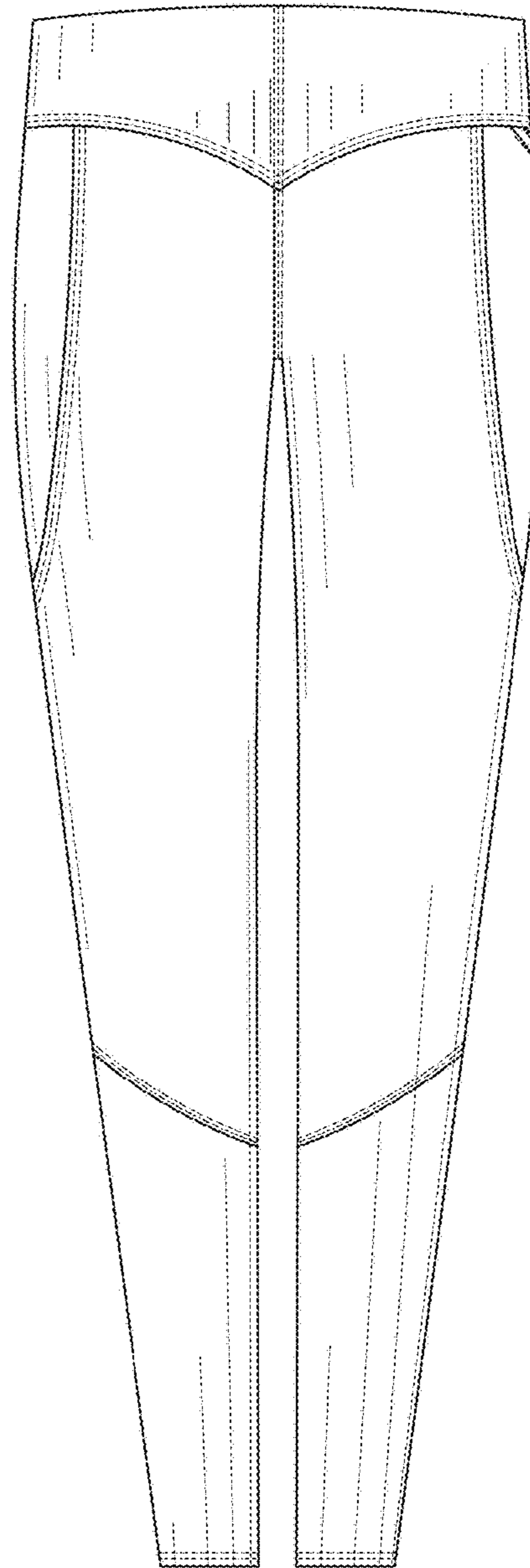

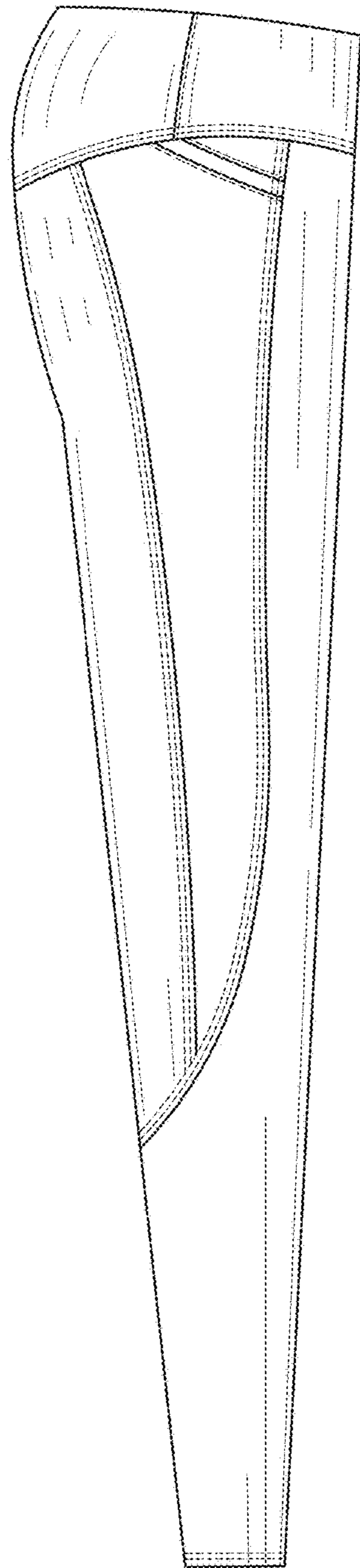

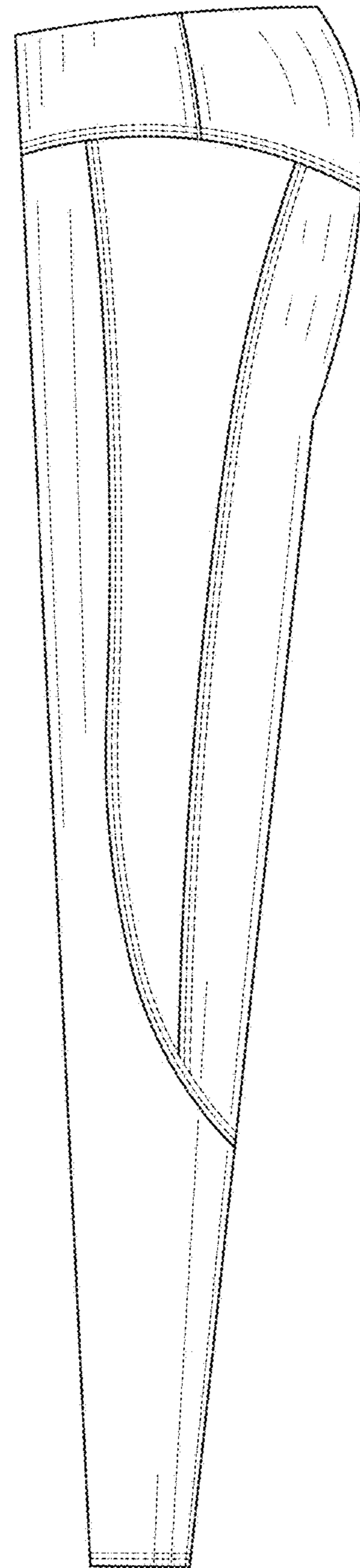
