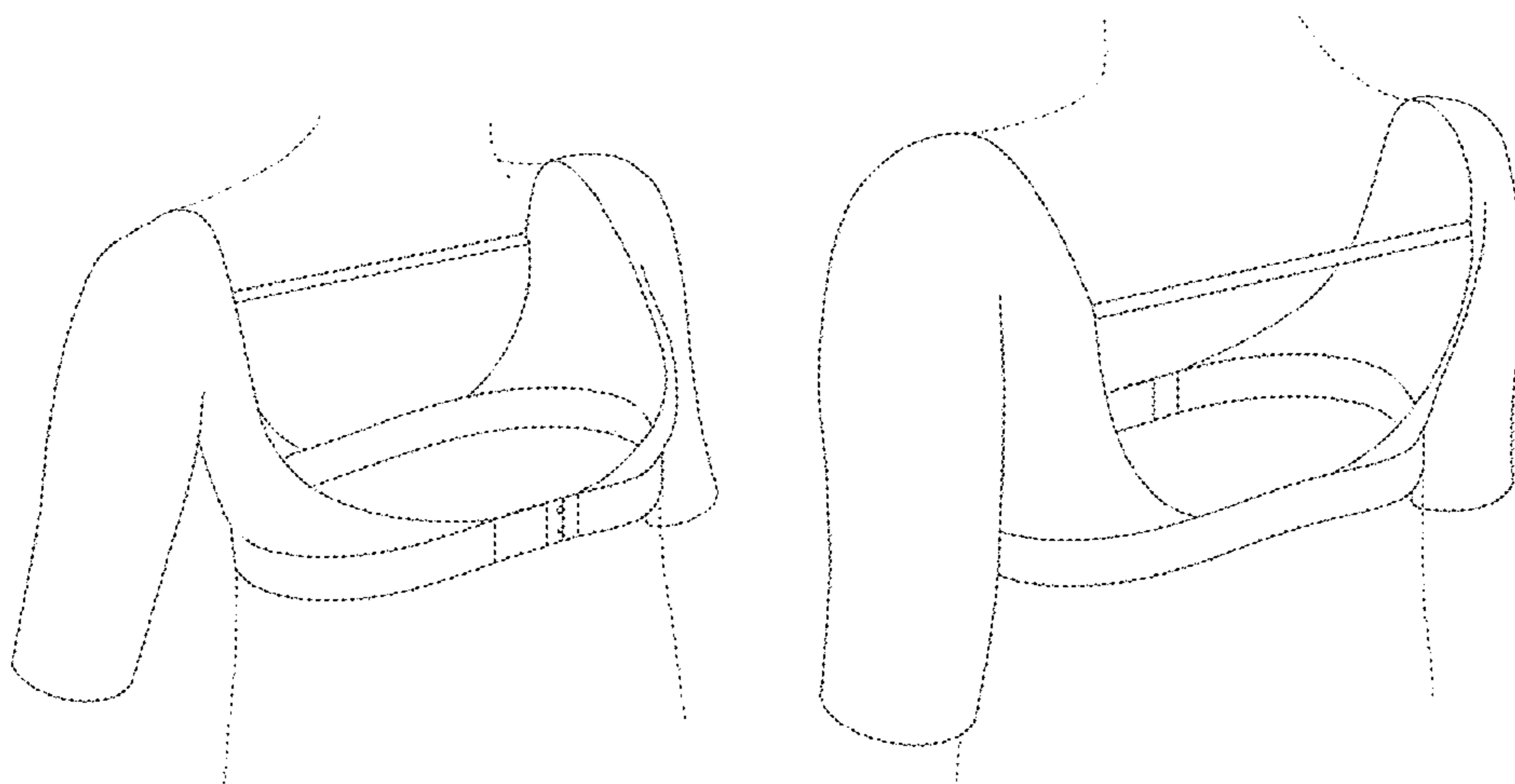
(57) **CLAIM**

The ornamental design for a short sleeve garment with back strap, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a short sleeve garment with back strap.
FIG. 2 is a back perspective view of a short sleeve garment with back strap.
FIG. 3 is a front elevation view of a short sleeve garment with back strap.
FIG. 4 is a back elevation view of a short sleeve garment with back strap.
FIG. 5 is a left side view of a short sleeve garment with back strap; and,
FIG. 6 is a right side view of a short sleeve garment with back strap.

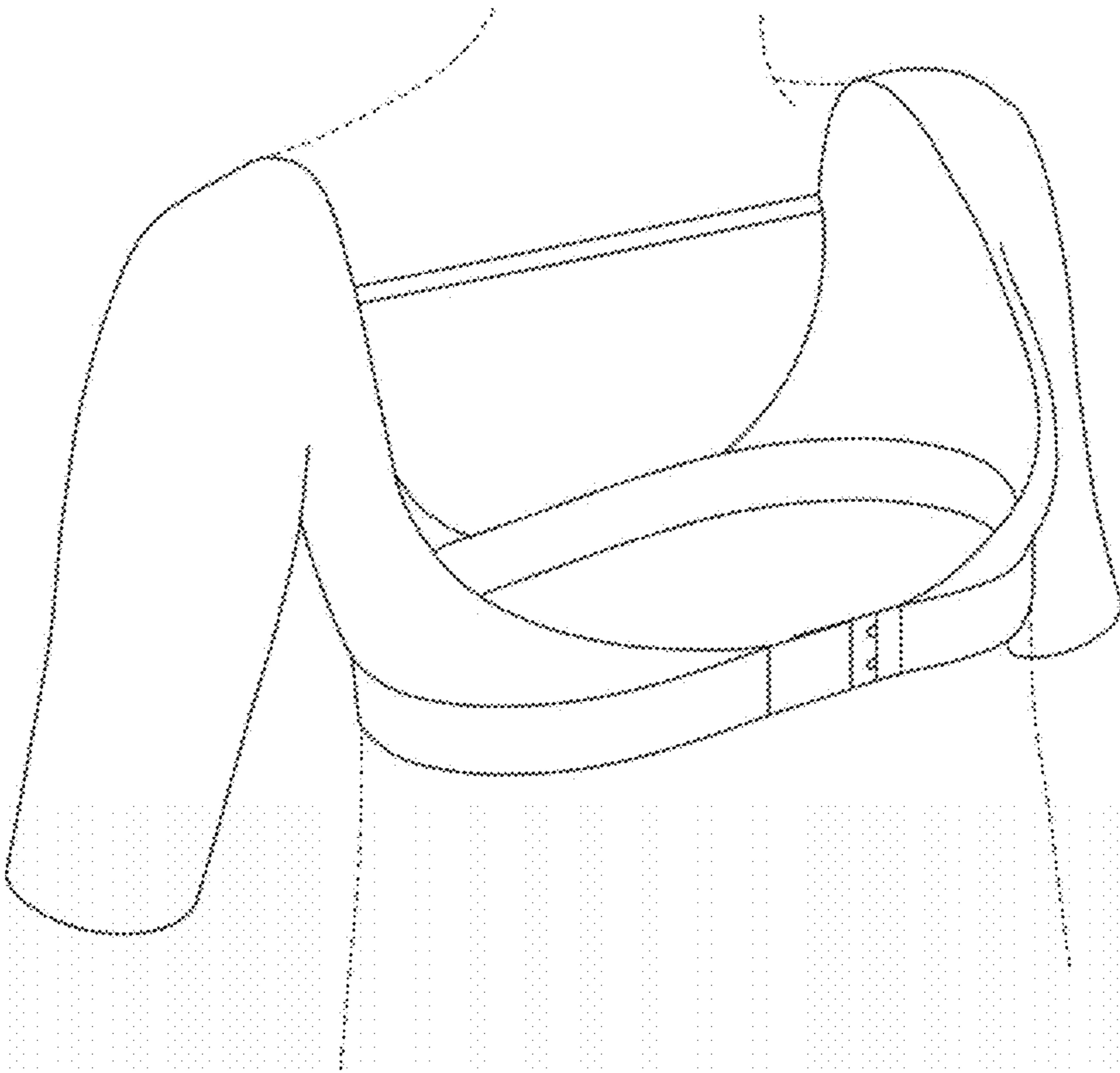

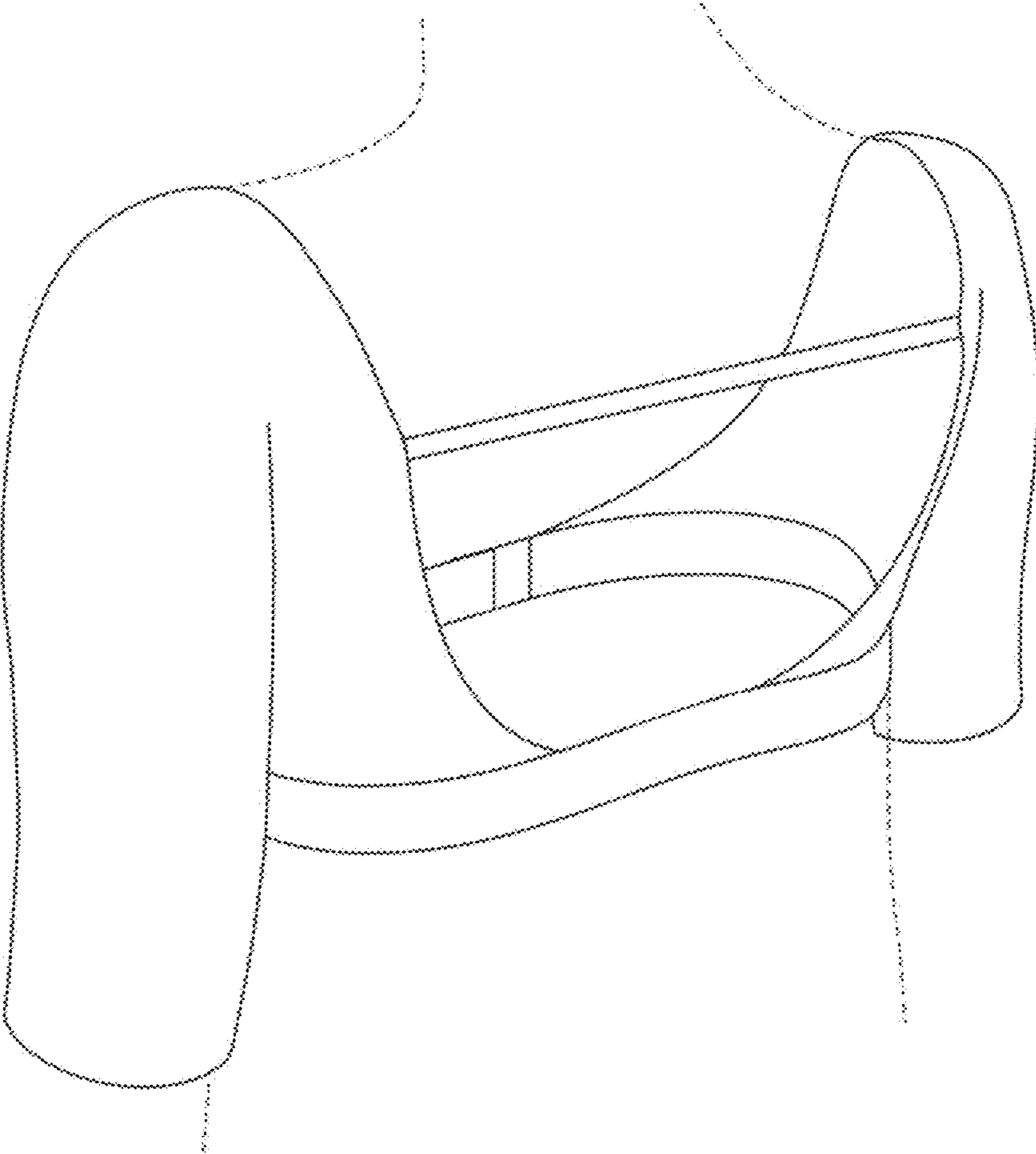

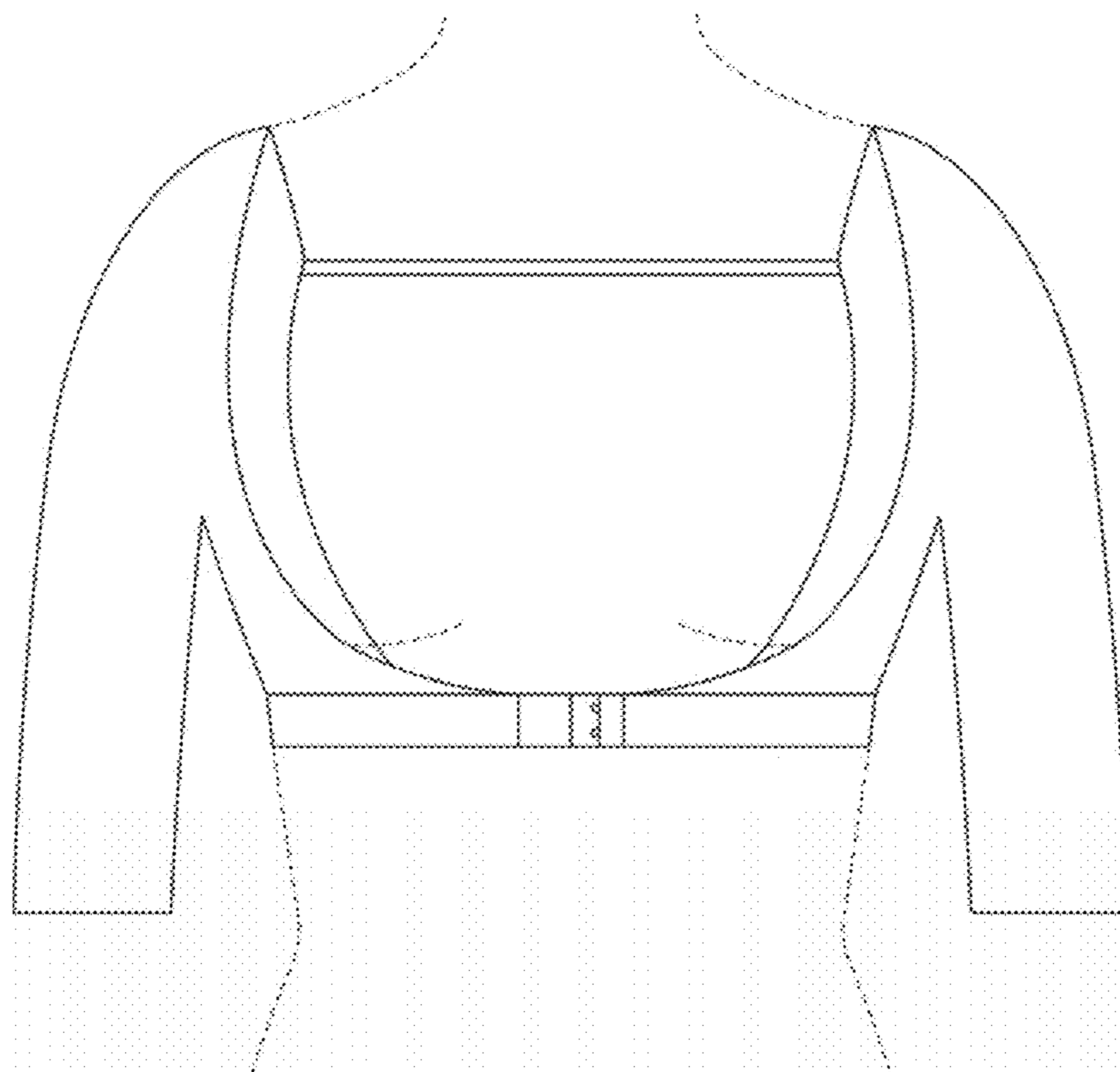

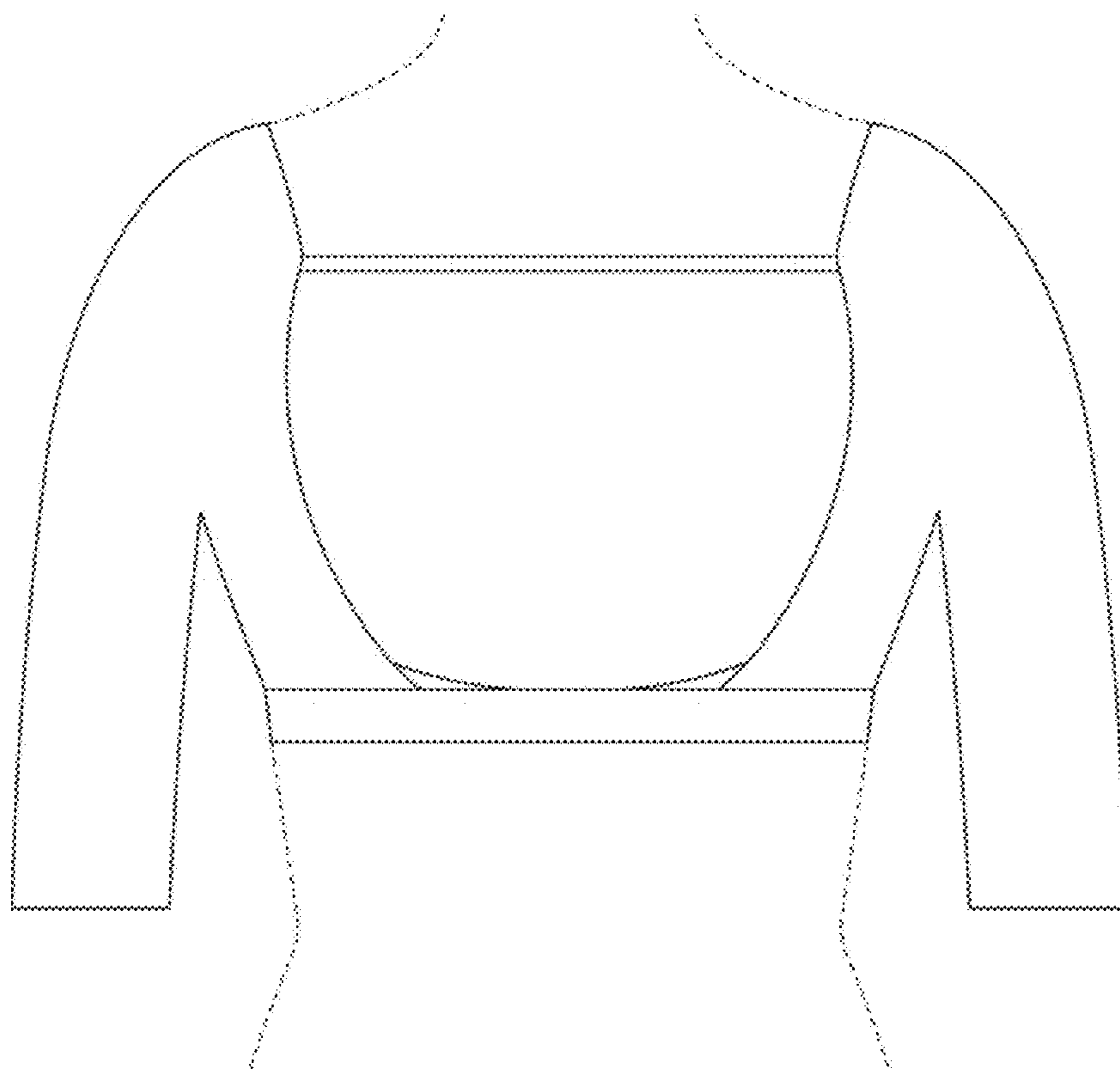

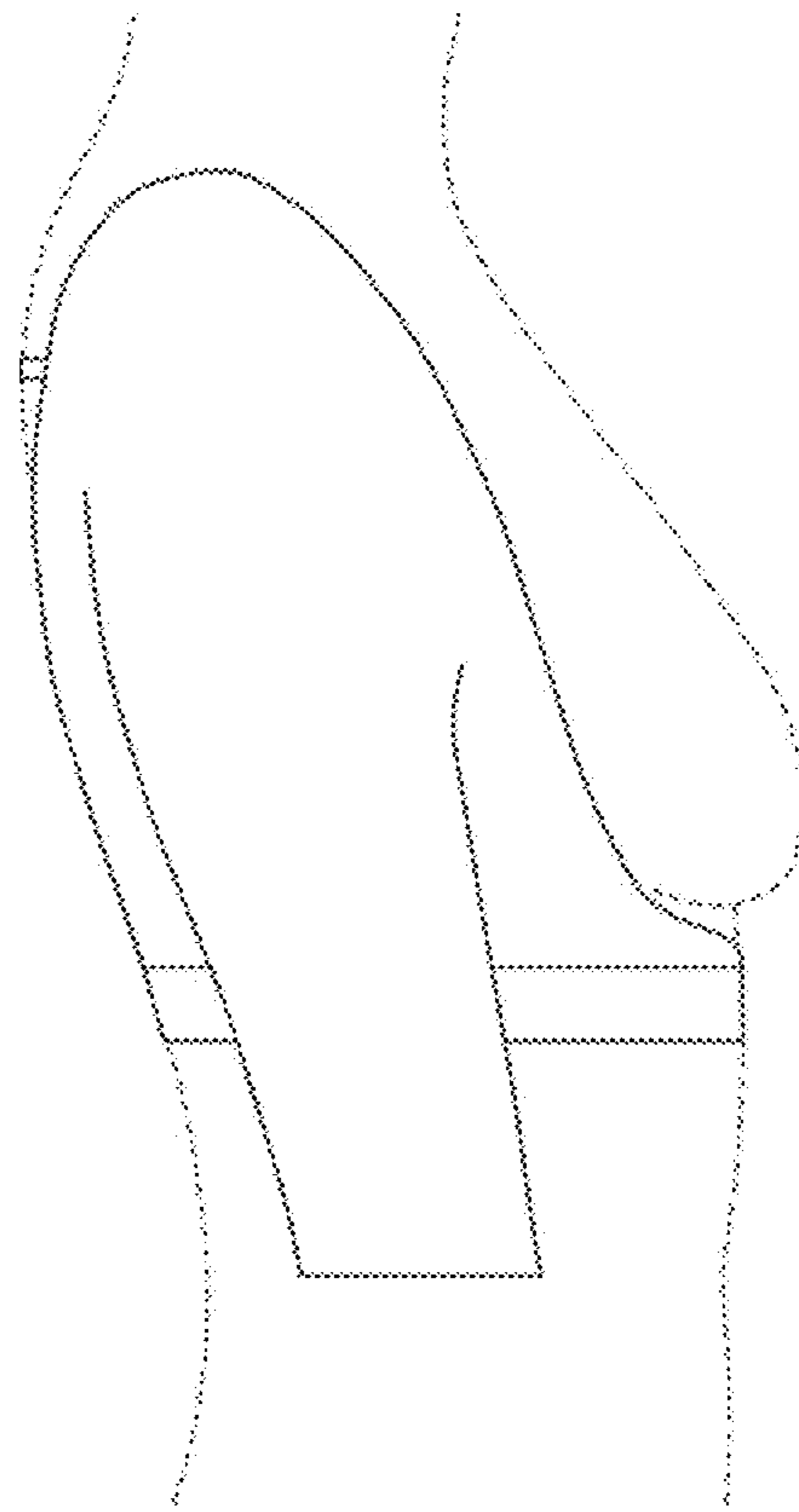

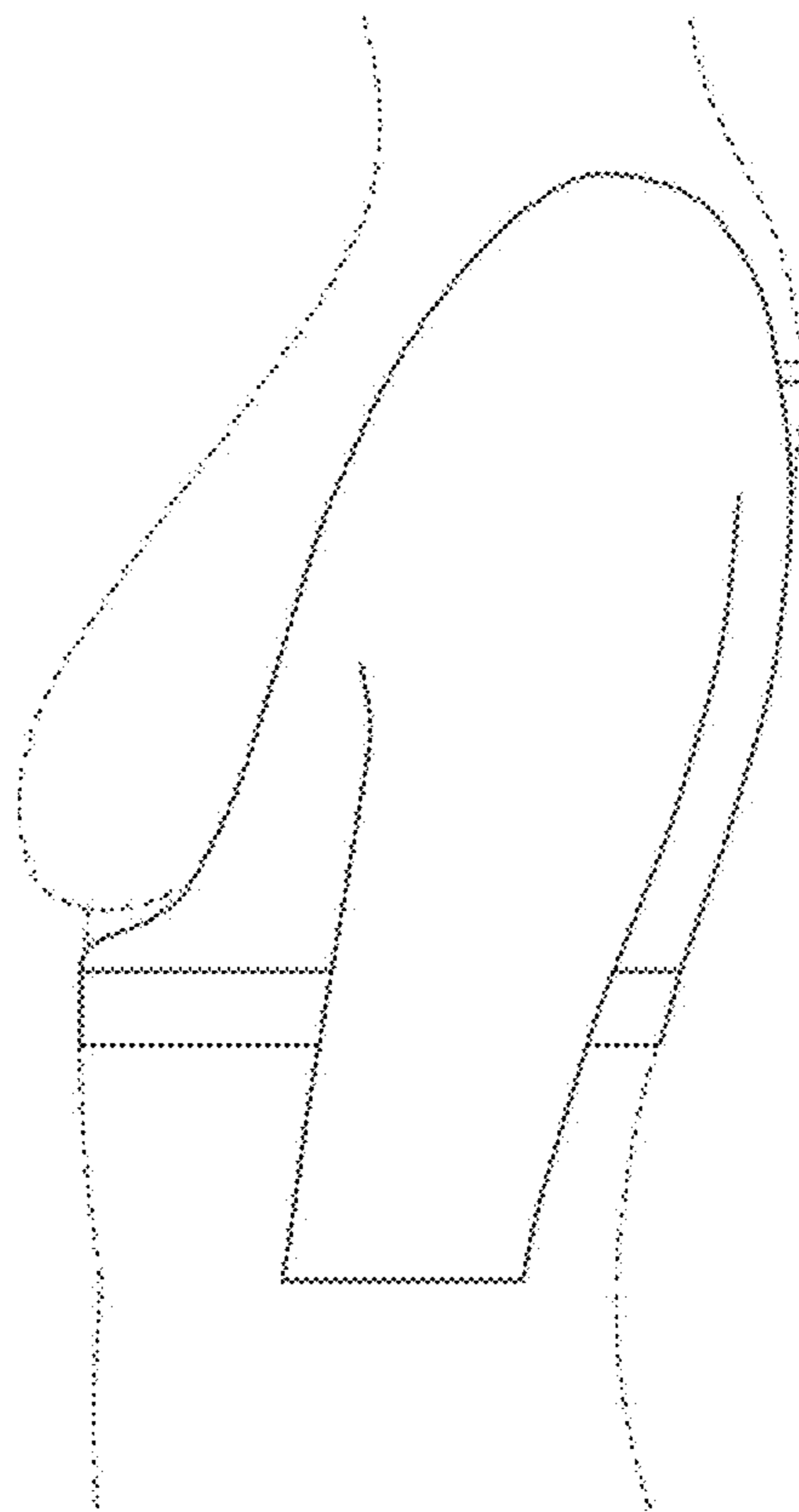
