(57) **CLAIM**


The ornamental design for a garment bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom, front, left side perspective view of a garment bag showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

The broken lines within the solid line boundaries shown in FIGS. 1-2 and 4-7 represent stitching that forms no part of the claimed design. The dash-dot-dash broken lines shown in FIGS. 1-2, 4-6 and 7 define boundaries of the claimed design and form no part thereof.














