**DESCRIPTION**

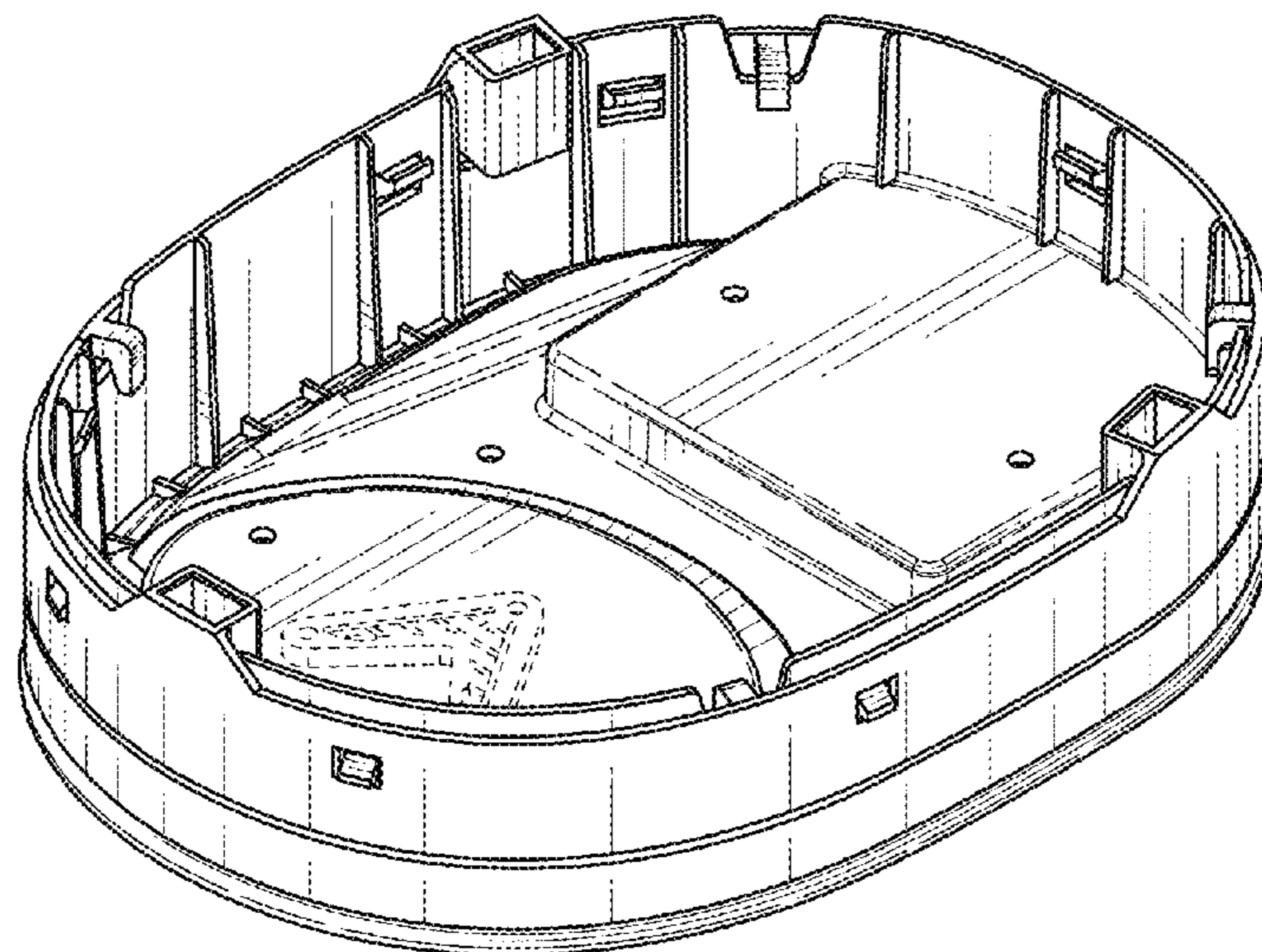
FIG. 1 is a top perspective view the golf bag base claimed herein;

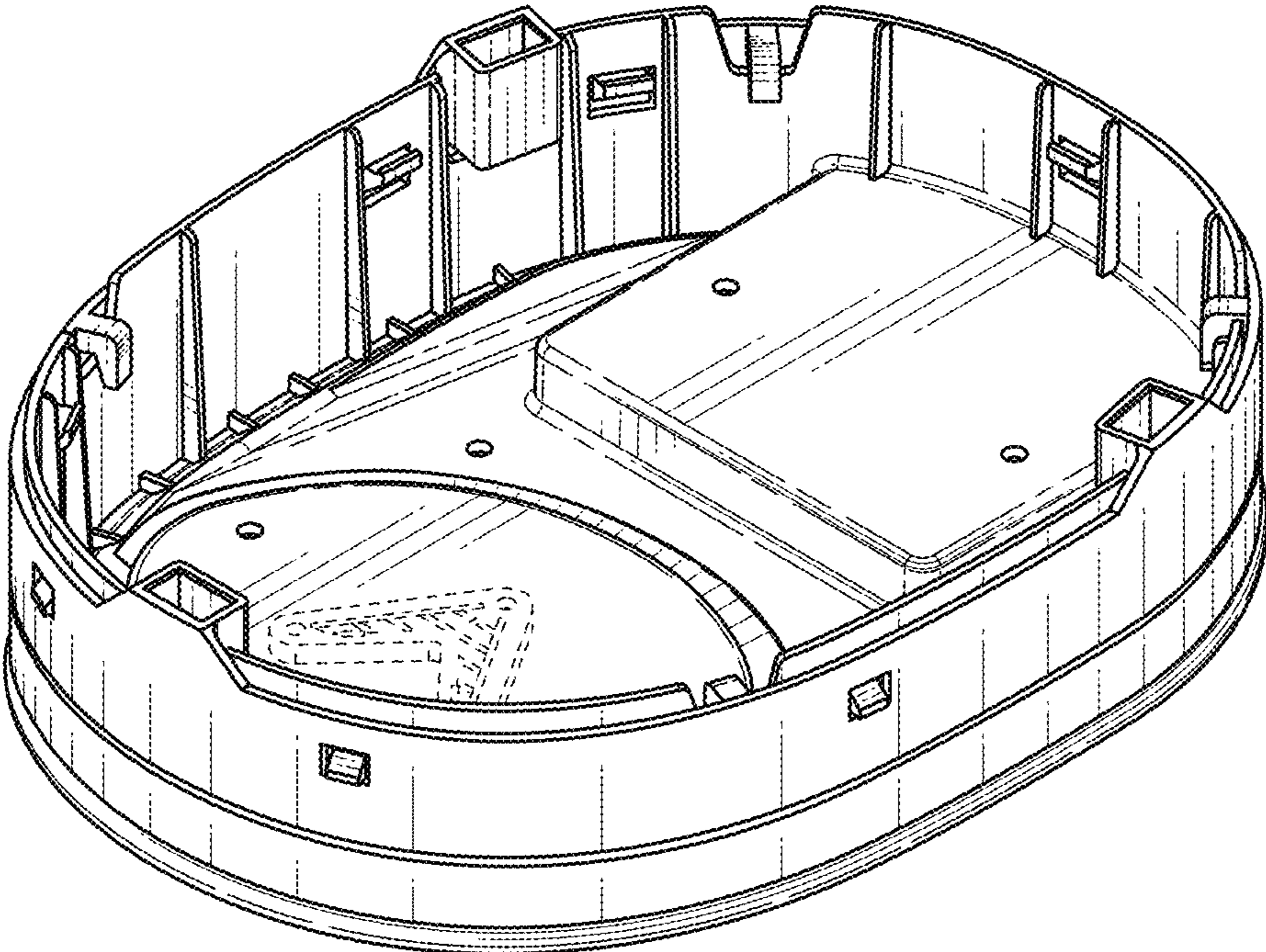

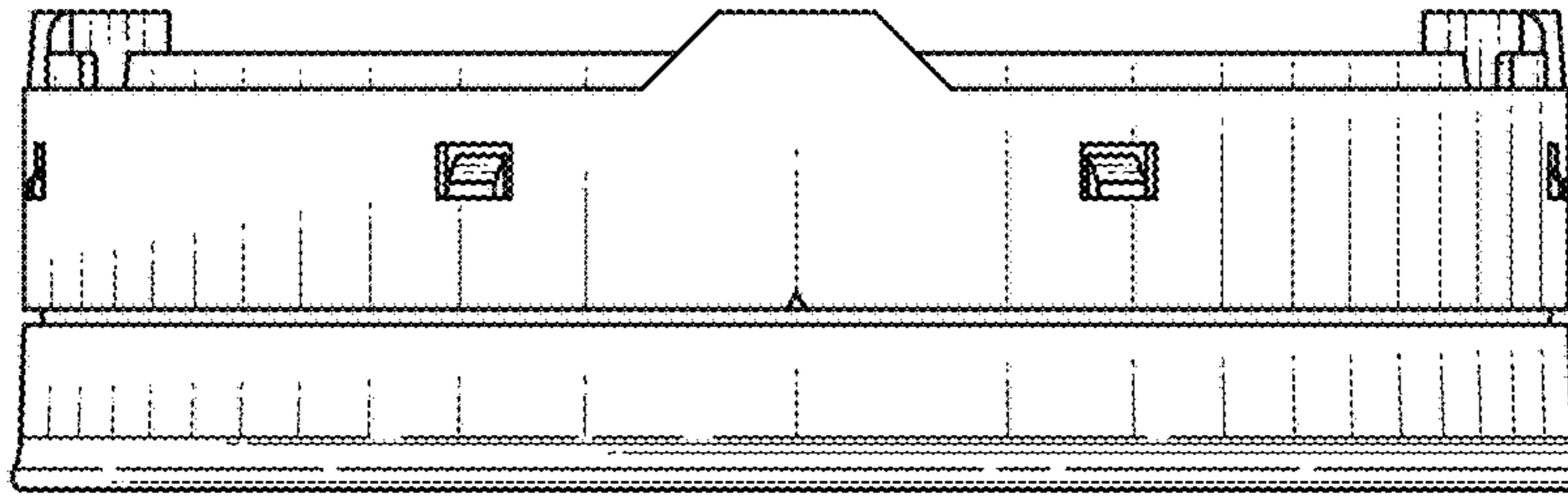

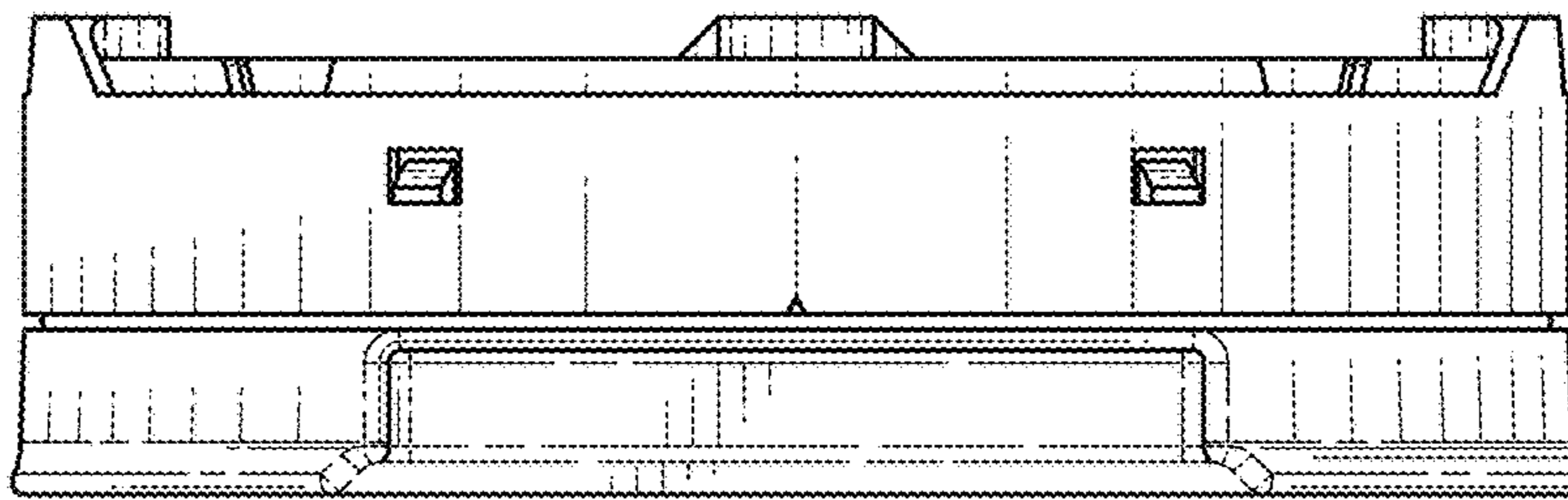

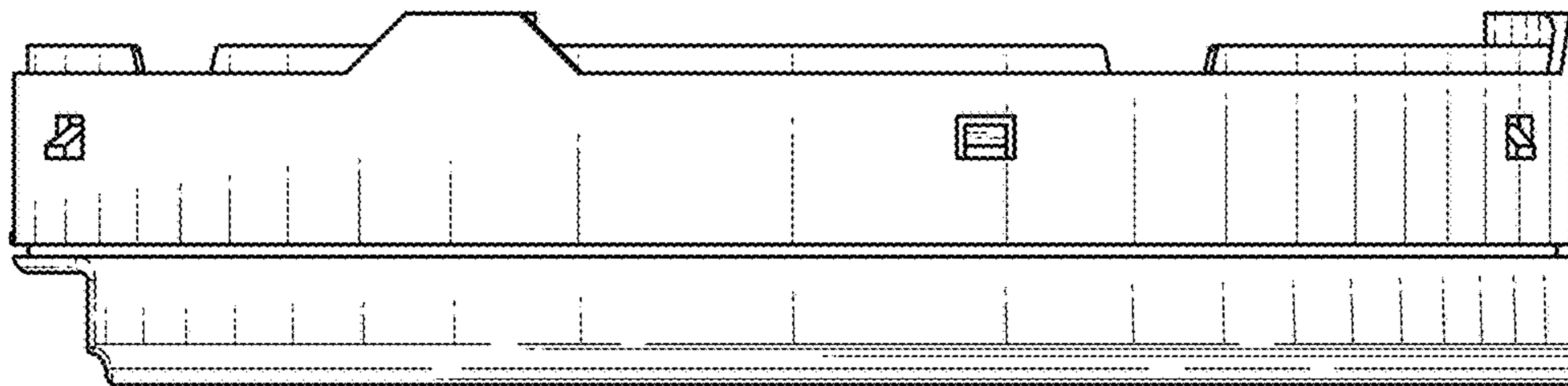

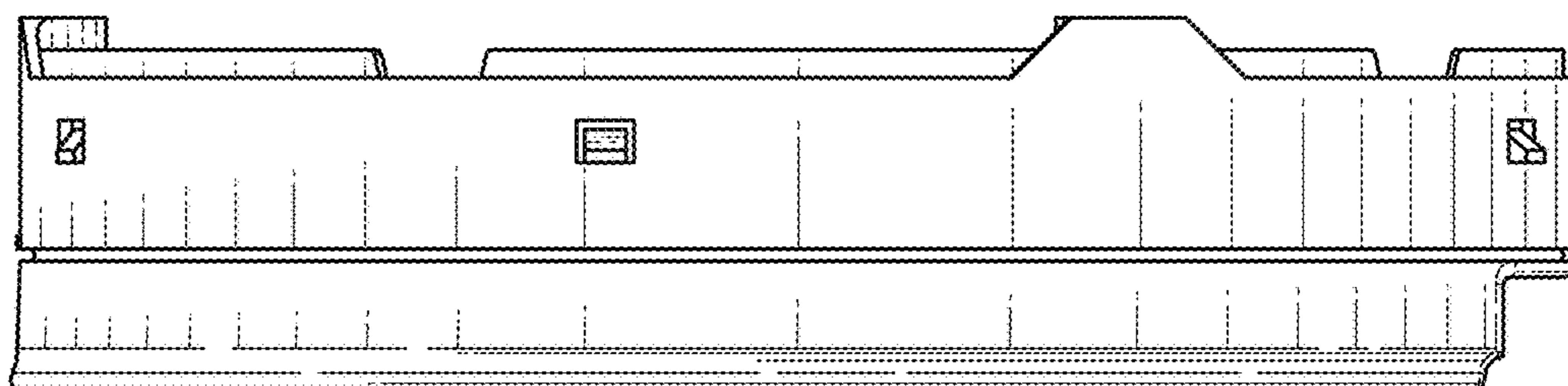

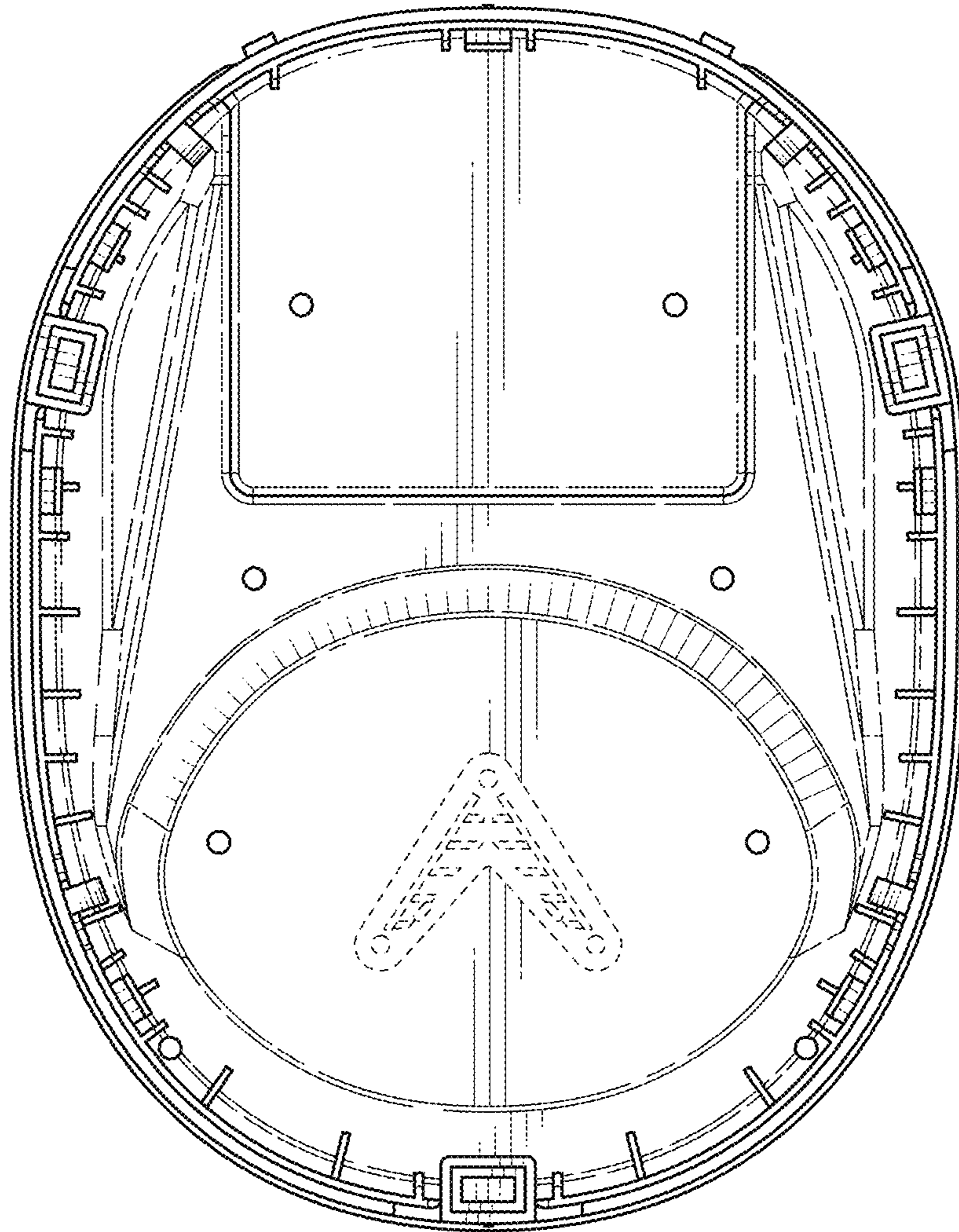

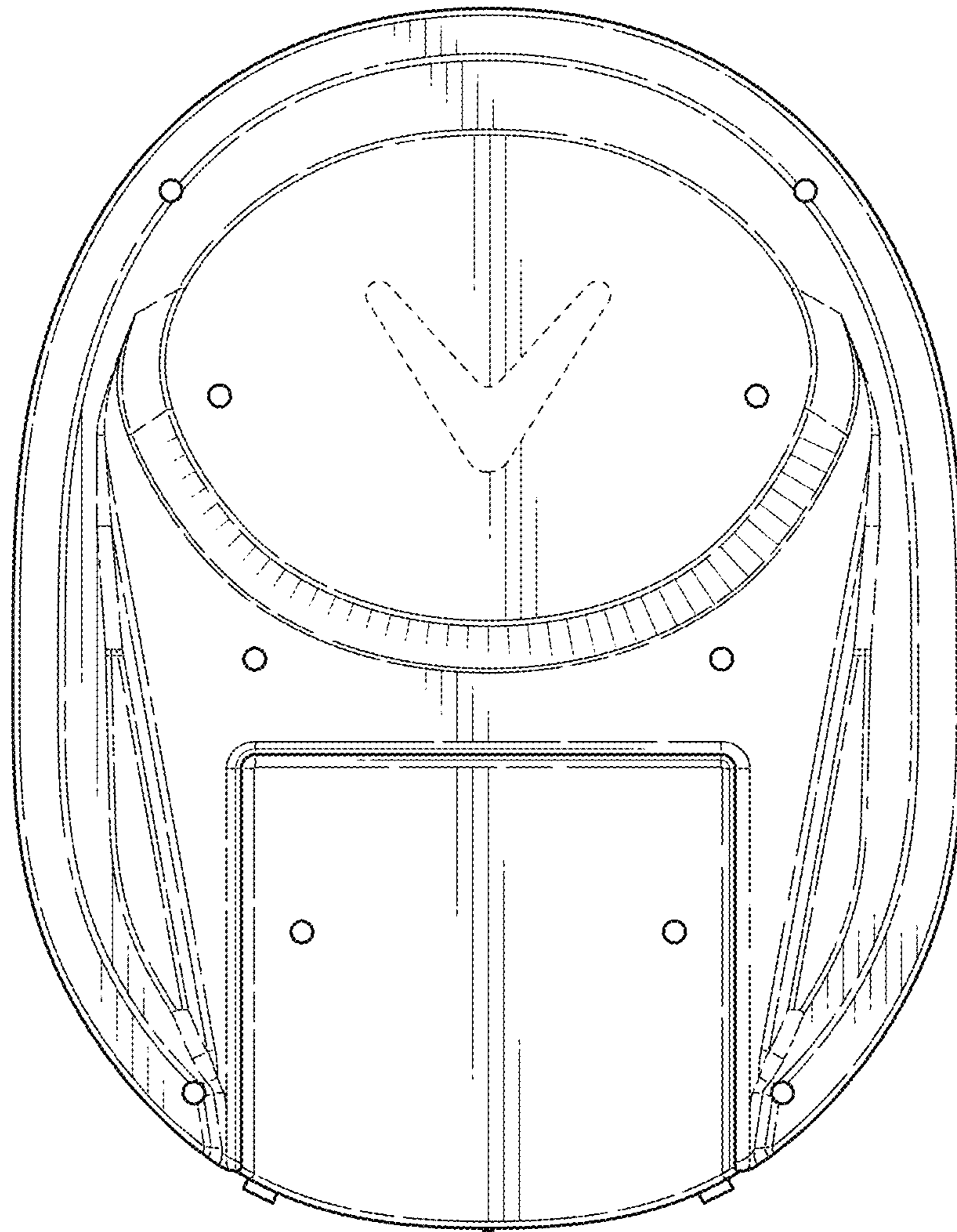
