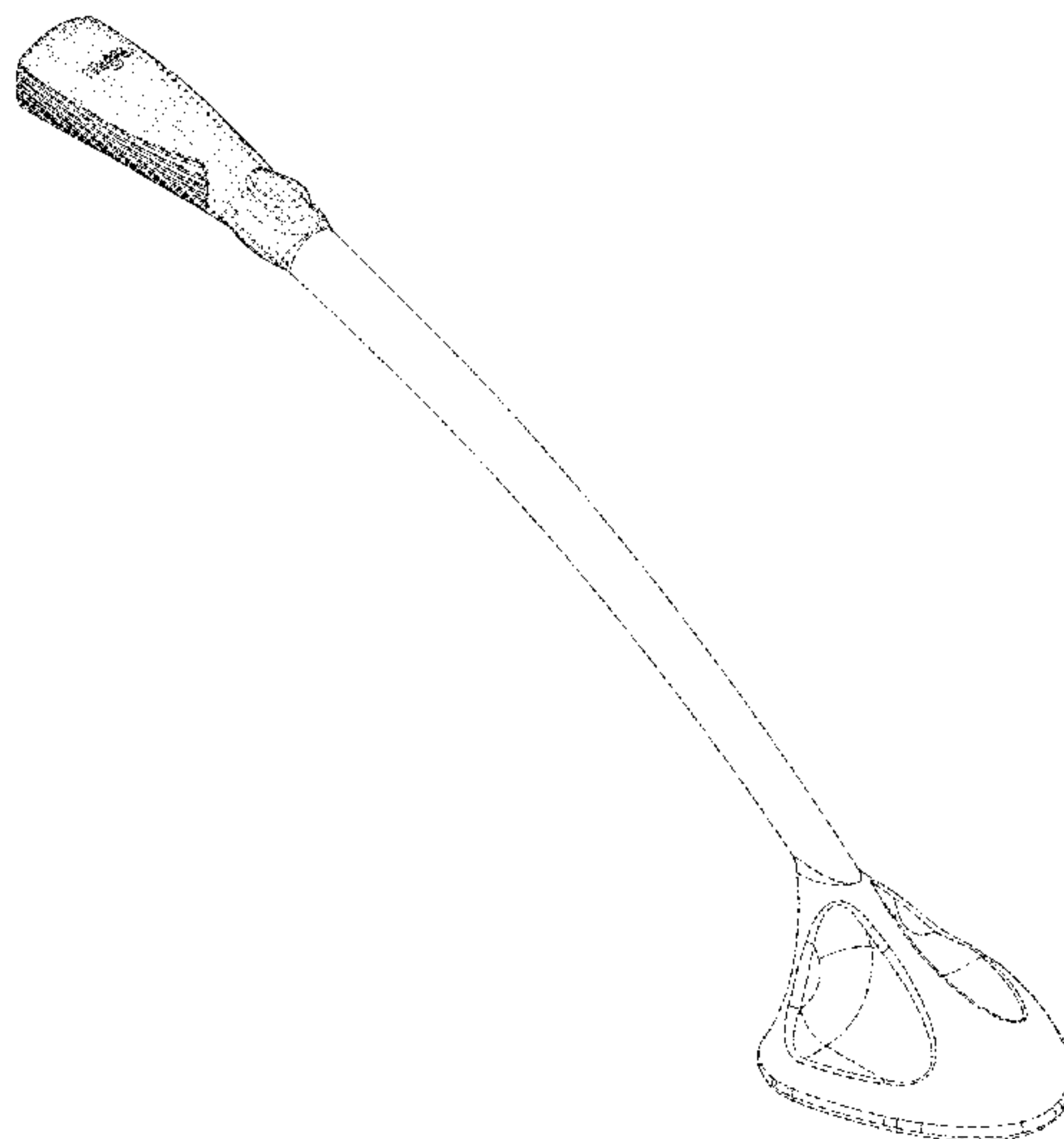
(57) **CLAIM**

The ornamental design for a brush handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a brush handle;  
FIG. 2 is a side elevation view thereof, the opposite side  
being a mirror image thereof;  
FIG. 3 is partially enlarged side elevation view thereof,  
taken from FIG. 2;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a rear view thereof; and,  
FIG. 7 is a front view thereof.  
The broken lines depicting a brush head and handle repre-  
sent unclaimed portions of the design.

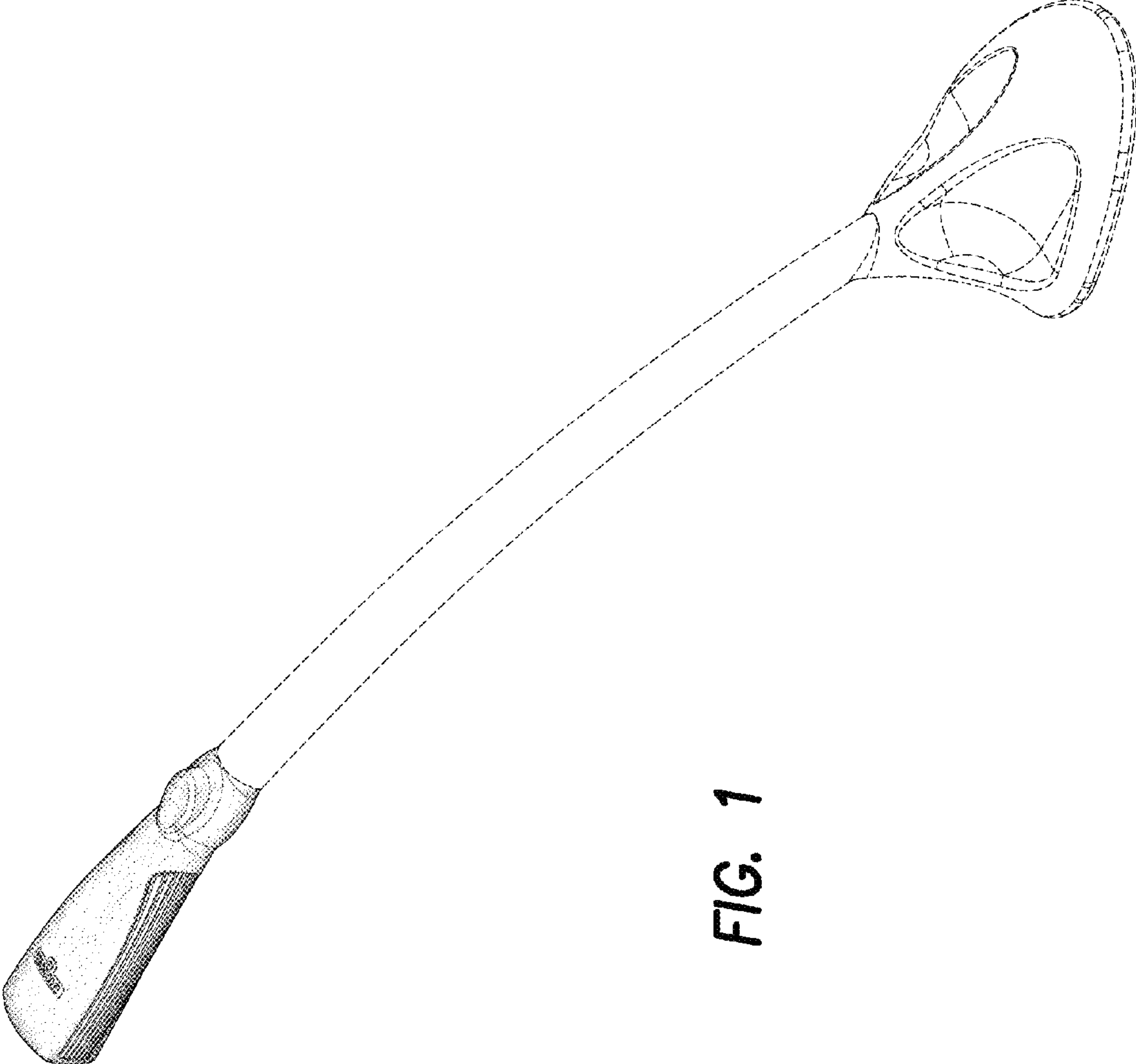

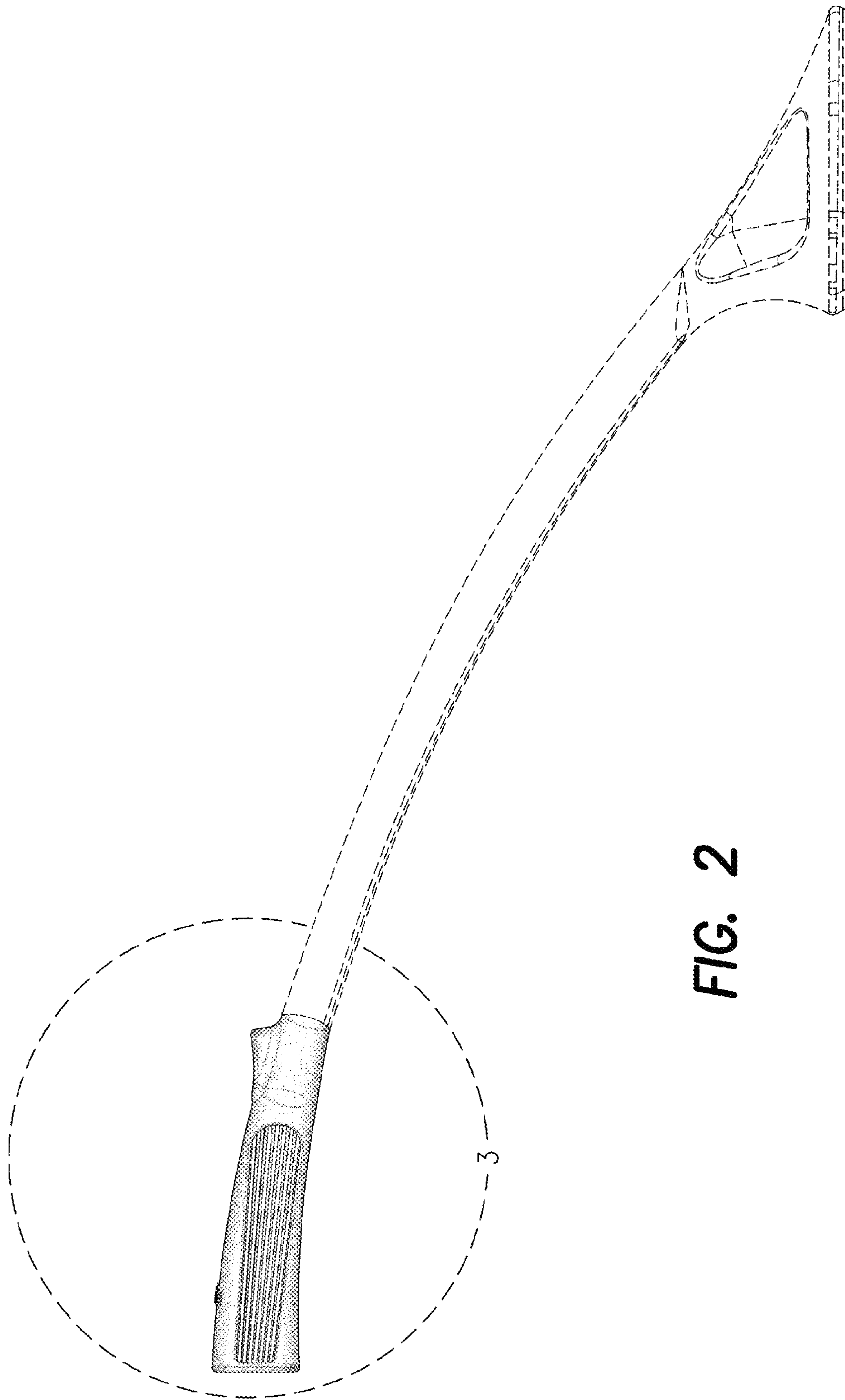
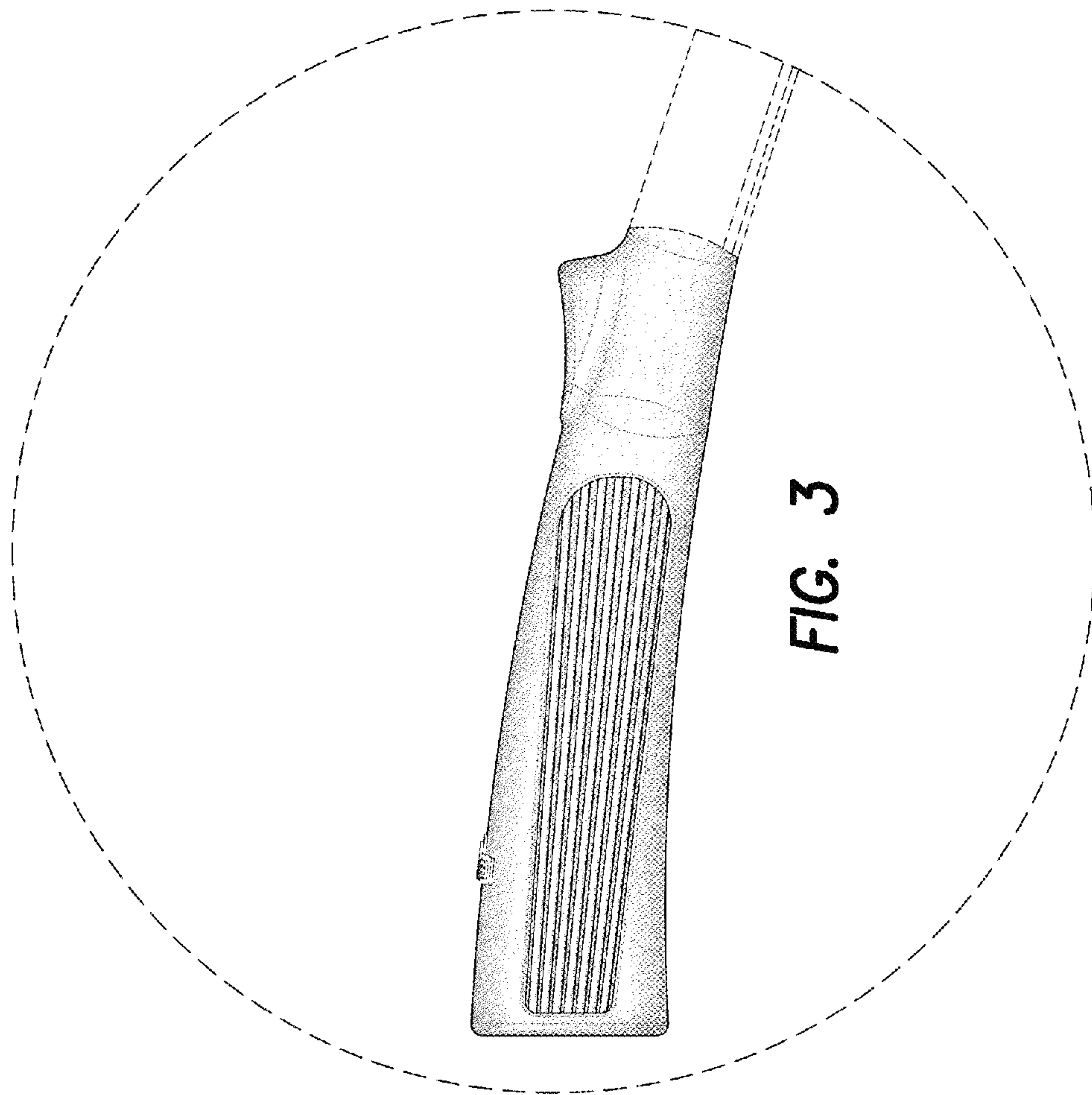

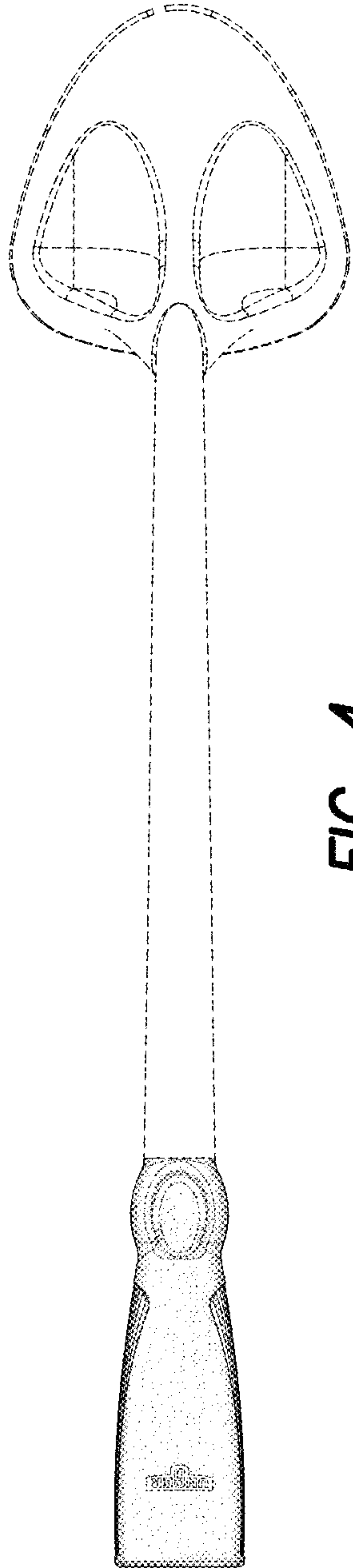

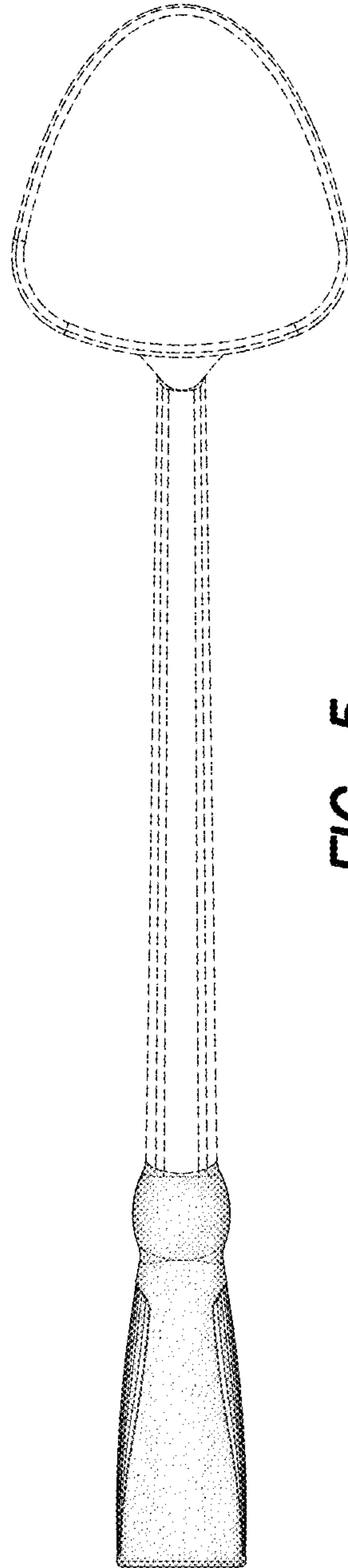
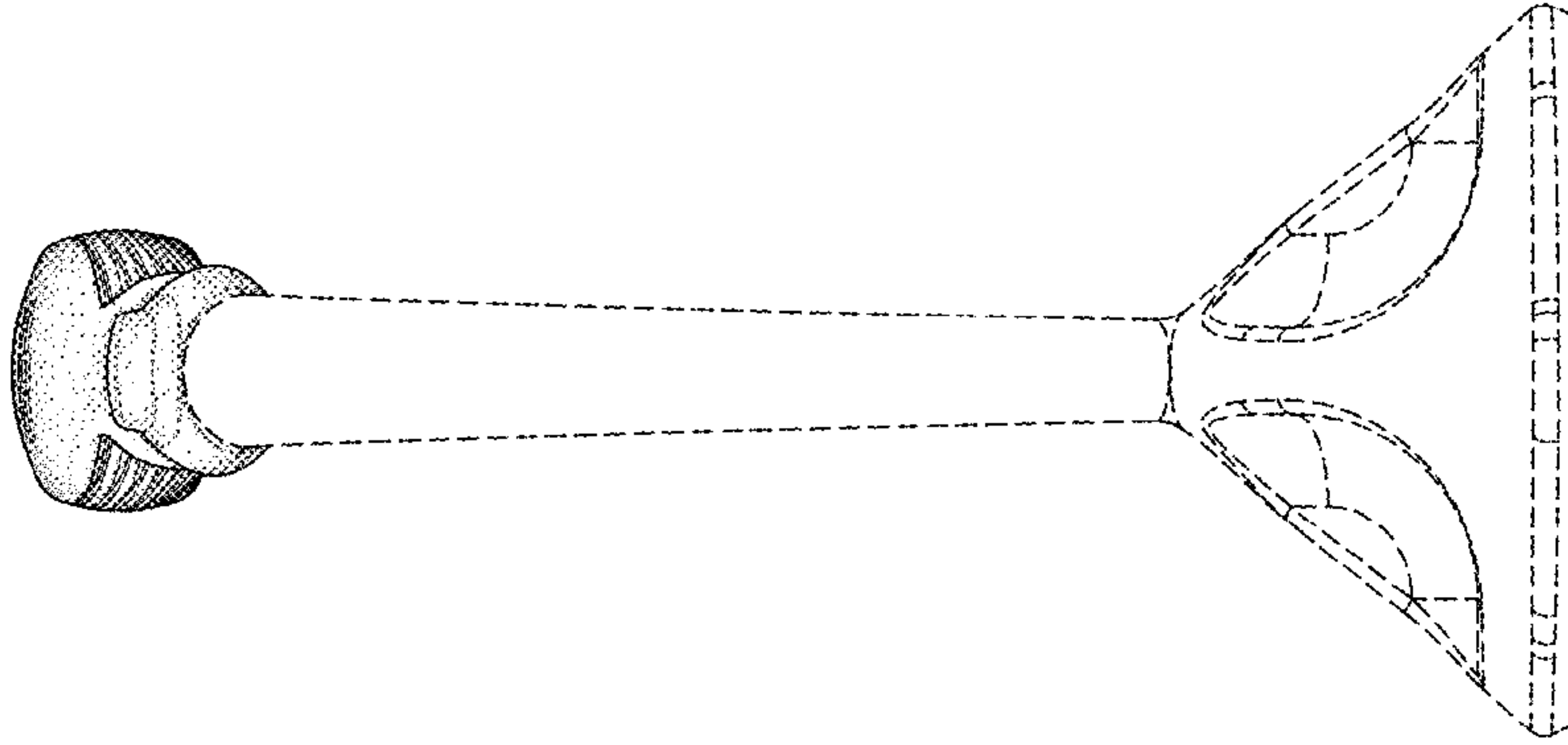
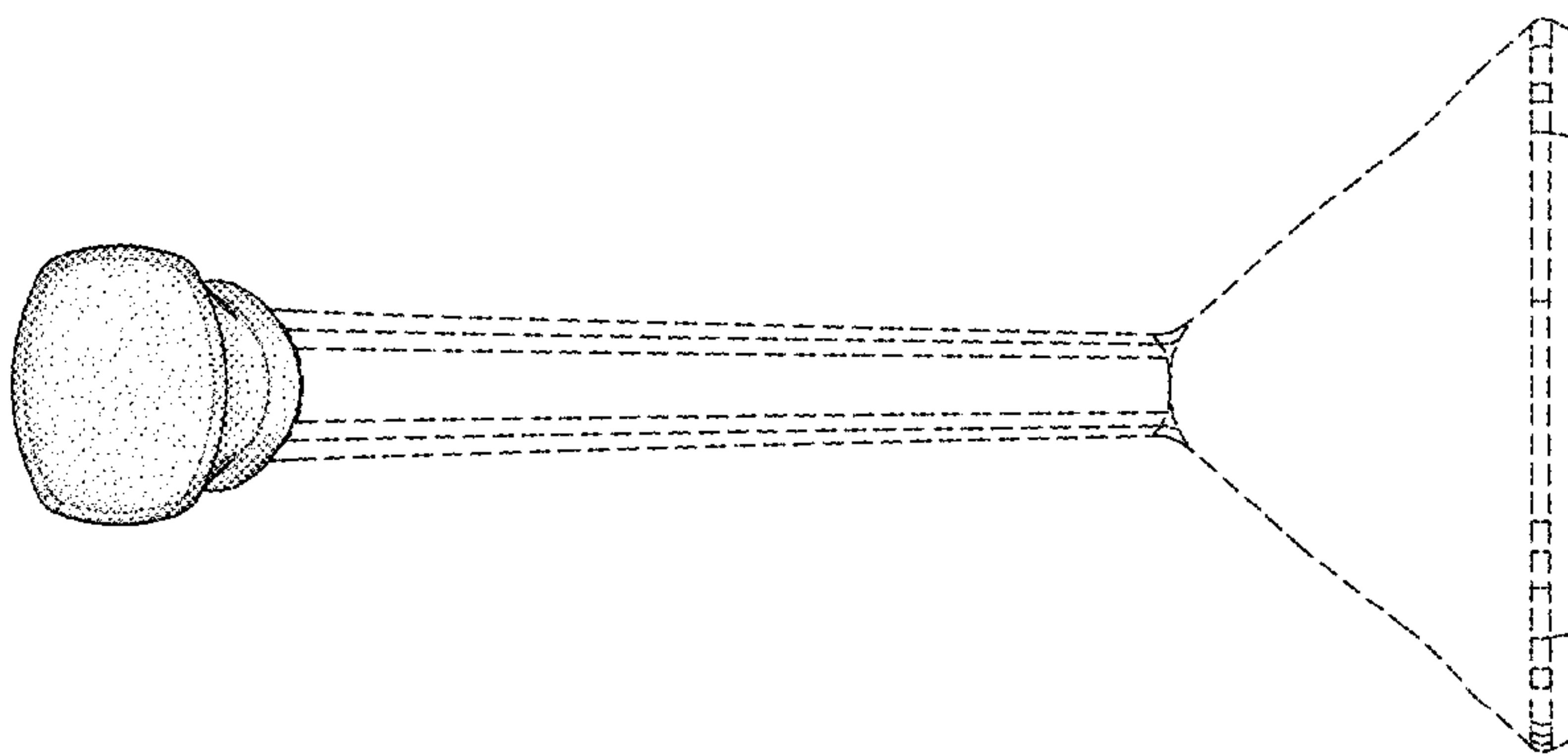
