(57) **CLAIM**

The ornamental design for a lace fabric, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a lace fabric in accordance with the present invention.
FIG. 2 is a reference view of FIG. 1 with broken lines shown therein to indicate the area of detail view, FIG. 5.
FIG. 3 is a back side of FIG. 1.
FIG. 4 is a front perspective of FIG. 1; and,
FIG. 5 is an enlarged detail view of area 5 circumscribed by broken line in FIG. 2.
The broken lines in FIG. 2 and surrounding FIG. 5 depict the boundaries of the detail and form no part of the claimed design.

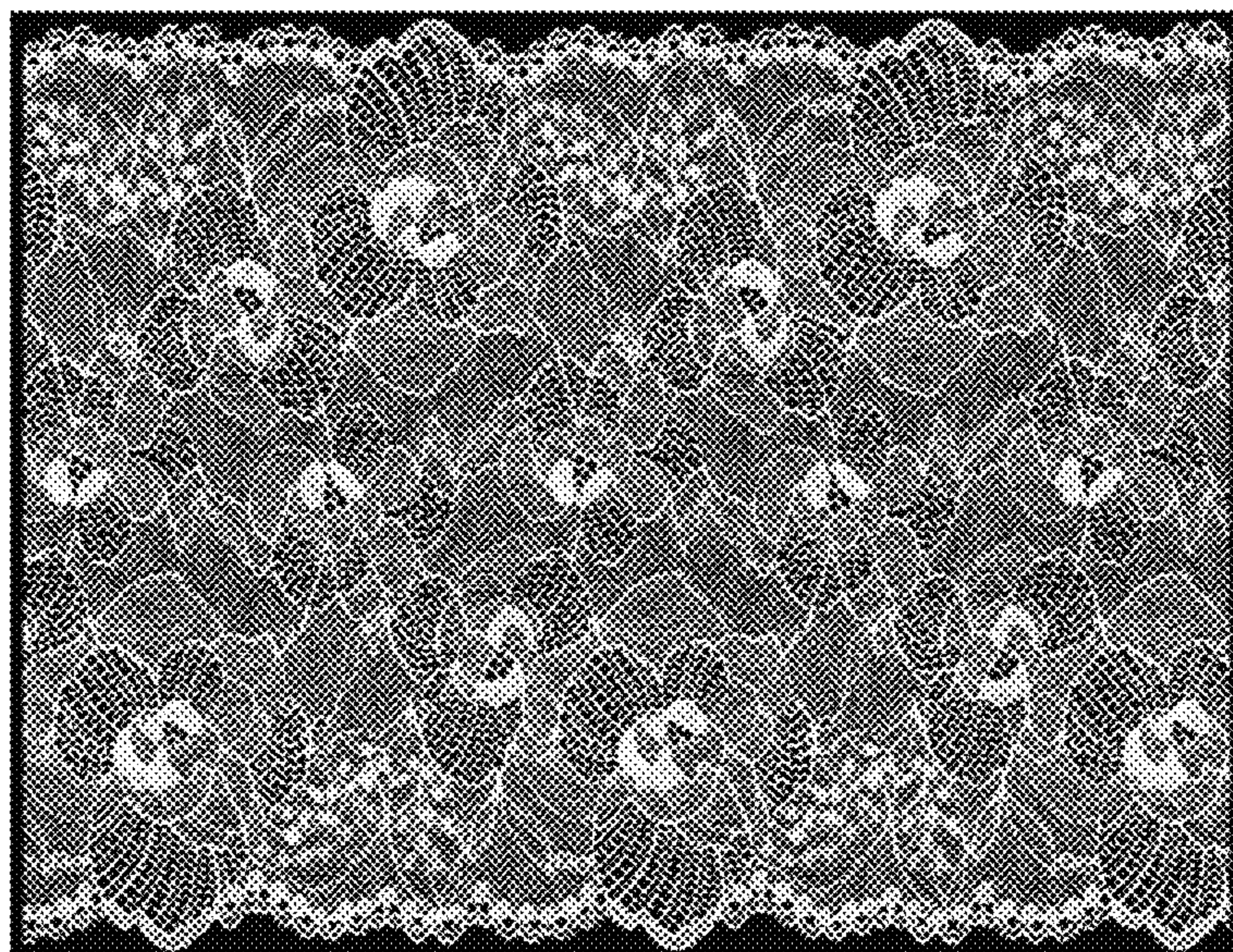

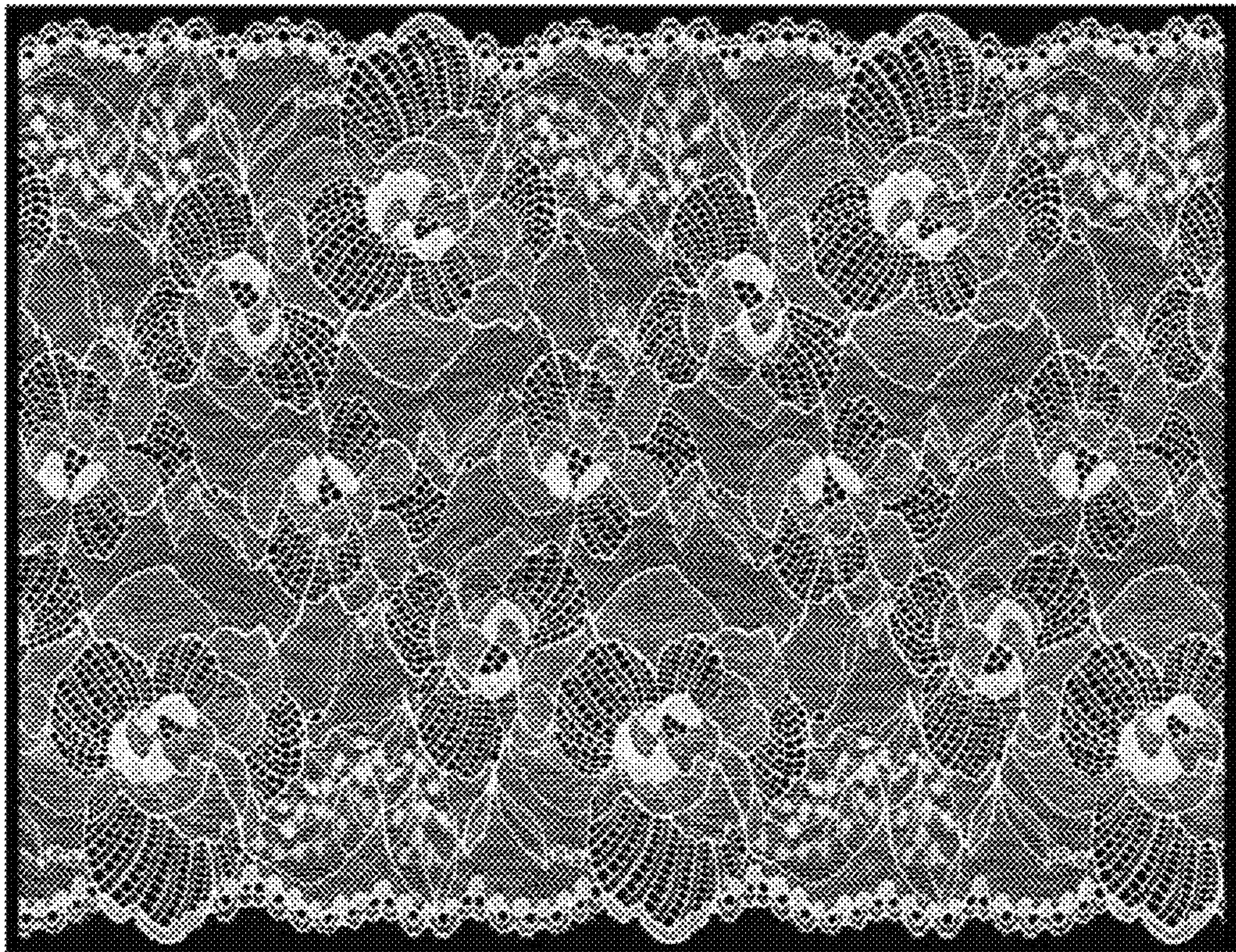

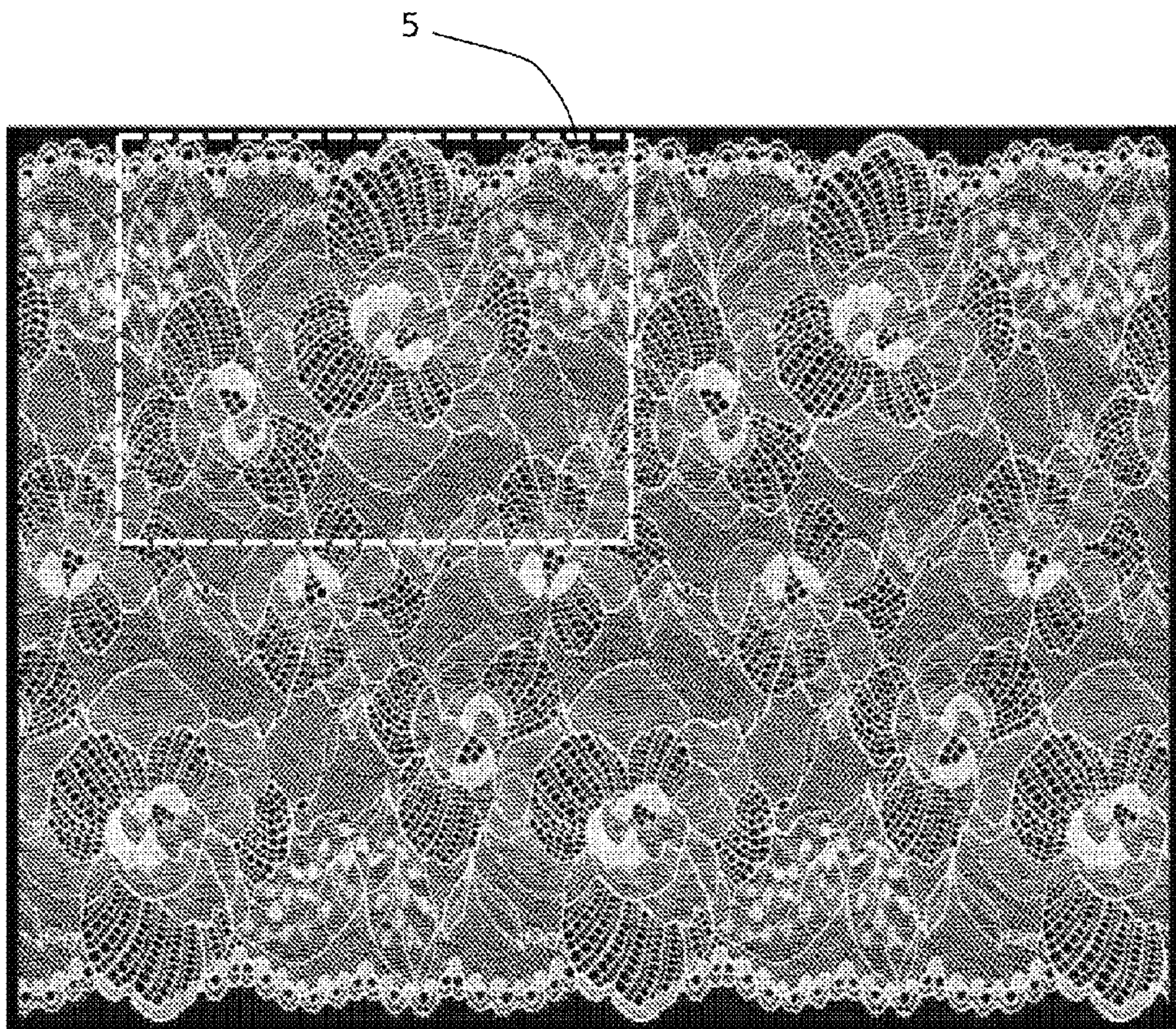

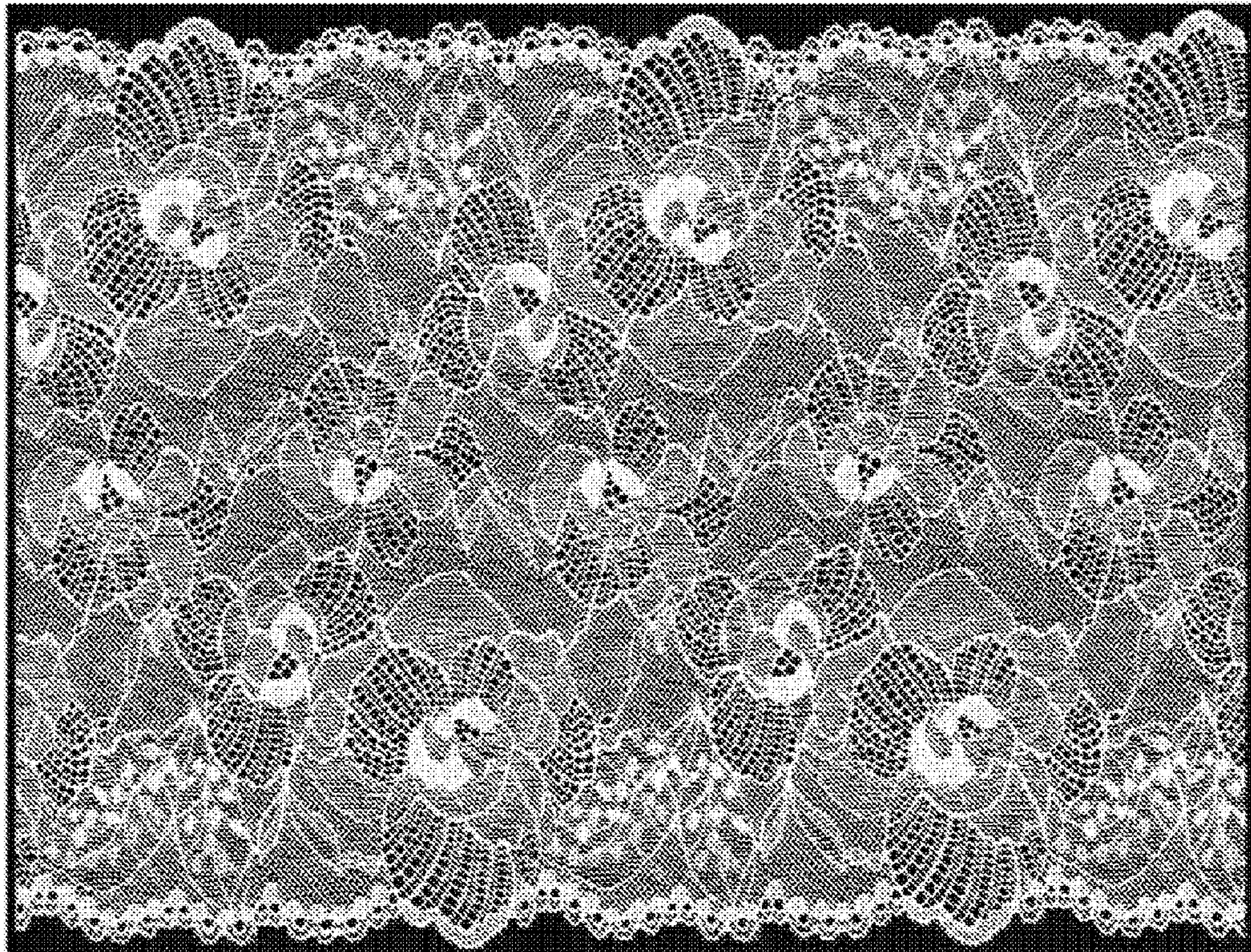

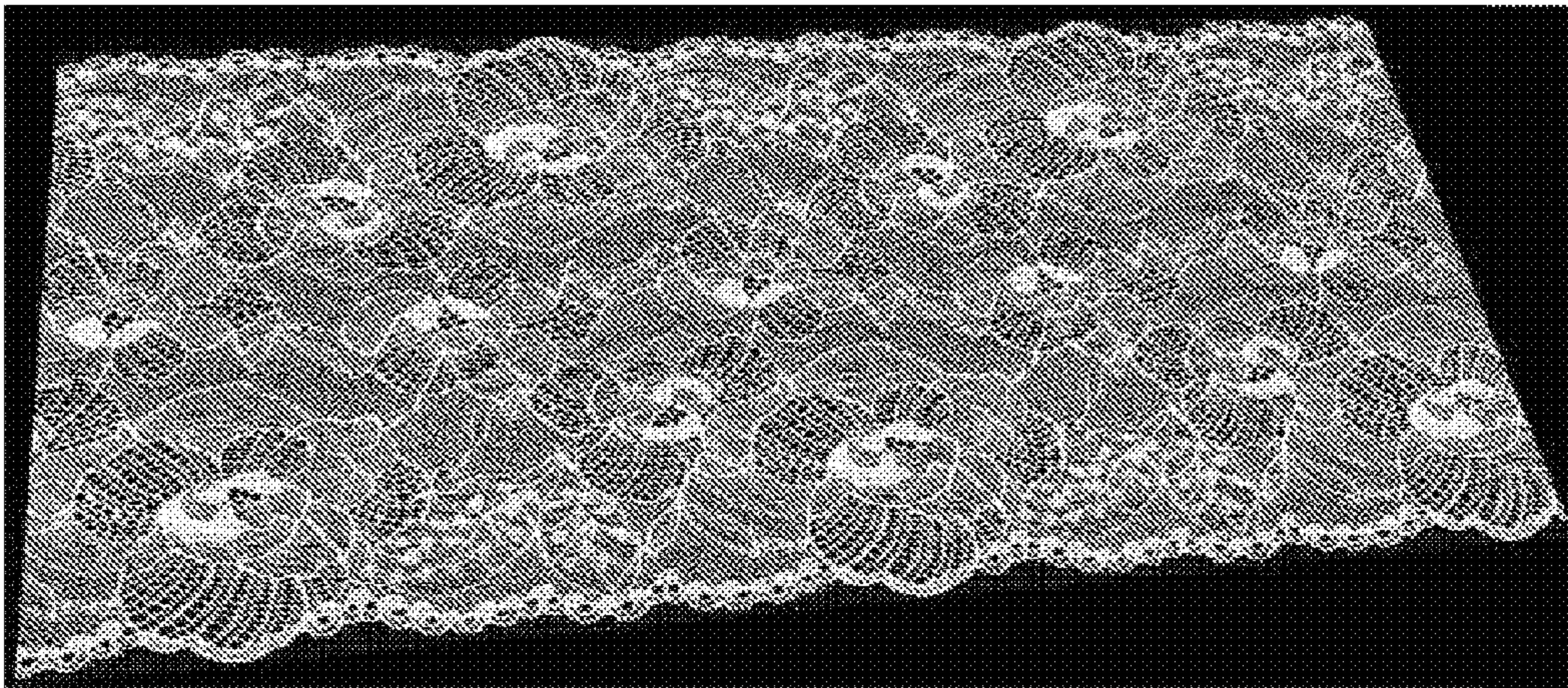
