DESCRIPTION

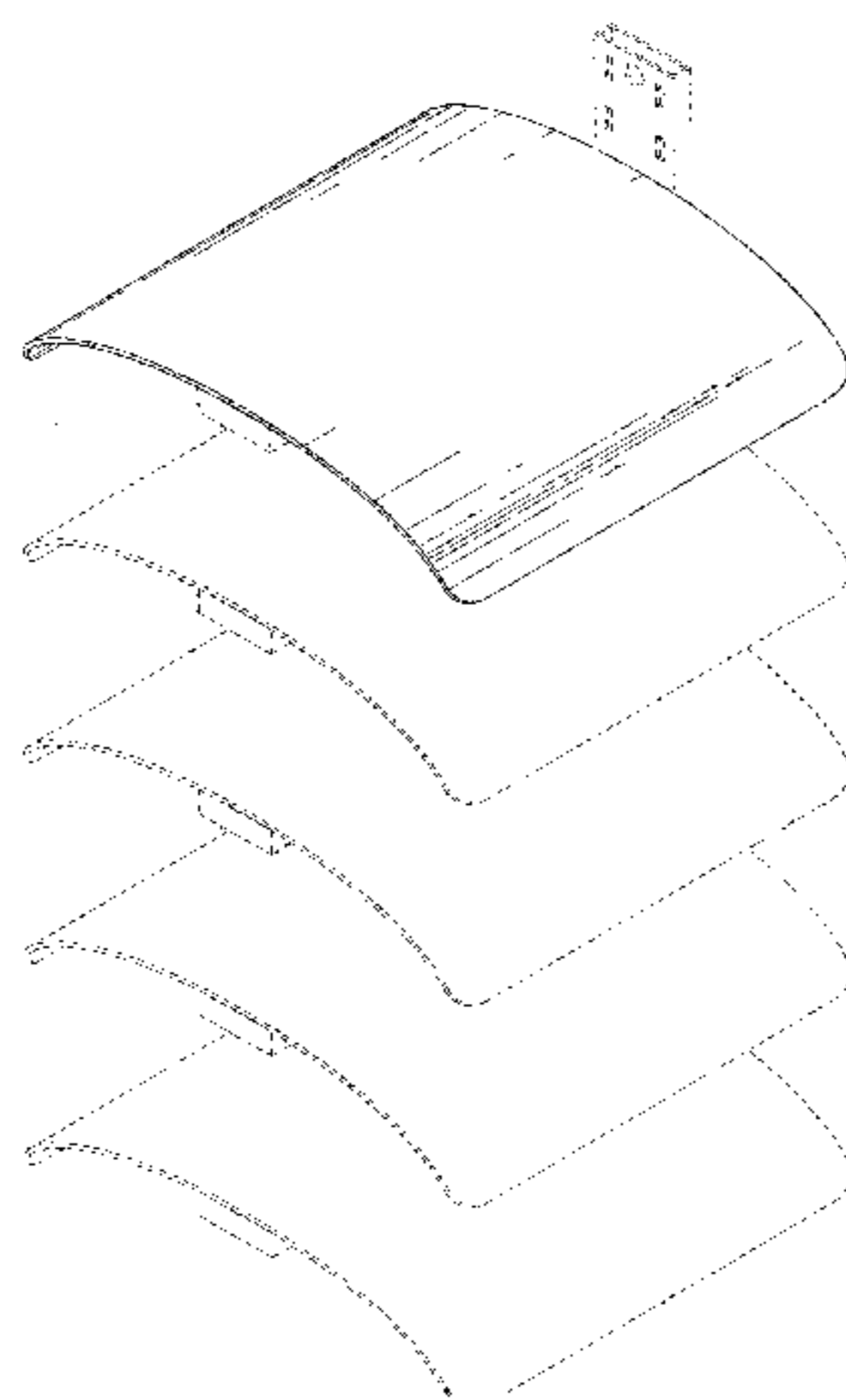
FIG. 1 is a perspective view showing my new design for a shelf.

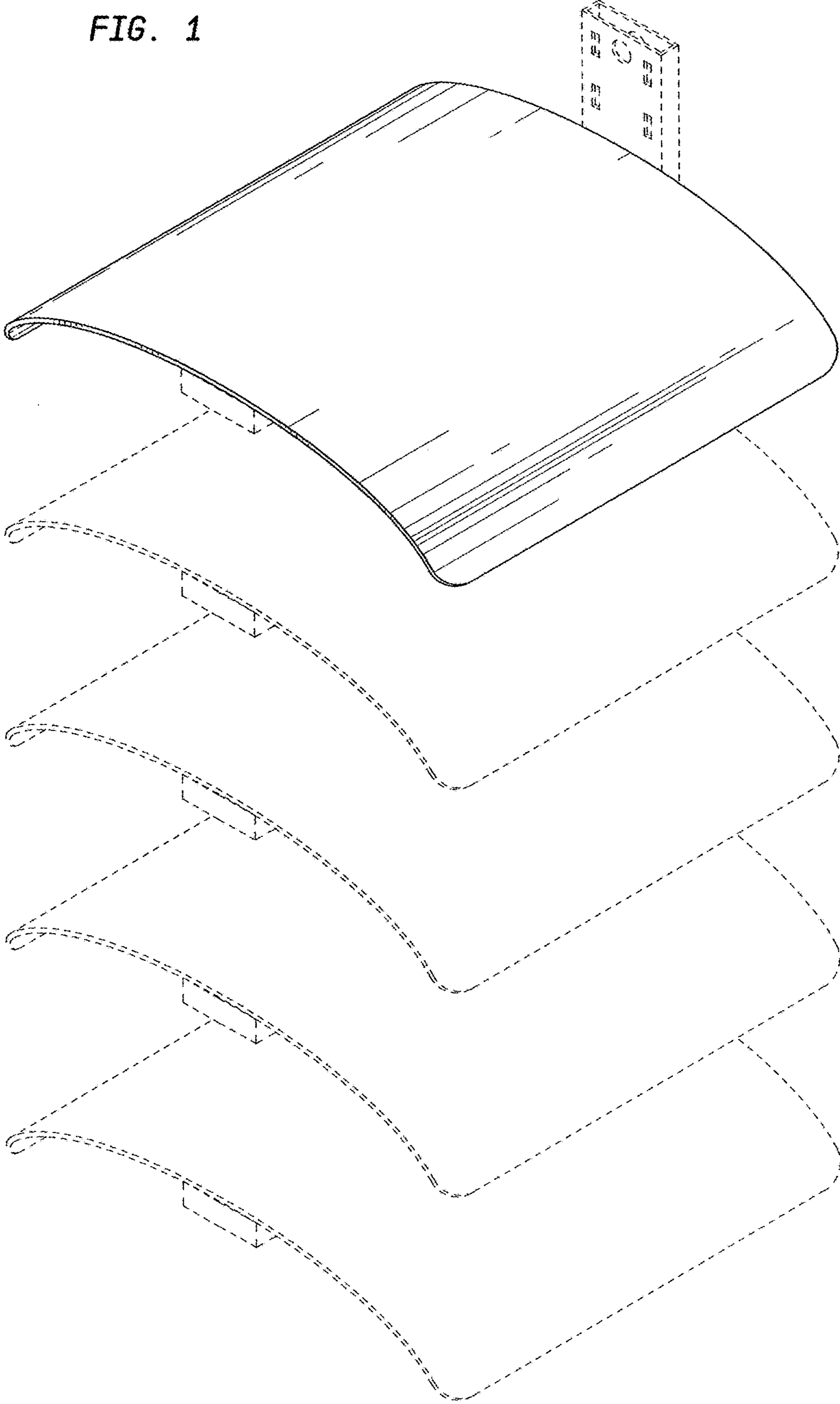

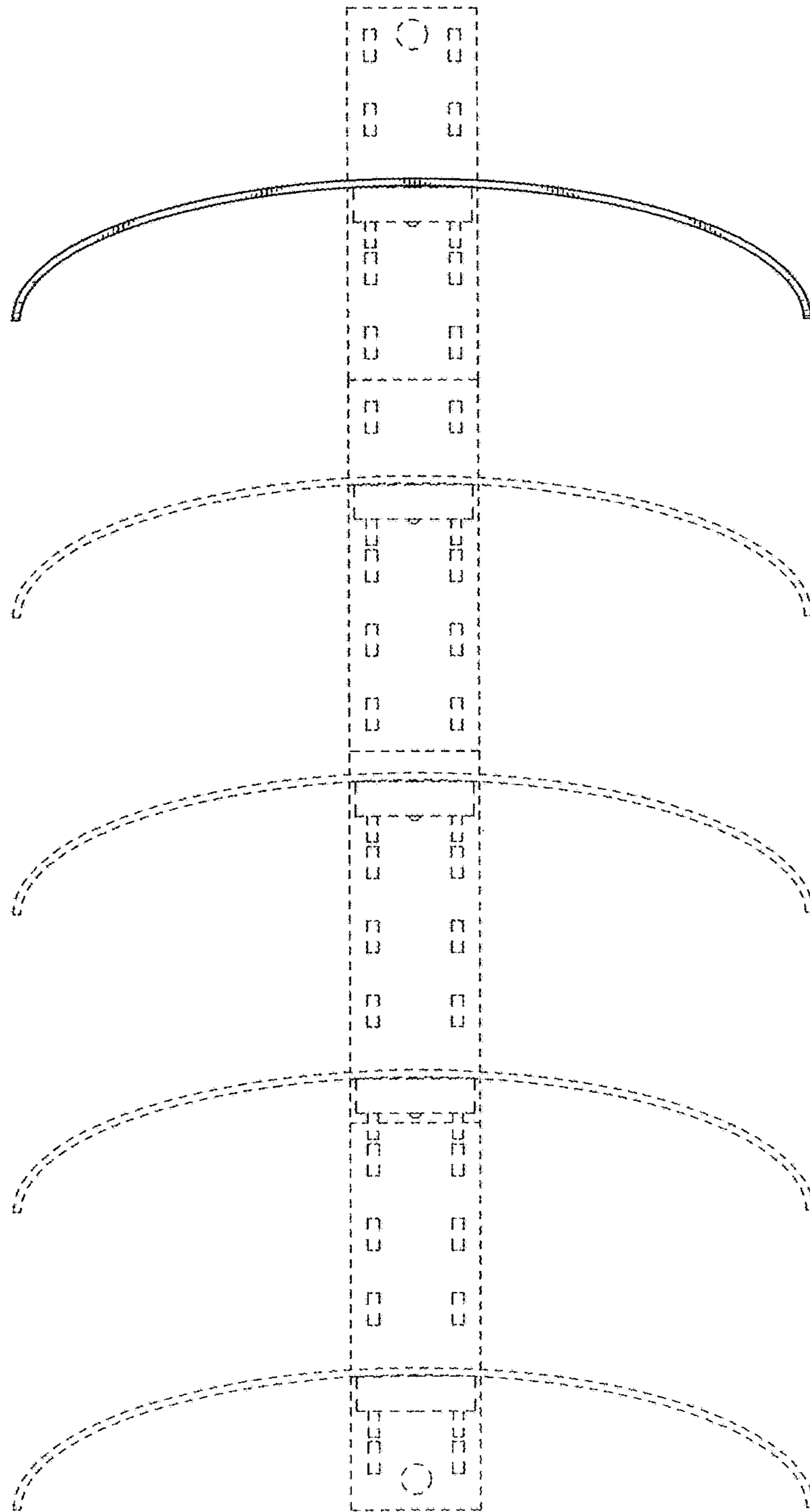

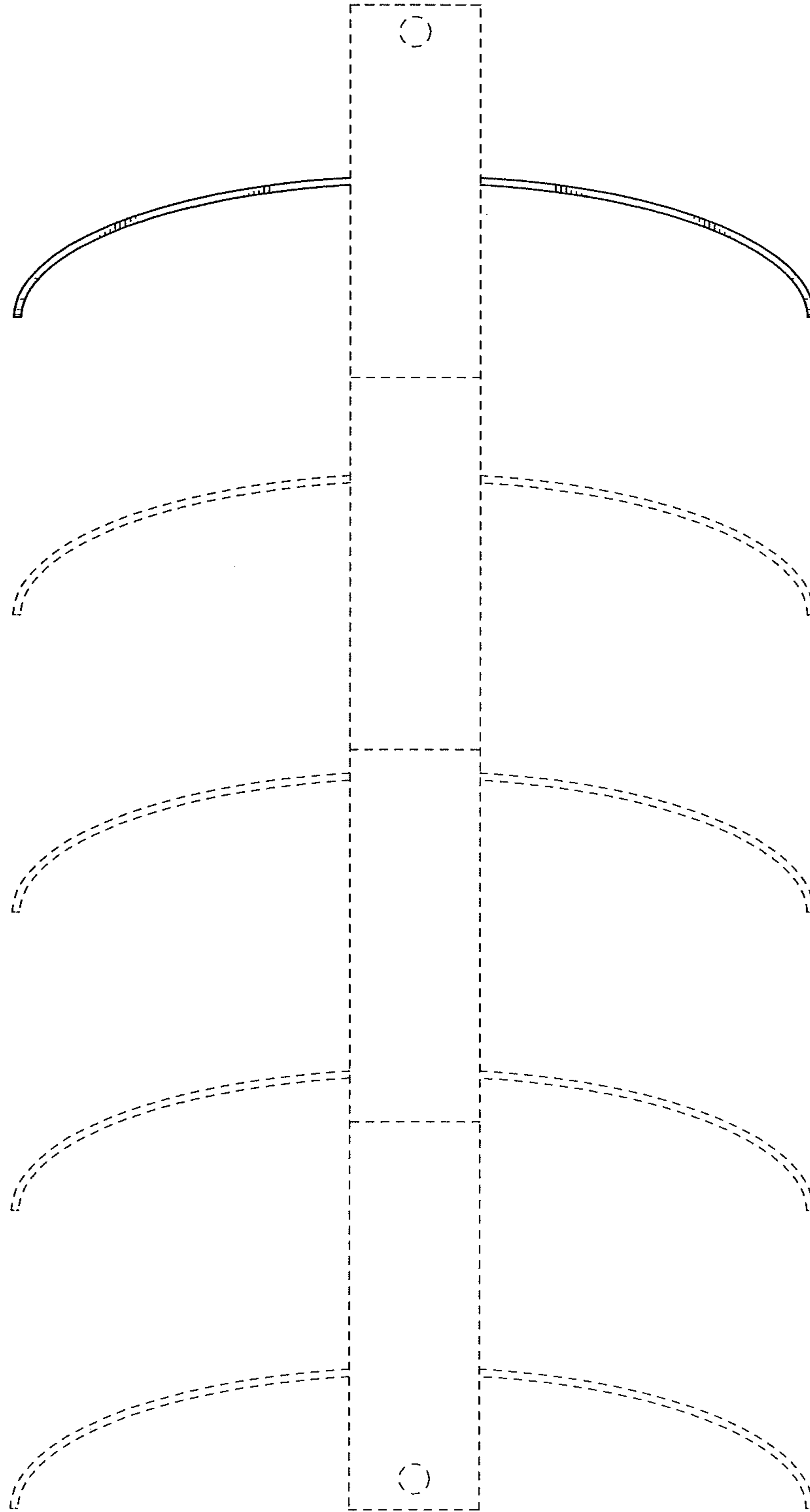

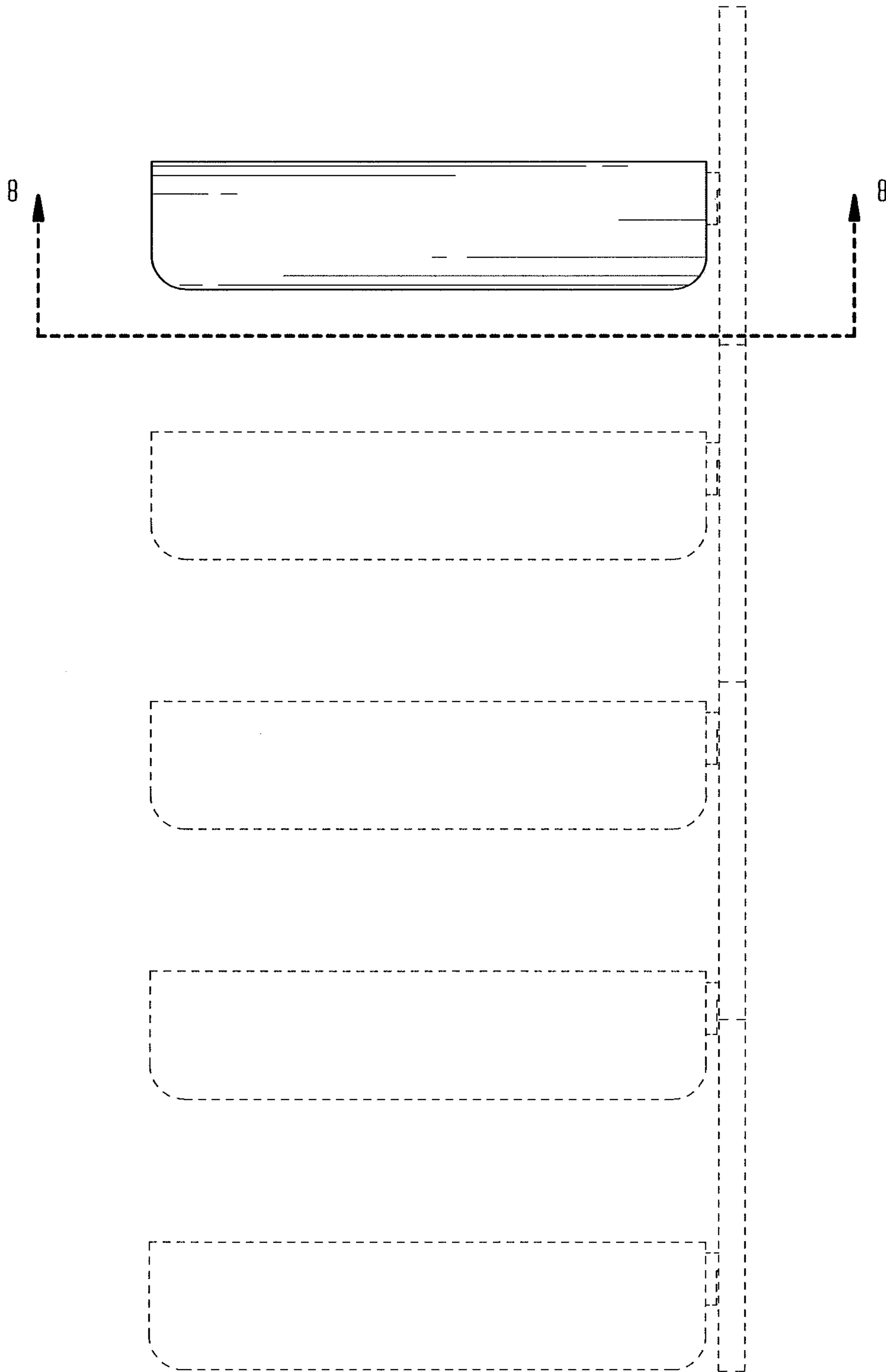

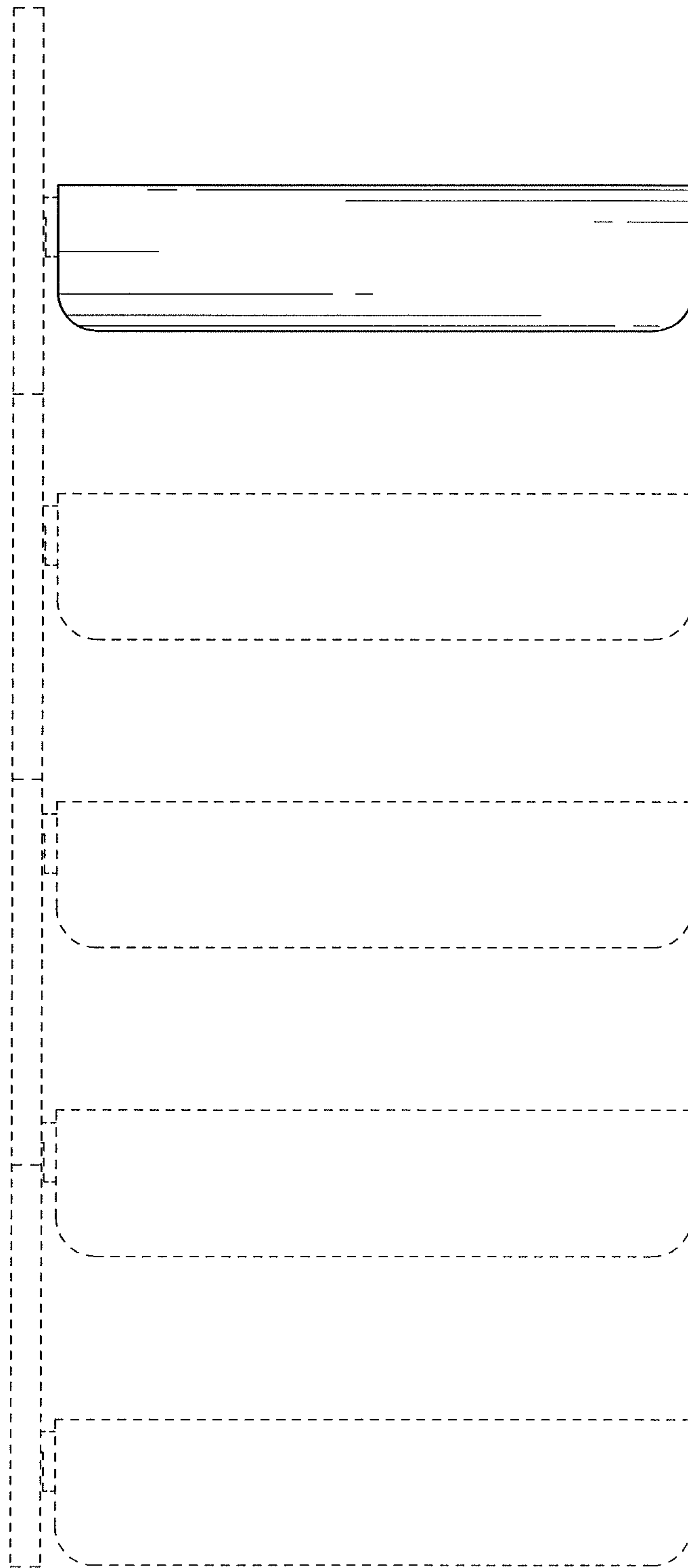

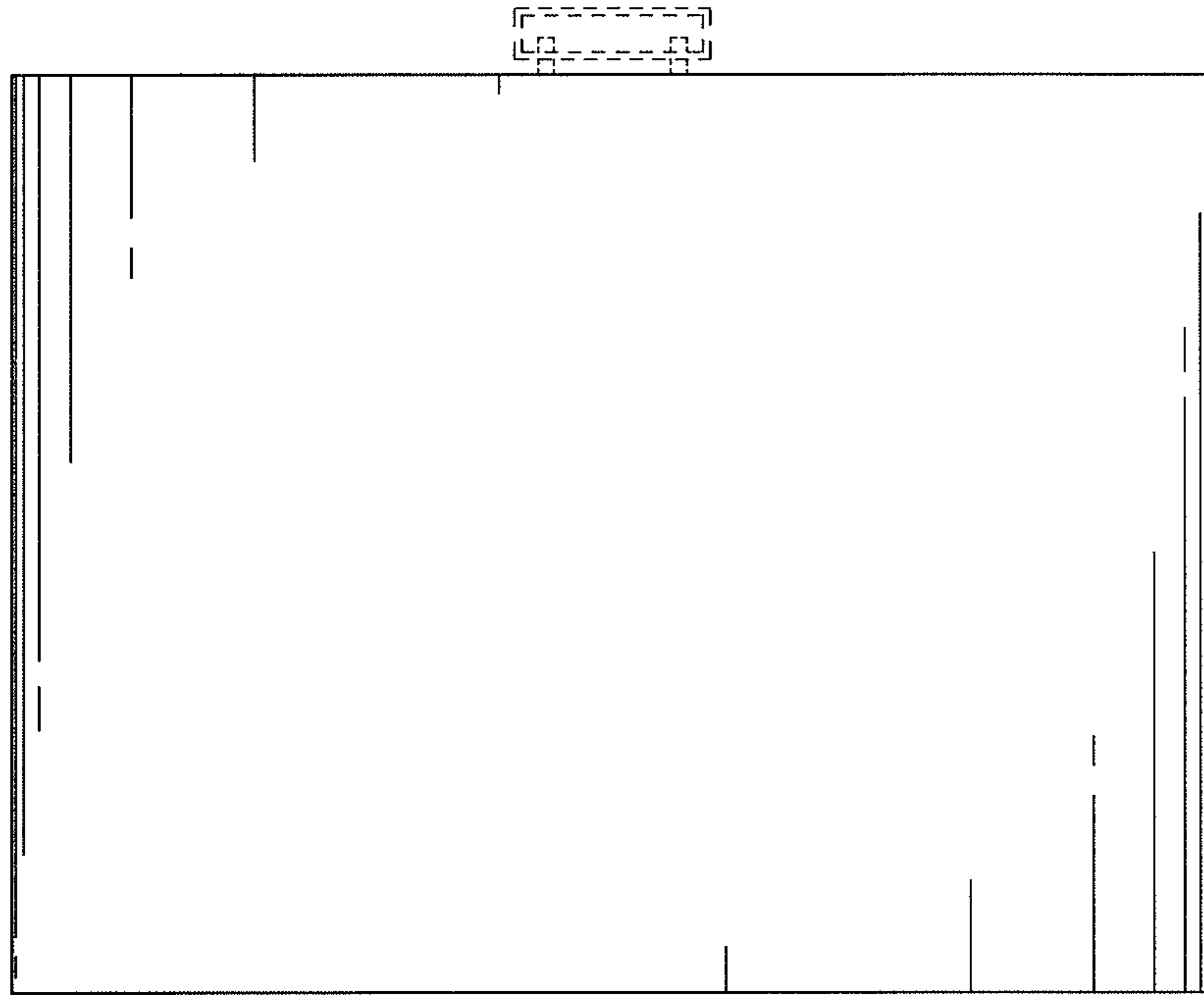

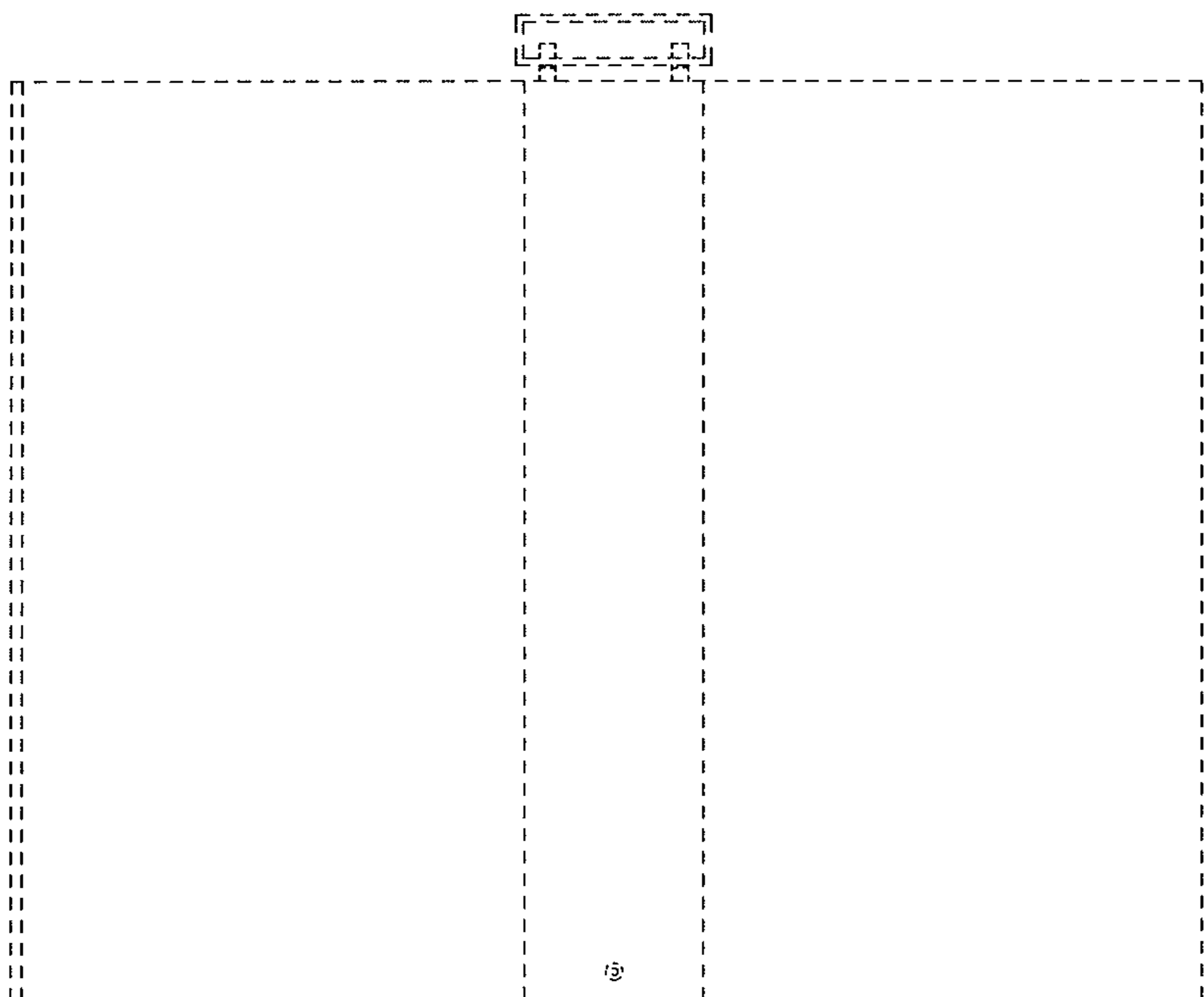

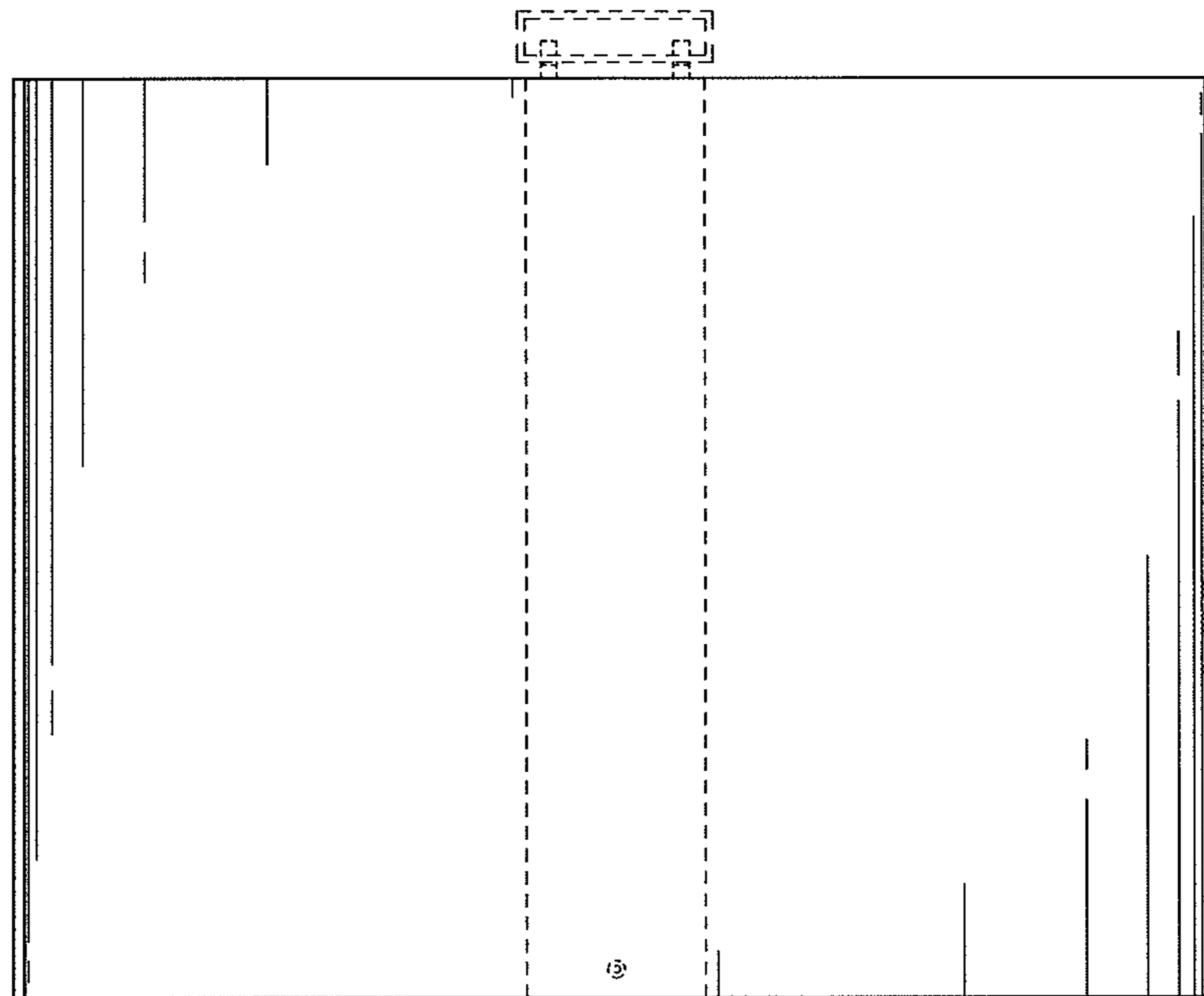

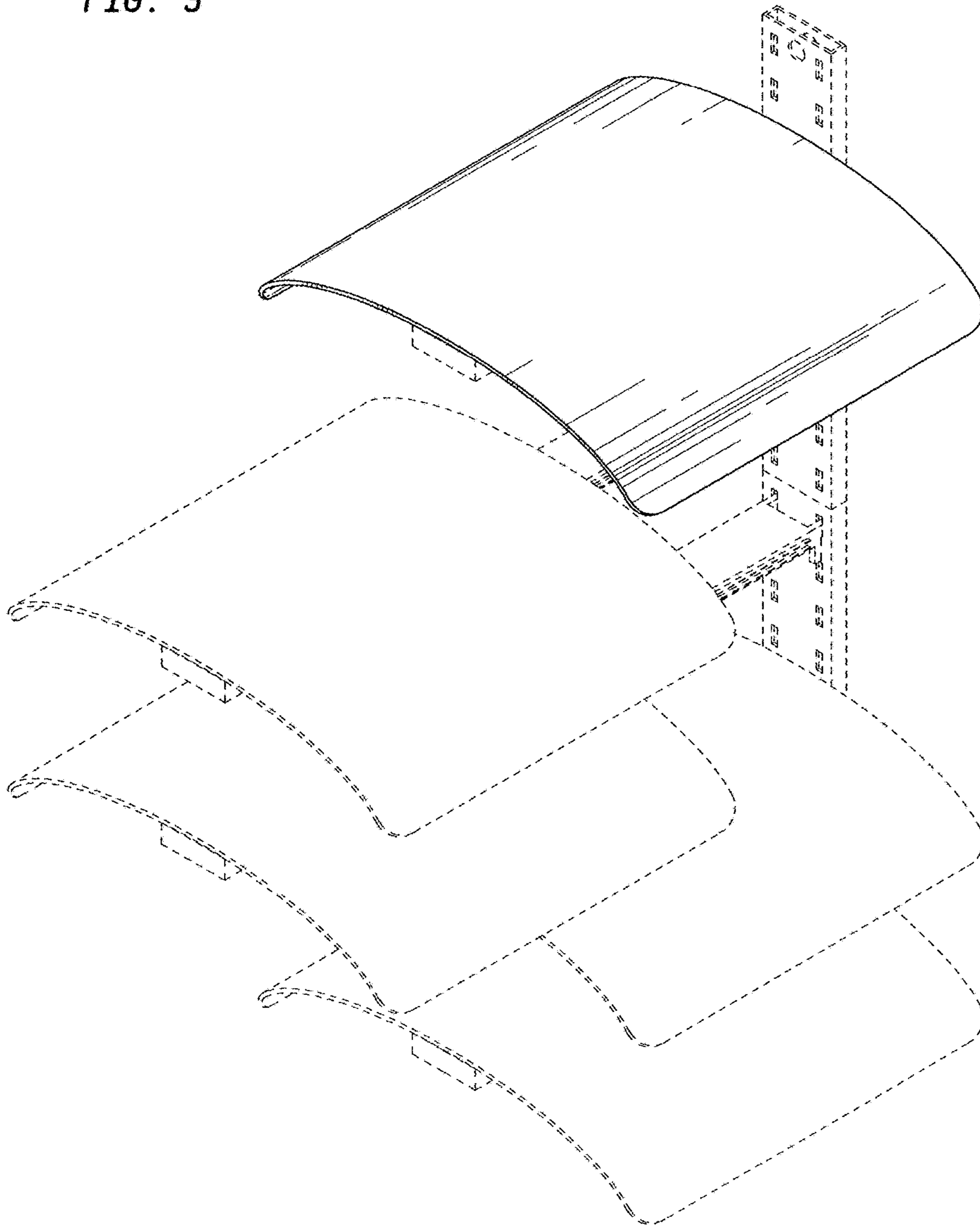
