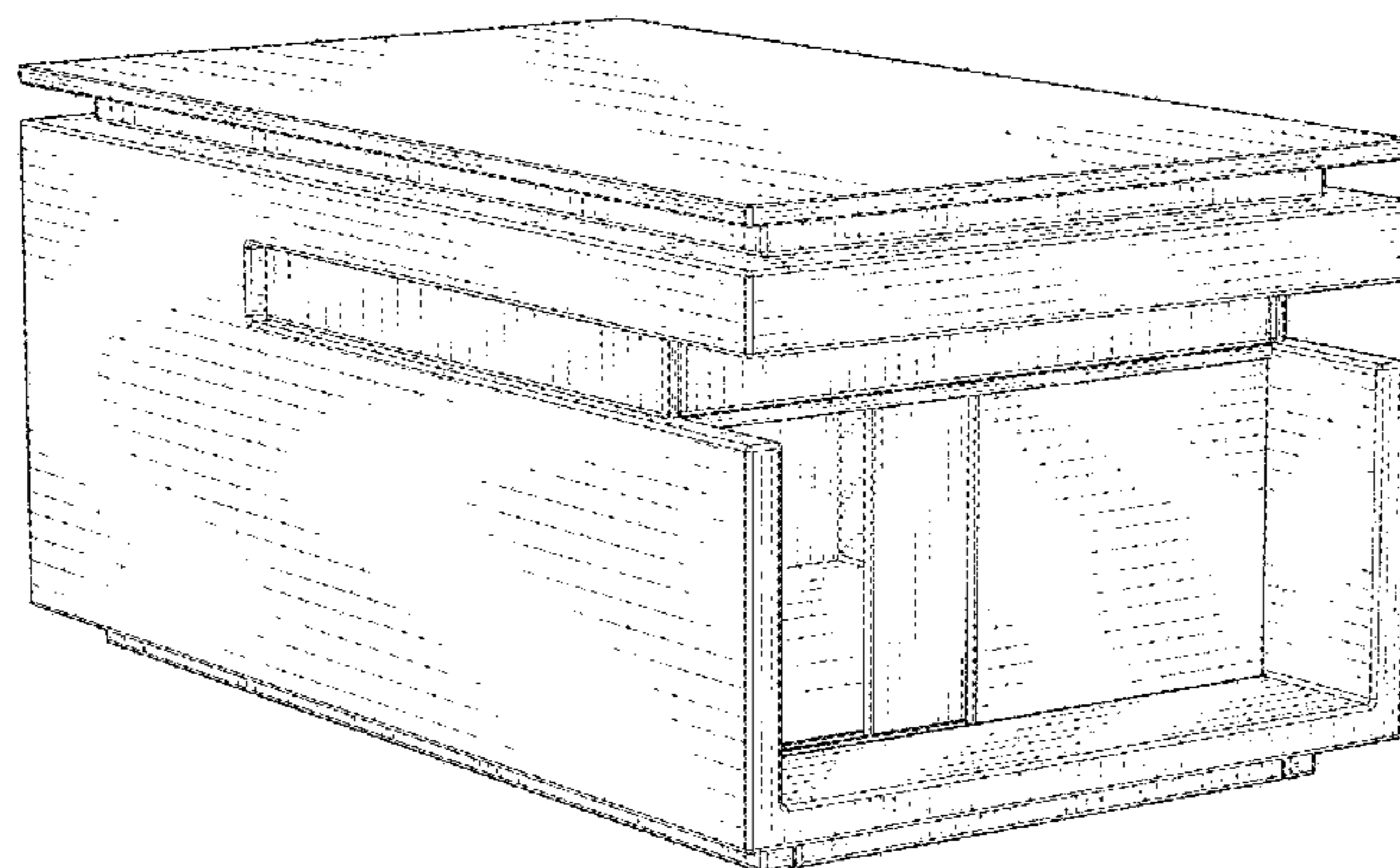
(57) **CLAIM**

The ornamental design for a coffee table, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a coffee table showing my new design.
FIG. 2 is a rear perspective view of the coffee table of FIG. 1.
FIG. 3 is a front elevation view of the coffee table of FIG. 1.
FIG. 4 is a top view of the coffee table of FIG. 1.
FIG. 5 is a right side elevation view of one end of the coffee table of FIG. 1 shown at a different scale.
FIG. 6 is a left side elevation view of one end of the coffee table of FIG. 1 shown at a different scale.
FIG. 7 is a rear elevation view of the coffee table of FIG. 1; and,
FIG. 8 is a bottom view of the coffee table of FIG. 1.
The broken line showing of elements on the table illustrate portions of the article and form no part of the claimed design.

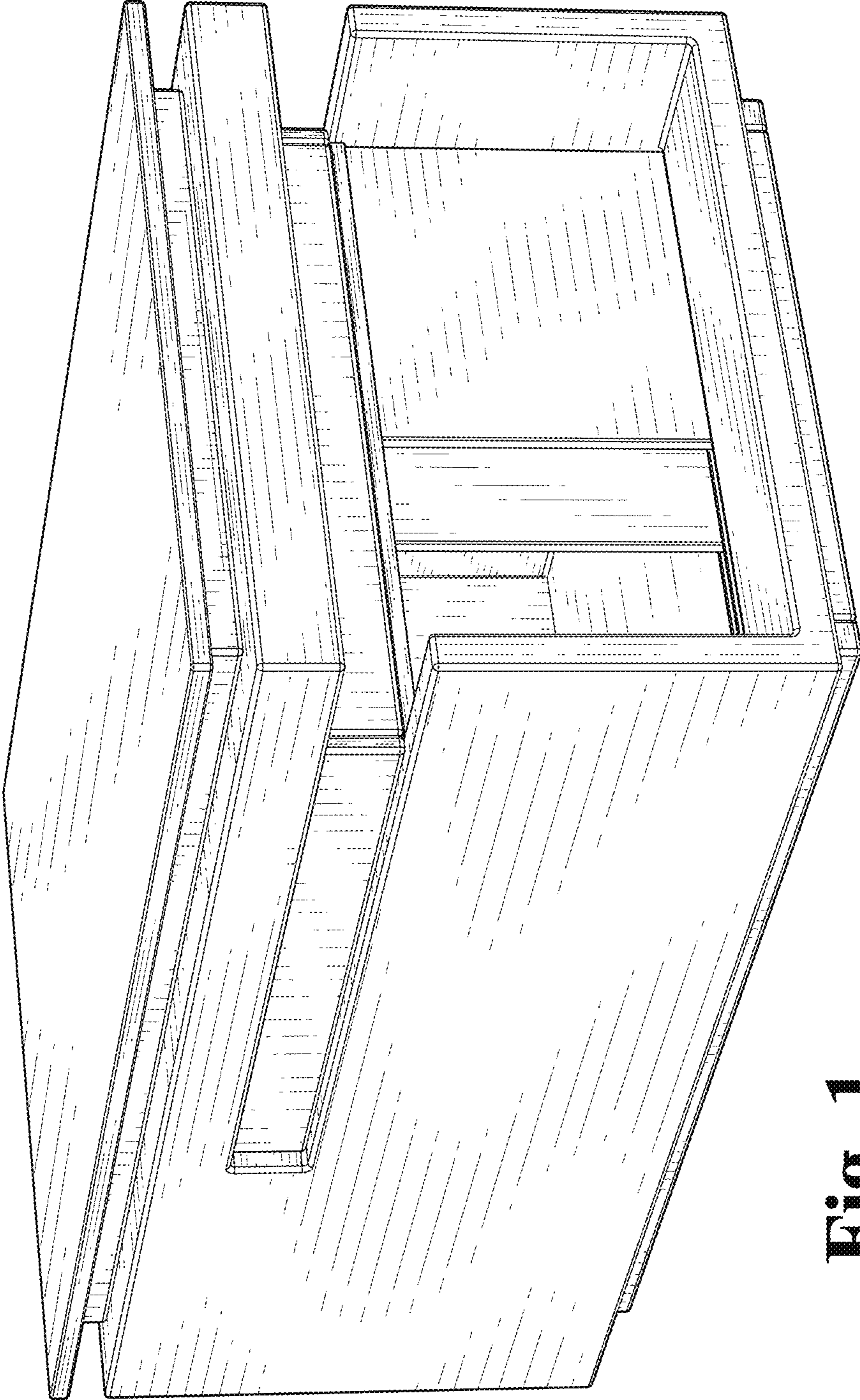

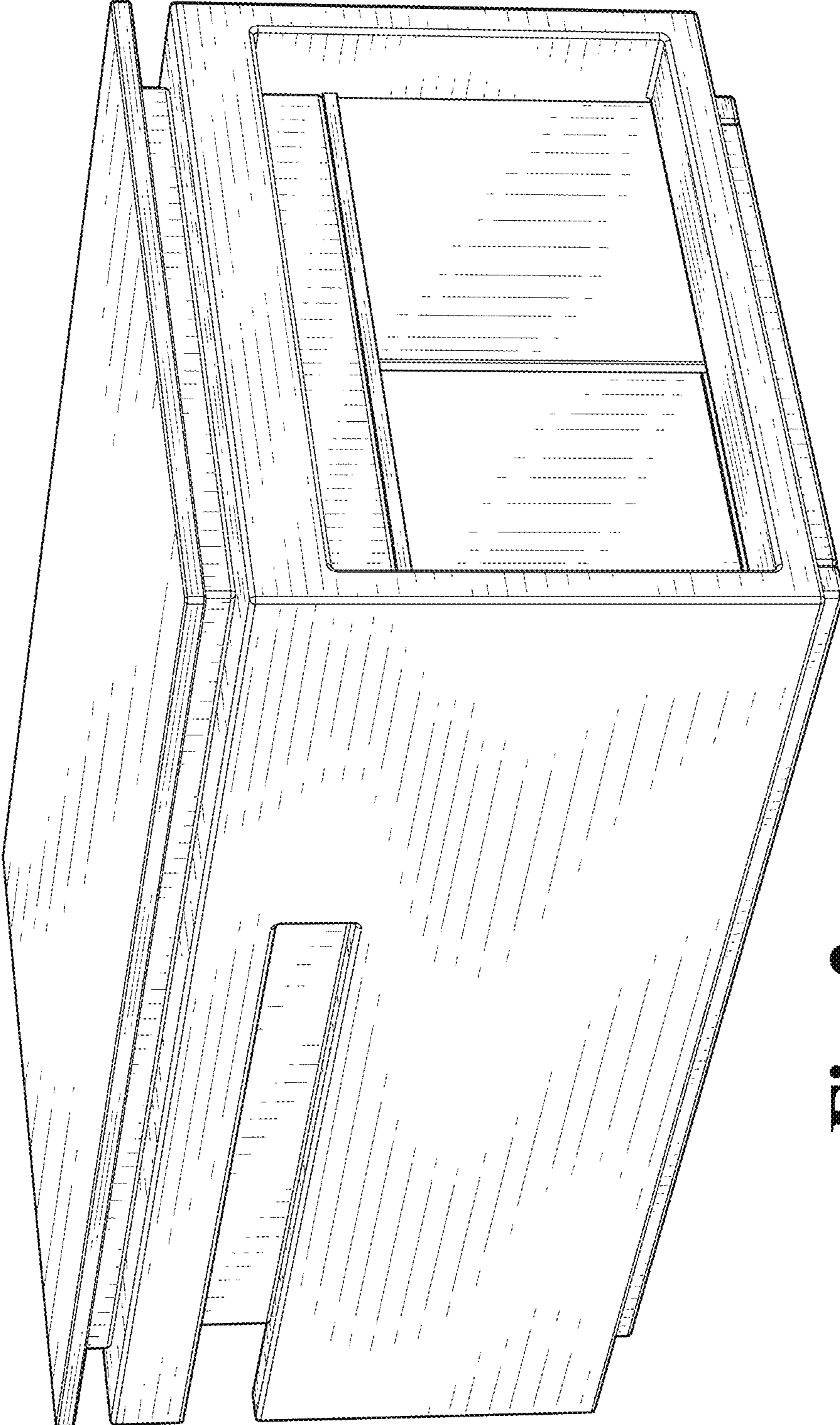

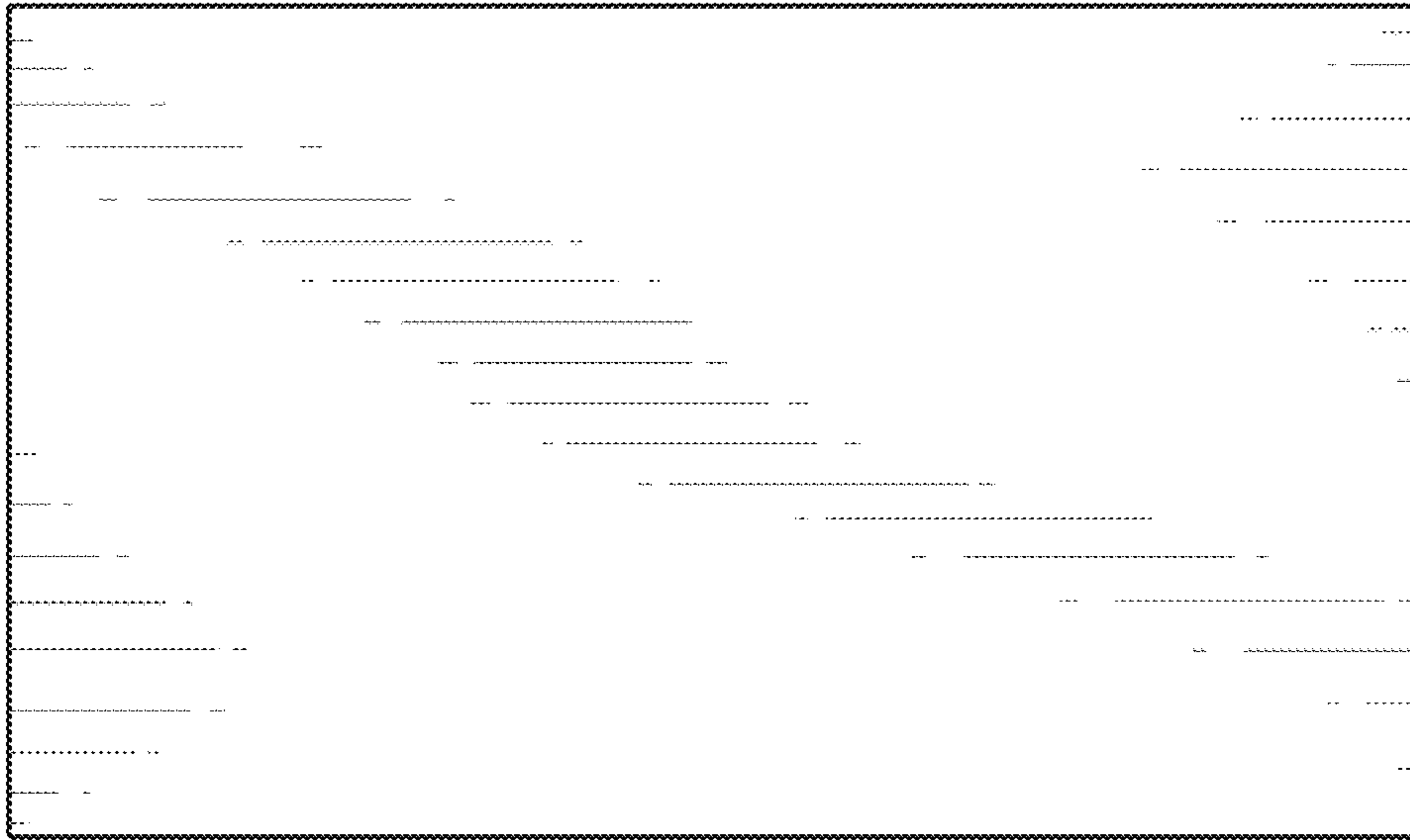

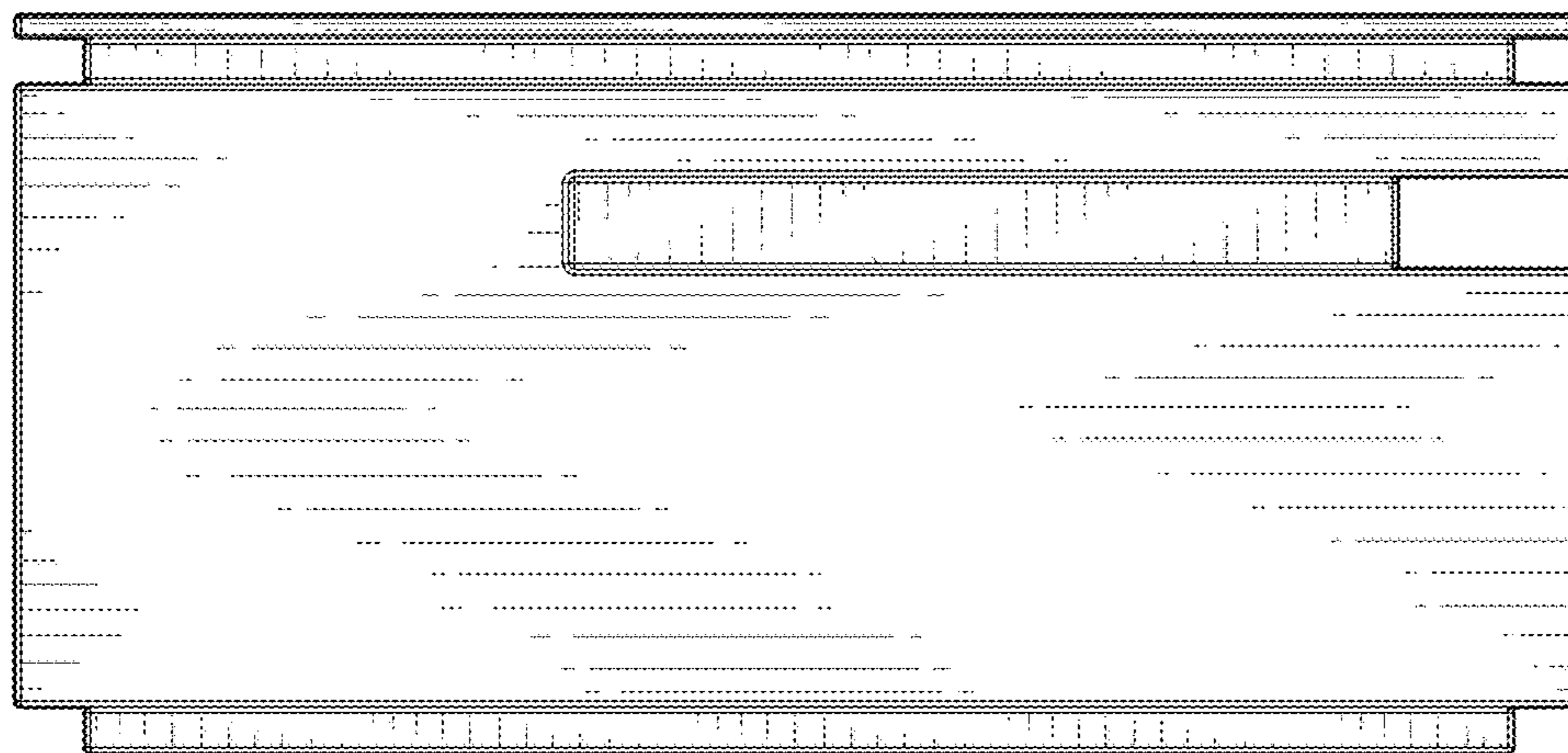

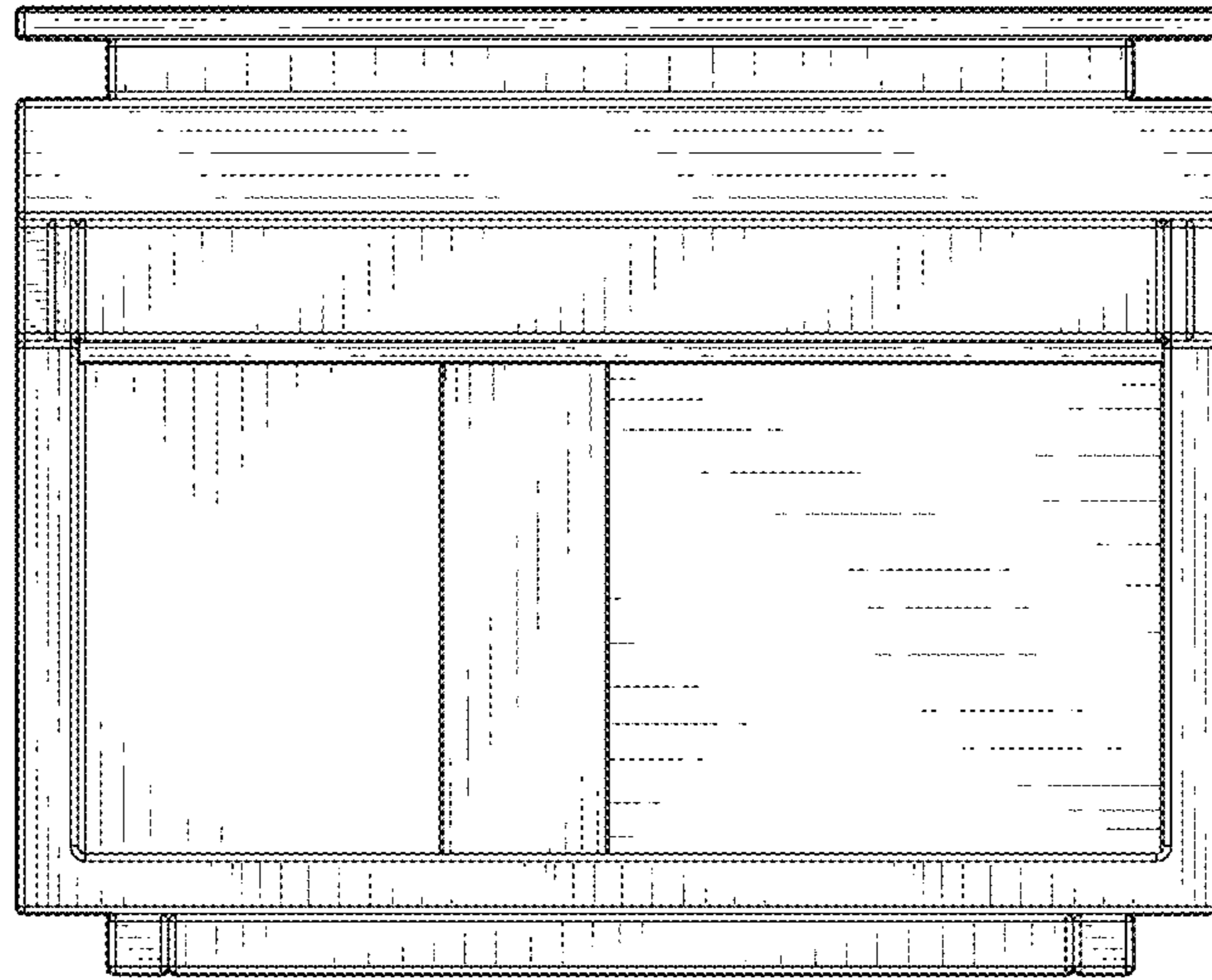

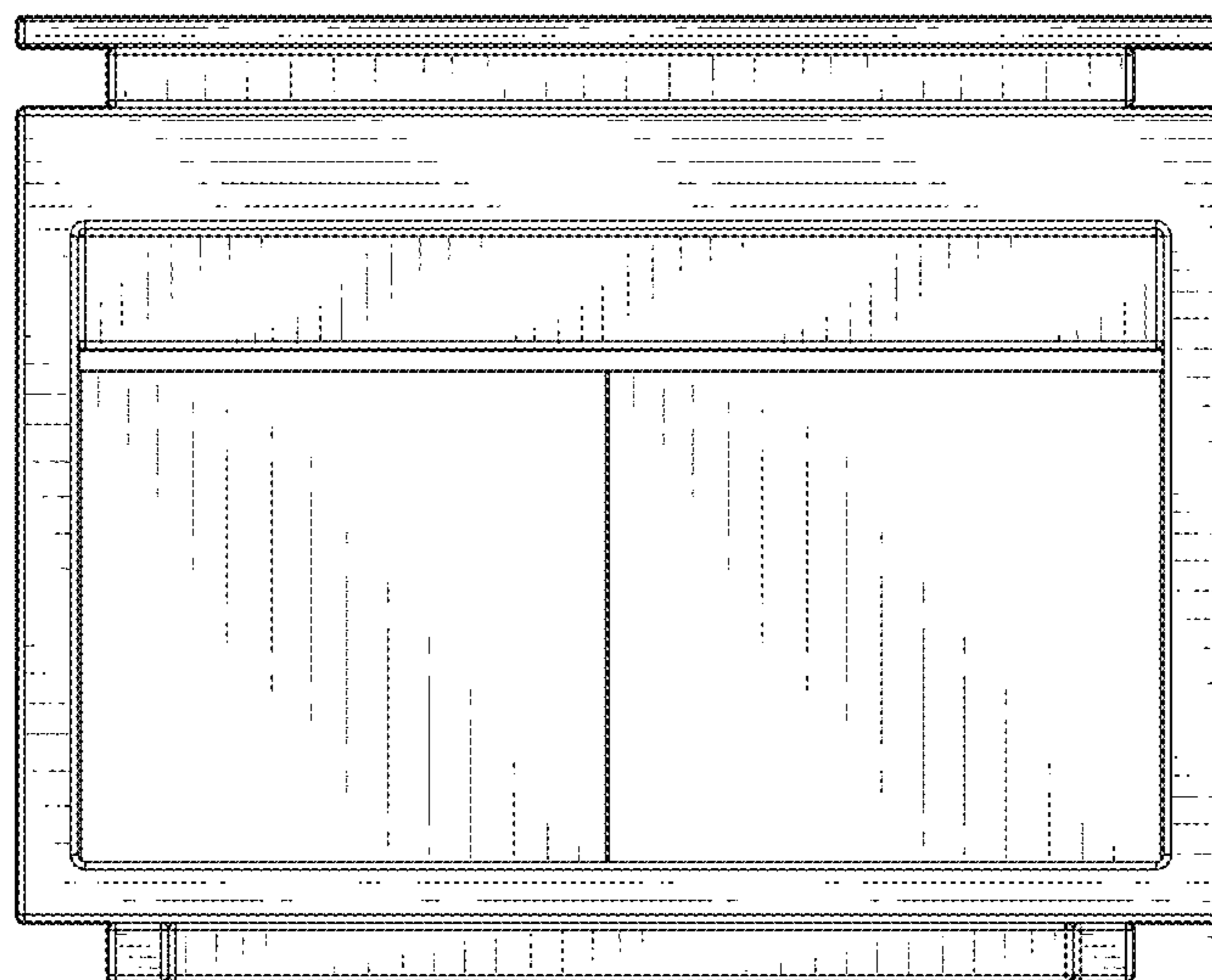

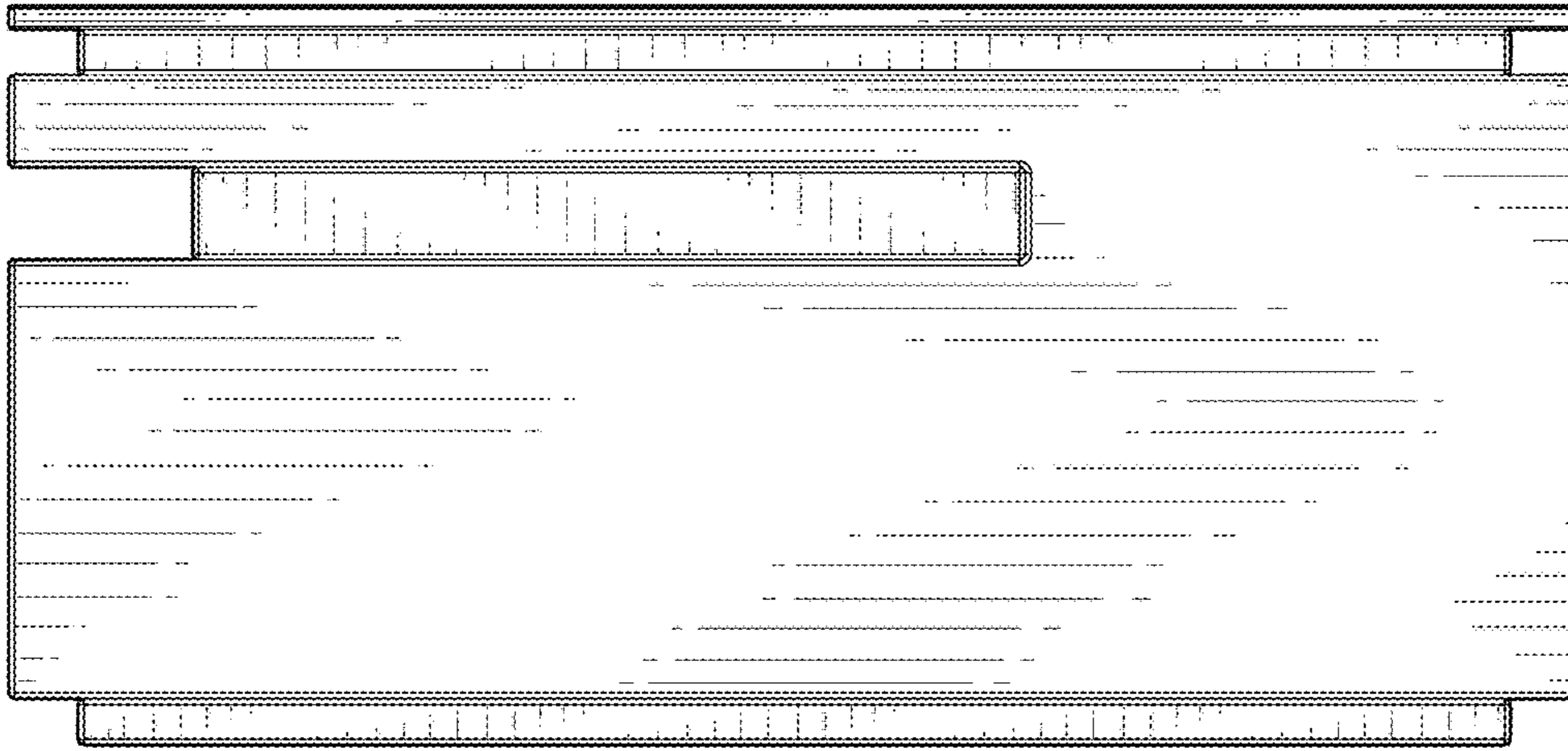

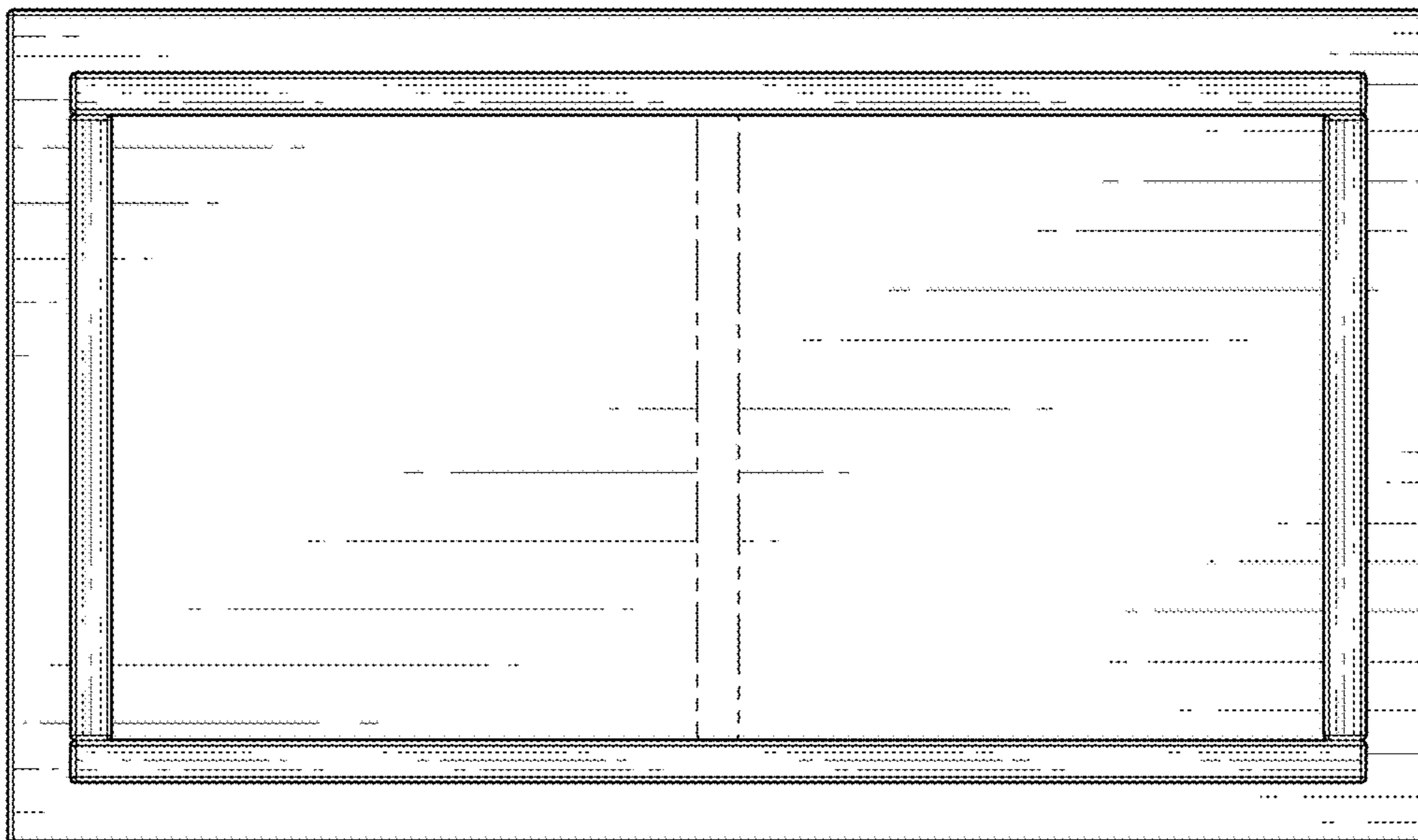
