The ornamental design for an induction range, as shown and described.

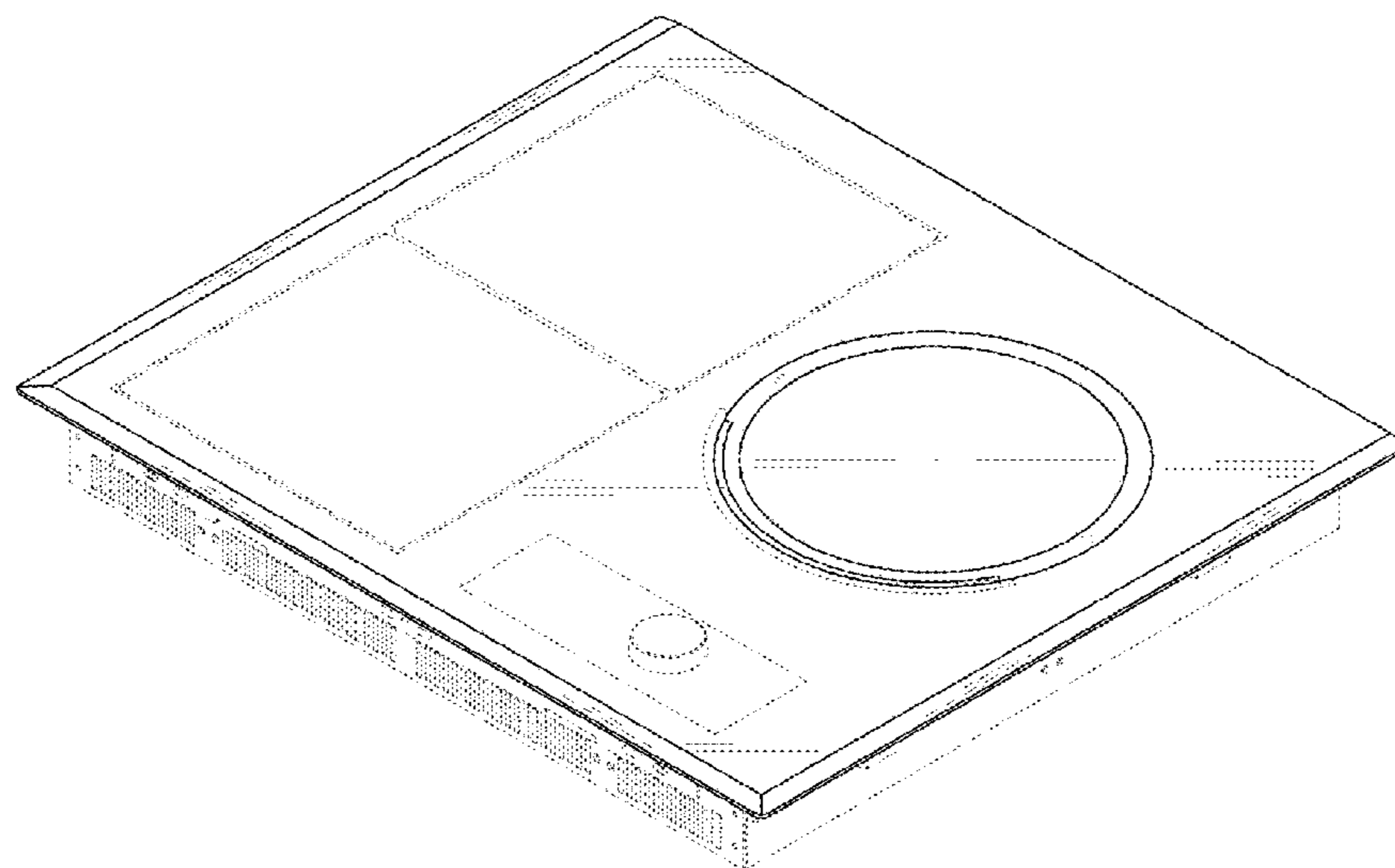
**DESCRIPTION**

FIG. 1 is a perspective view of an induction range, showing our new design;  
FIG. 2 is a front view thereof;

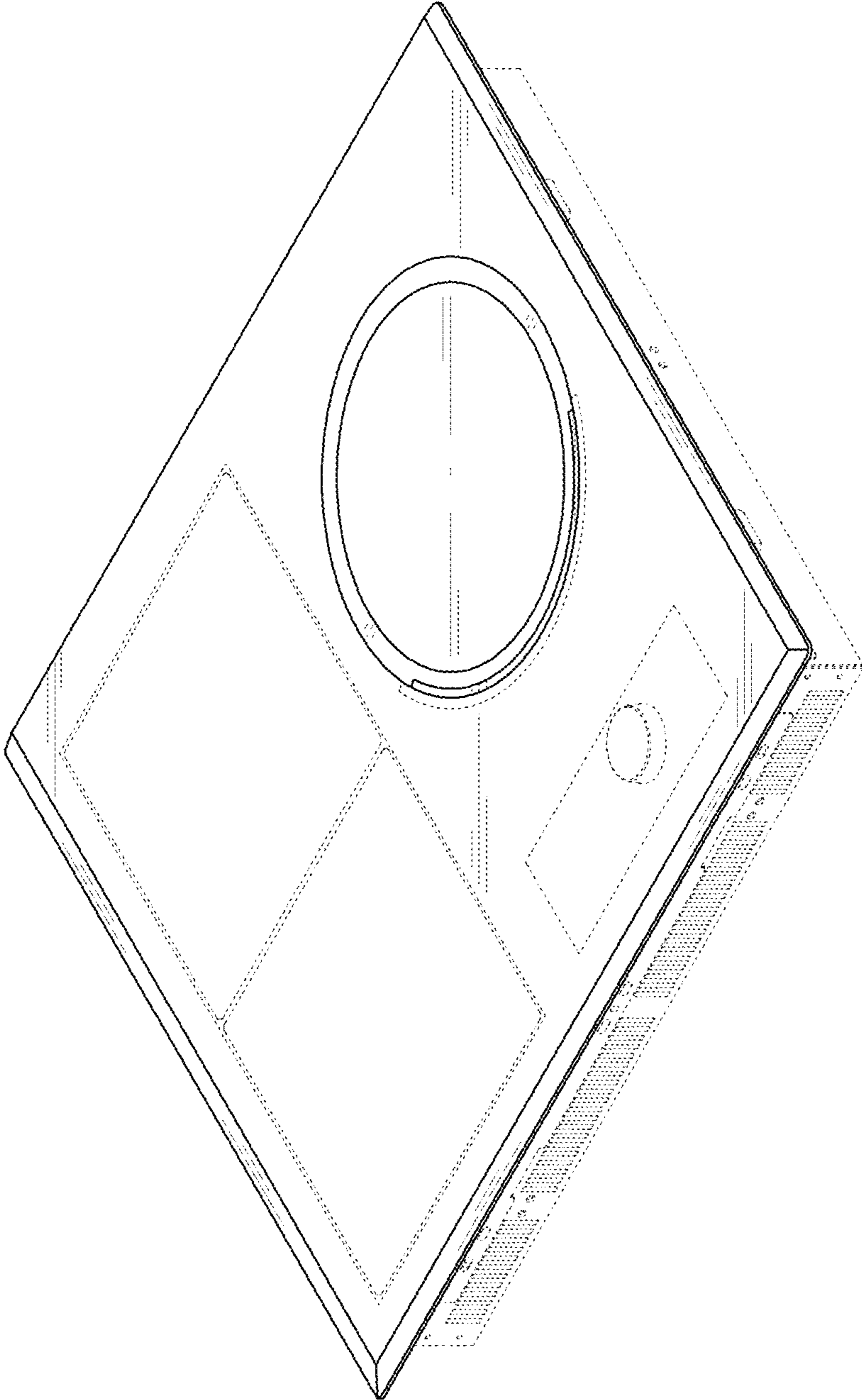

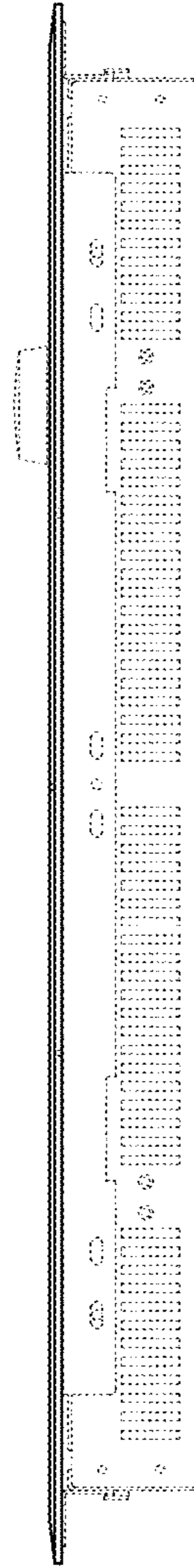

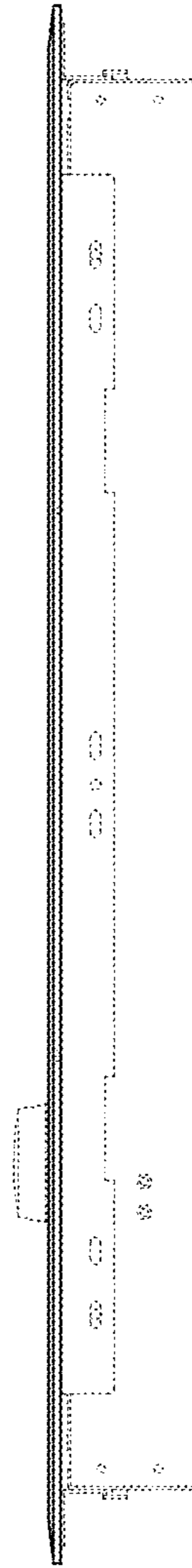

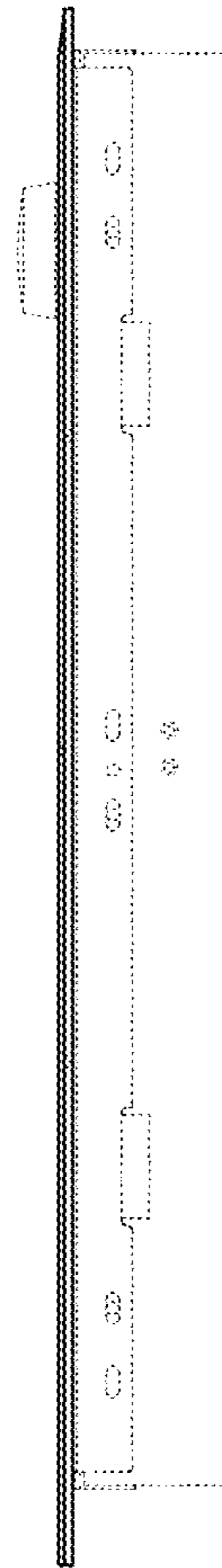
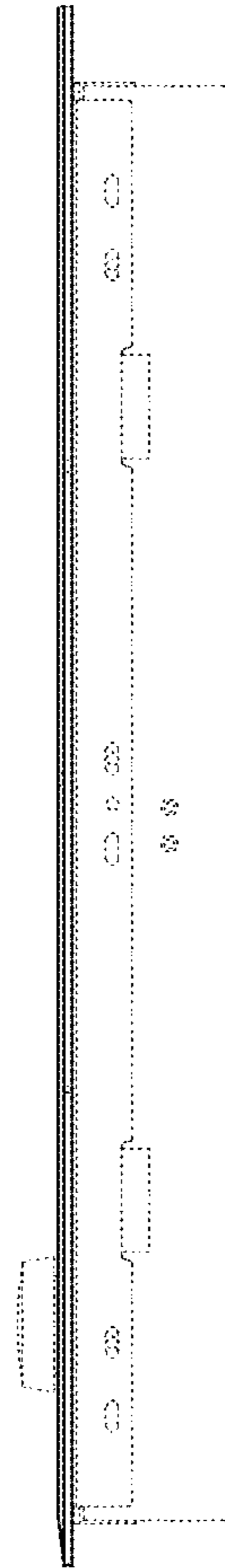

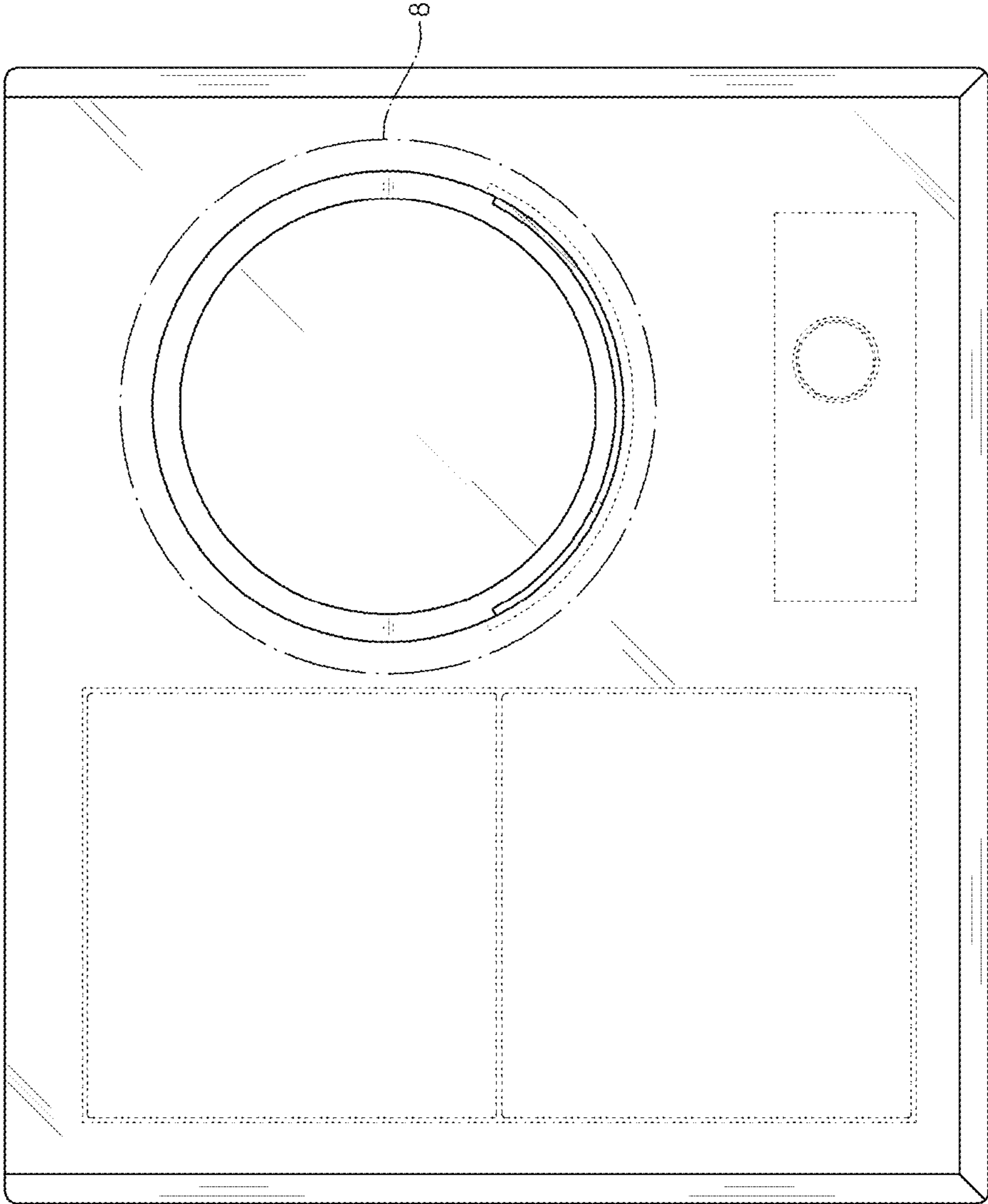

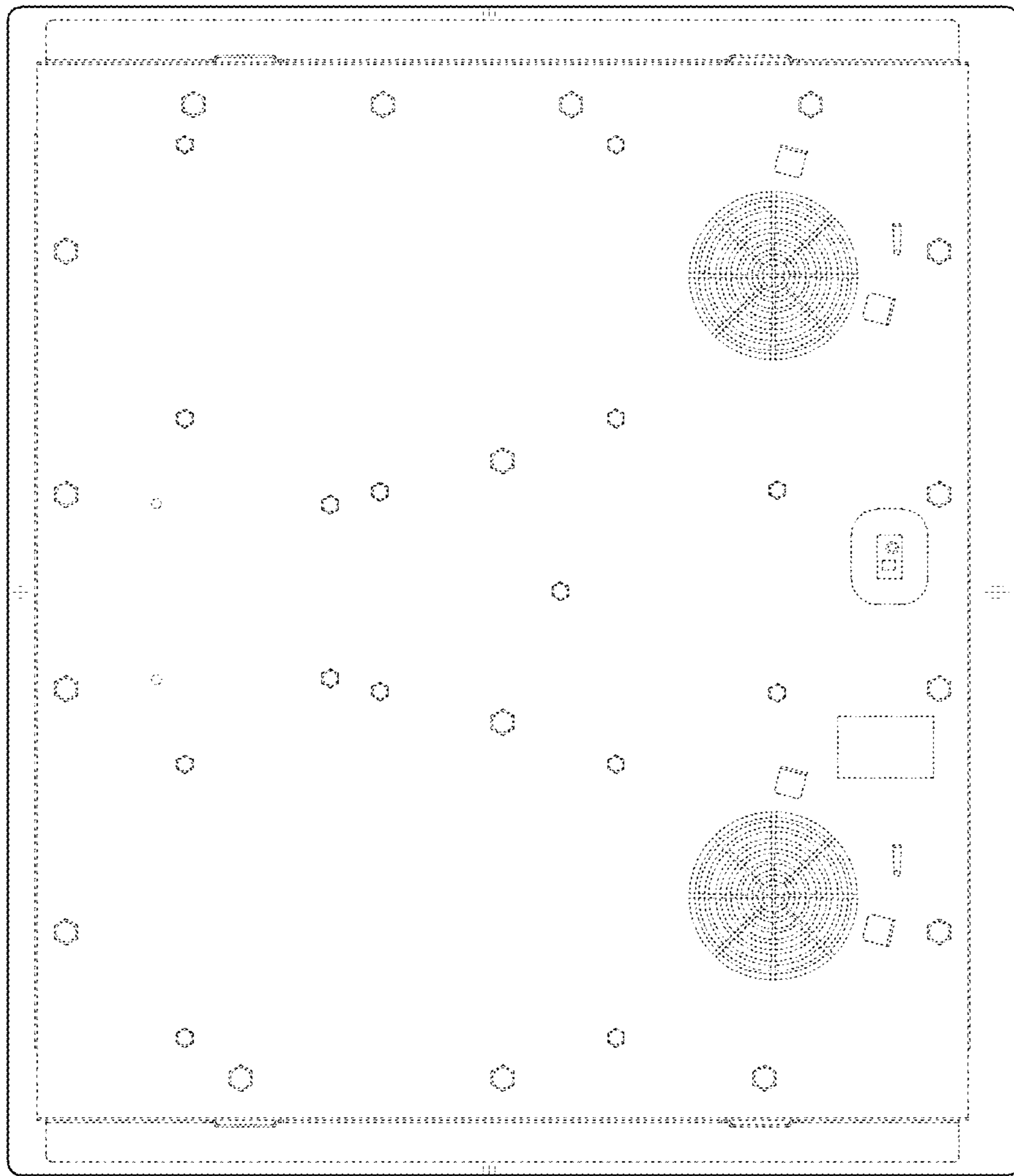
