**DESCRIPTION**

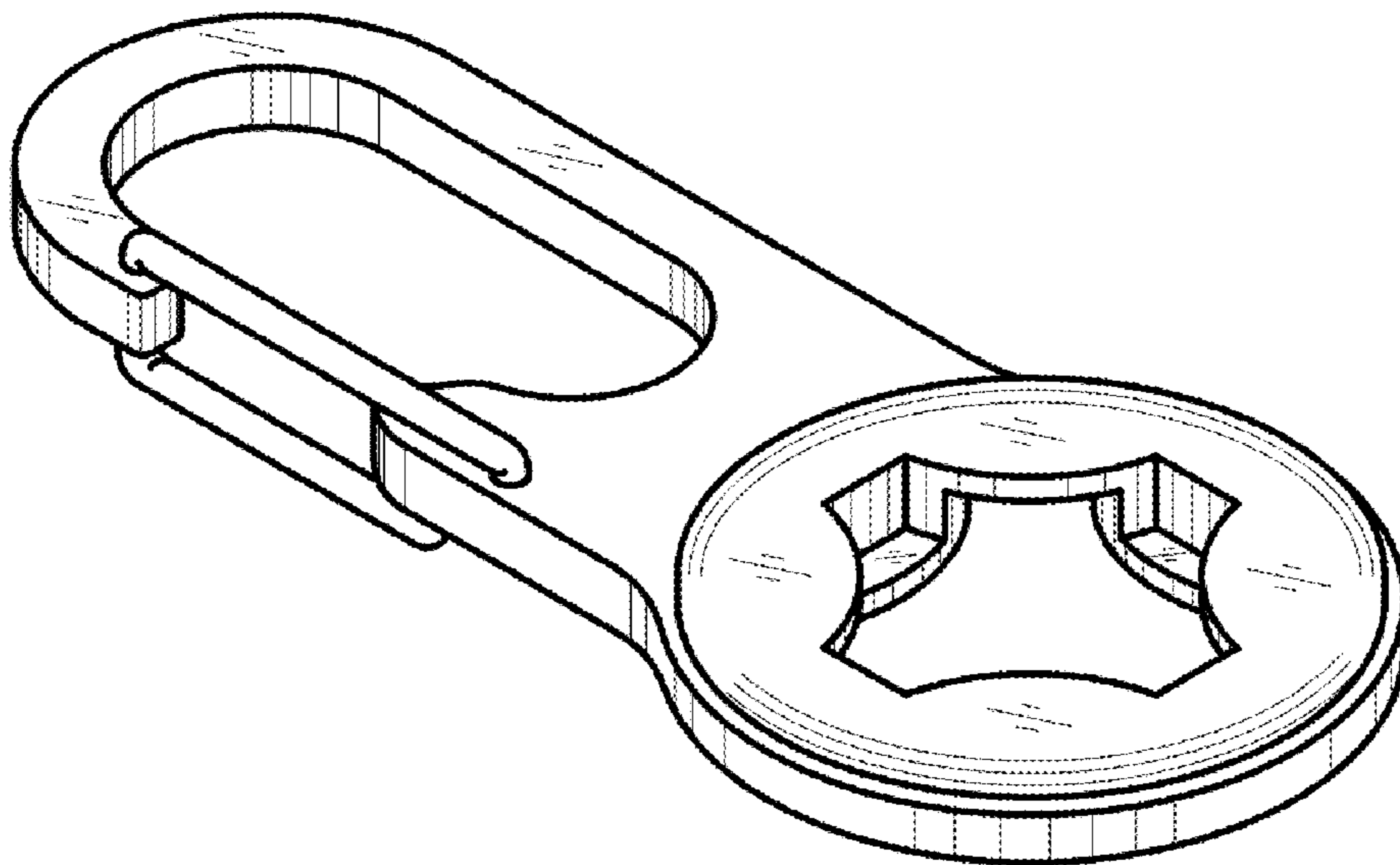
FIG. 1 is a top perspective view of a knob adjustment

part of the claimed design.

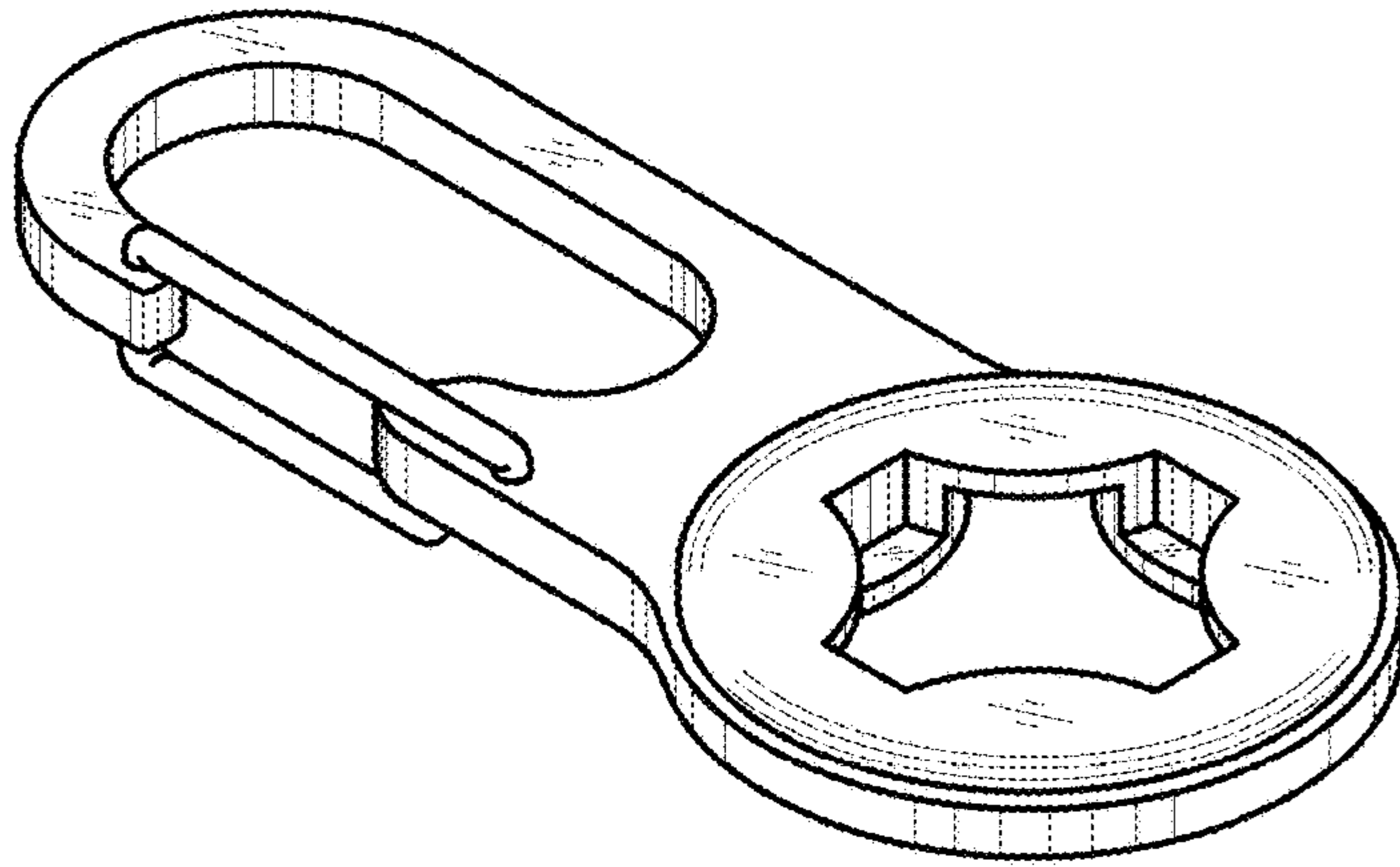

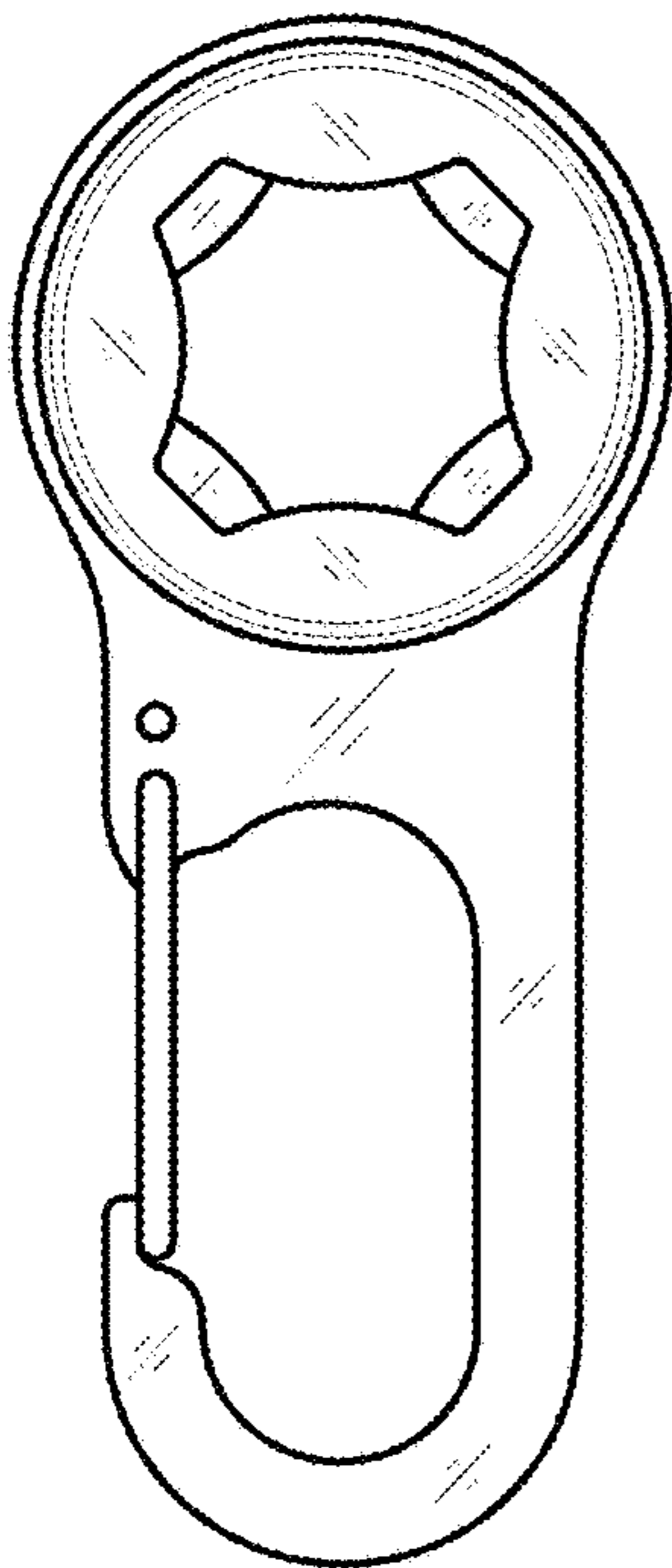

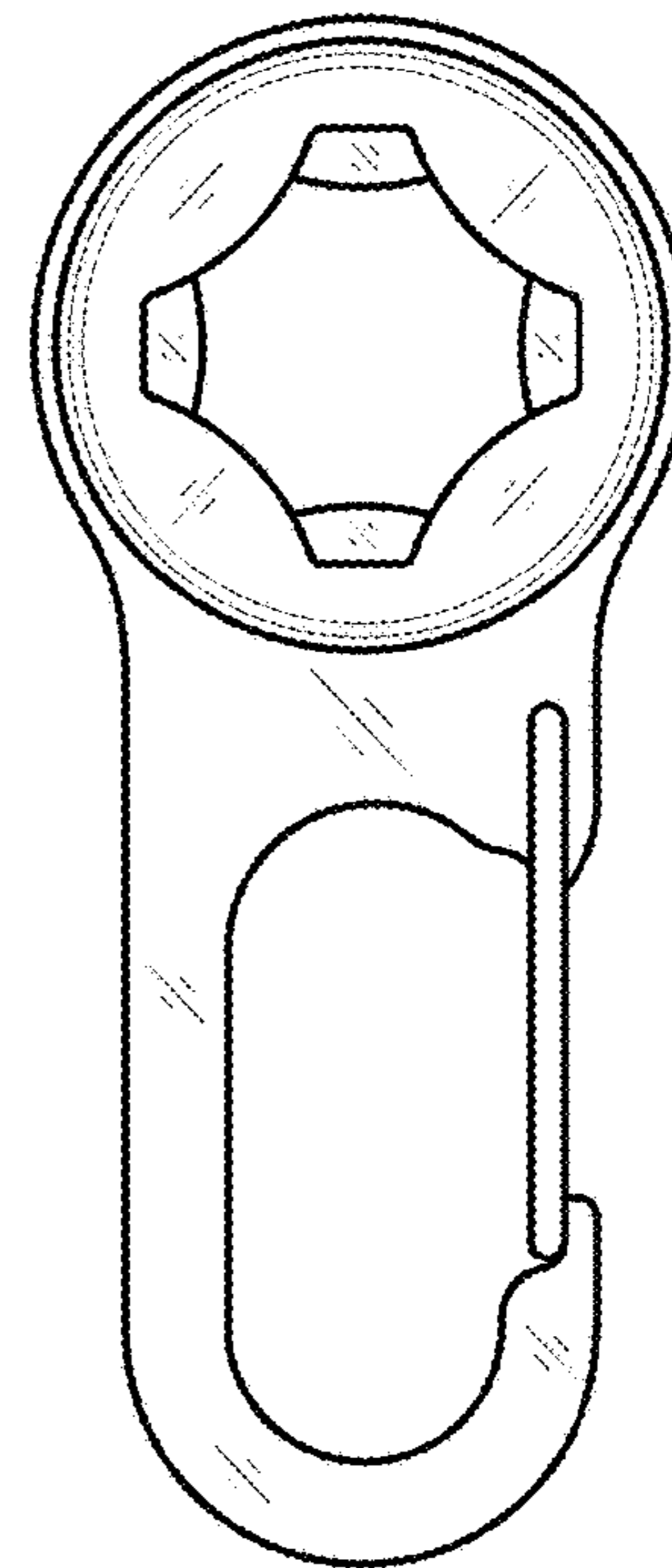

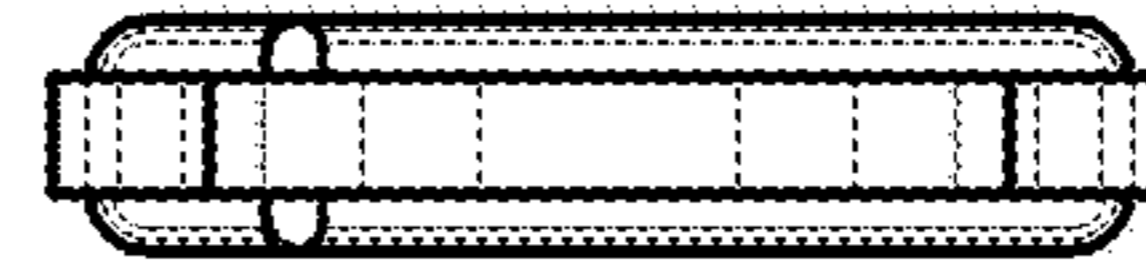

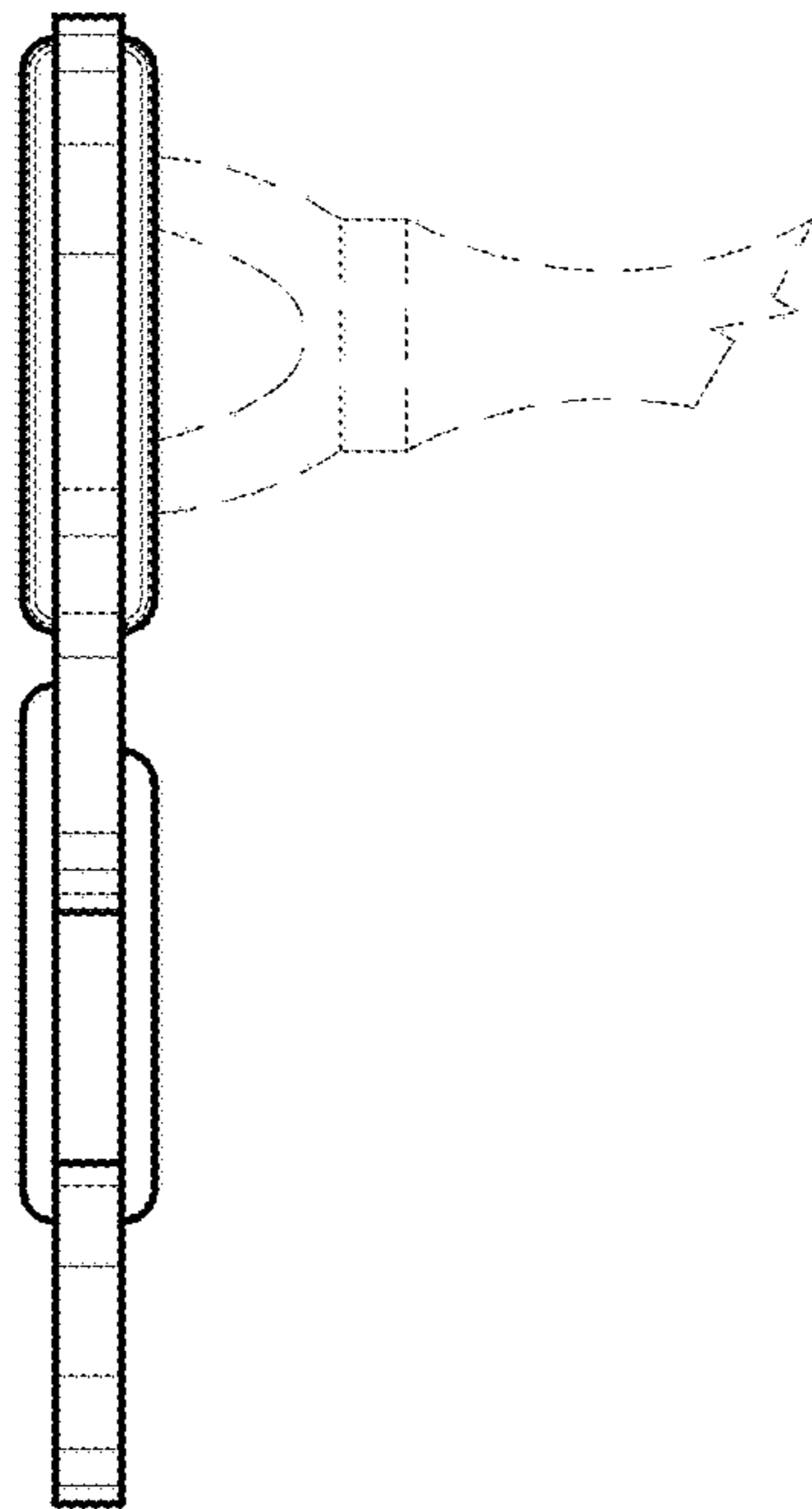

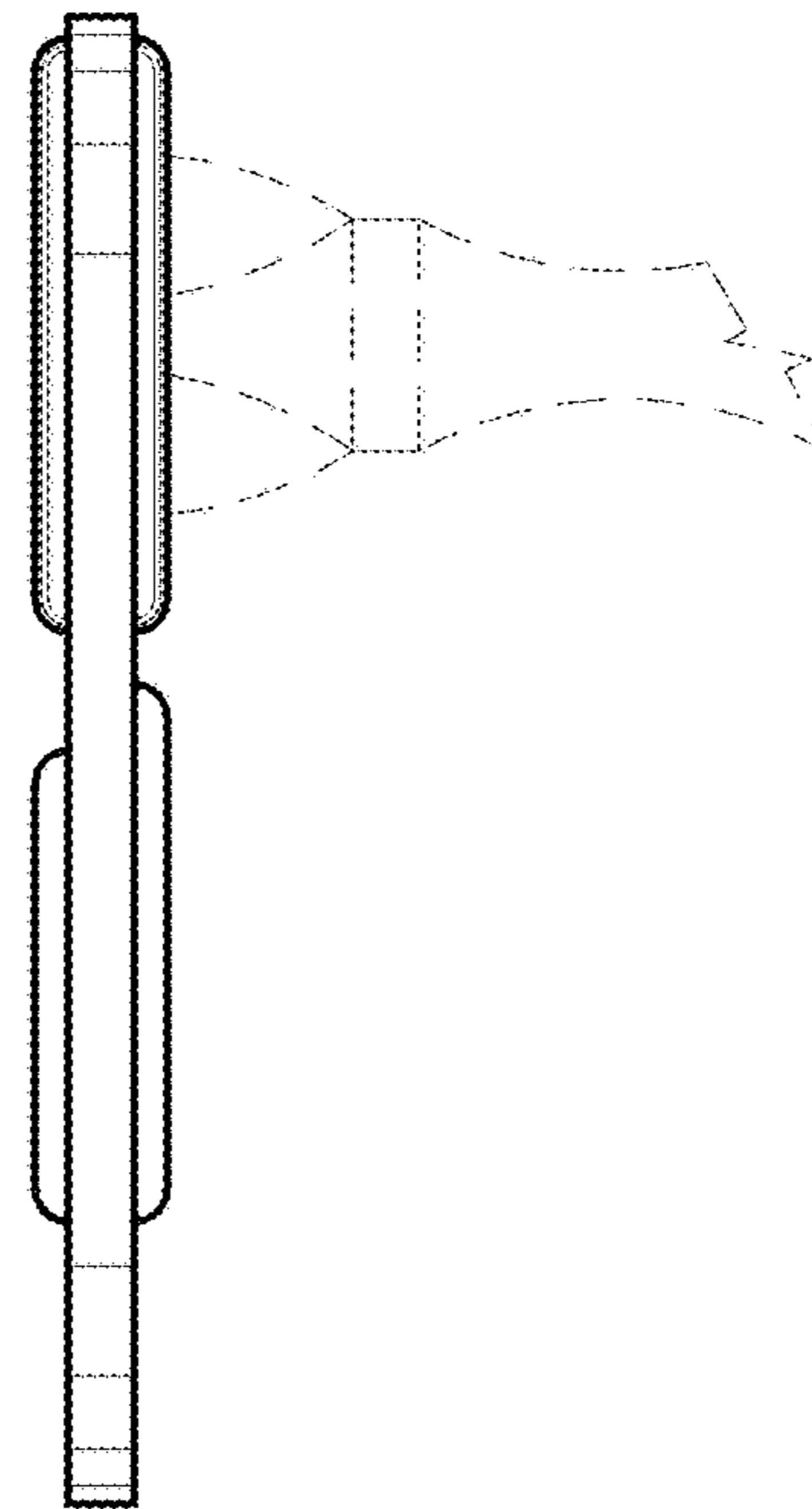

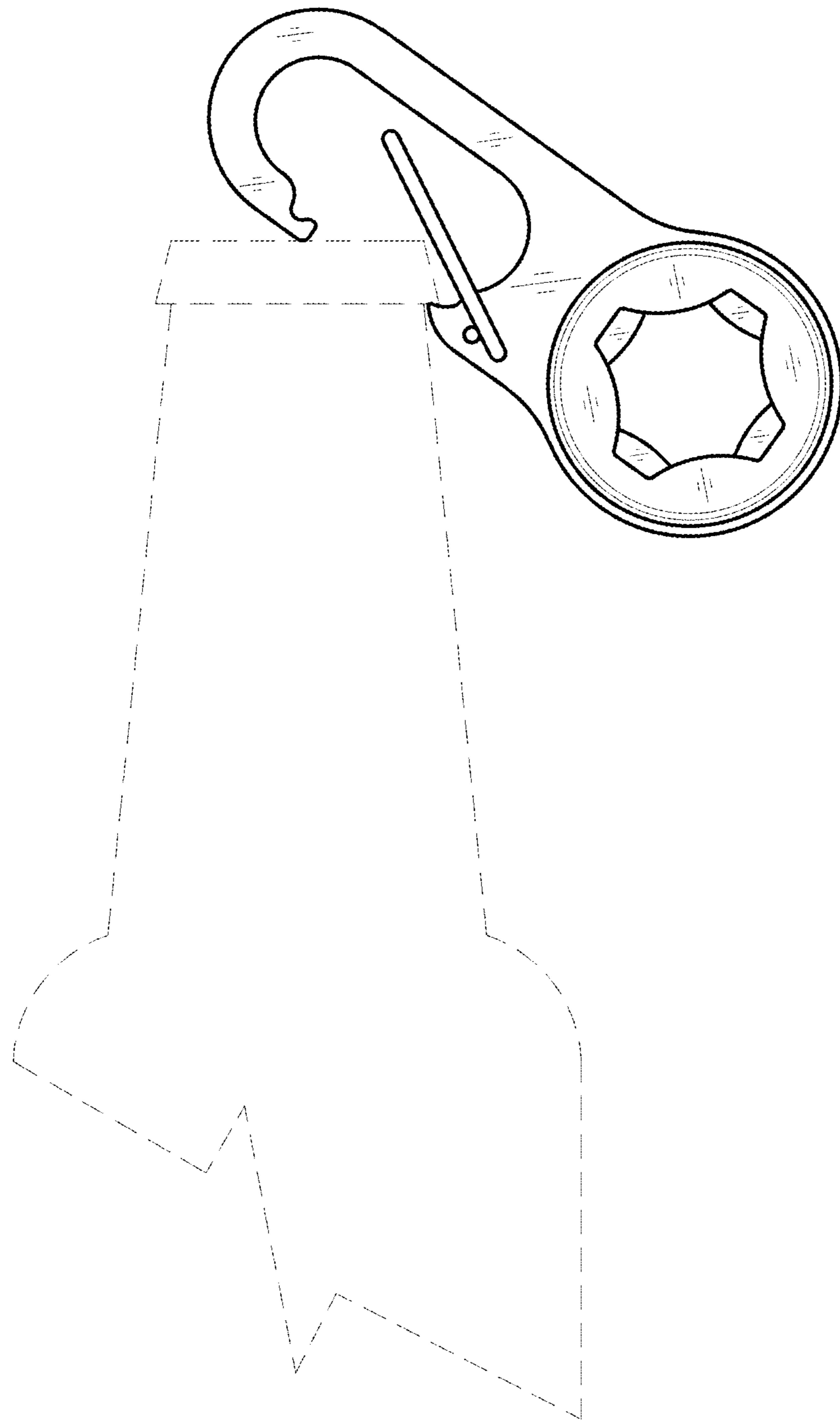
