**DESCRIPTION**

FIG. 1 is a first perspective view of a container, comprising  
a top portion and a bottom portion showing my new design.  
FIG. 2 is a front elevational view thereof.

FIG. 3 is a rear elevational view thereof. The left and right  
side elevational views are identical to the rear view shown.

FIG. 4 is a top plan view thereof.

FIG. 5 is a bottom plan view thereof.

FIG. 6 is a bottom perspective view thereof.

FIG. 7 is a cross-sectional view taken along line 7-7 of FIG.  
4.

FIG. 8 is an perspective view thereof.

FIG. 9 is a cross-sectional view taken along line 9-9 of FIG.  
4.

FIG. 10 is a perspective view of the bottom portion of the

FIG. 11 is a front elevational view thereof.

FIG. 12 is a rear elevational view thereof. The left and right  
side elevational views are identical to the rear view shown.

FIG. 14 is a bottom plan view thereof.

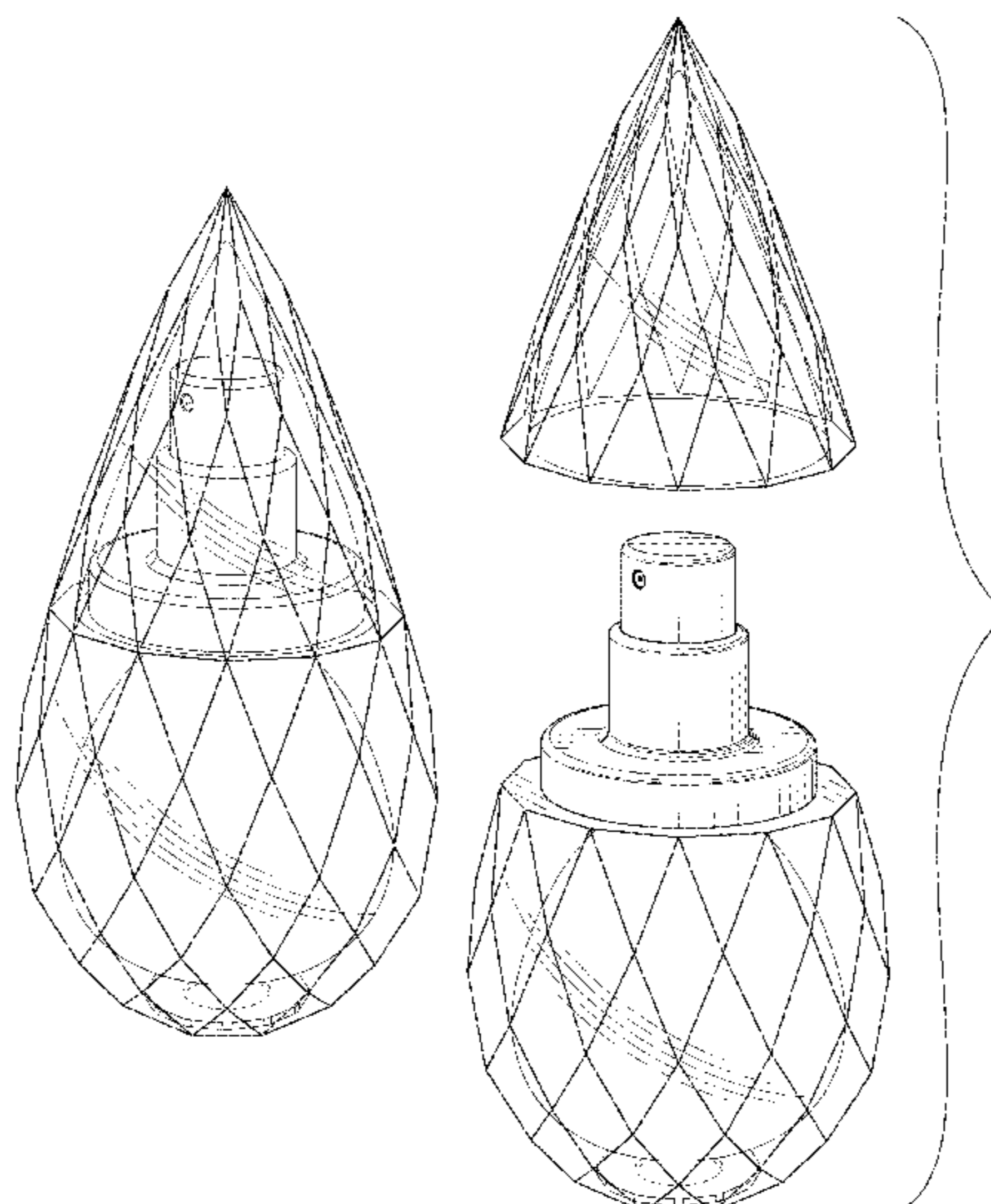
FIG. 15 is a perspective view of the top portion of the

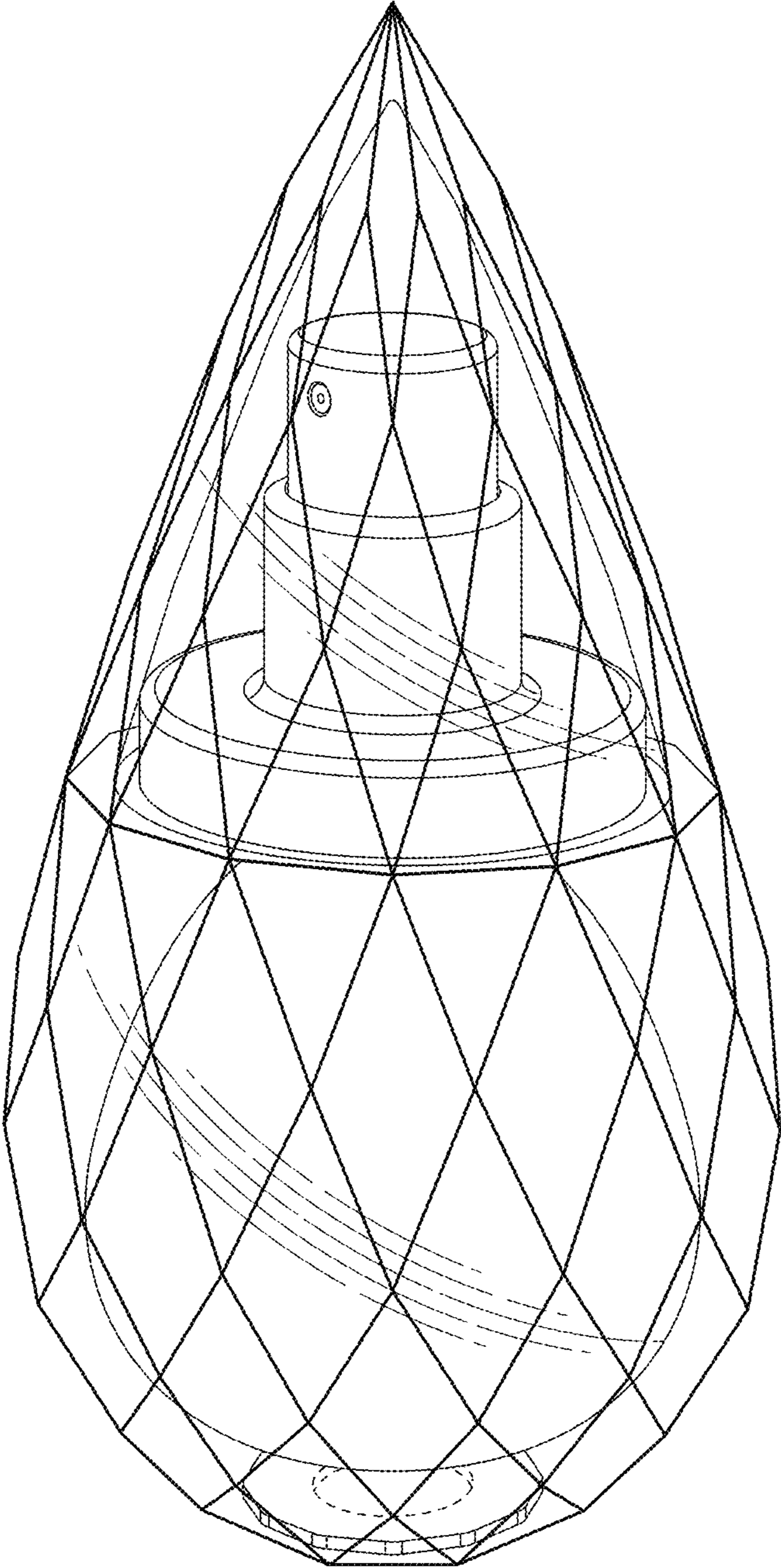

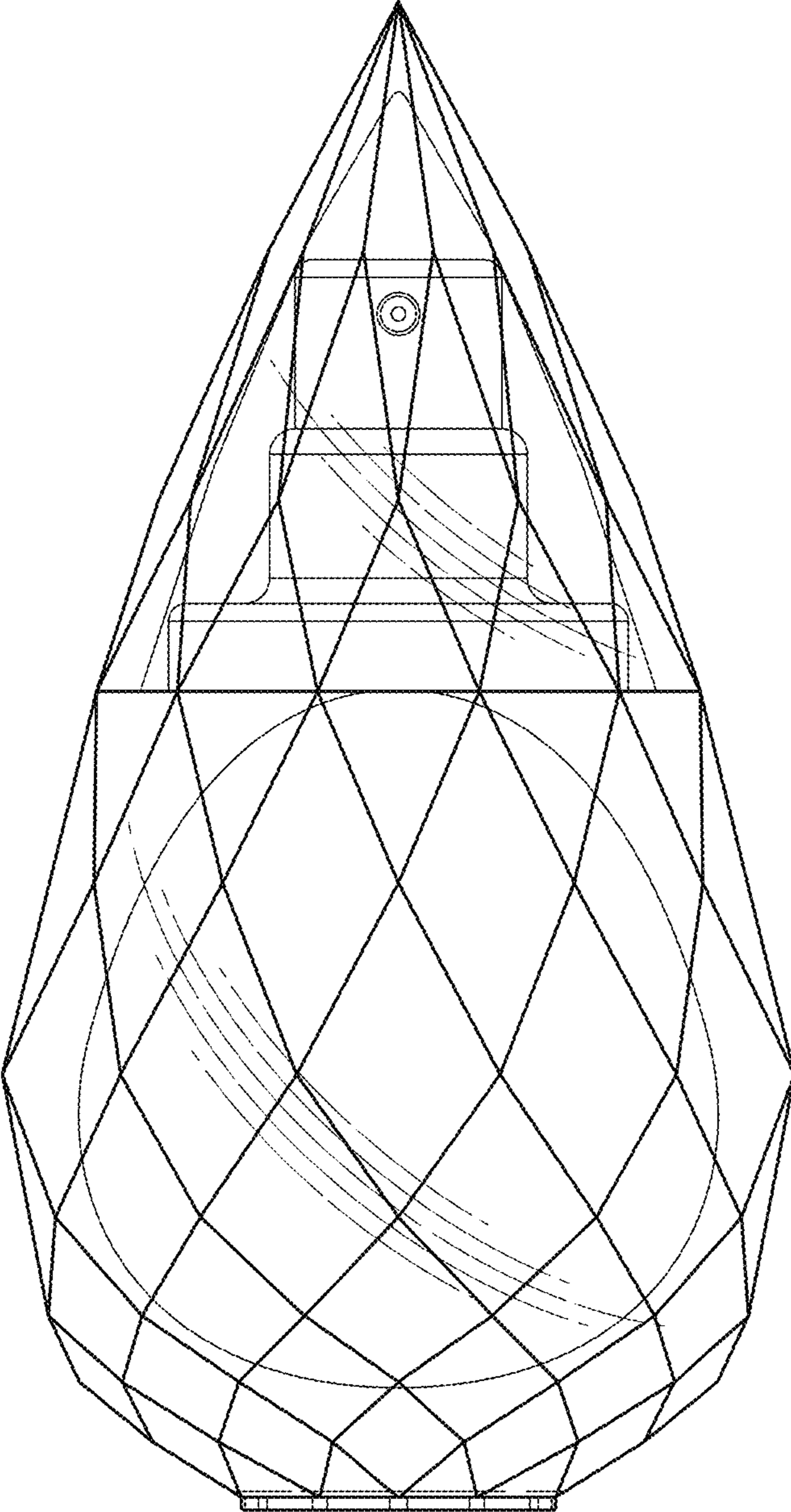

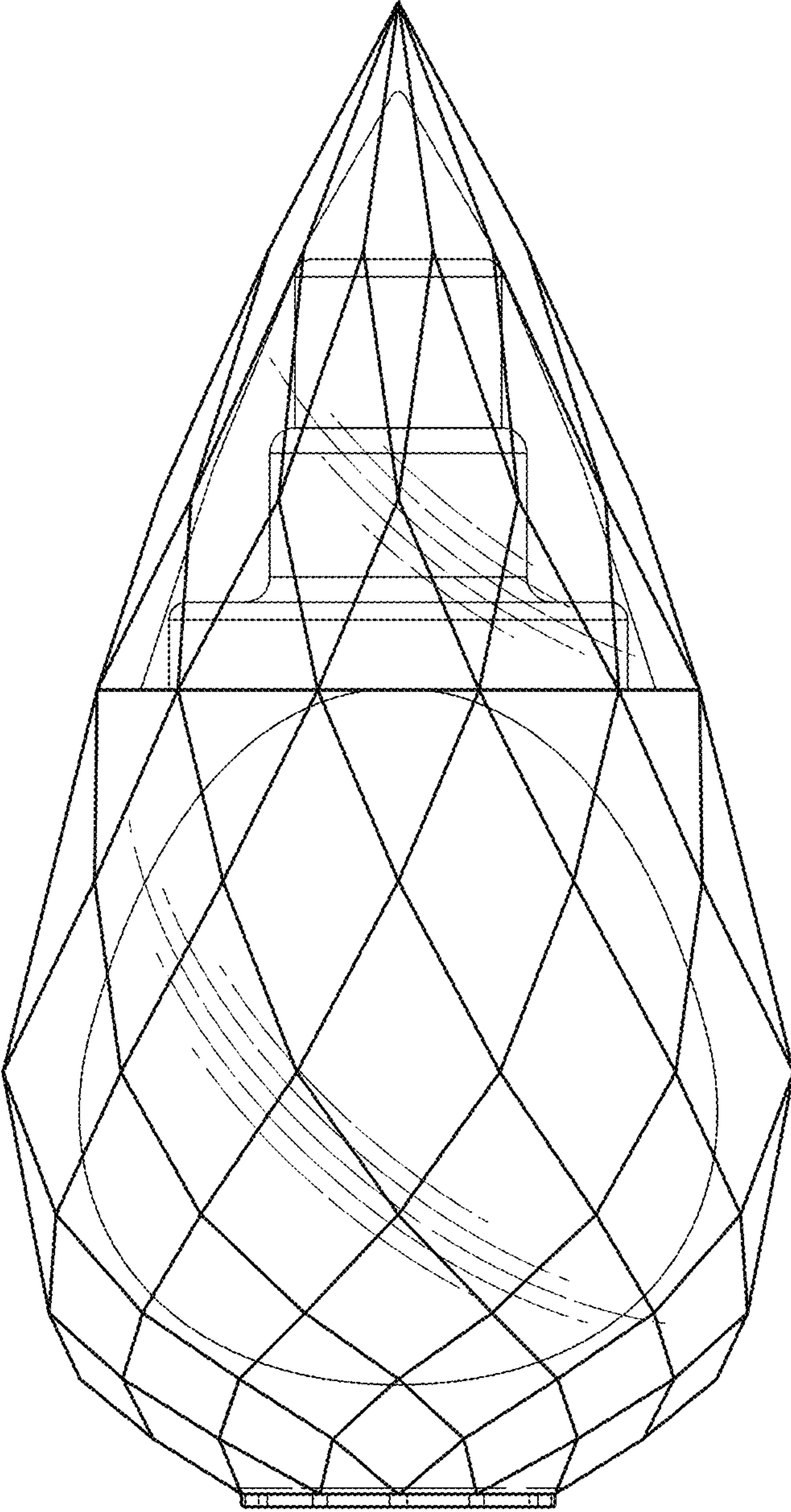

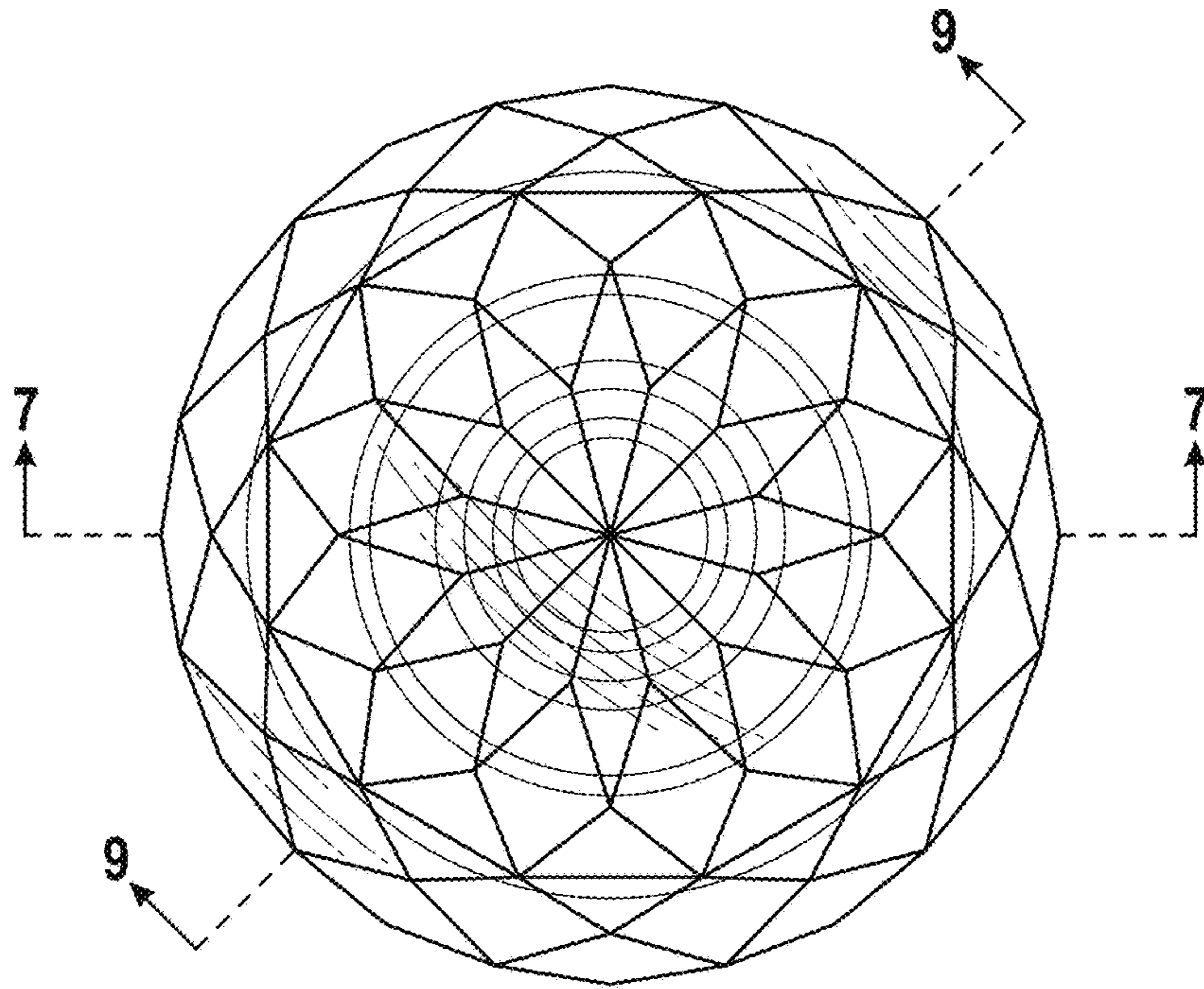

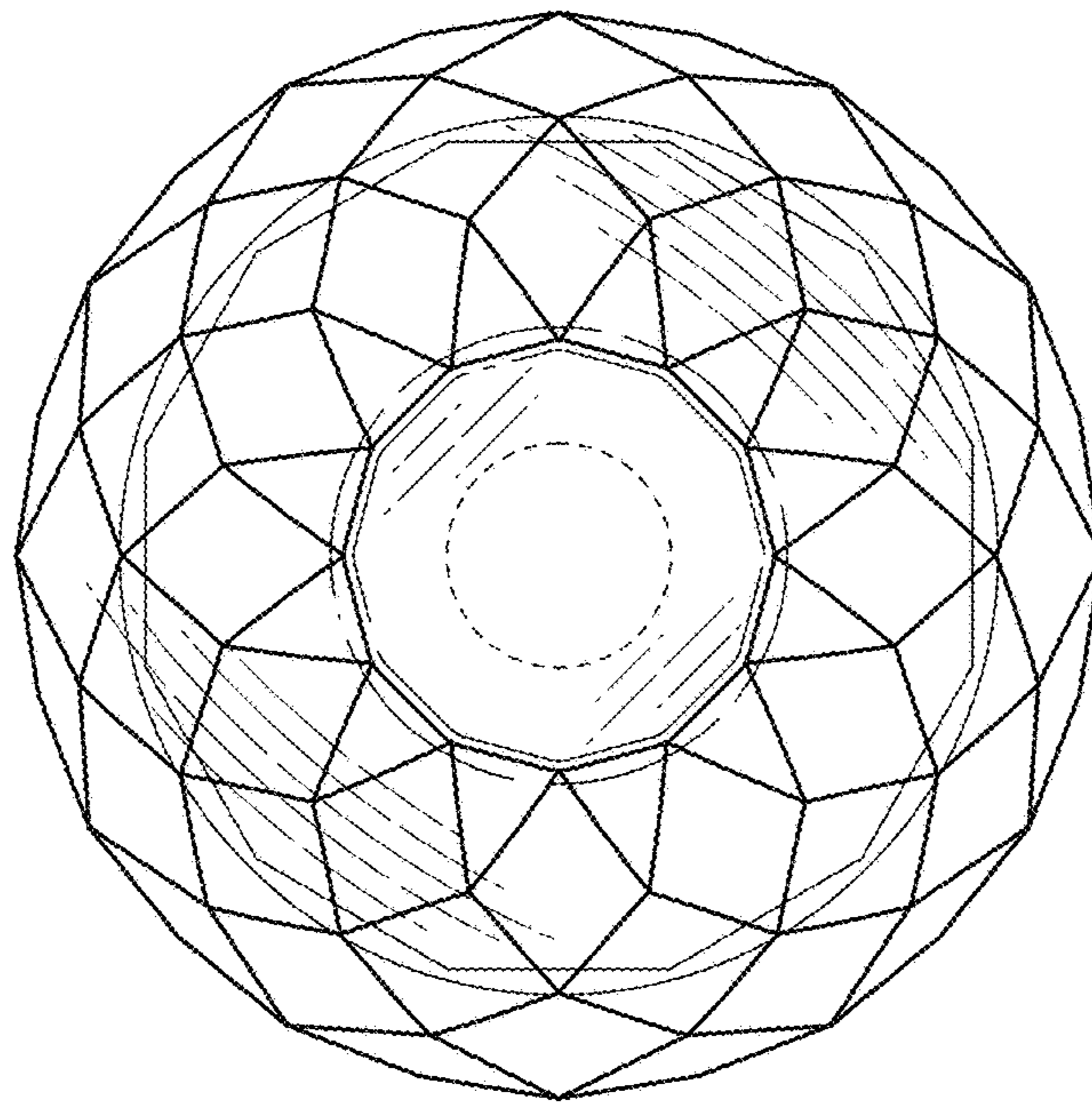

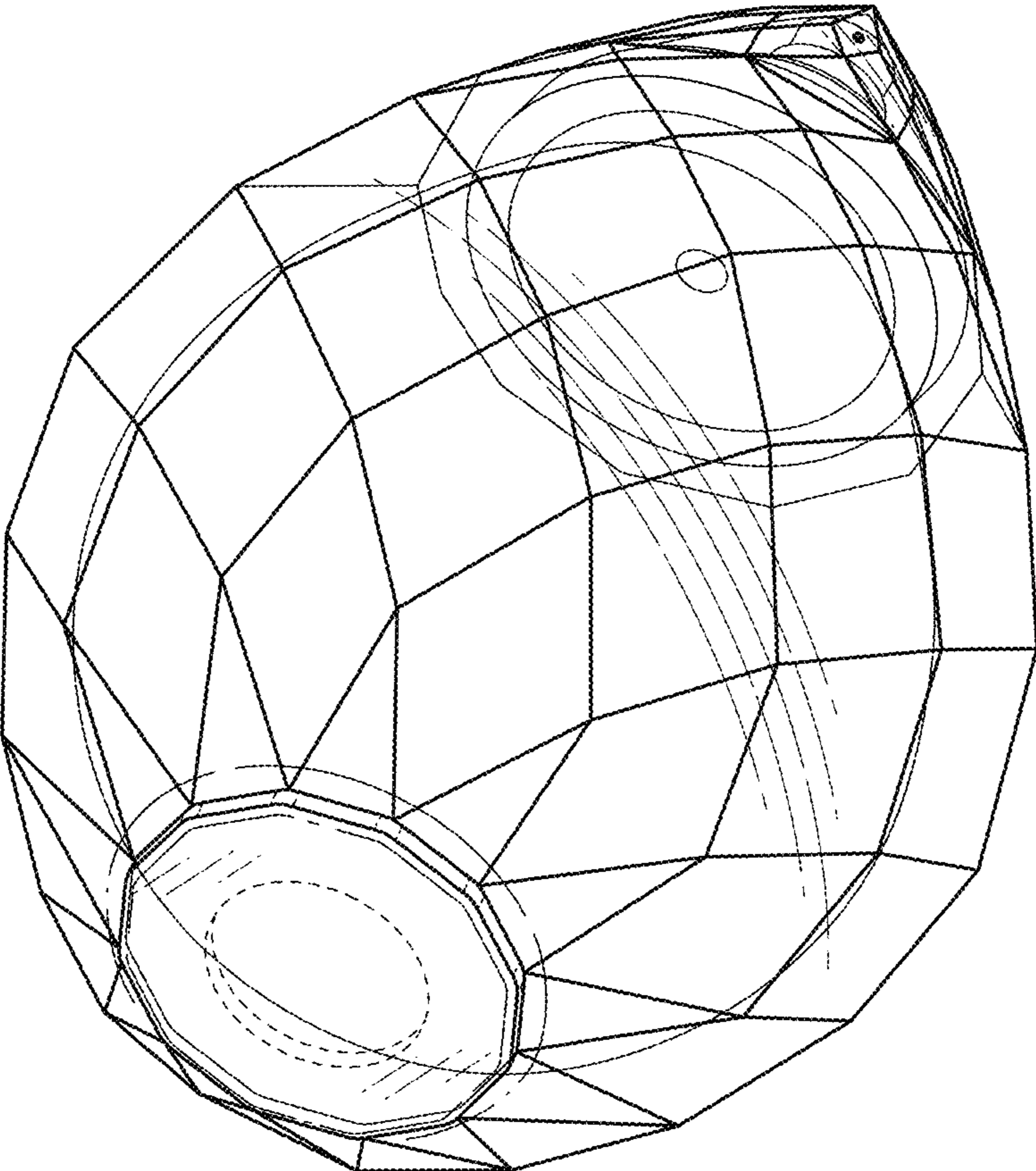

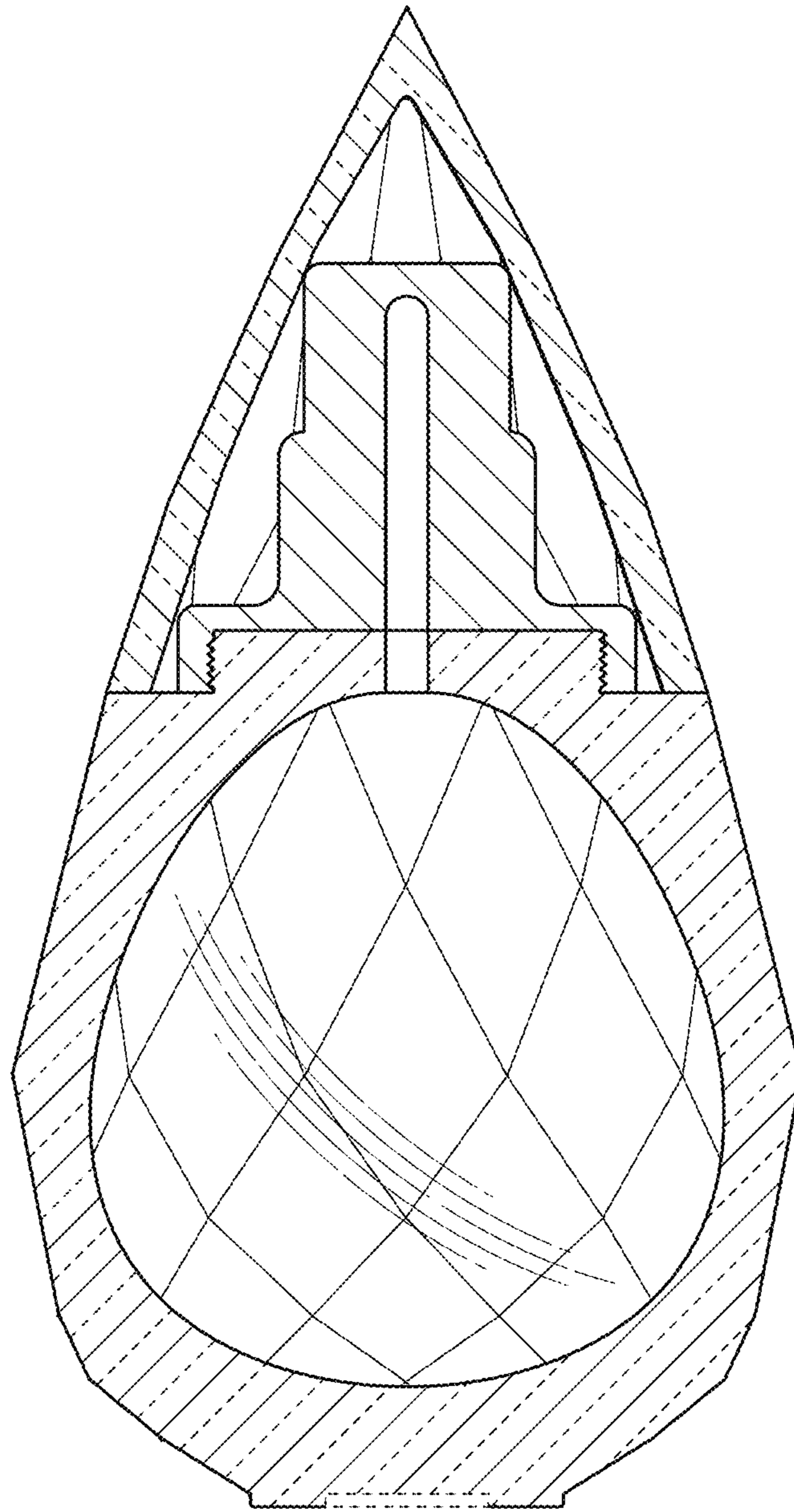

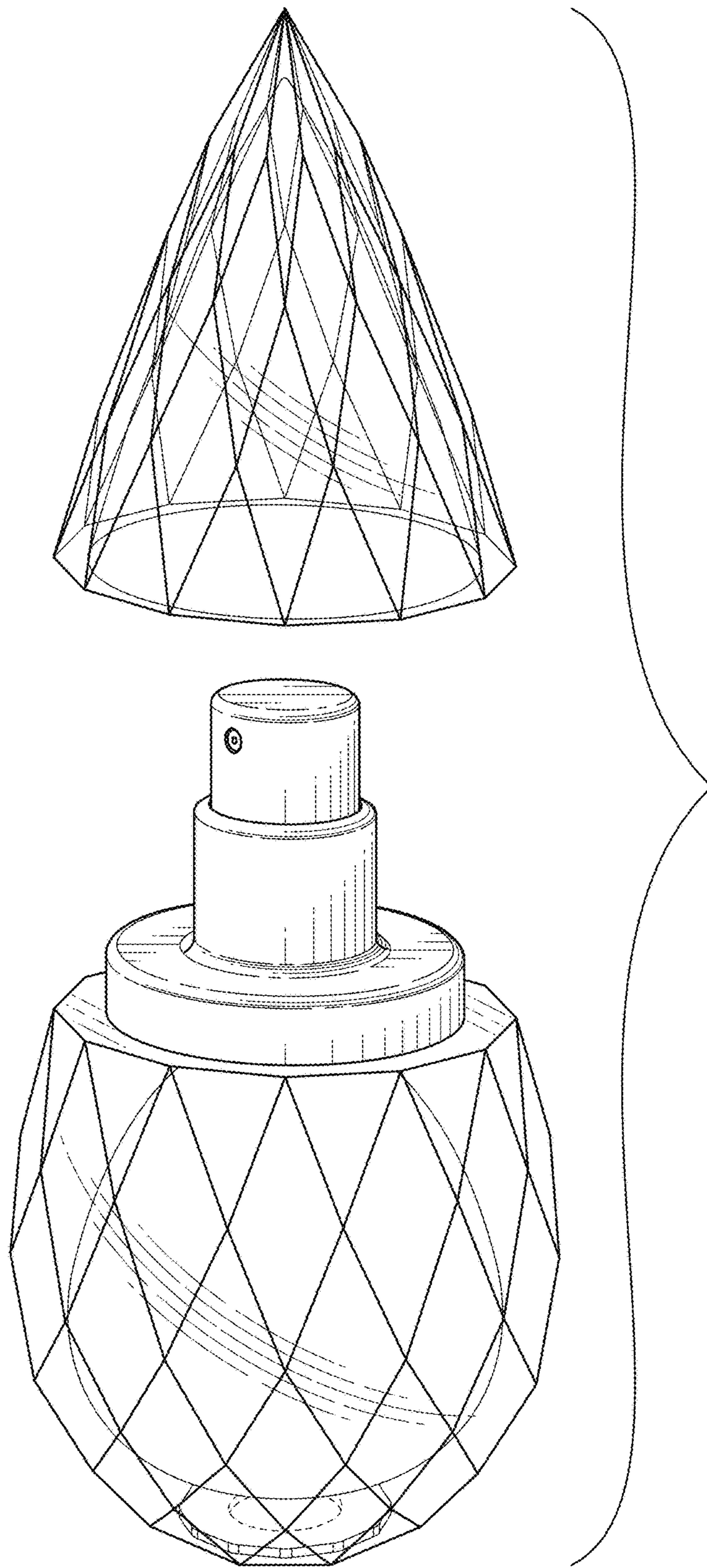

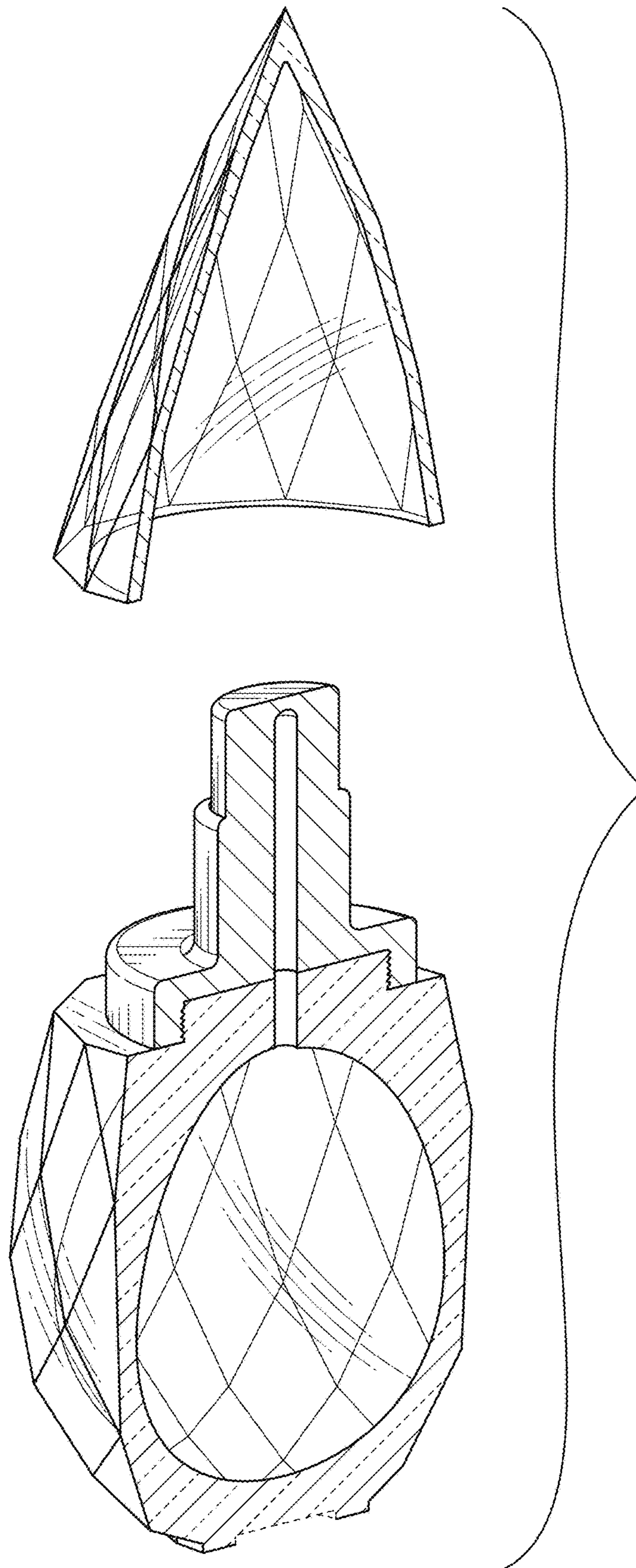

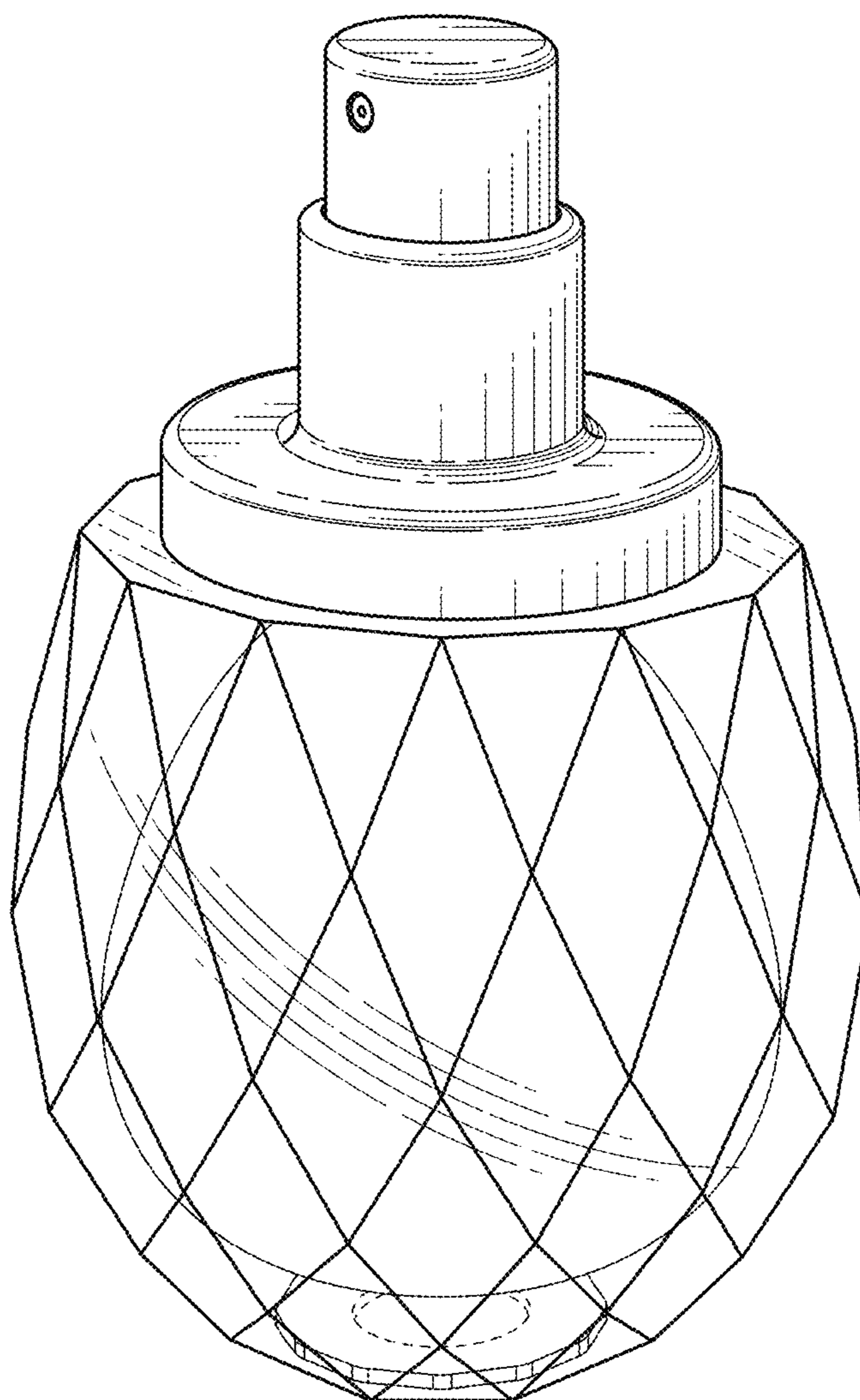

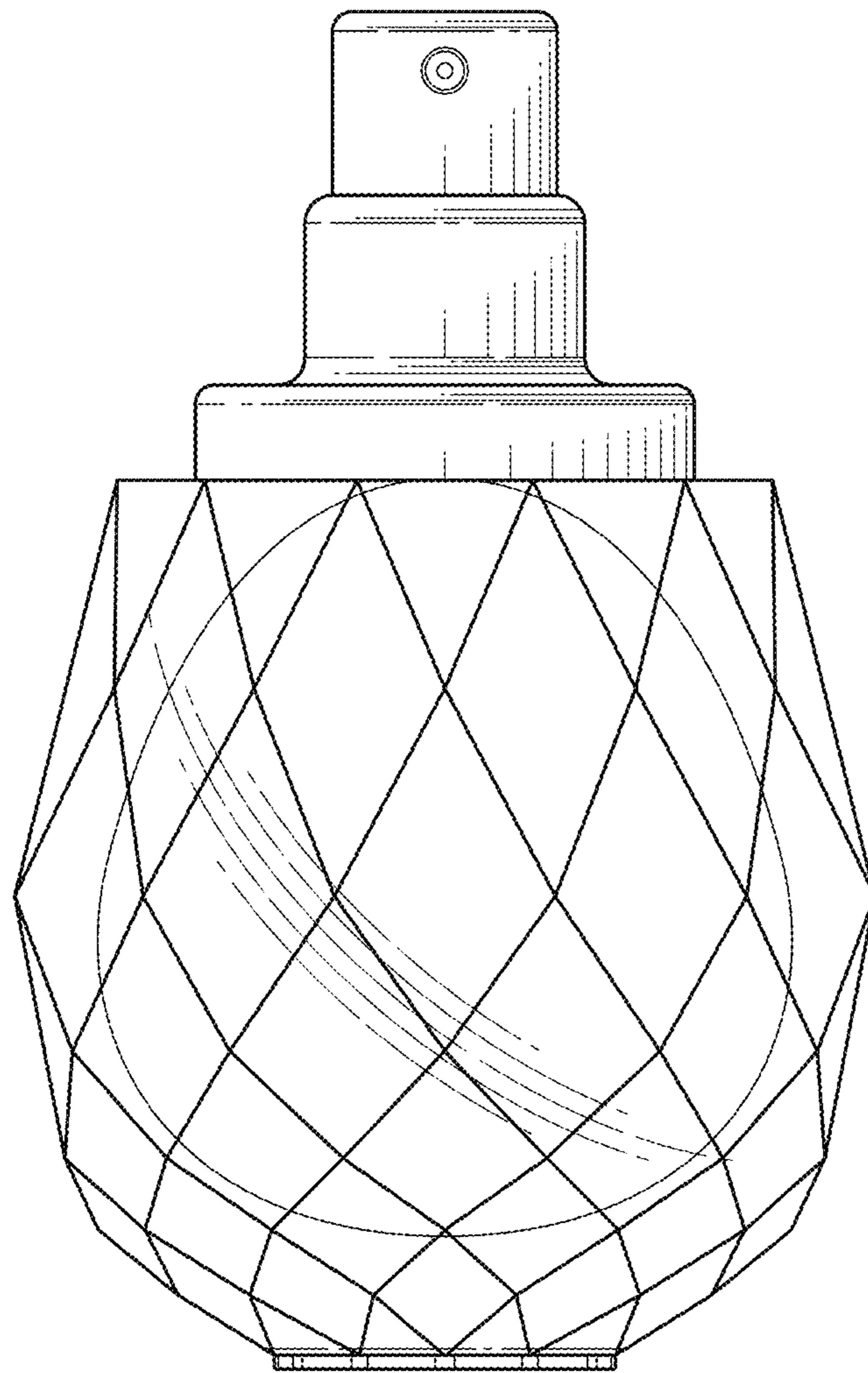

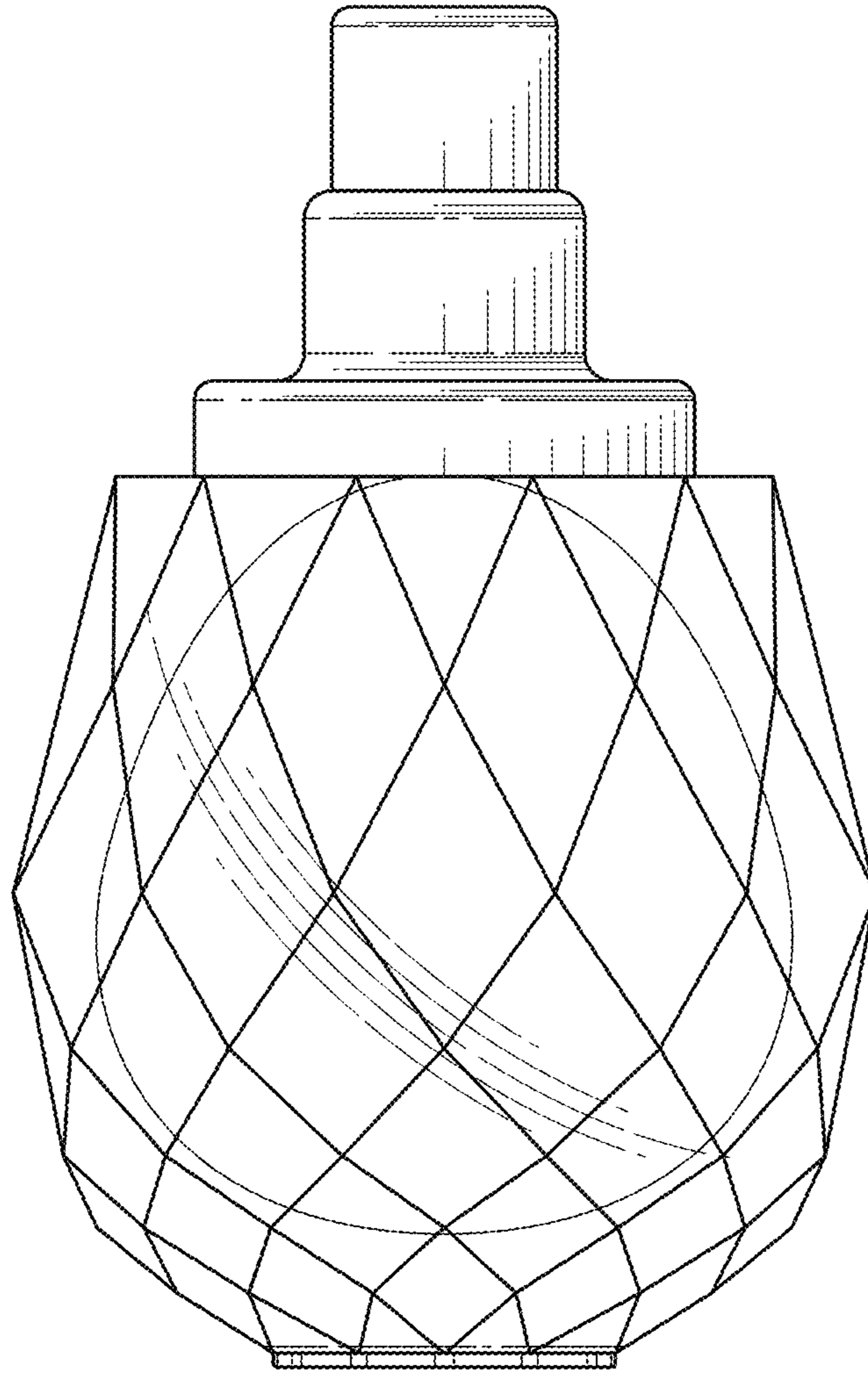

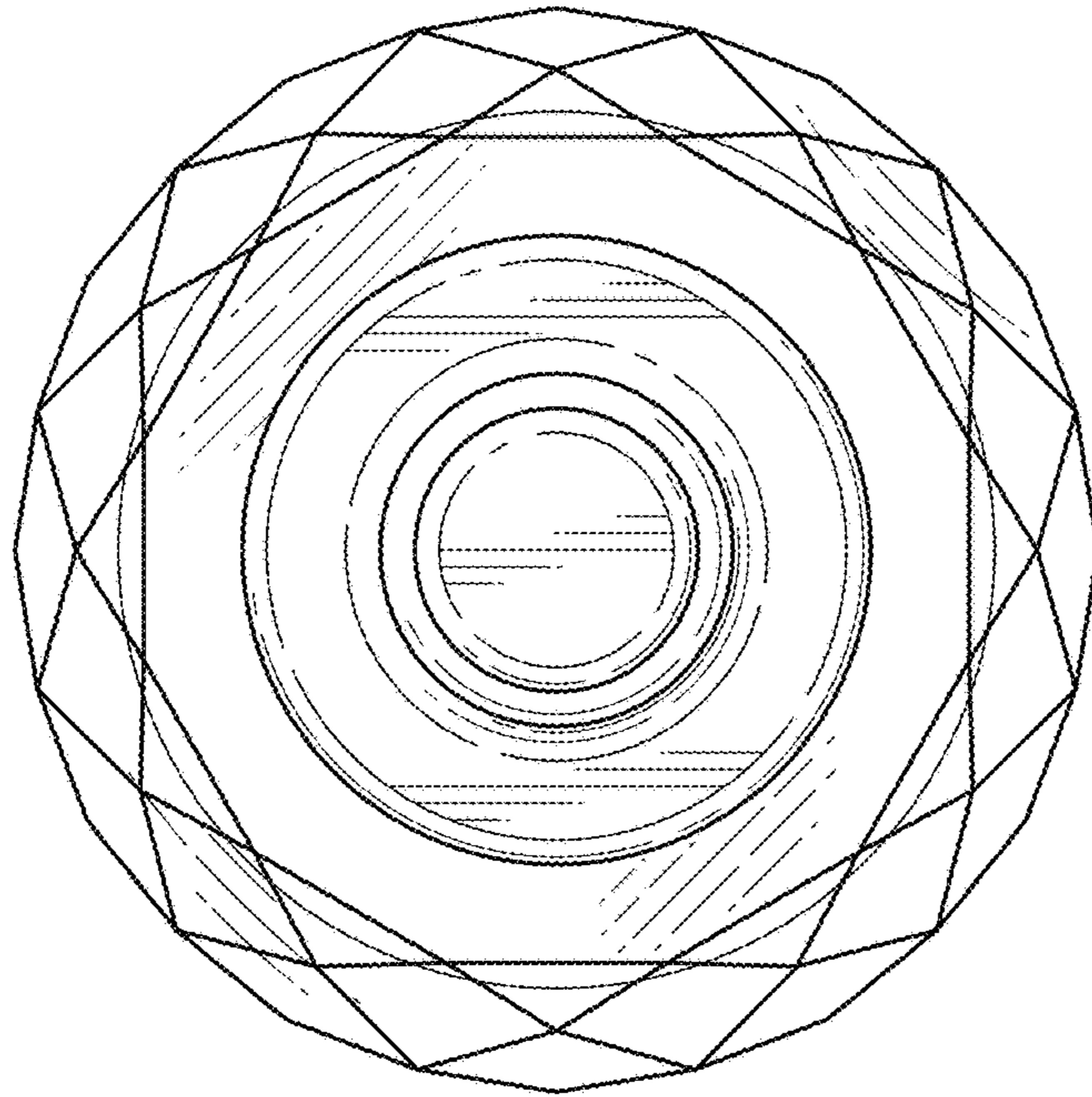

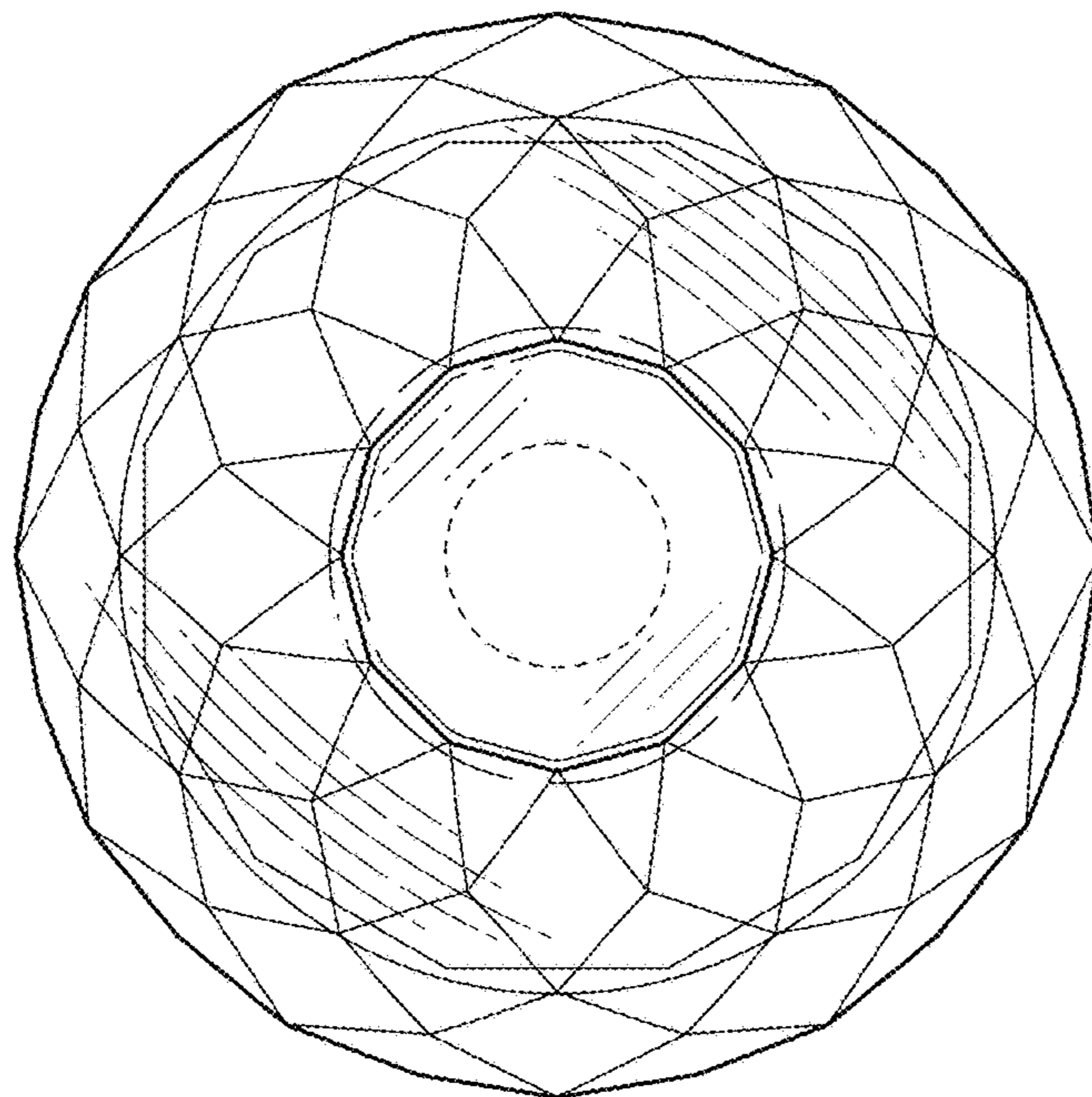

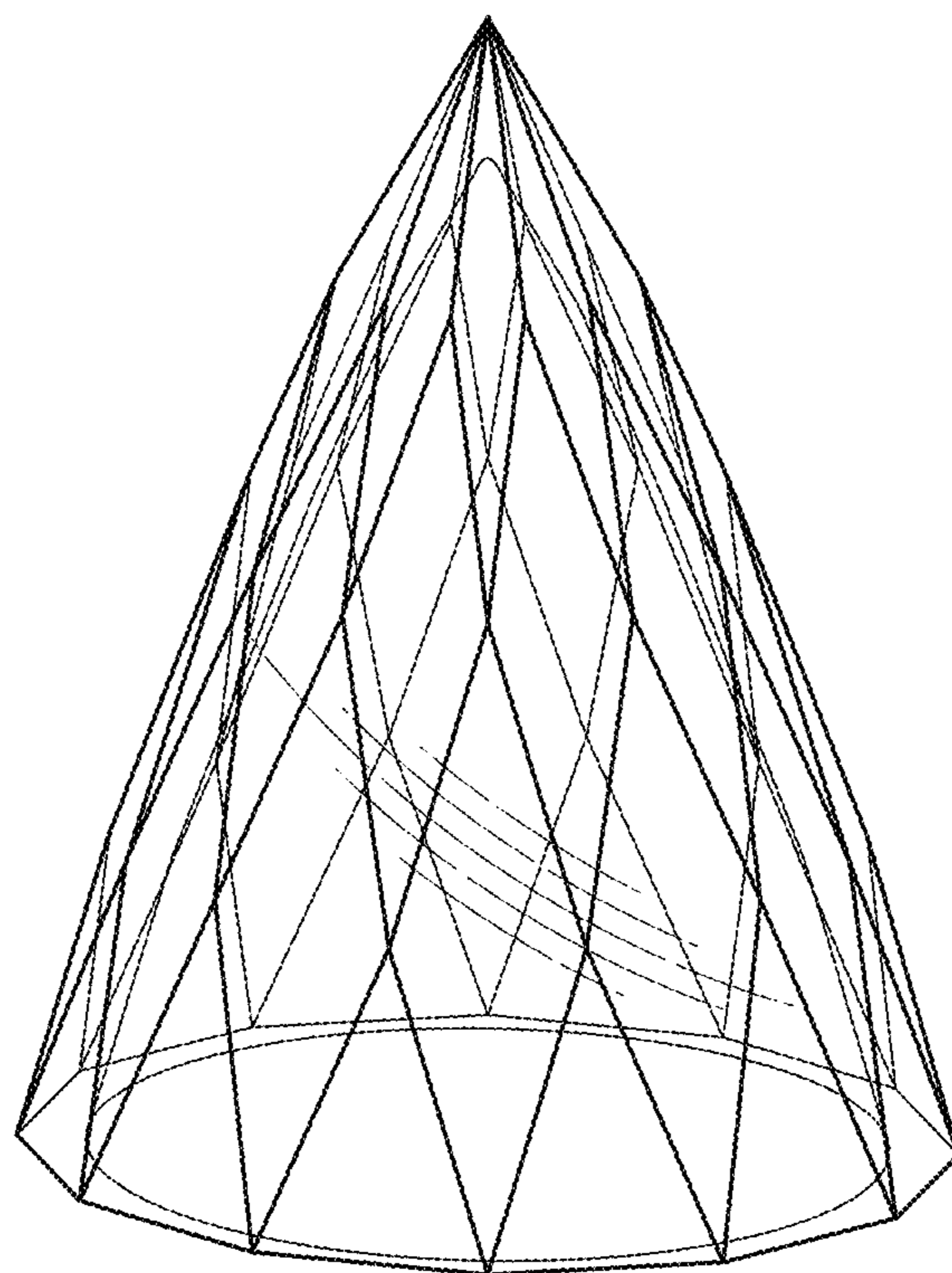

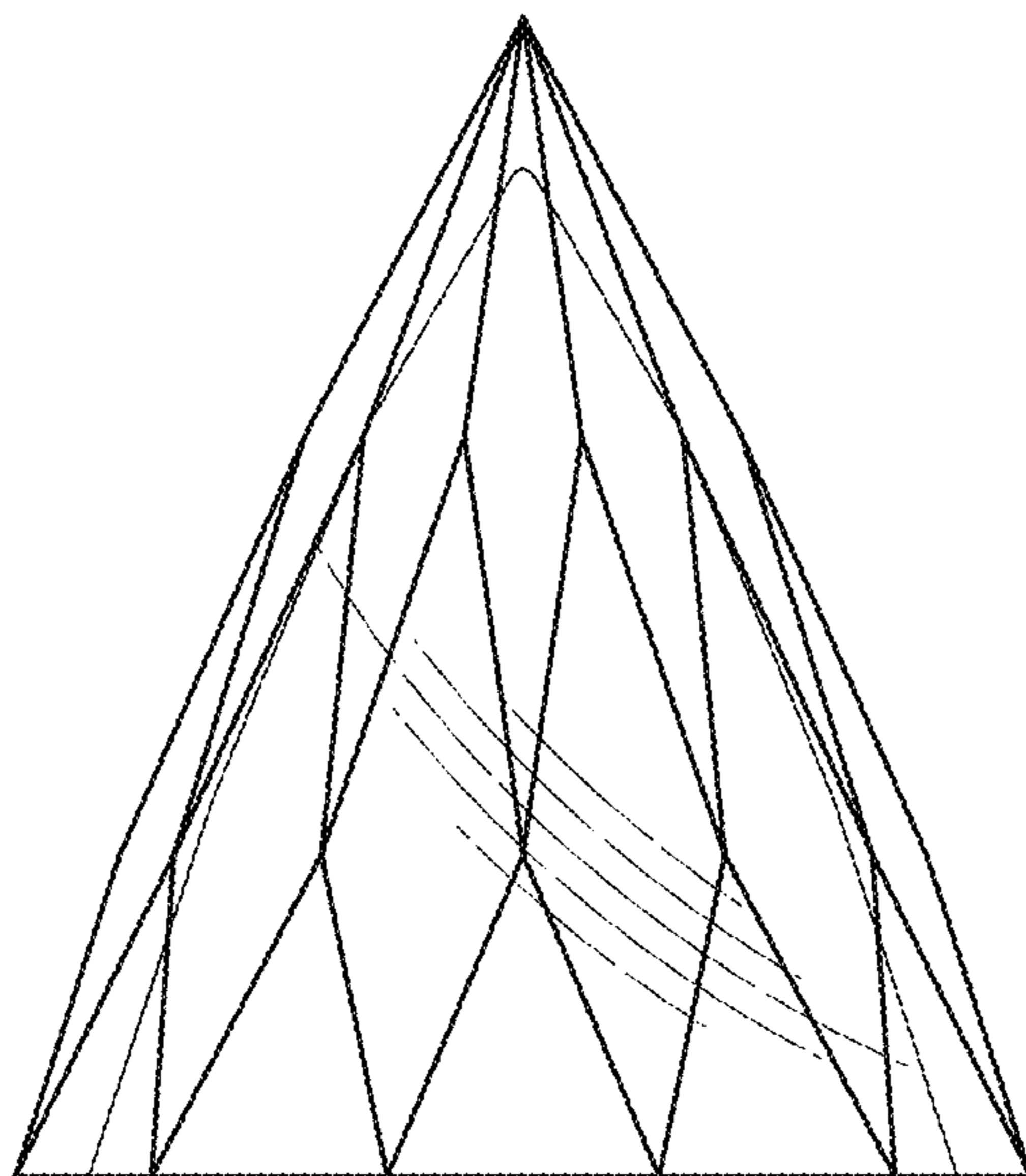

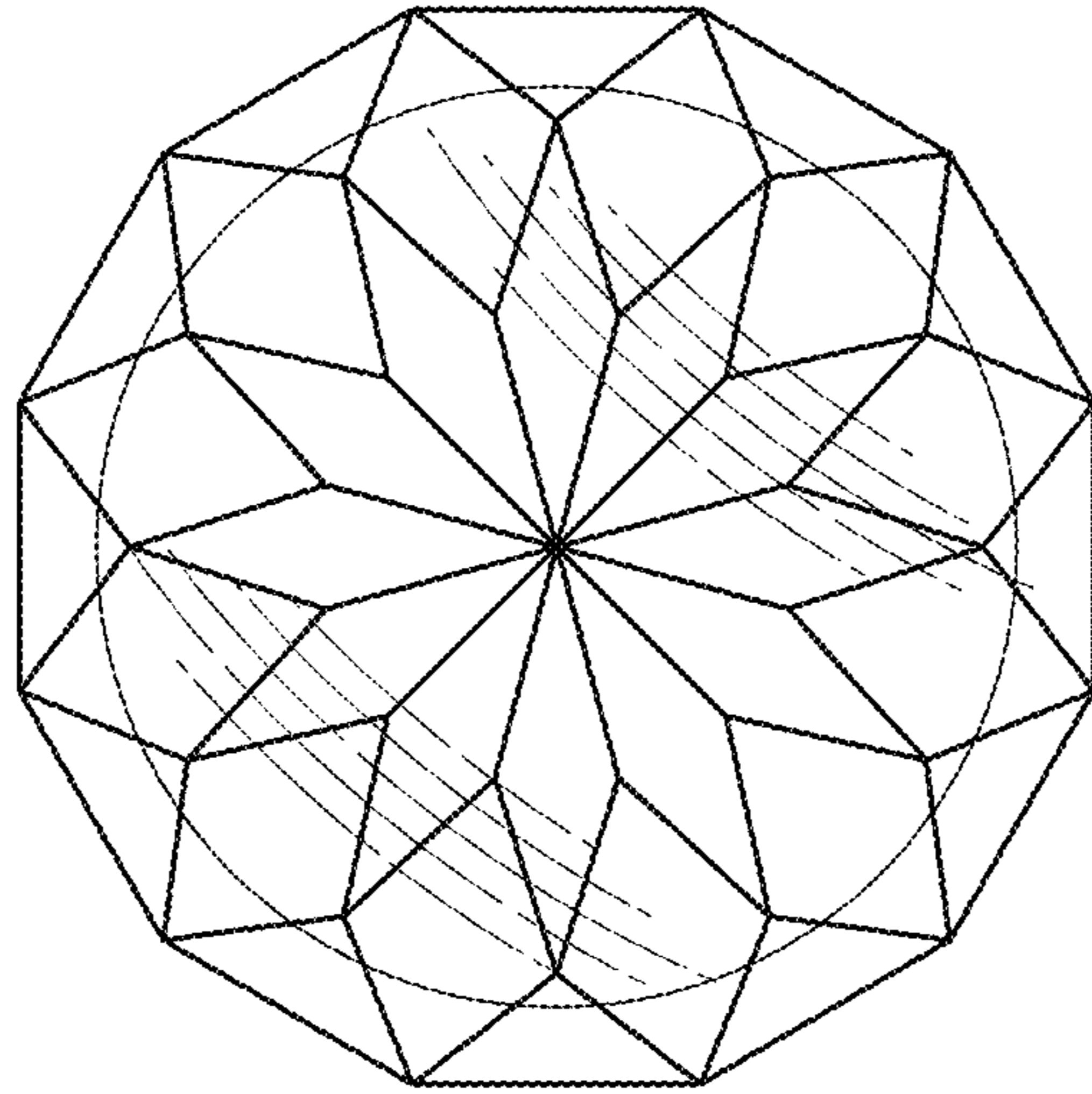

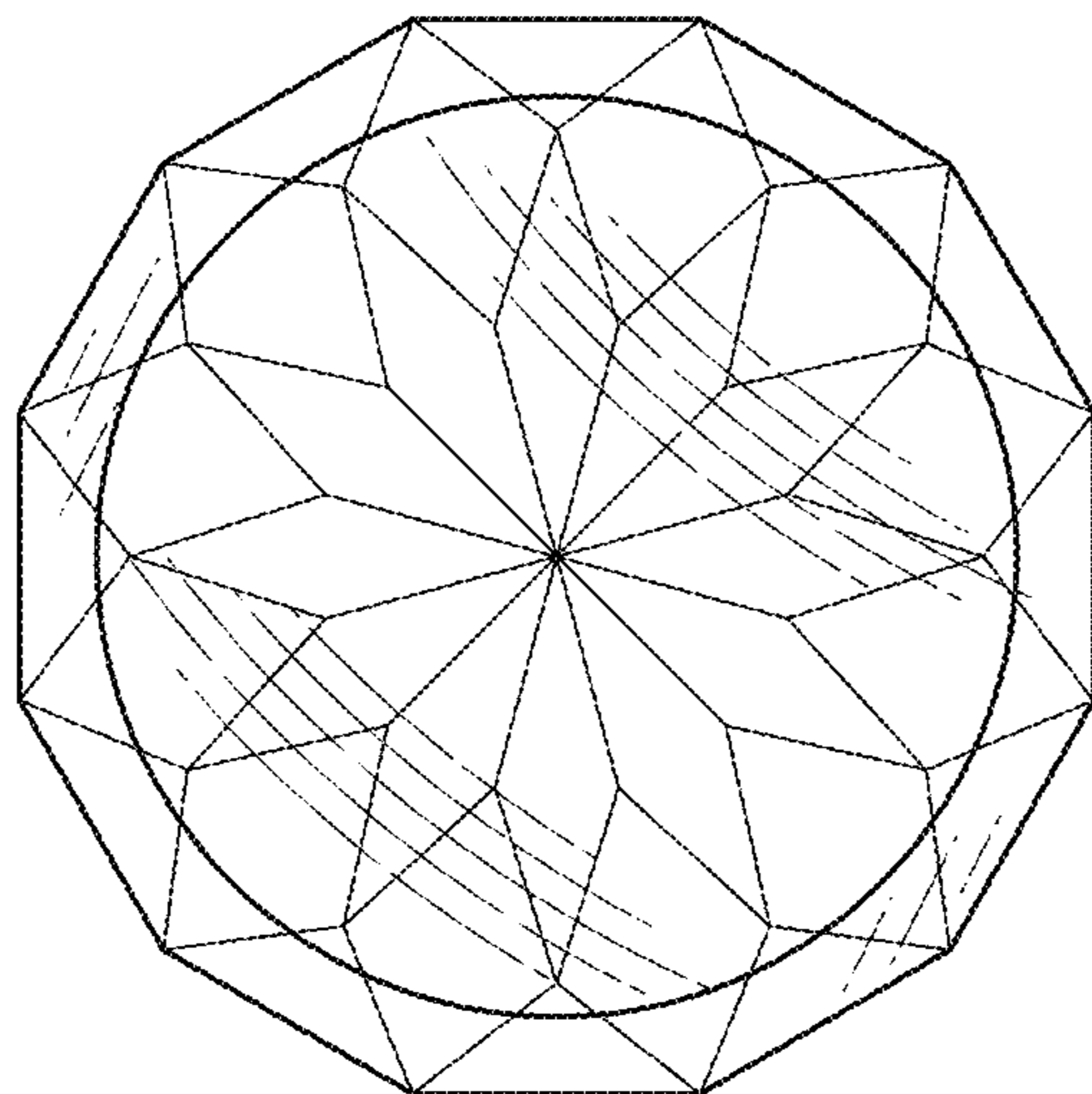
