We claim the ornamental design for a display screen or portion thereof with animated icon, as shown and described.

DESCRIPTION

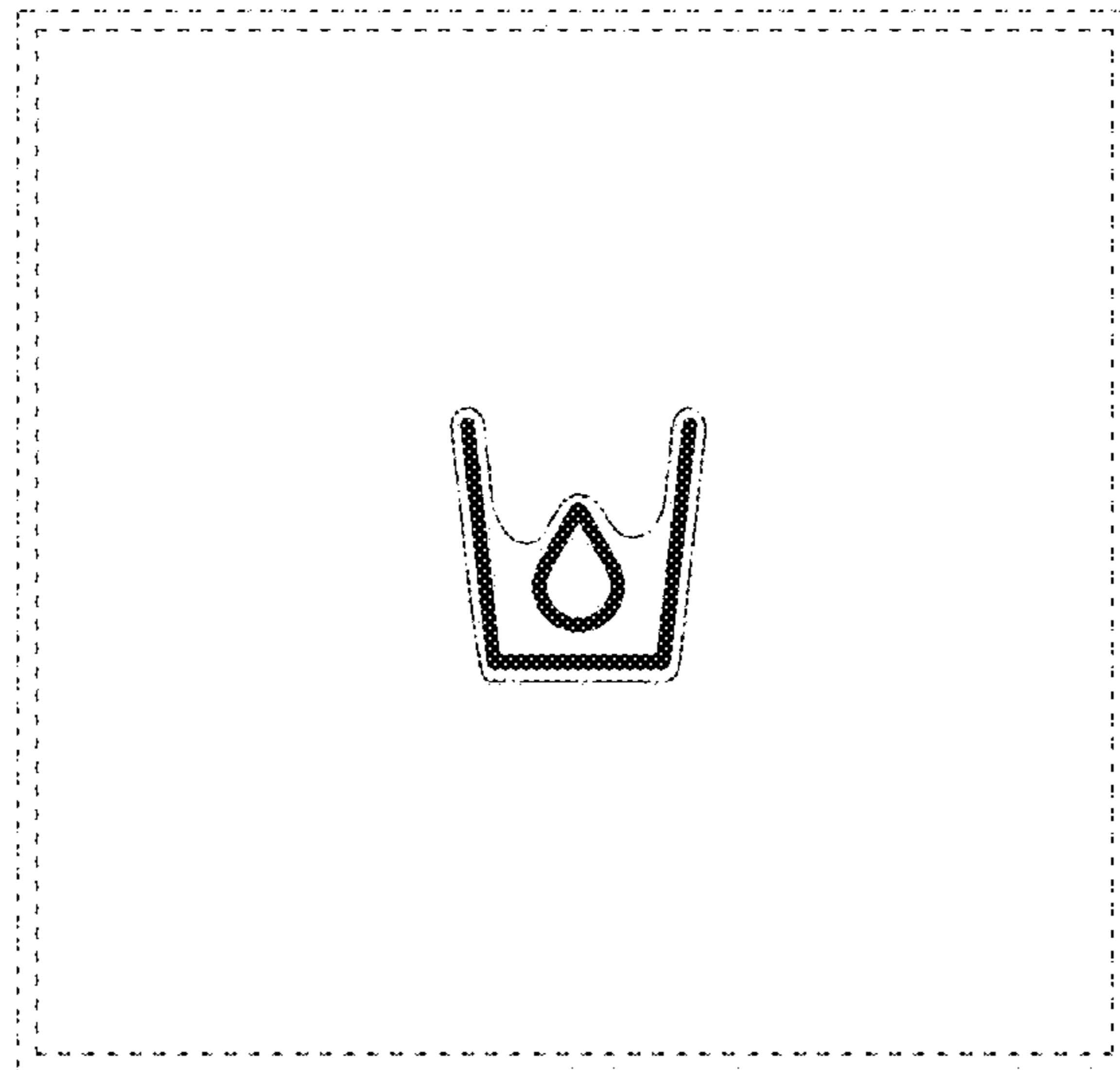
FIG. 1 shows a display screen or portion thereof with animated icon in a first configuration showing our new design;

FIG. 2 shows a display screen or portion thereof with animated icon in a second configuration showing our new design; and,

FIG. 3 shows a display screen or portion thereof with animated icon in a third configuration showing our new design.

The dash-dash broken lines illustrate the display screen or portion thereof and forms no part of the claimed design. The dot-dash broken line forms no part of the claimed design. The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1-3. The process or period in which one image transitions to another image forms no part of the claimed design.

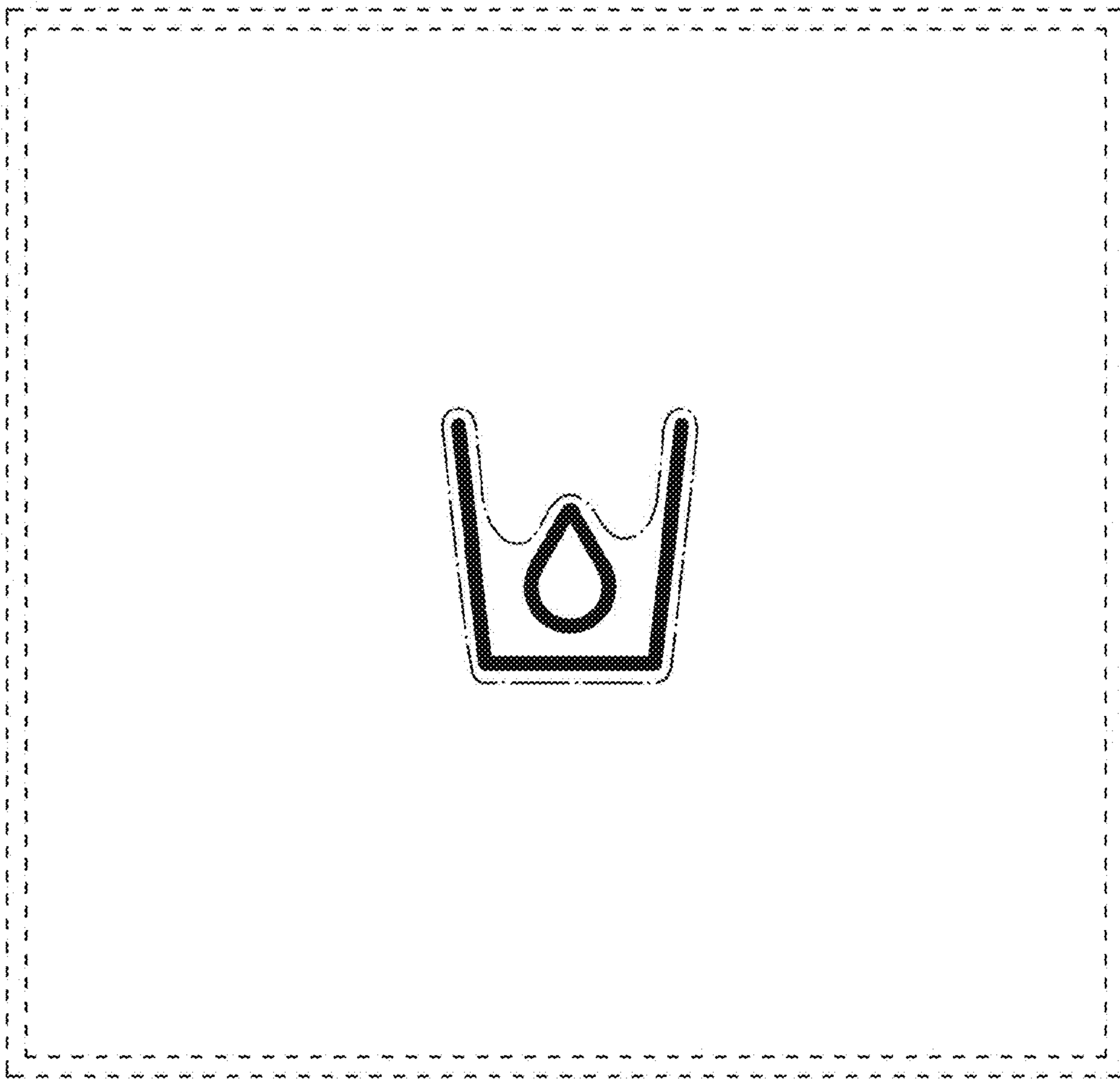

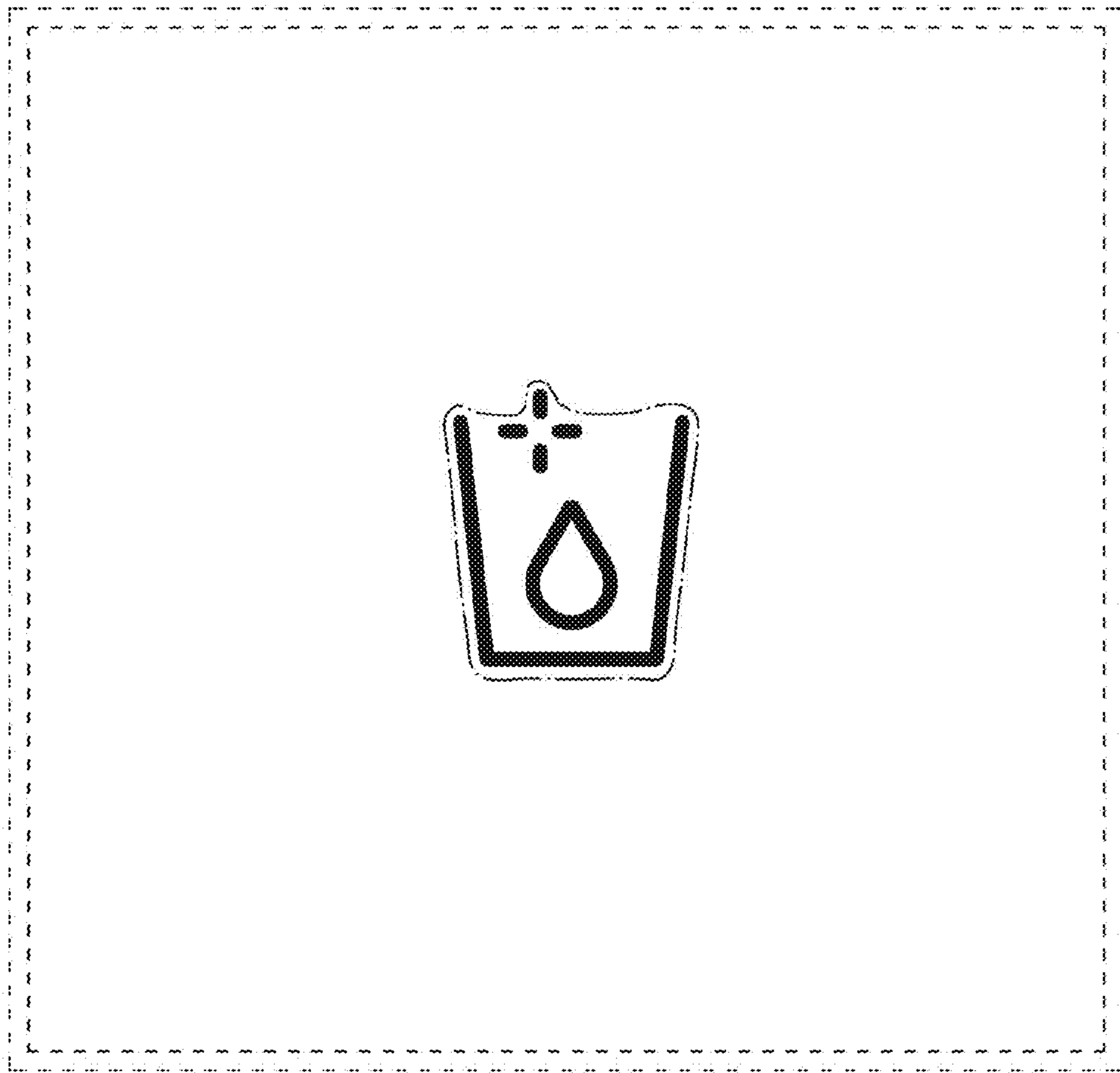
