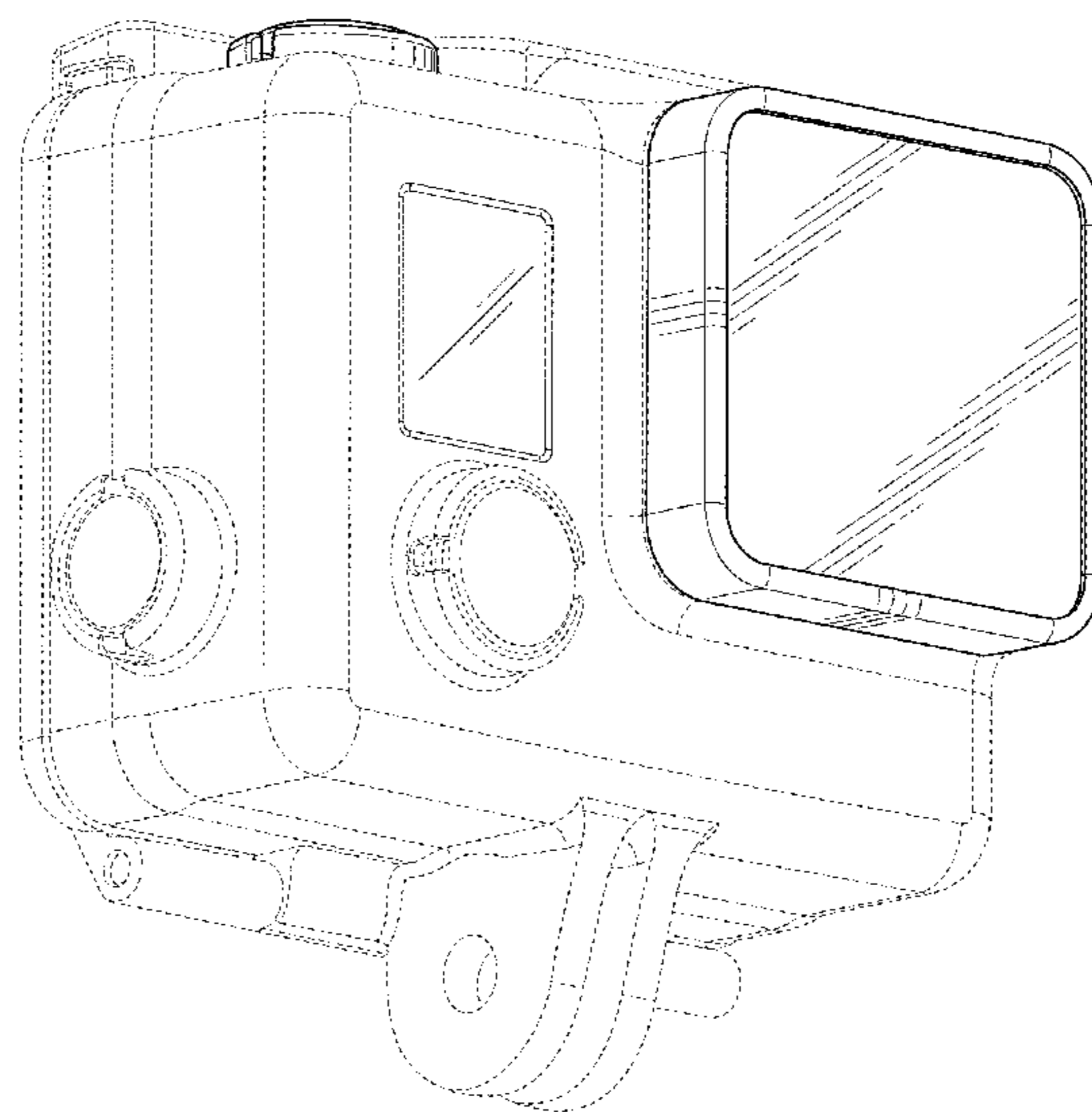
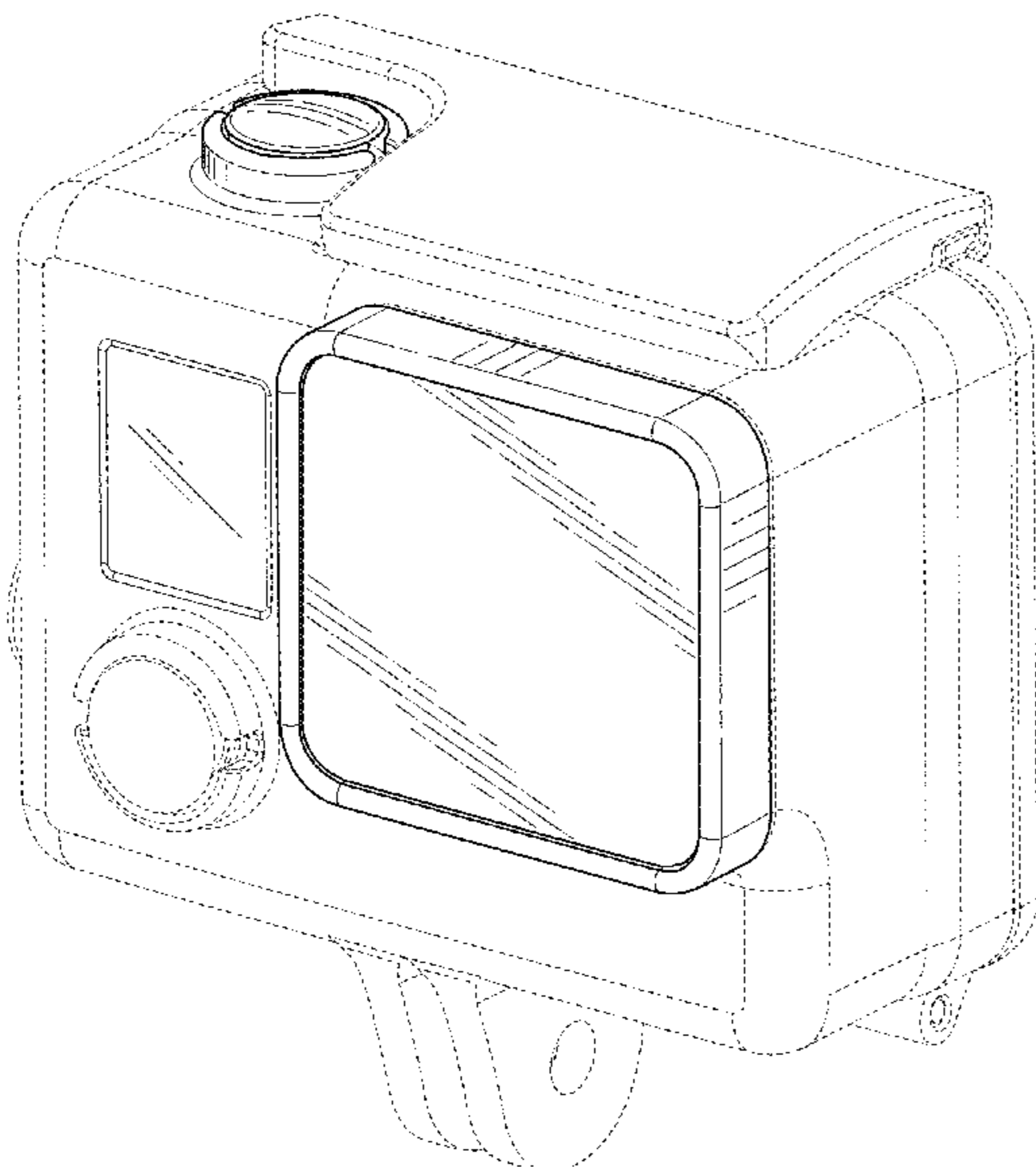
The ornamental design for a camera housing, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, and right side perspective view of a camera housing showing our new design; FIG. 2 is a front, bottom and left side perspective view thereof; FIG. 3 is a rear, bottom and right side perspective view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof.

The broken lines depict portions of a camera housing in which the design is embodied that form no part of the claimed design.

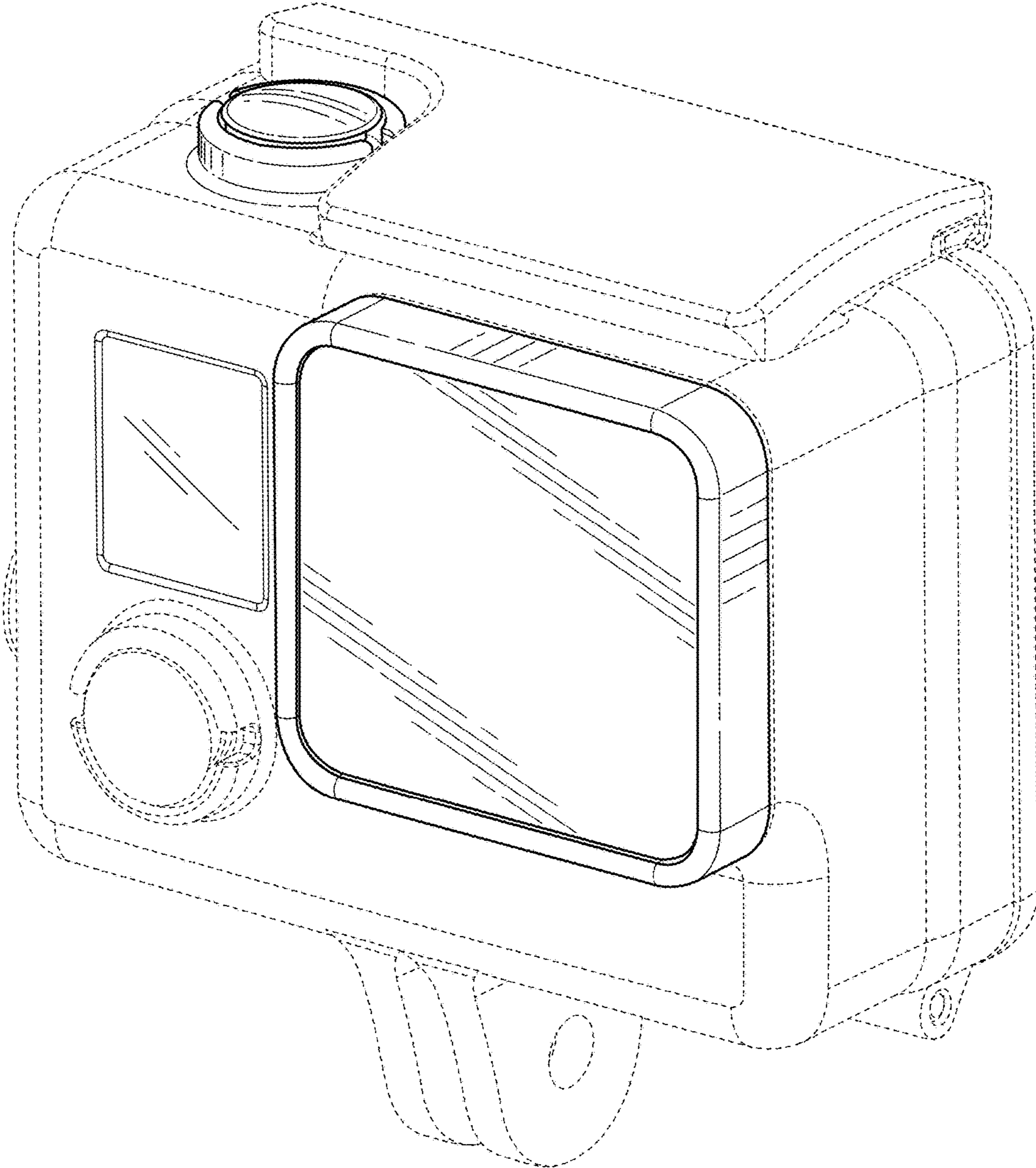

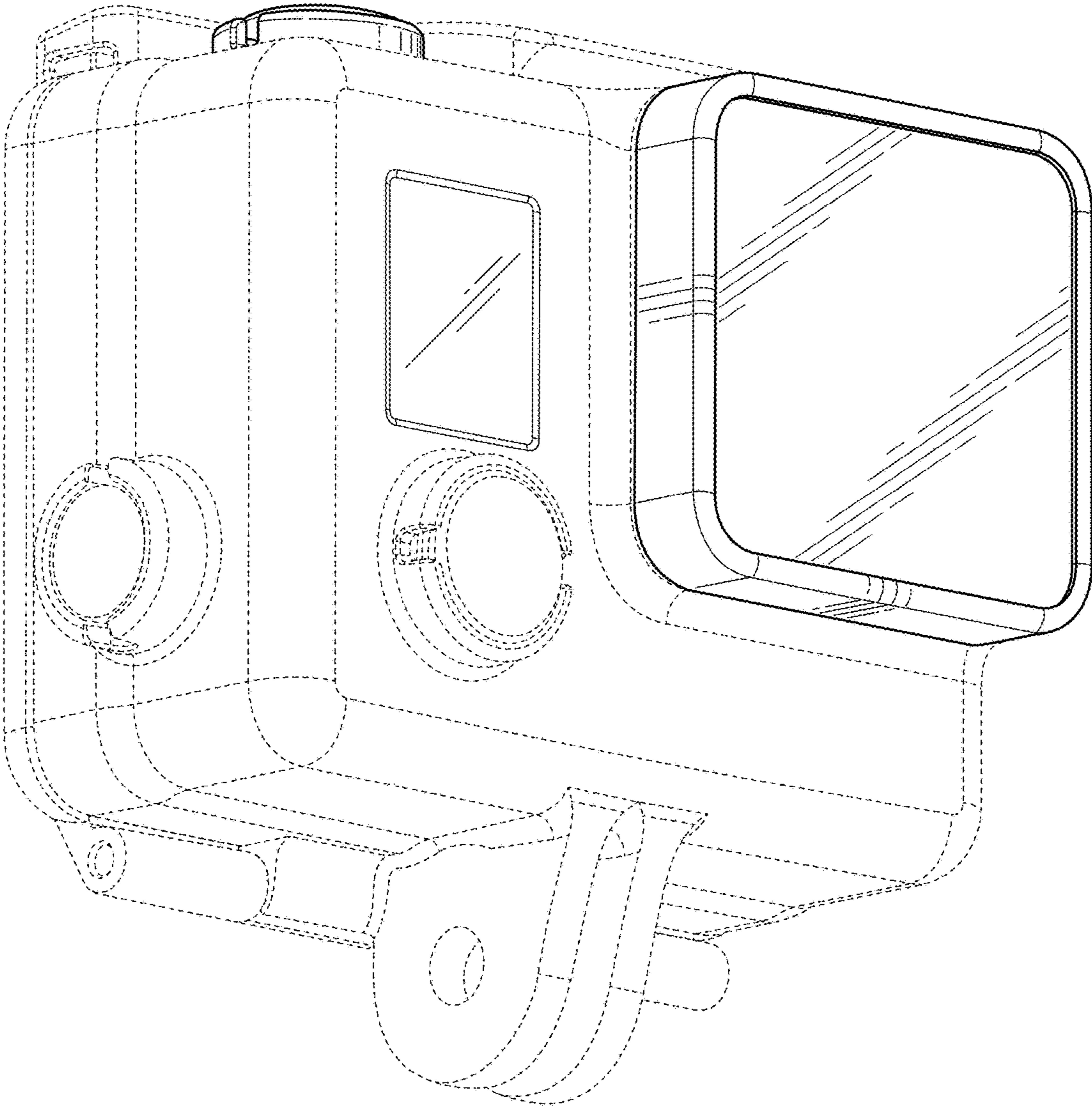

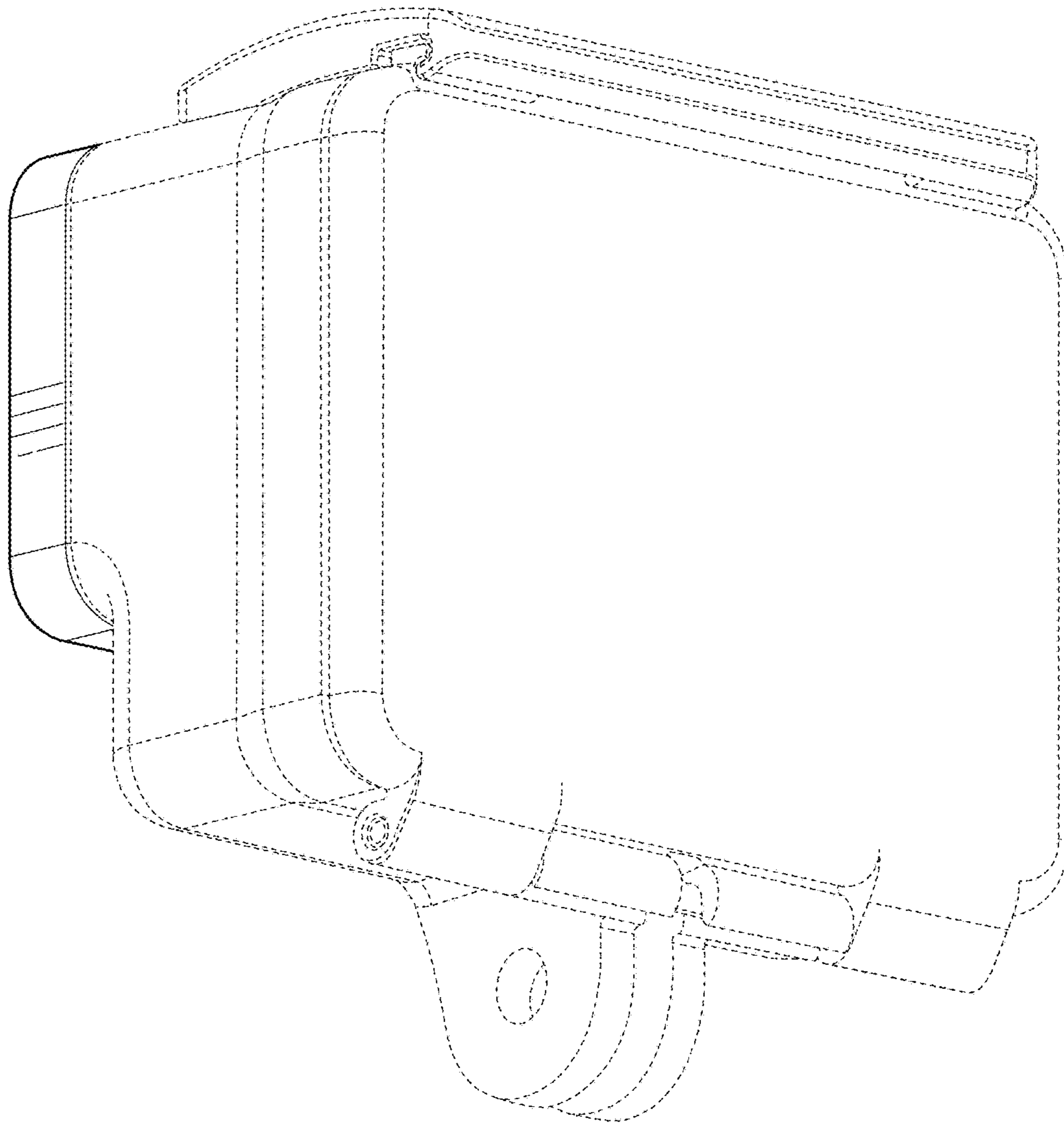

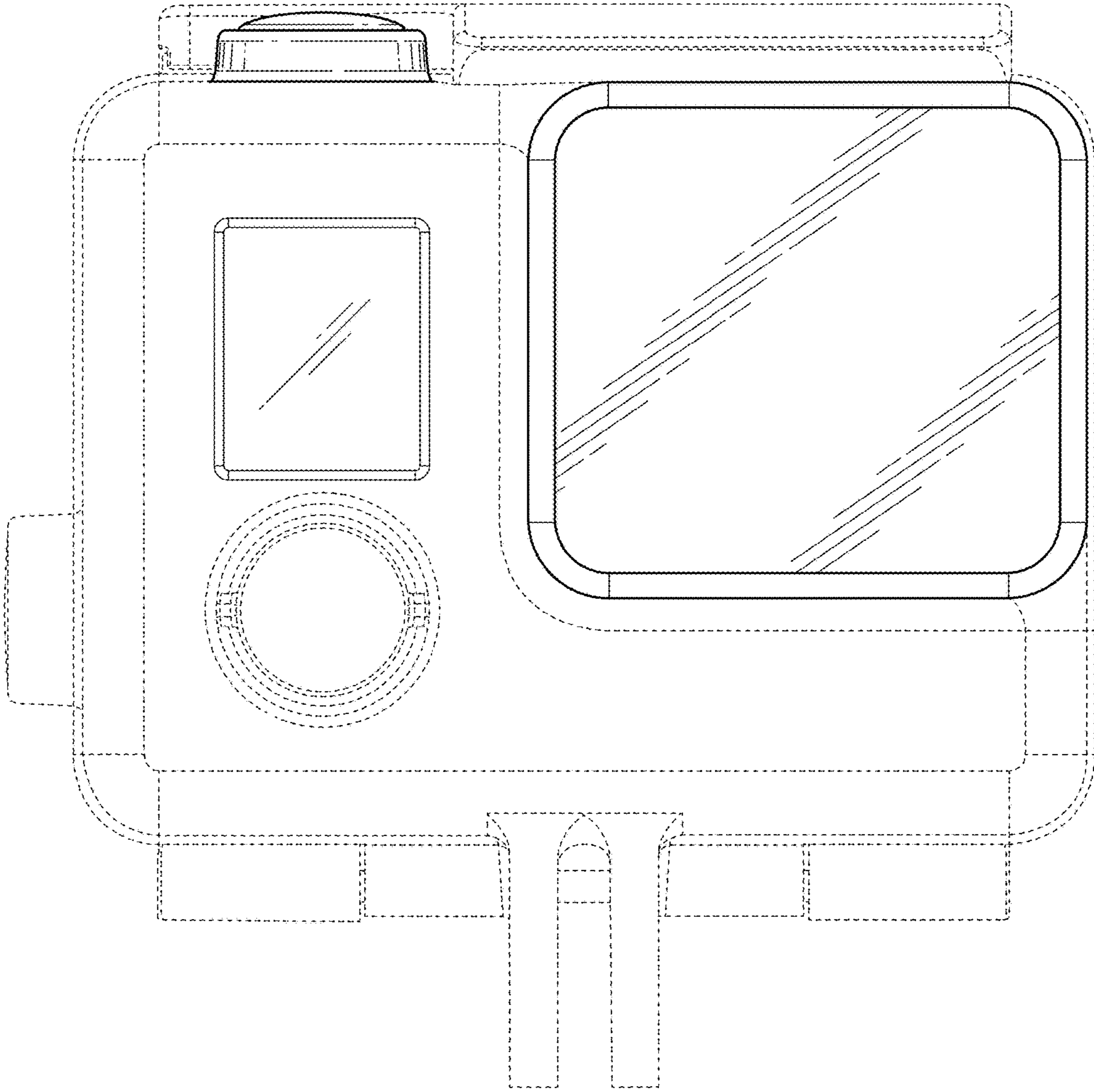

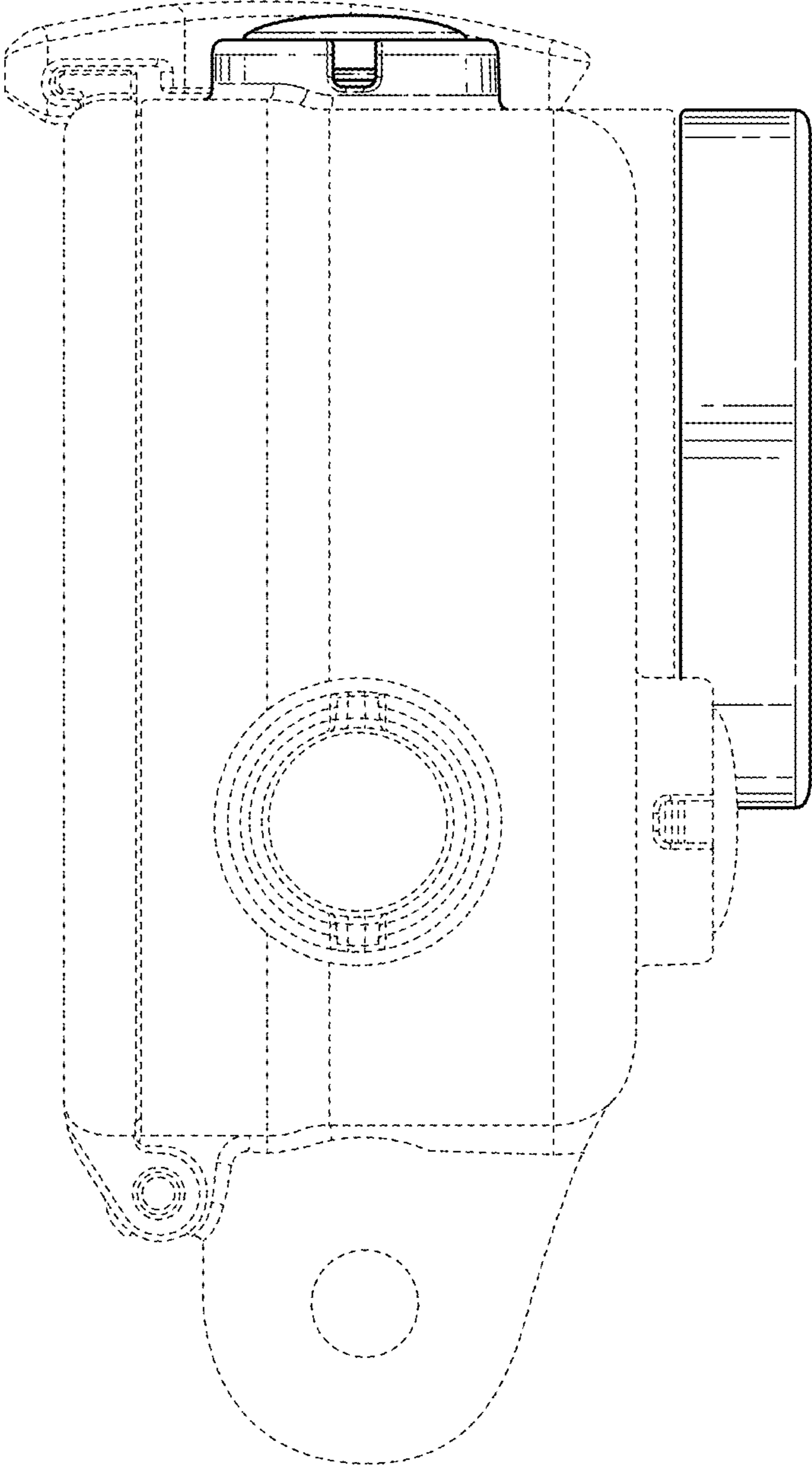

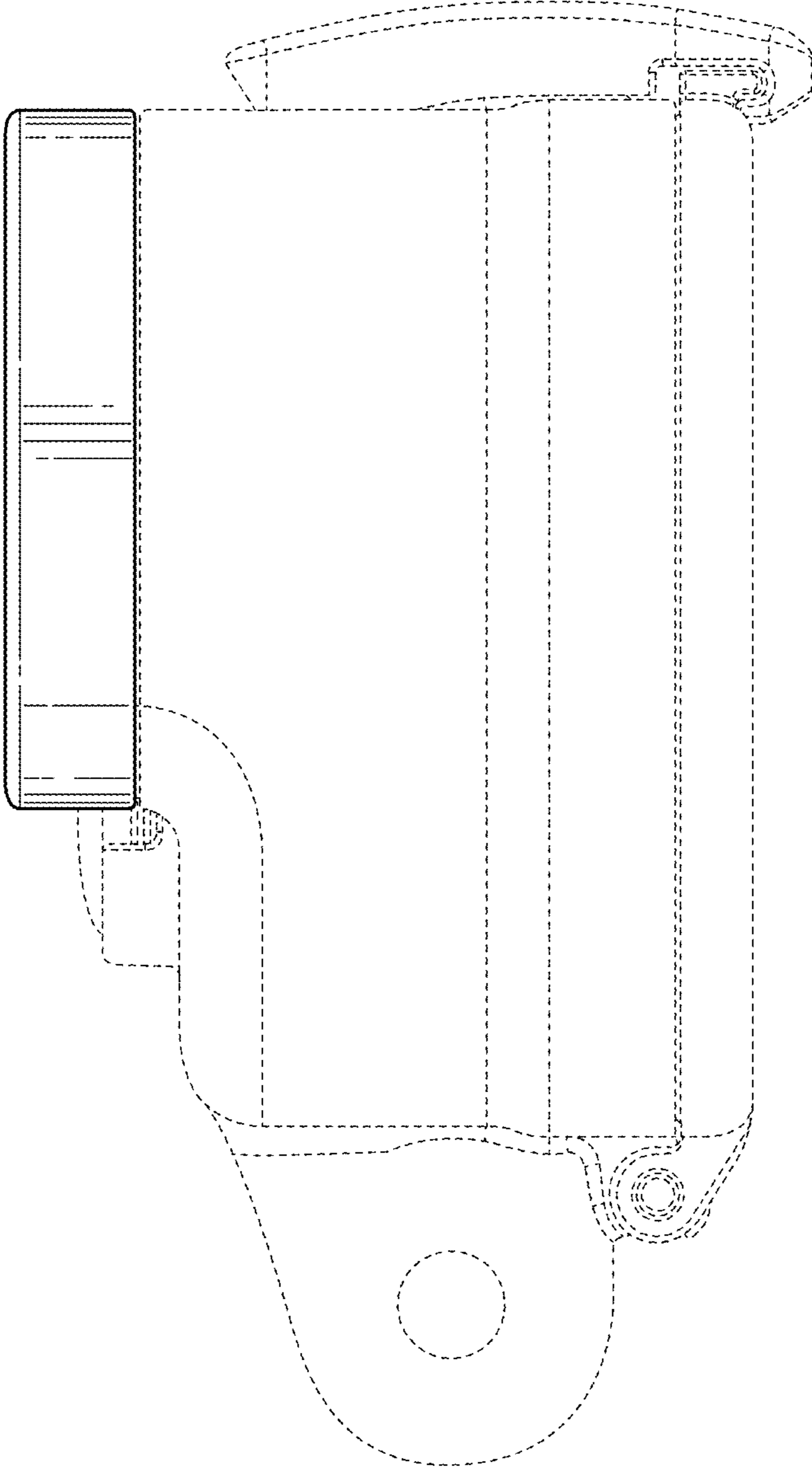

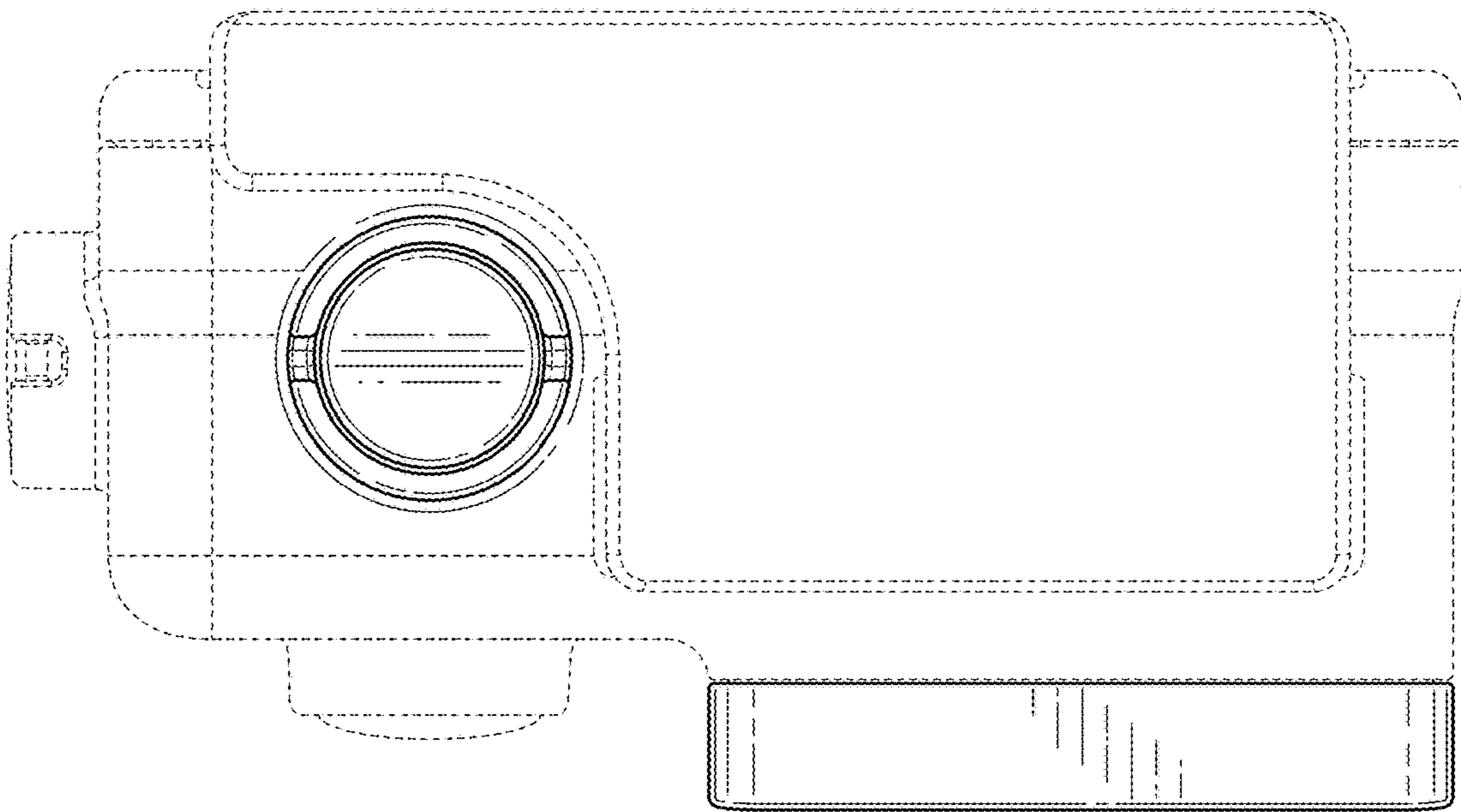

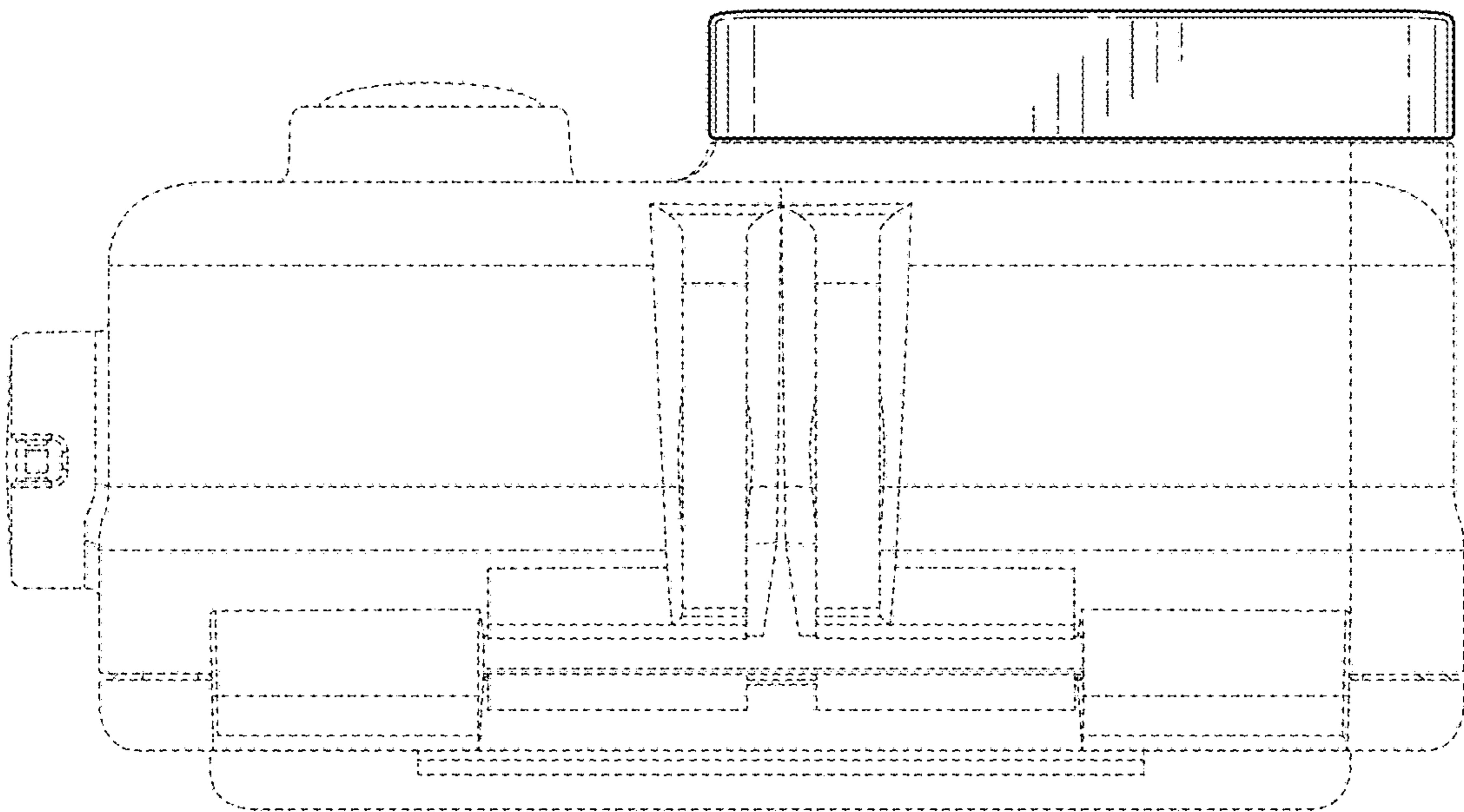
