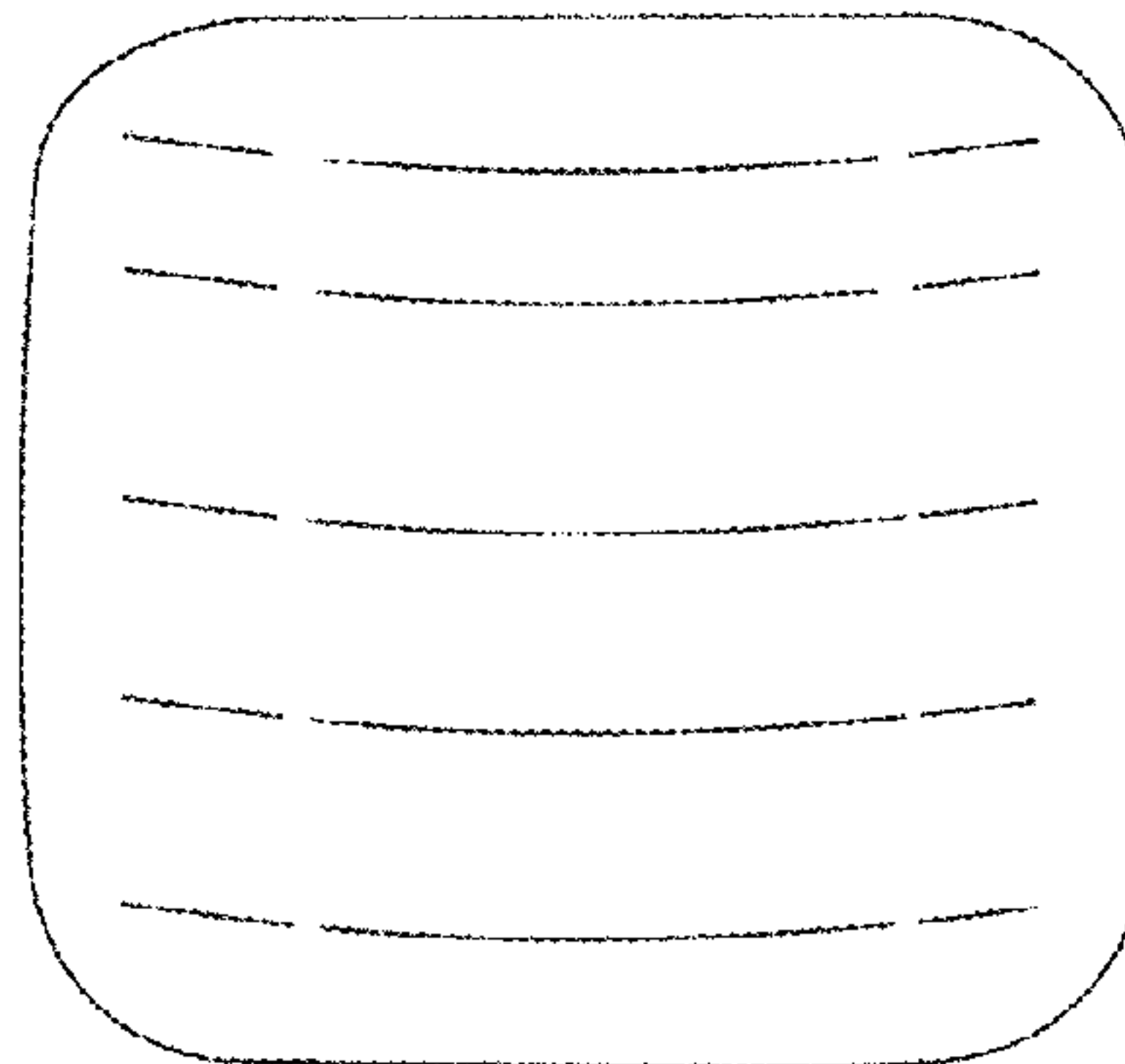
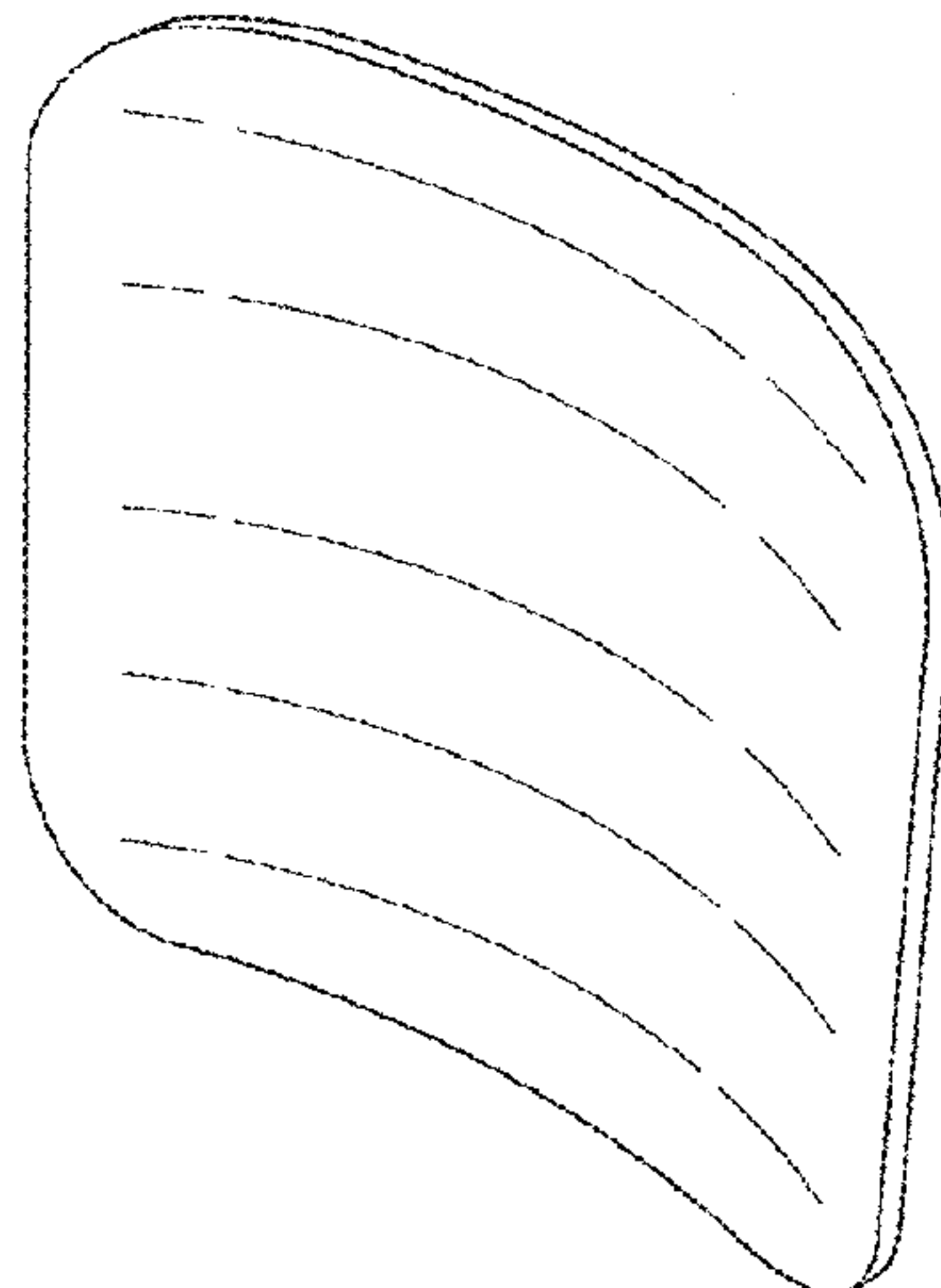
(57) **CLAIM**

An ornamental design for a hand held strapless water paddle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of subject hand held strapless water paddle illustrating my new design.

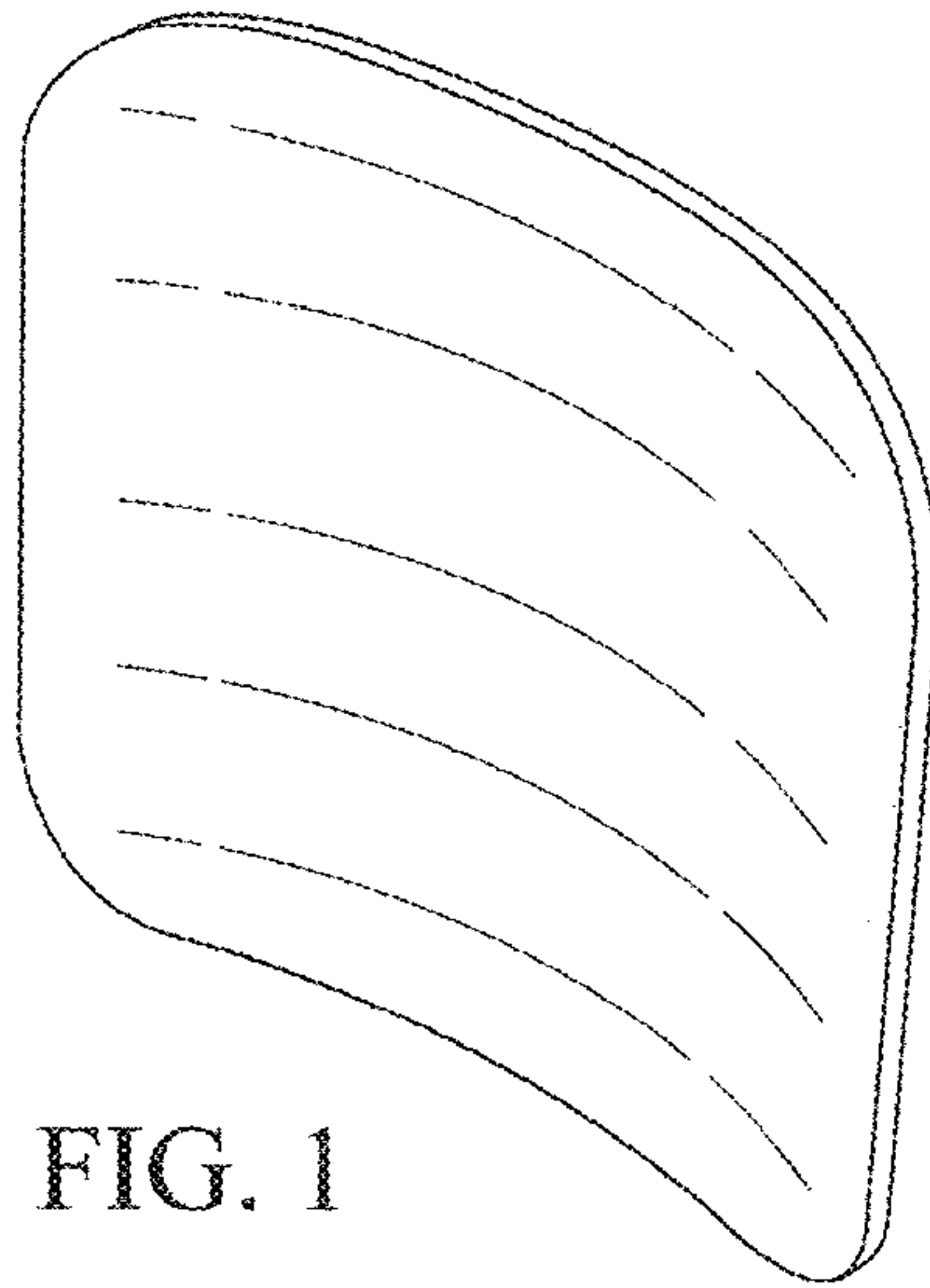

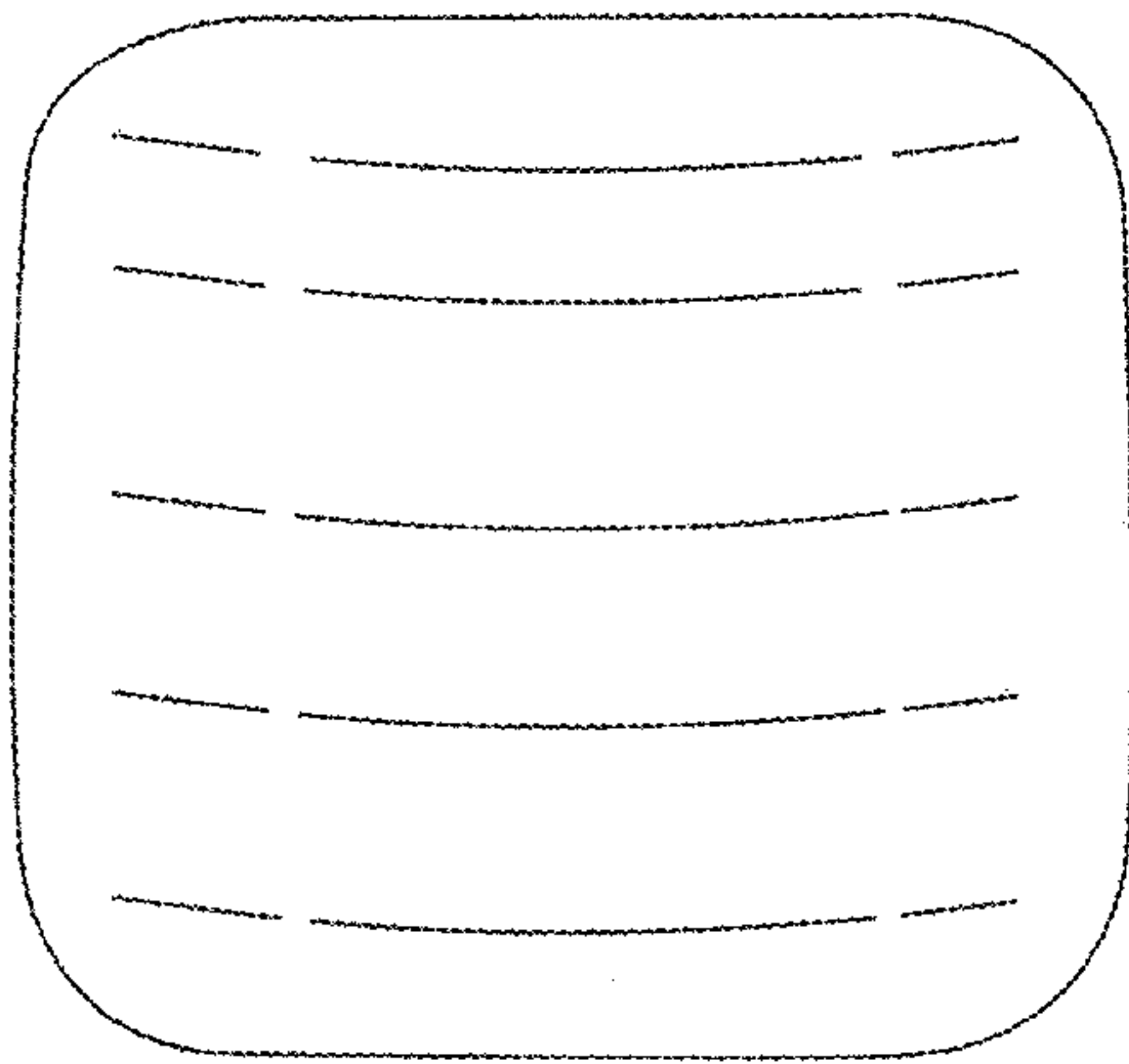

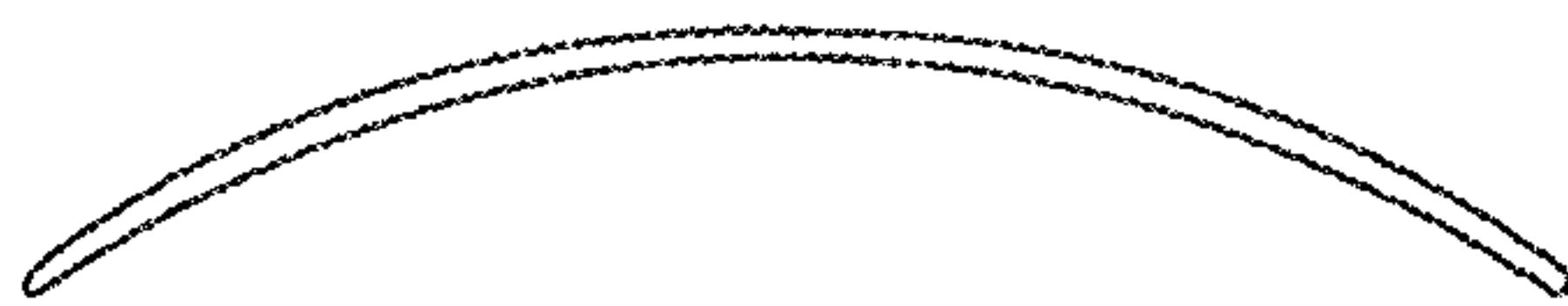

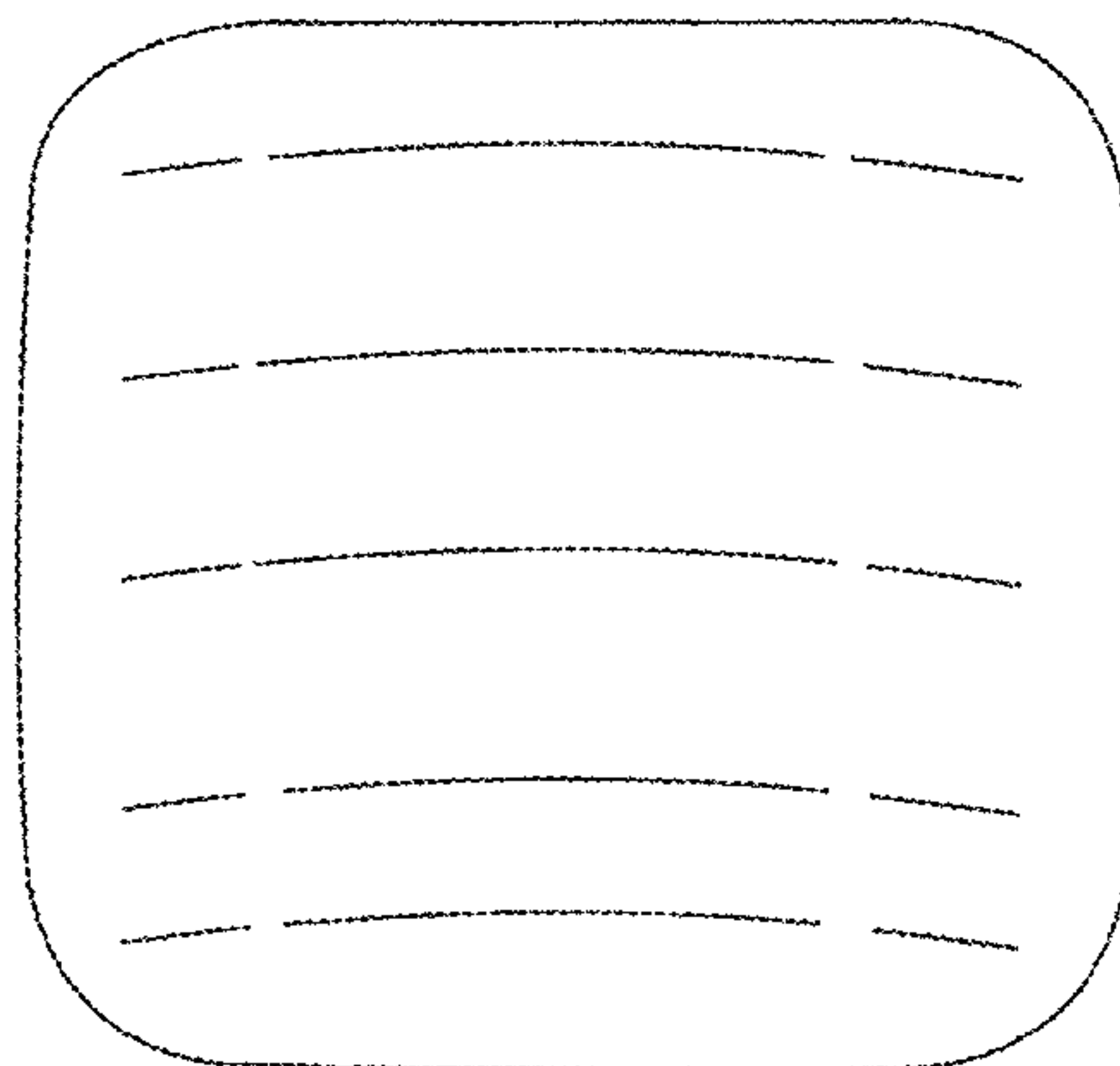

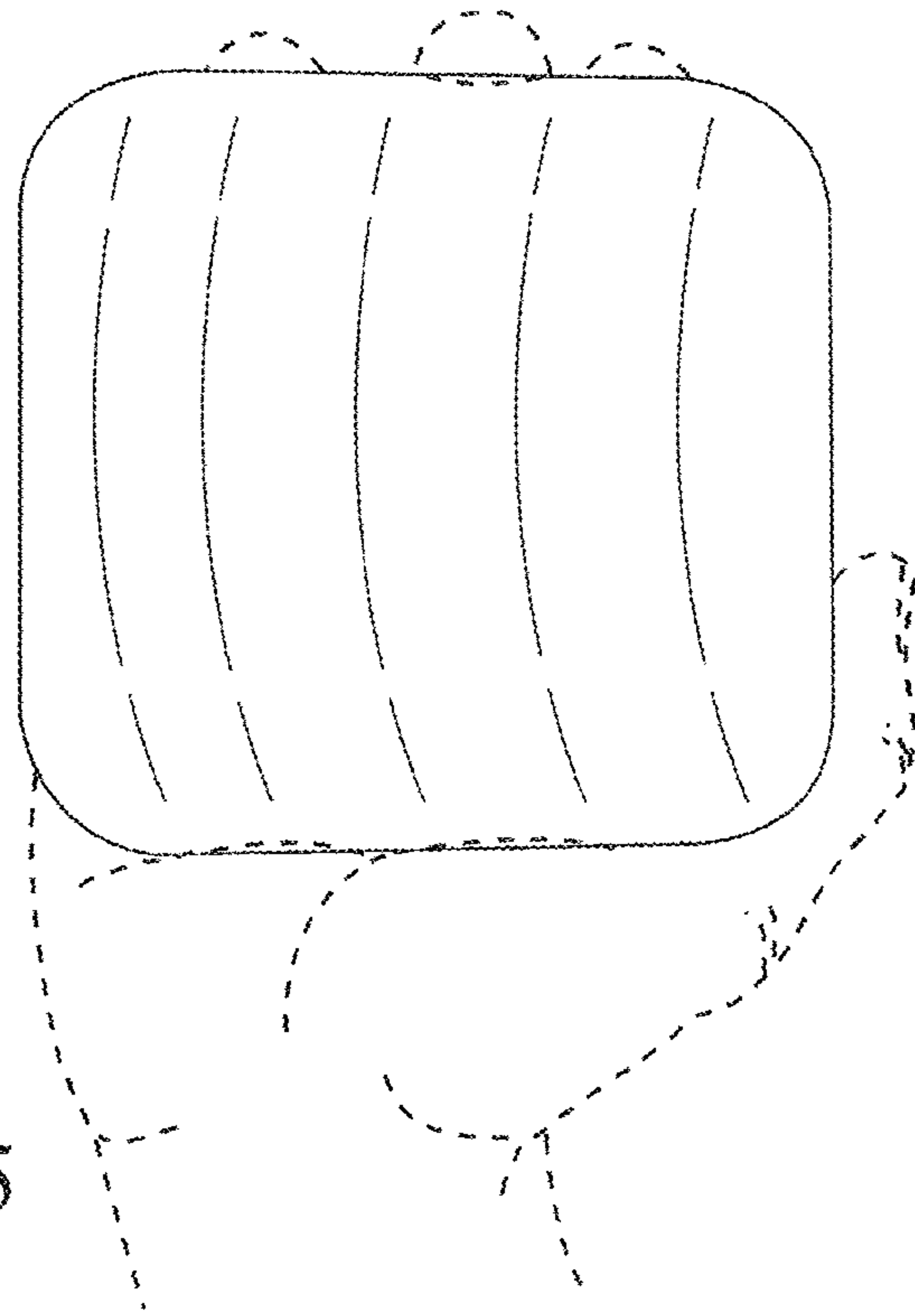

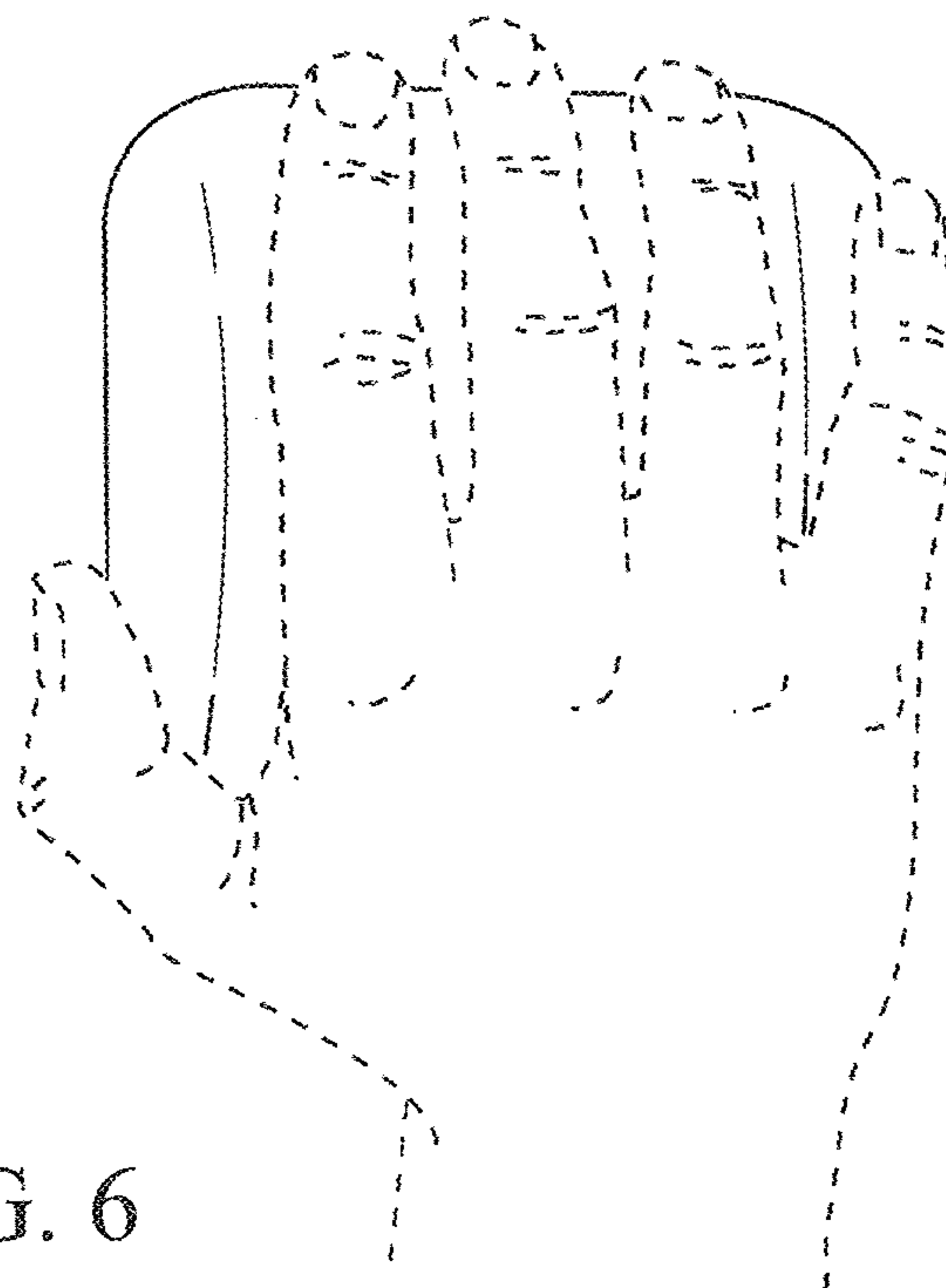
