The ornamental design for a pistol with suppressor, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a pistol with suppressor according to our invention;
FIG. 2 is a right side view of a pistol with suppressor shown in FIG. 1;
FIG. 3 is a left side view of a pistol with suppressor shown in FIG. 1;
FIG. 4 is a top view of a pistol with suppressor shown in FIG. 1;

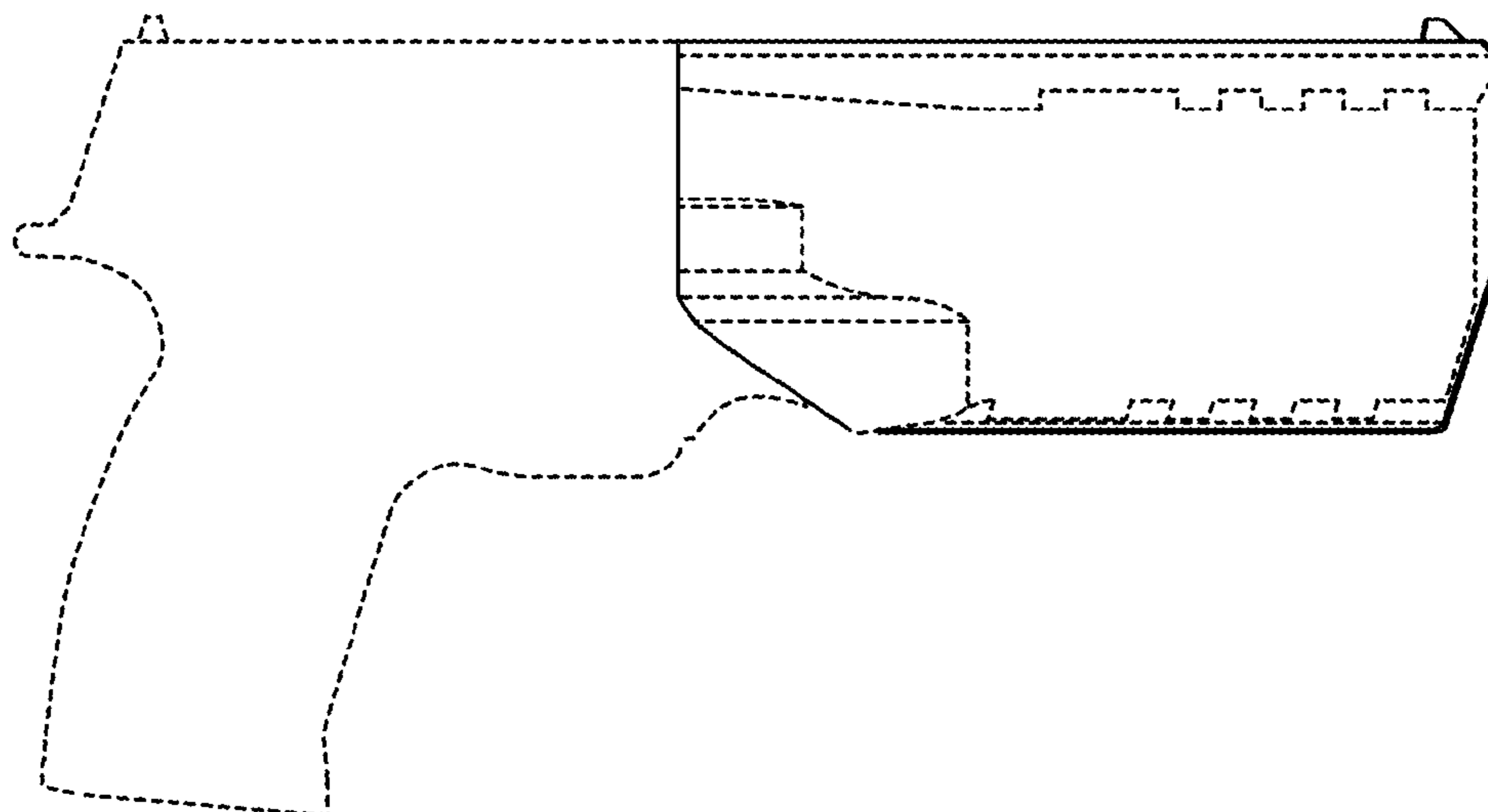

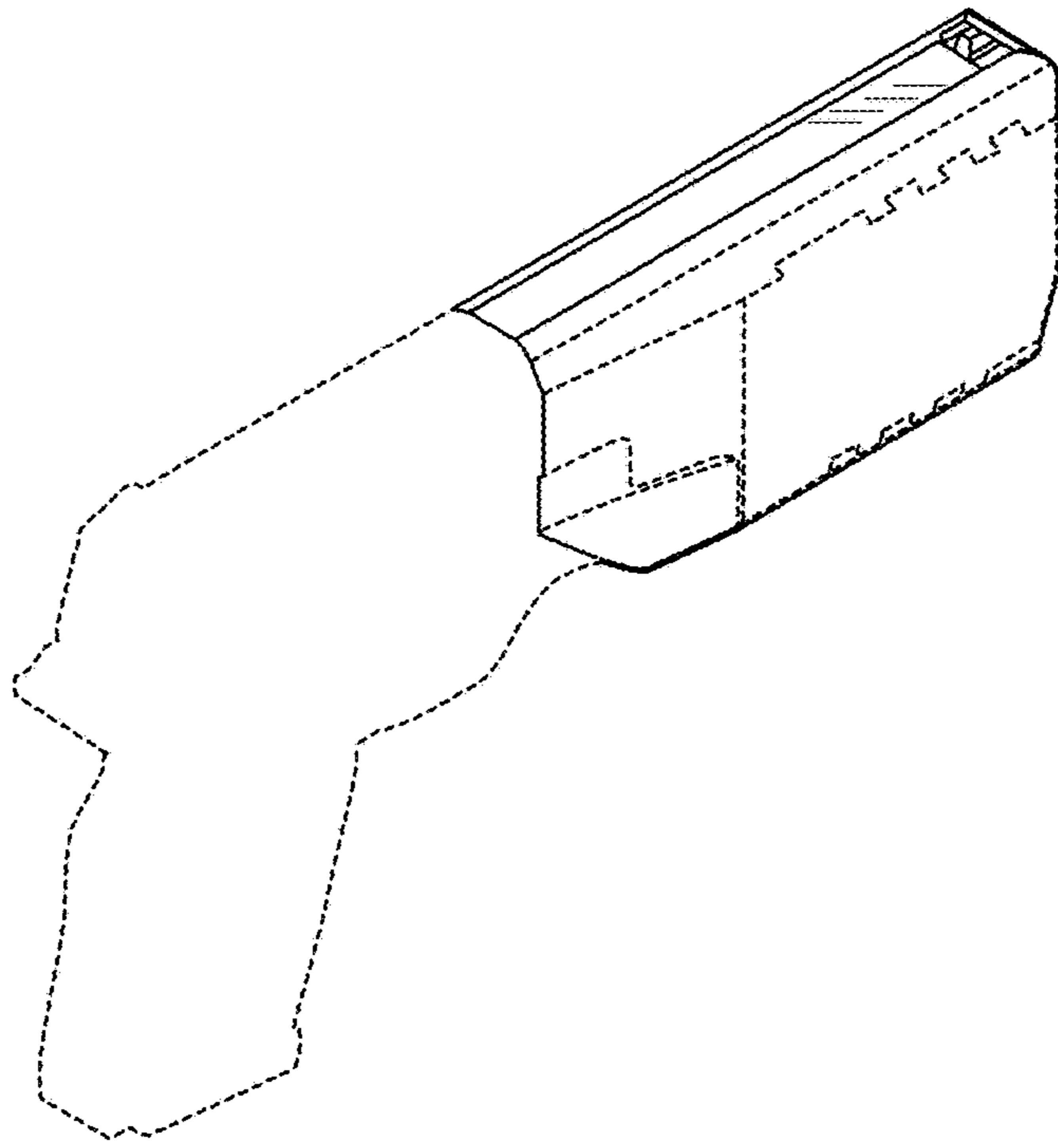

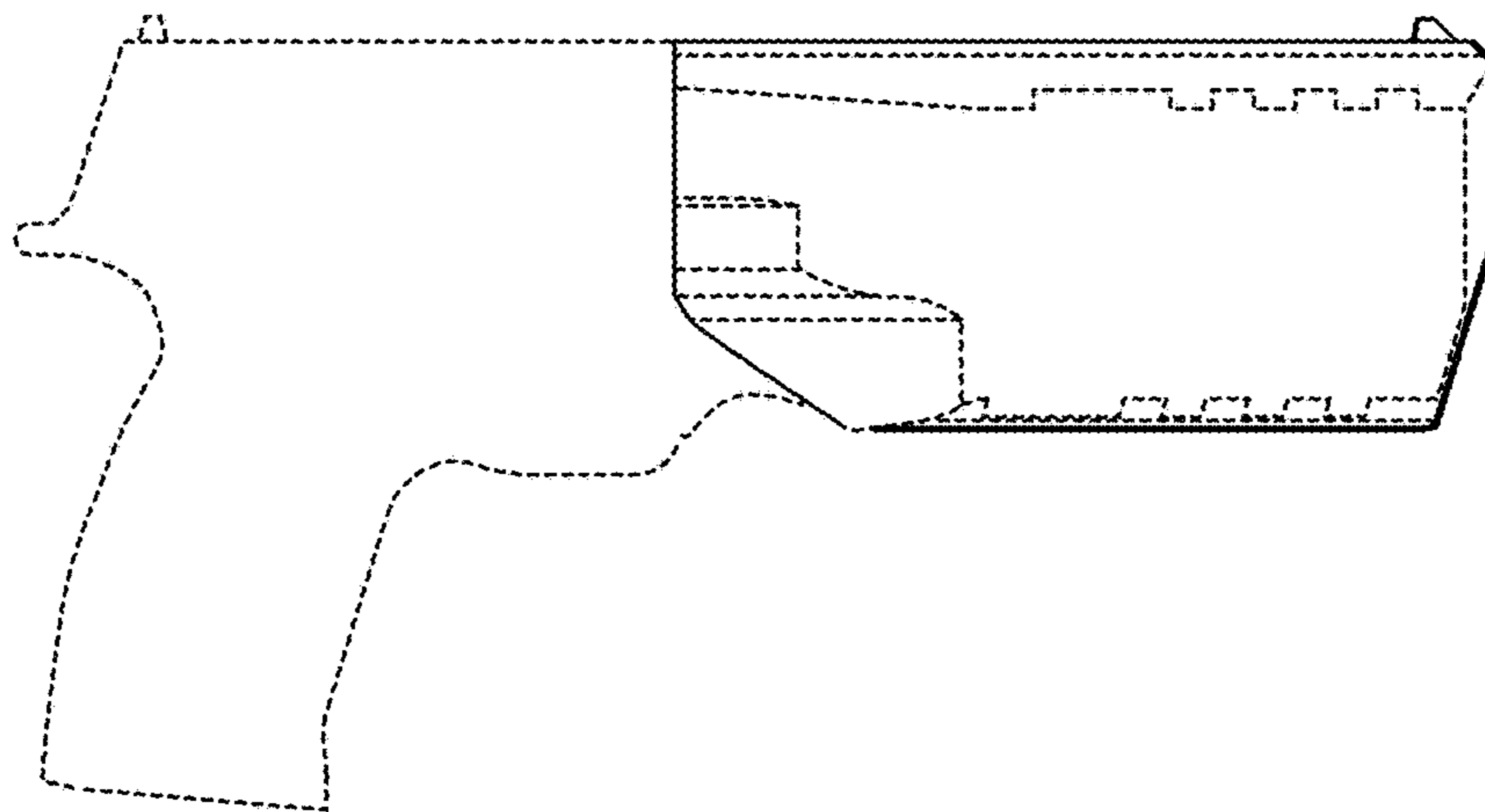

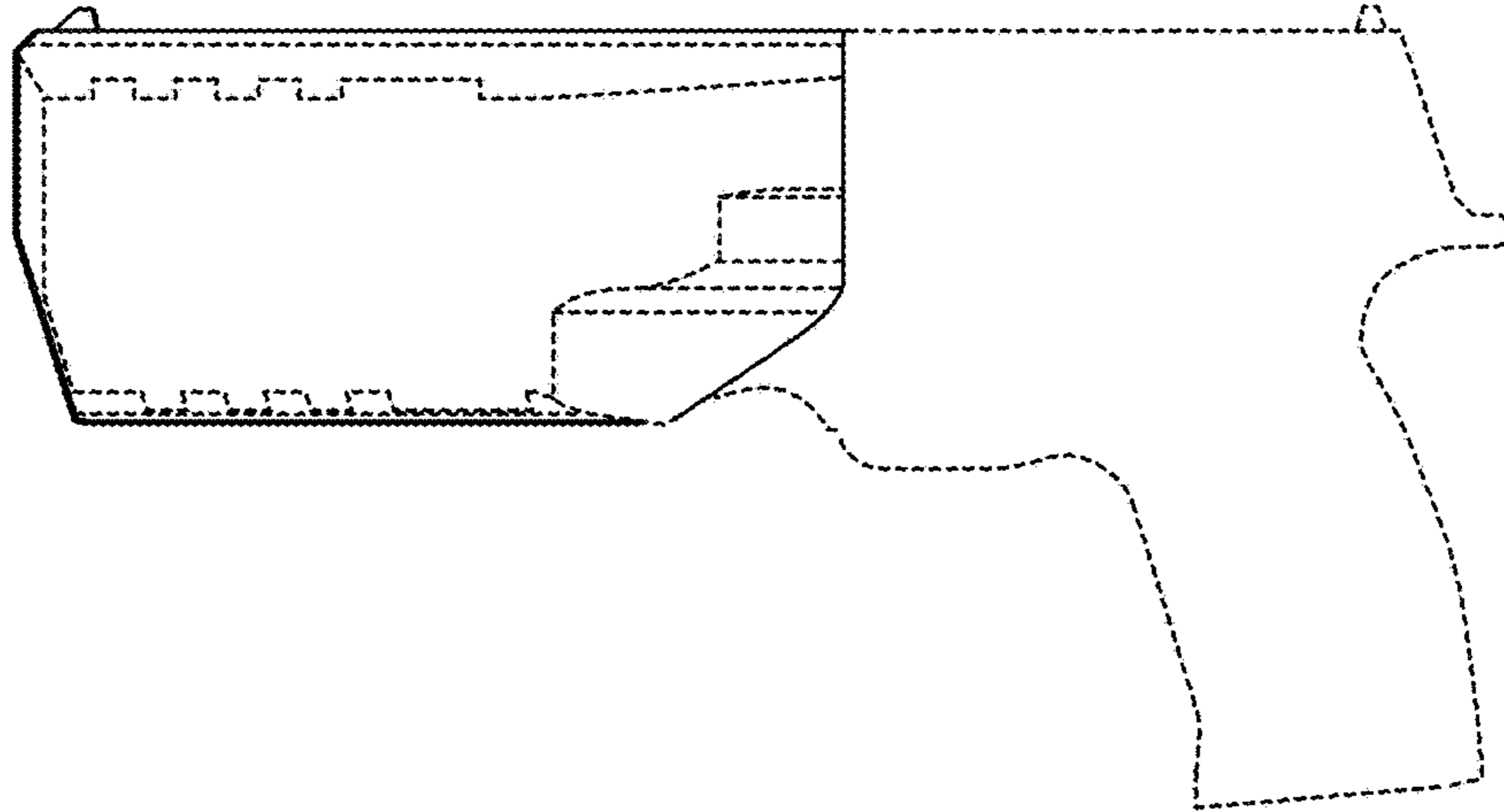

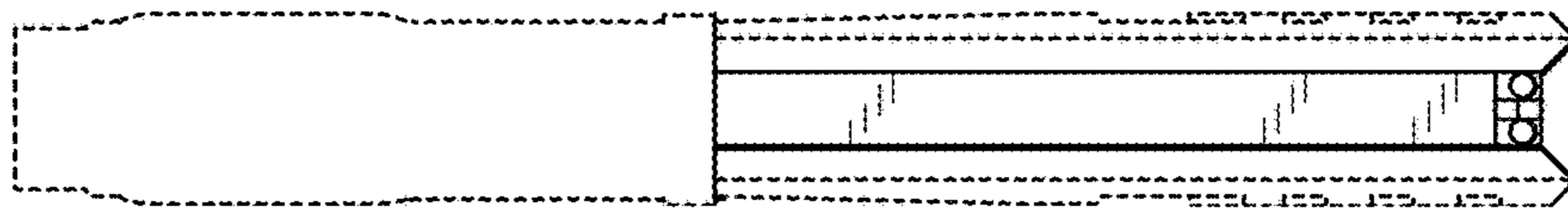

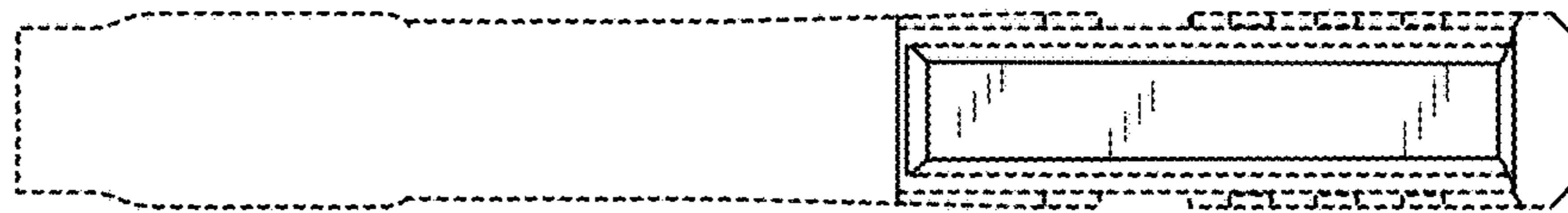

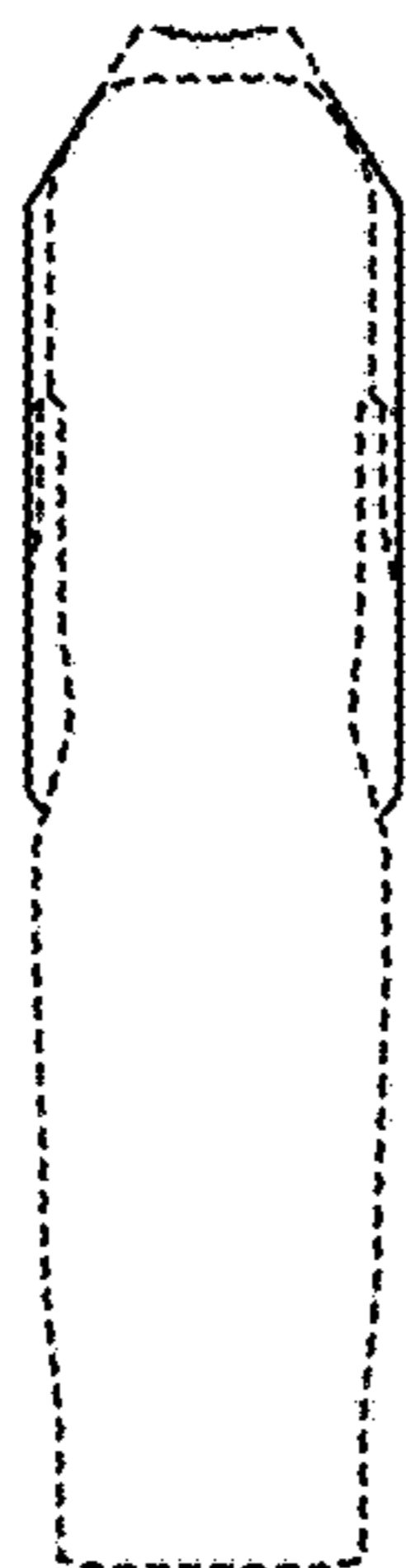
