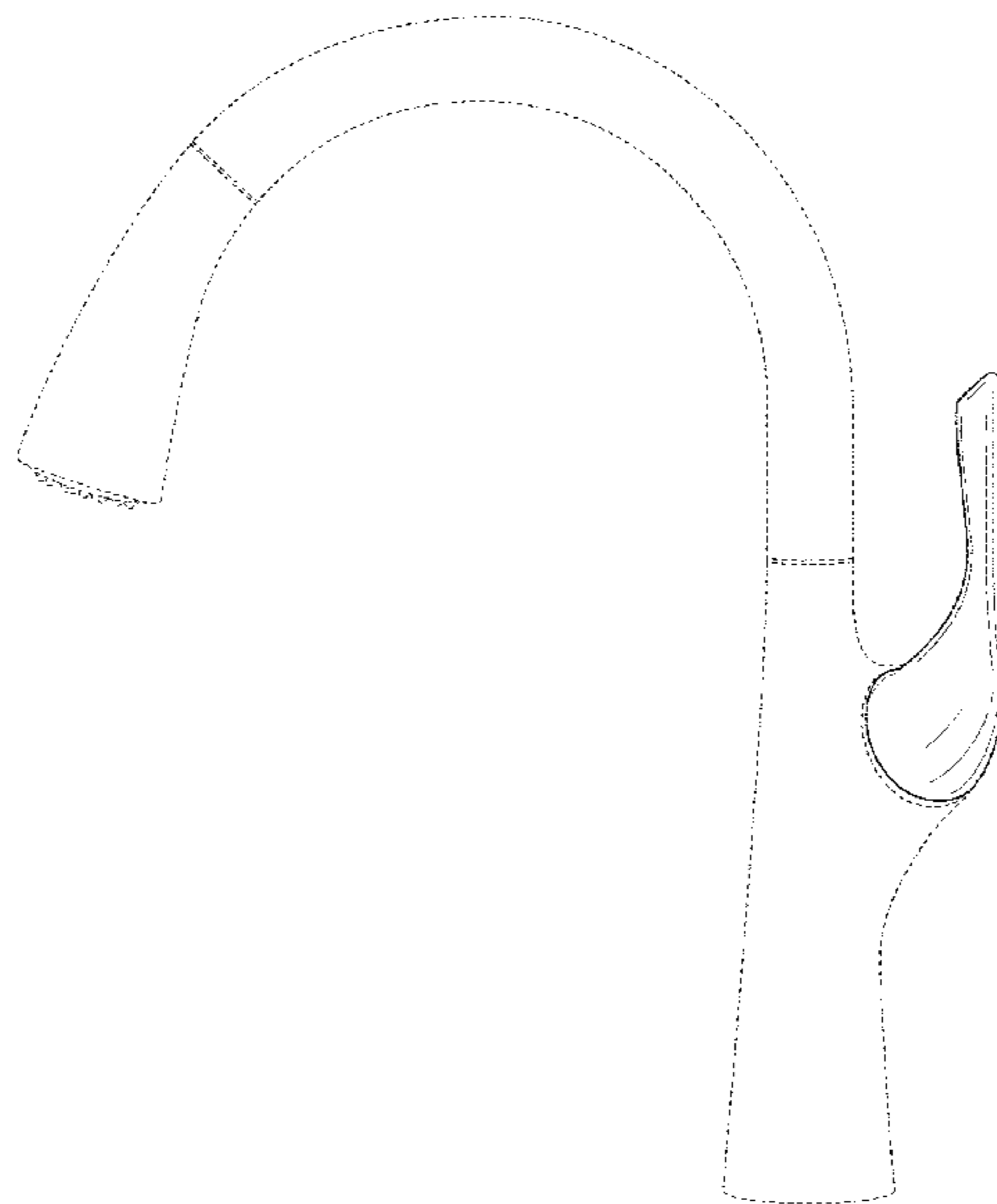
(57) **CLAIM**

We claim the ornamental design for a faucet handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an embodiment of the claimed design;  
FIG. 2 is a front view thereof;

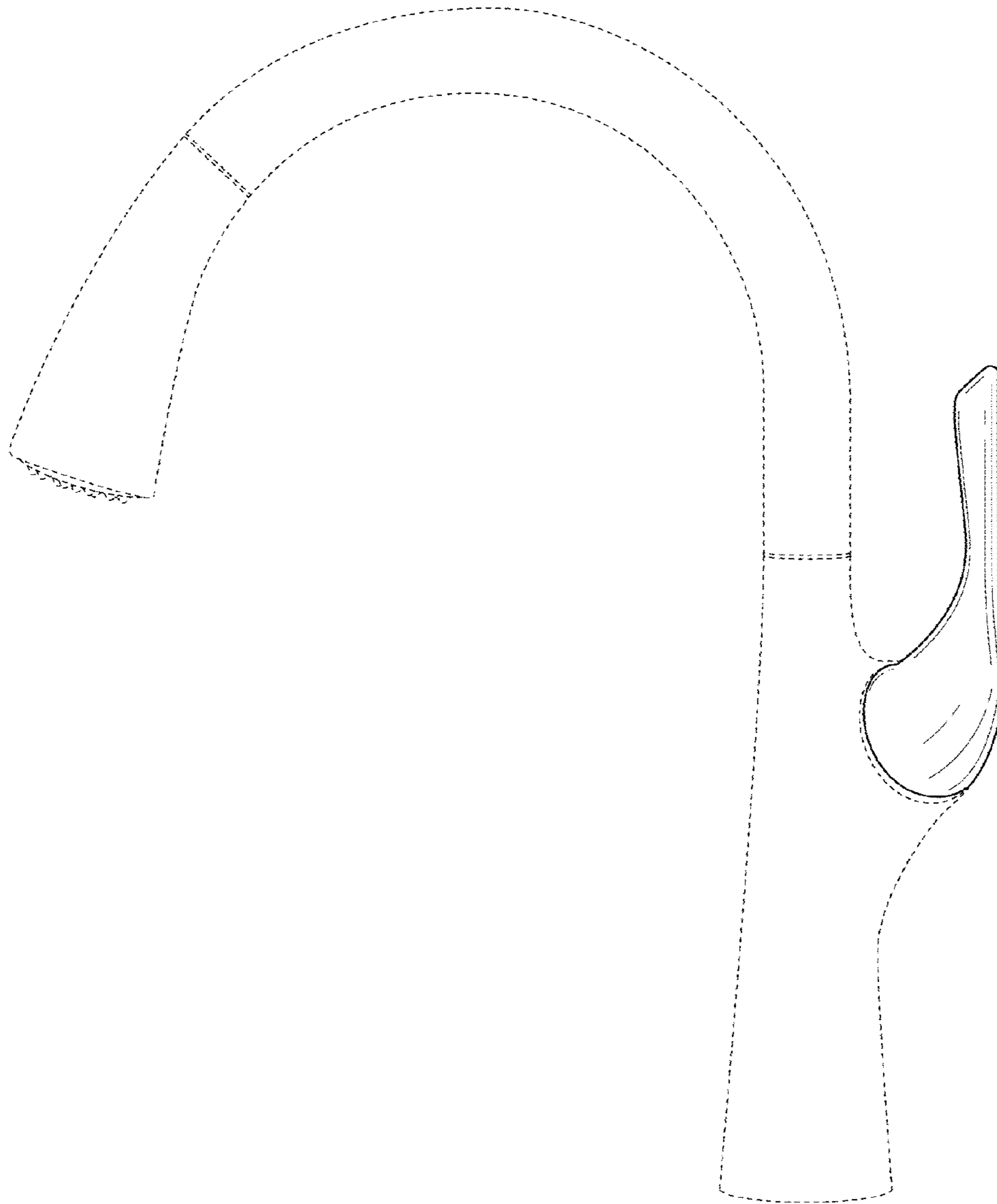

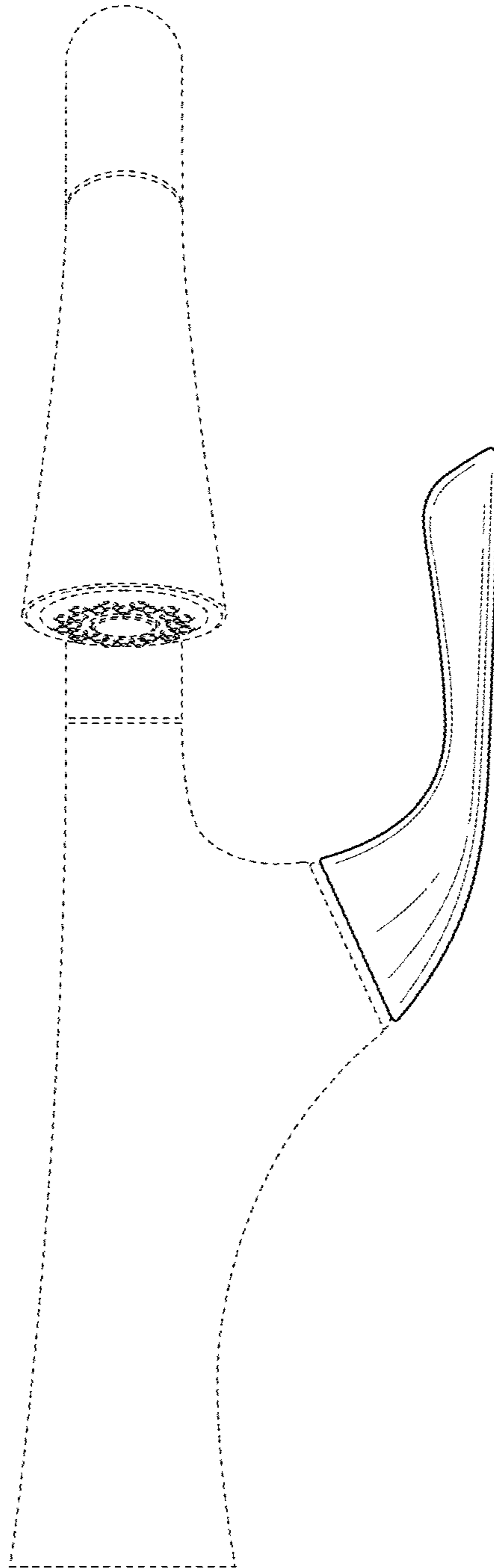
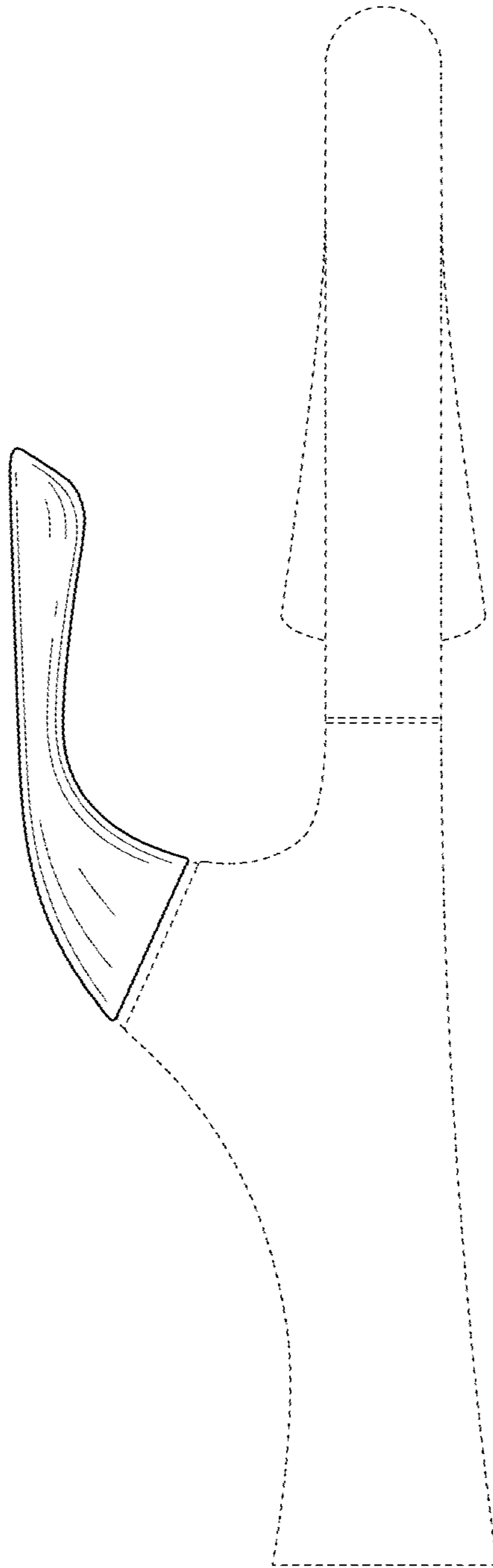

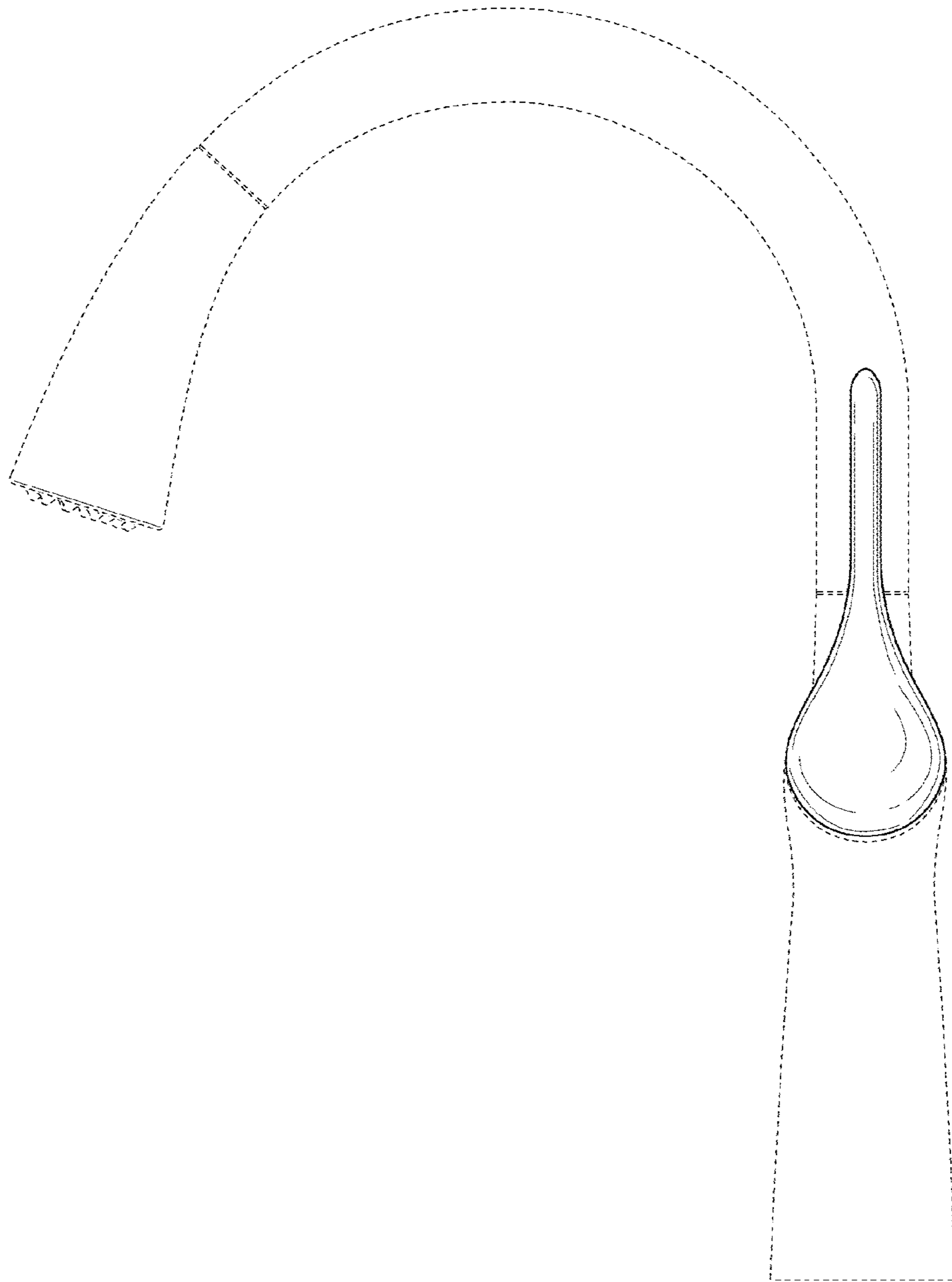

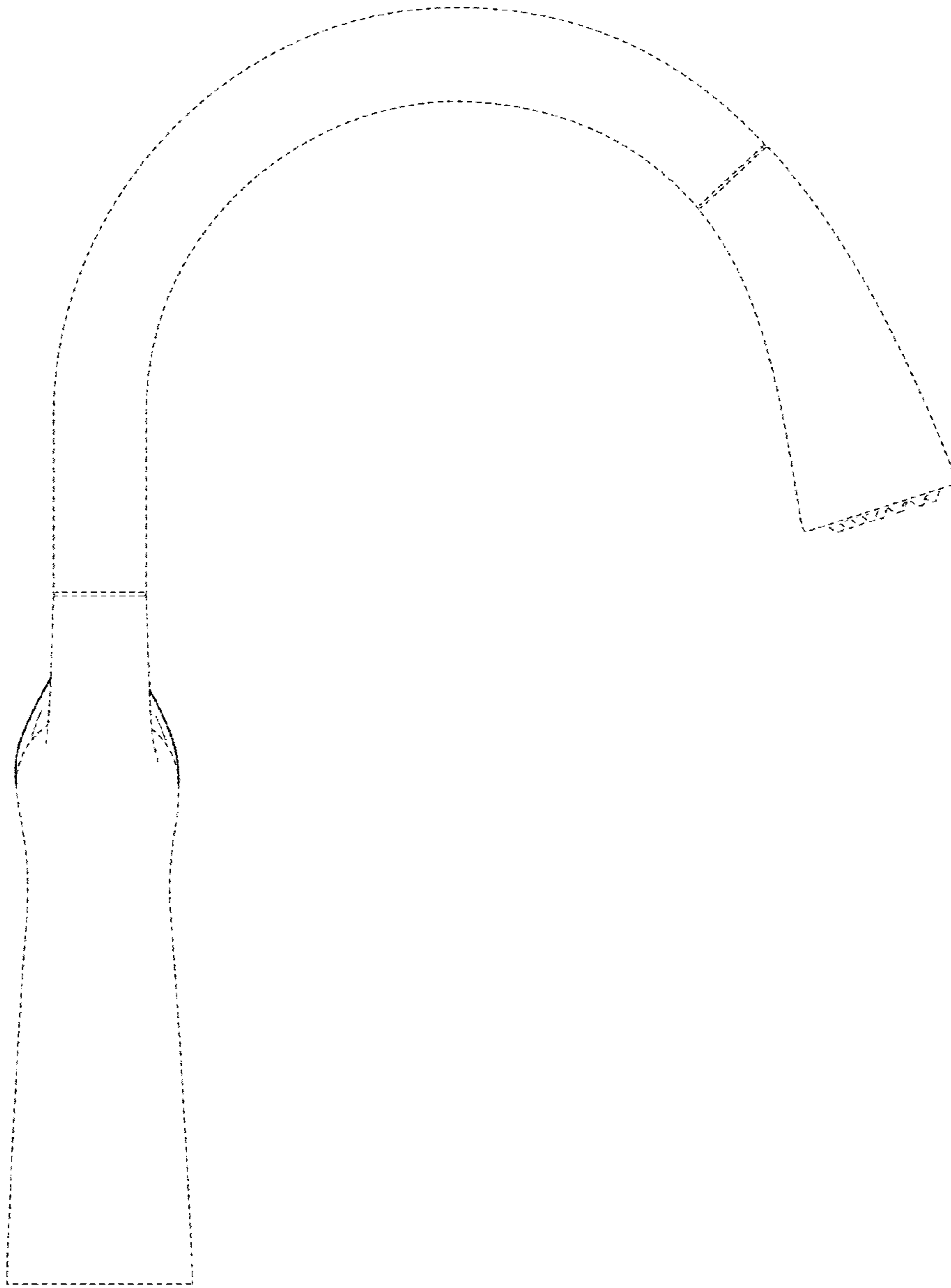

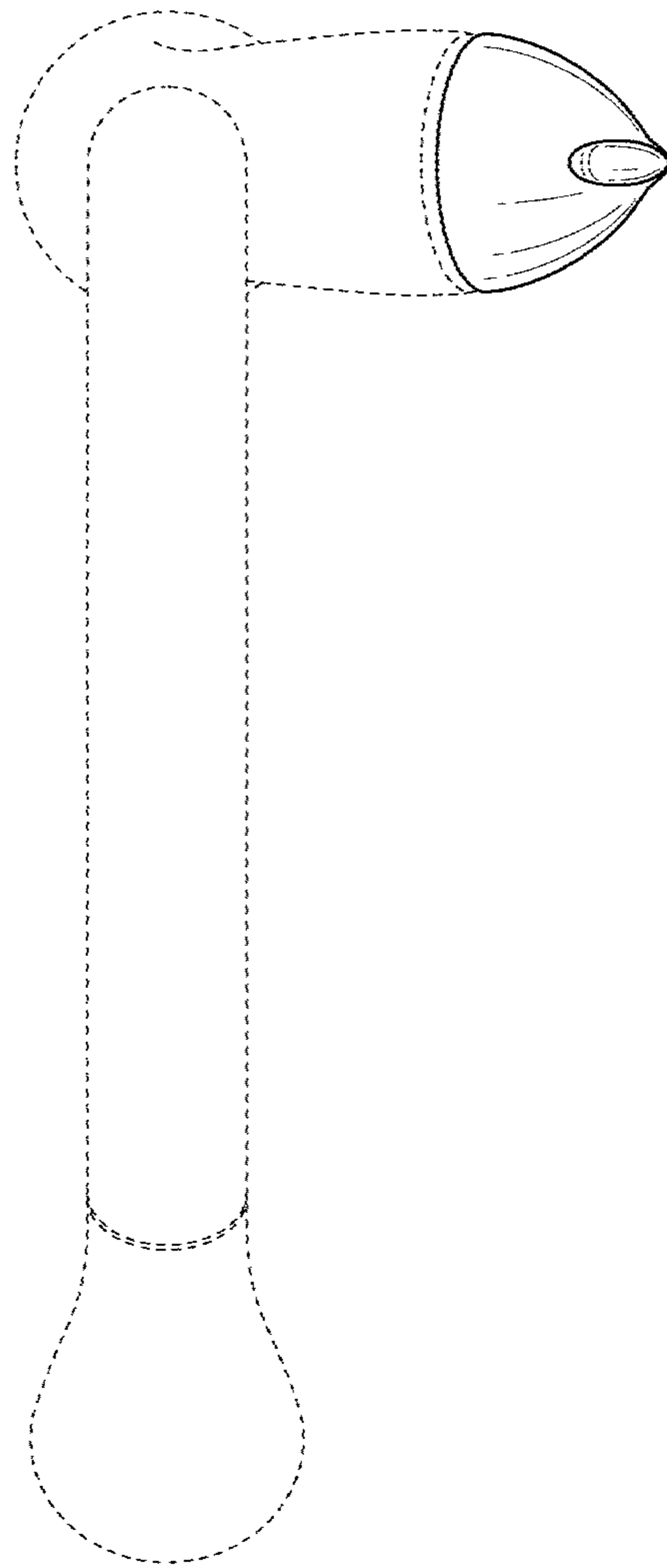
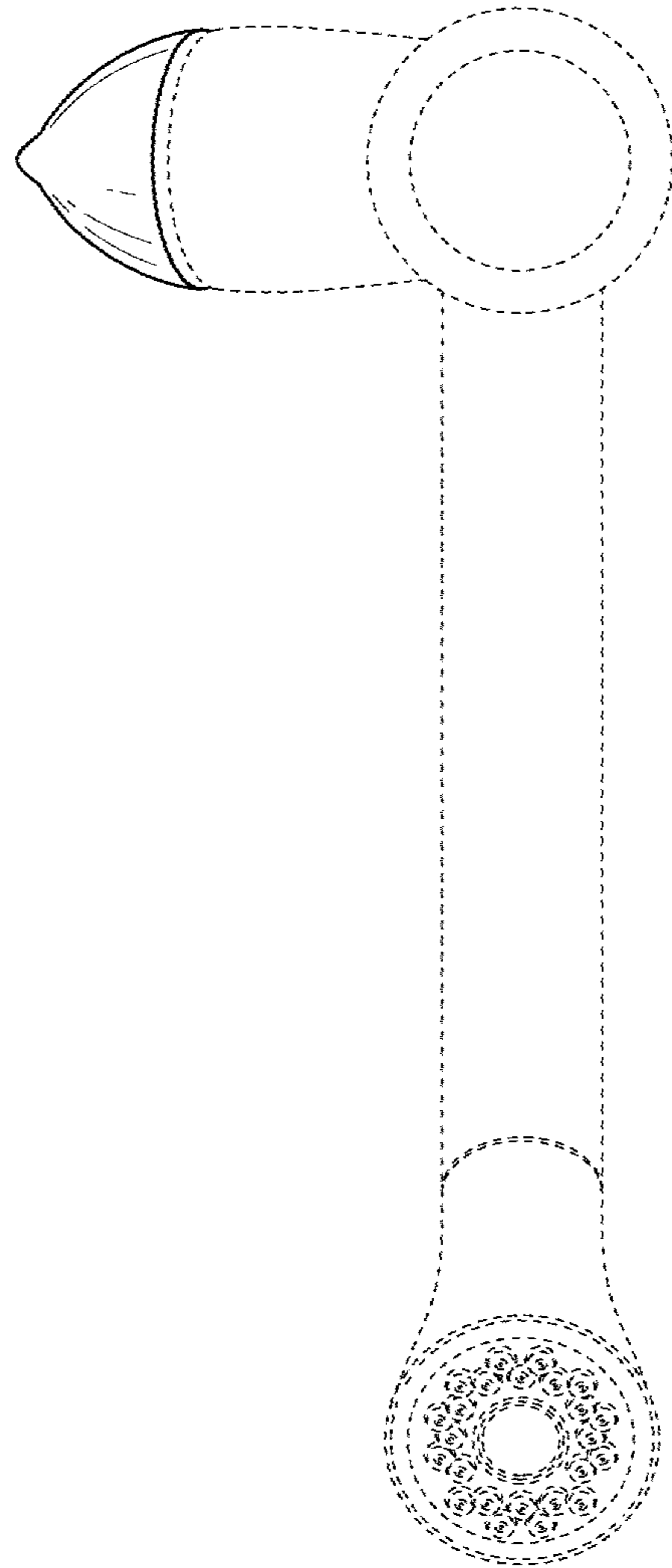
