(57) **CLAIM**

The ornamental design for a cosmetic applicator, as shown and described.

**DESCRIPTION**

FIG. 1 is an exploded perspective view of a cosmetic applicator.

FIG. 2 is a front view of the lower portion of FIG. 1 with the cap removed.

FIG. 3 is a right side elevation view of FIG. 2.

FIG. 4 is a left side elevation view of FIG. 2.

FIG. 5 is a top plan view of FIG. 2.

FIG. 6 is an enlarged perspective view of the corresponding box of FIG. 1.

FIG. 7 is an enlarged front view taken from the corresponding box in FIG. 2.

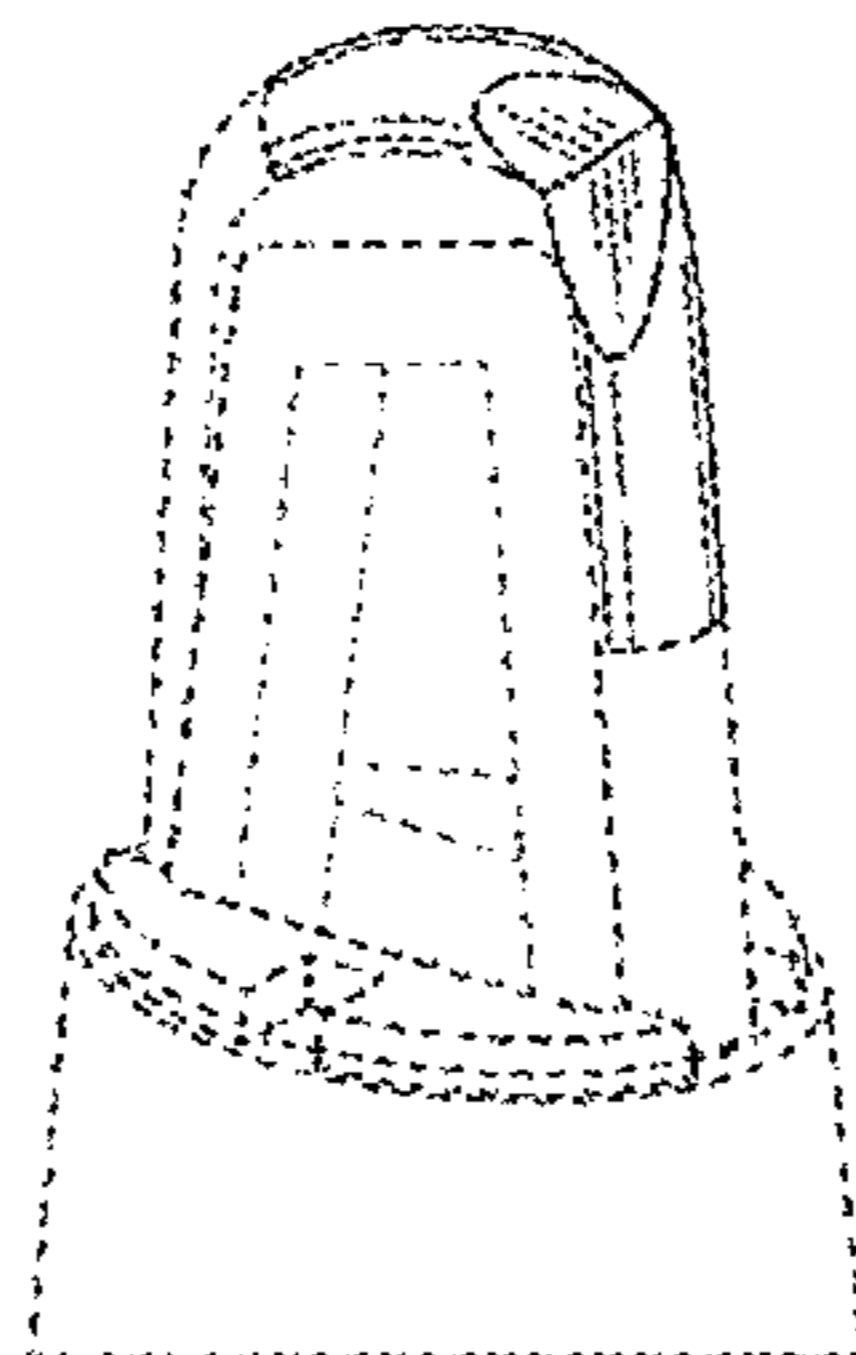
FIG. 8 is an enlarged right side view taken from the corresponding box in FIG. 3.

FIG. 9 is an enlarged left side view taken from the corresponding box in FIG. 4; and,

FIG. 10 is an enlarged top plan view taken from the corresponding portion of FIG. 5.

The dashed lines are included for the purpose of illustrating the portions of the article that form no part of the claimed design. The dot-dashed lines in FIGS. 6-10 show unclaimed boundaries, and the boxes in dot-dot-dashed lines indicate the areas of enlargement in FIGS. 6-10.

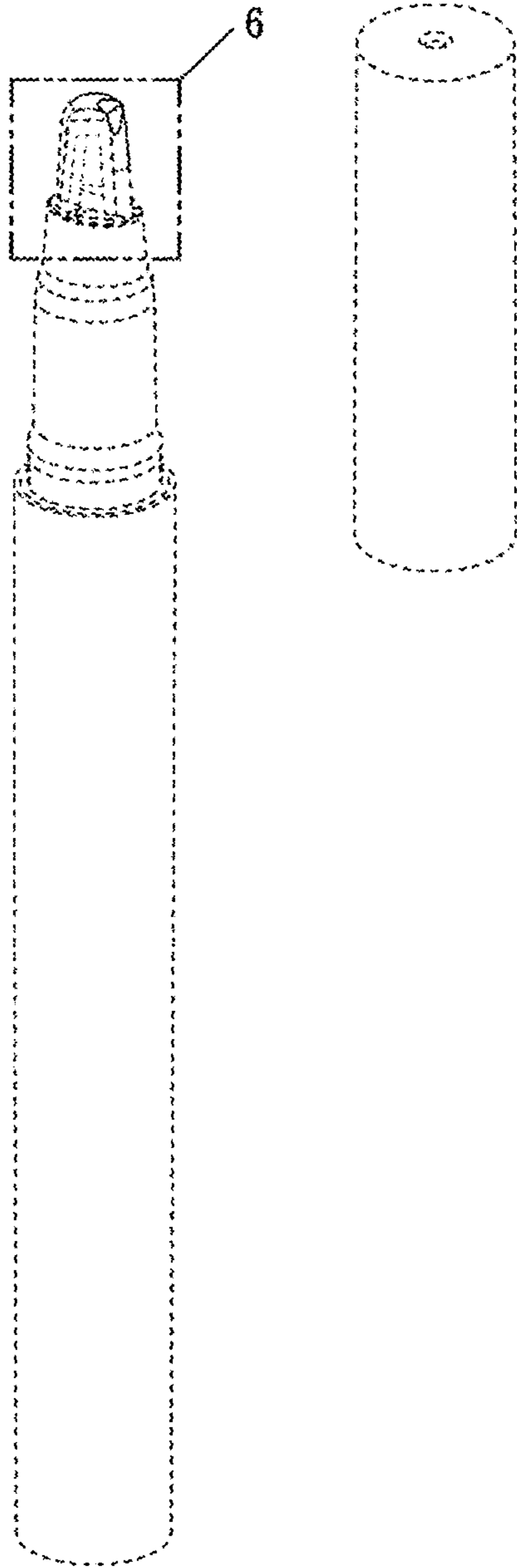

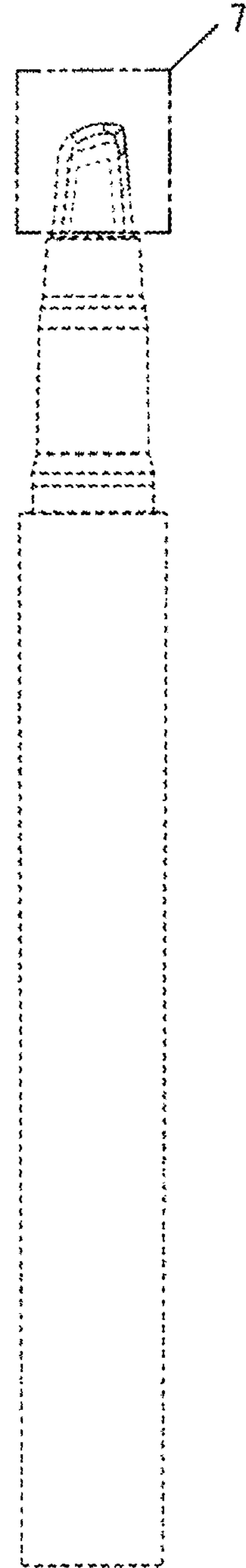

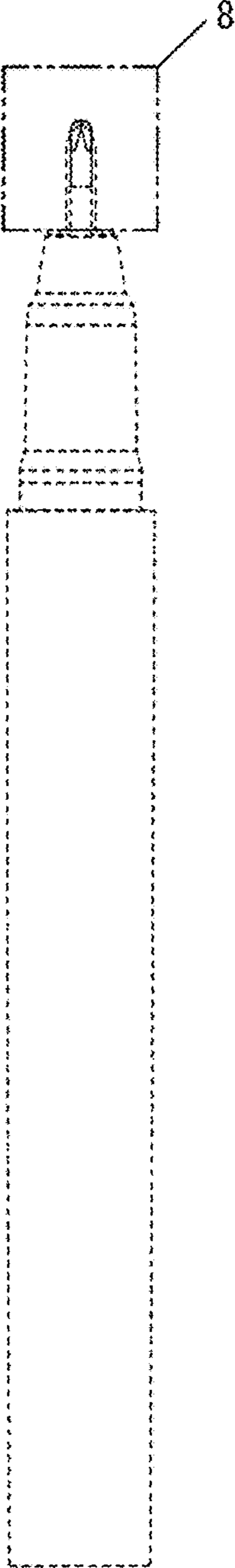

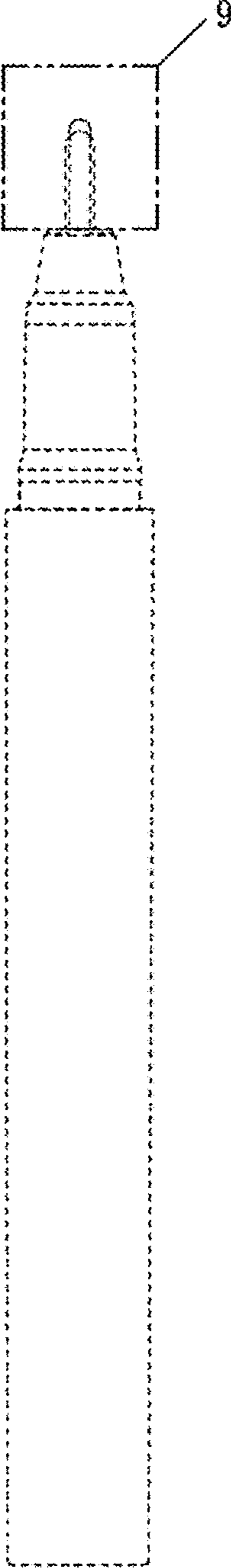

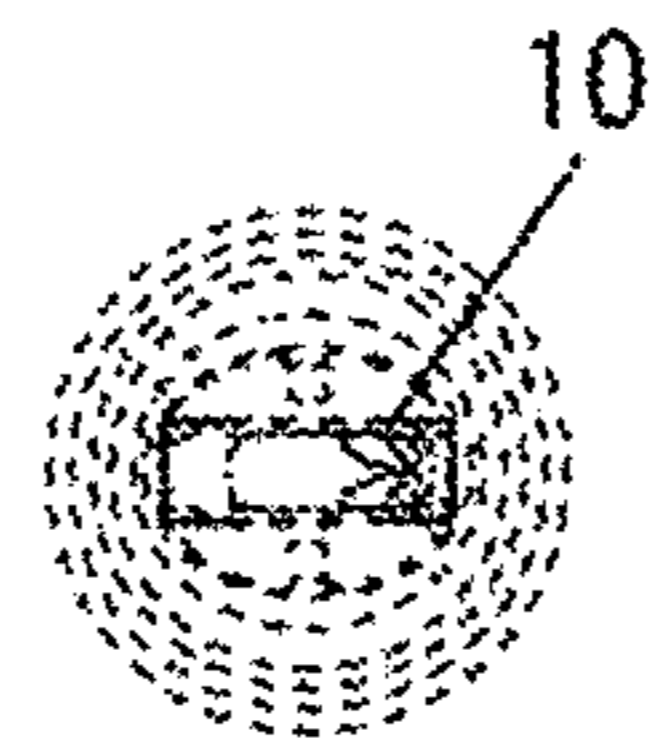

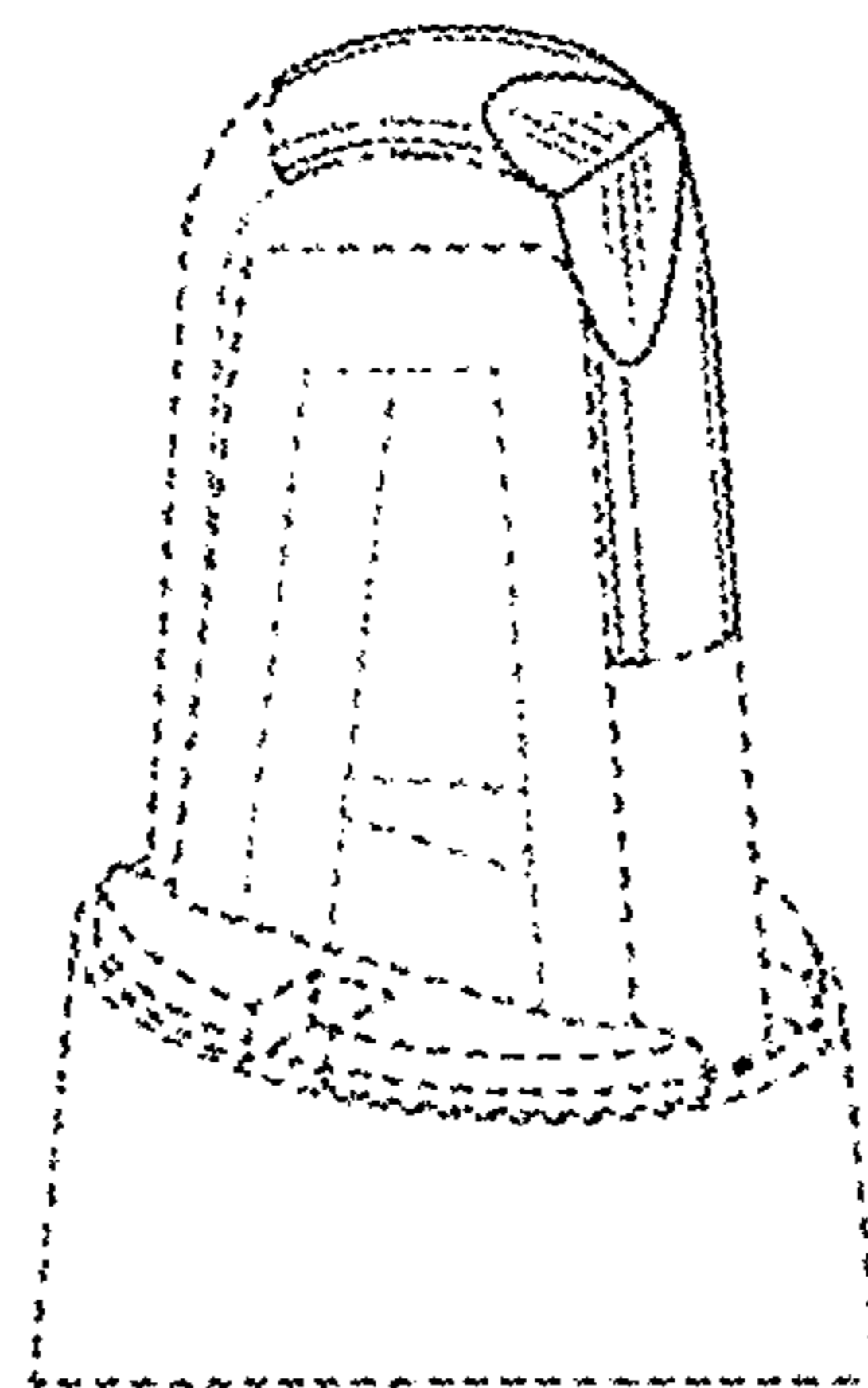

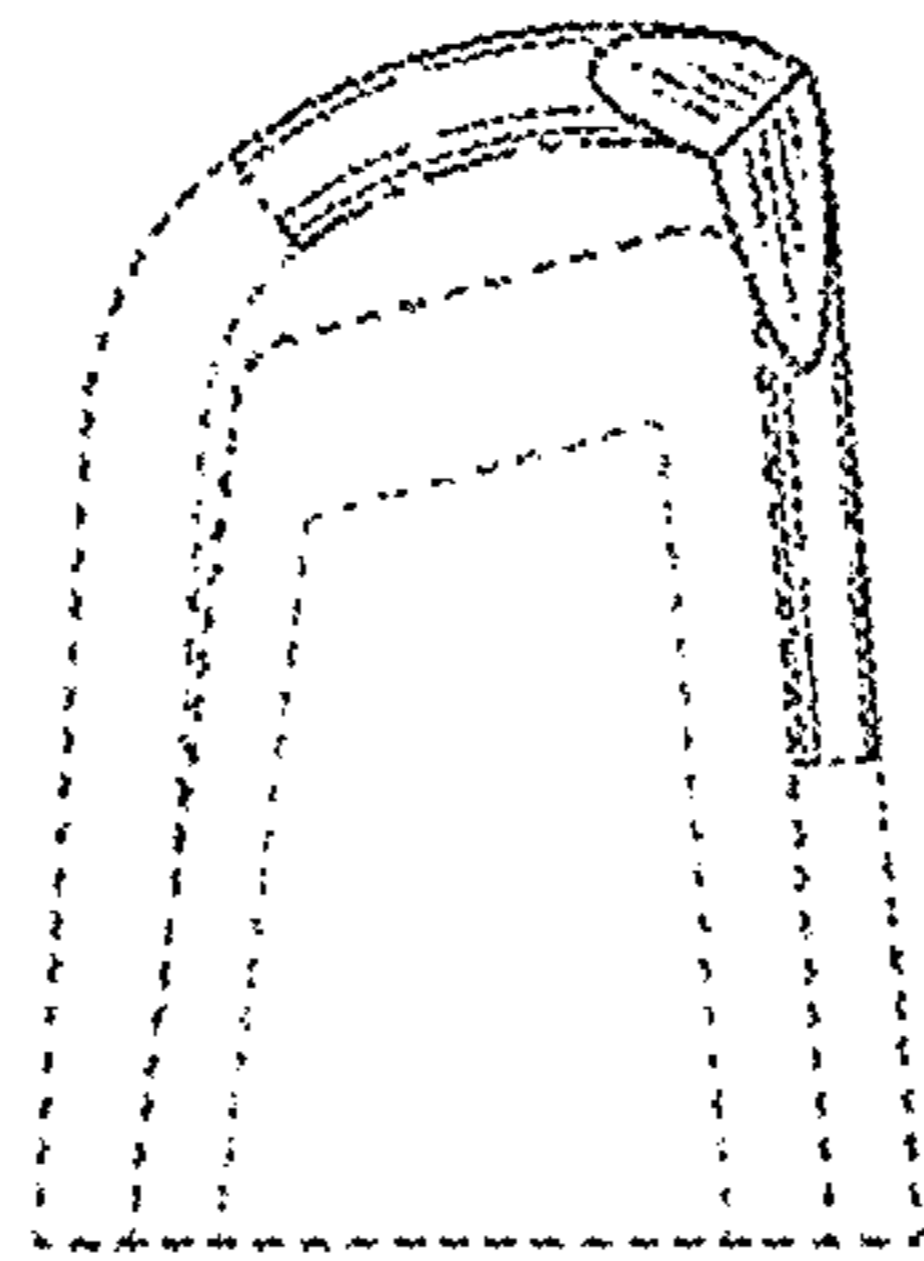

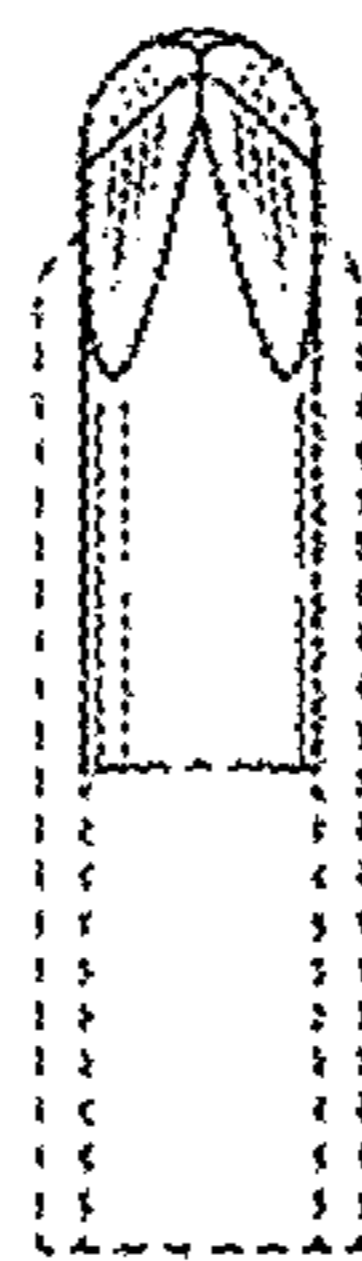

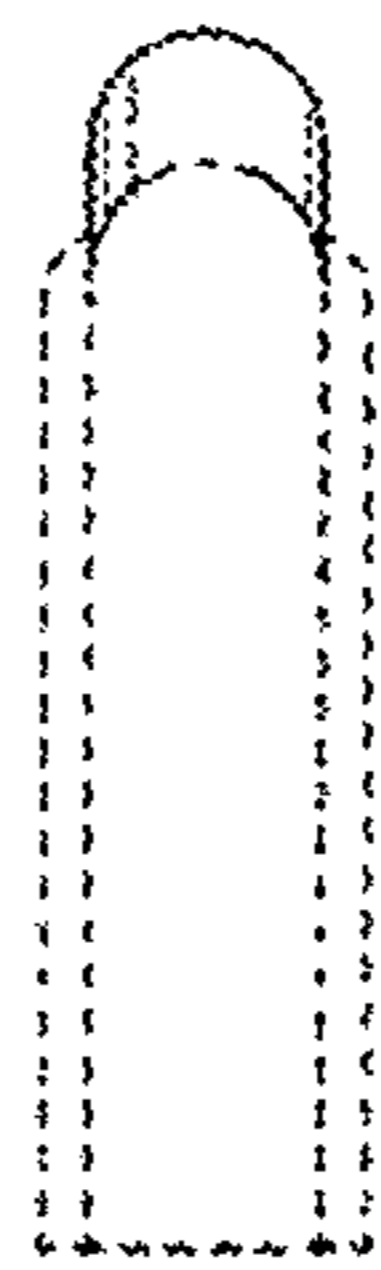
