**DESCRIPTION**

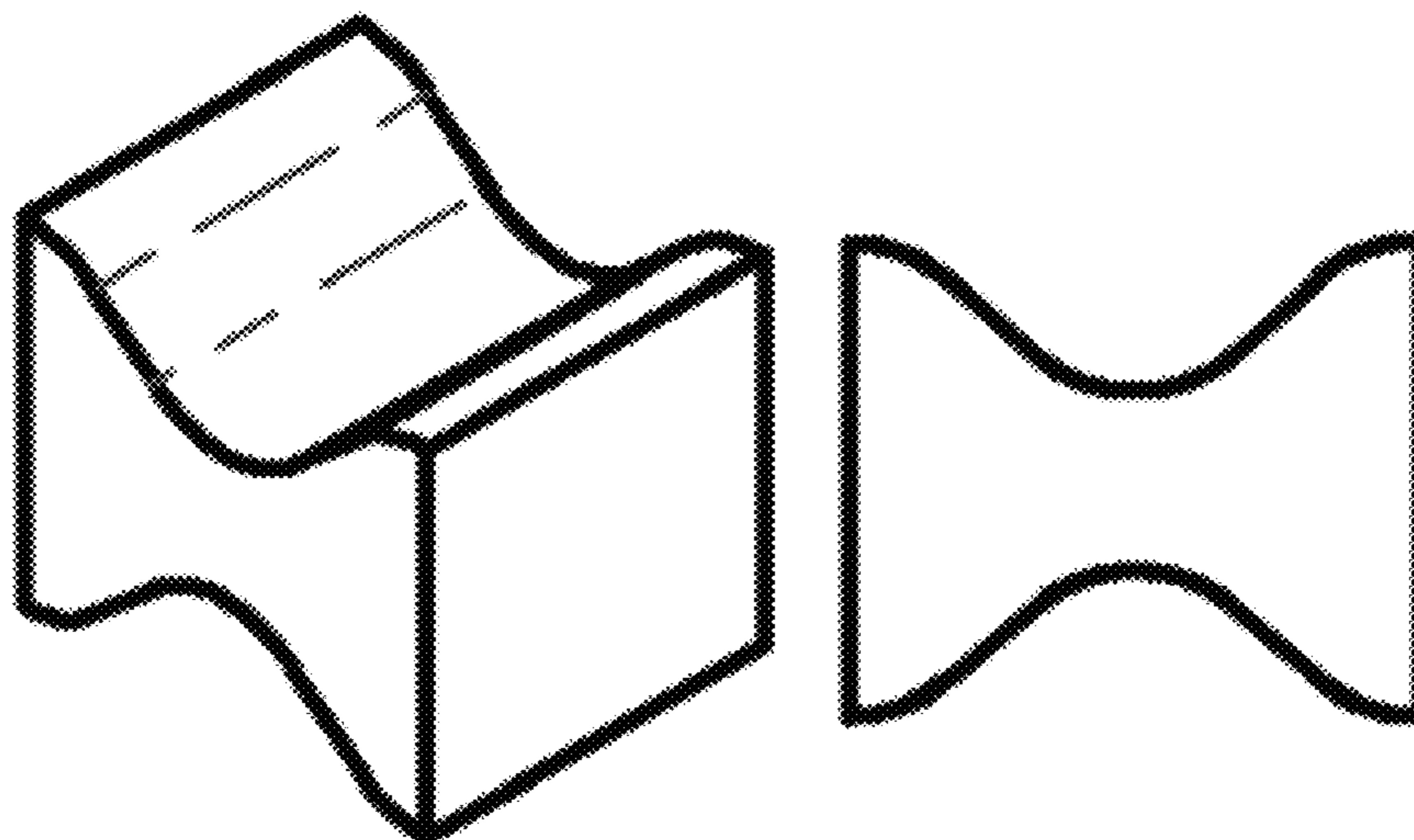
FIG. 1 is a perspective view of a food product in accordance with this invention.

FIG. 2 is a side view of the food product of FIG. 1, wherein the opposite side view of the food product is a mirror image of FIG. 2 and therefore not shown.

FIG. 3 is a right elevational view of the food product of FIG. 1, wherein the left elevational view of the food product is a mirror image of FIG. 3 and therefore not shown; and,

FIG. 4 is a top view of the food product of FIG. 1, wherein the bottom view of the food product is a mirror image of FIG. 4 and therefore not shown.

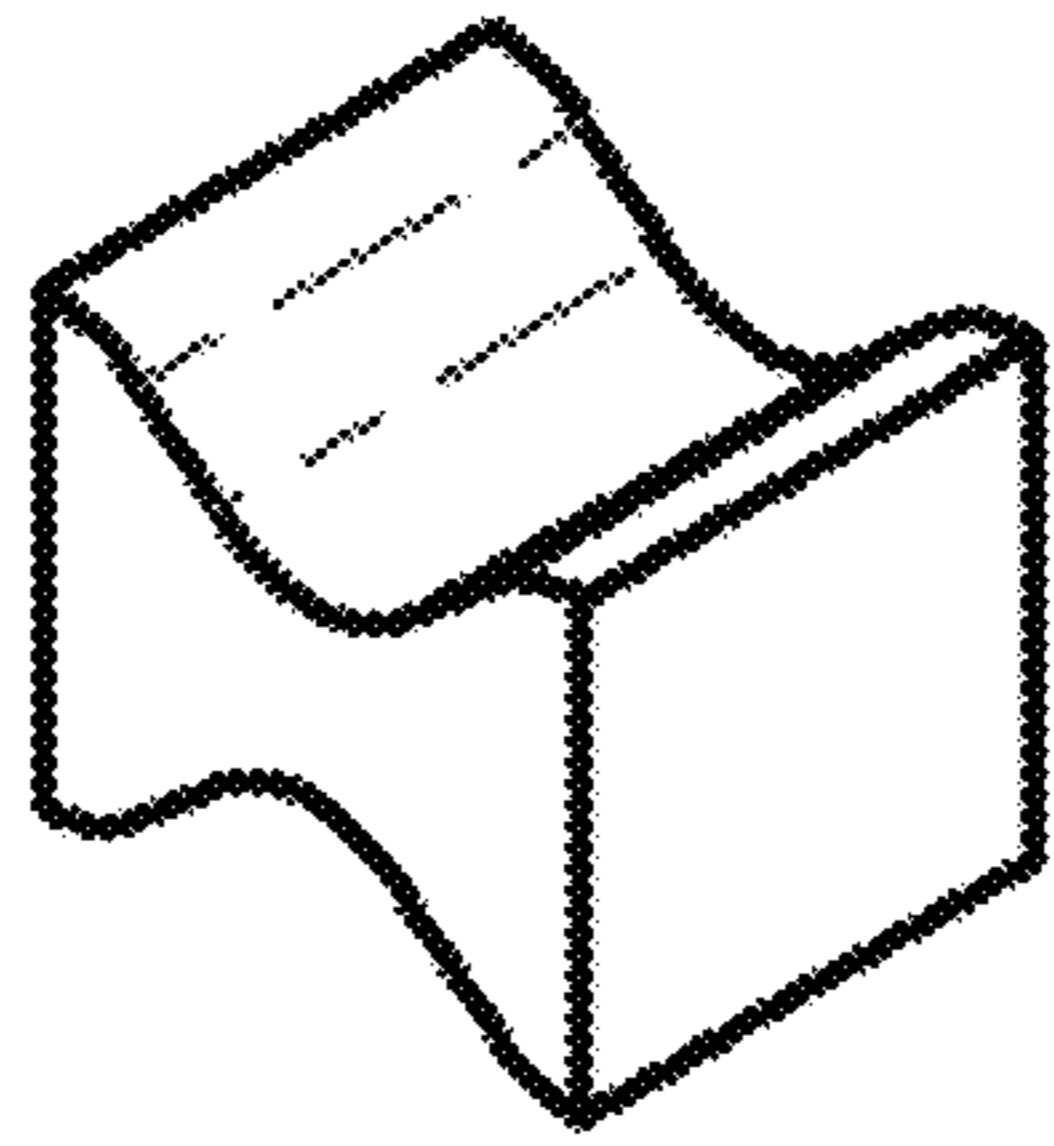

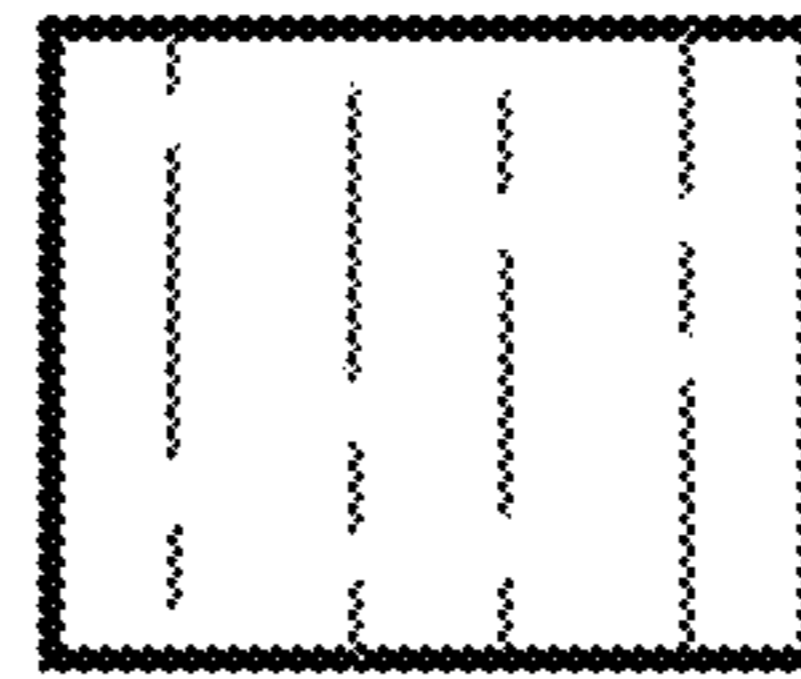

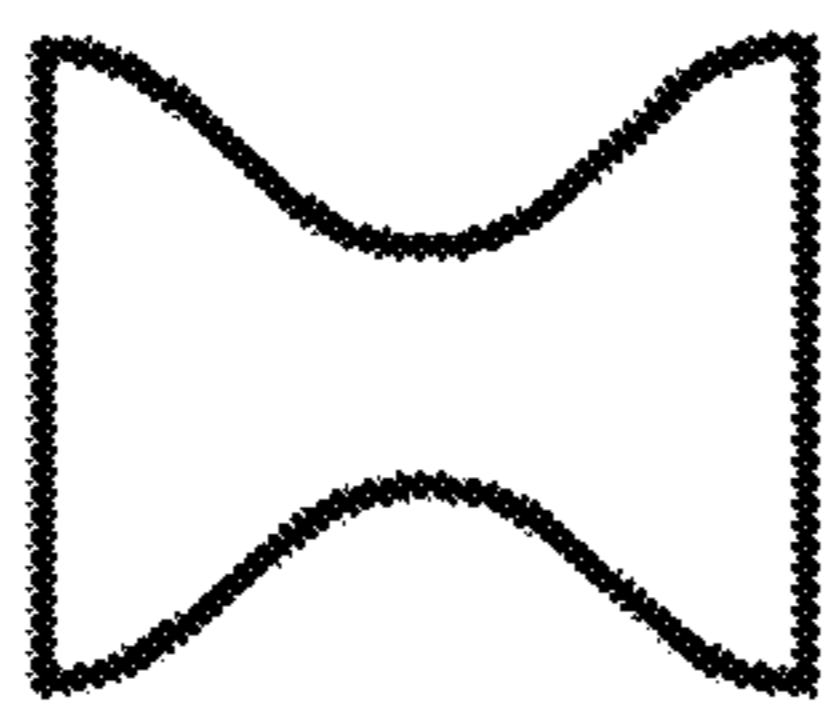

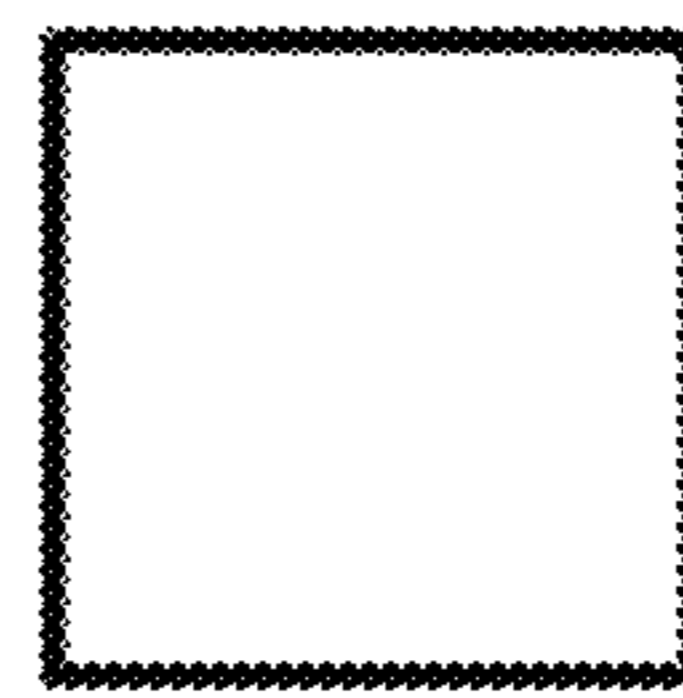
