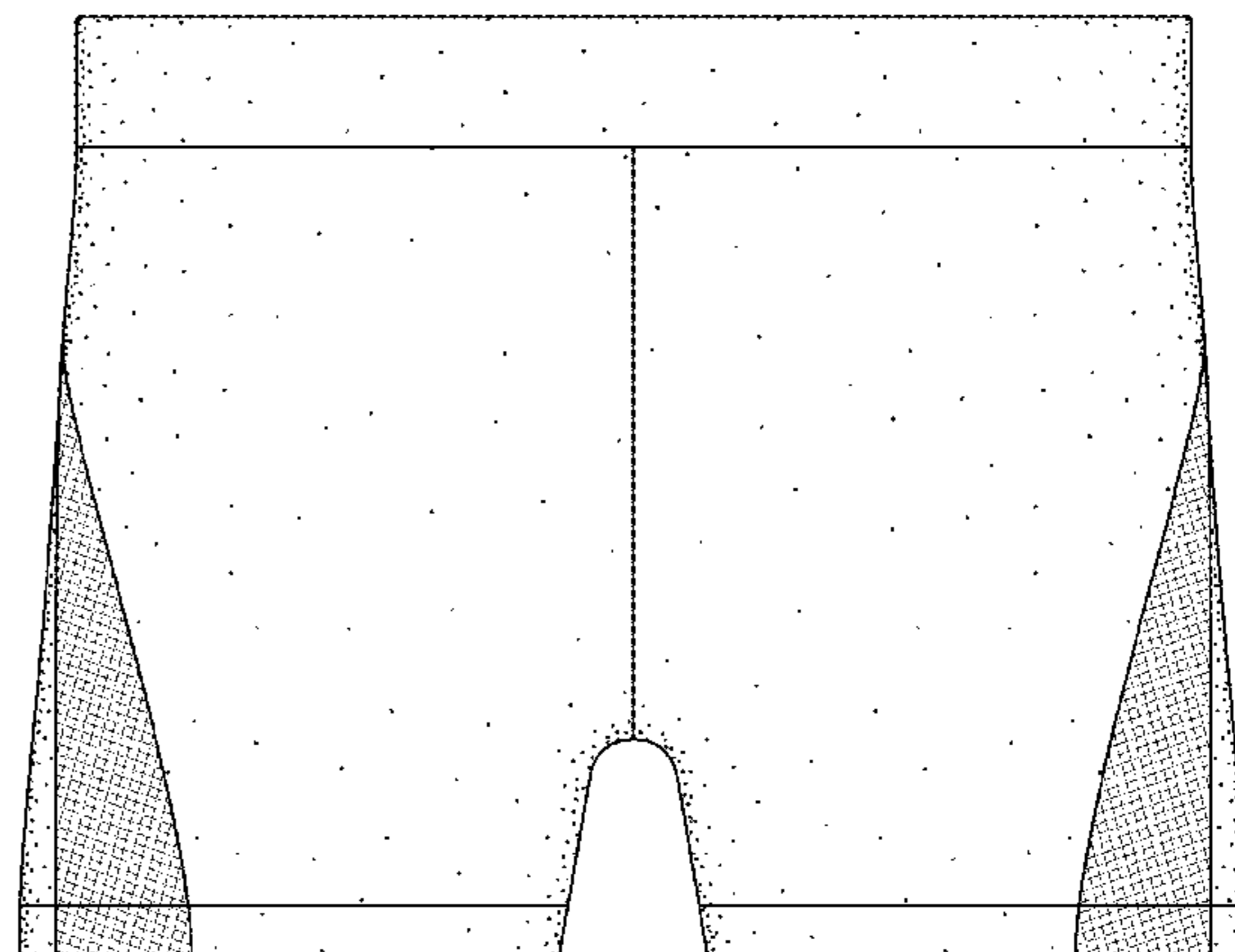
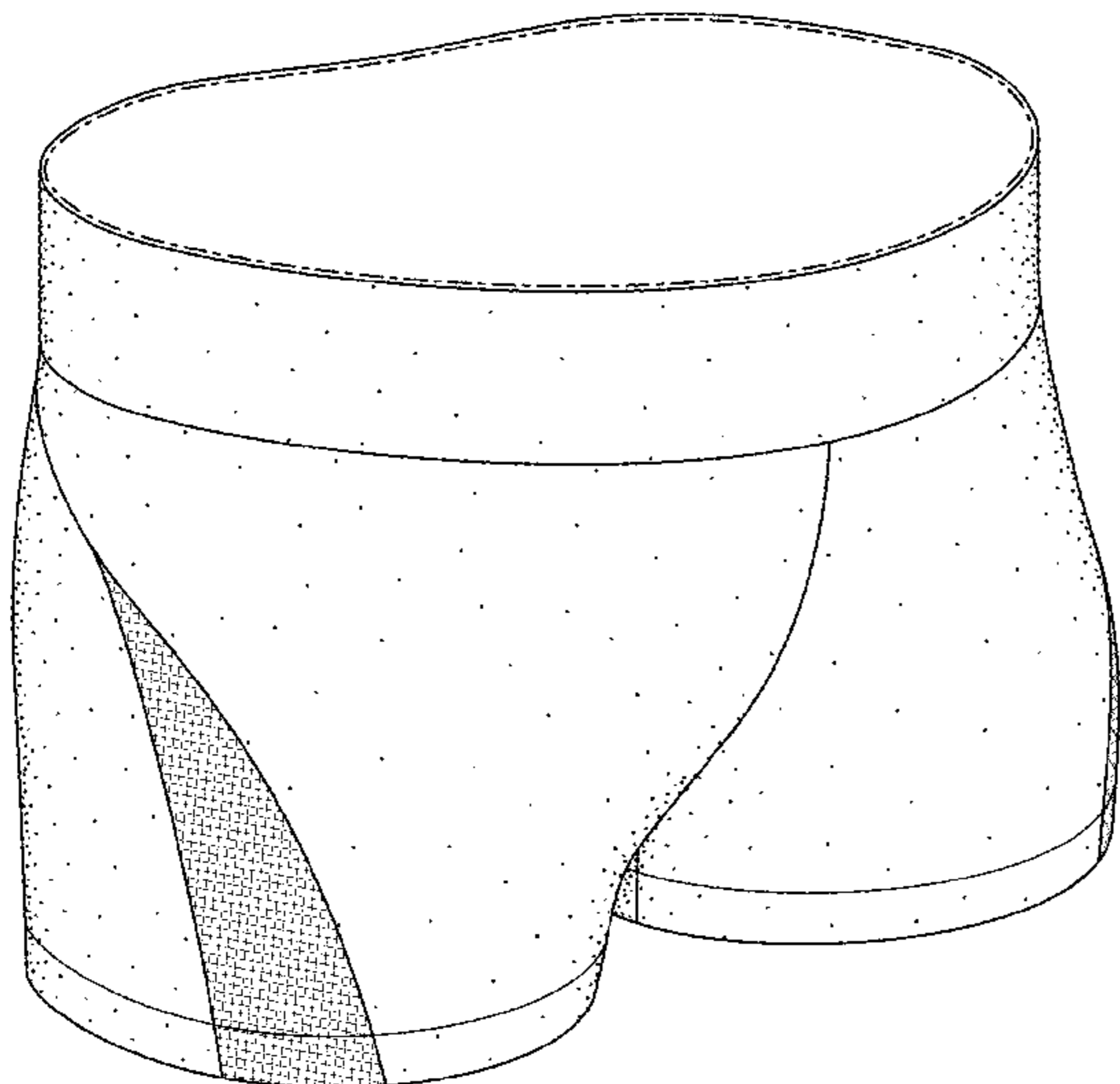
(57) **CLAIM**

The ornamental design for shorts, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of shorts showing our new design in an in-use configuration;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a side view thereof;  
FIG. 5 is a second side view thereof;  
FIG. 6 is a top view thereof; and,  
FIG. 7 is a bottom view thereof.  
The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The unshaded regions demarcated by the broken lines, represent unclaimed portions of the shorts. The broken lines showing the remainder of the shorts are for environmental purposes only and form no part of the claimed design.

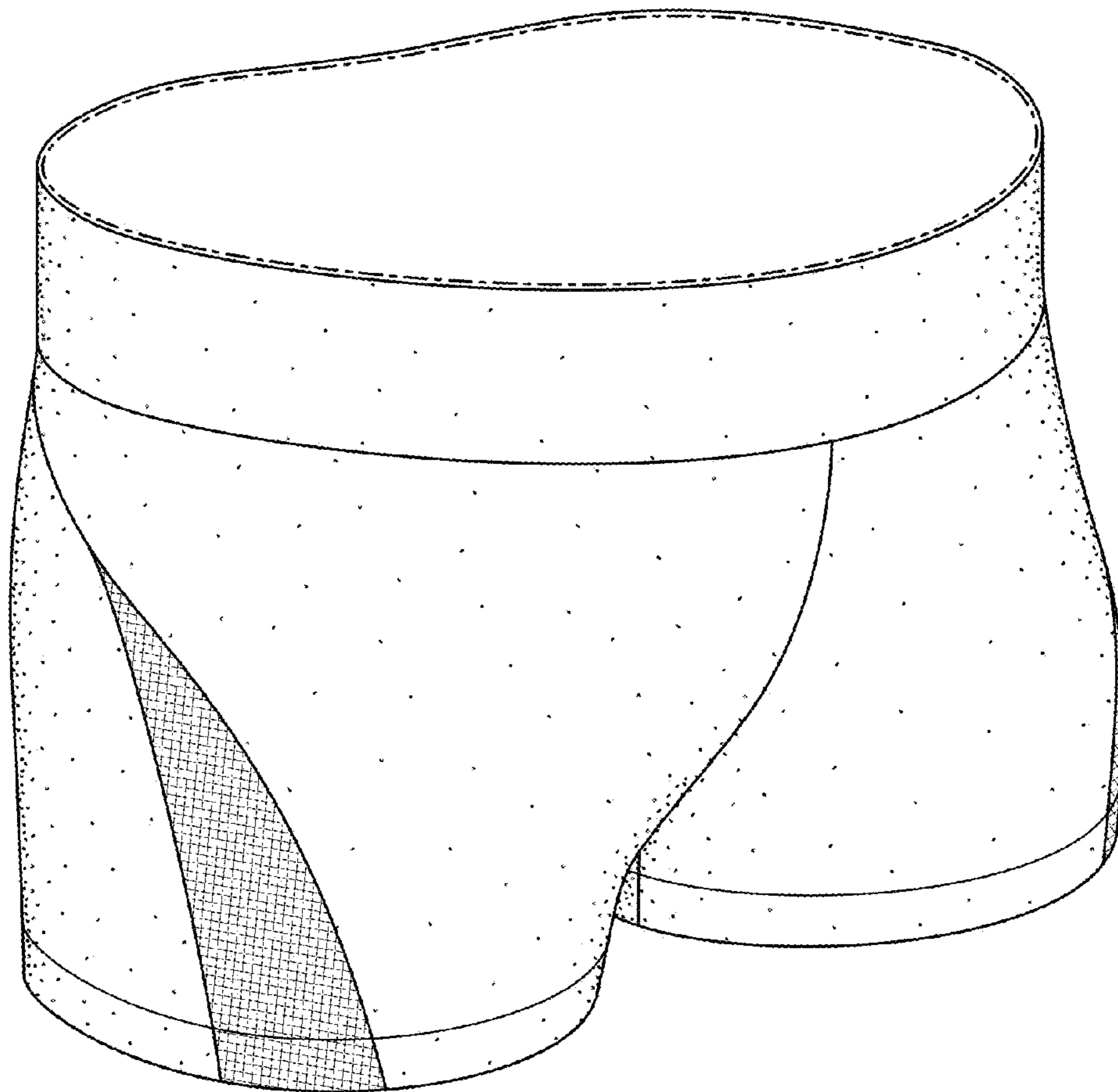

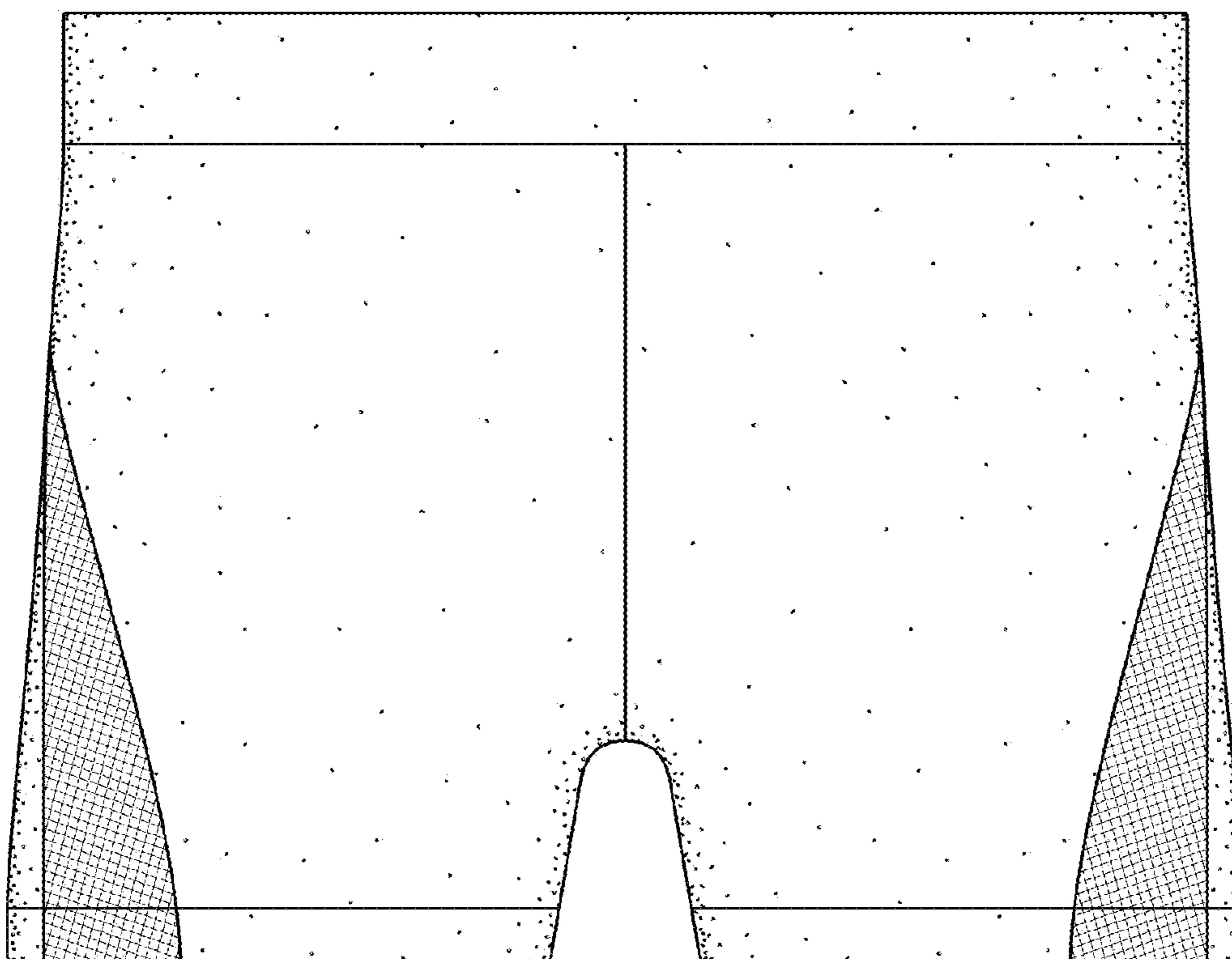

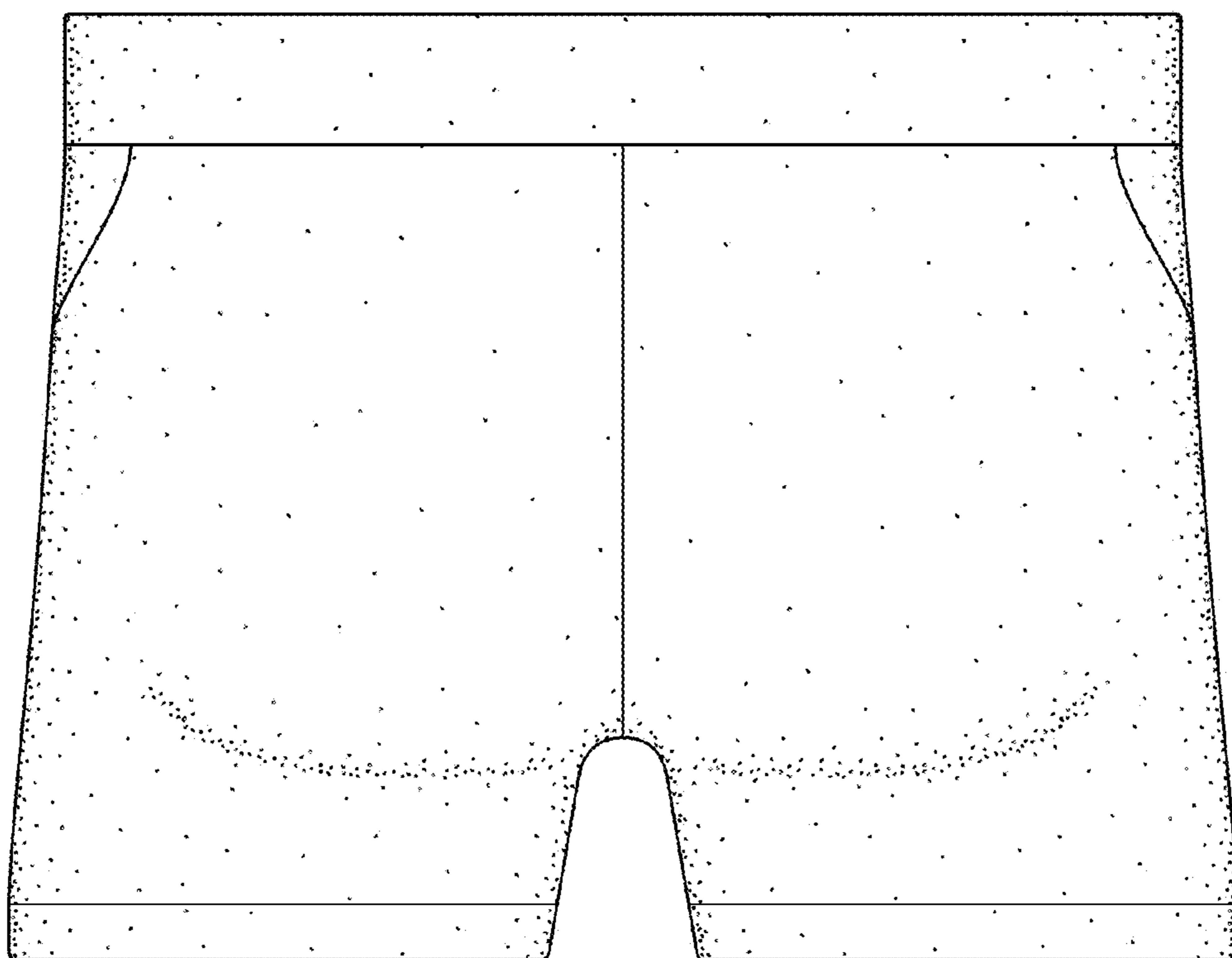

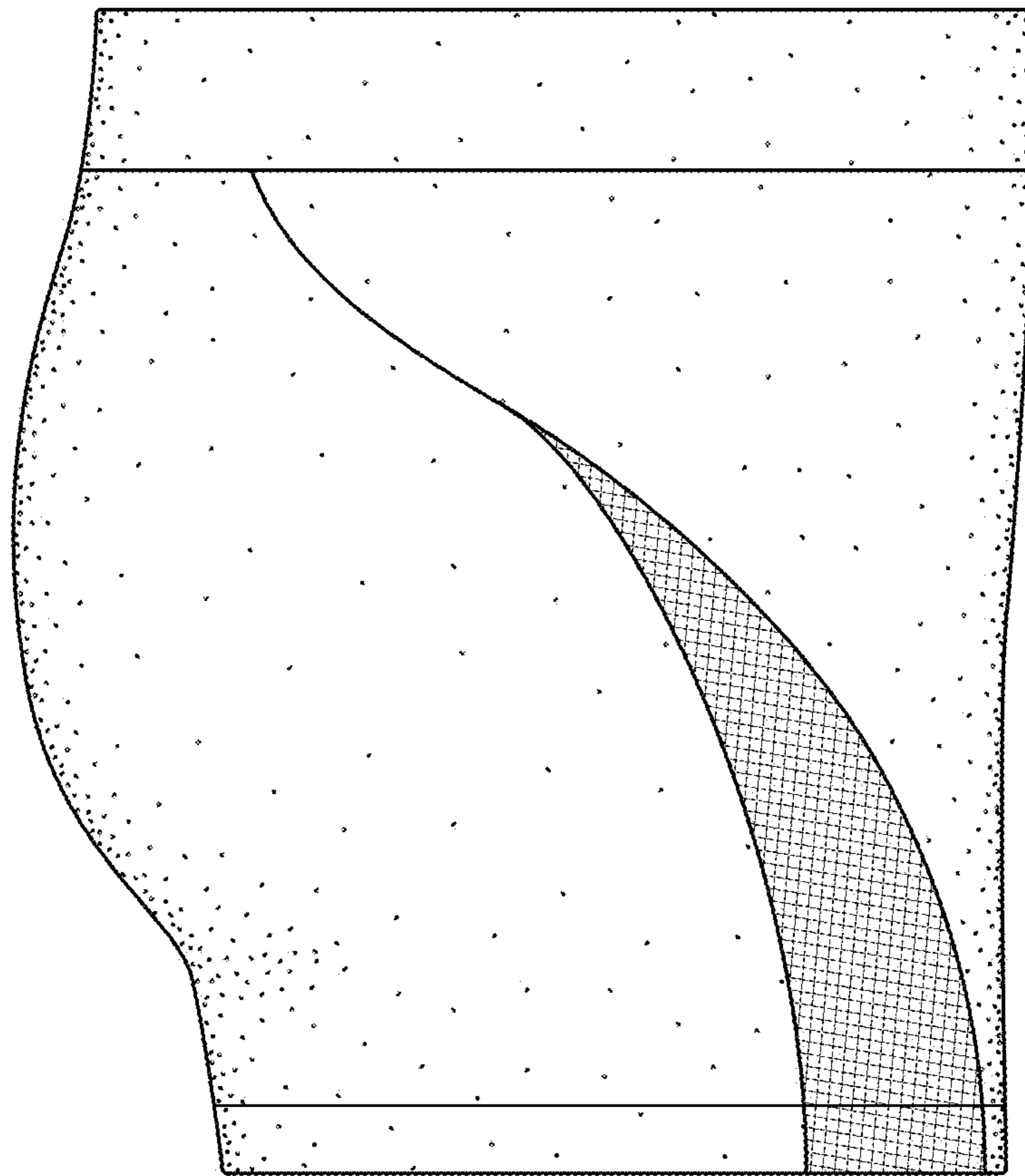

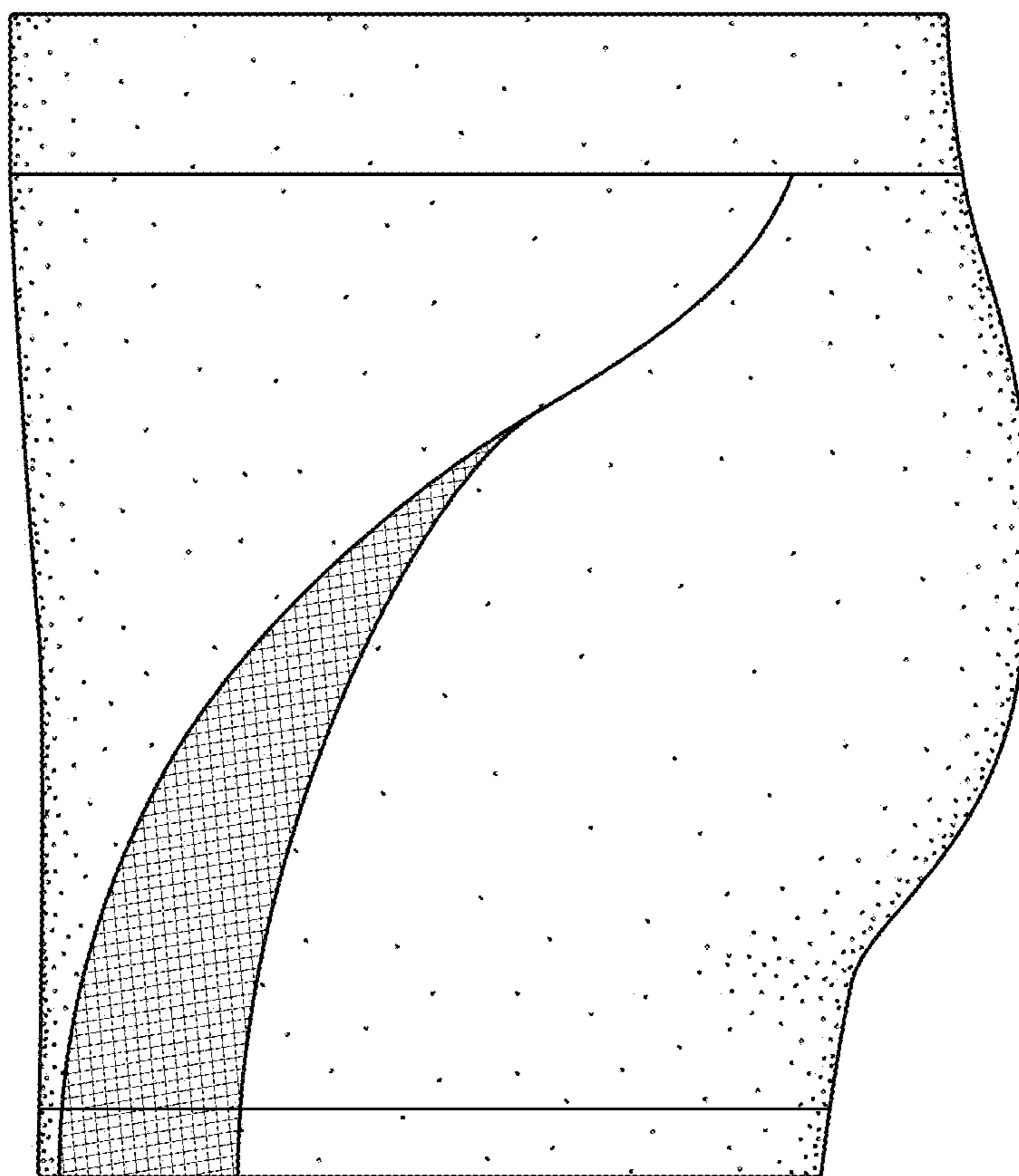

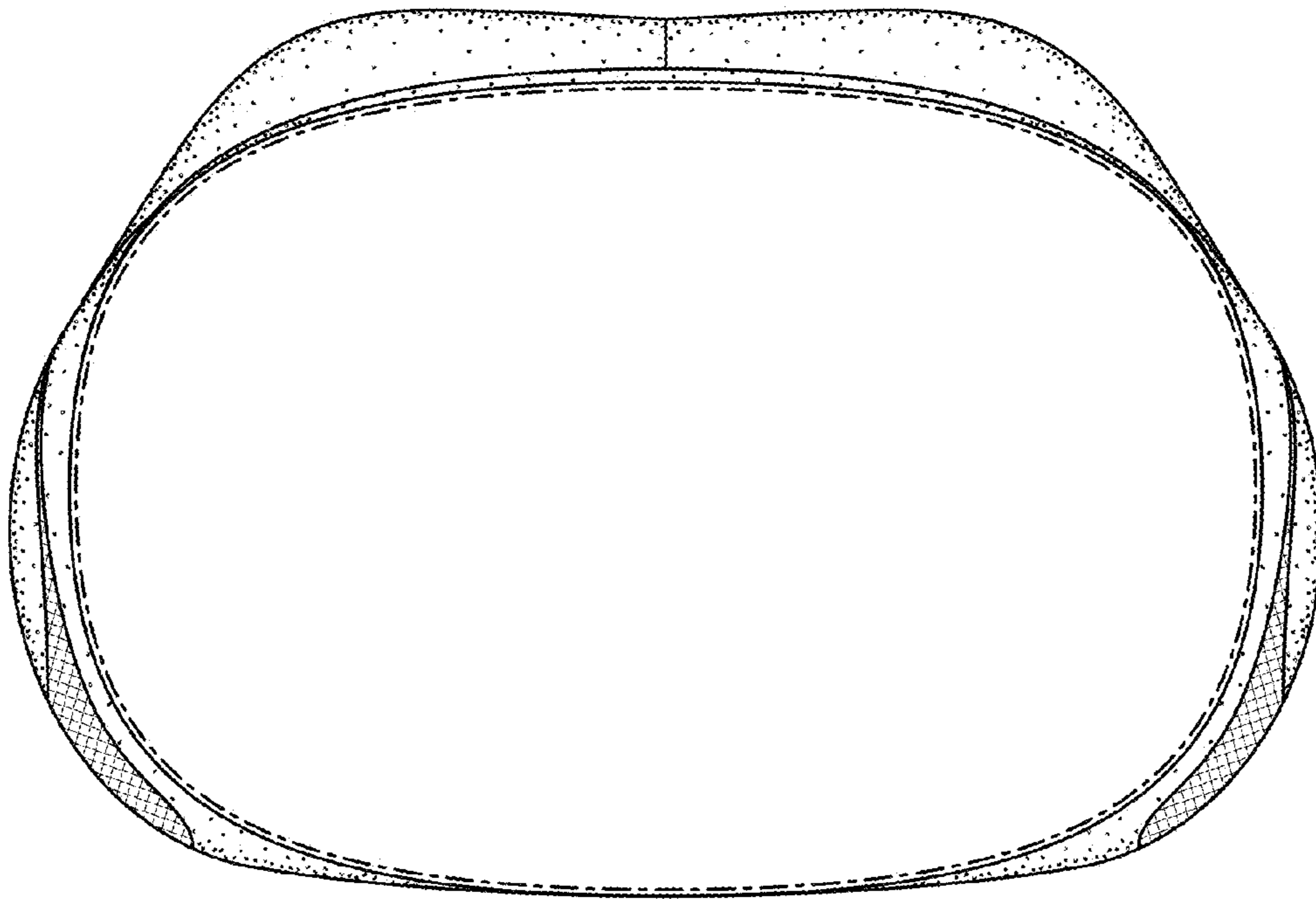

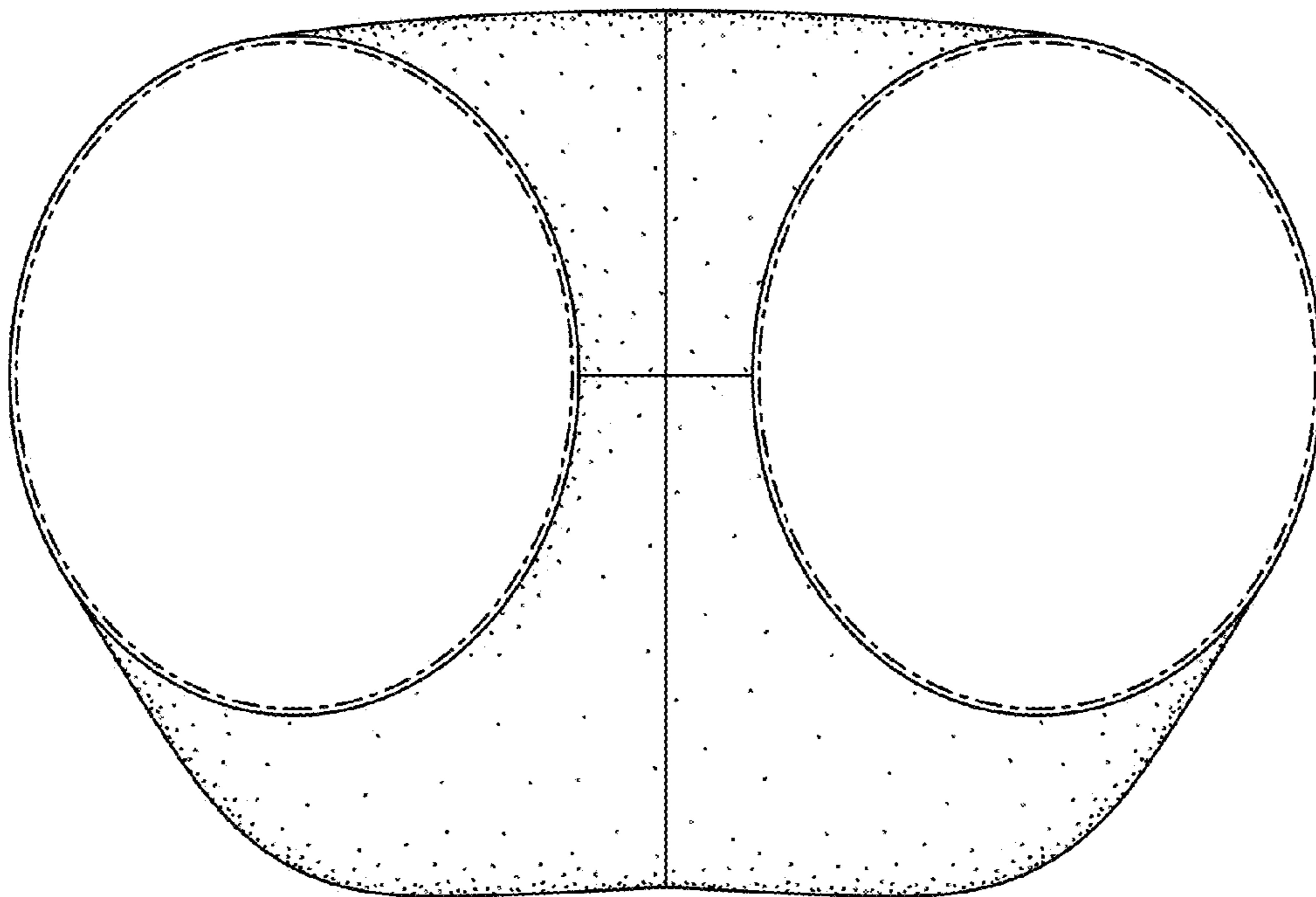
