(57) **CLAIM**

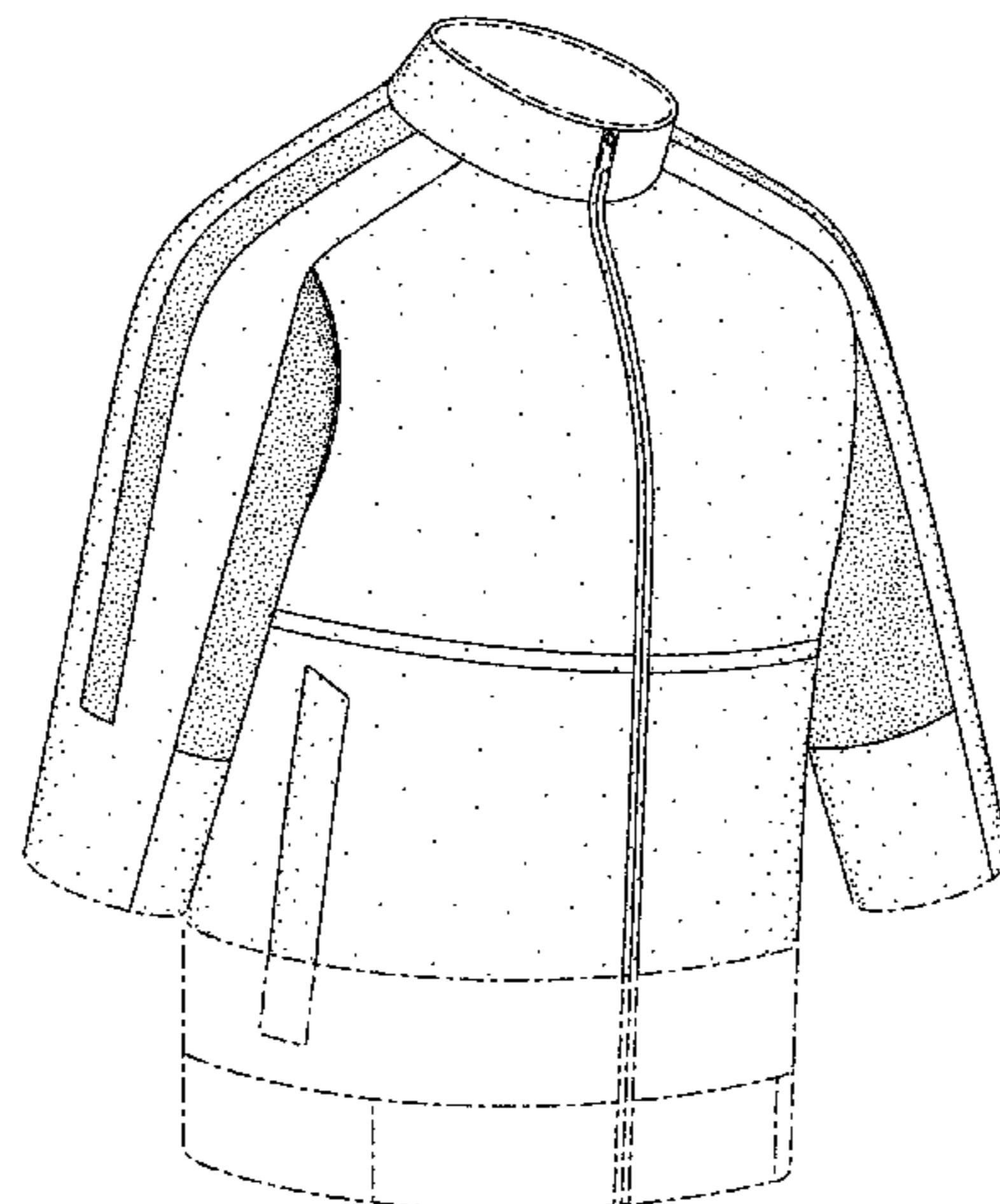
The ornamental design for a garment, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a garment showing our new design in an in-use configuration;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof;
FIG. 8 is a left side view shown in FIG. 4 with the sleeve removed for clarity to show the features of the claimed design; and,
FIG. 9 is a right side view shown in FIG. 5 with the sleeve removed for clarity to show the features of the claimed design.

The broken lines immediately adjacent to the shaded area represent an unclaimed boundary of the design. The contrast in shading represents a contrast in appearance only and does not represent any particular color, material, texture or finish. The broken lines showing the remainder of the garment are for environmental purposes only and form no part of the claimed design.

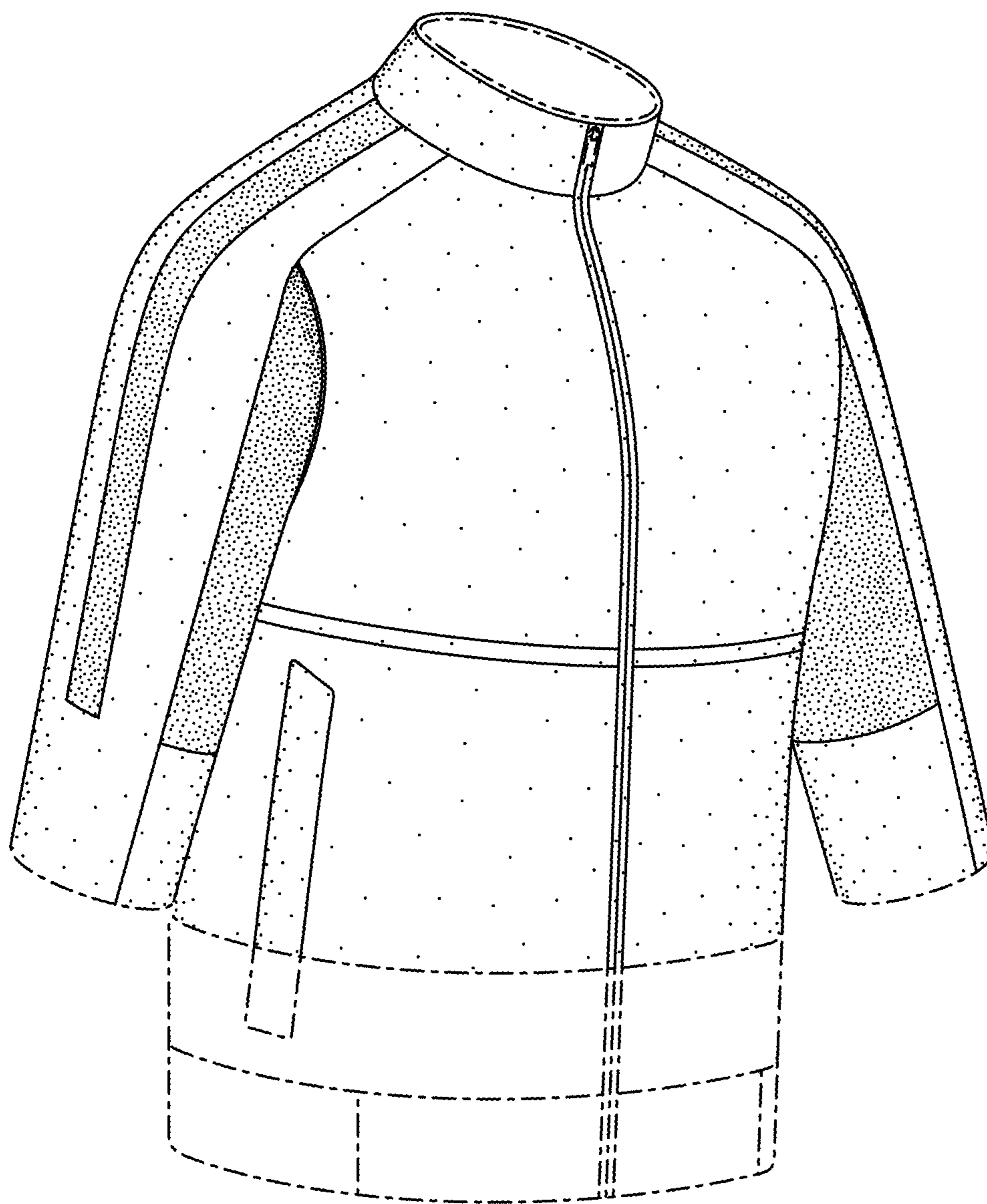

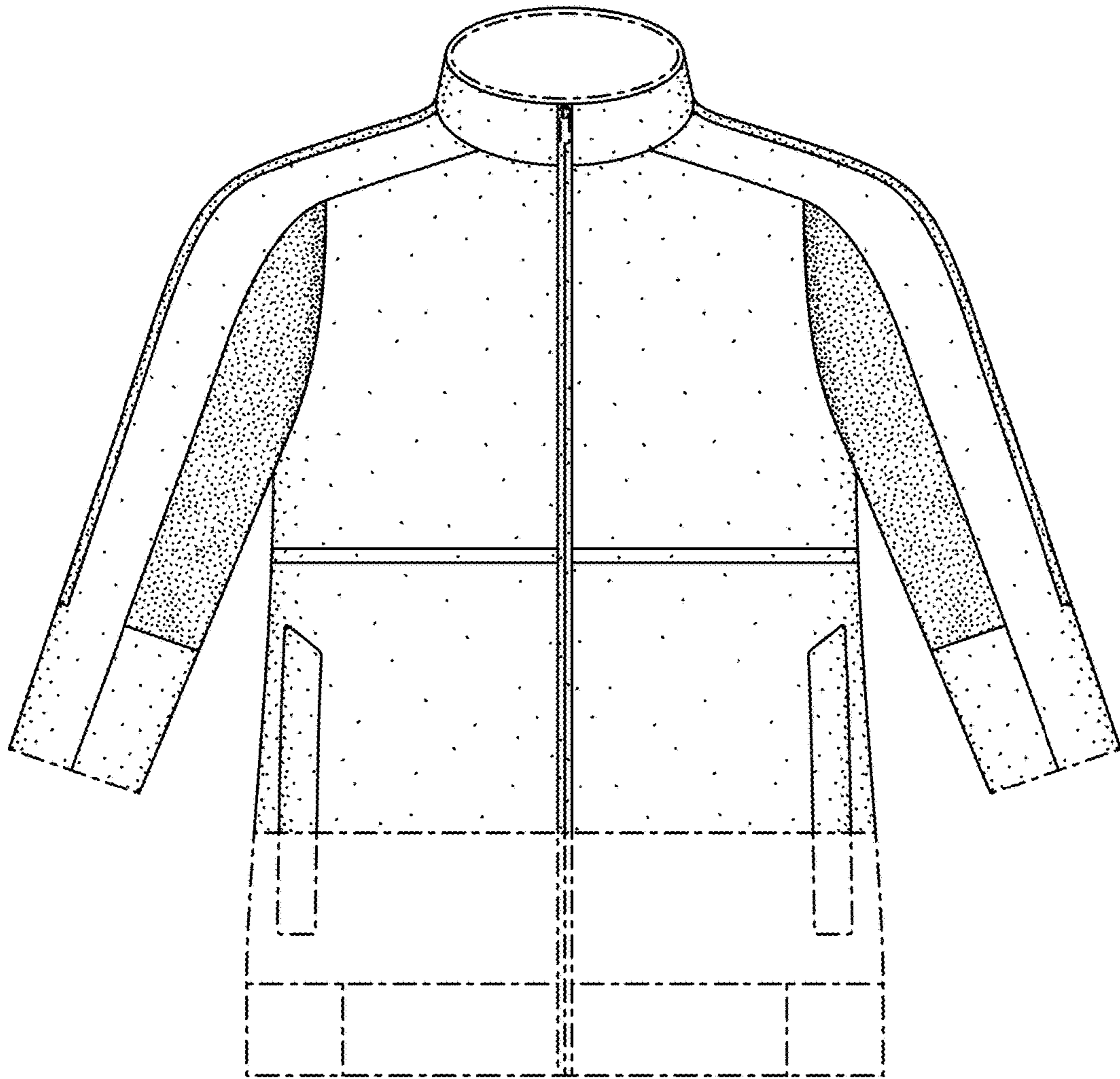

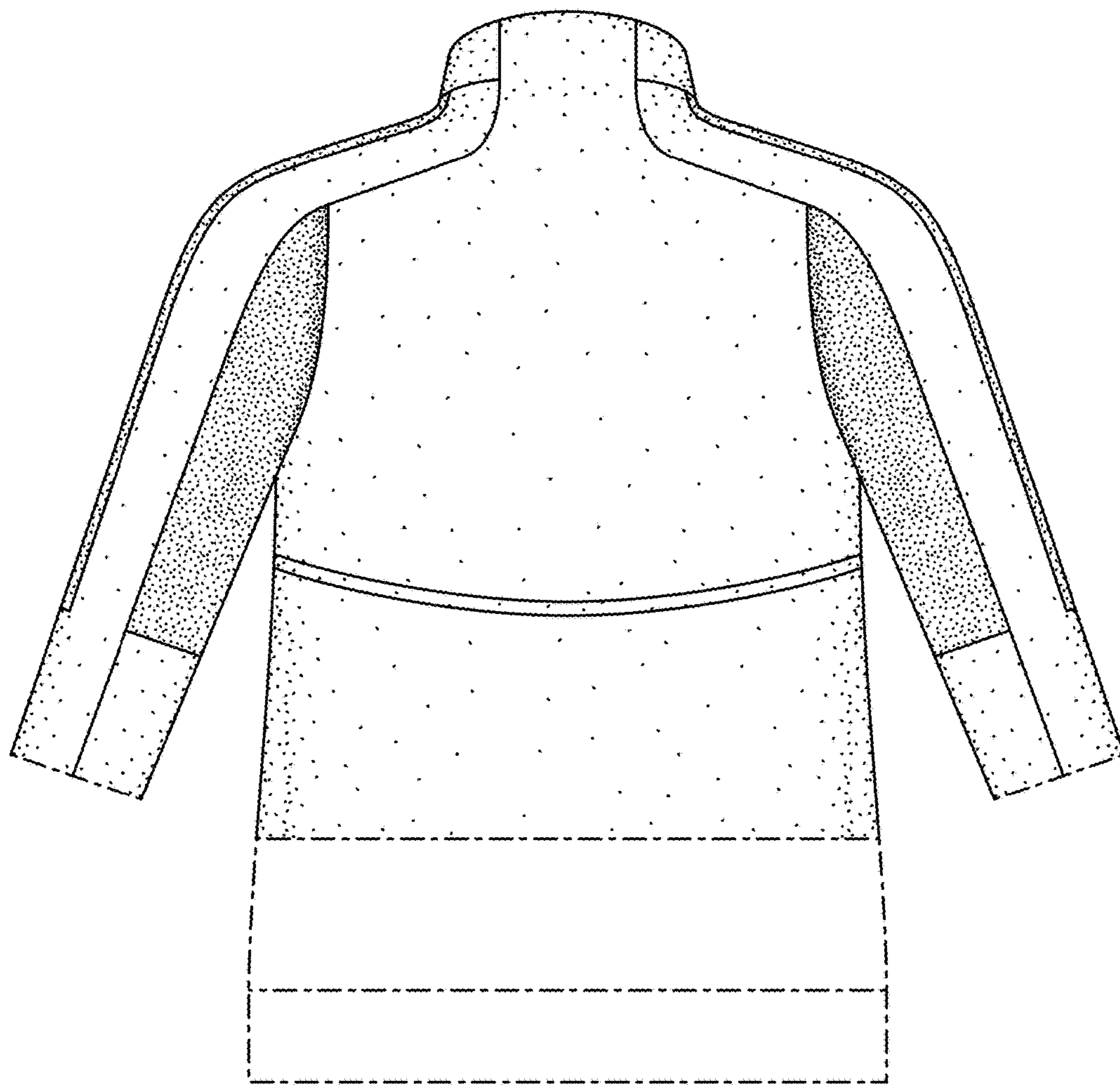

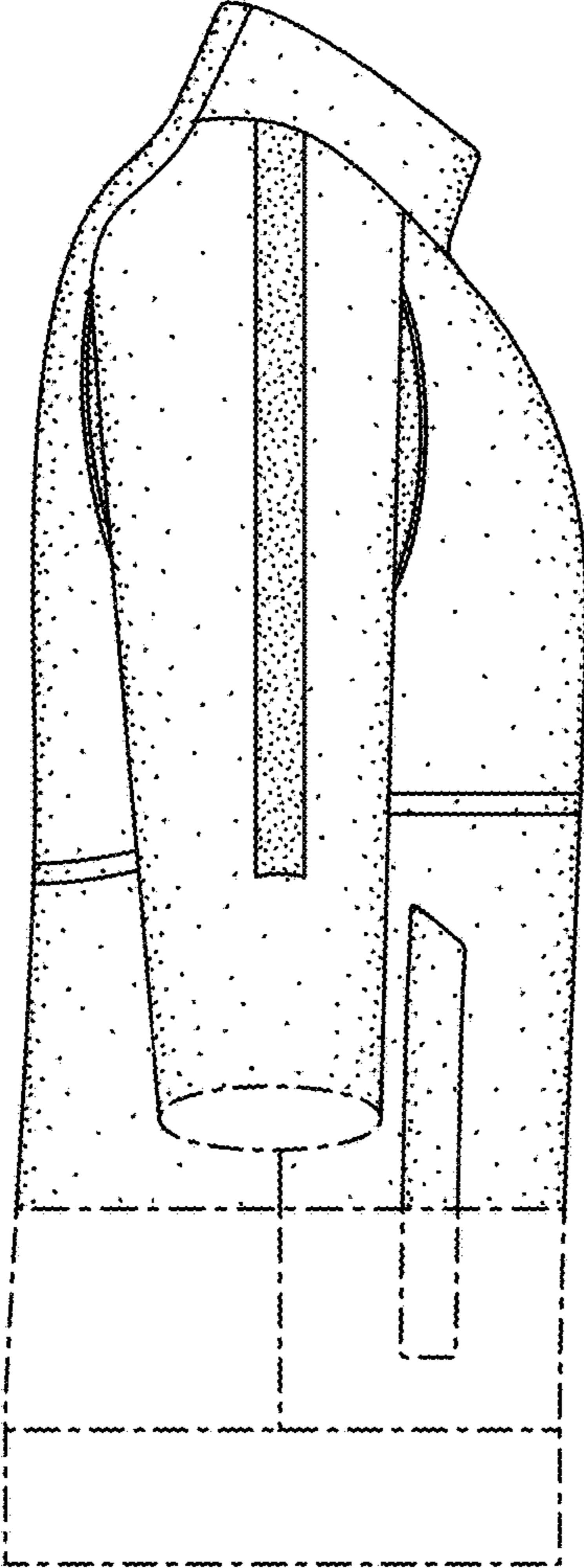

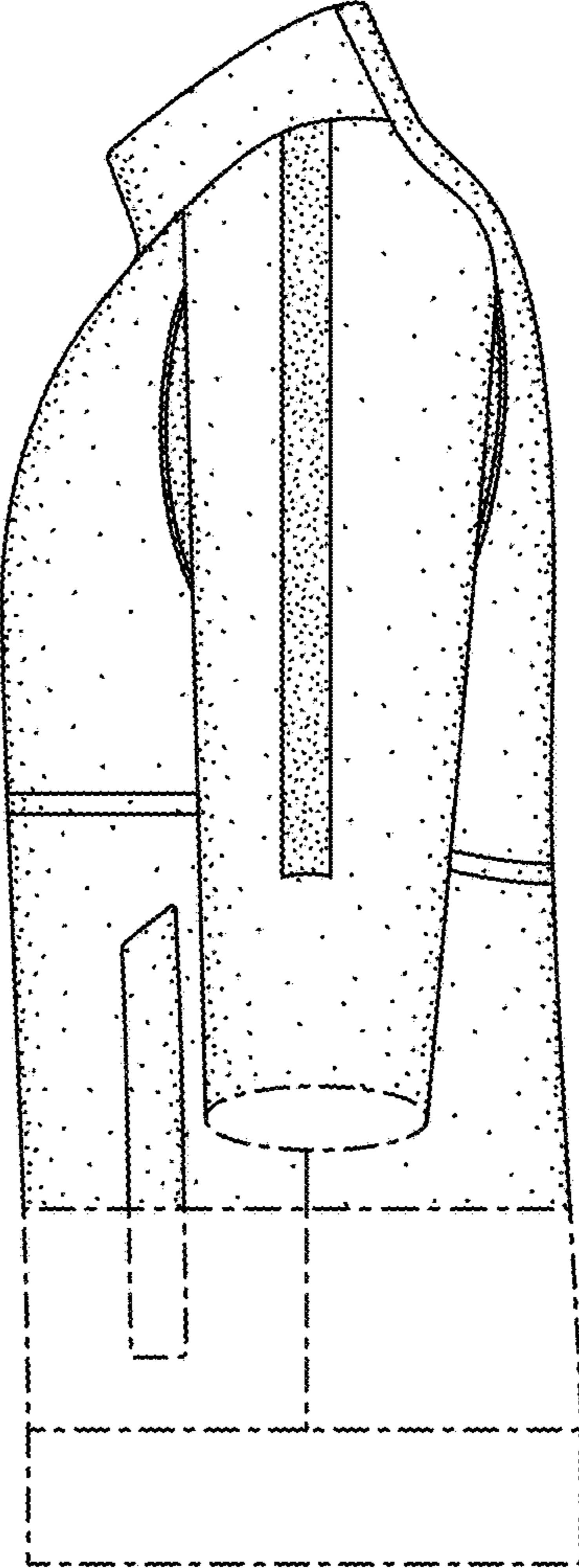

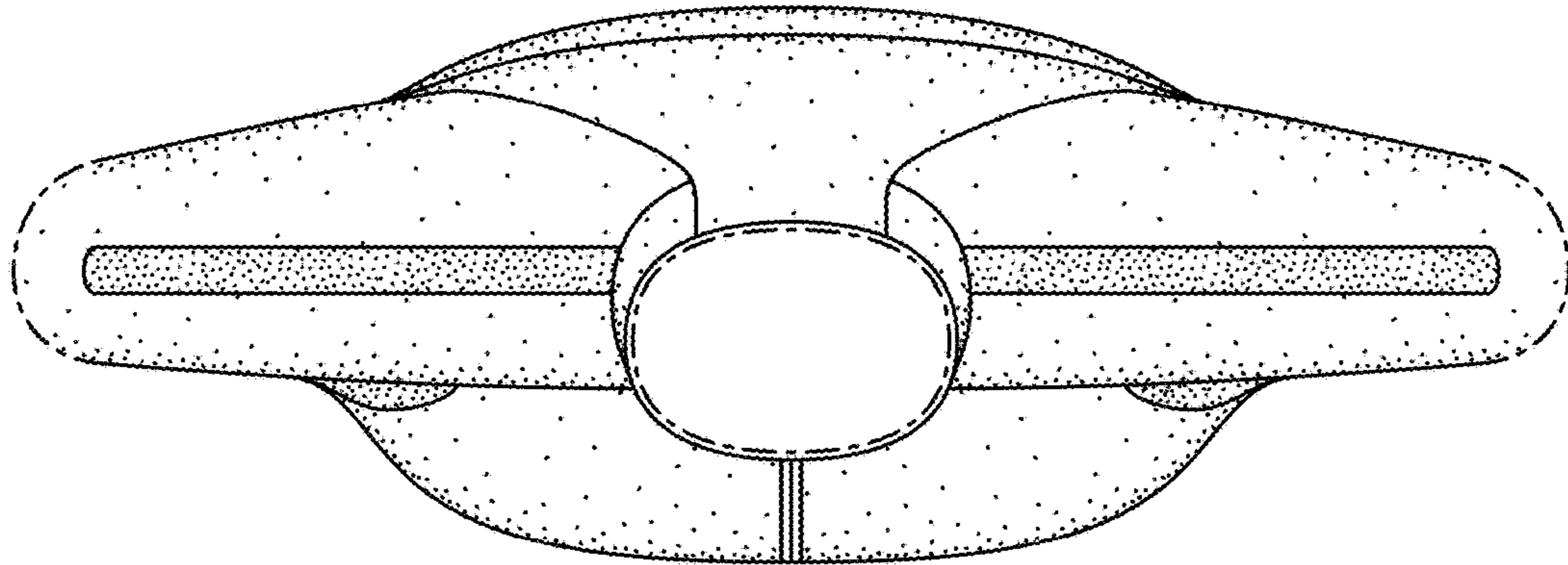

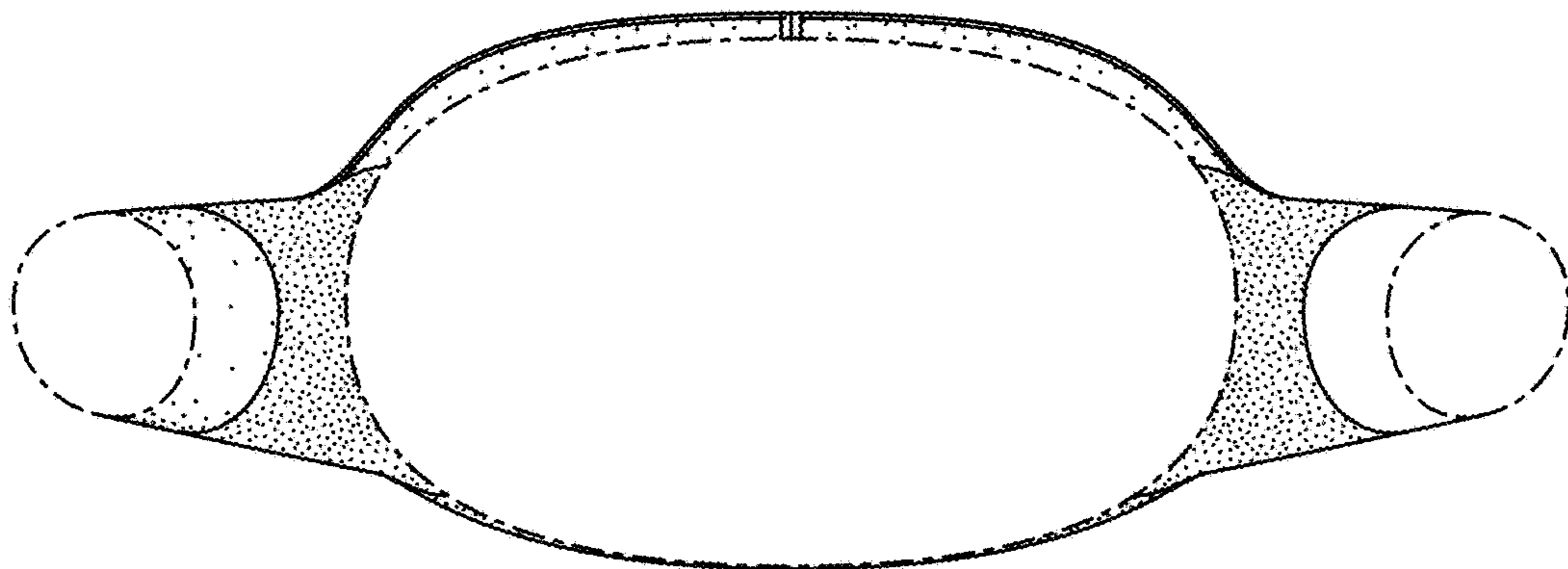

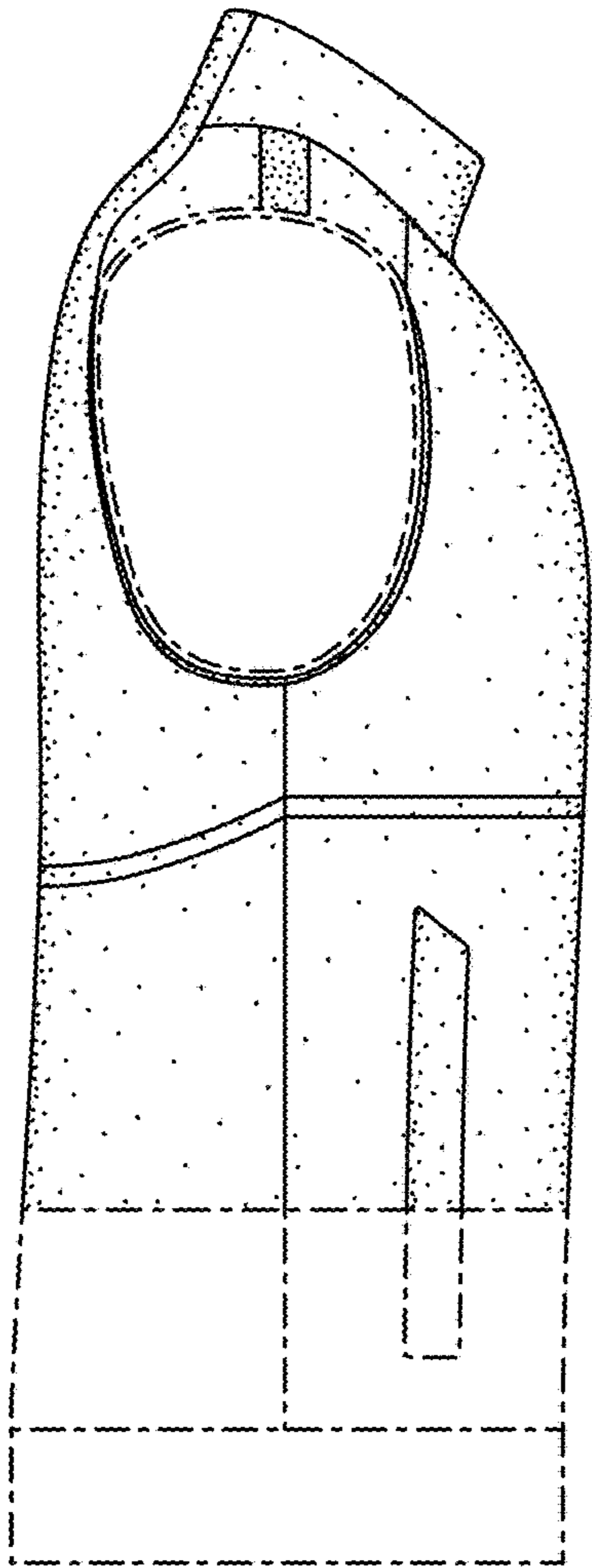

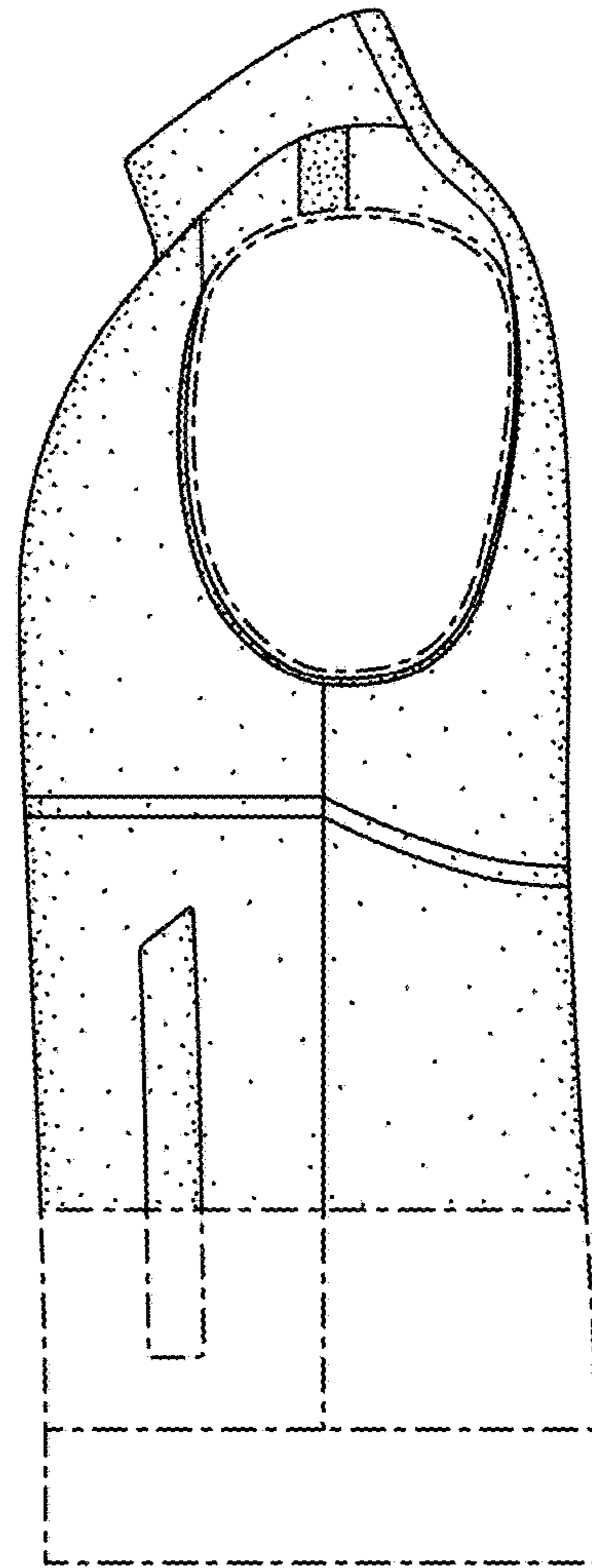
