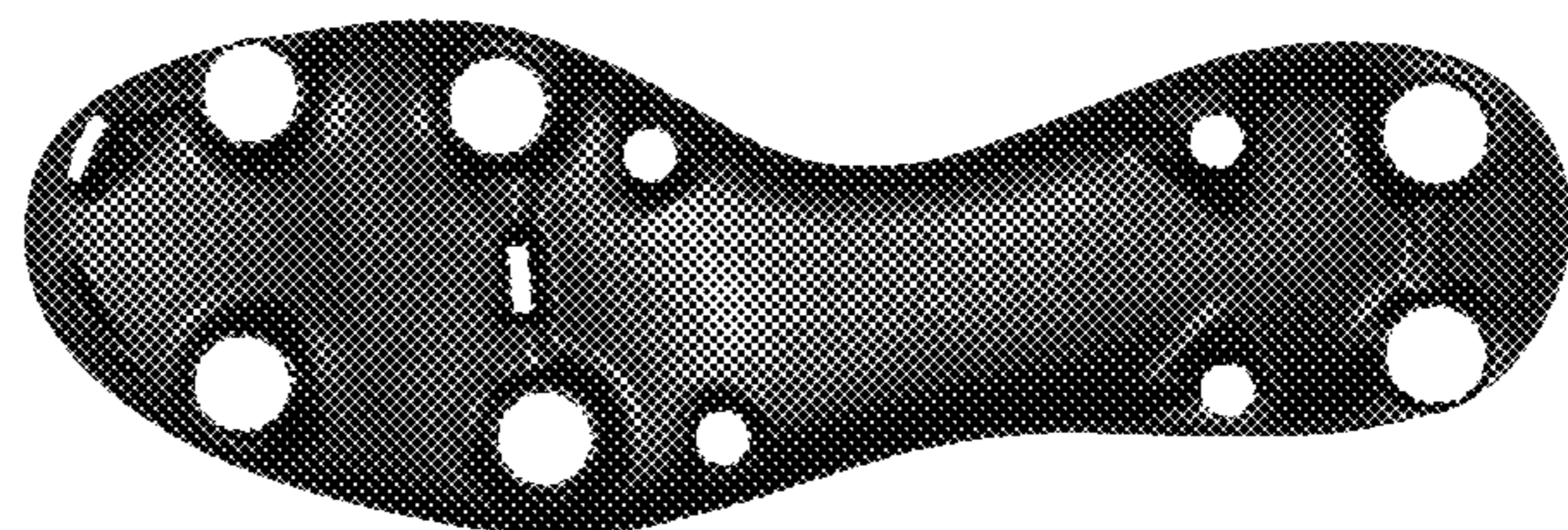
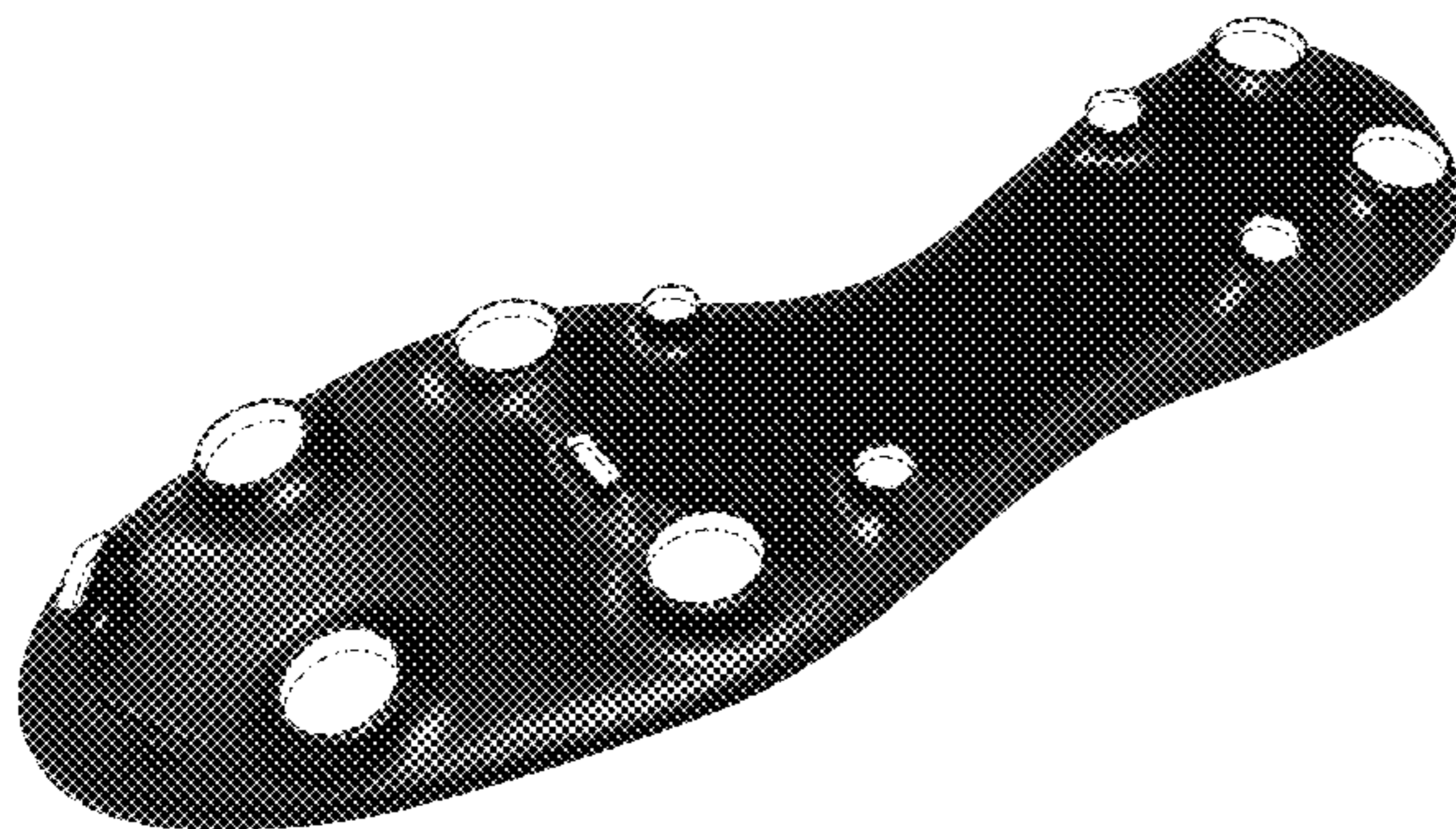
(57) **CLAIM**

The ornamental design for a shoe outsole, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe outsole showing our new design;
