(57) **CLAIM**

The ornamental design for a set of shoe panels, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevation view of a set of shoe panels showing my new design mounted on a shoe shown in broken lines;

FIG. 2 is another right side elevation view thereof, with the panels shown separate from the shoe;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a front elevation view thereof;

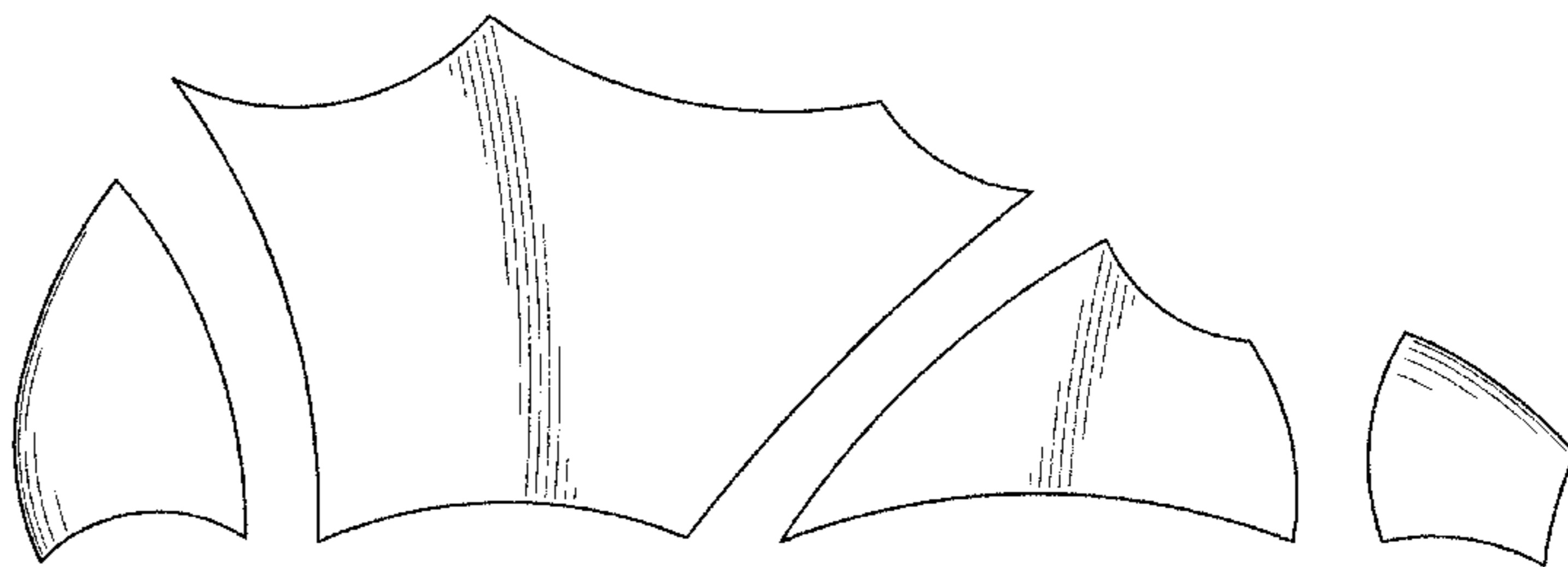
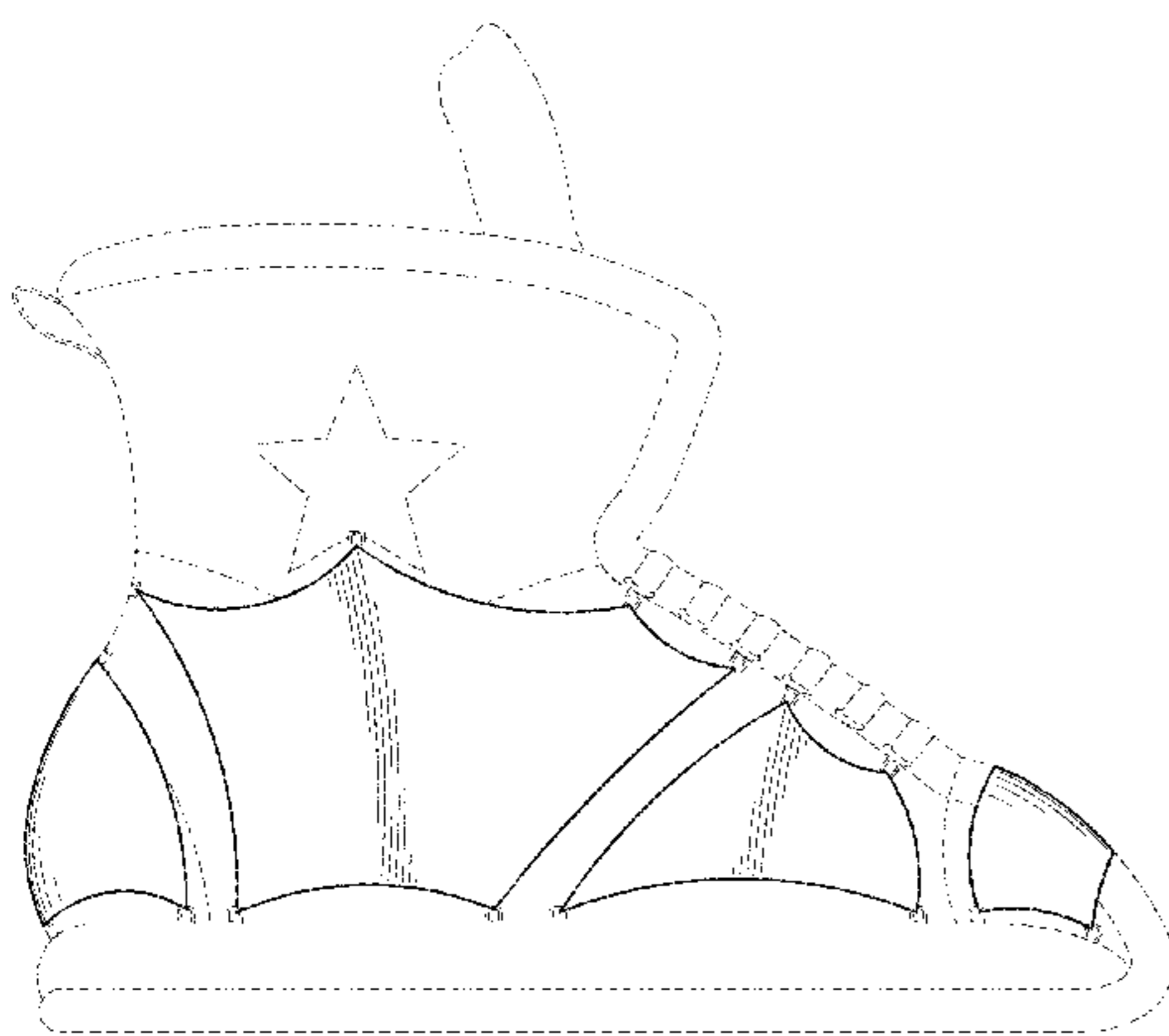
FIG. 5 is a top plan view thereof; and,

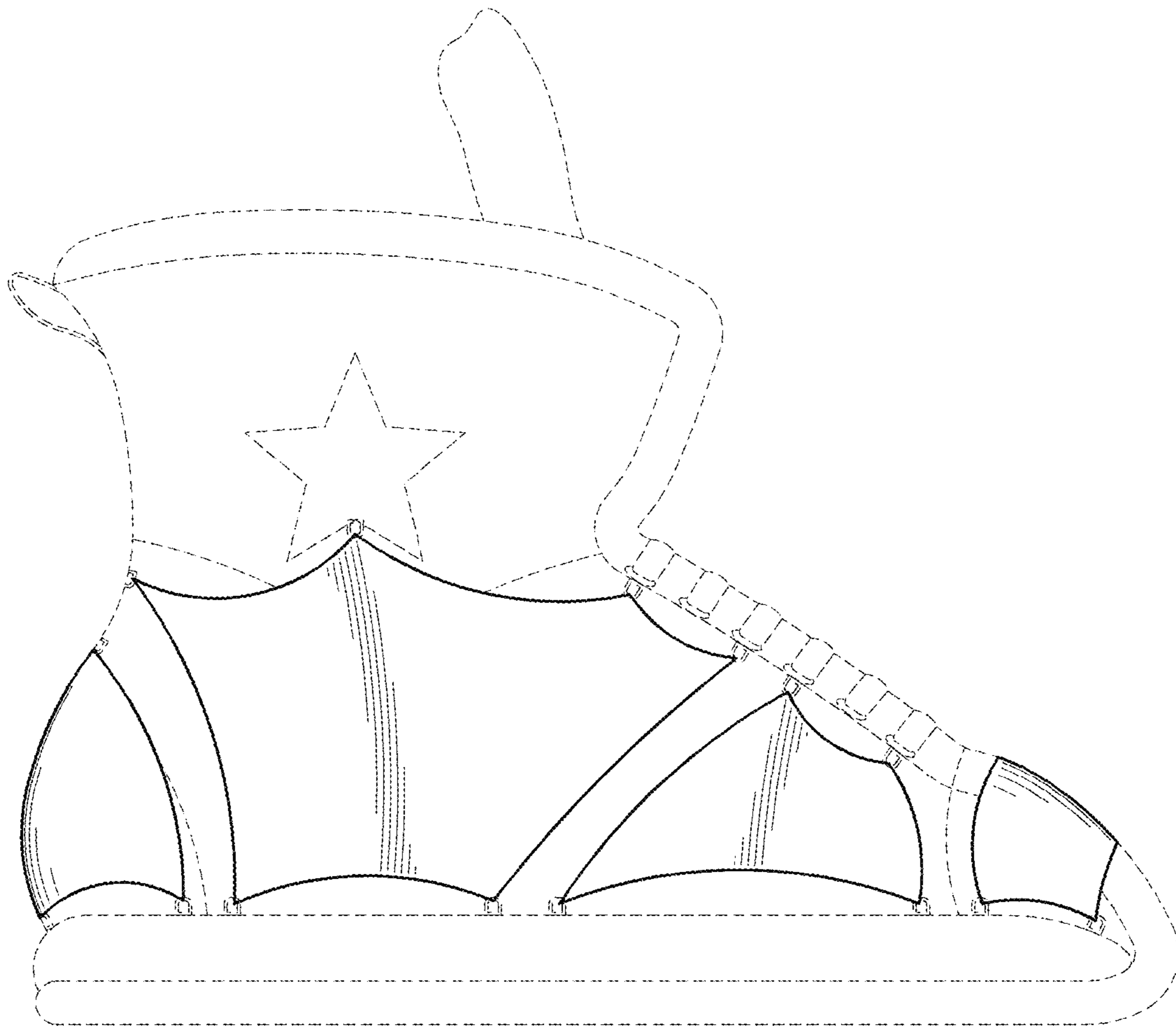

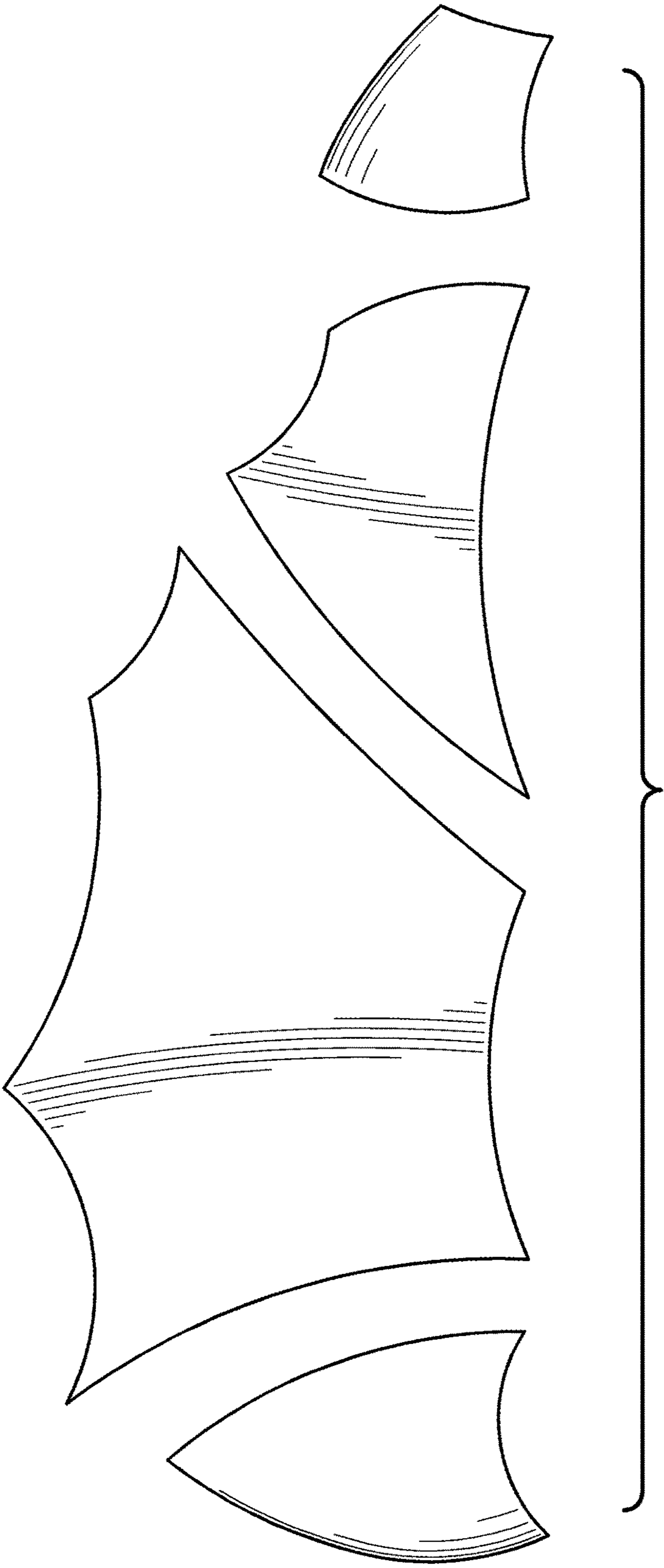

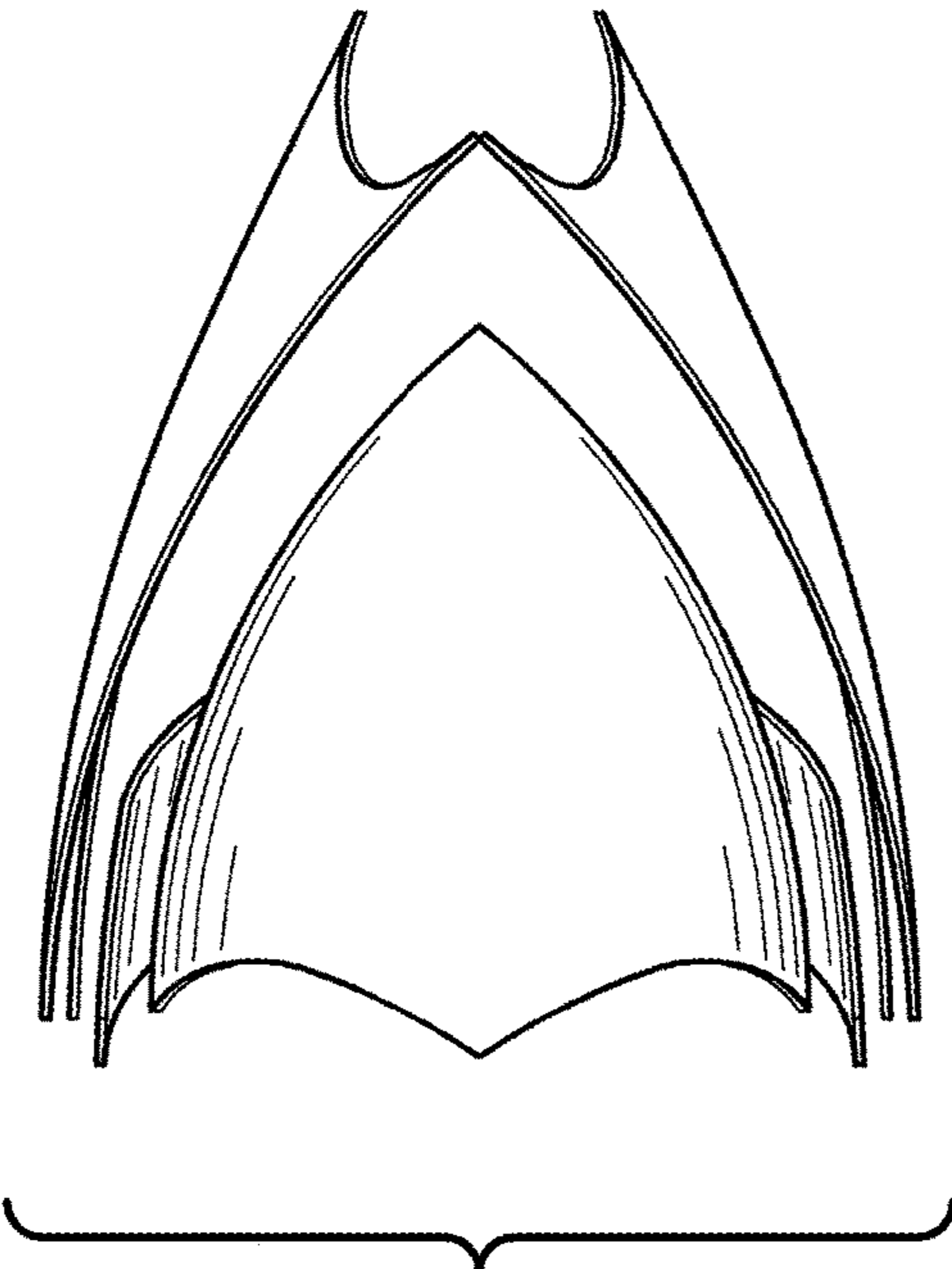

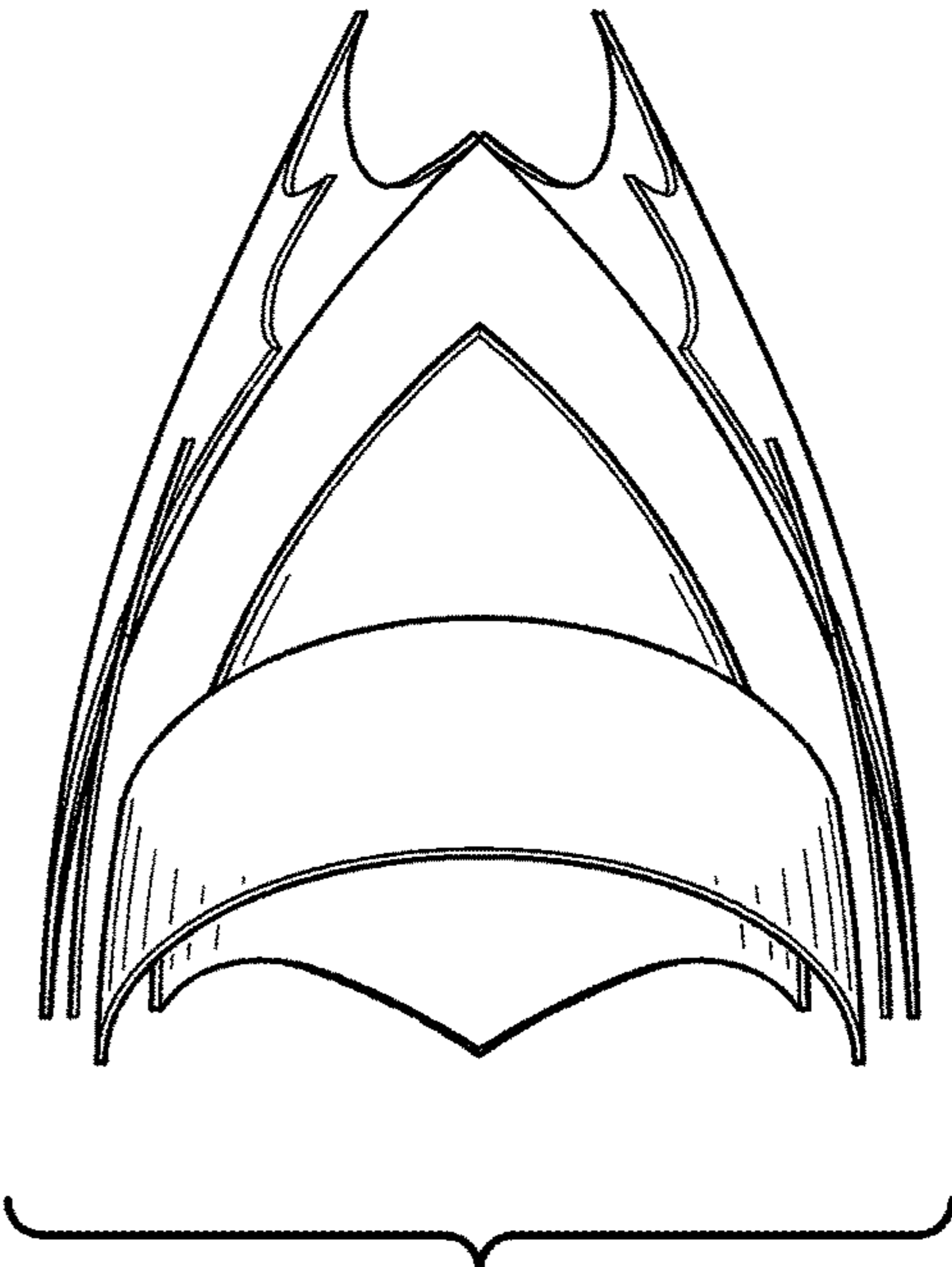

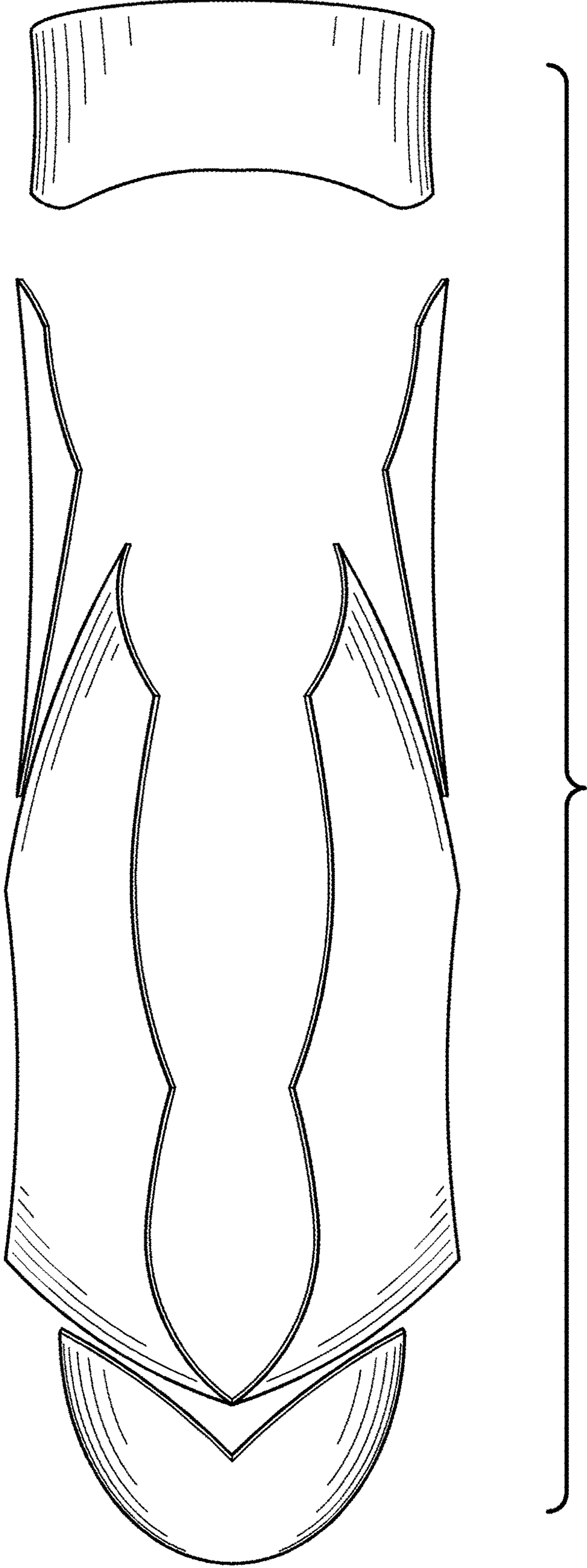

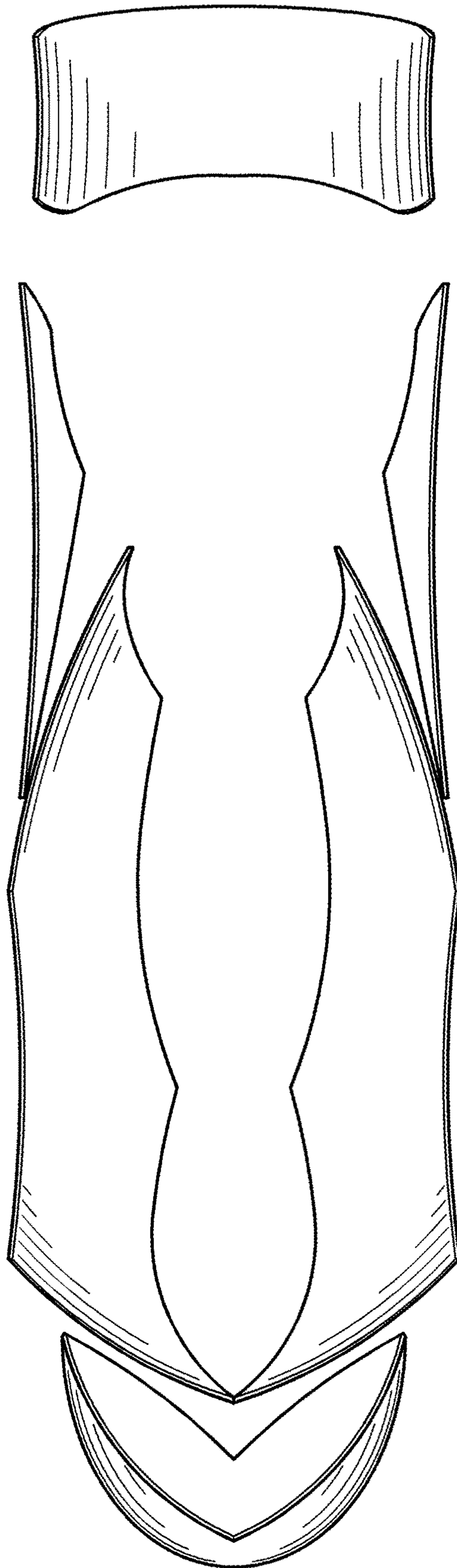
