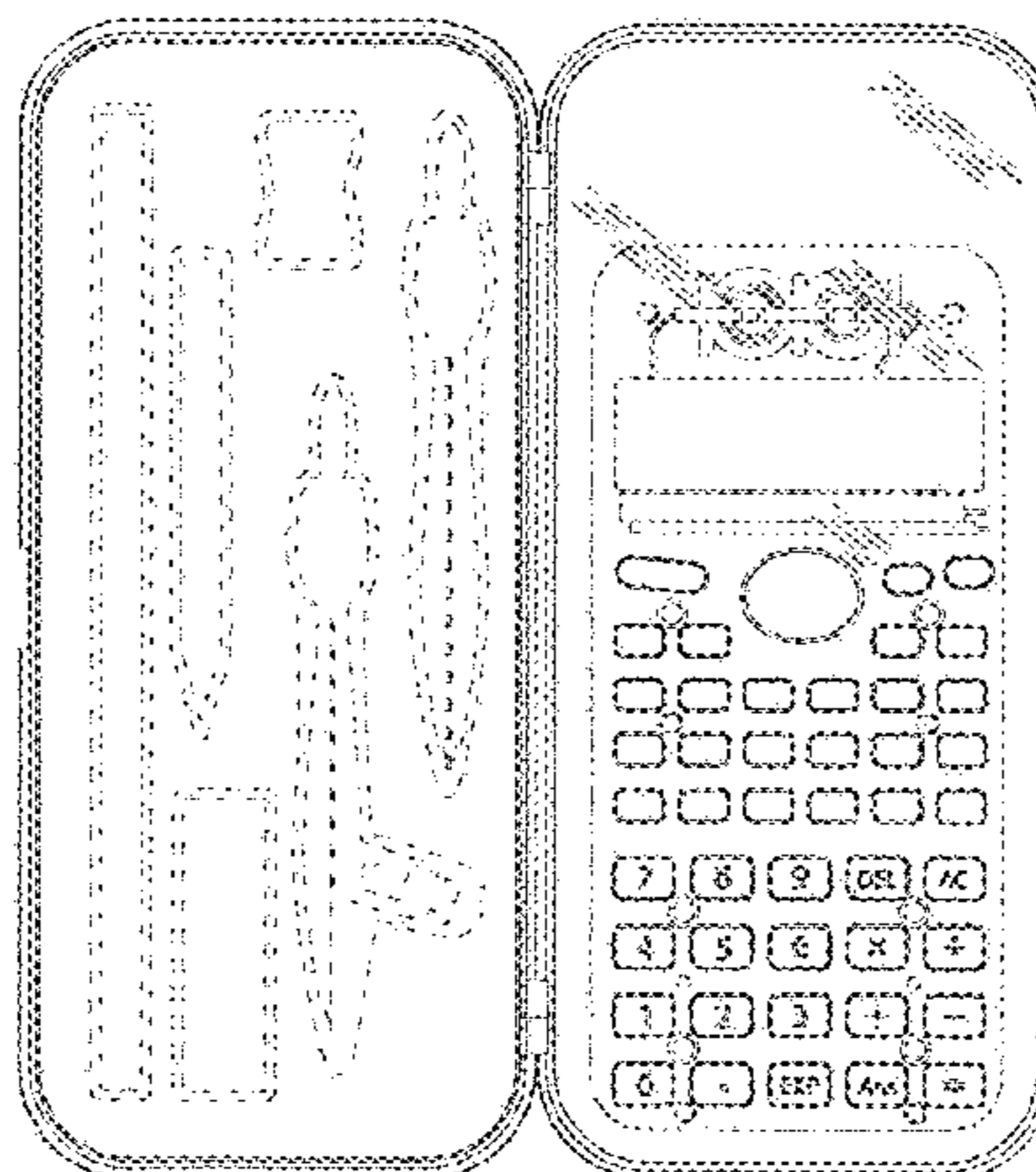


FIG. 15 is a front elevational view of an instrument case in accordance with a third embodiment of the present invention;

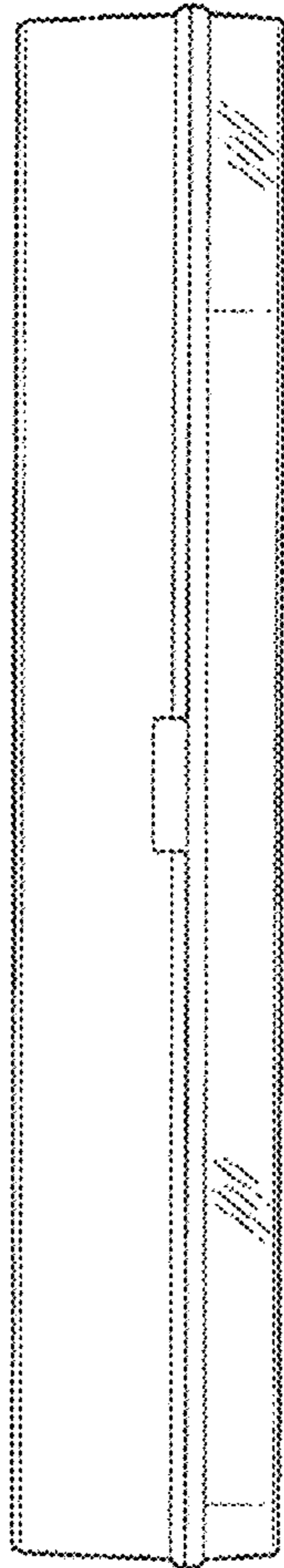

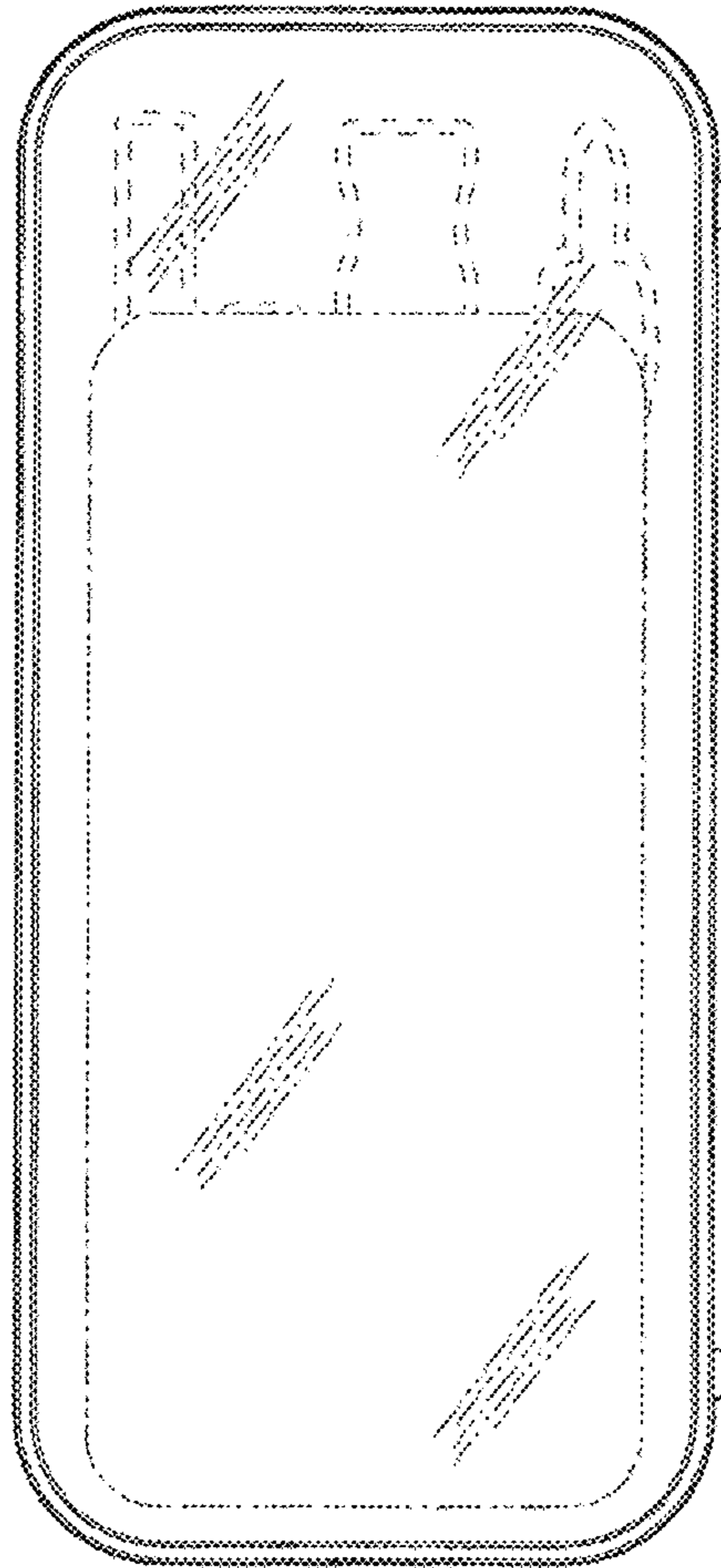

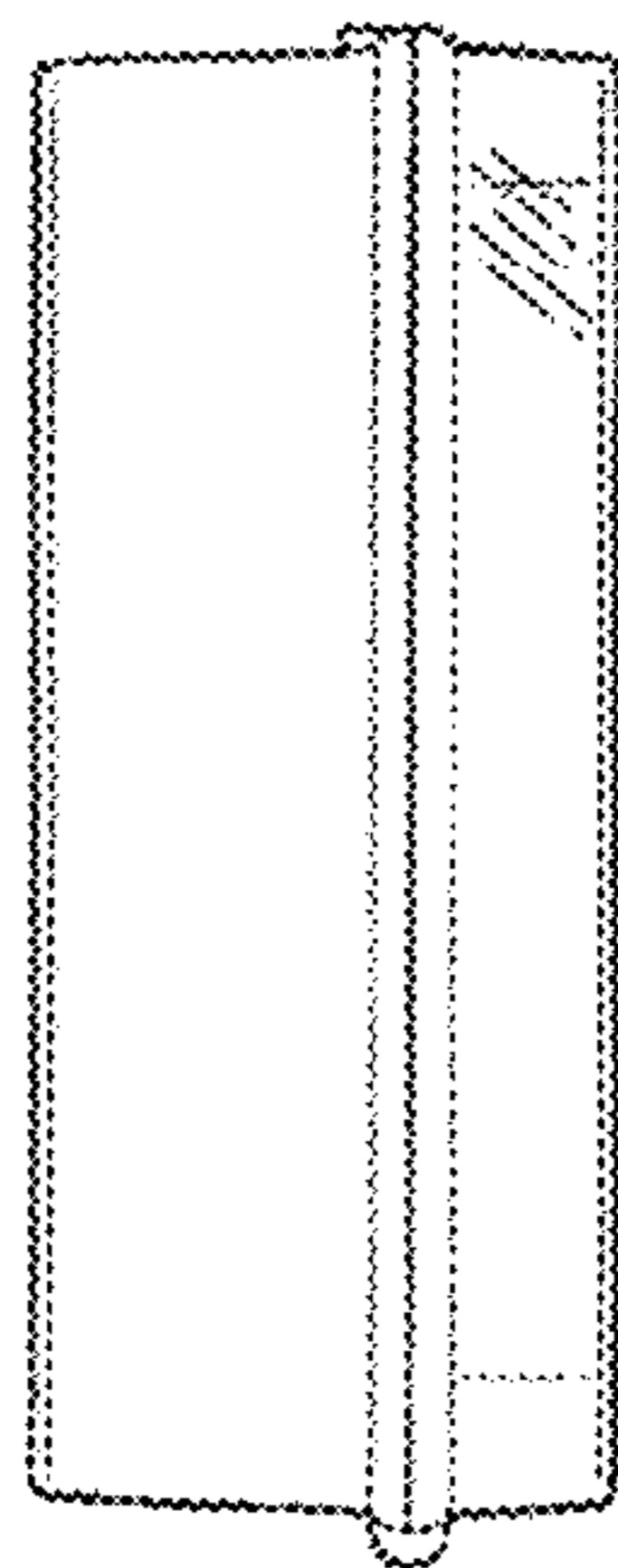

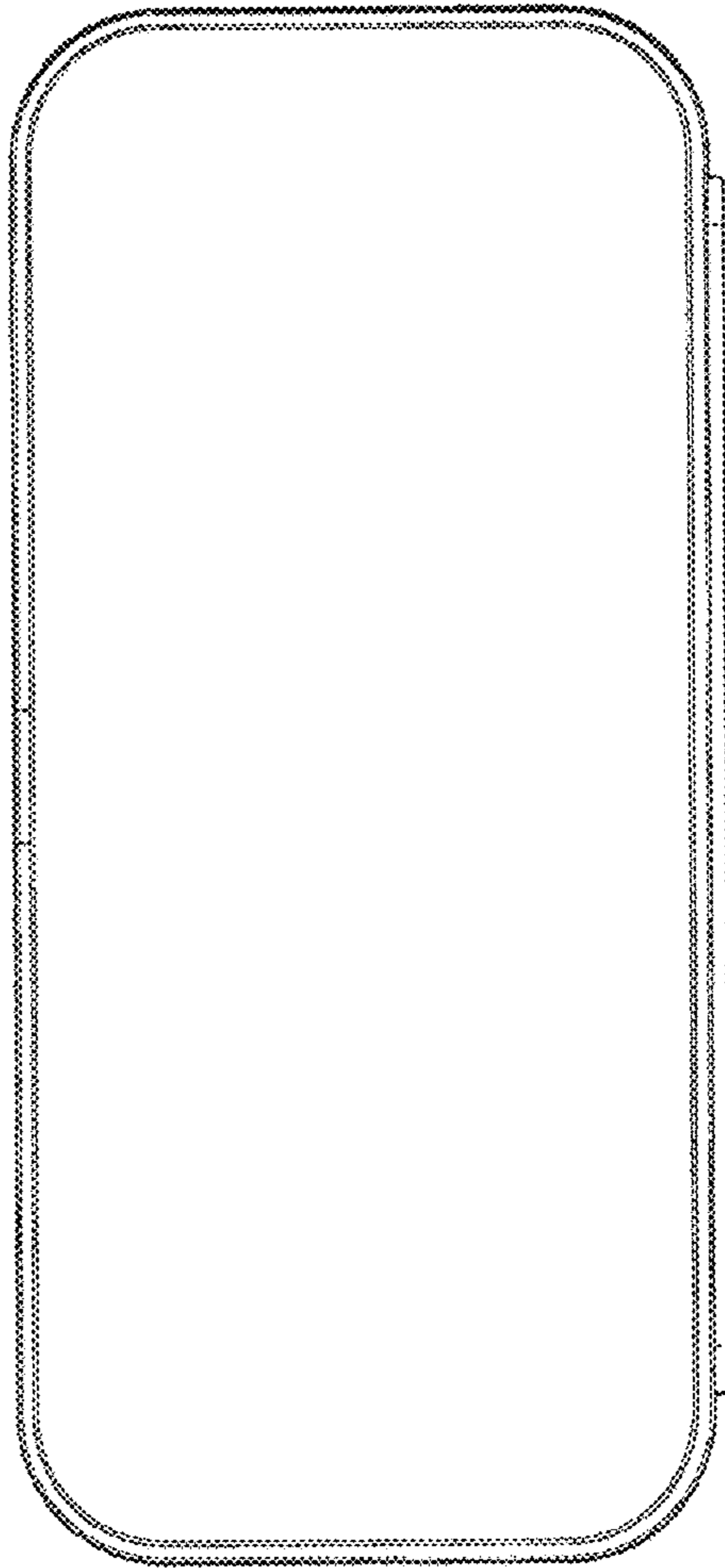

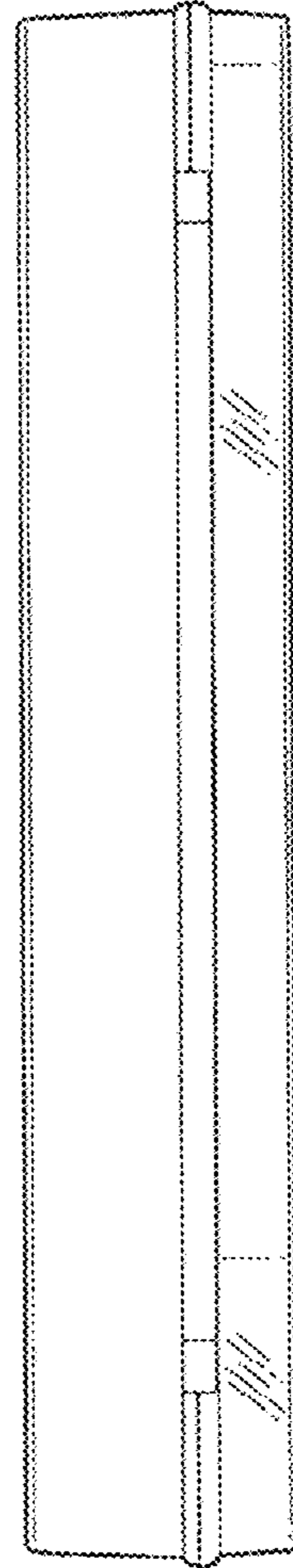
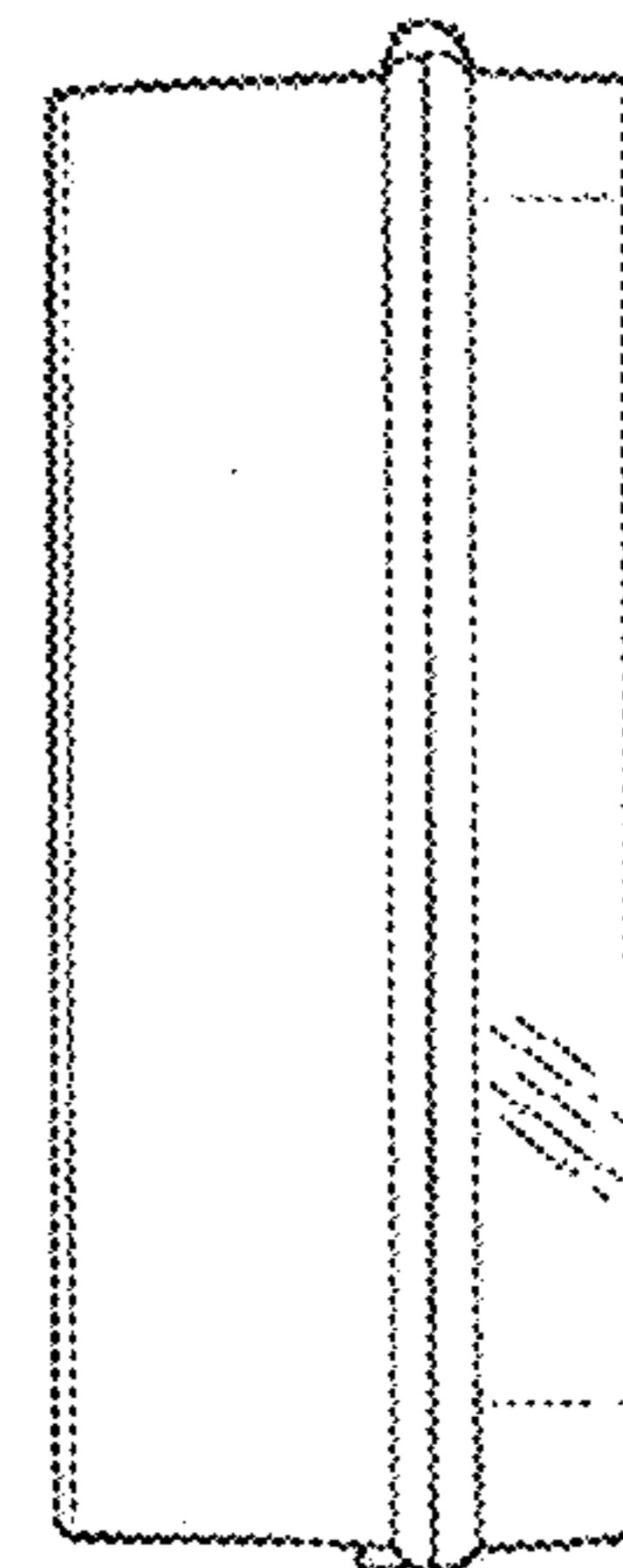

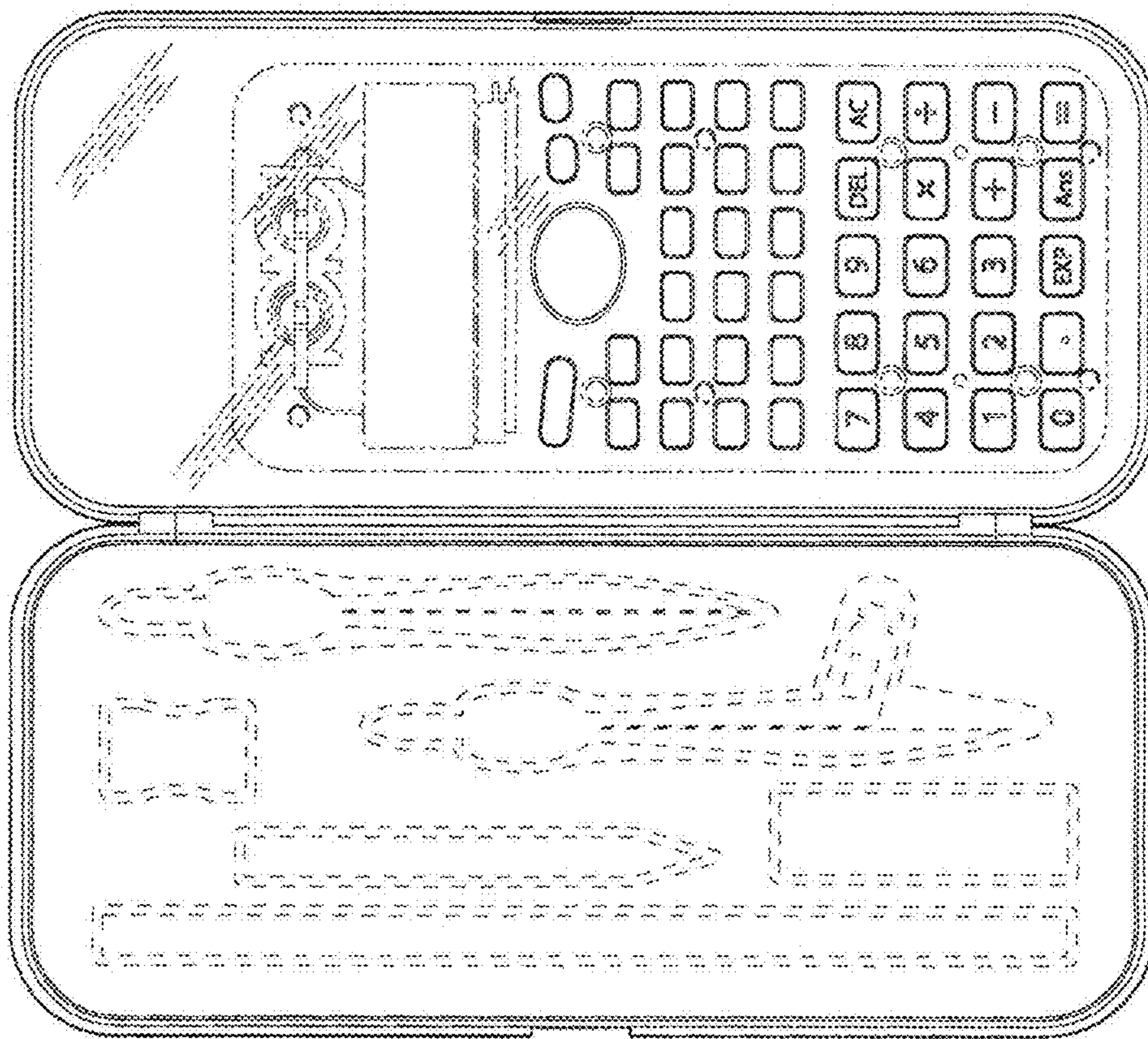

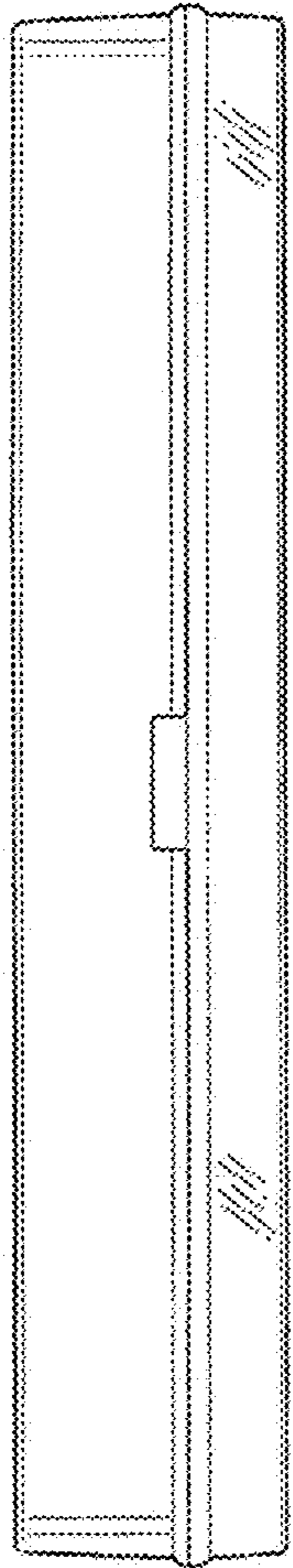

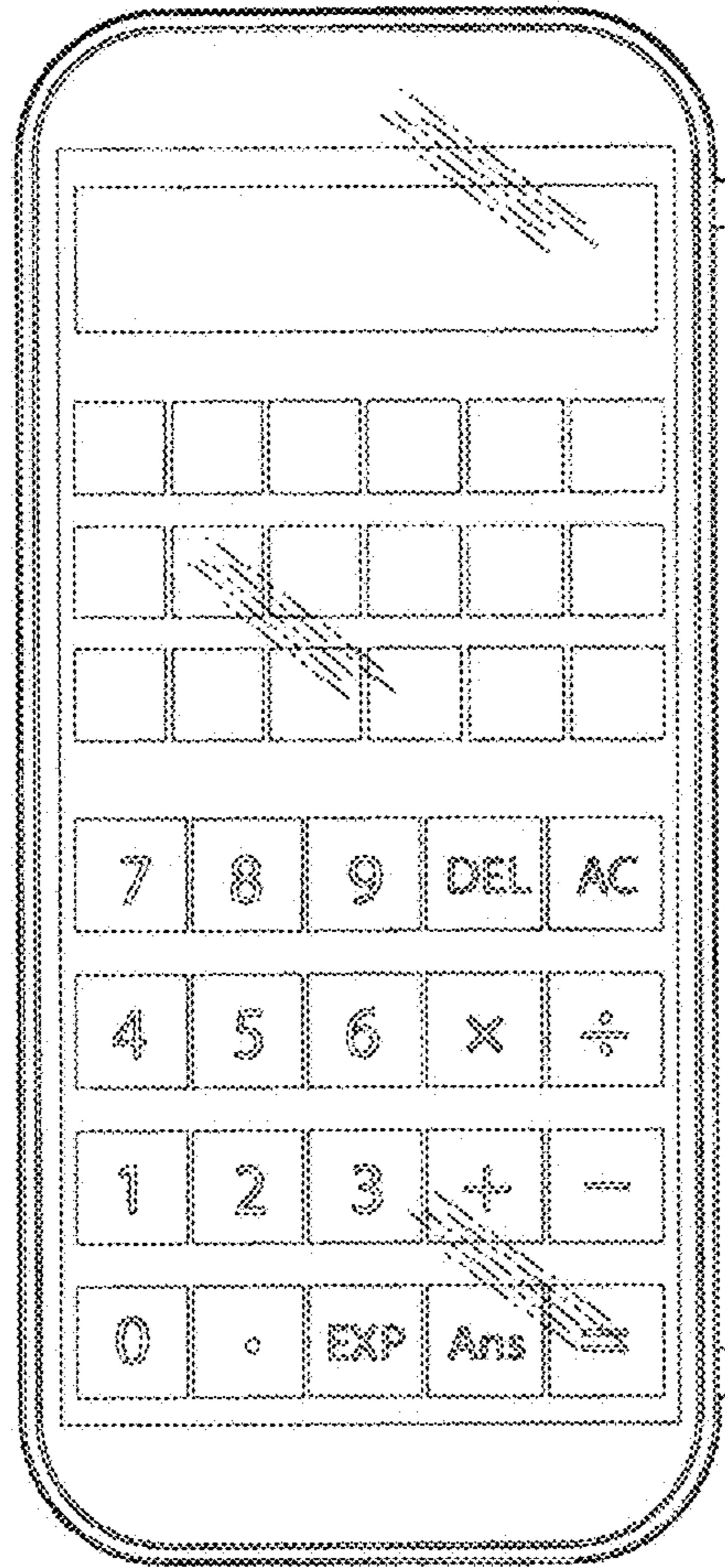

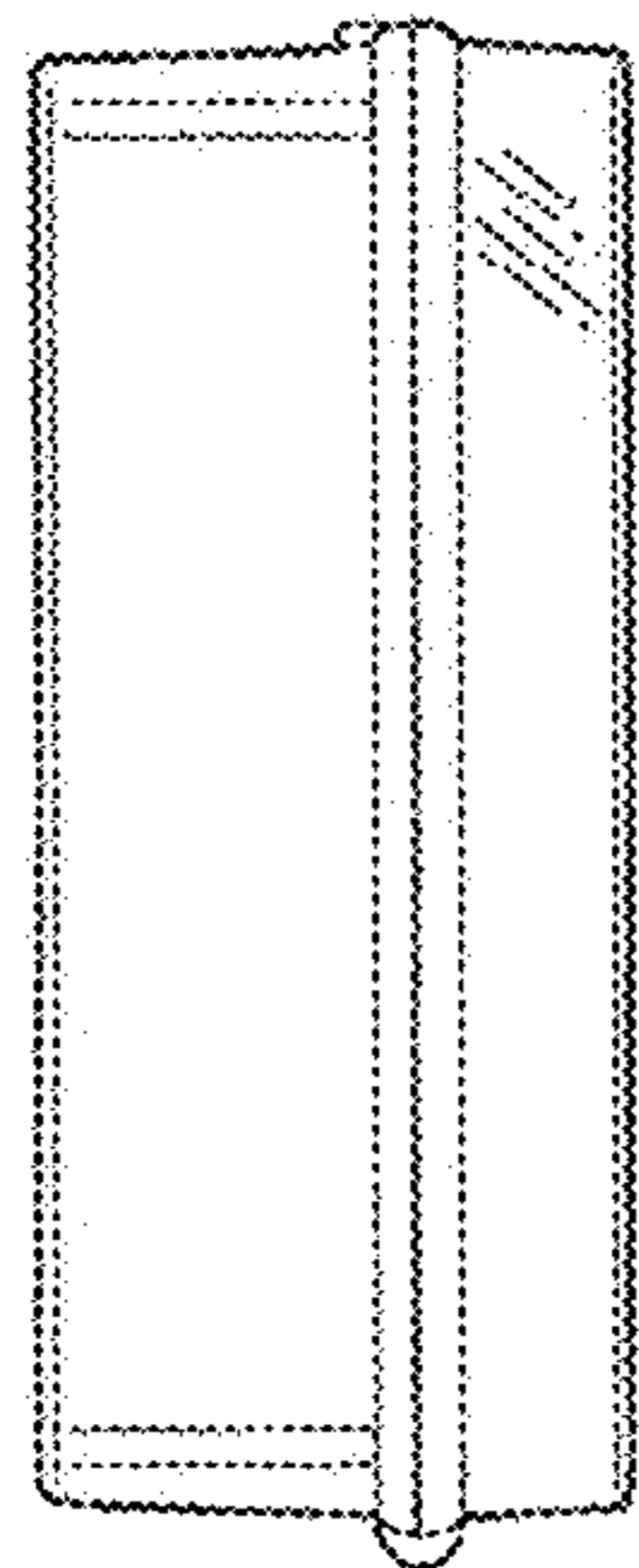

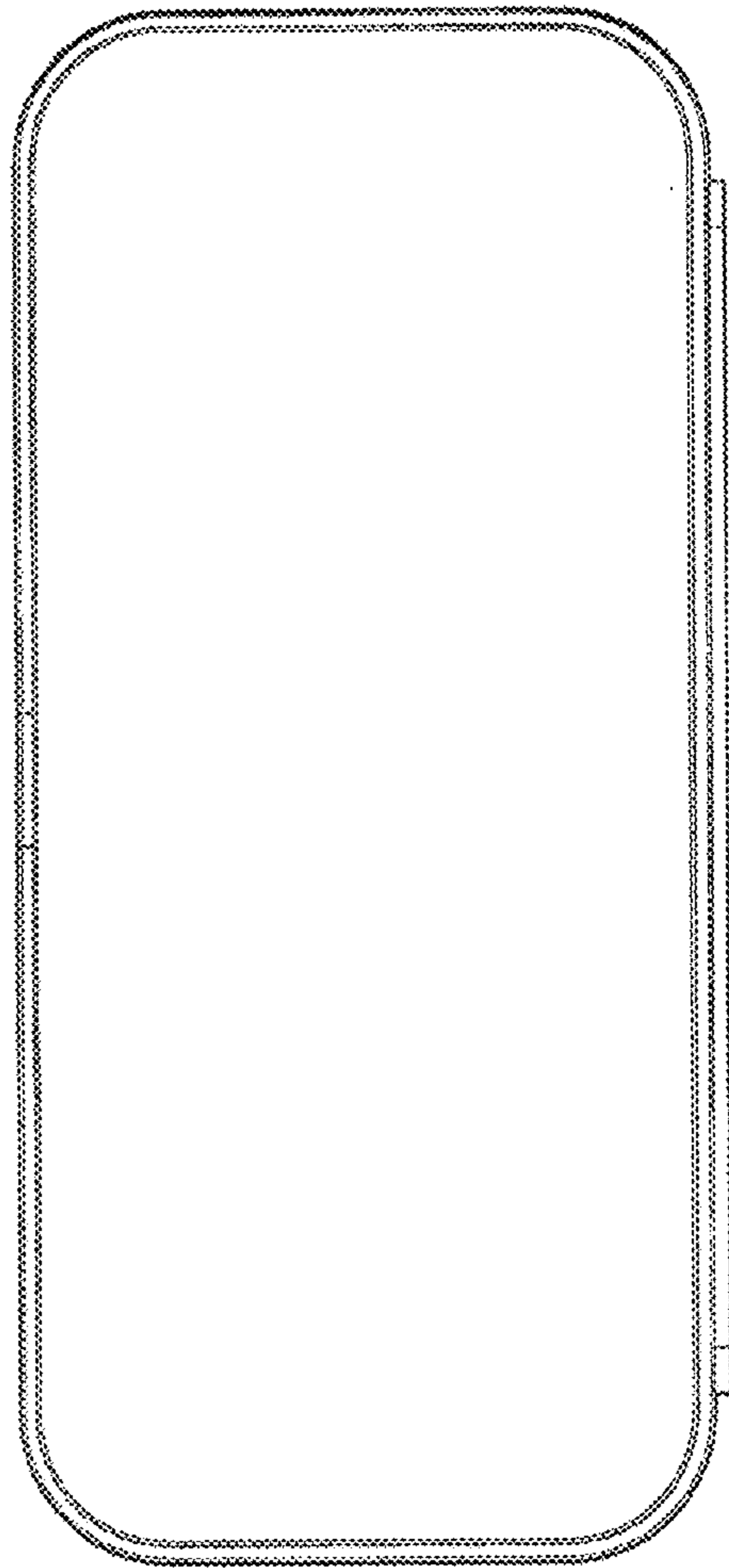

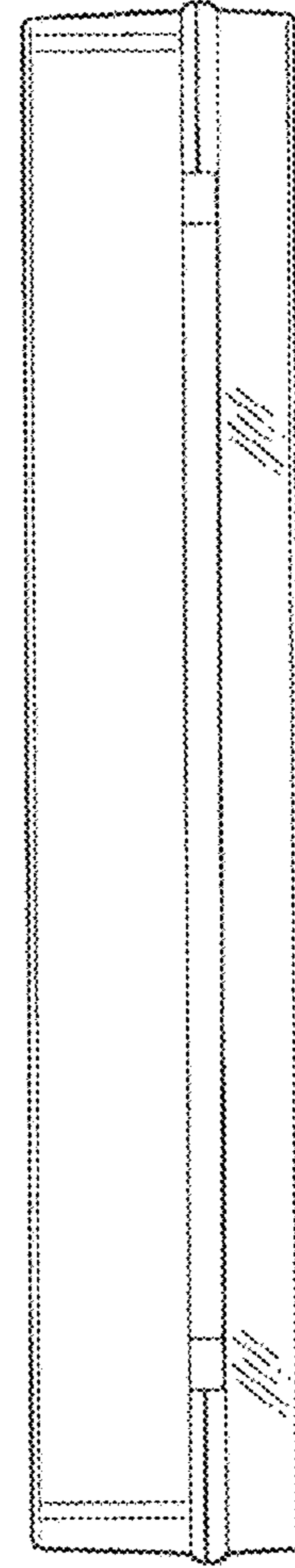
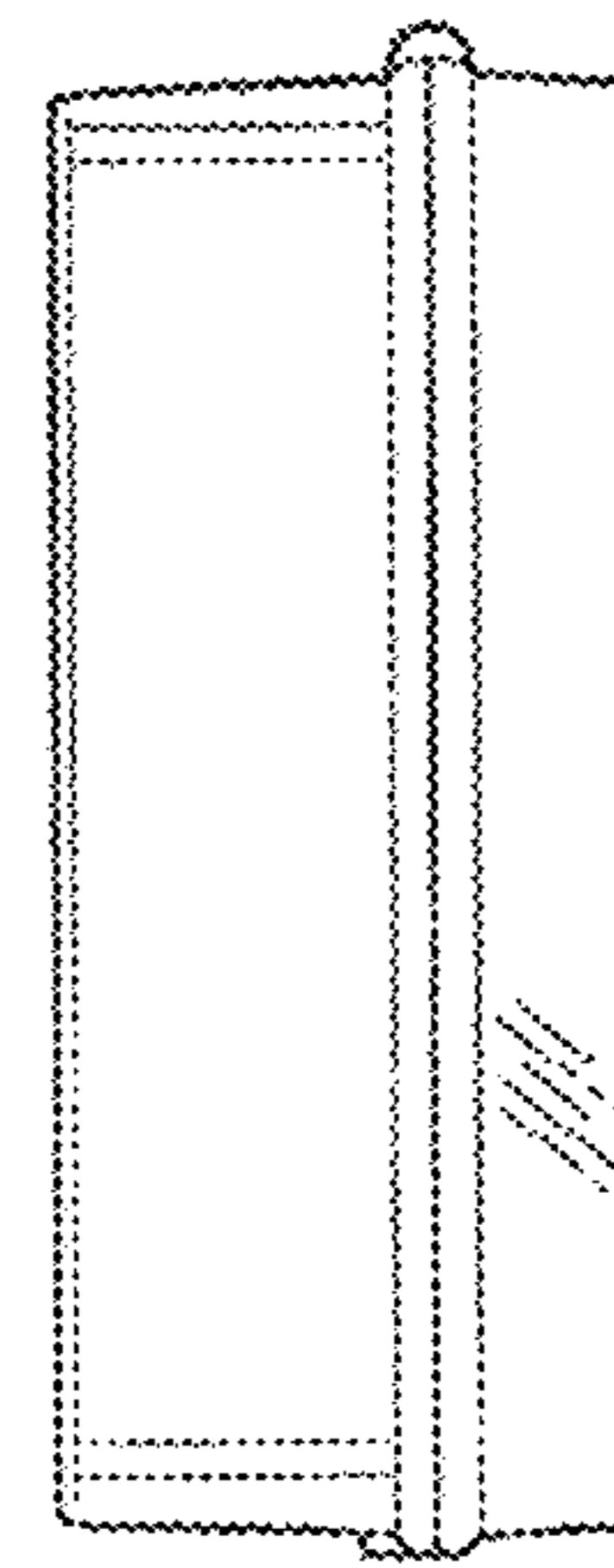

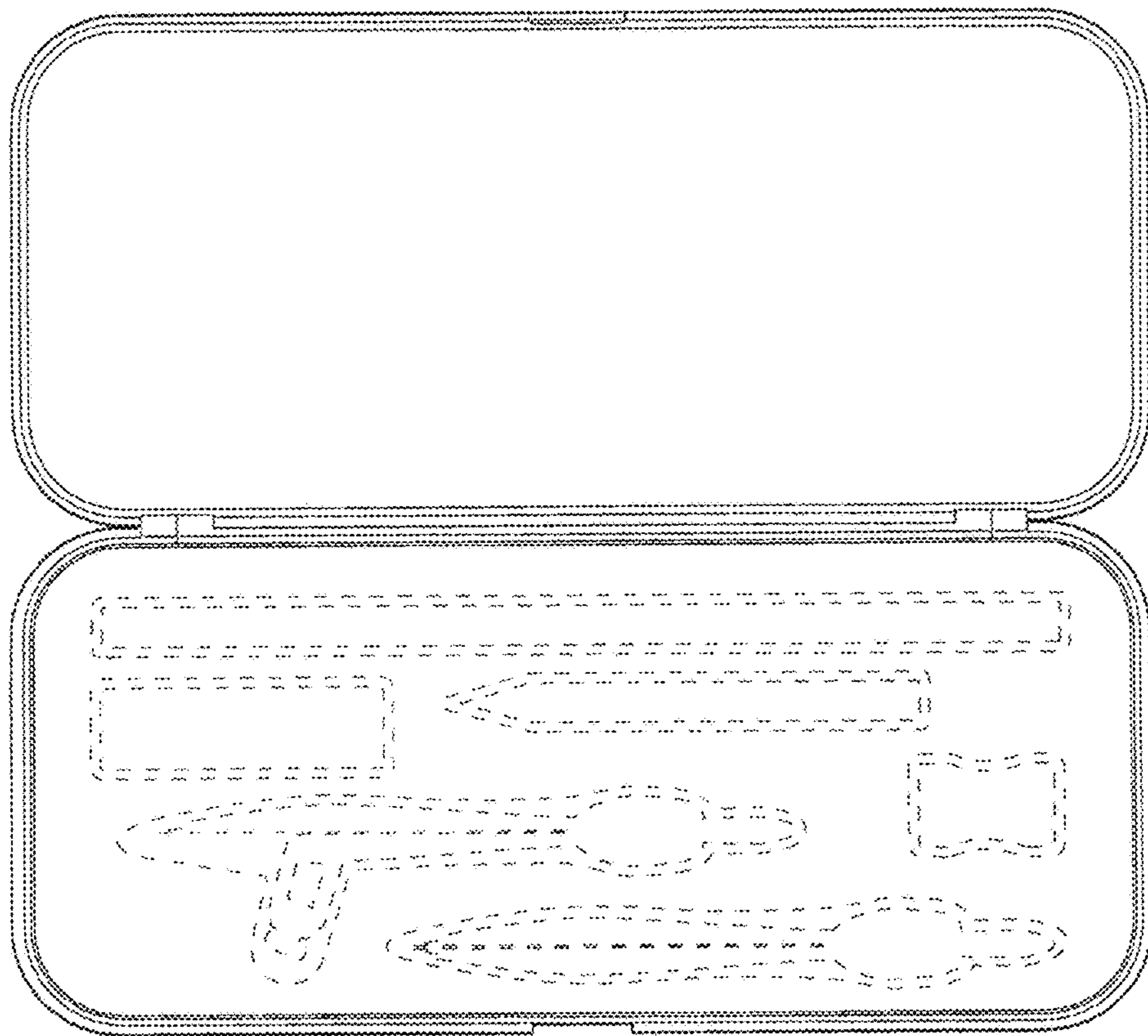

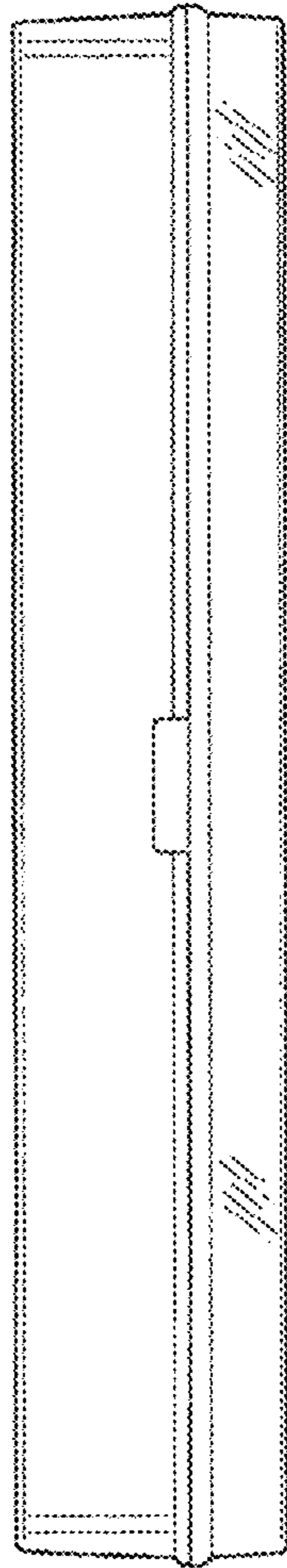

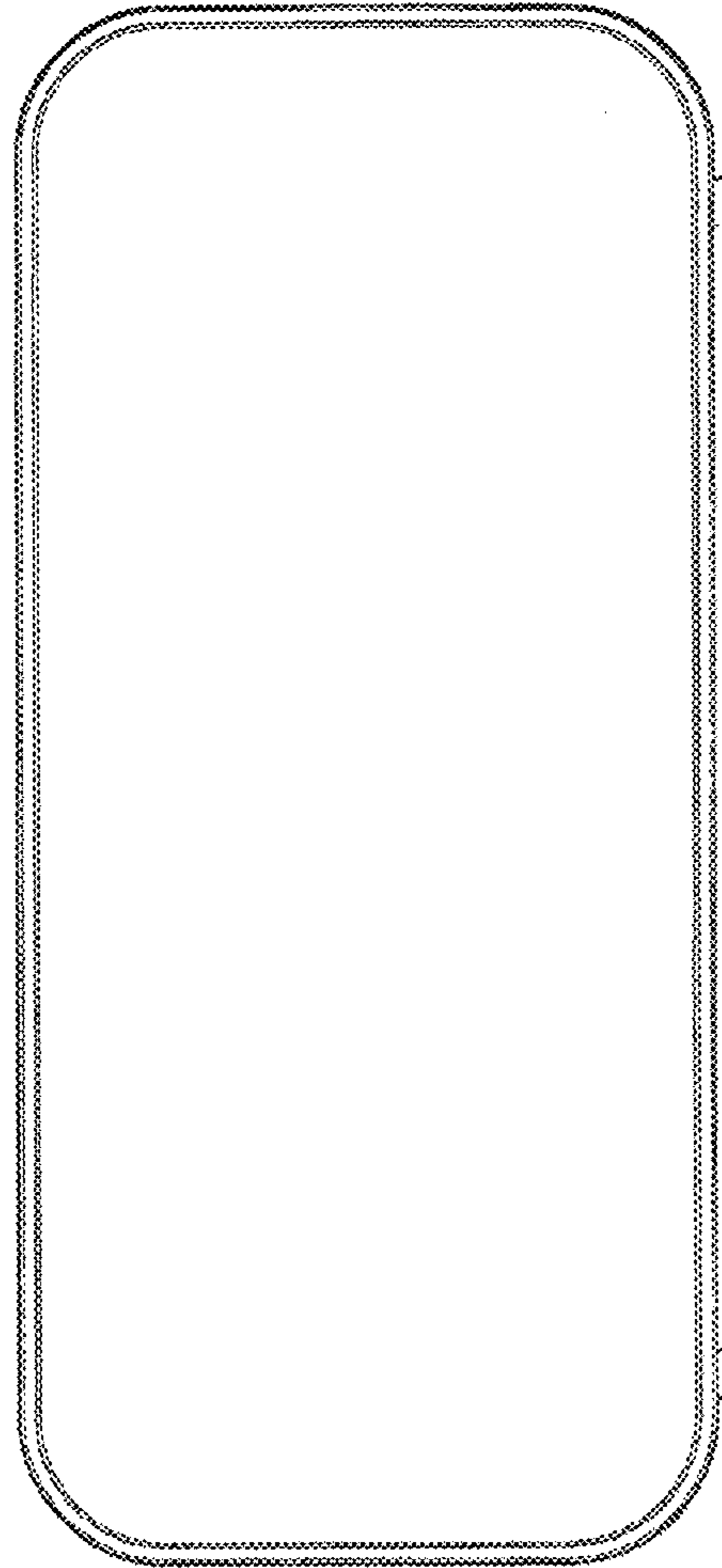

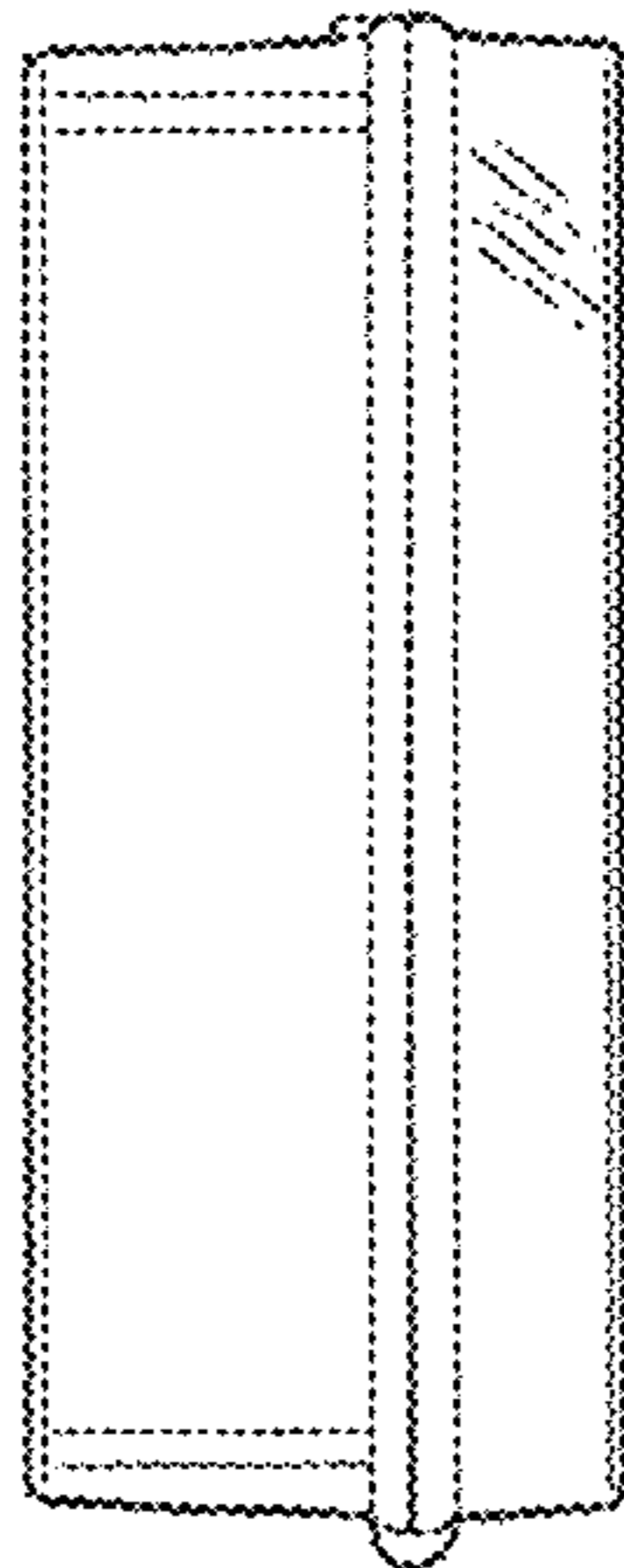

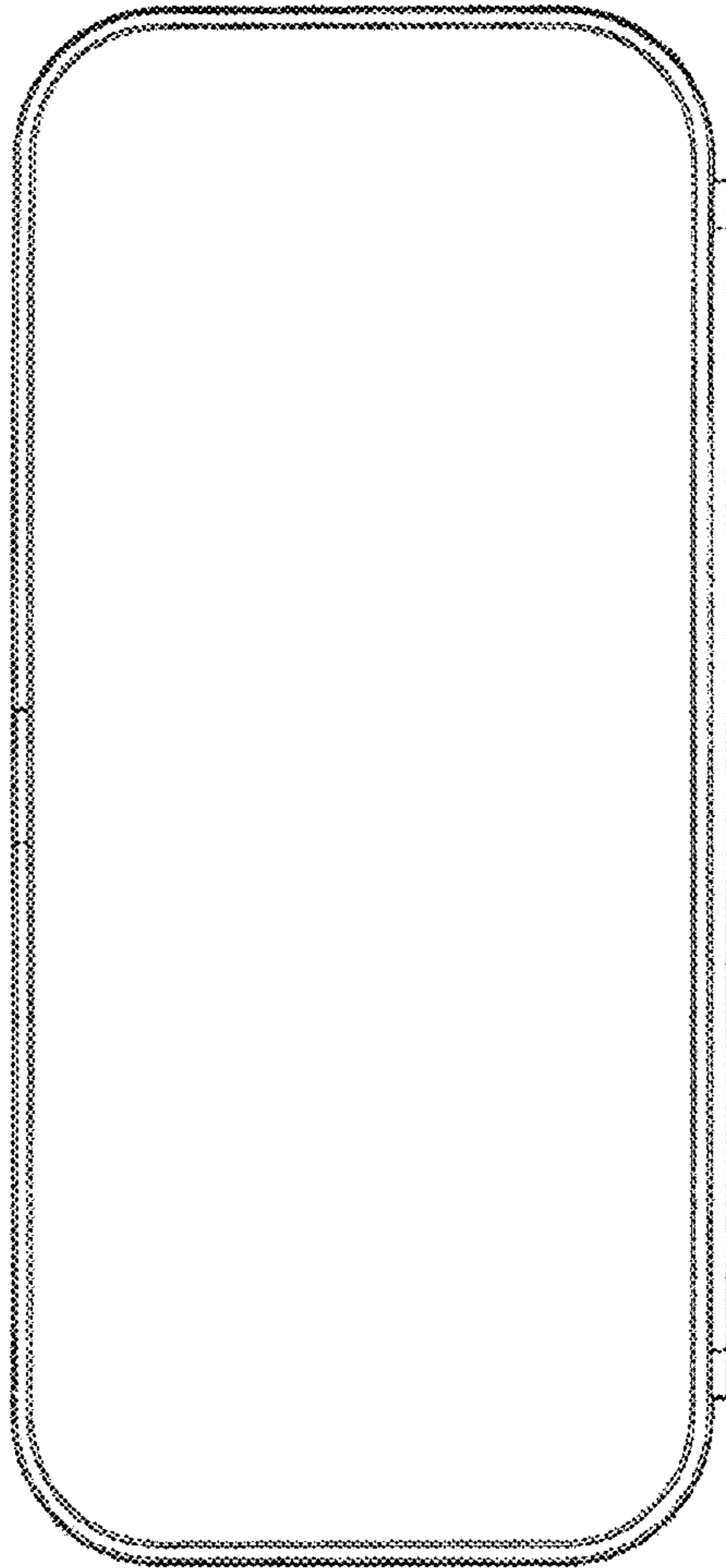

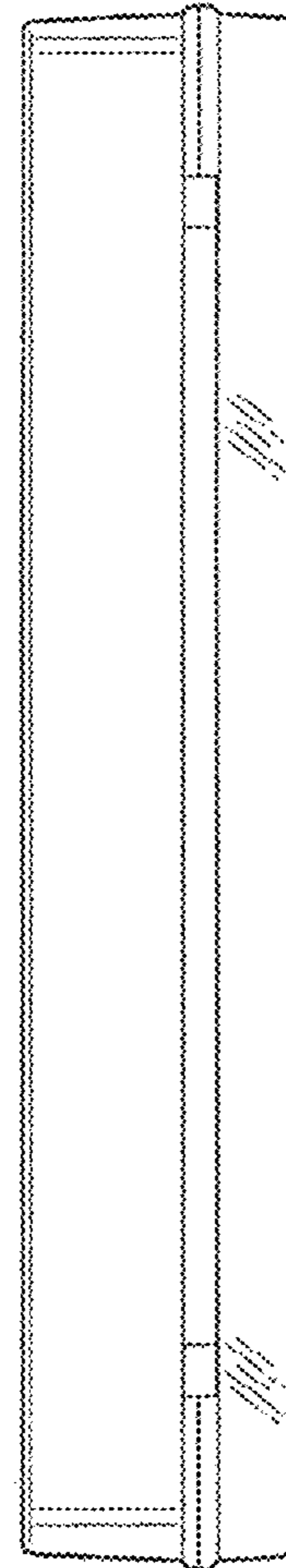
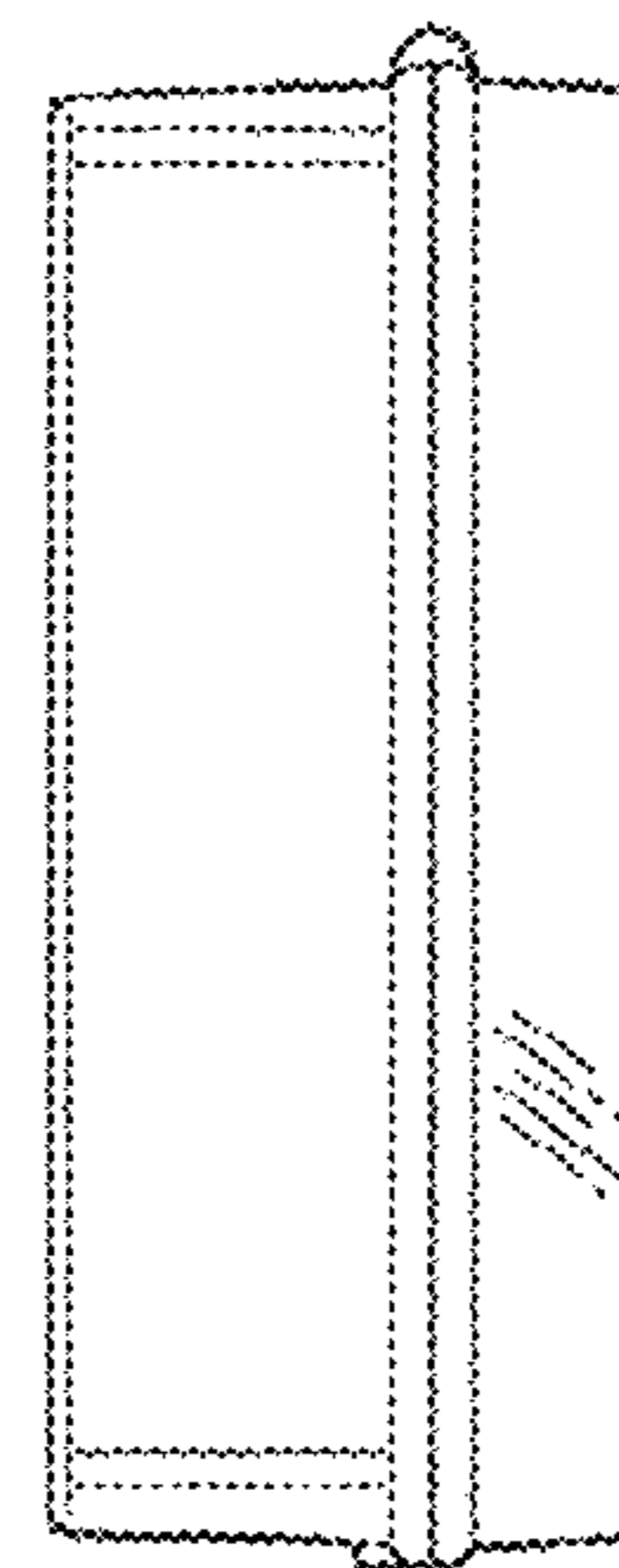

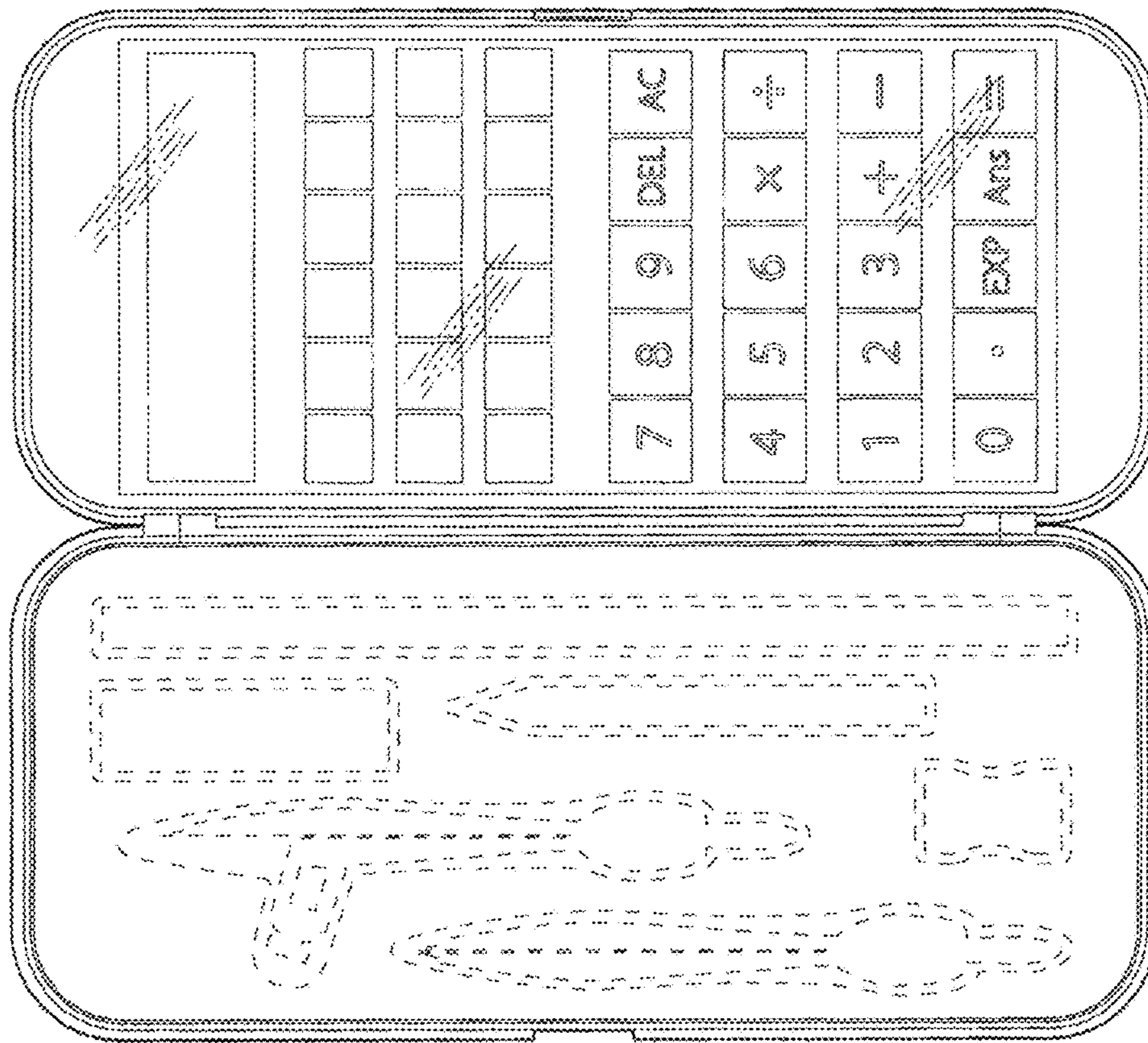
