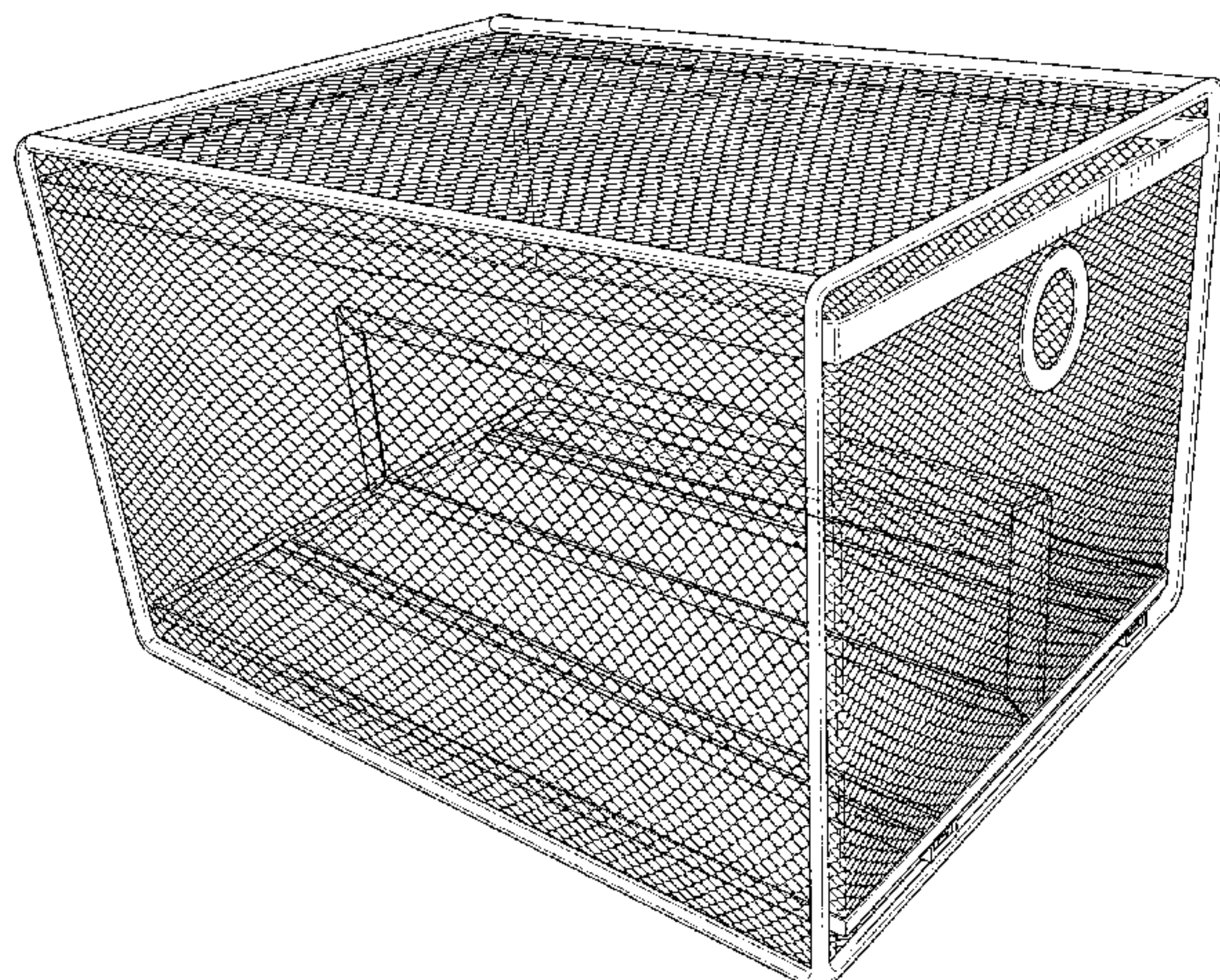

(57) **CLAIM**

The ornamental design for a stackable mesh drawer assembly, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a stackable mesh drawer assembly in accordance with my design.

FIG. 2 is a front elevational view of the drawer assembly shown in FIG. 1;

FIG. 3 is rear elevational view of the drawer assembly shown in FIG. 1;

FIG. 4 is a side elevational view thereof as viewed from the left side of FIG. 1;

FIG. 5 is a side elevational view thereof as viewed from the right side of FIG. 1;

FIG. 6 is a top plan view of the drawer assembly shown in FIG. 1;

FIG. 7 is a bottom plan view of the drawer assembly shown in FIG. 1;

FIG. 8 is a perspective view of a stackable mesh drawer assembly in accordance with an alternate embodiment of my design, with the drawer of FIG. 8 being shorter than the drawer of FIGS. 1-7;

FIG. 9 is a front elevational view of the drawer assembly shown in FIG. 8;

FIG. 10 is rear elevational view of the drawer assembly shown in FIG. 8;

FIG. 11 is a side elevational view thereof as viewed from the left side of FIG. 8;

FIG. 12 is a side elevational view thereof as viewed from the right side of FIG. 8;

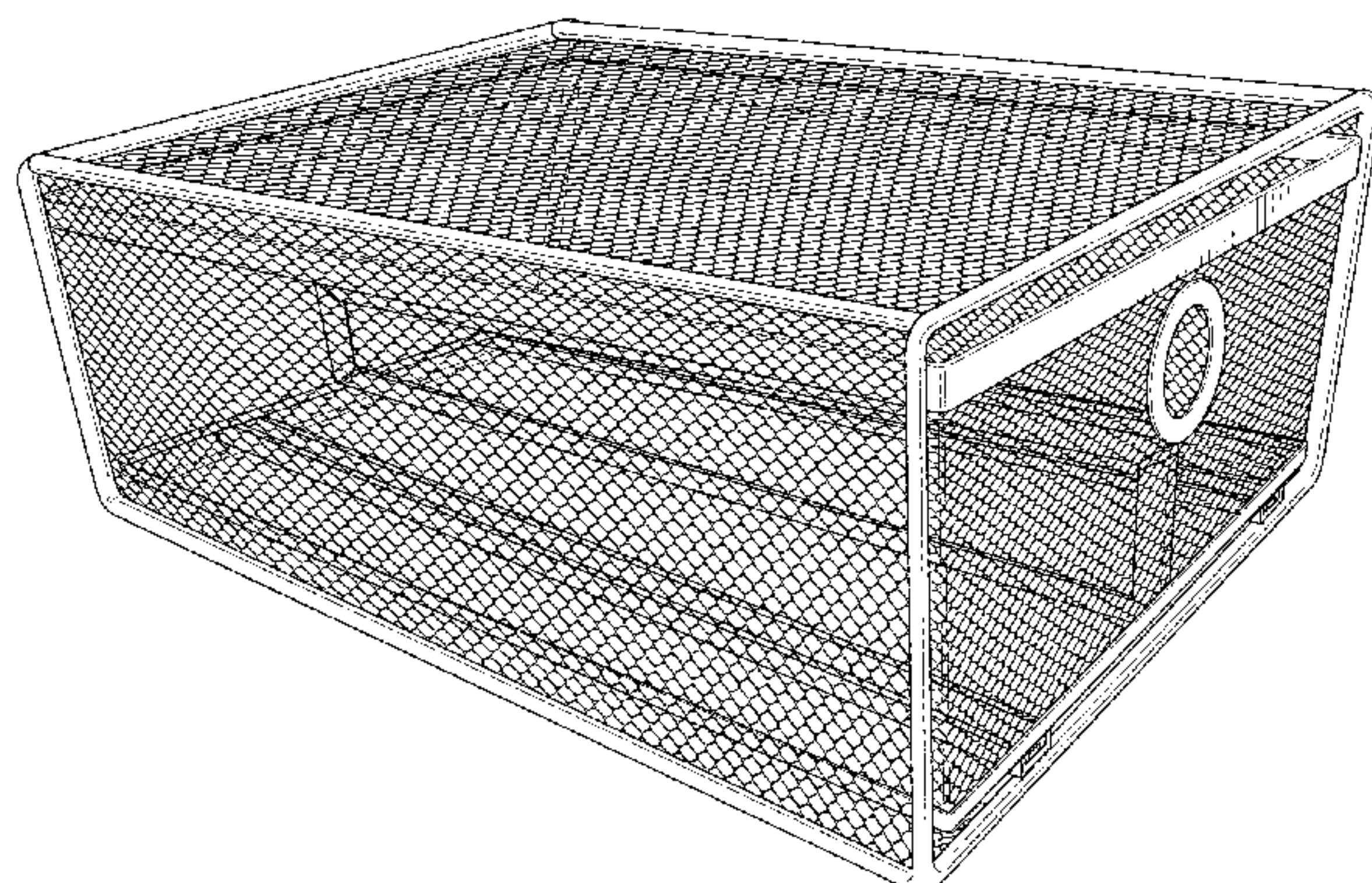


FIG. 13 is a top plan view of the drawer assembly shown in FIG. 8; and,

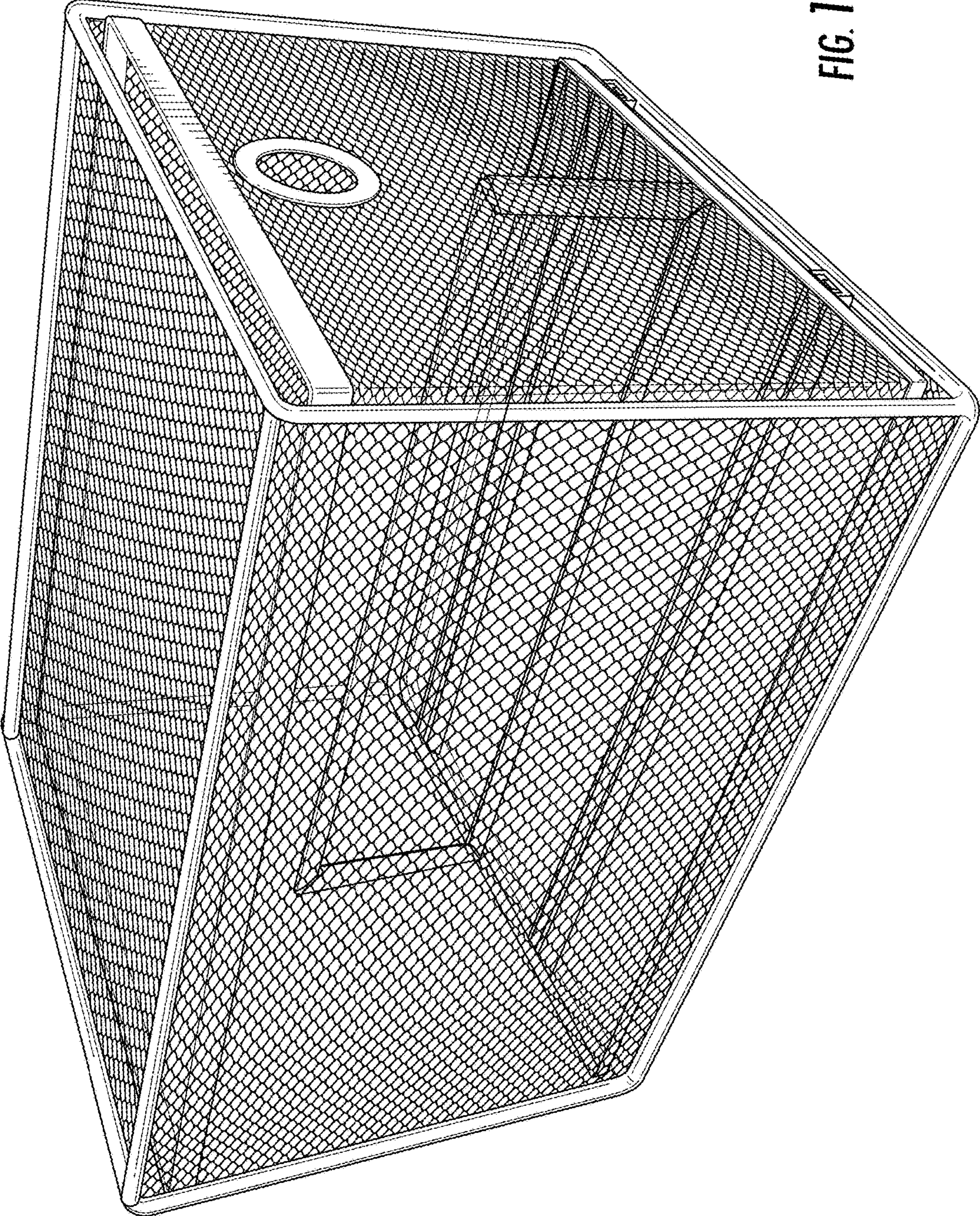

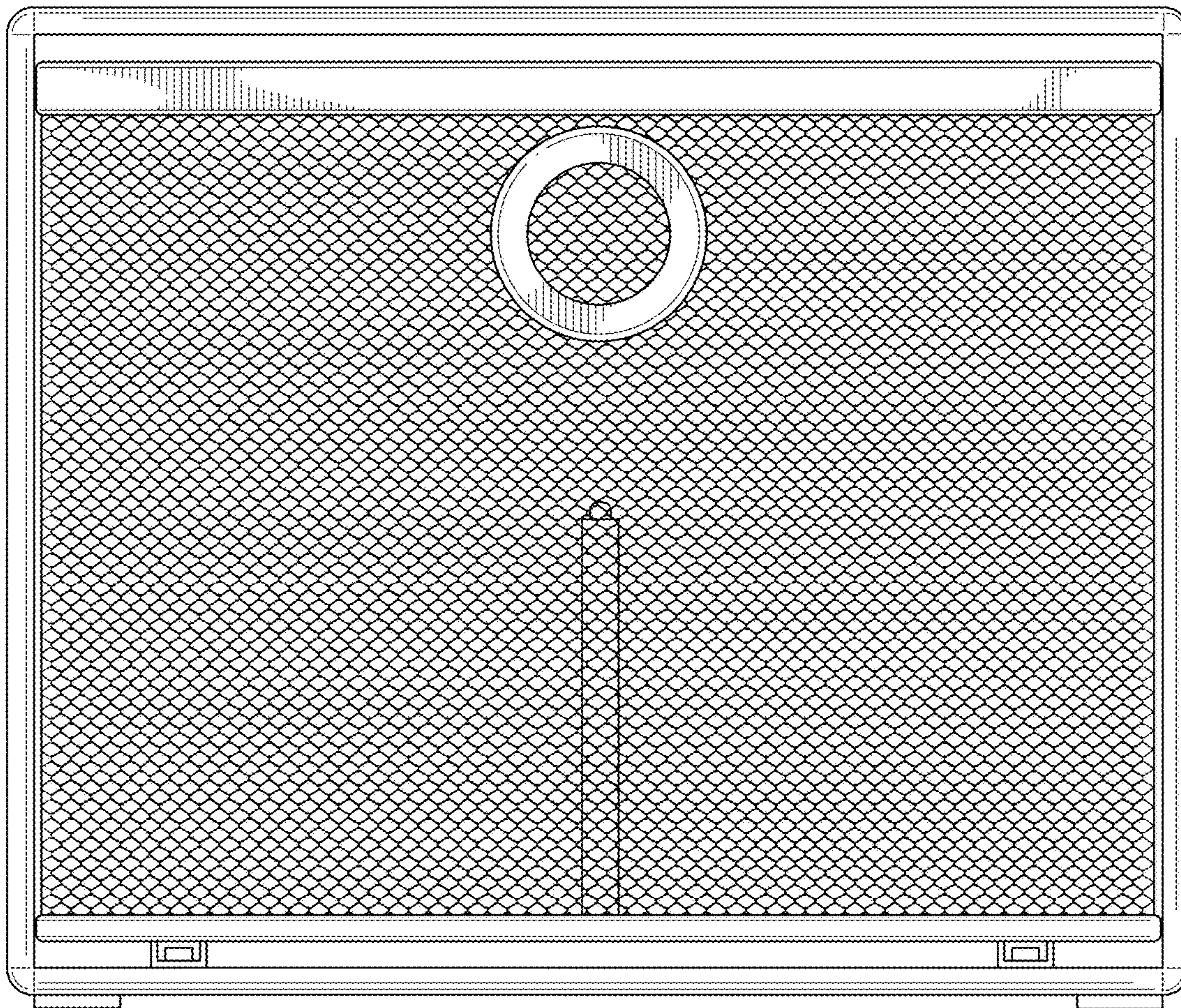

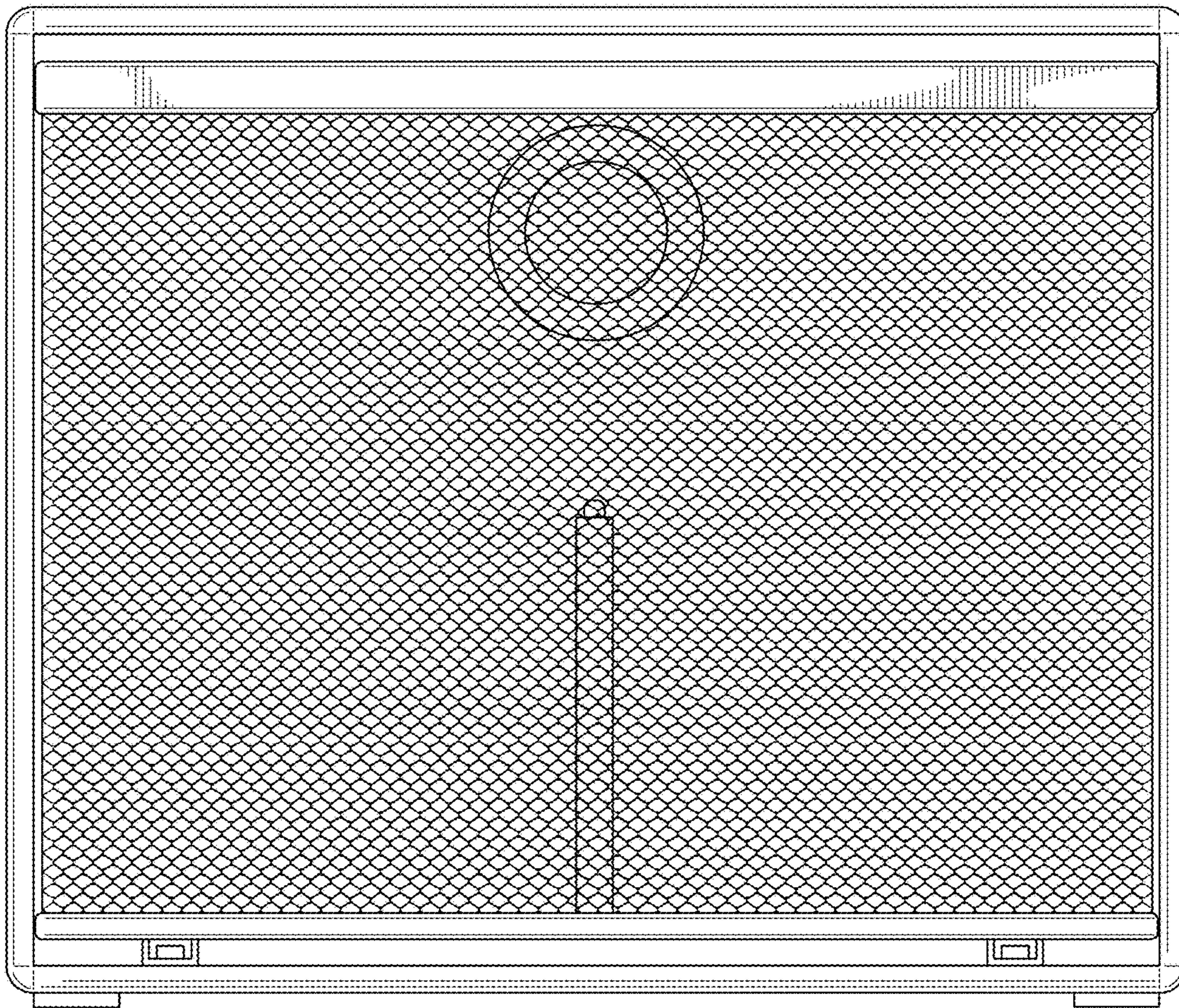

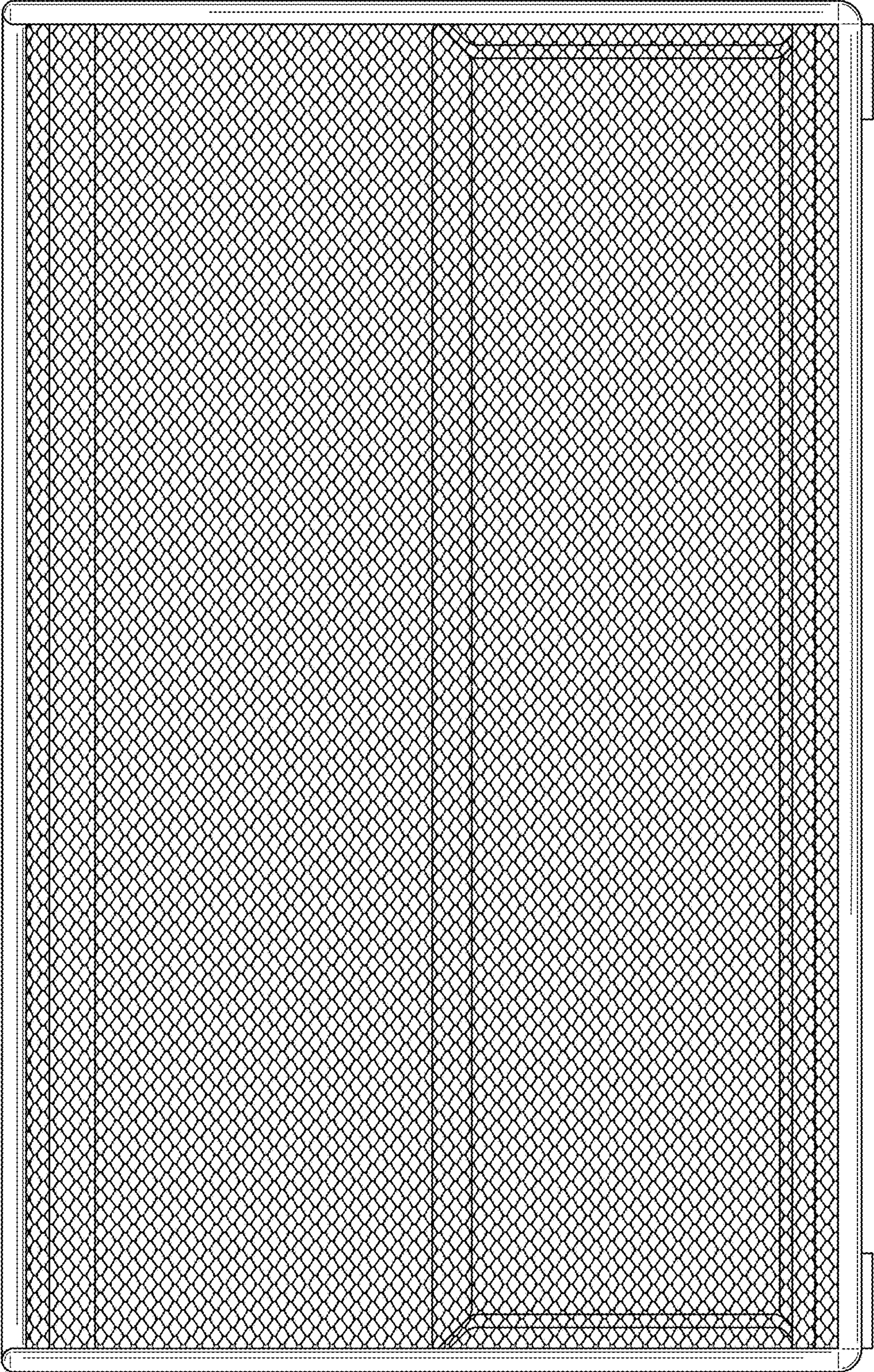

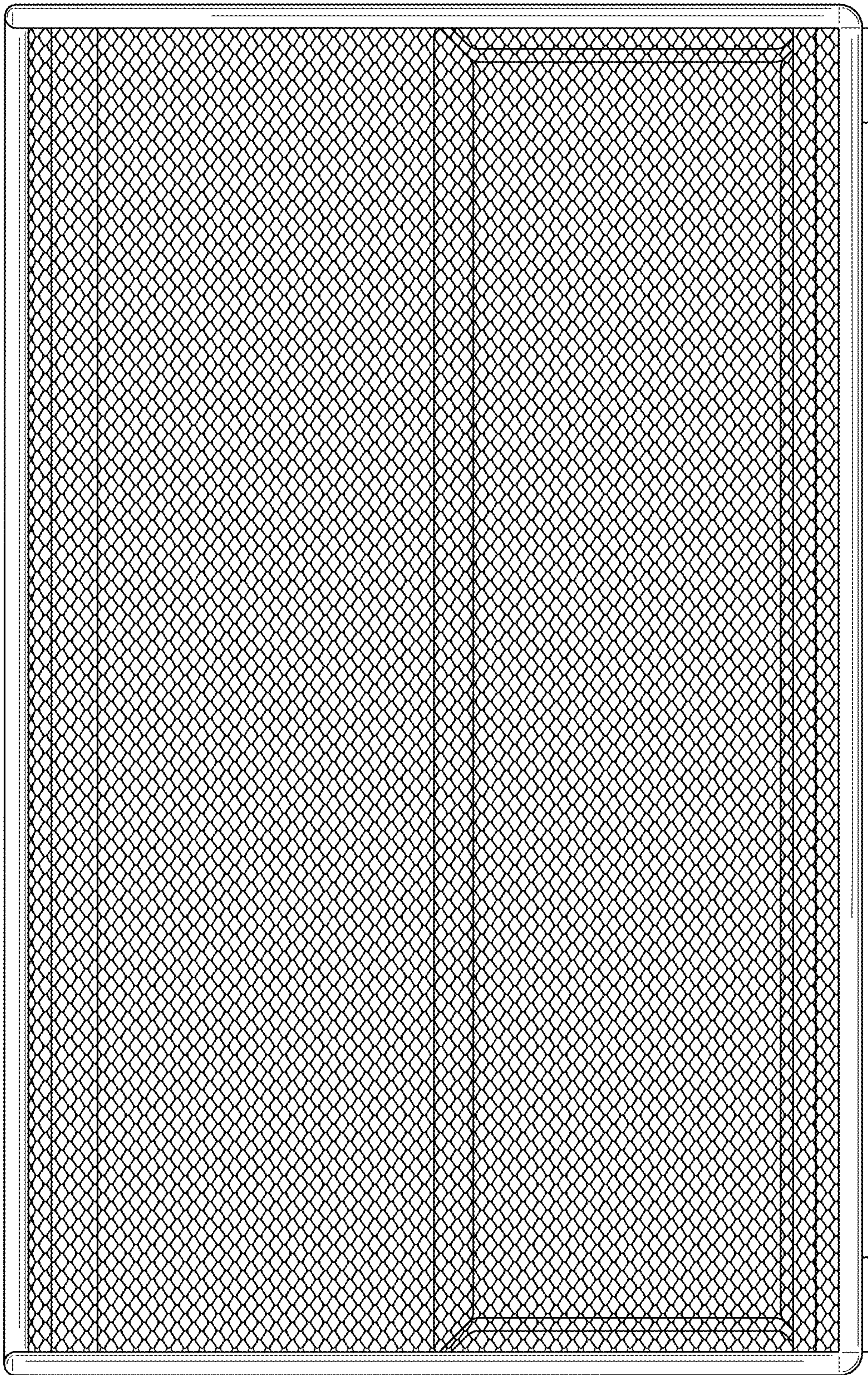

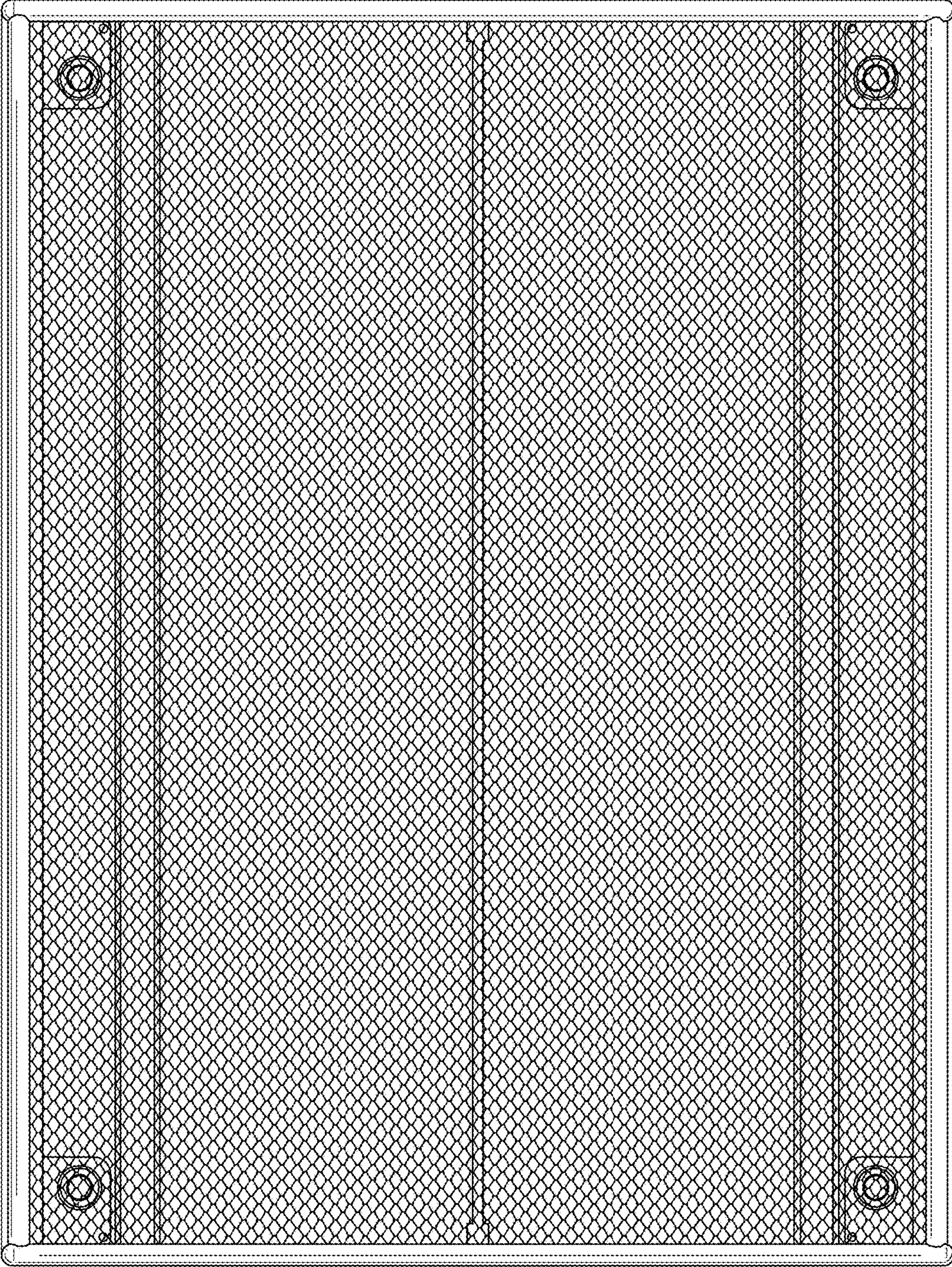
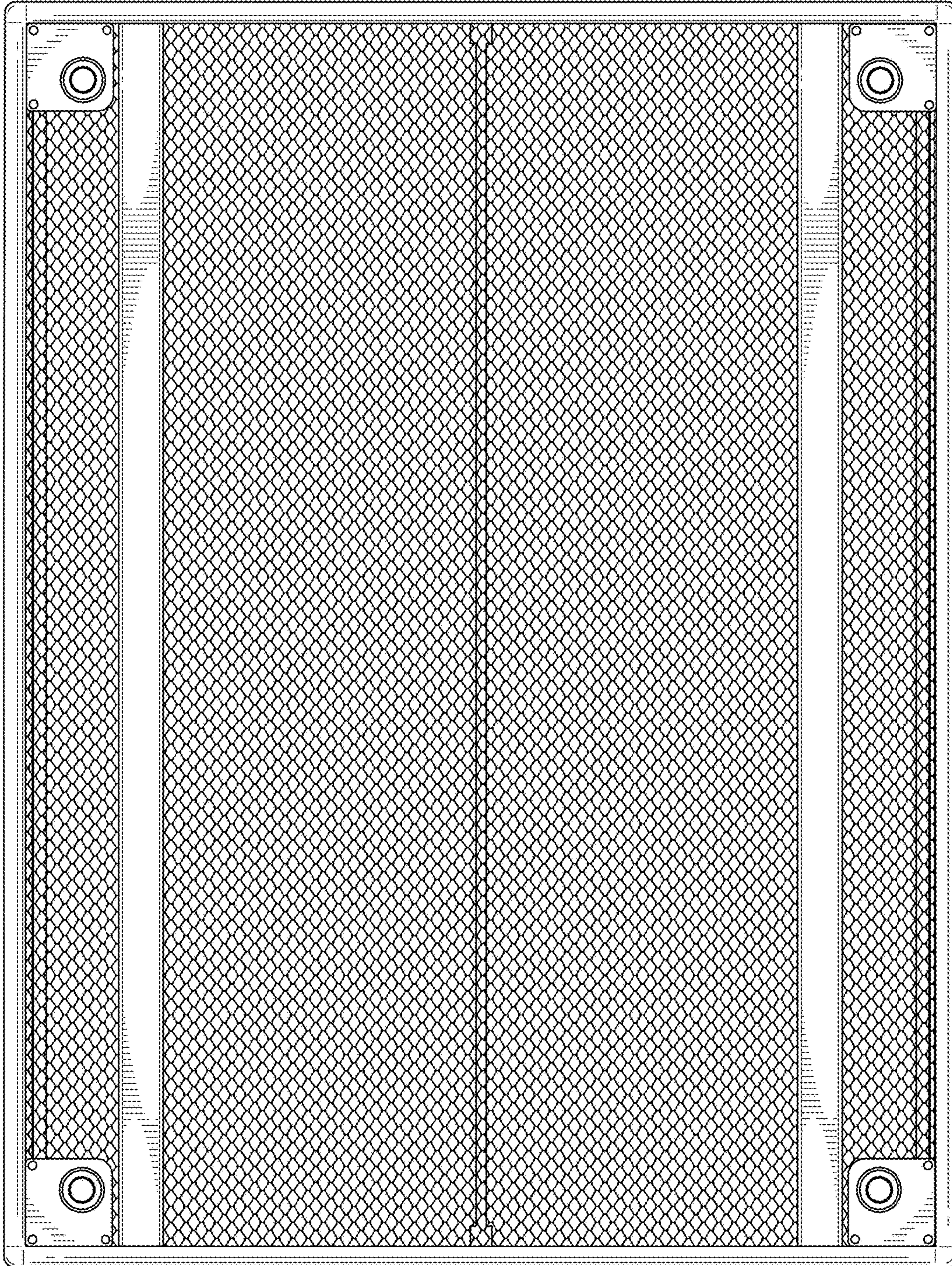

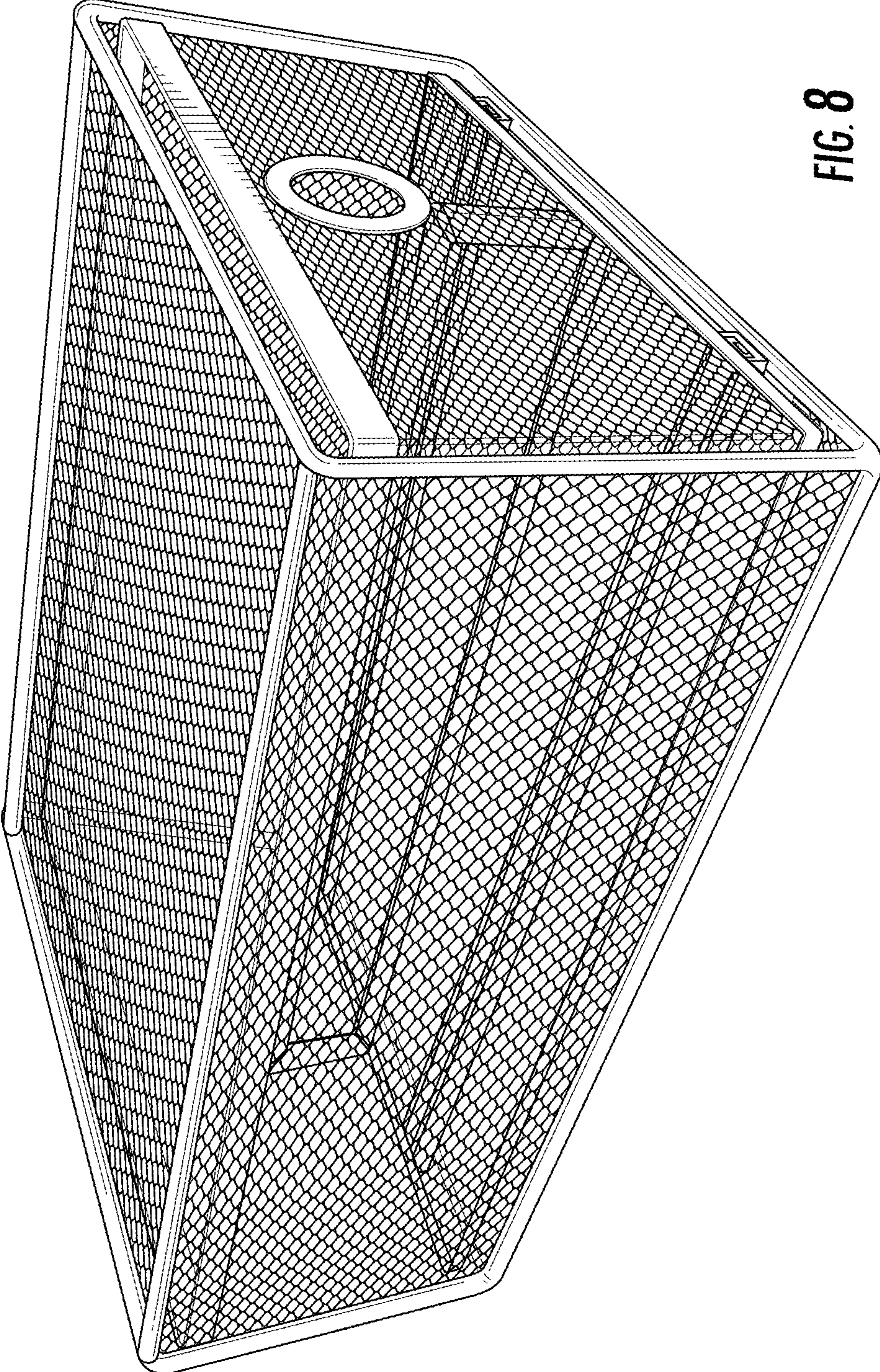

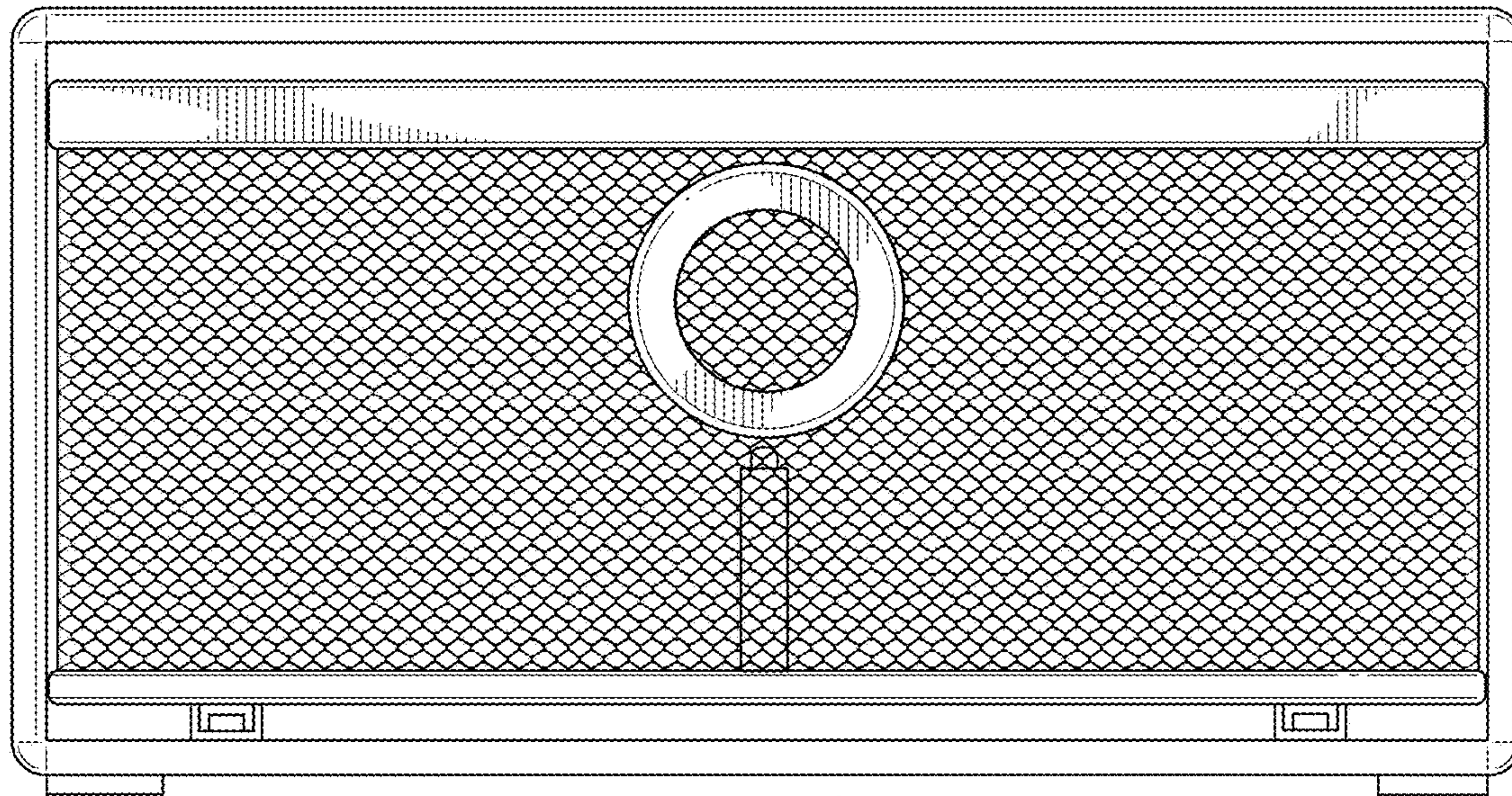

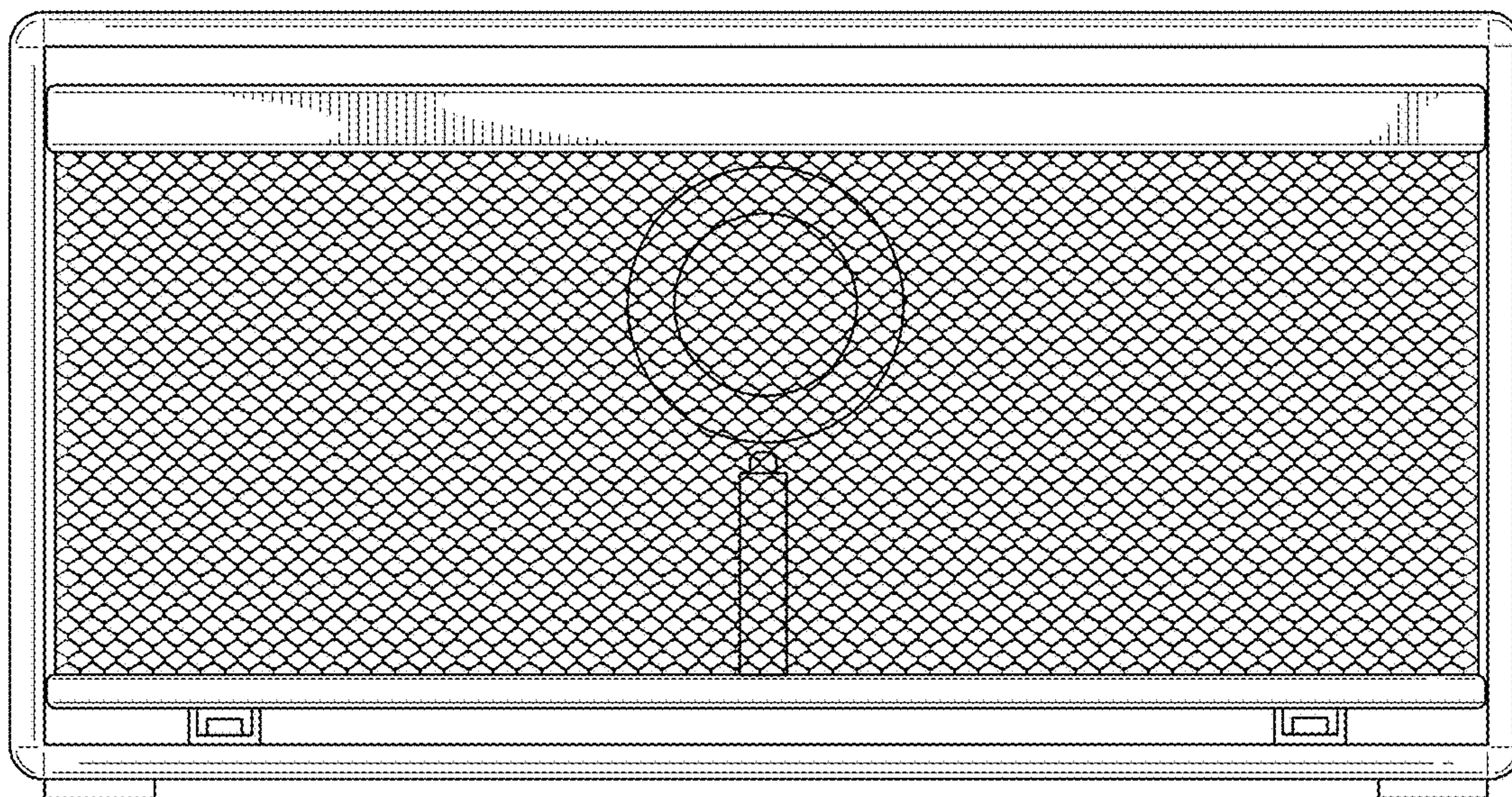

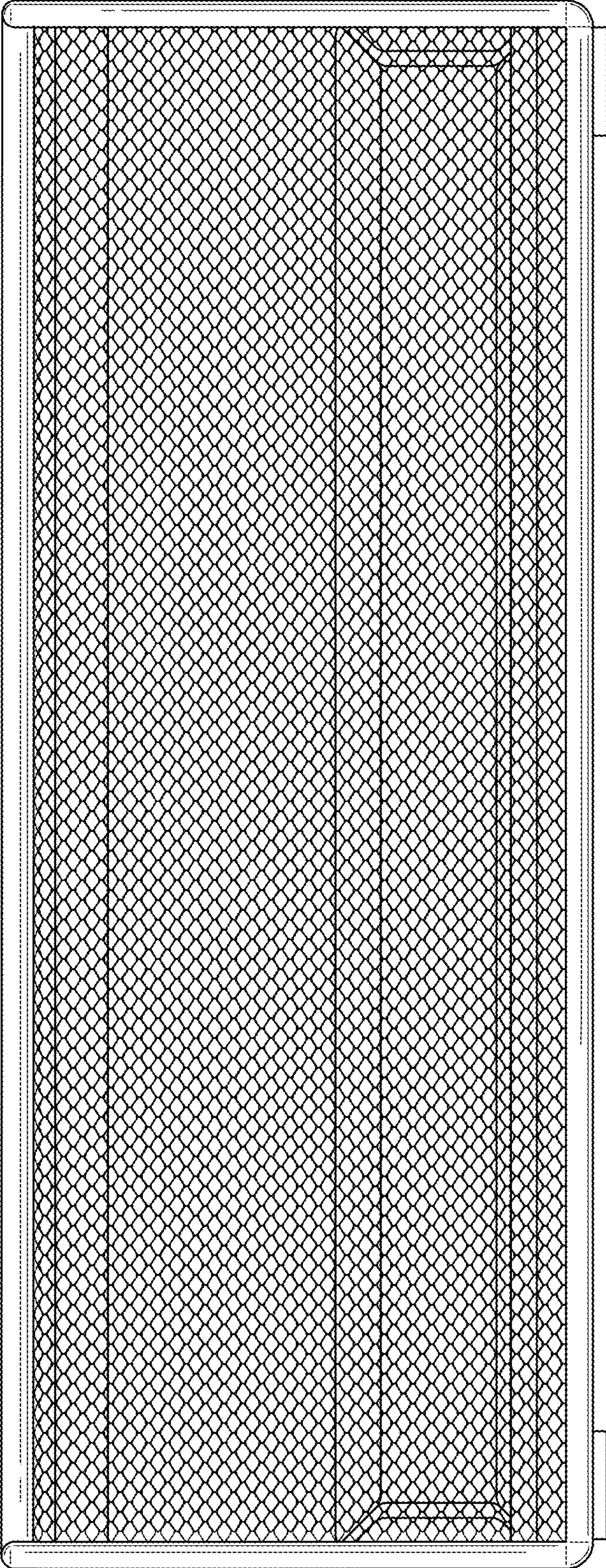

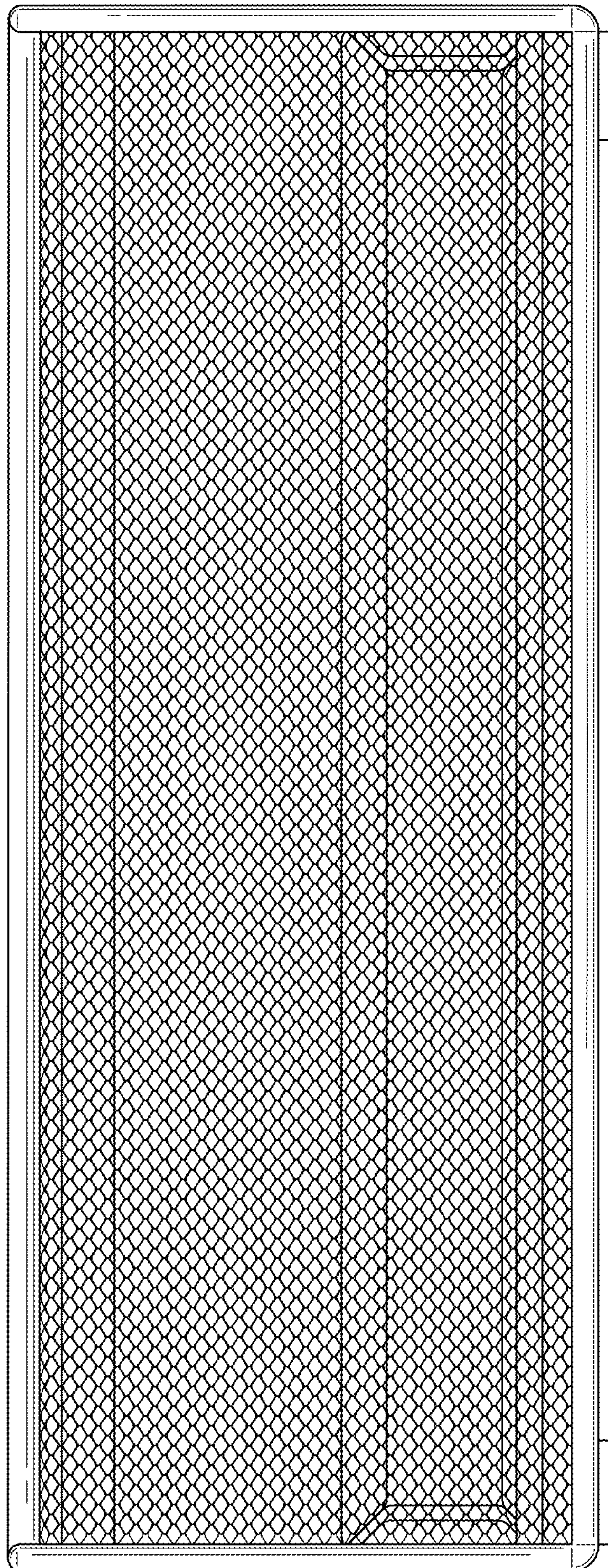

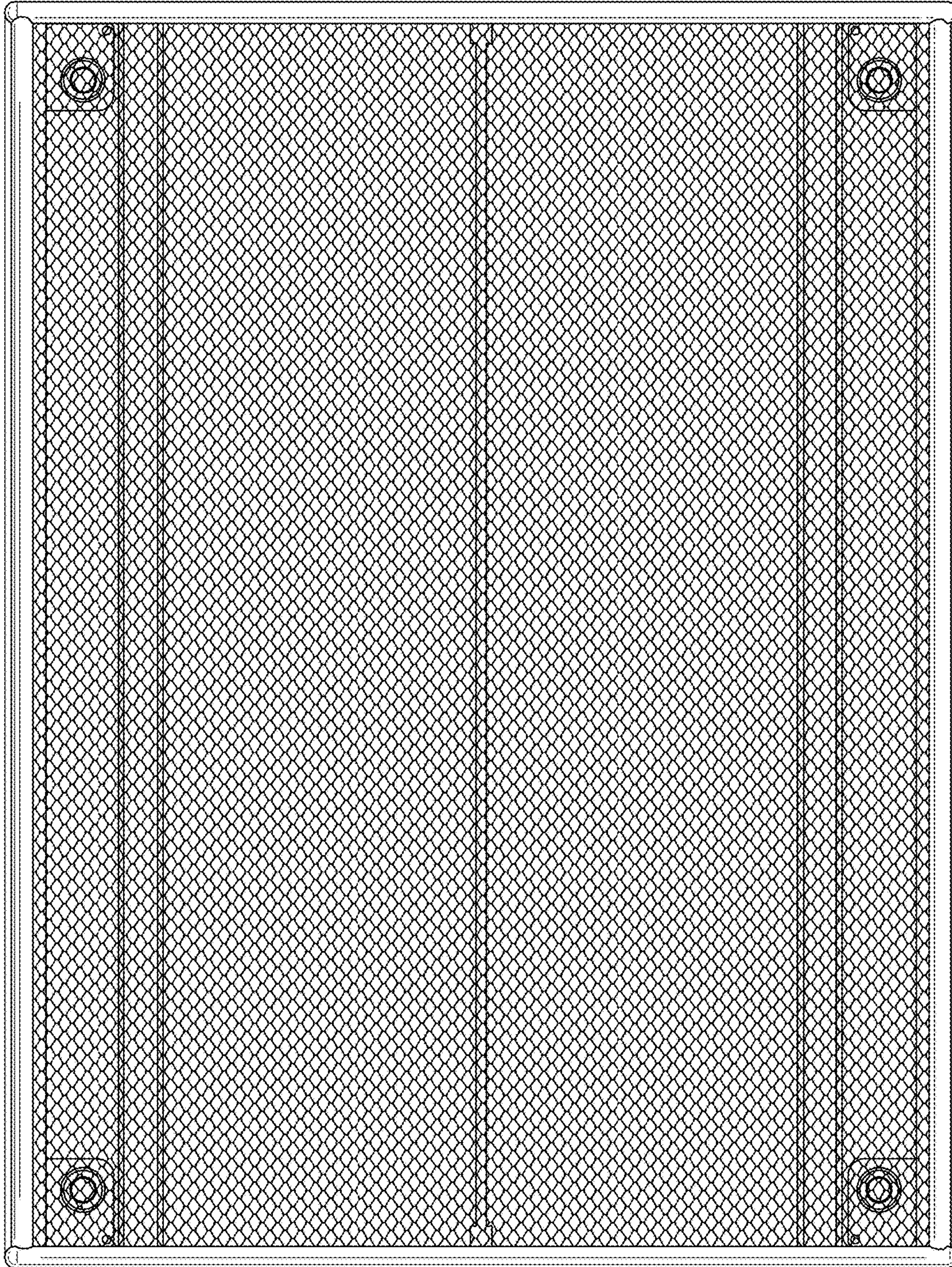
