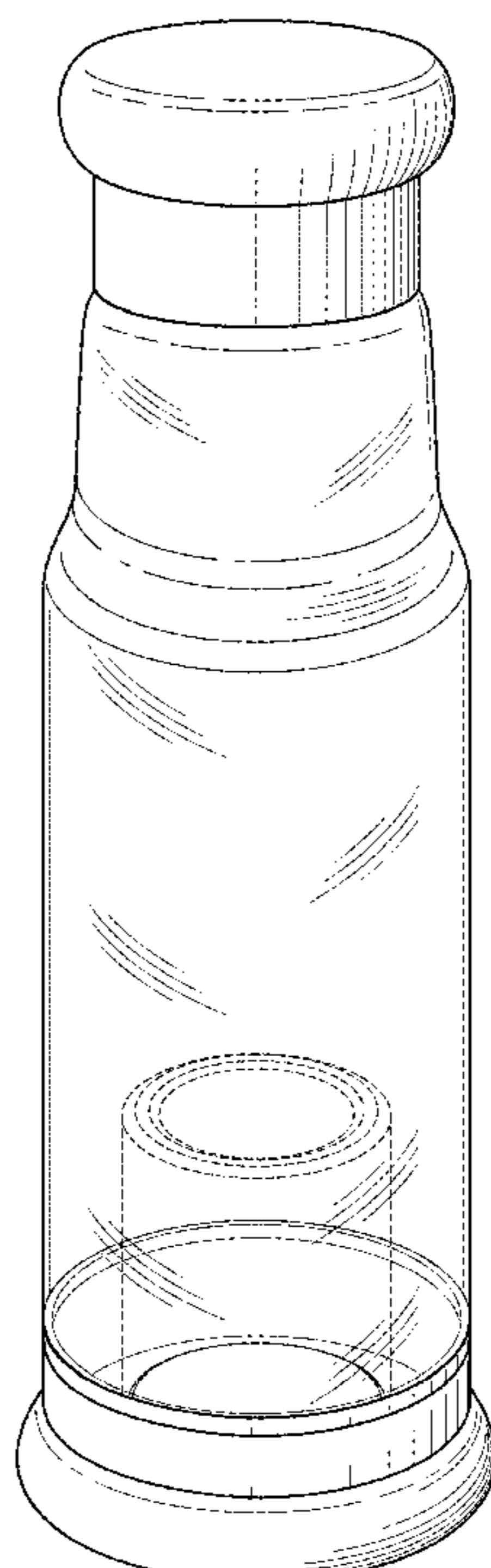

The ornamental design for a tea bottle, as shown and described.

DESCRIPTION
FIG. 1 is a top and side perspective view of a tea bottle showing my new design;
FIG. 2 is a side view thereof;

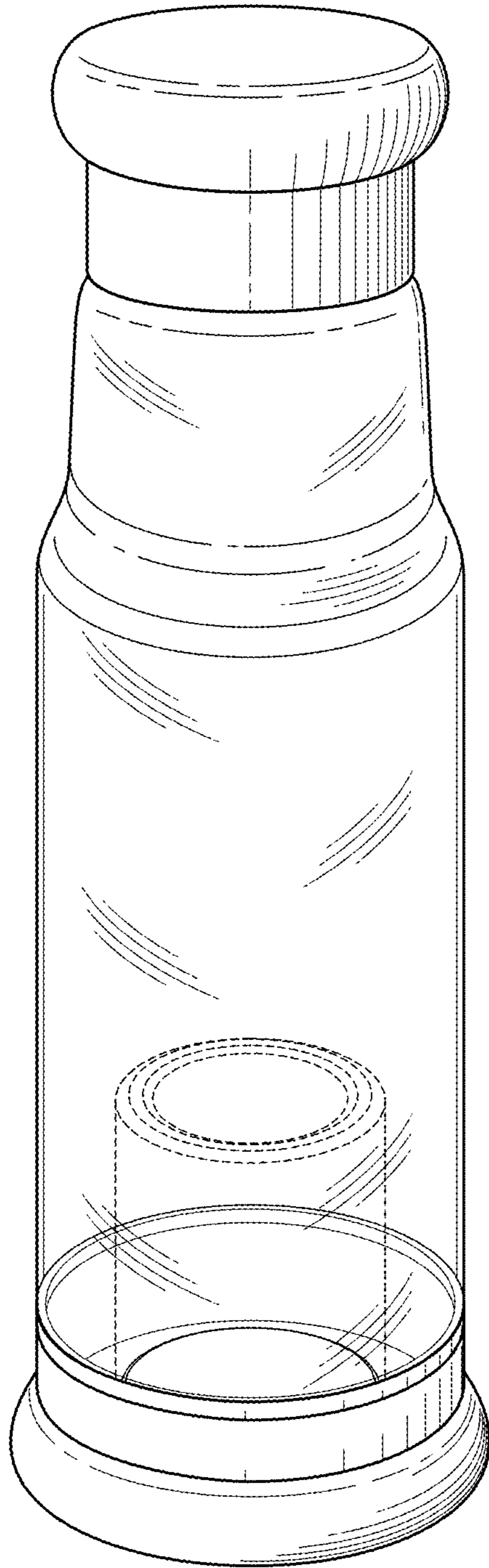

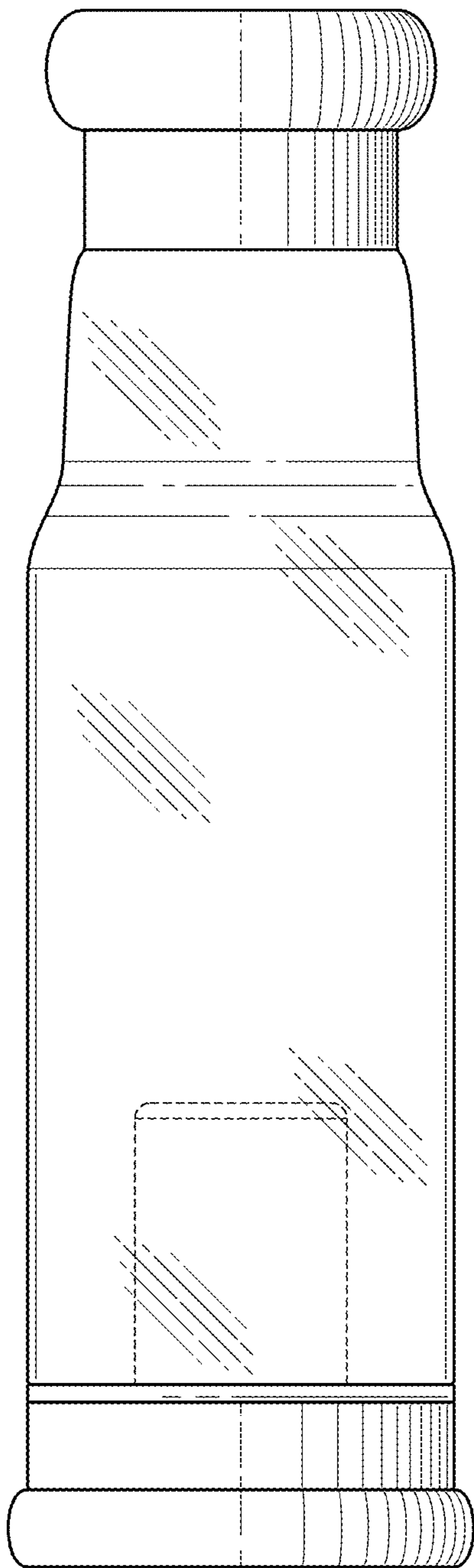

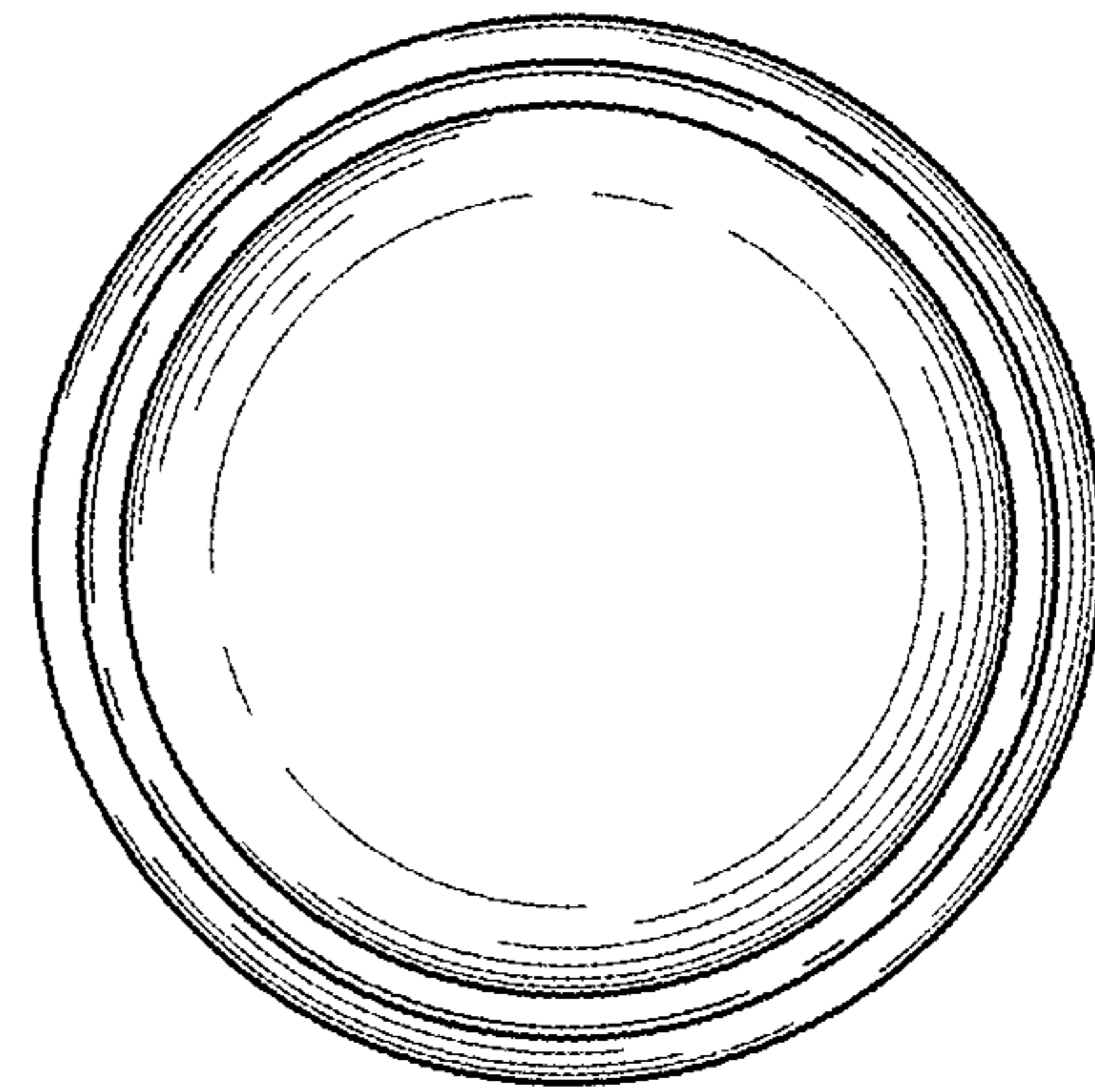

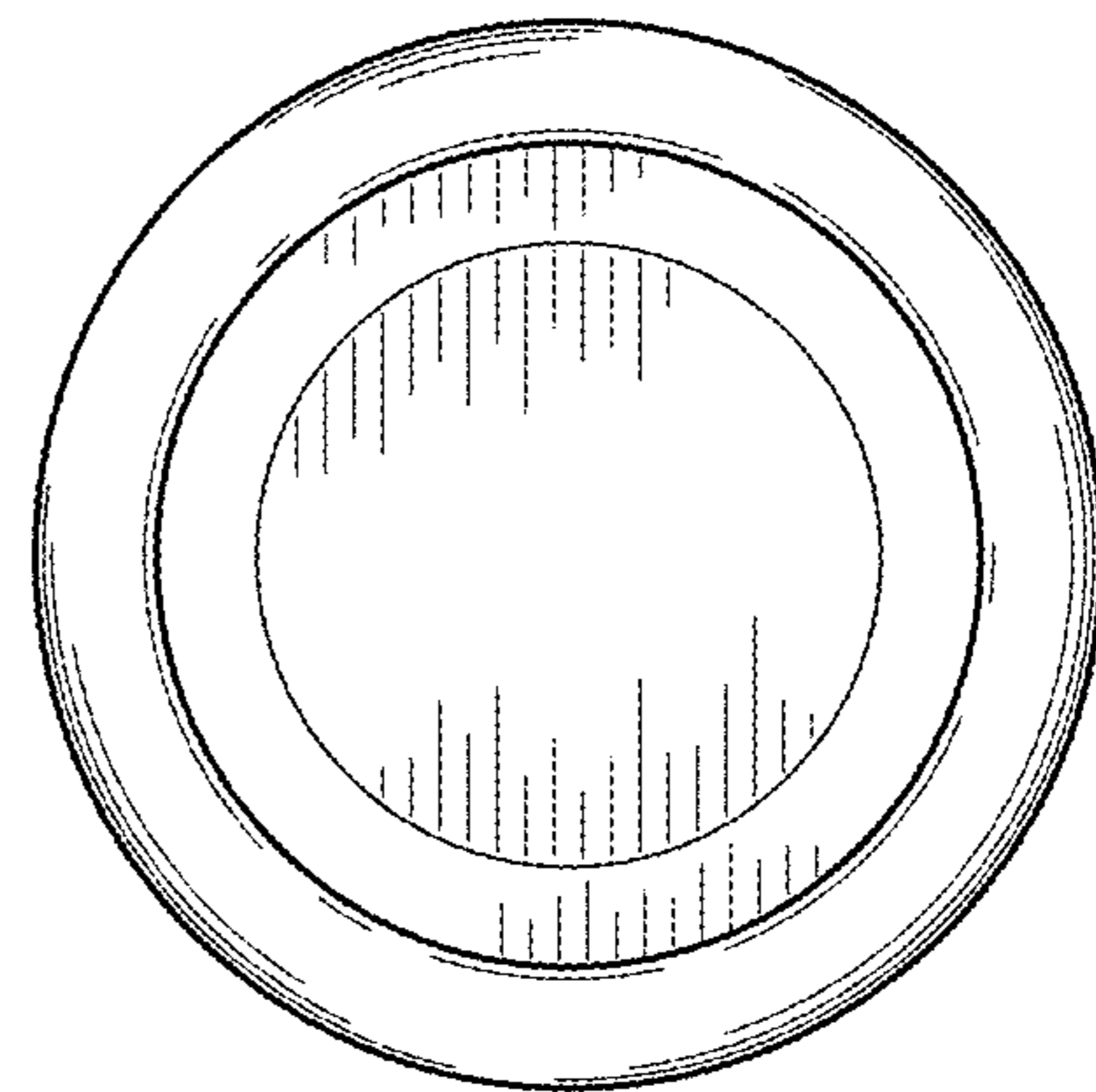
