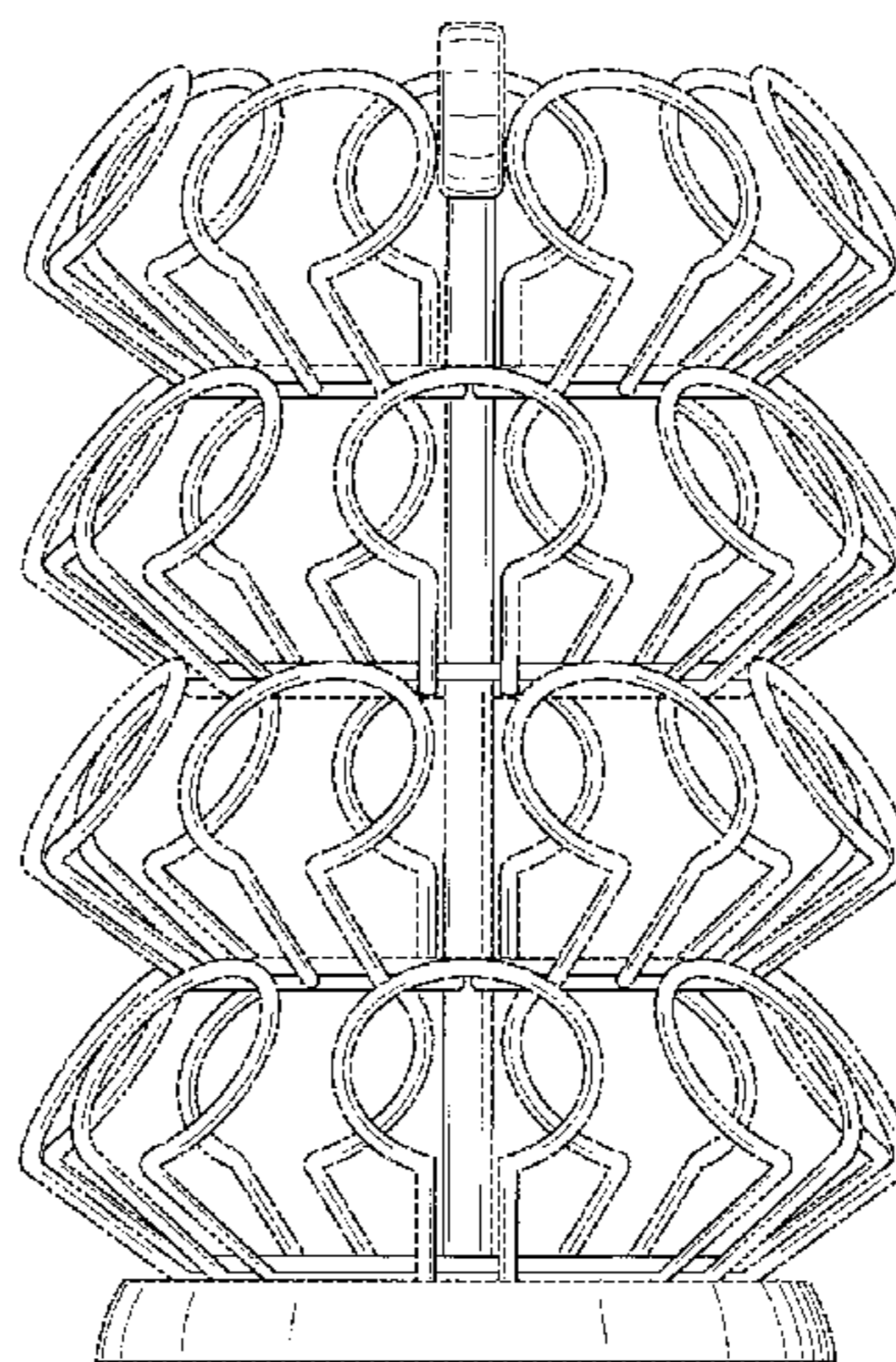
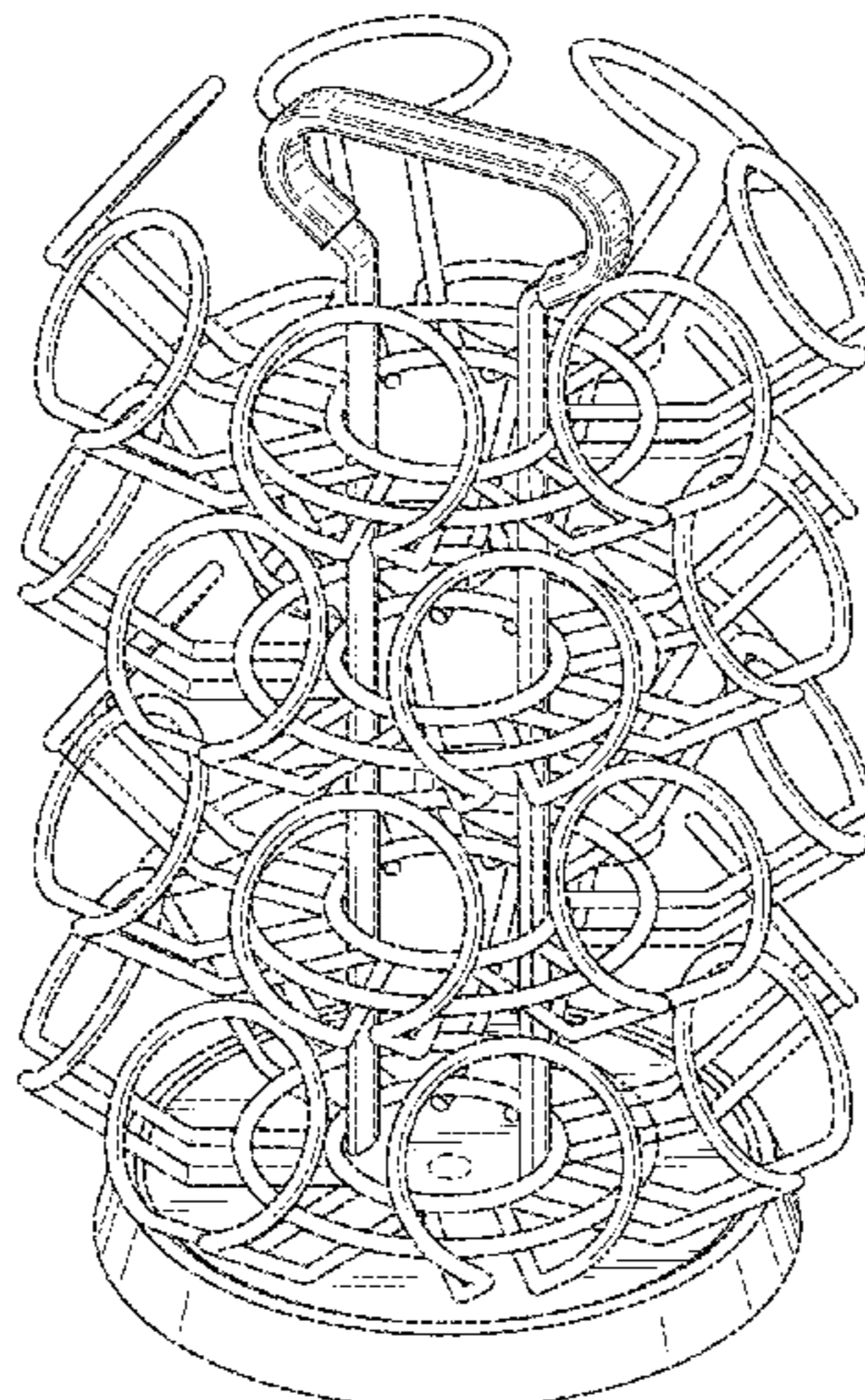
(57) **CLAIM**

The ornamental design for a carousel for foodstuff containers, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a carousel for foodstuff containers showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.  
The broken lines shown in FIG. 1 and FIG. 7 represent portions of the carousel foodstuff containers that form no part of the claimed design.

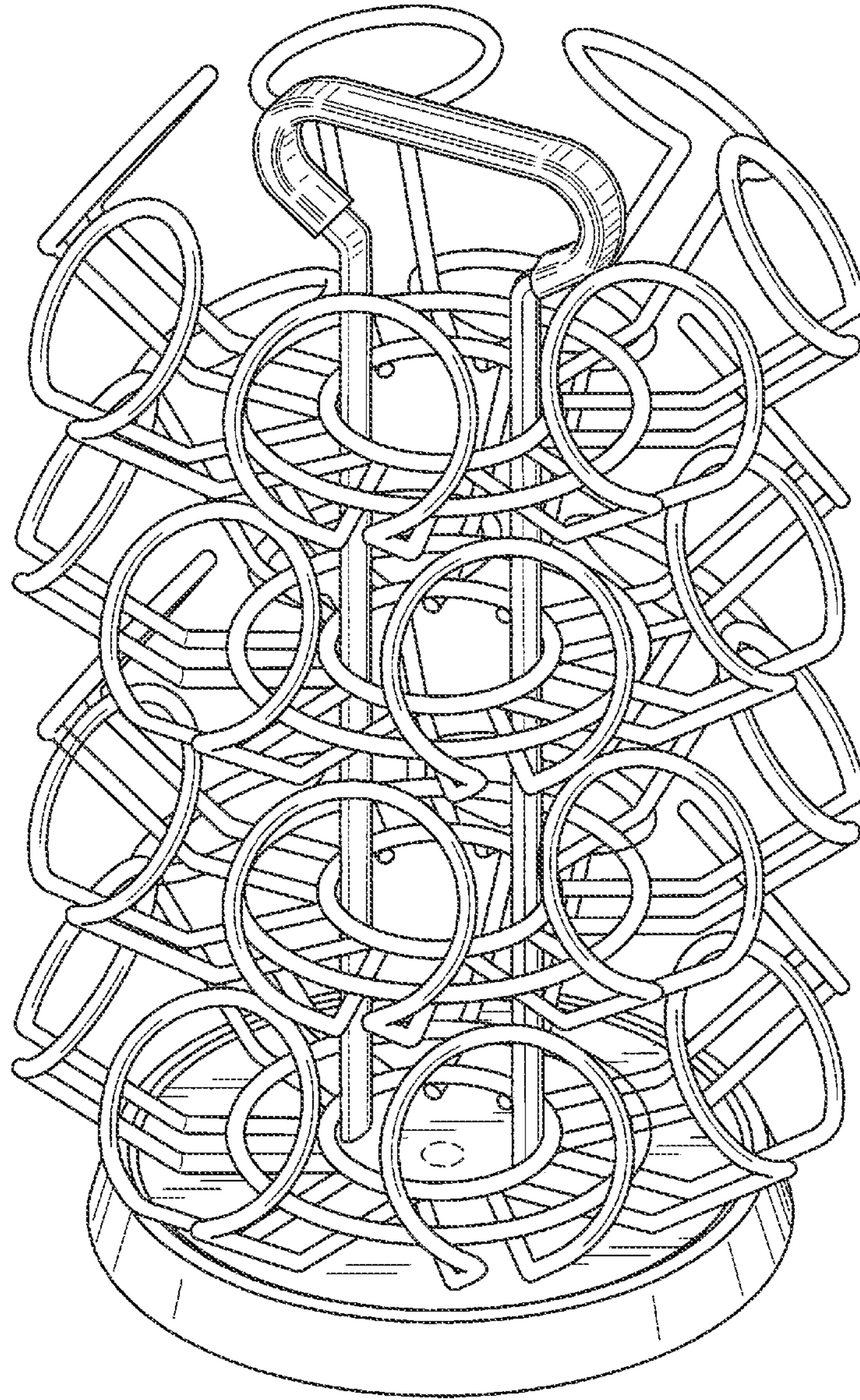

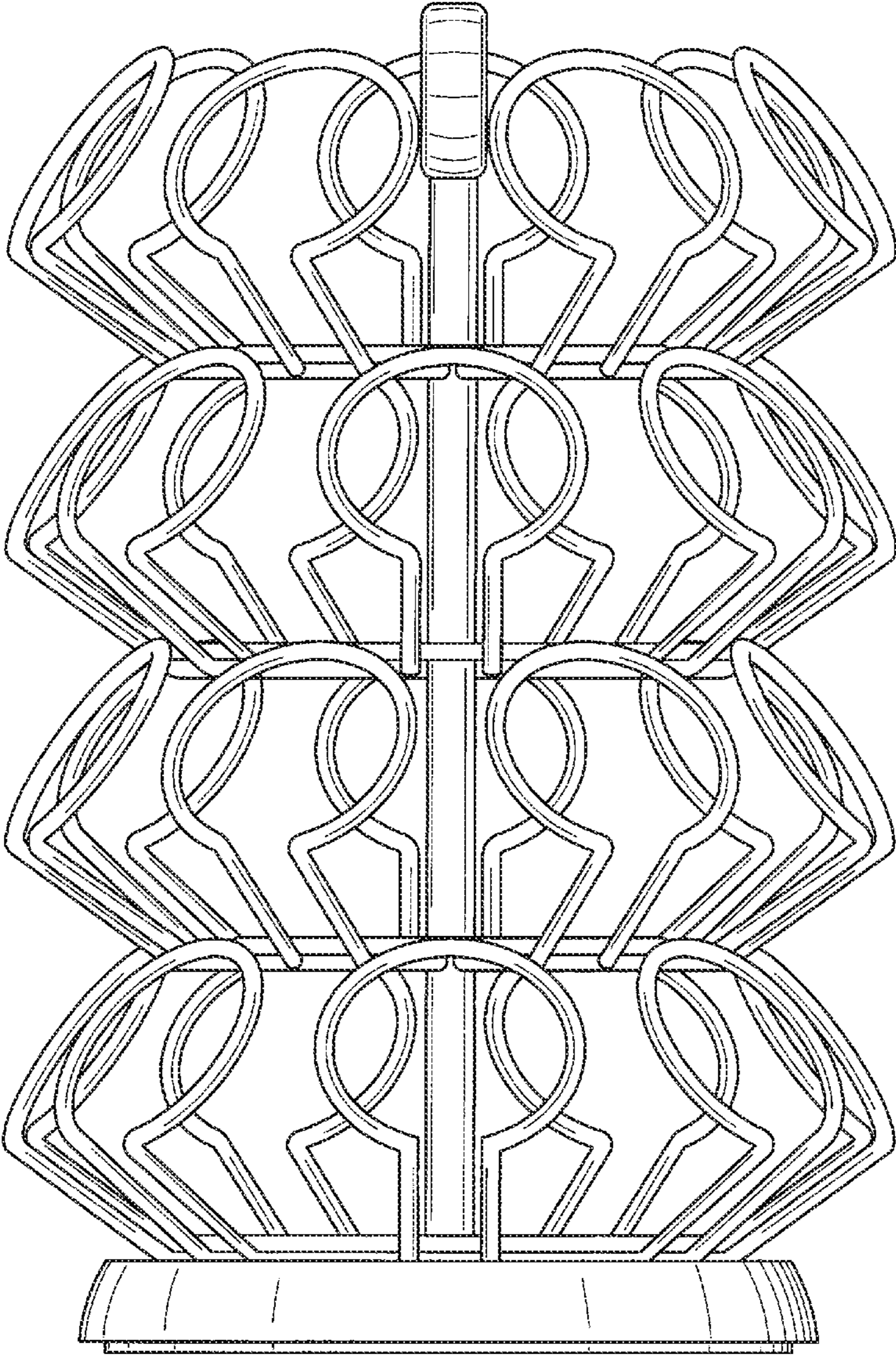

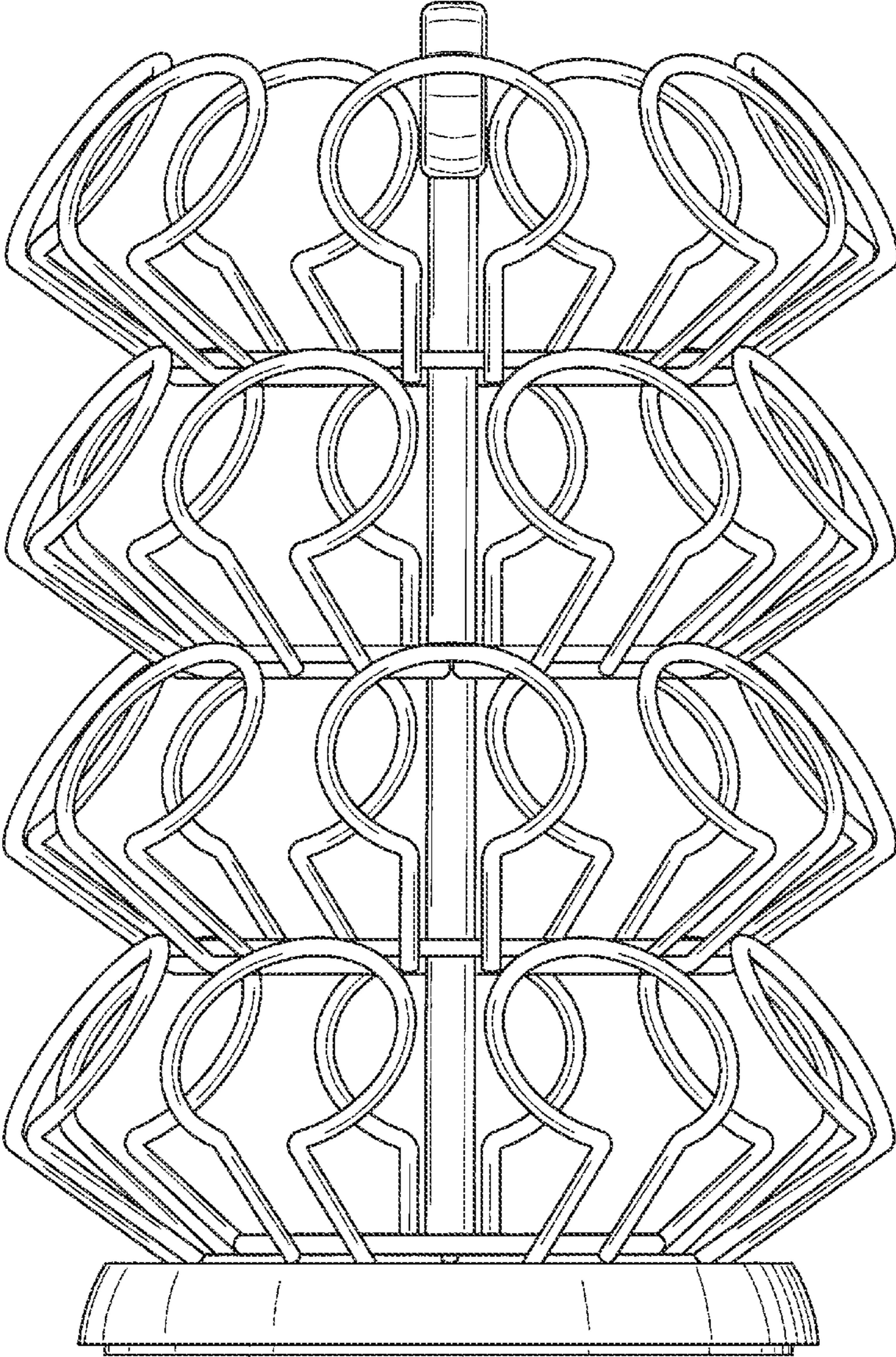

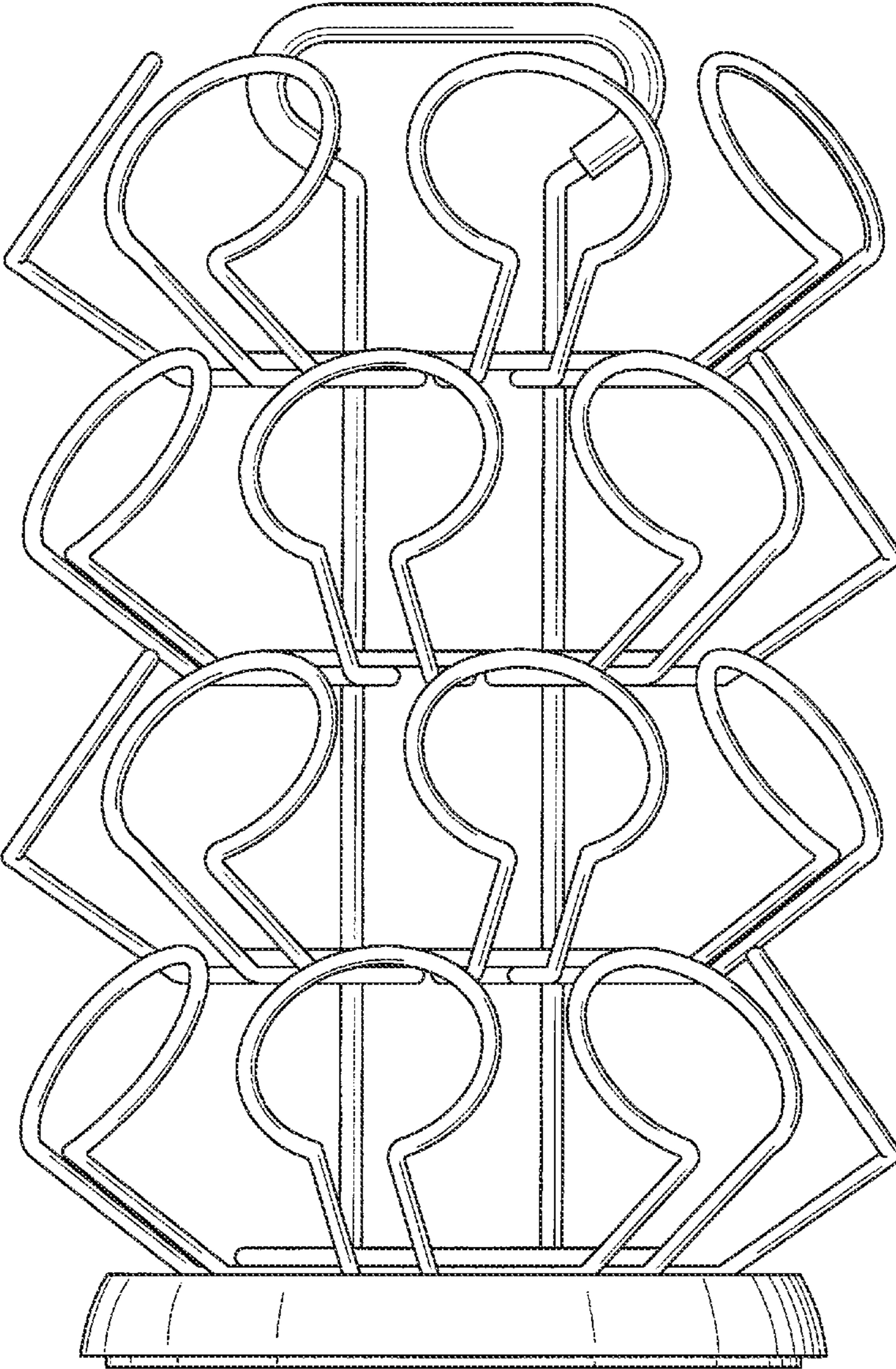

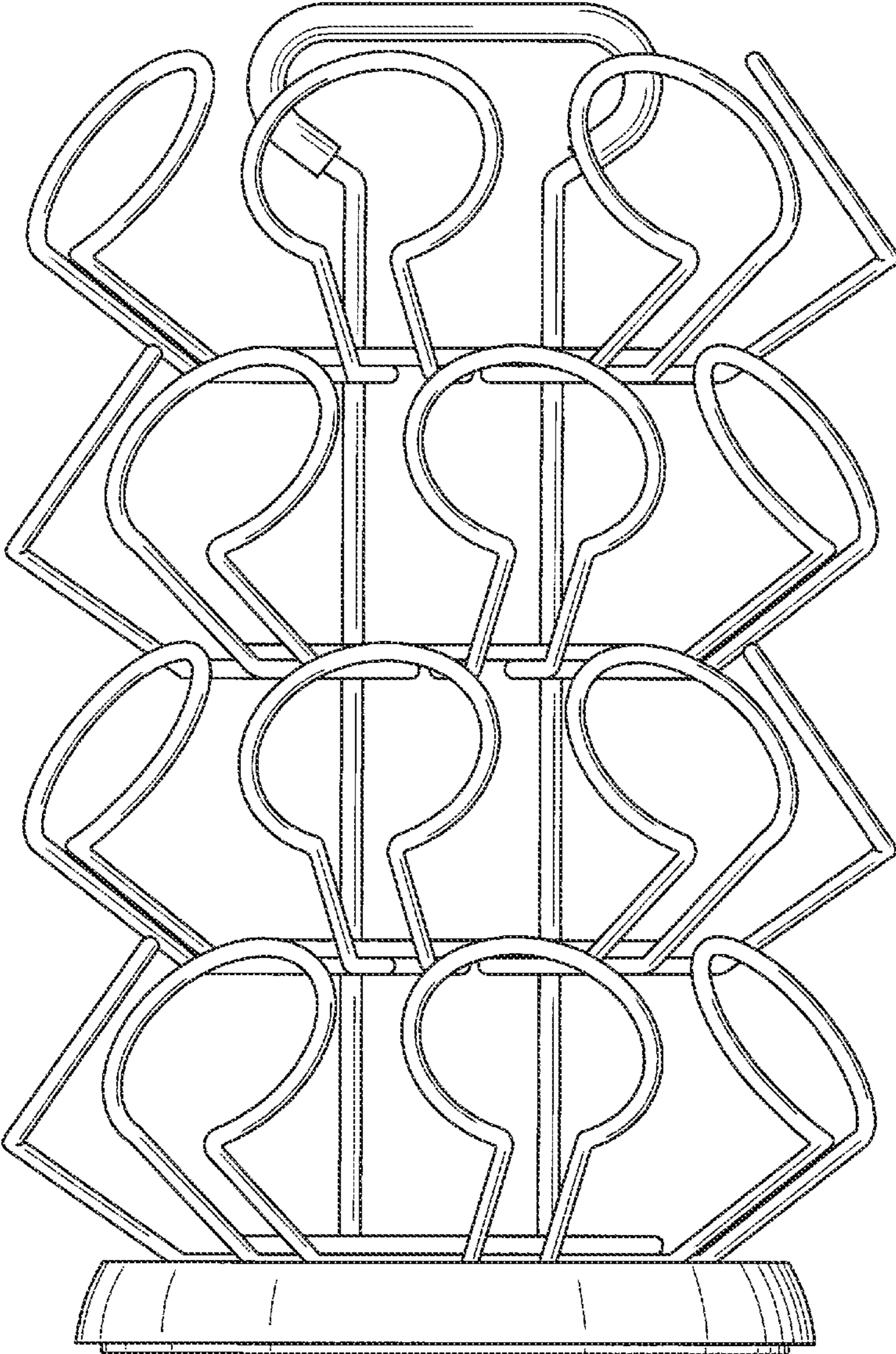

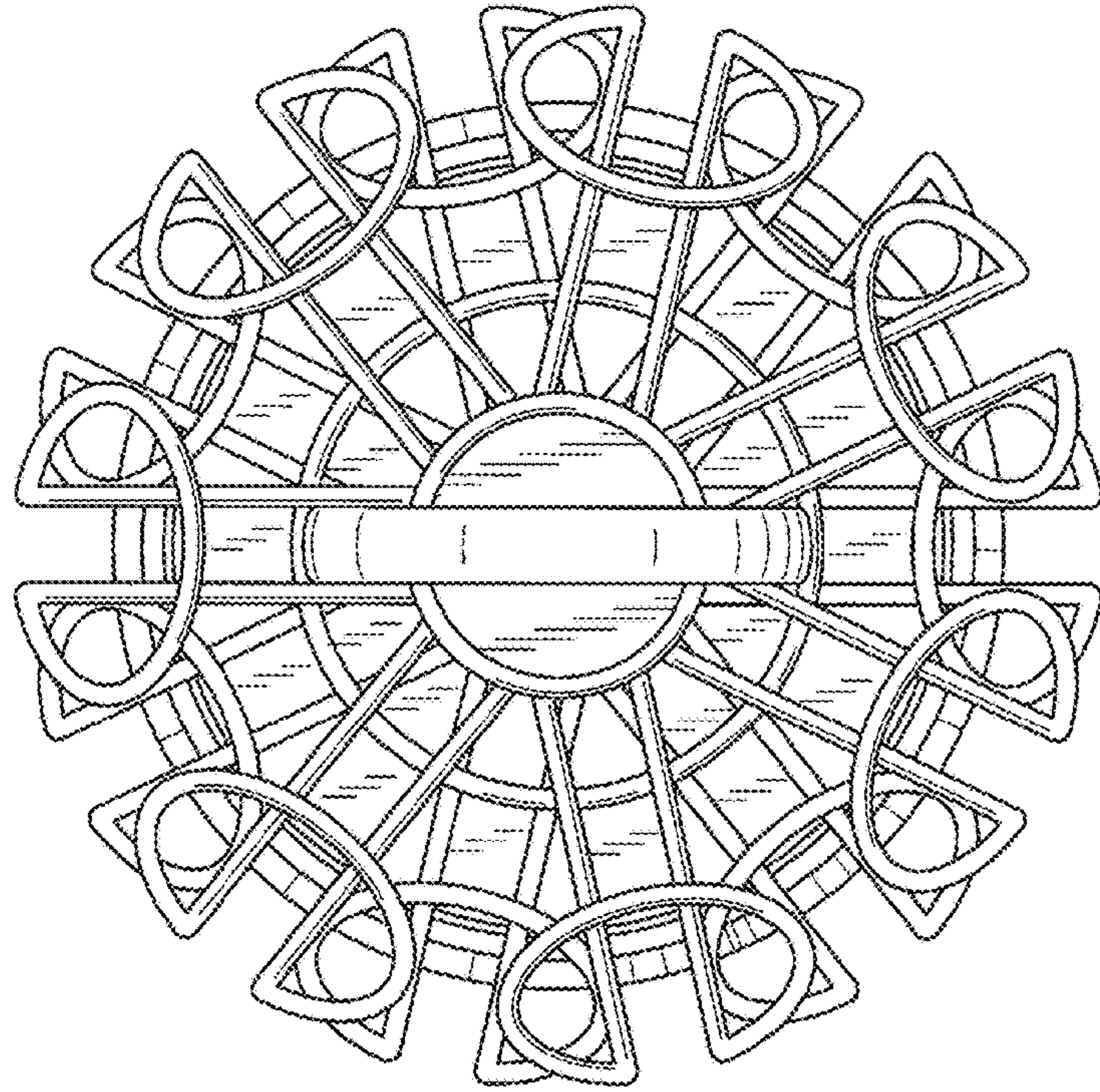

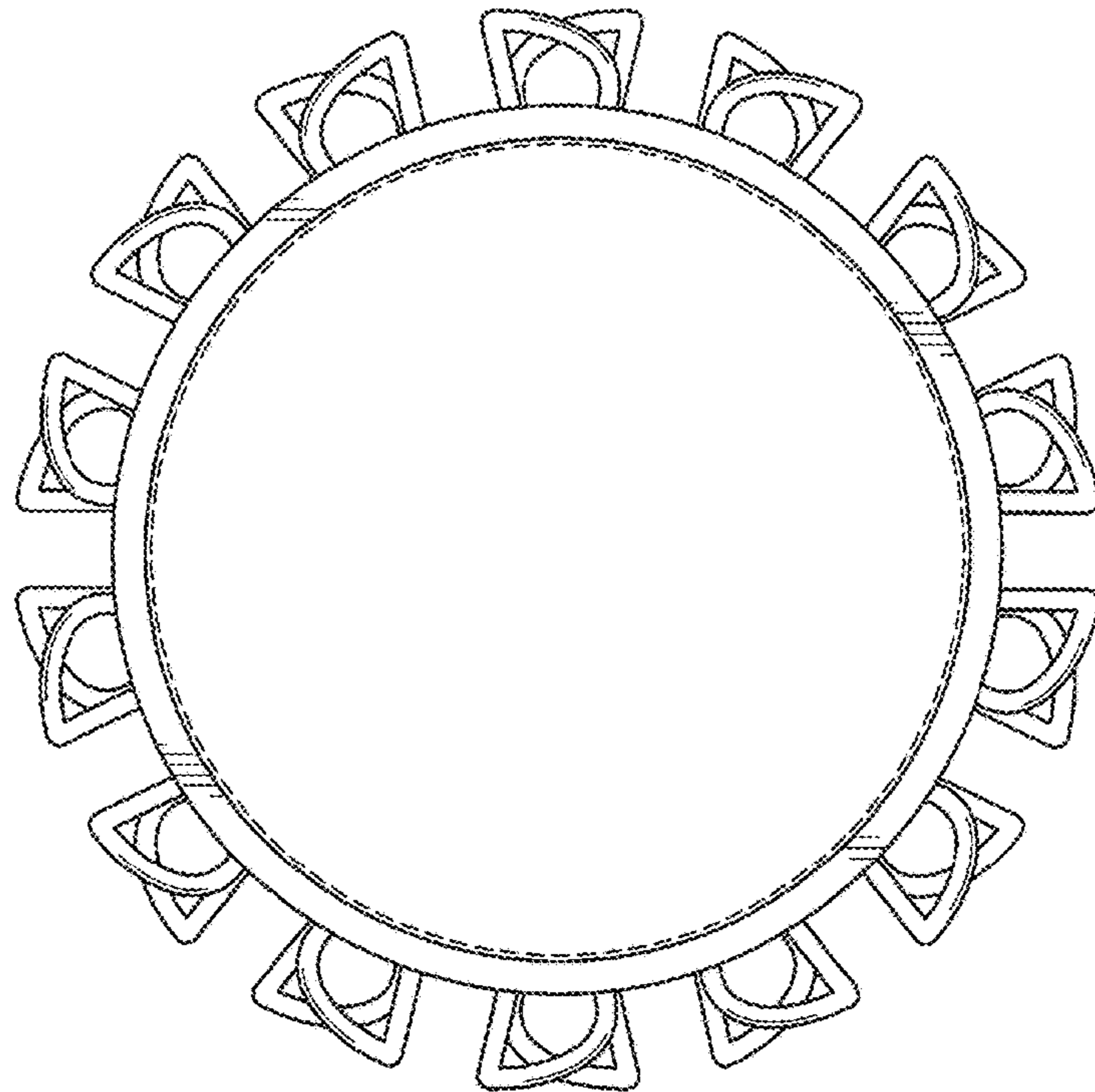
