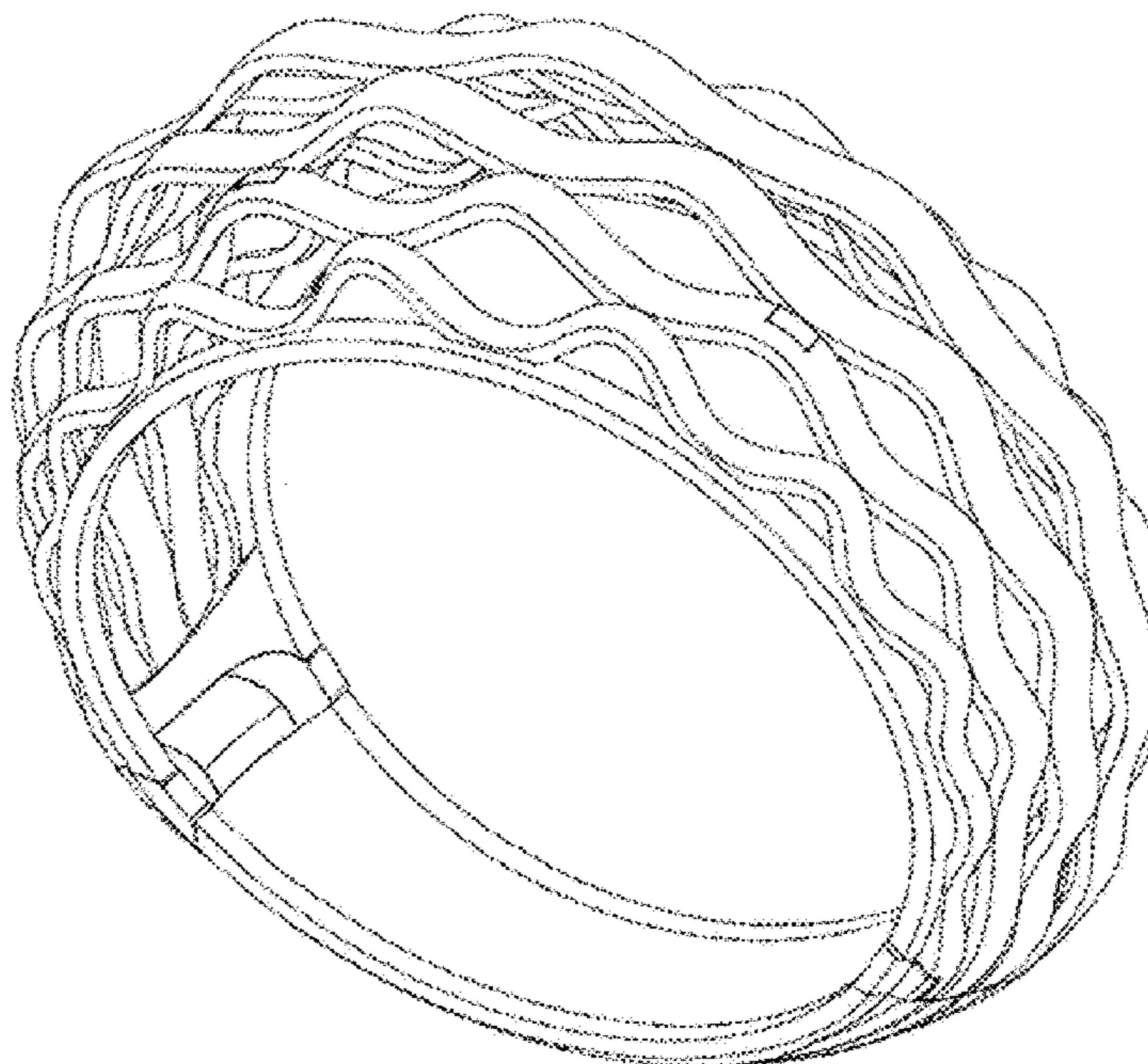
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevation view of a bracelet showing my new design.
FIG. 2 is a rear elevation view of the bracelet of FIG. 1.

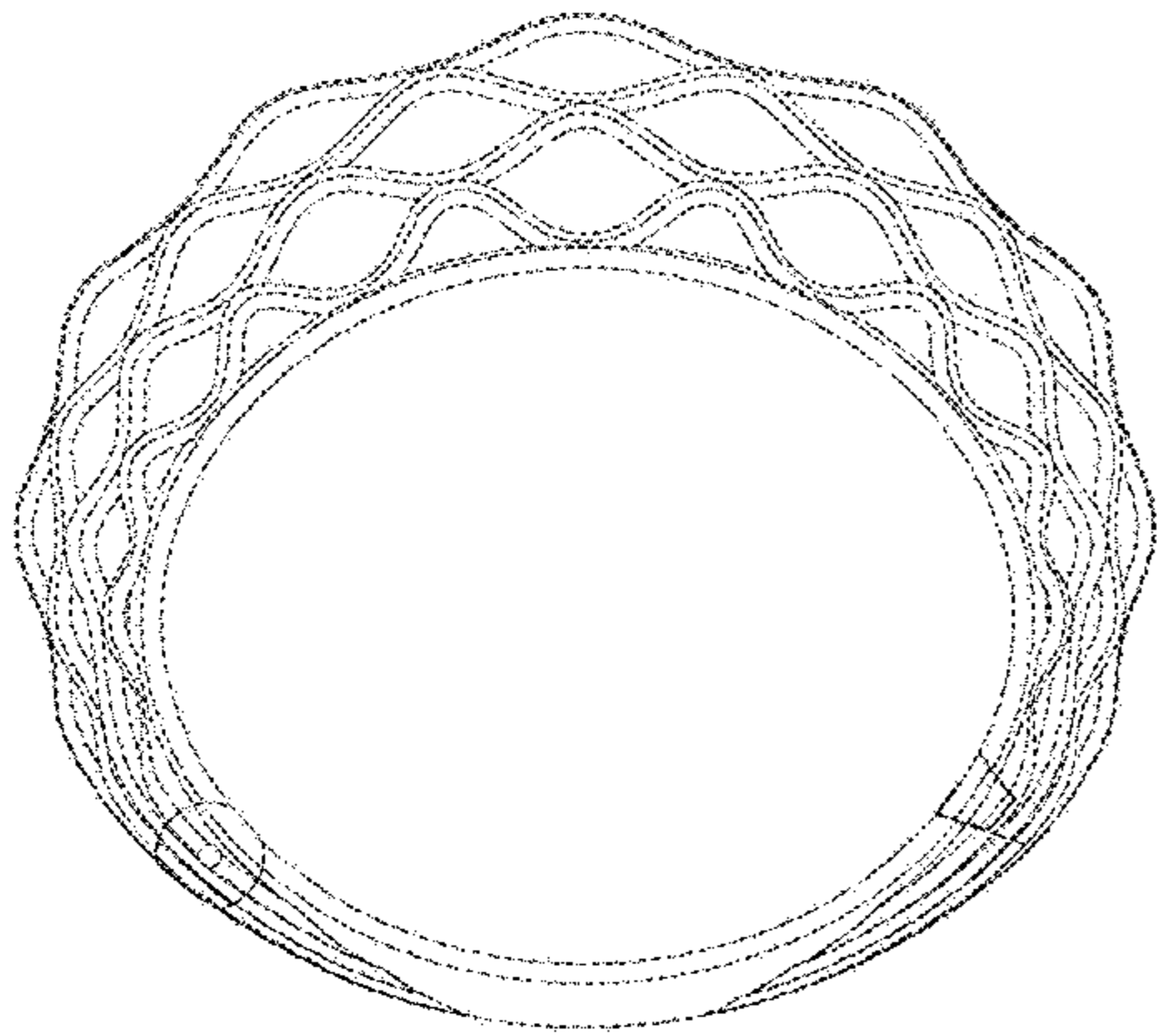

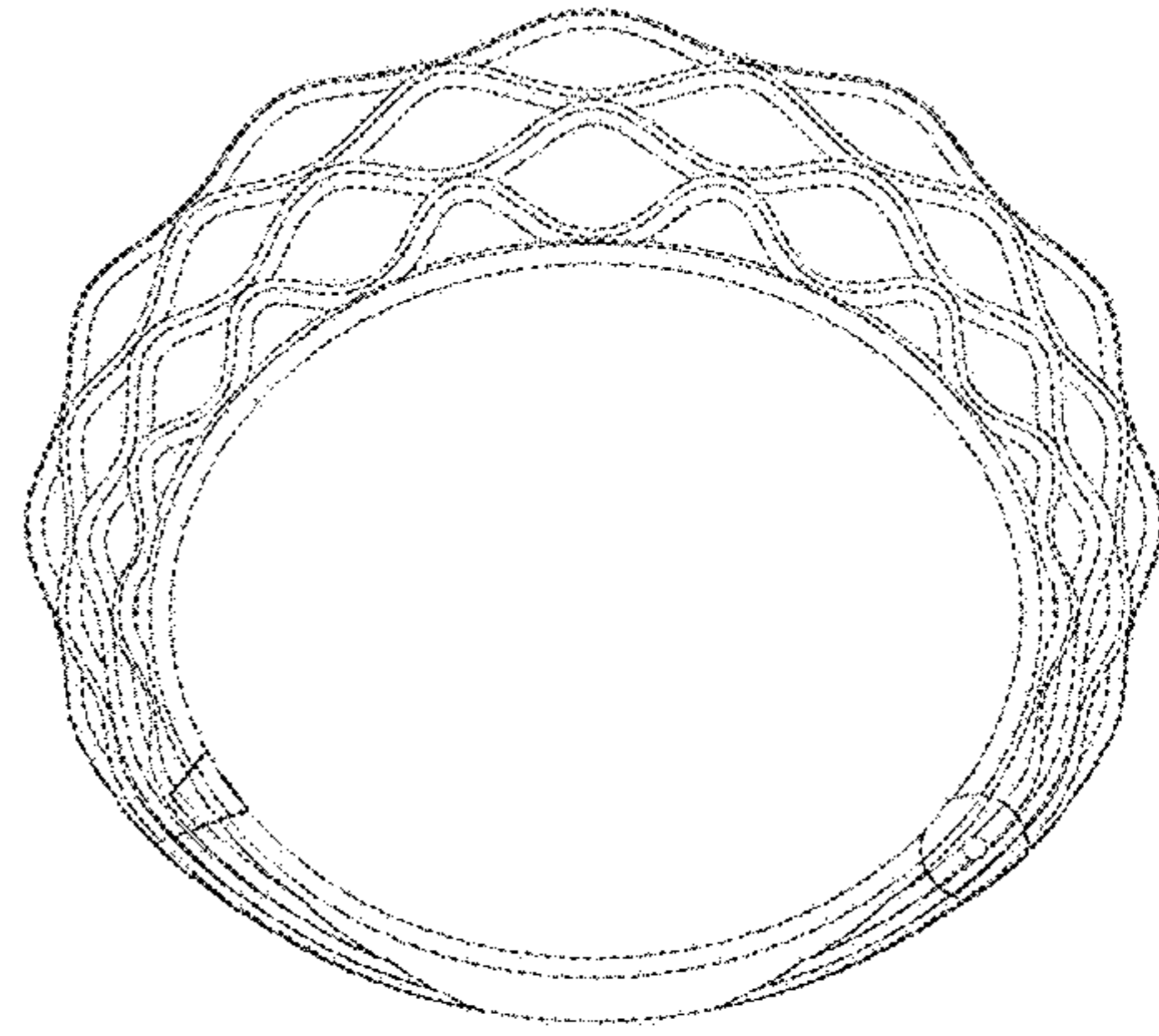

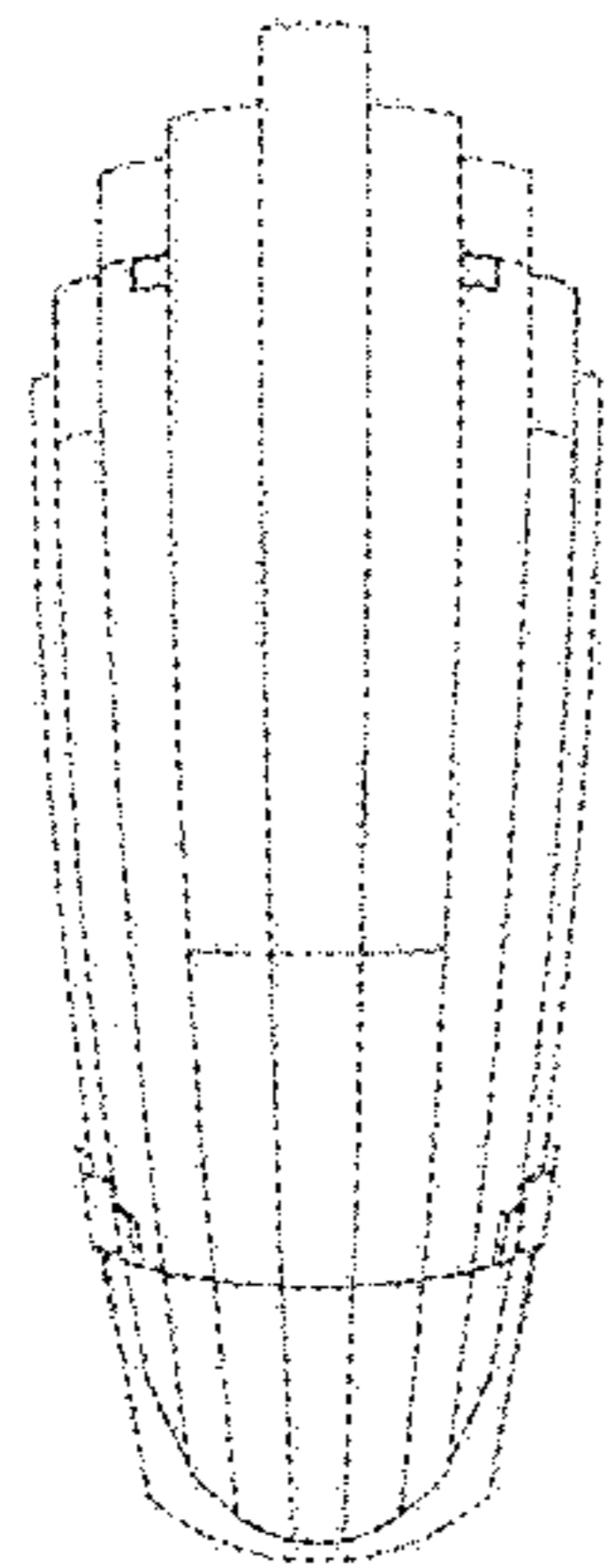

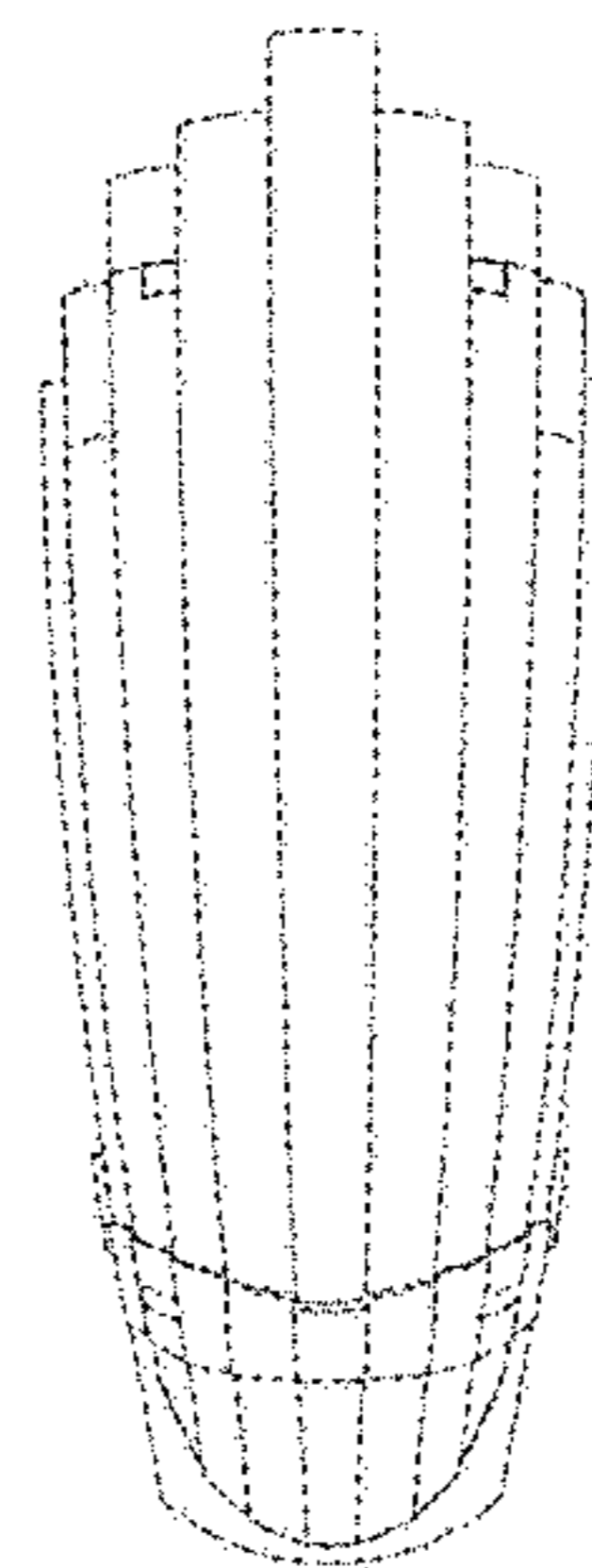

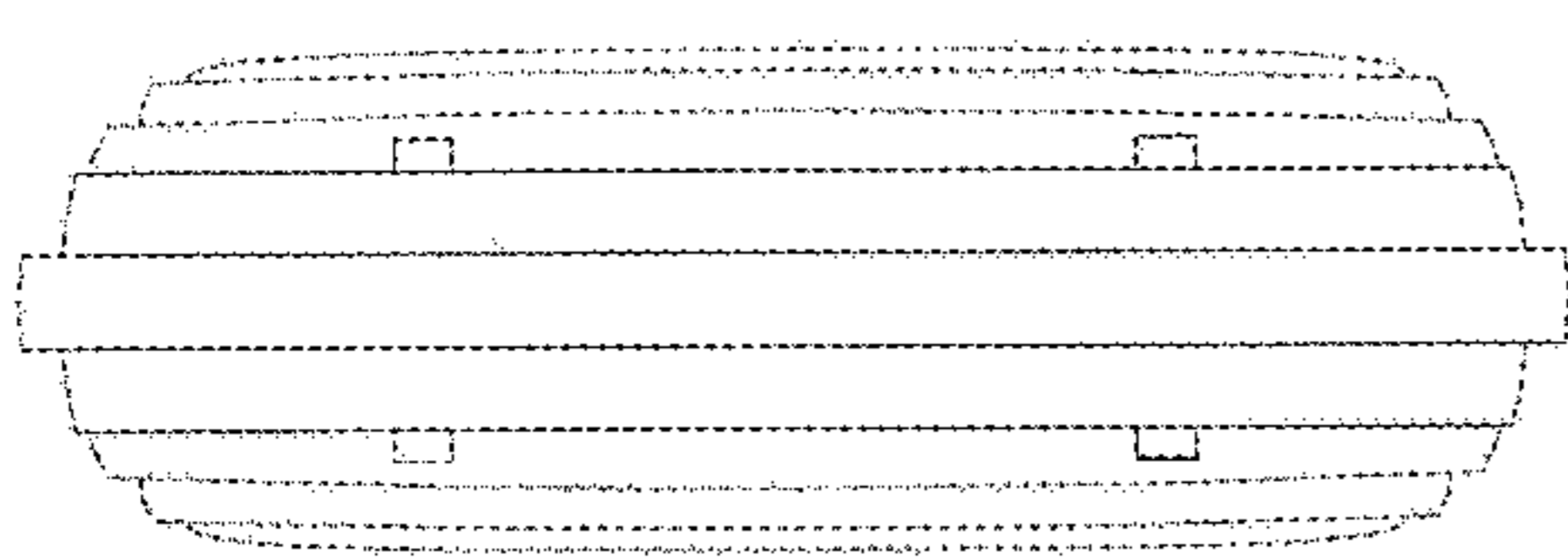

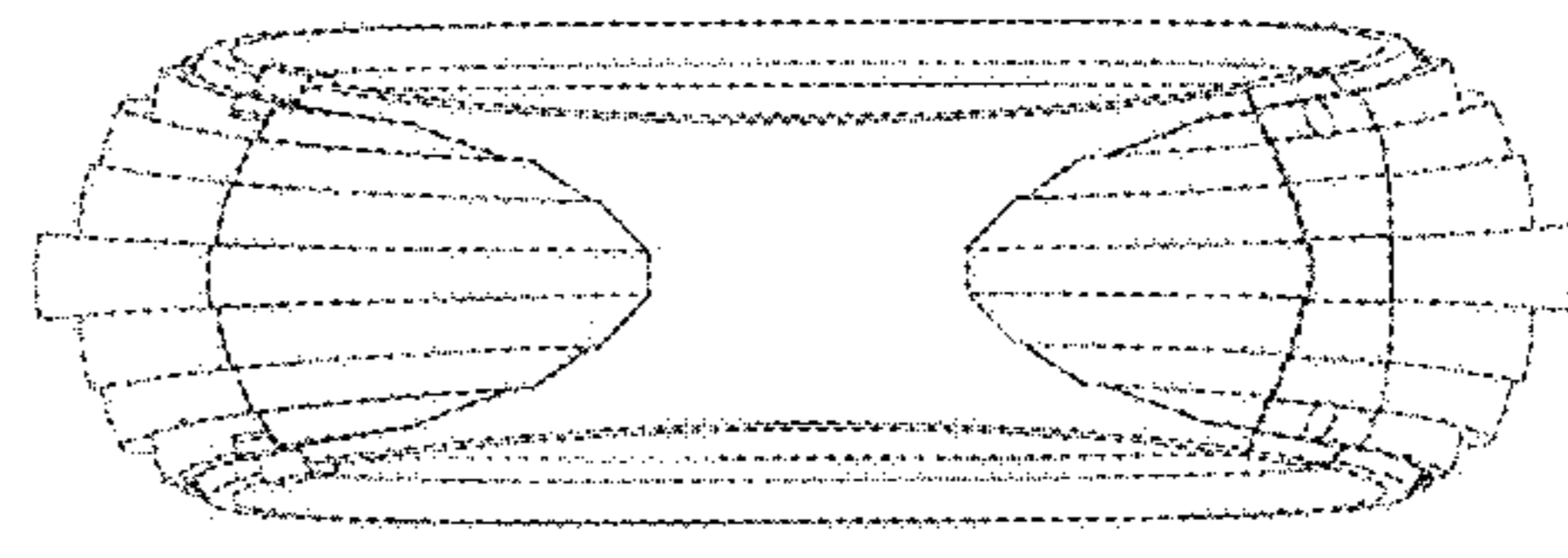

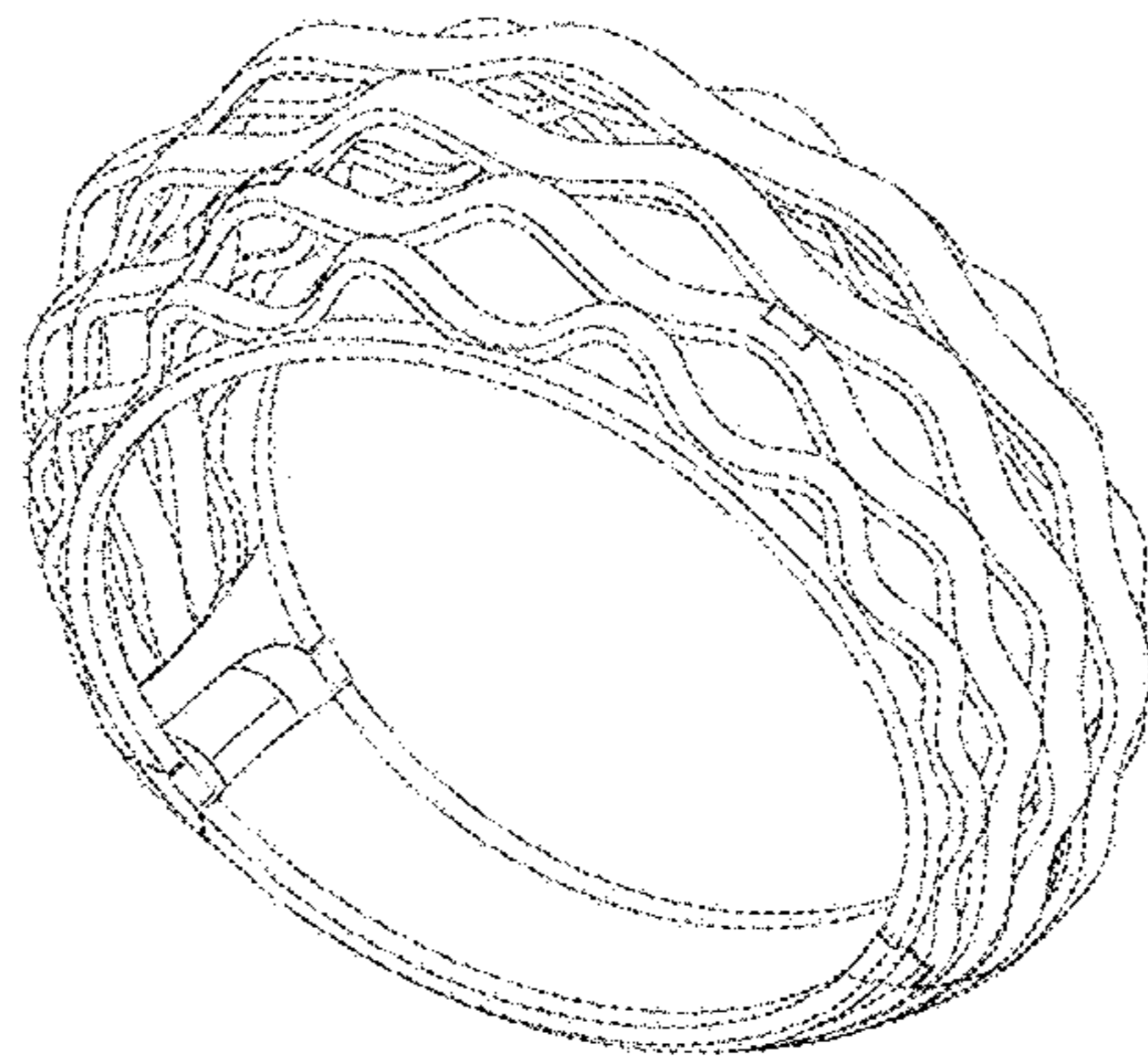
