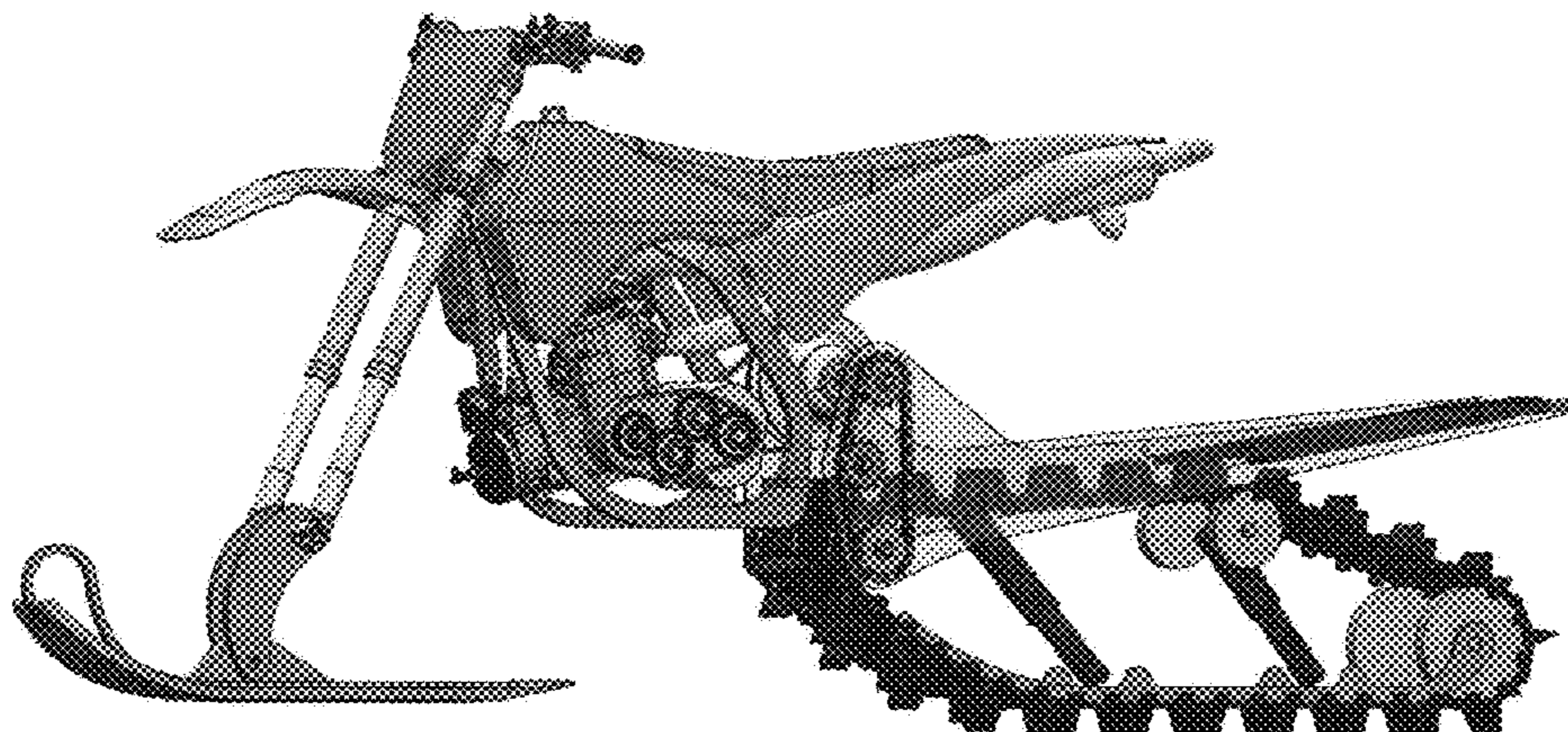
FIG. 1 is a front left perspective view of the snow bike of the present invention;

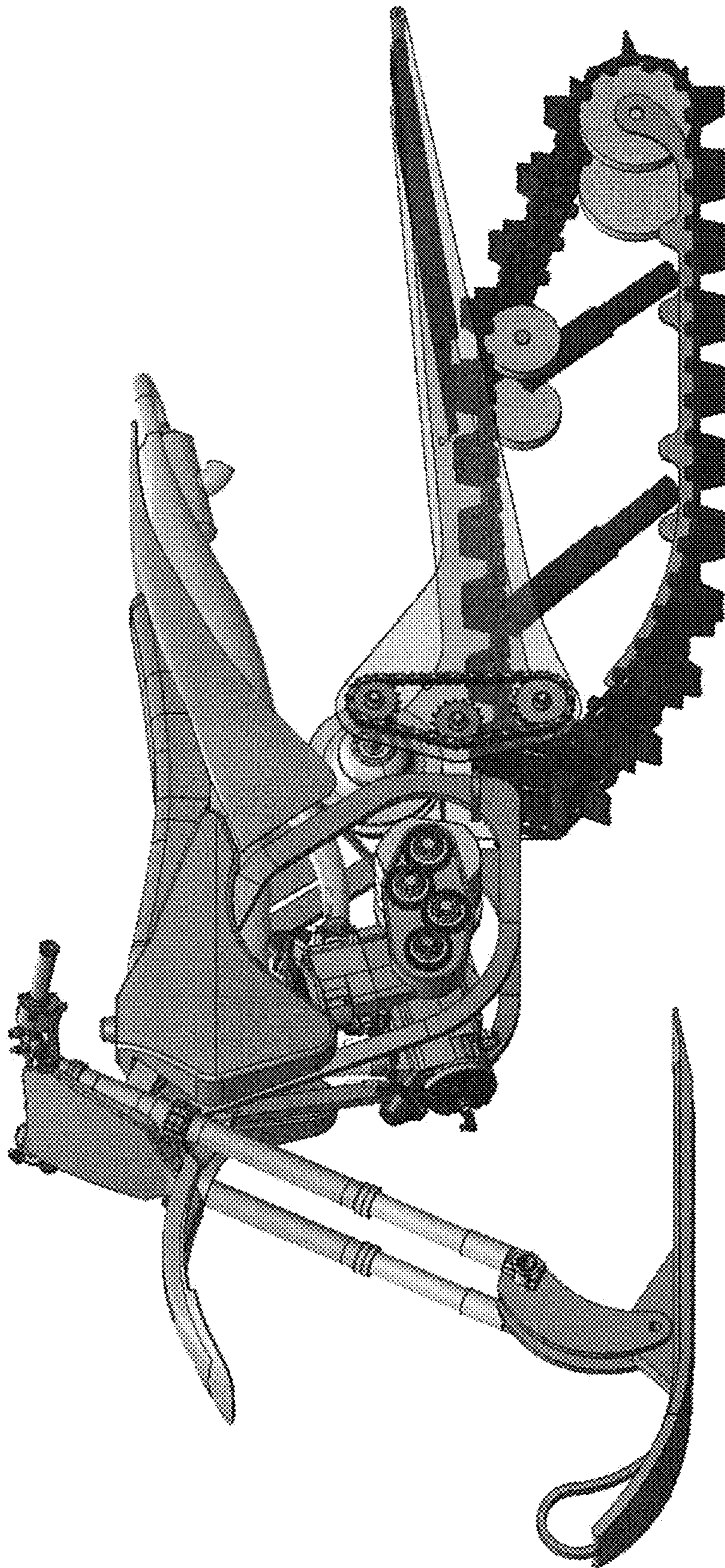

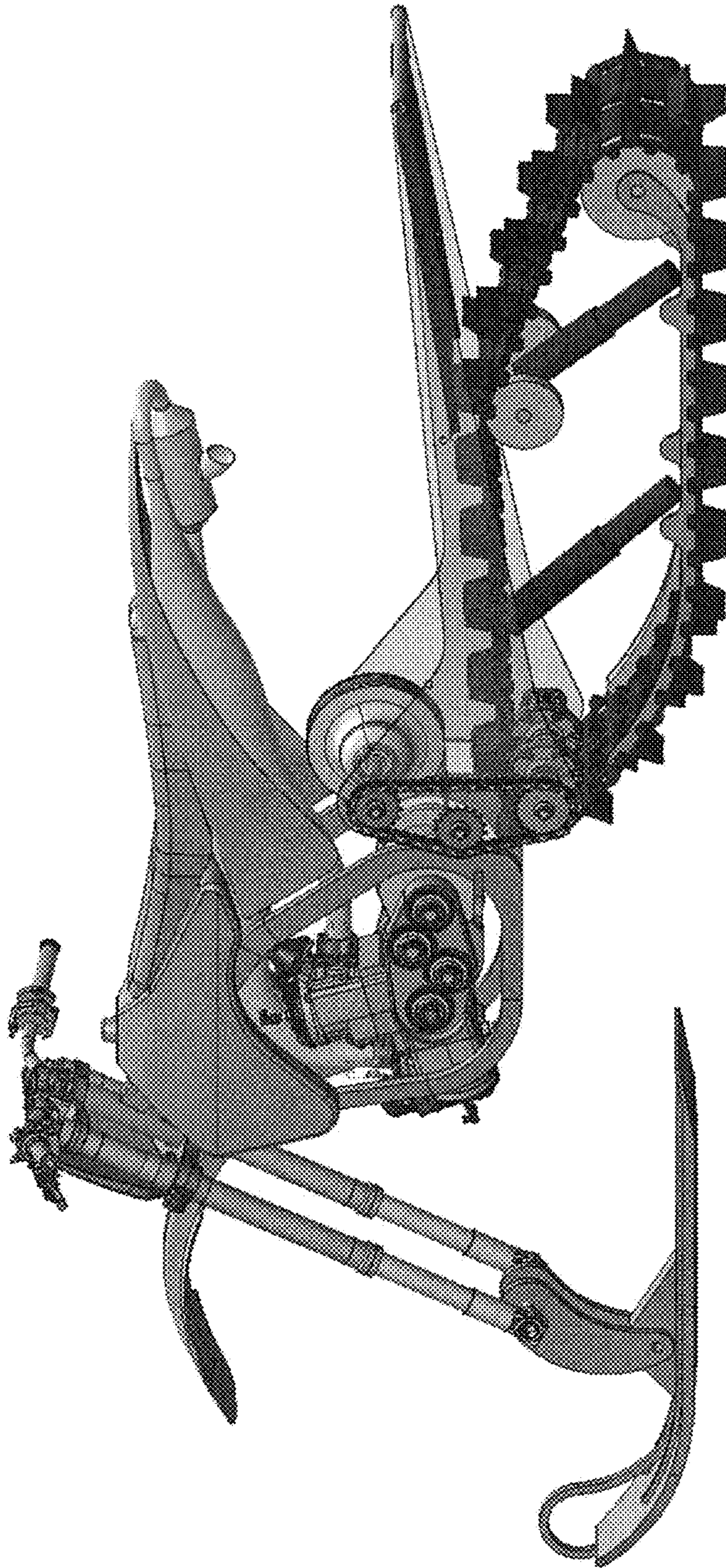

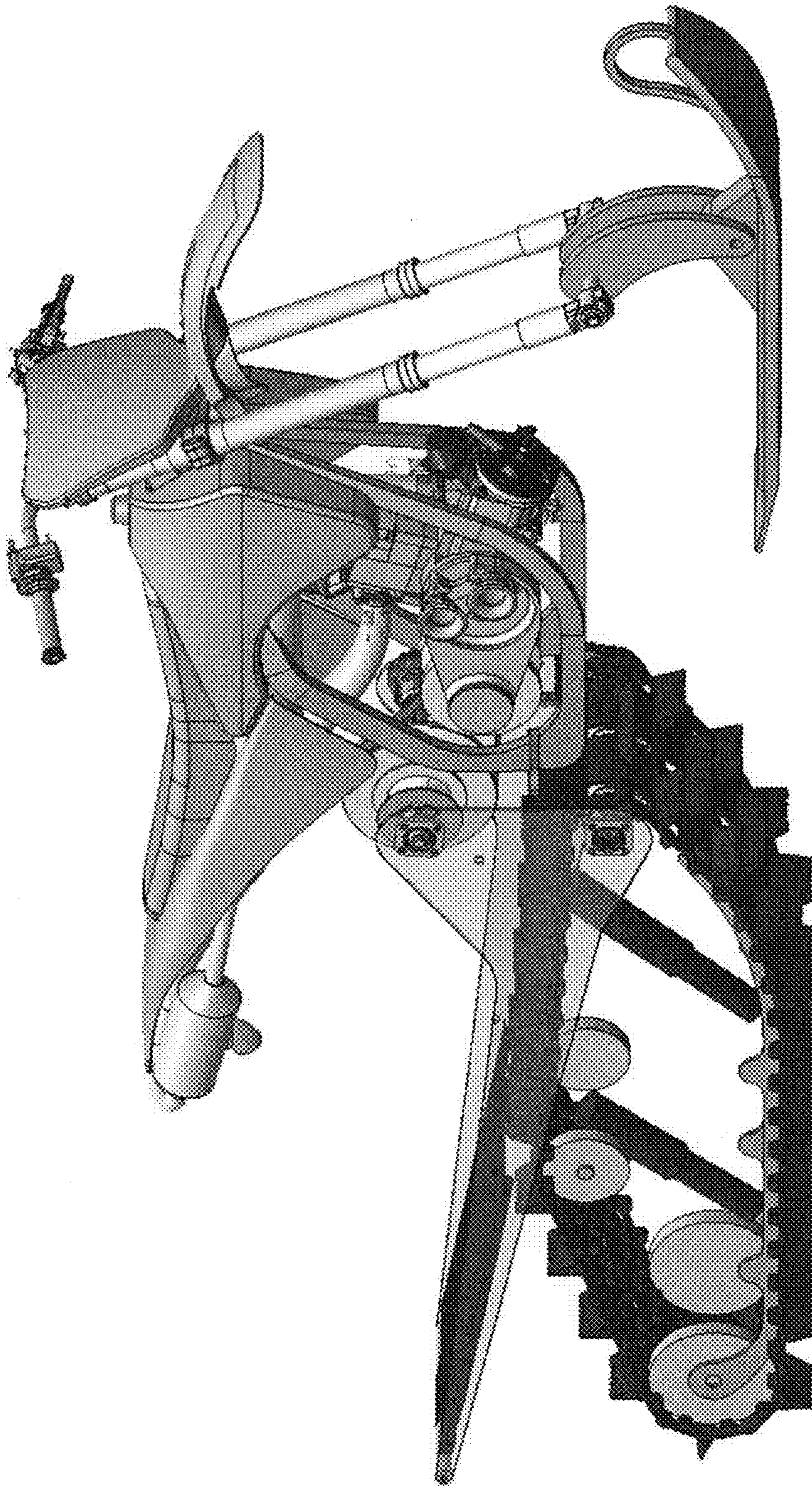

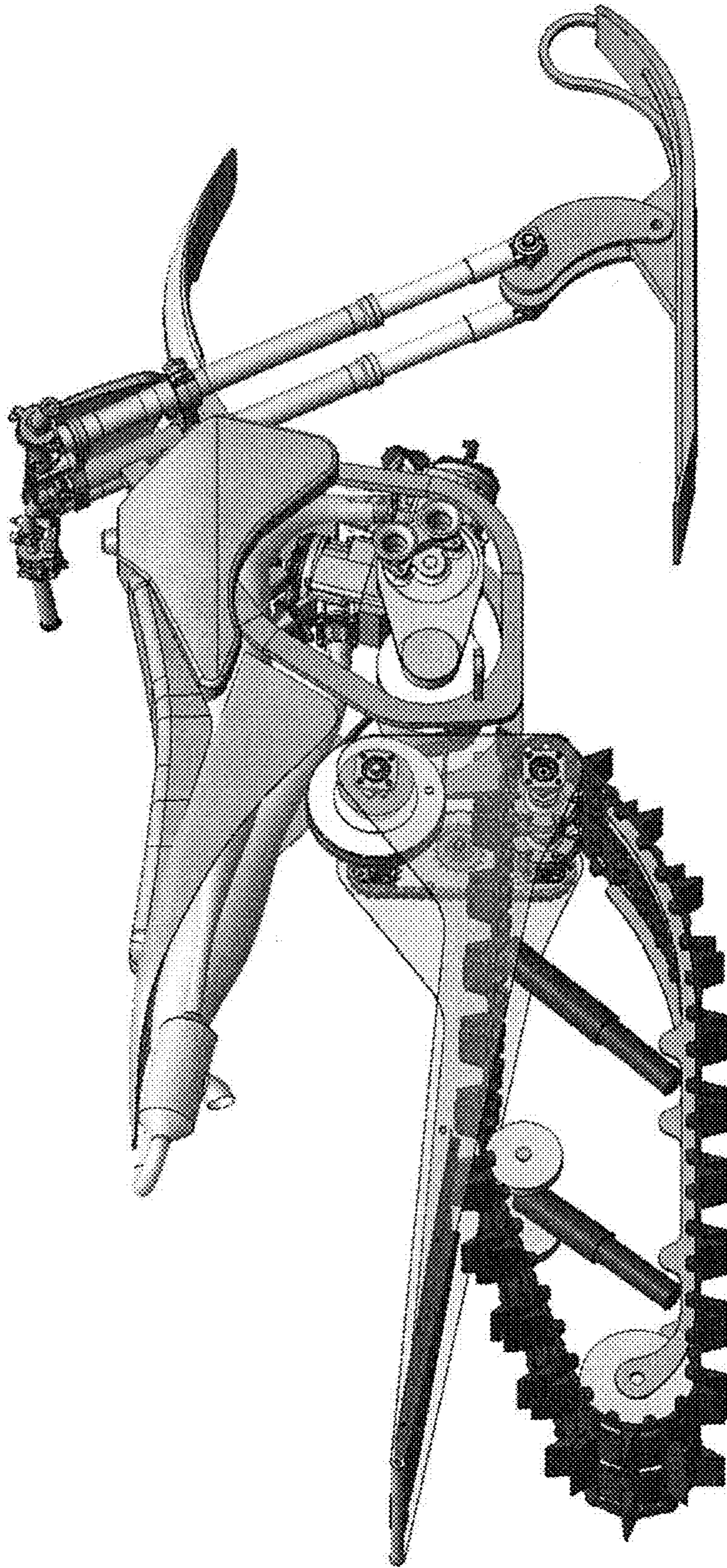

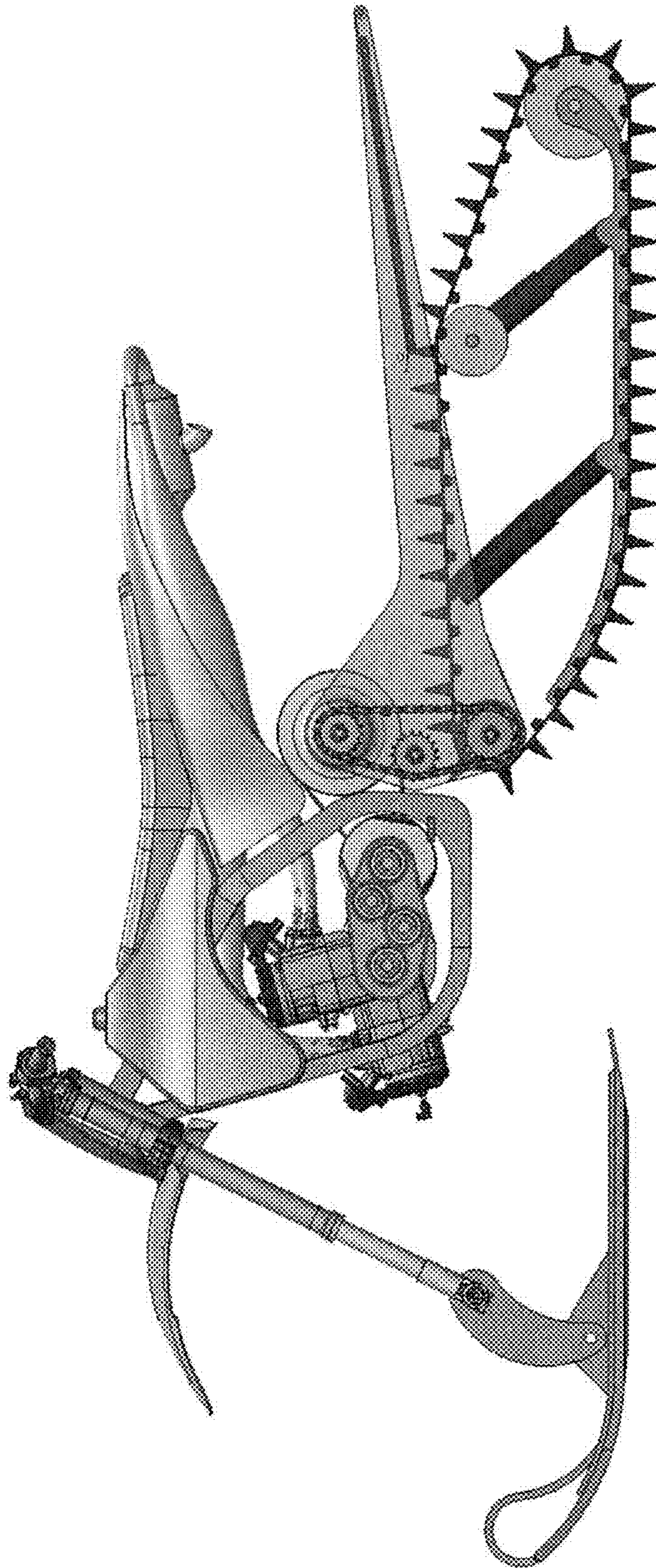

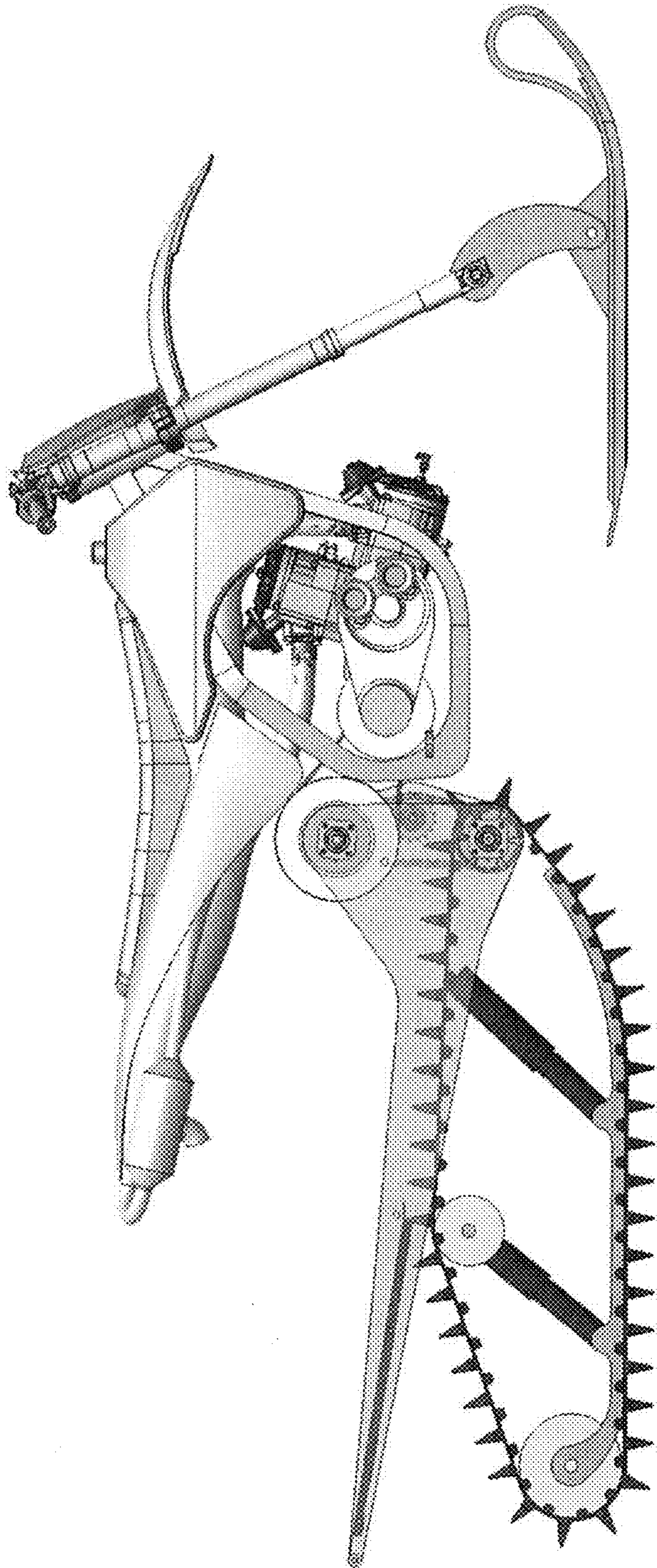

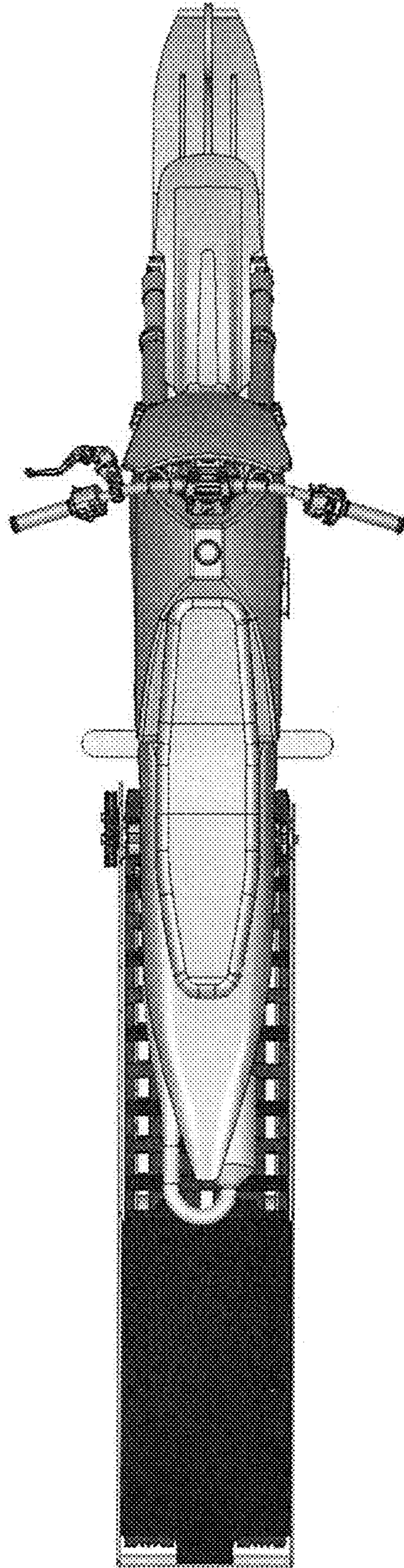

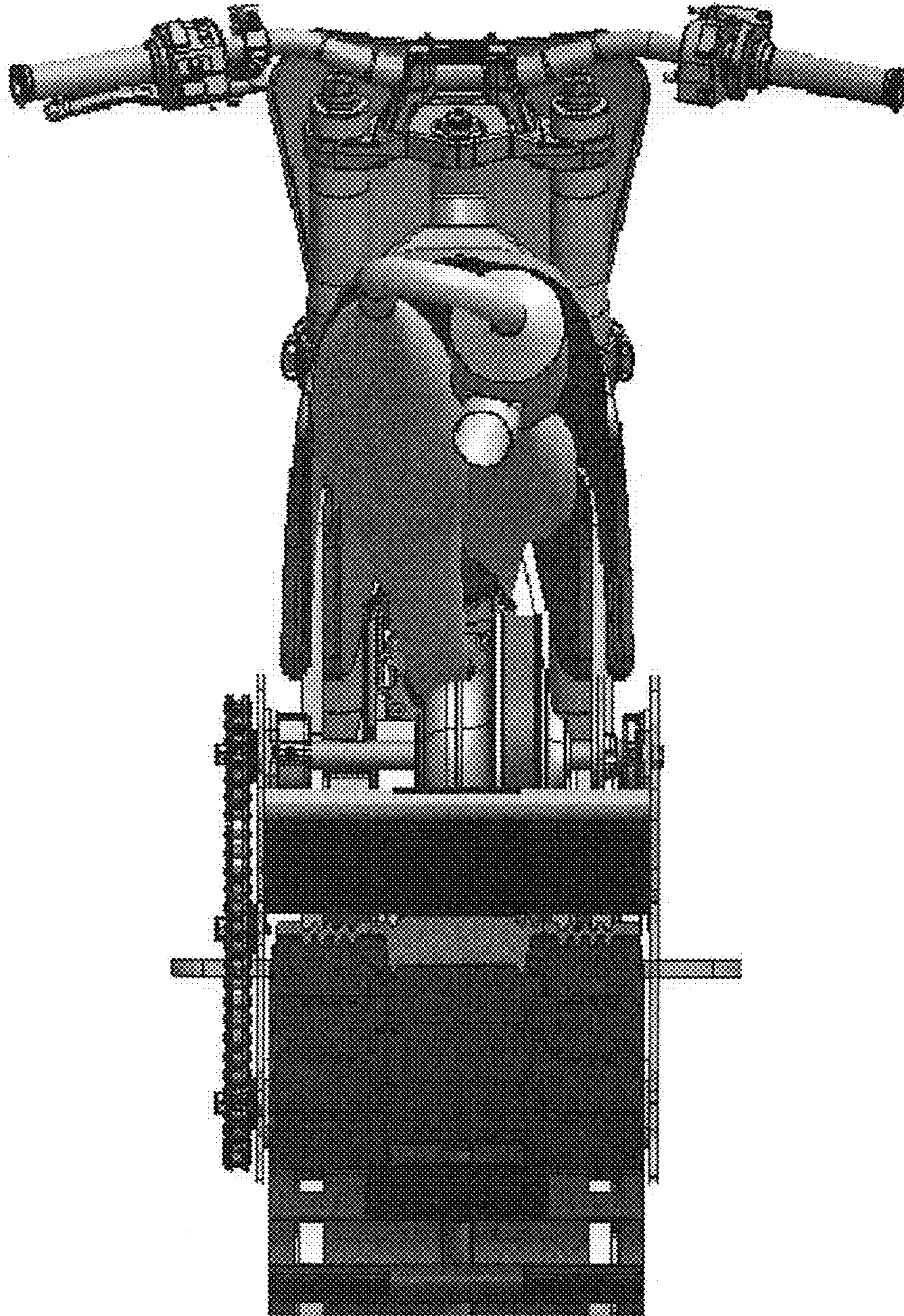

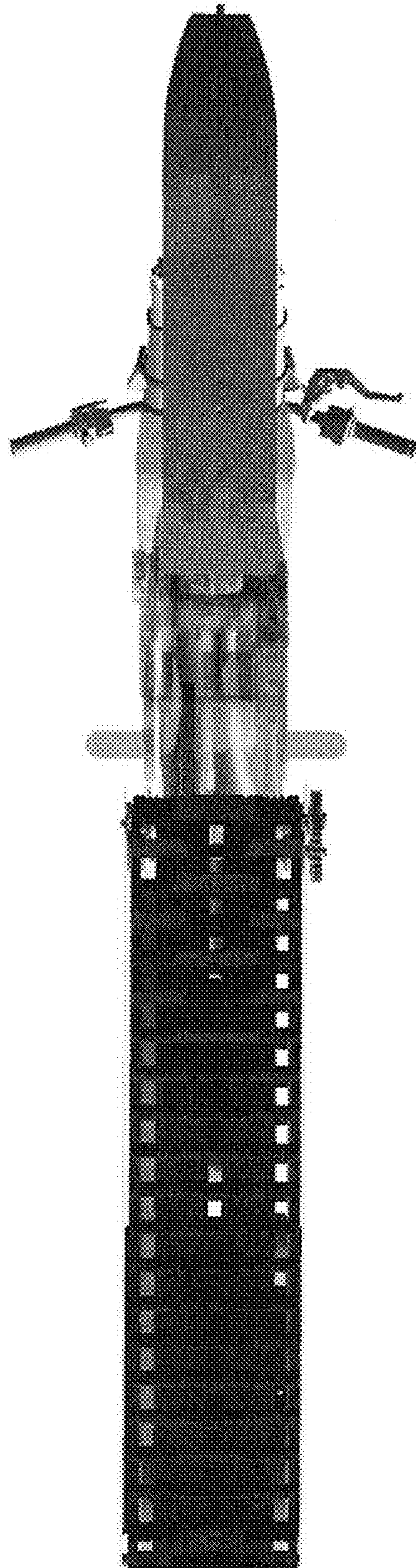

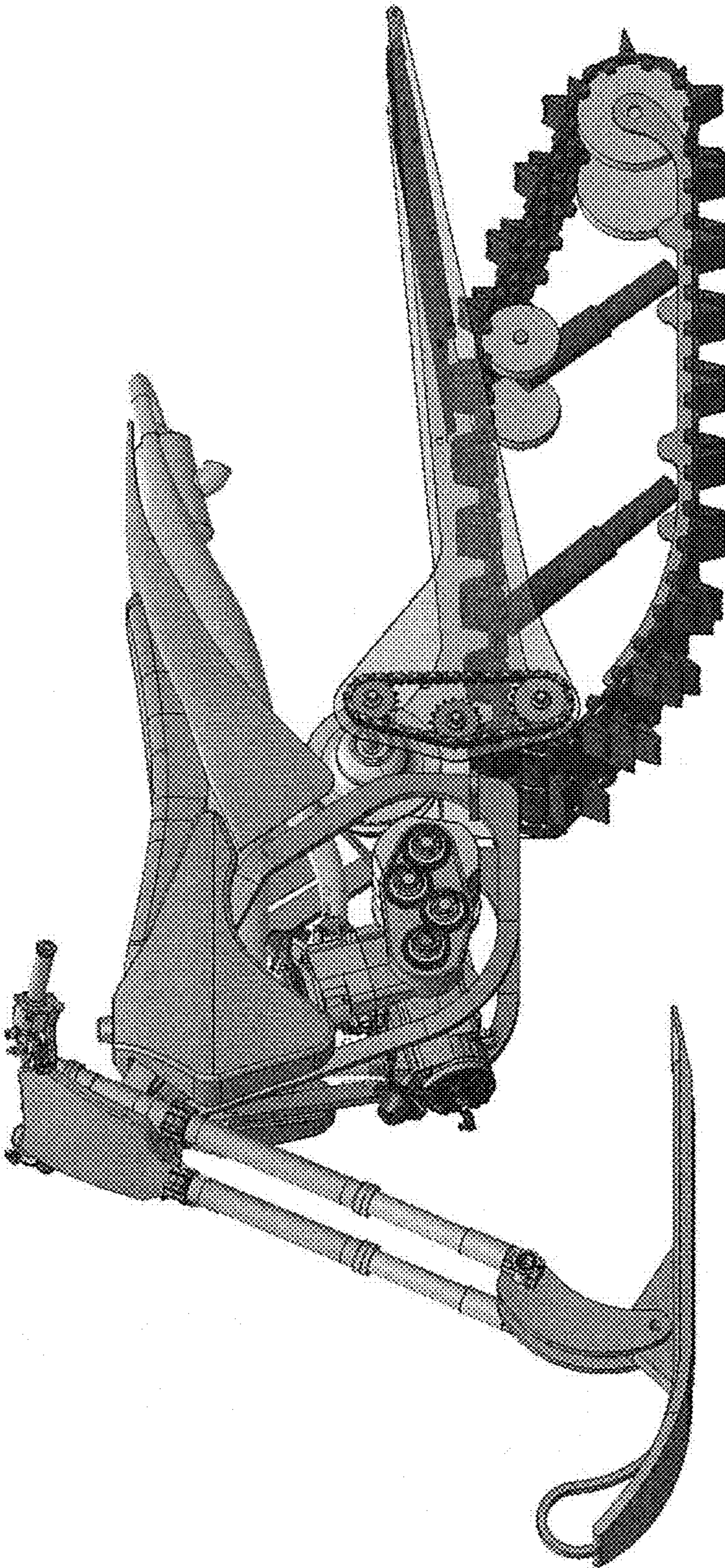
