FIG. 6 is a front elevational view thereof, shown in use.  
In FIGS. 1 through 6, the broken line showing of grille bars and fog lights illustrate portions of the automobile grille or replica thereof that form no part of the claimed design. In FIGS. 5 and 6, the broken line showing of an automobile illustrates environmental structure.

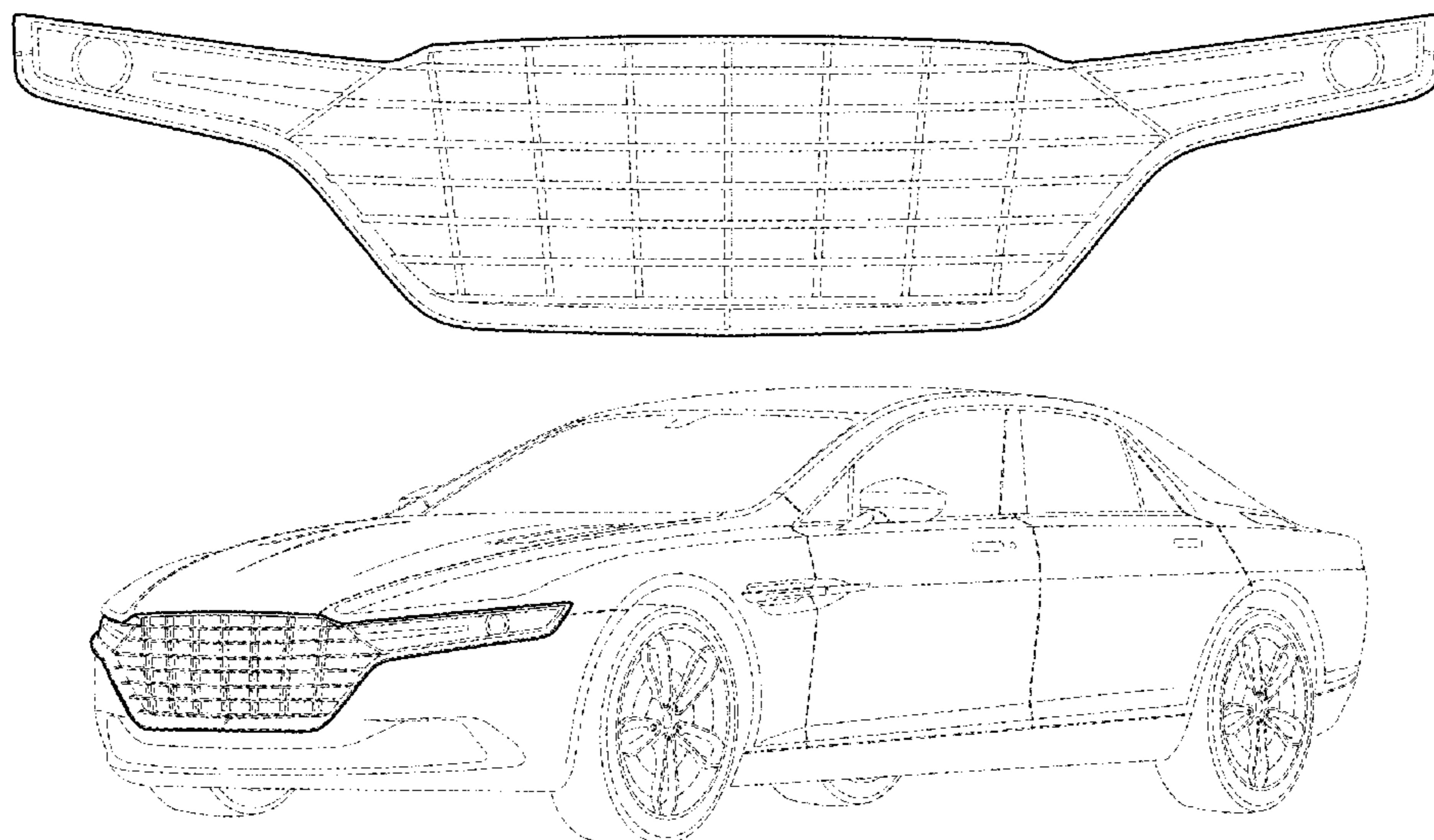

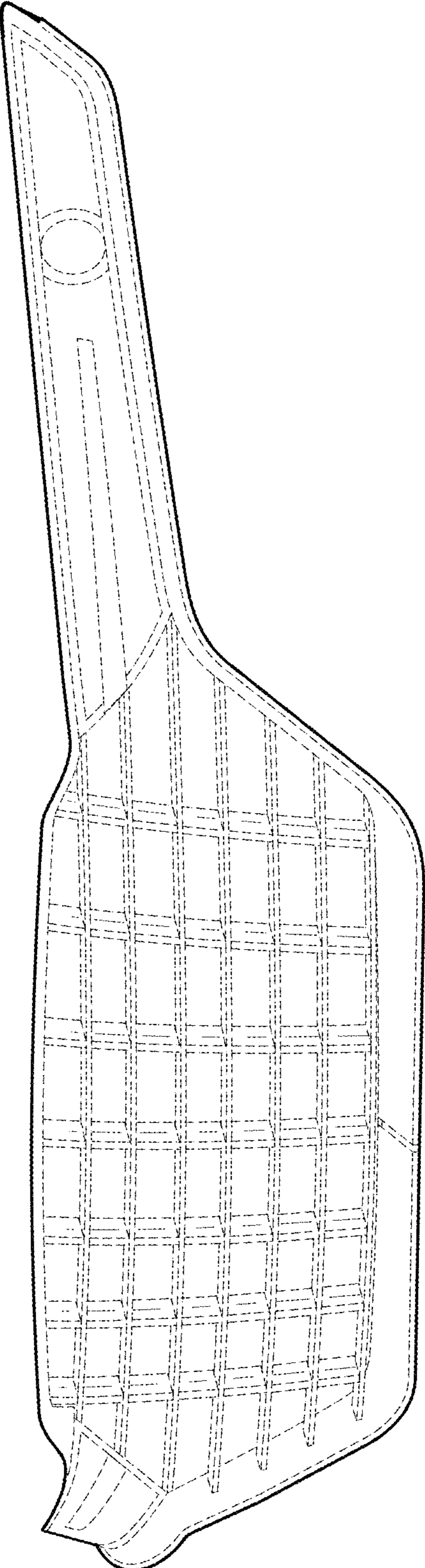

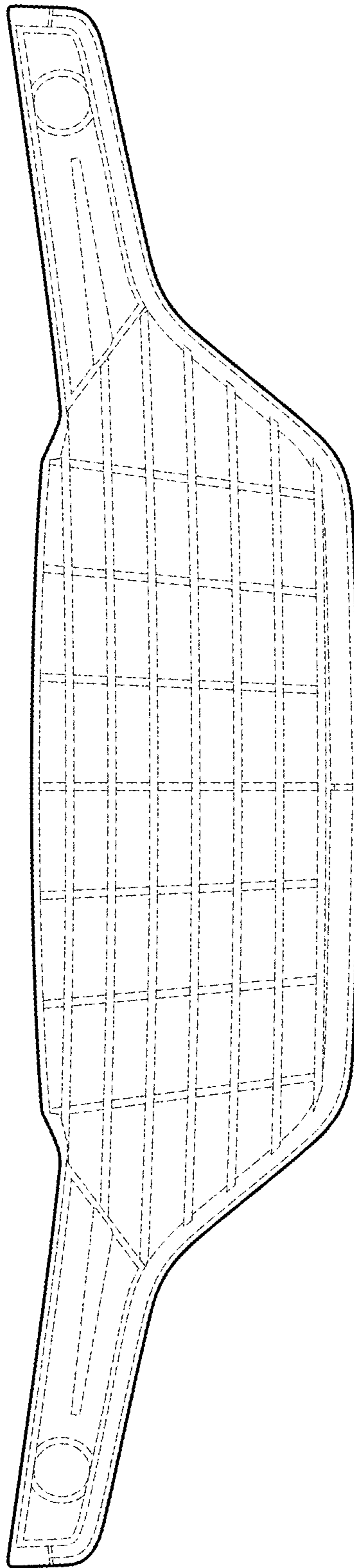
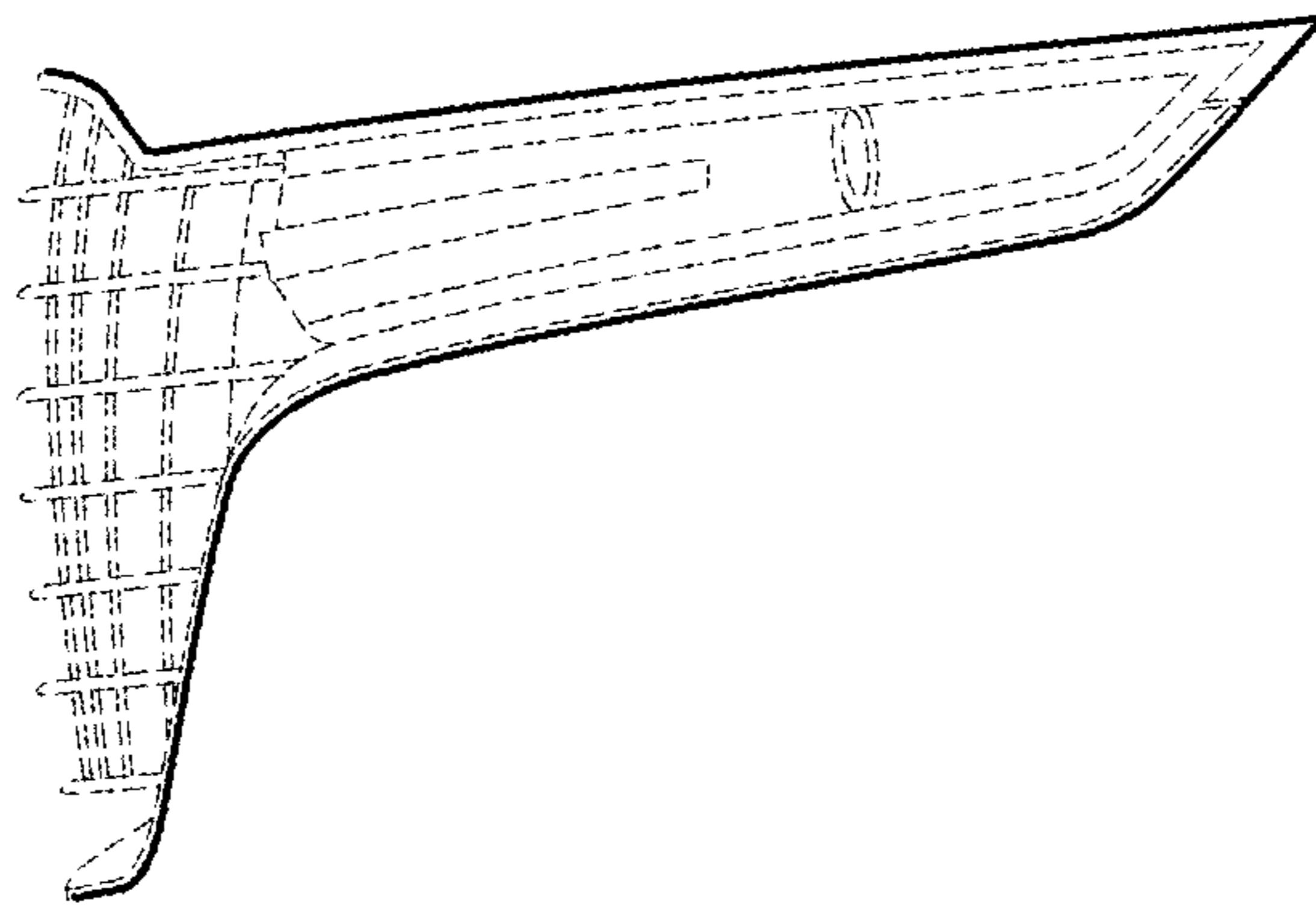

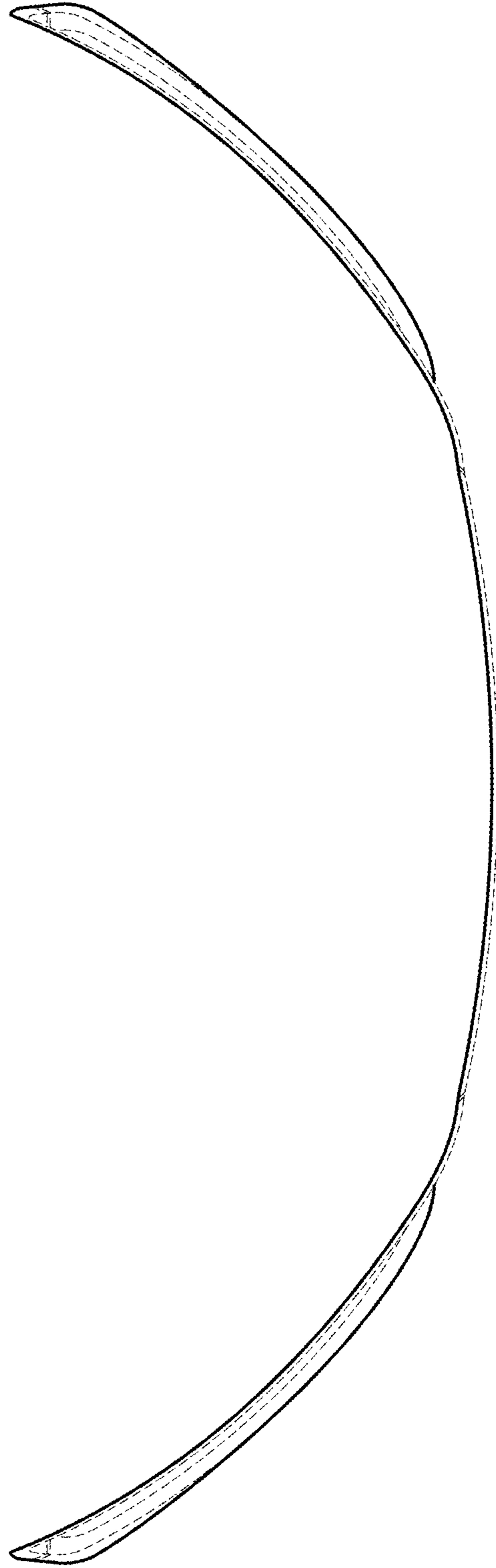

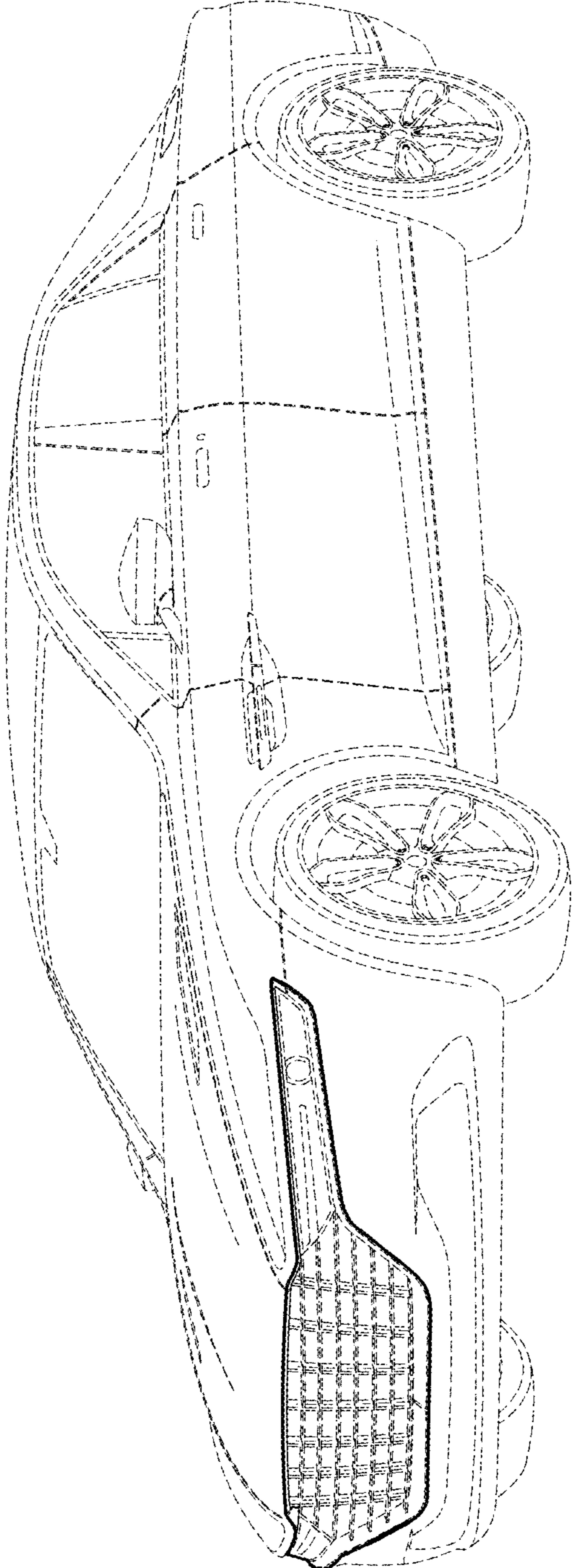

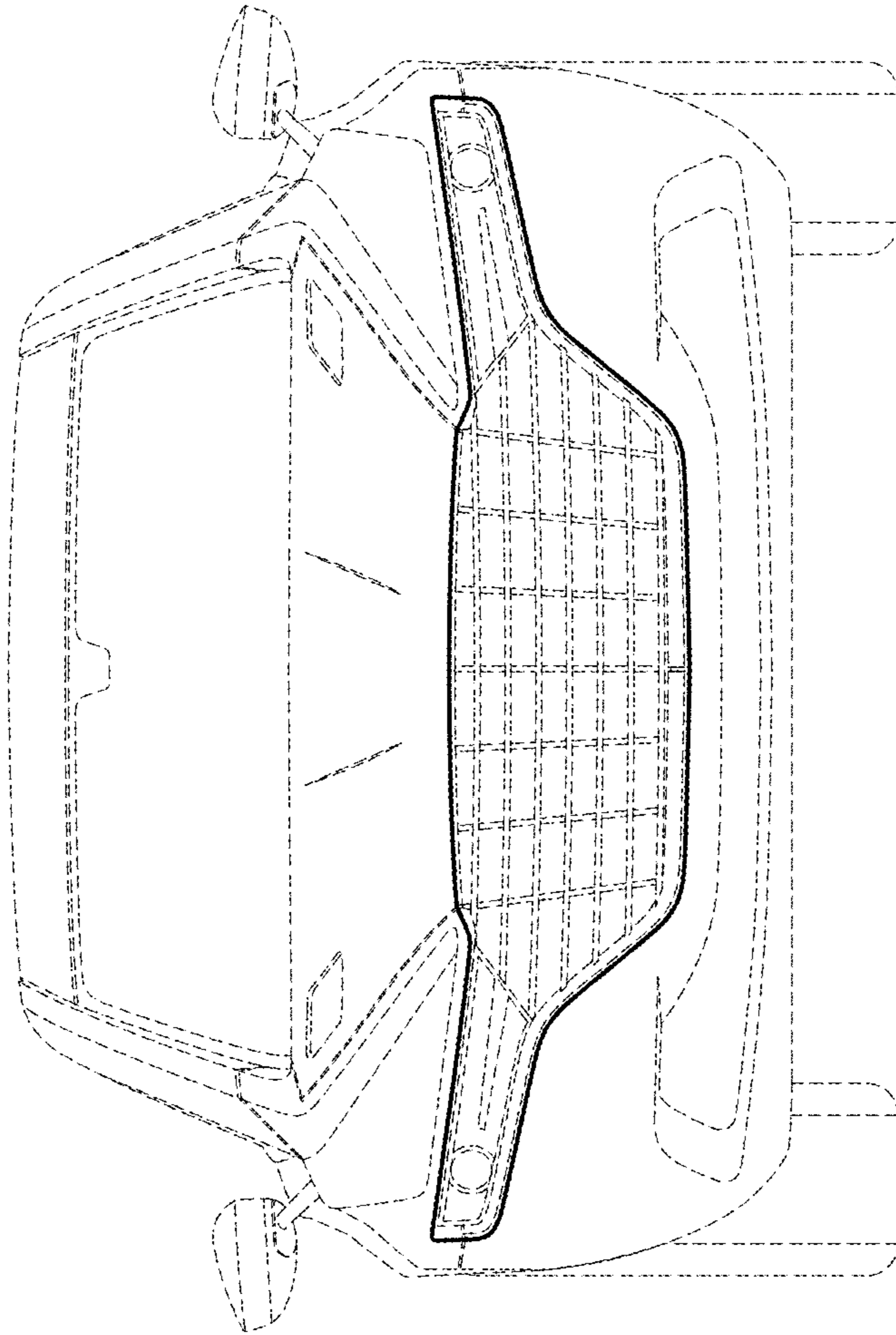
