FIG. 5 is a left elevation view thereof.

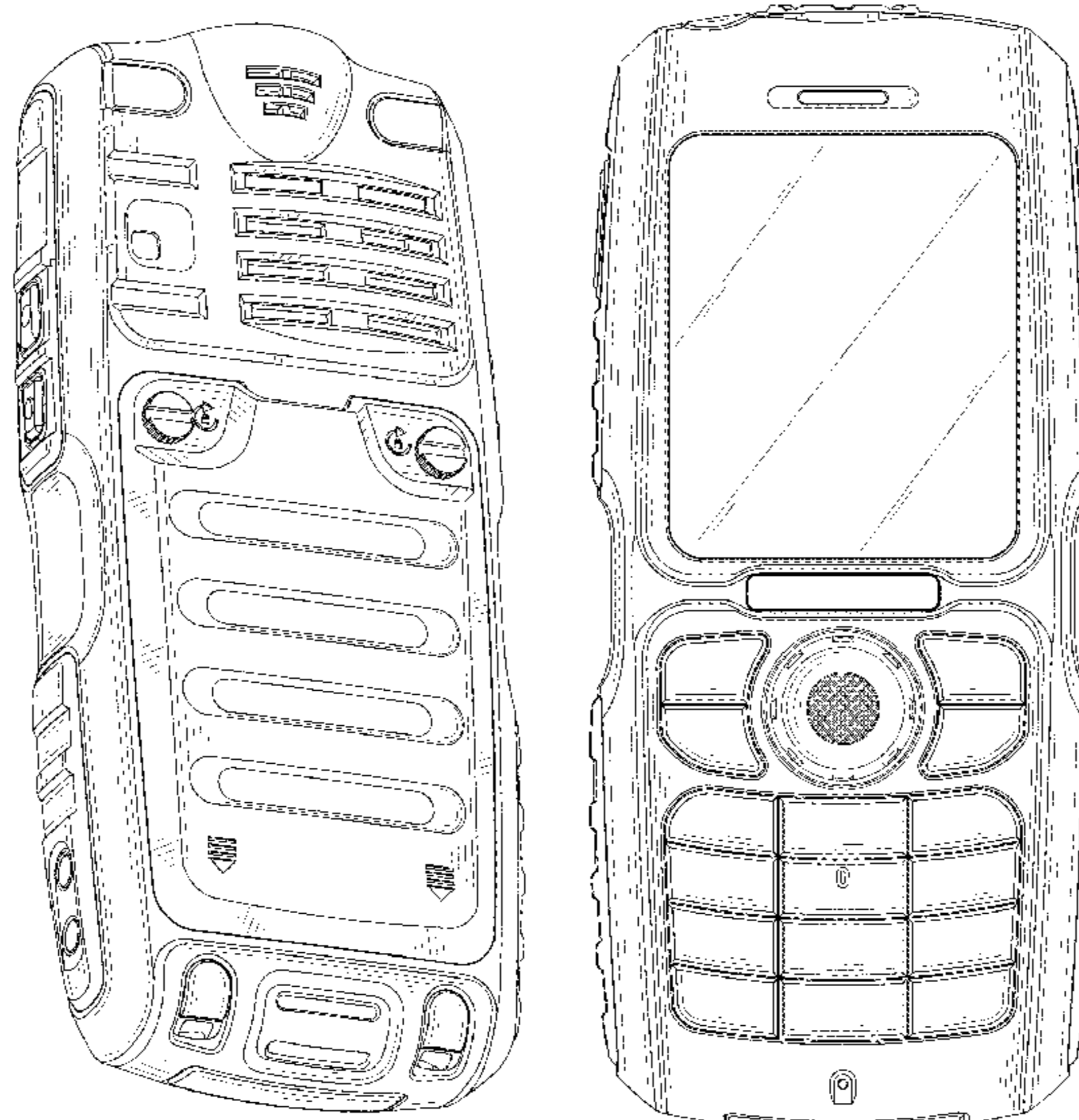
FIG. 6 is a right elevation view thereof.

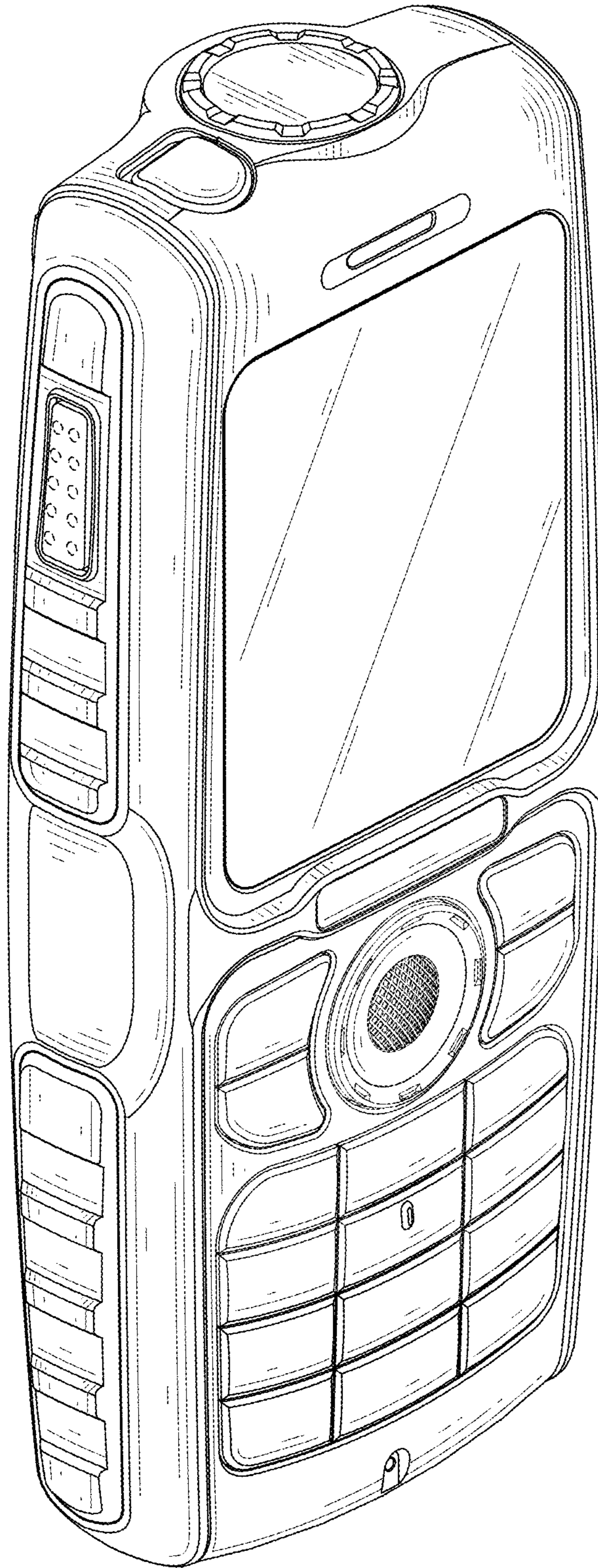

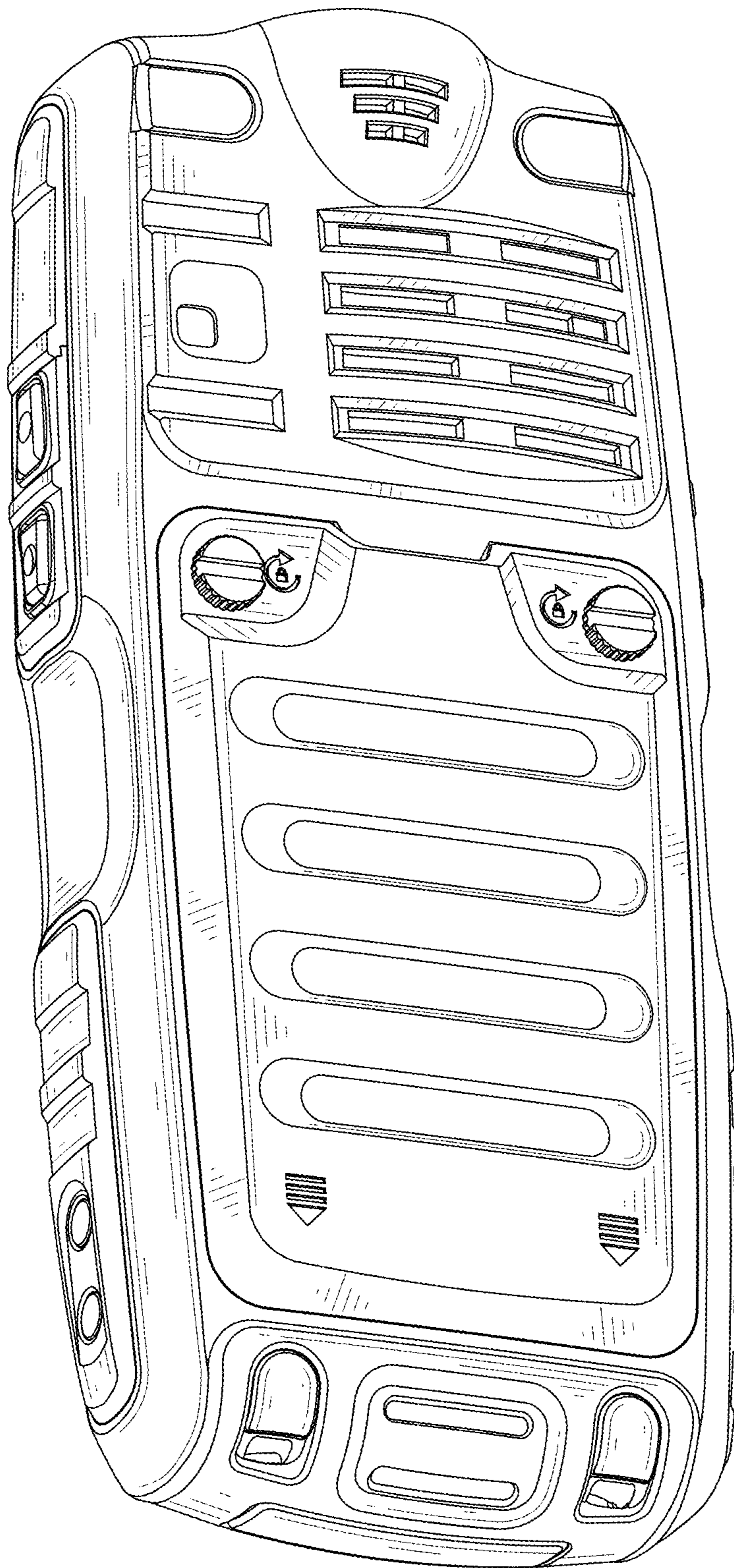

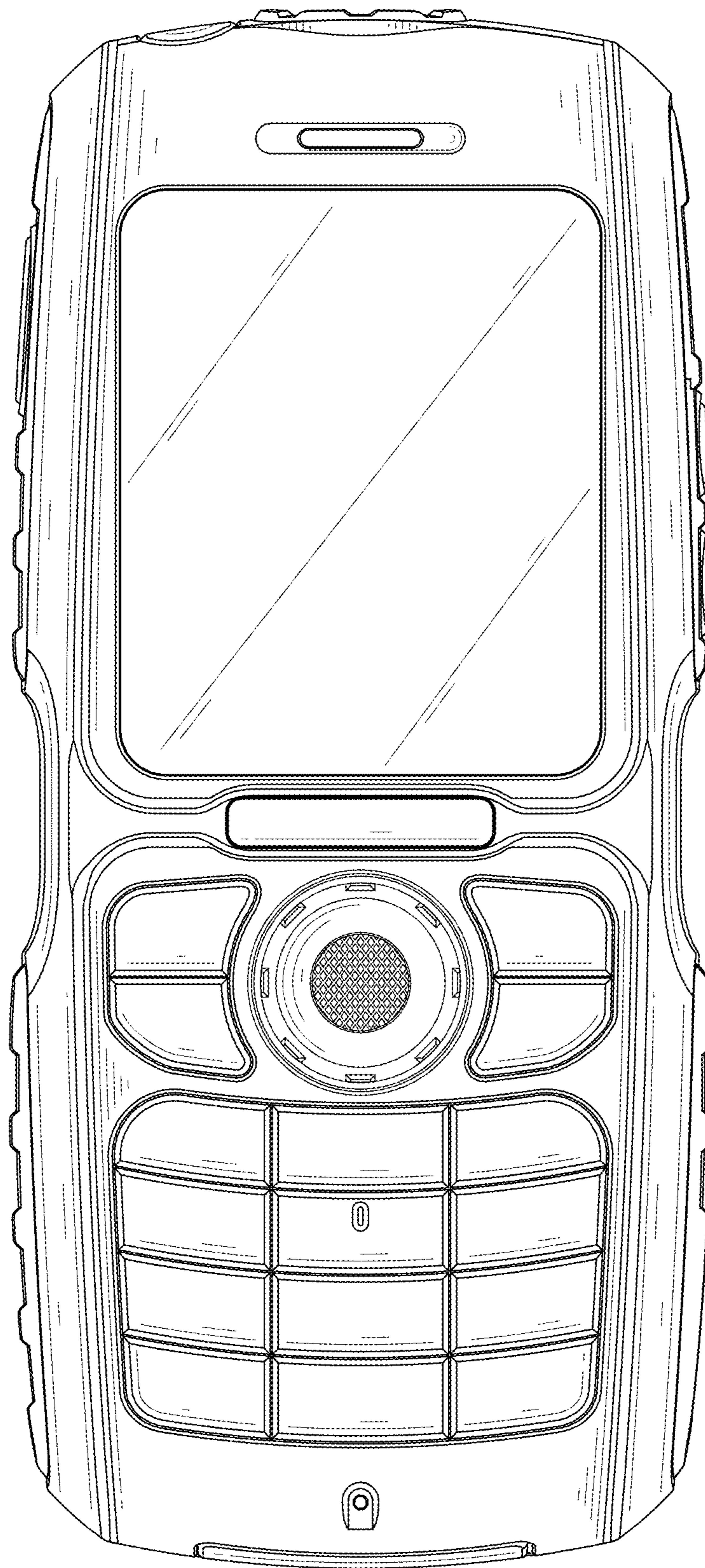

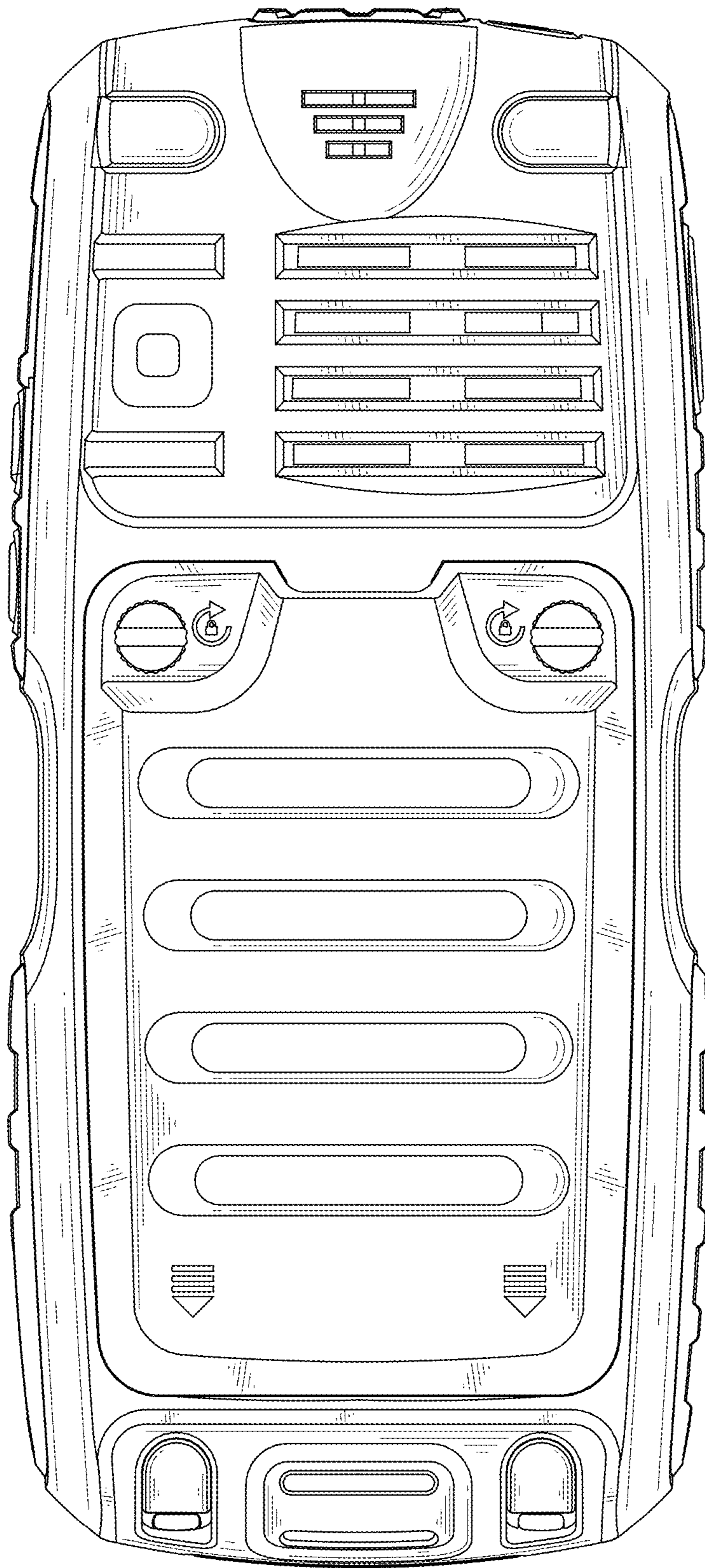

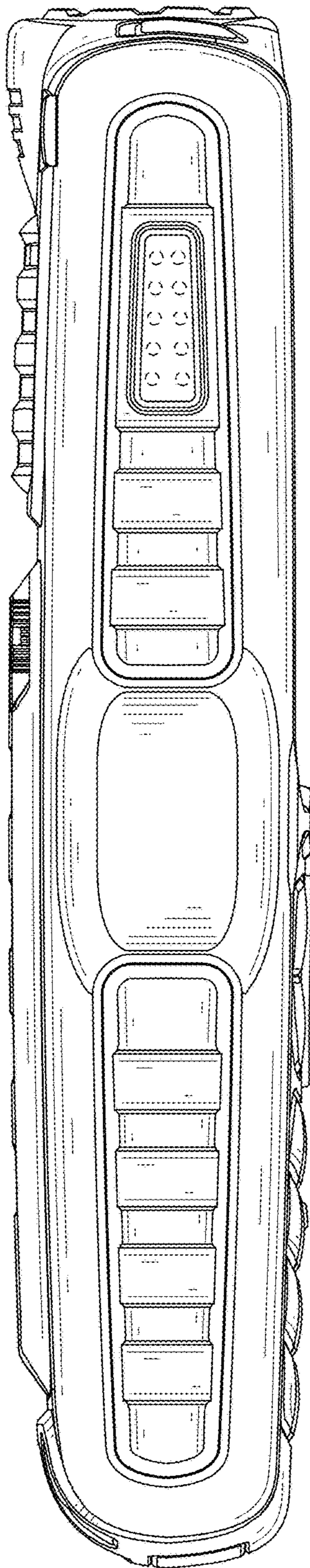

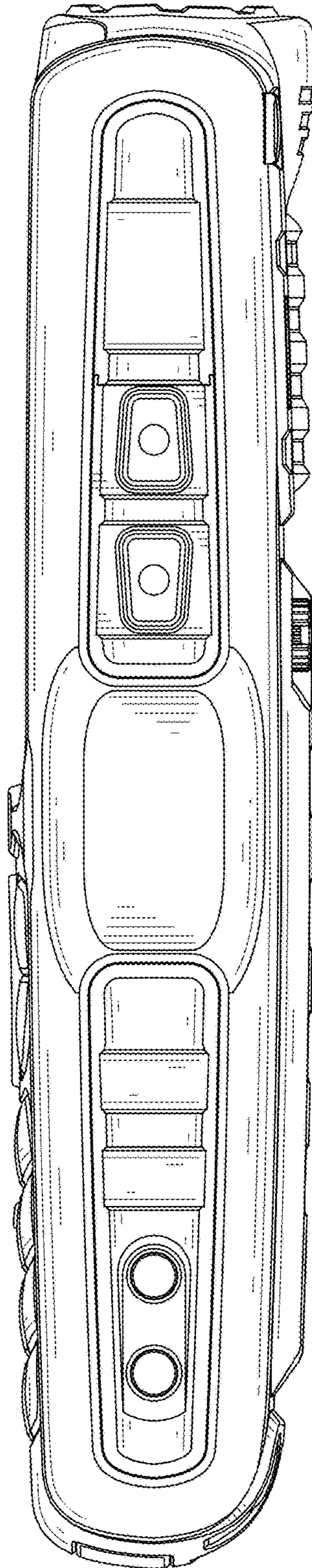

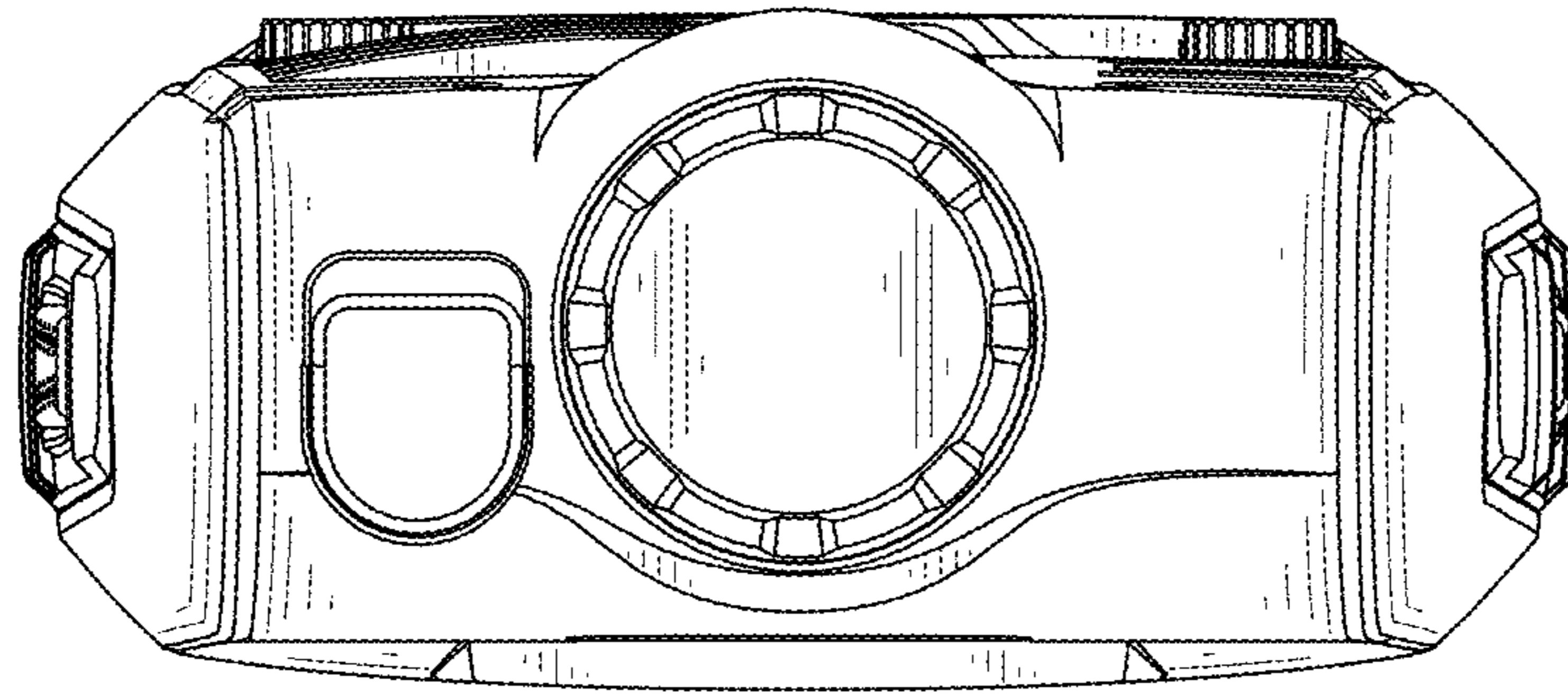

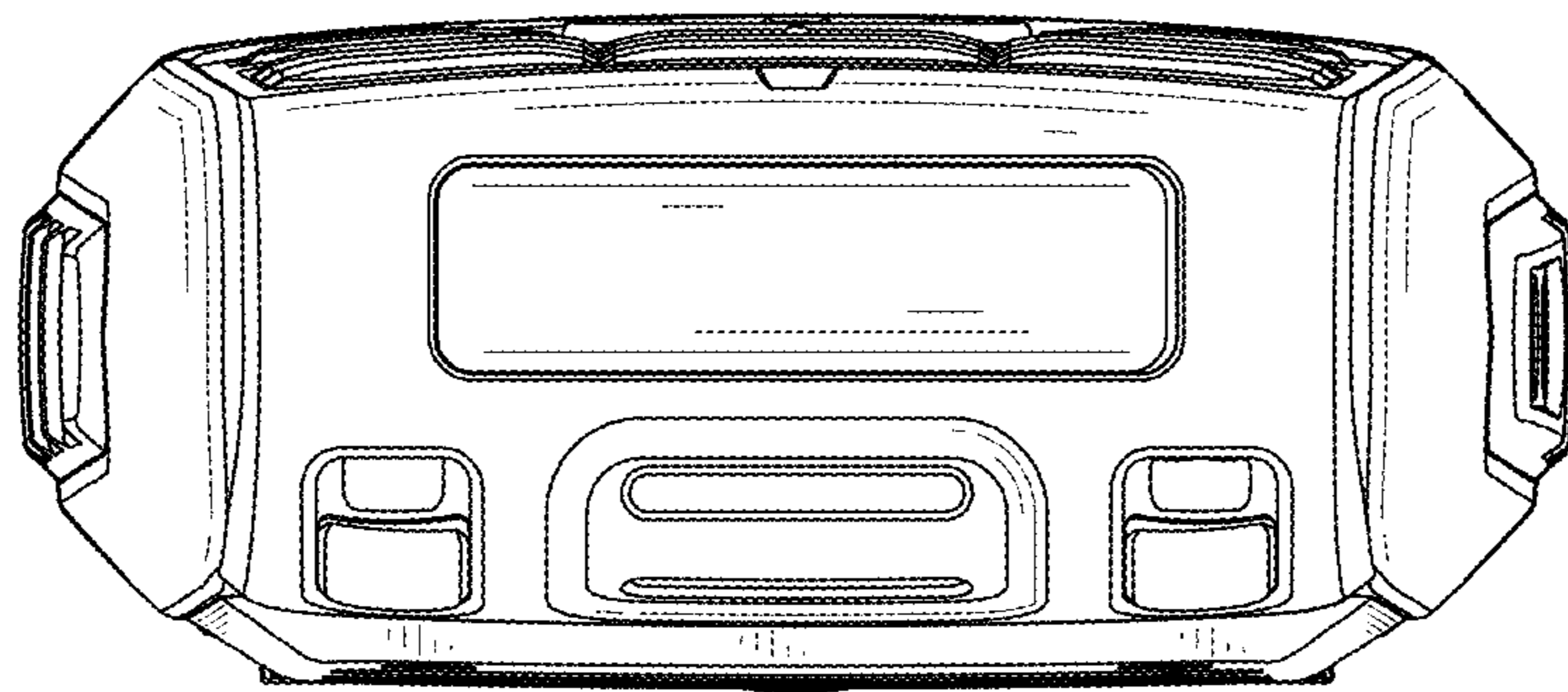
