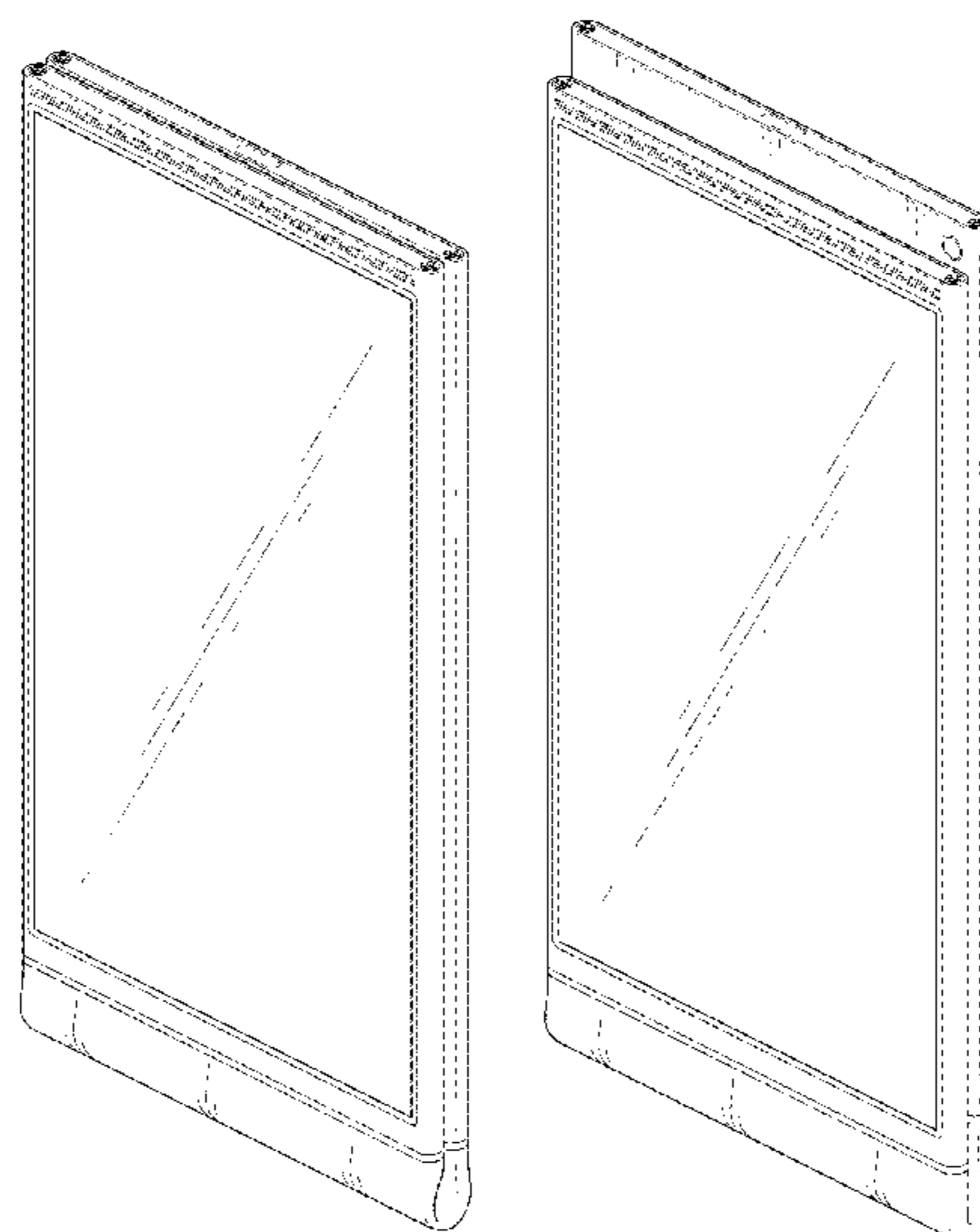
(57) **CLAIM**

The ornamental design for a cellular phone, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right side, perspective view of a cellular phone showing our new design;

FIG. 13 is a top view with the slid-up rear body thereof; and,  
FIG. 14 is a bottom view with the slid-up rear body thereof.

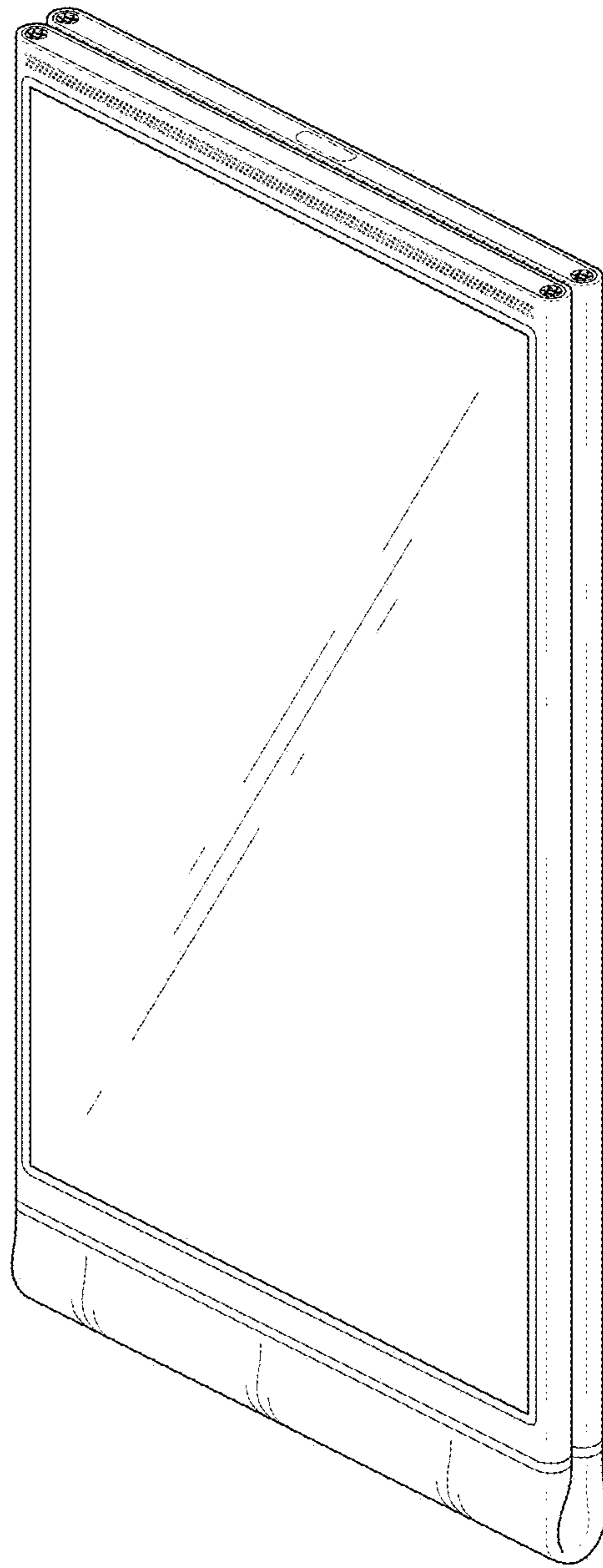

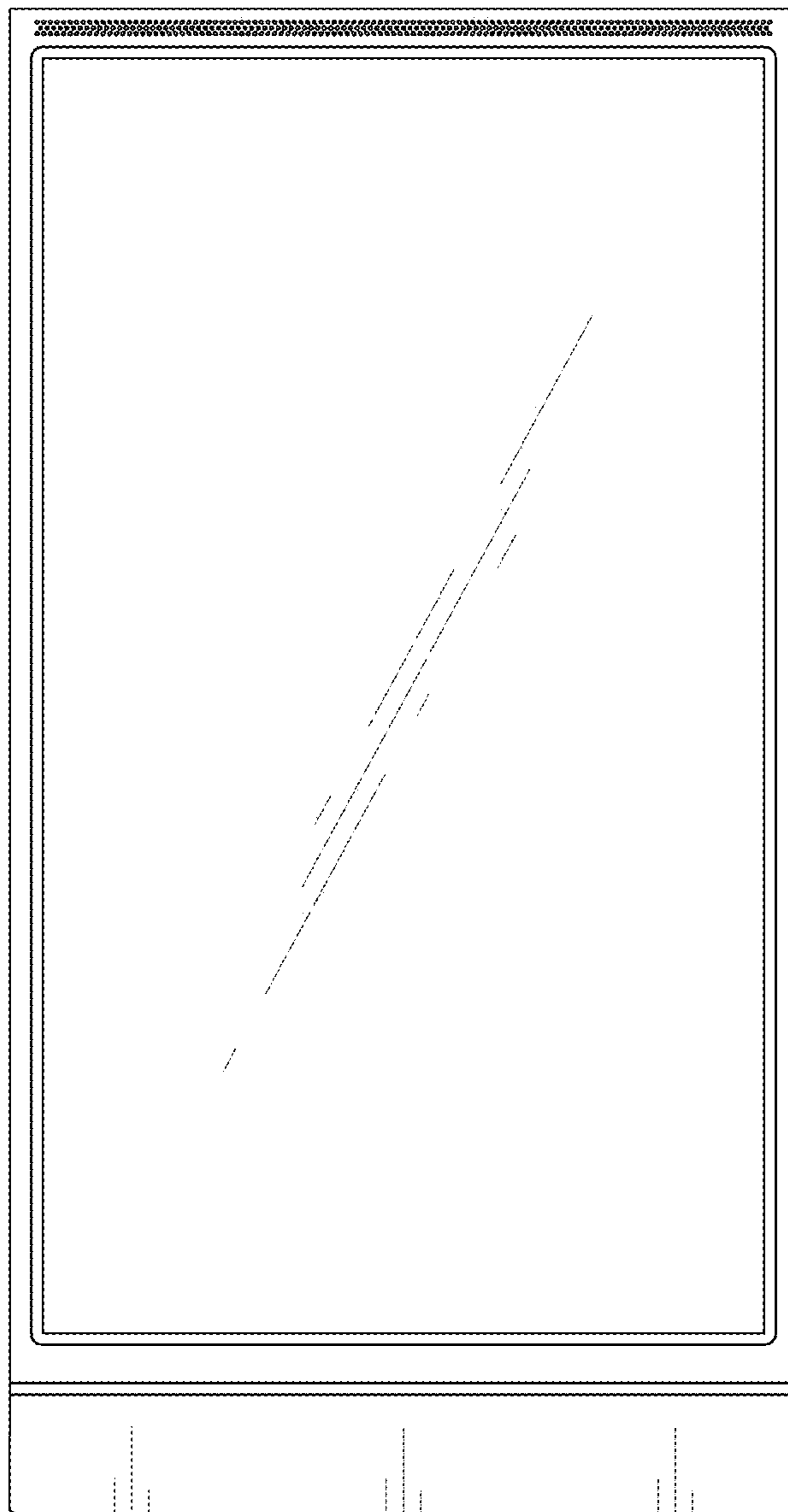

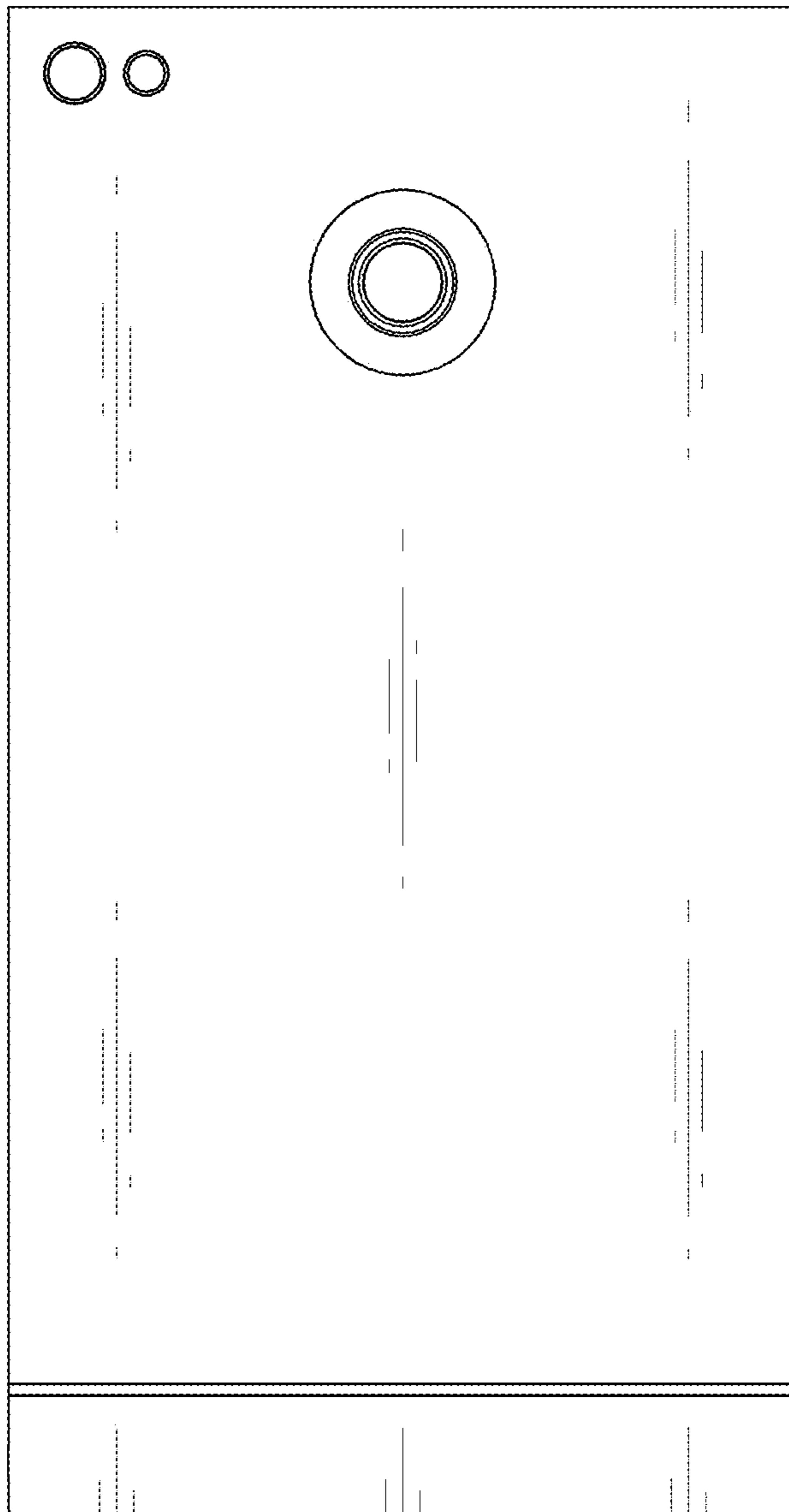

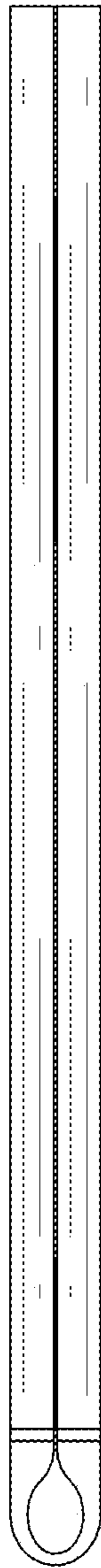

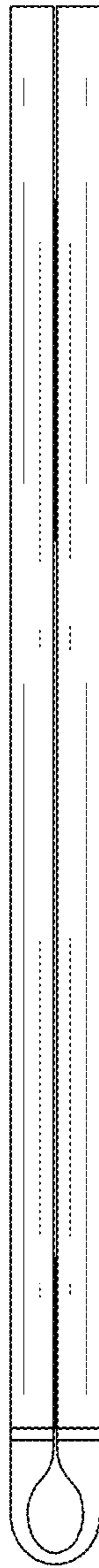

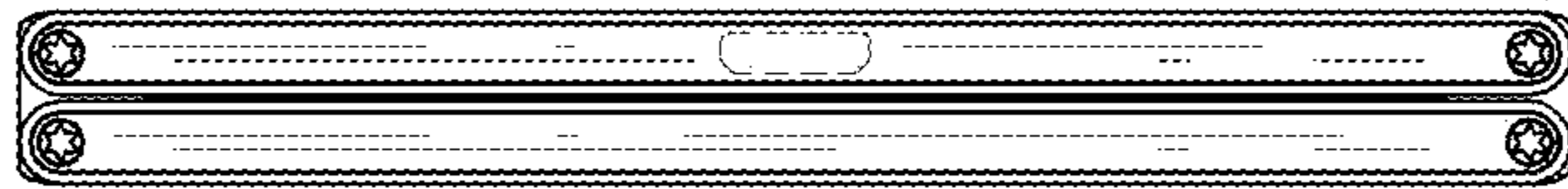

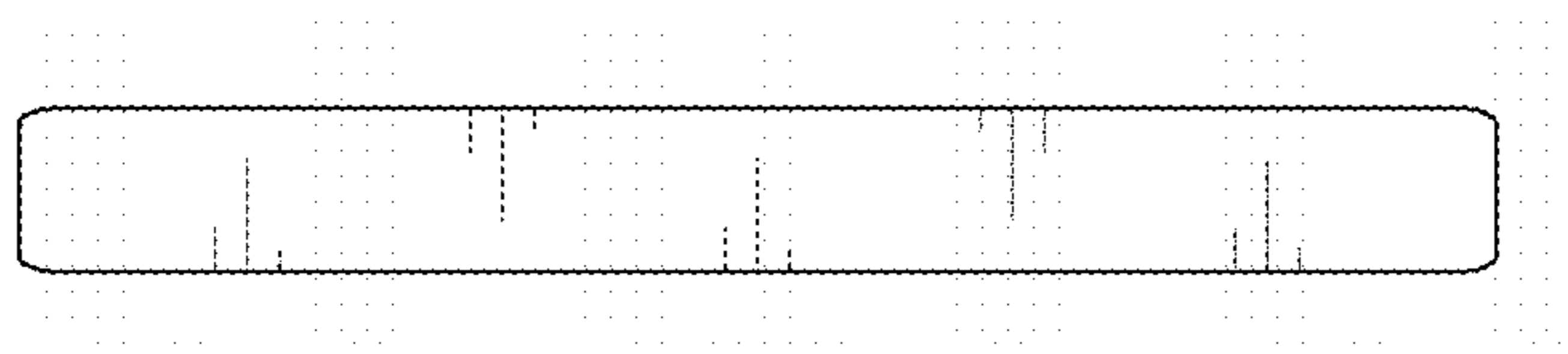

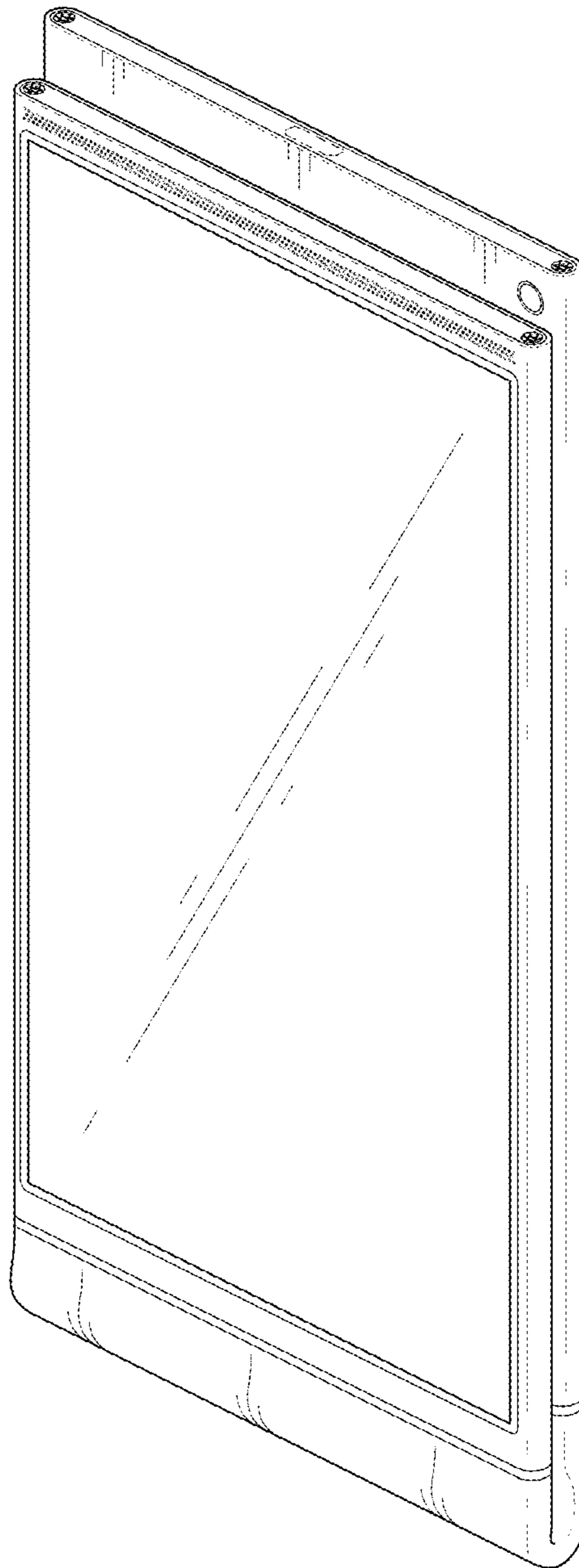

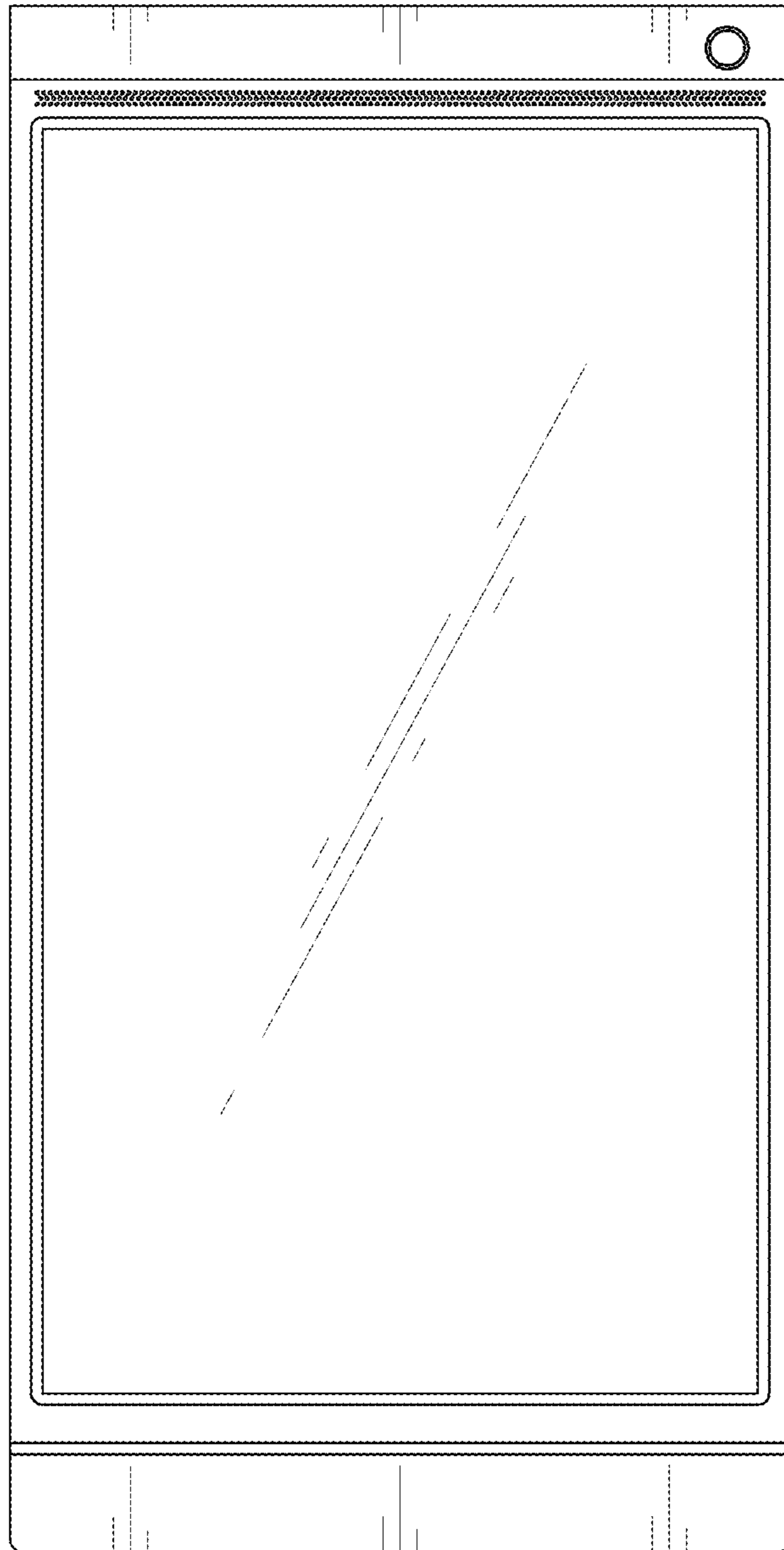

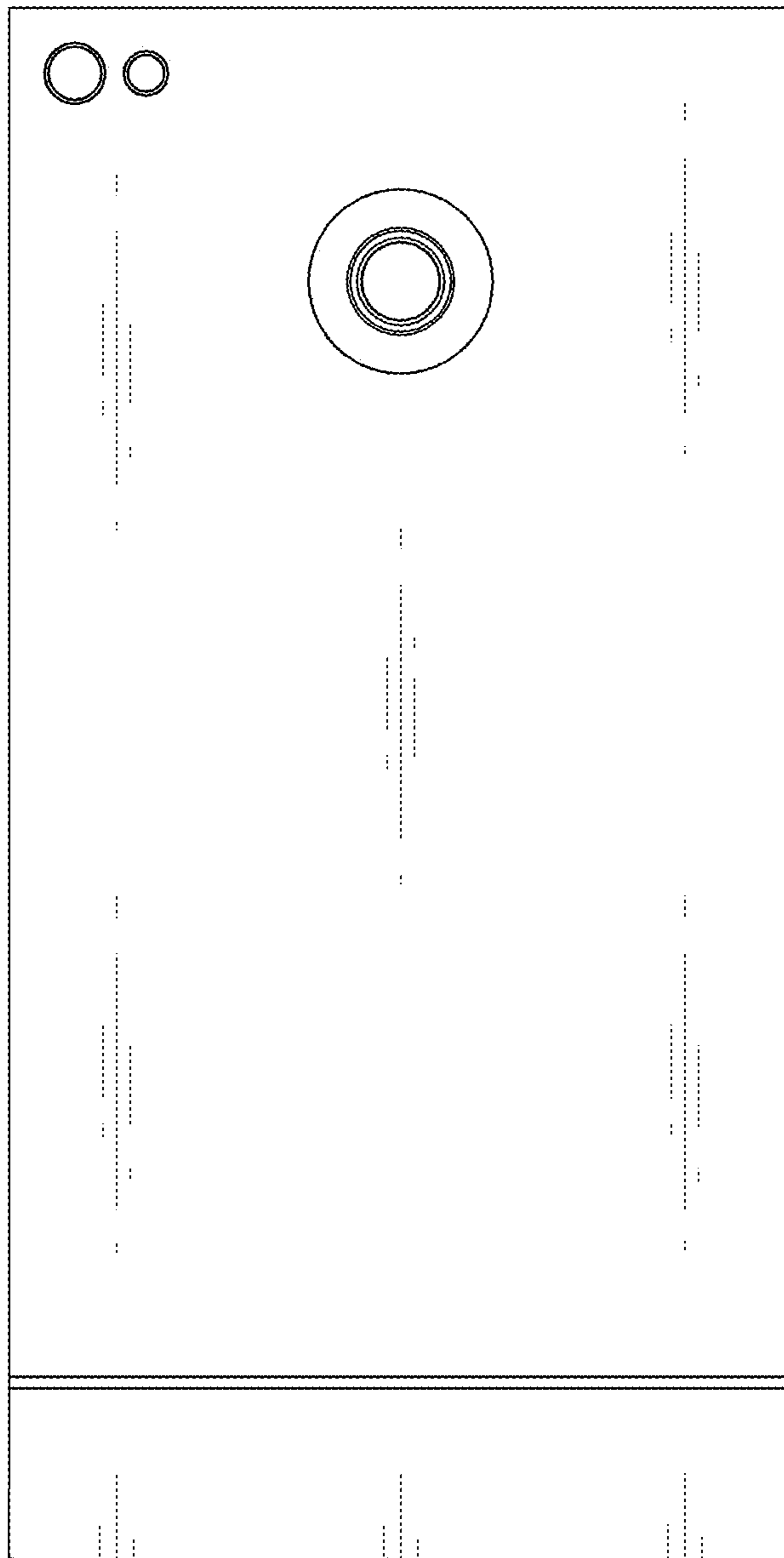

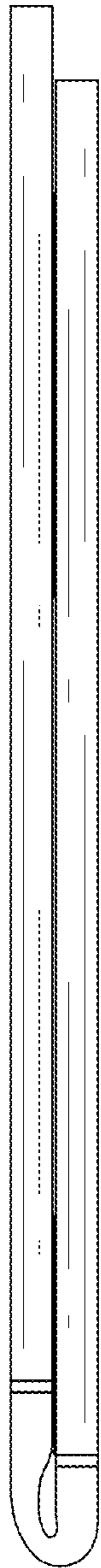

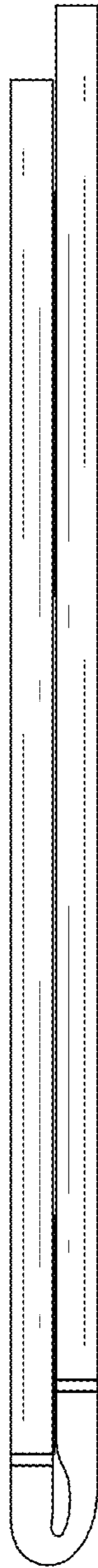
