(57) **CLAIM**

The ornamental design for a display panel with graphical
user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display panel with graphical user
interface;

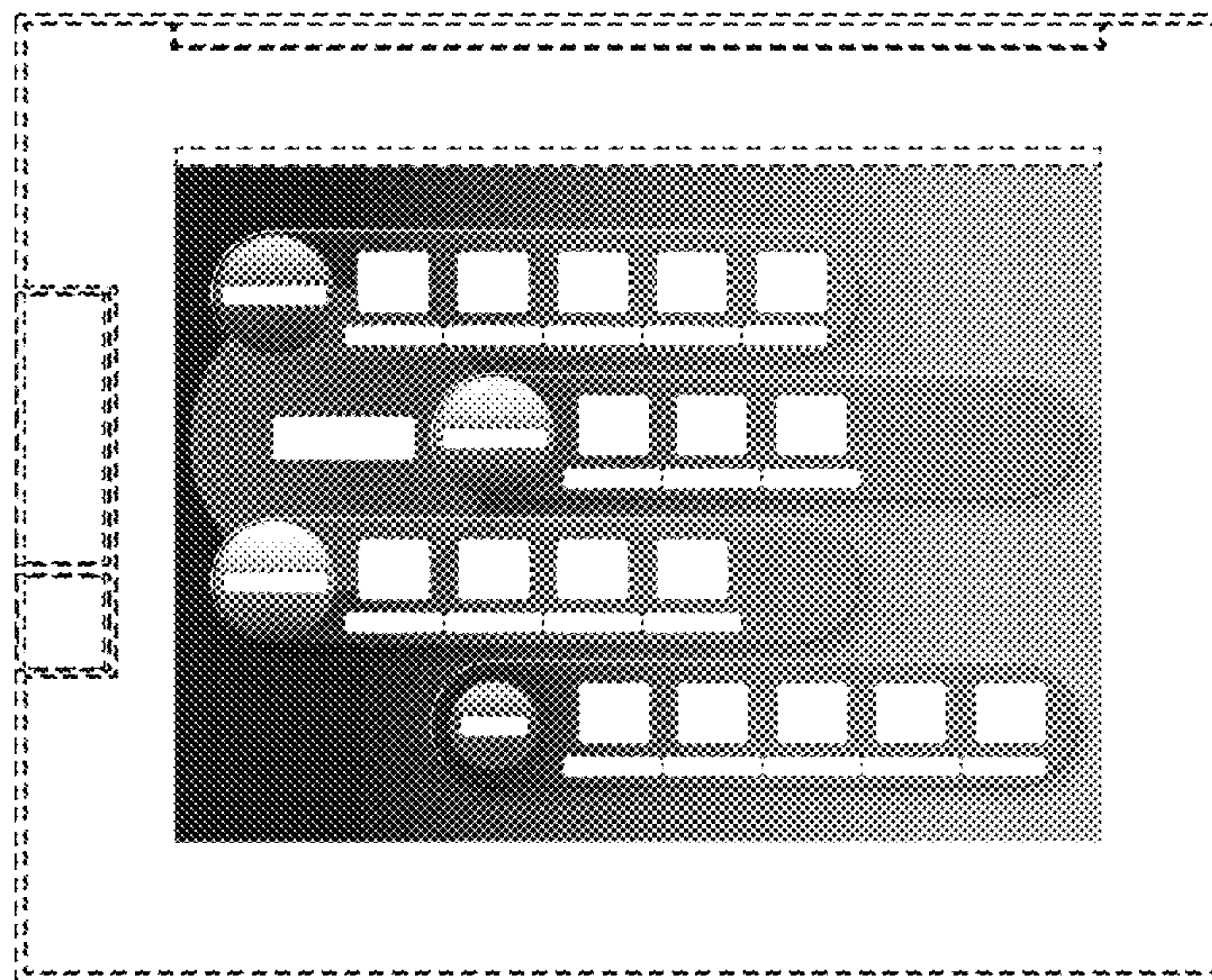
FIG. 2 is a left side elevational view thereof;

FIG. 3 is a top plan view thereof; and,

FIG. 4 is an enlarged view of the graphical user interface
portion of FIG. 1.

The outermost broken lines in FIG. 1, as well as all broken

broken lines in FIG. 1 and all broken lines in FIG. 4 showing
a display panel and portions of the graphical user interface

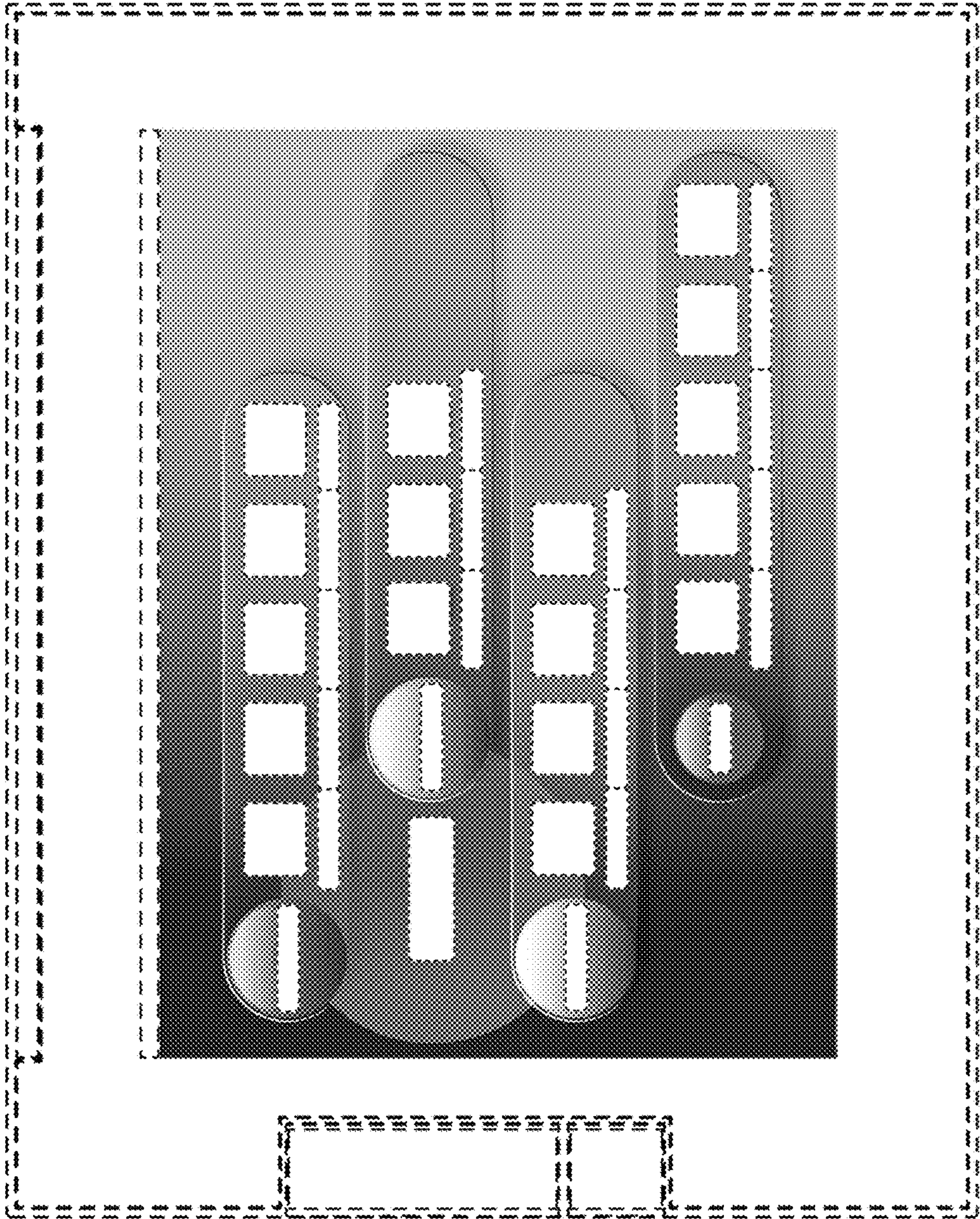
