The ornamental design for a display panel with icon, as shown and described.

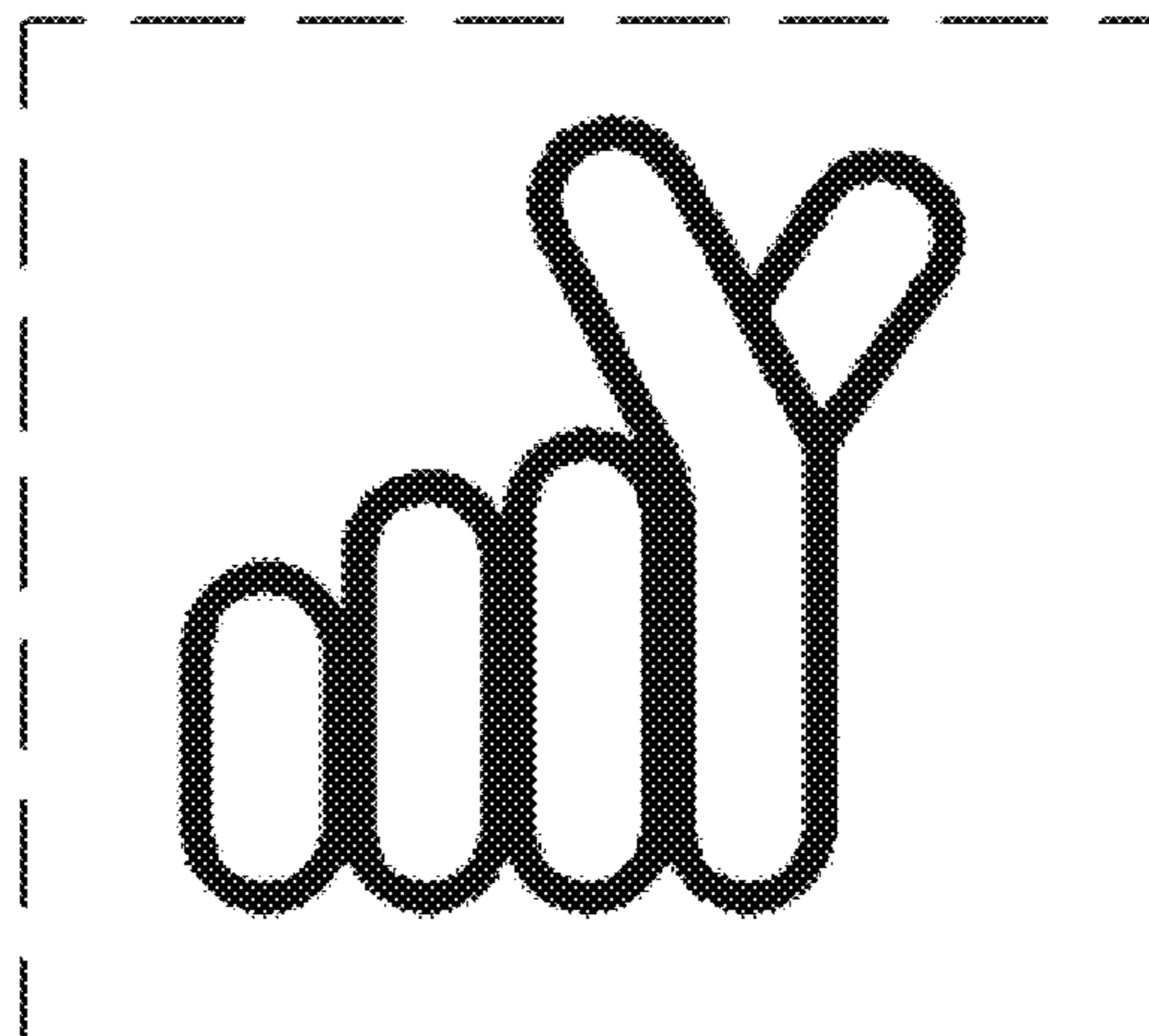
DESCRIPTION

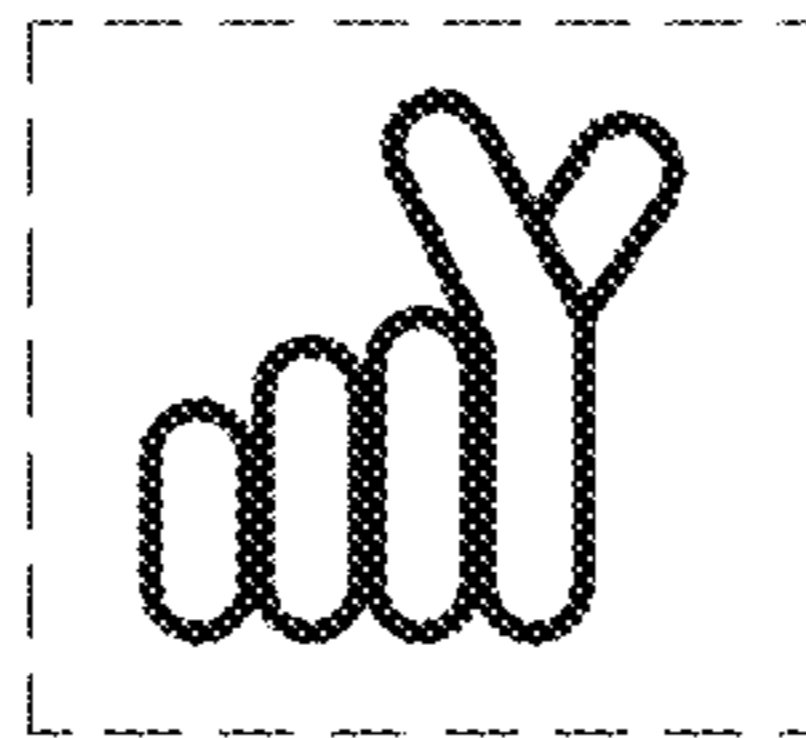
