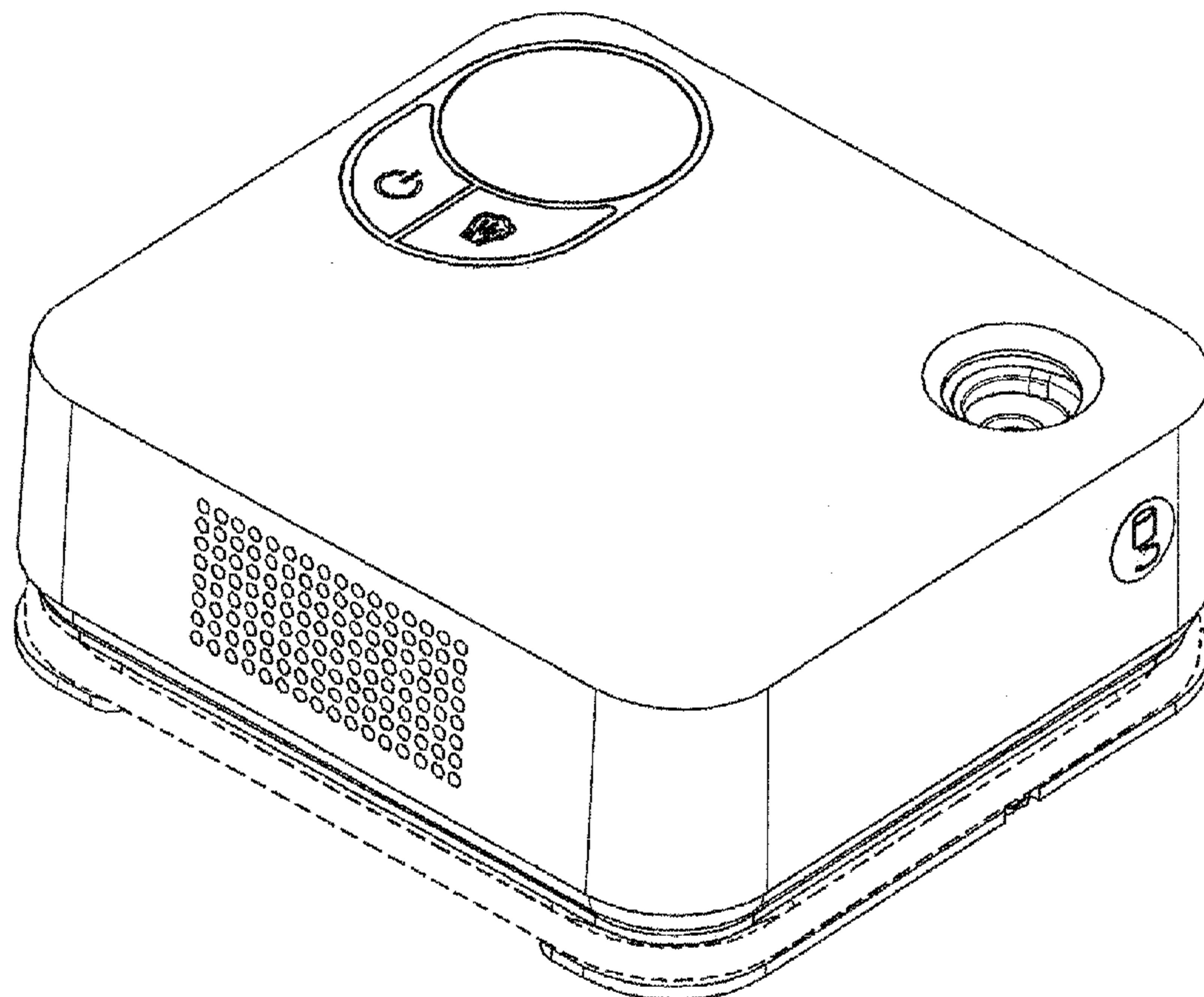
(57) **CLAIM**

I claim the ornamental design for accessory for inflation and repair of tires, as shown.

DESCRIPTION

FIG. 1 is a top/side perspective view of a first embodiment of said new design for accessory for inflation and repair of tires;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a front elevation view thereof;
FIG. 6 is a right side elevation view thereof; and,
FIG. 7 is a left side elevation view thereof.
The broken lines are included for the purpose of illustrating portions of the accessory for inflation and repair of tires that form no part of the claimed design.
The internal portions of the accessory that can be viewed through the grille in FIGS. 4 and 5 are disclaimed as forming no part of the claimed design.

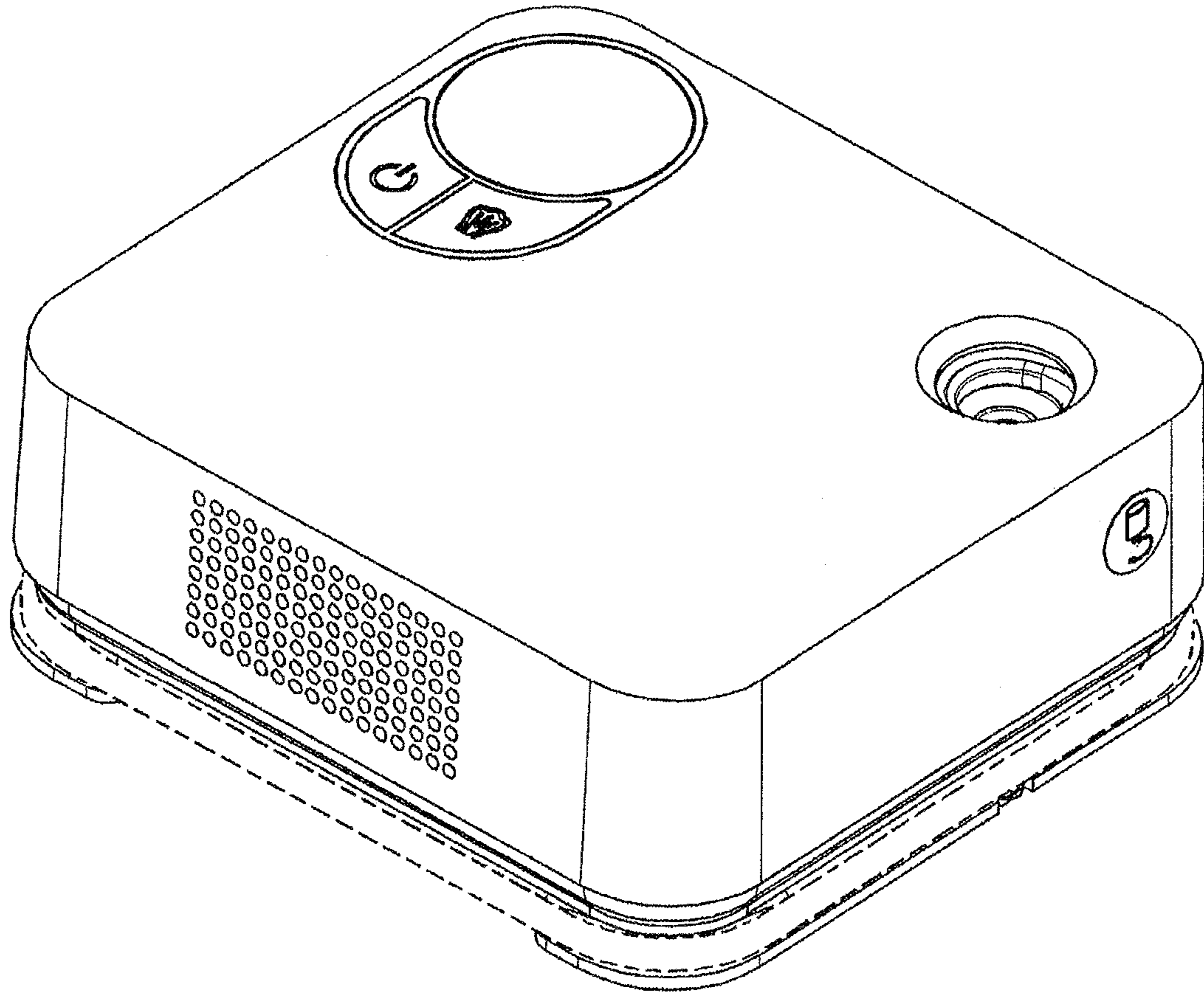

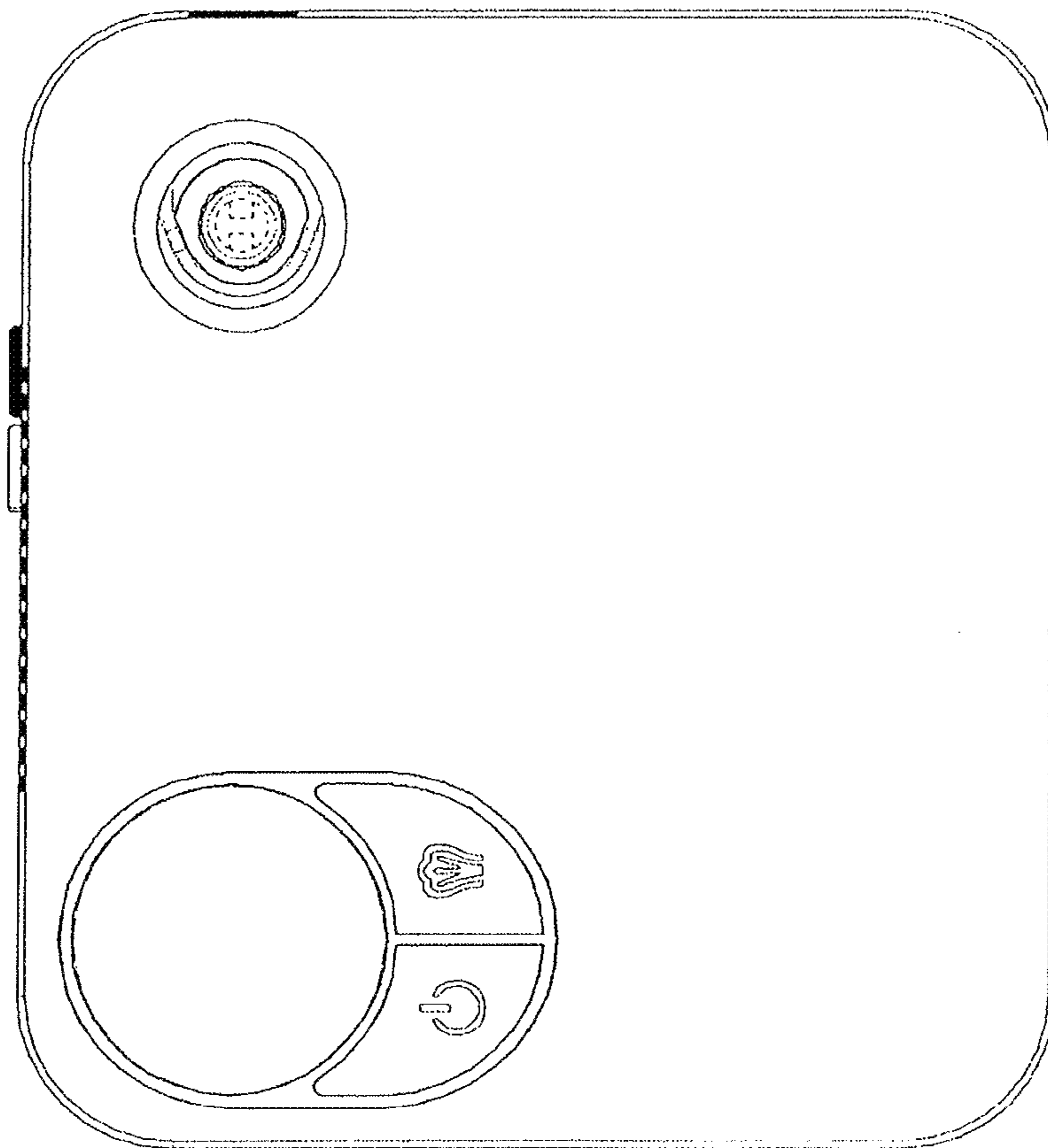

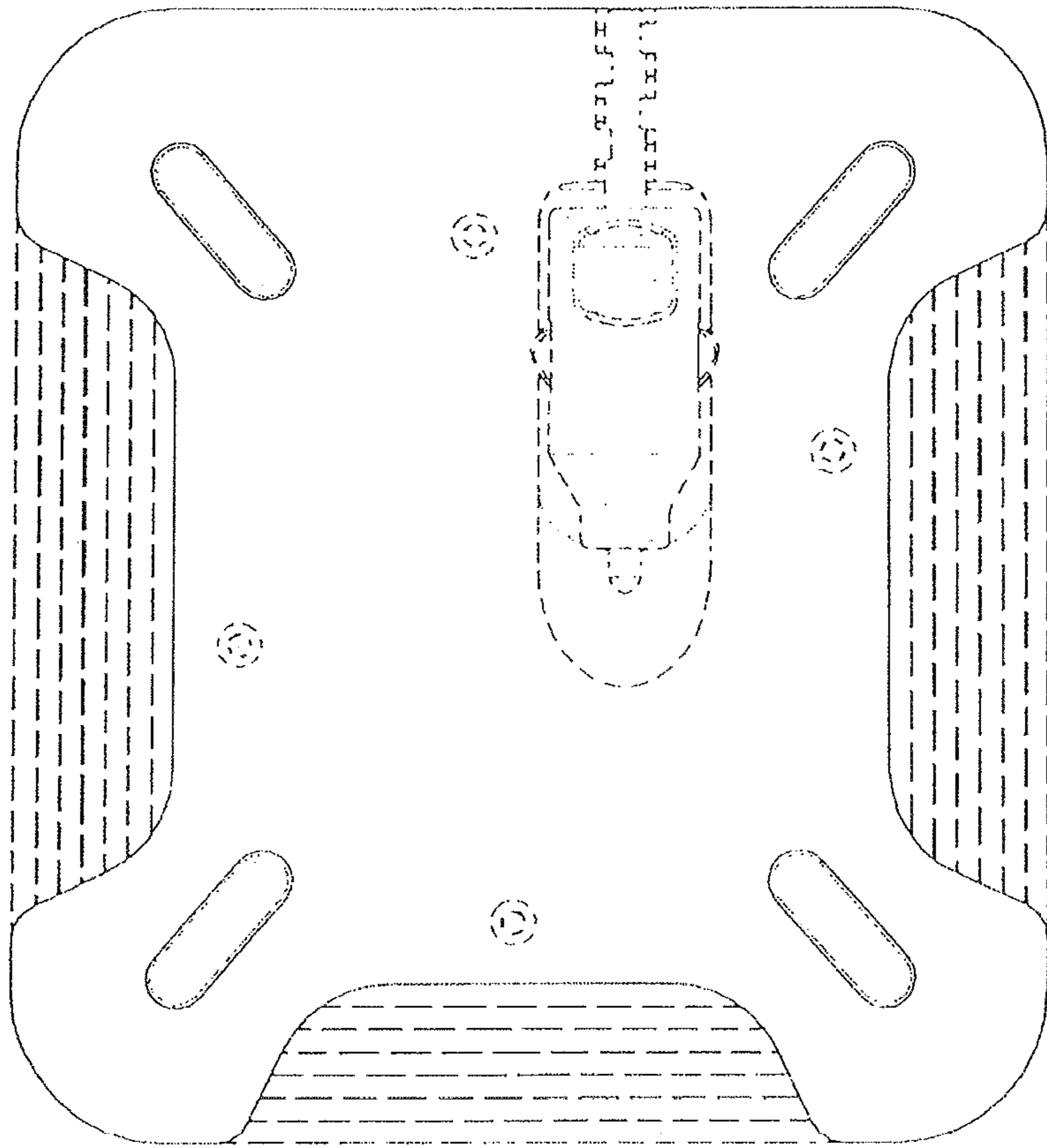

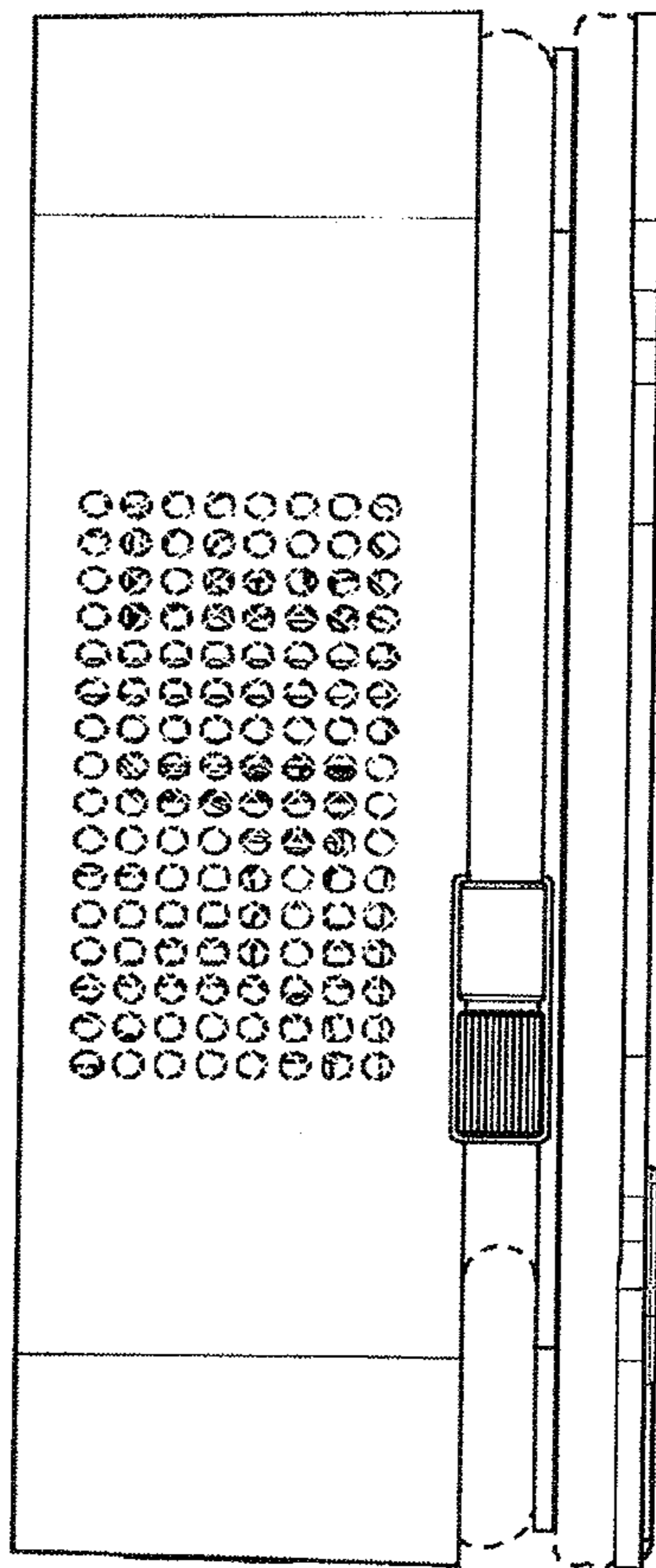

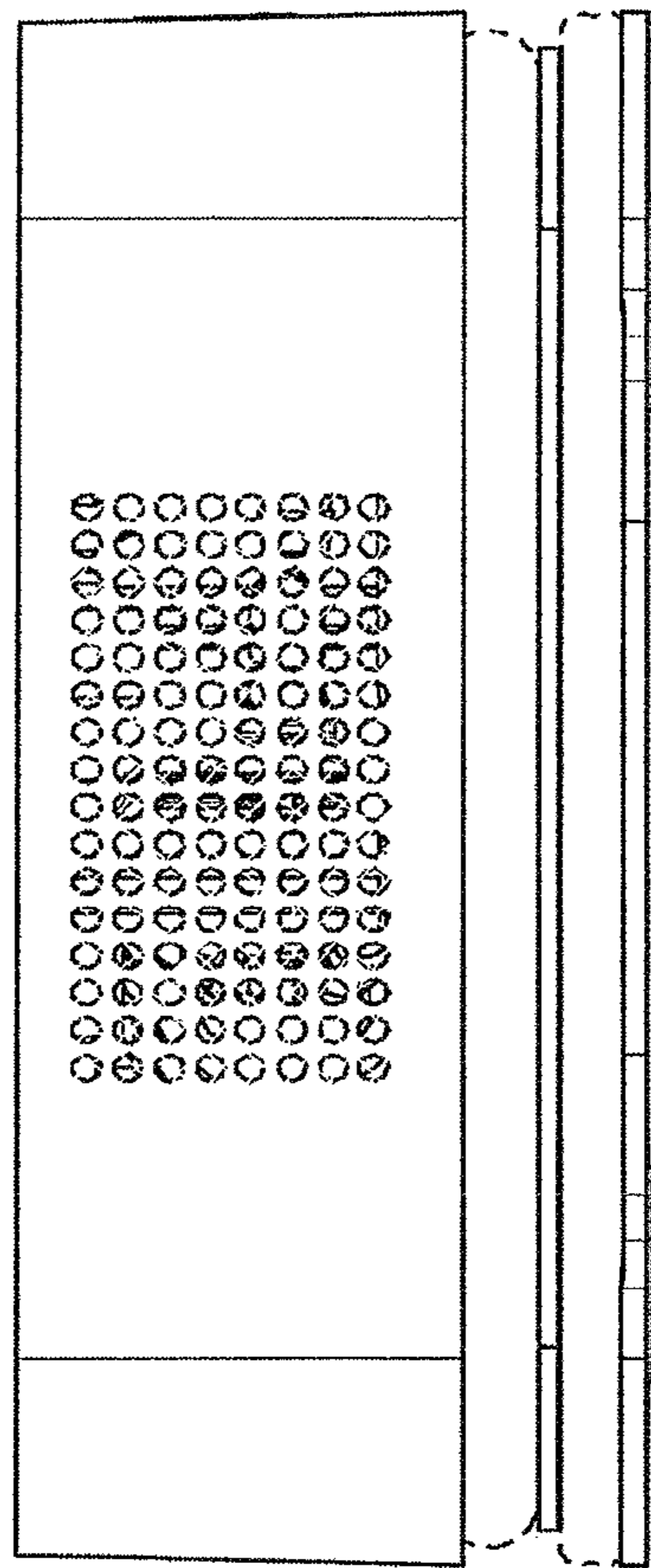

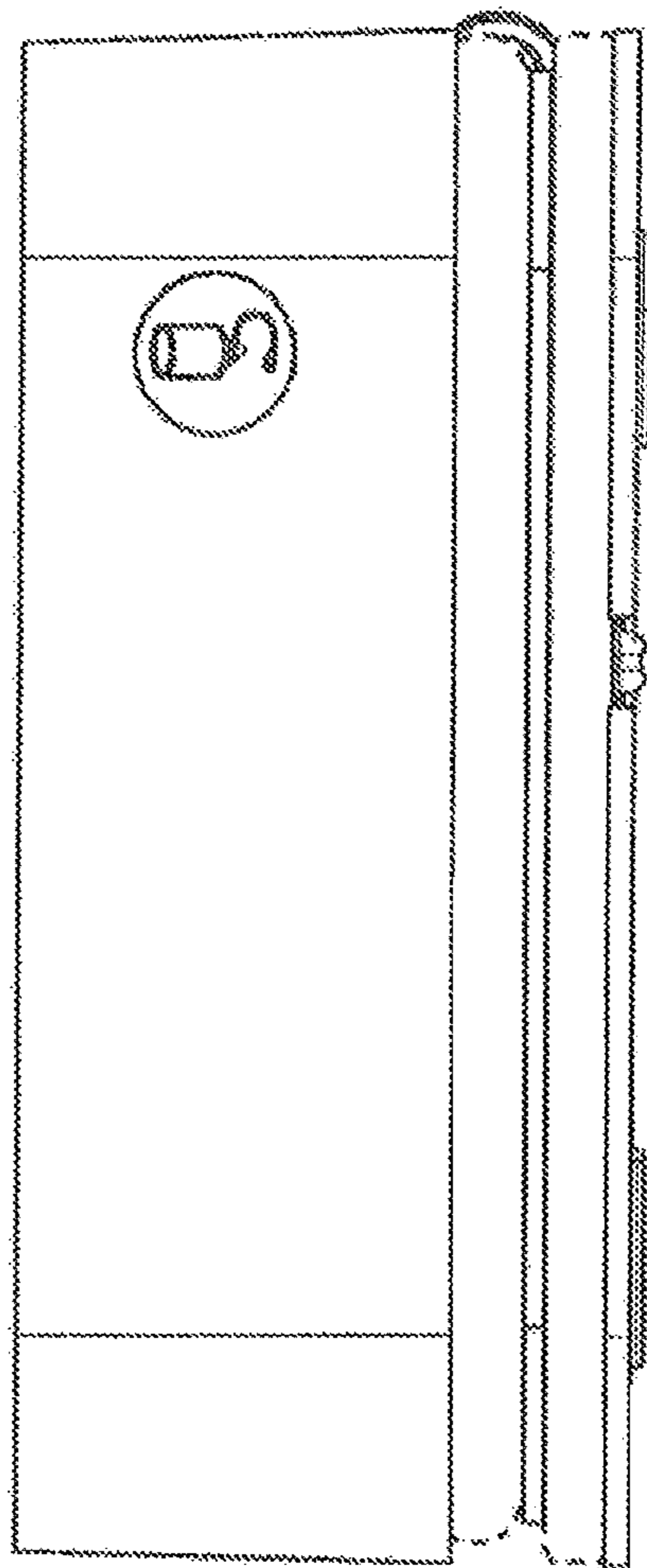

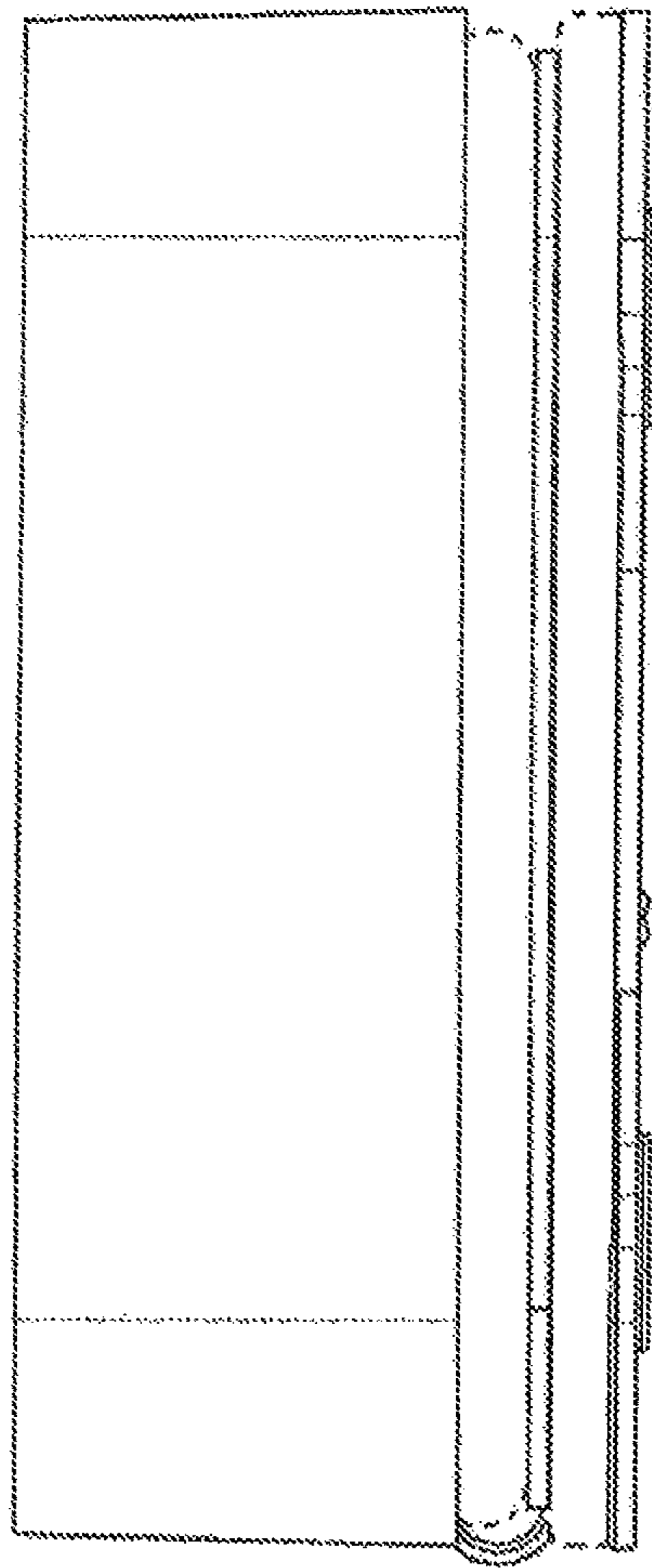
