(57) **CLAIM**

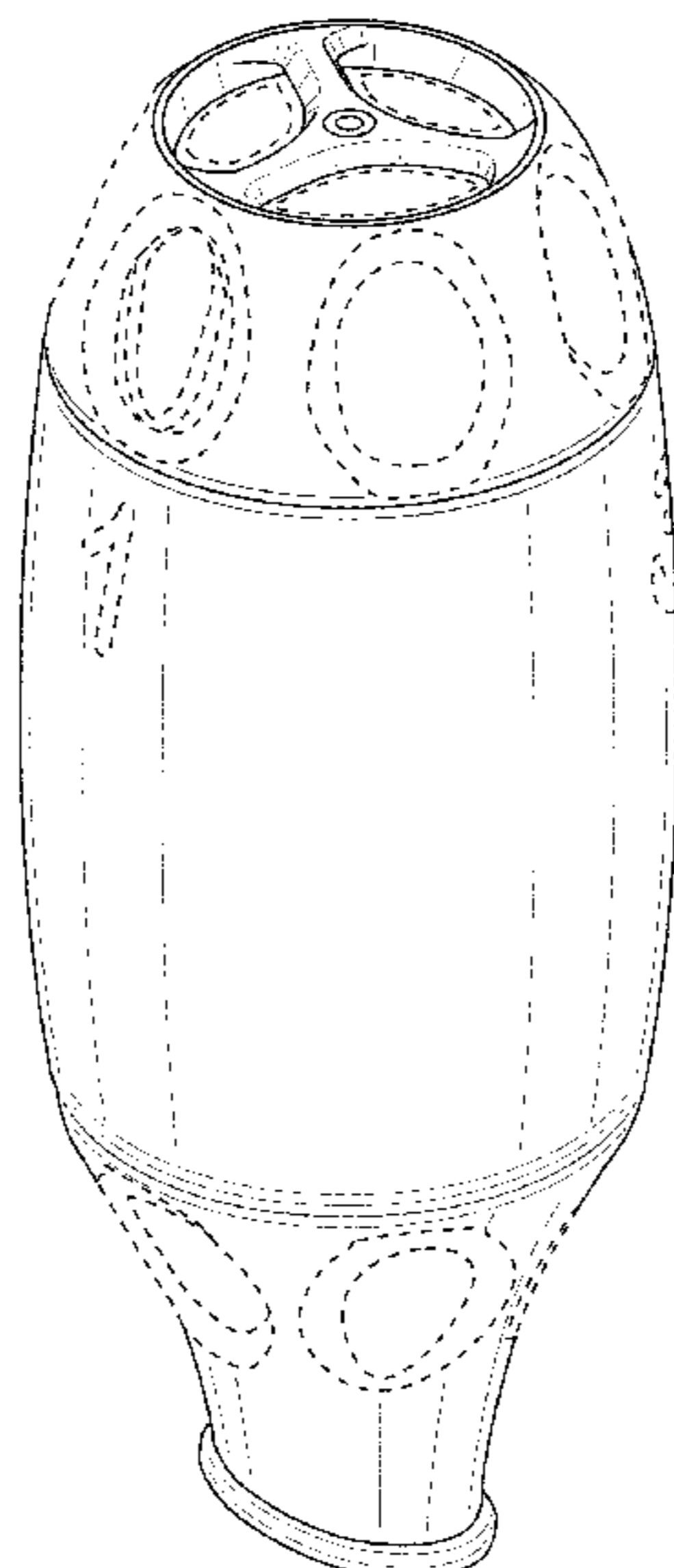
The ornamental design for a positive expiratory pressure device, as shown and described.

**DESCRIPTION**

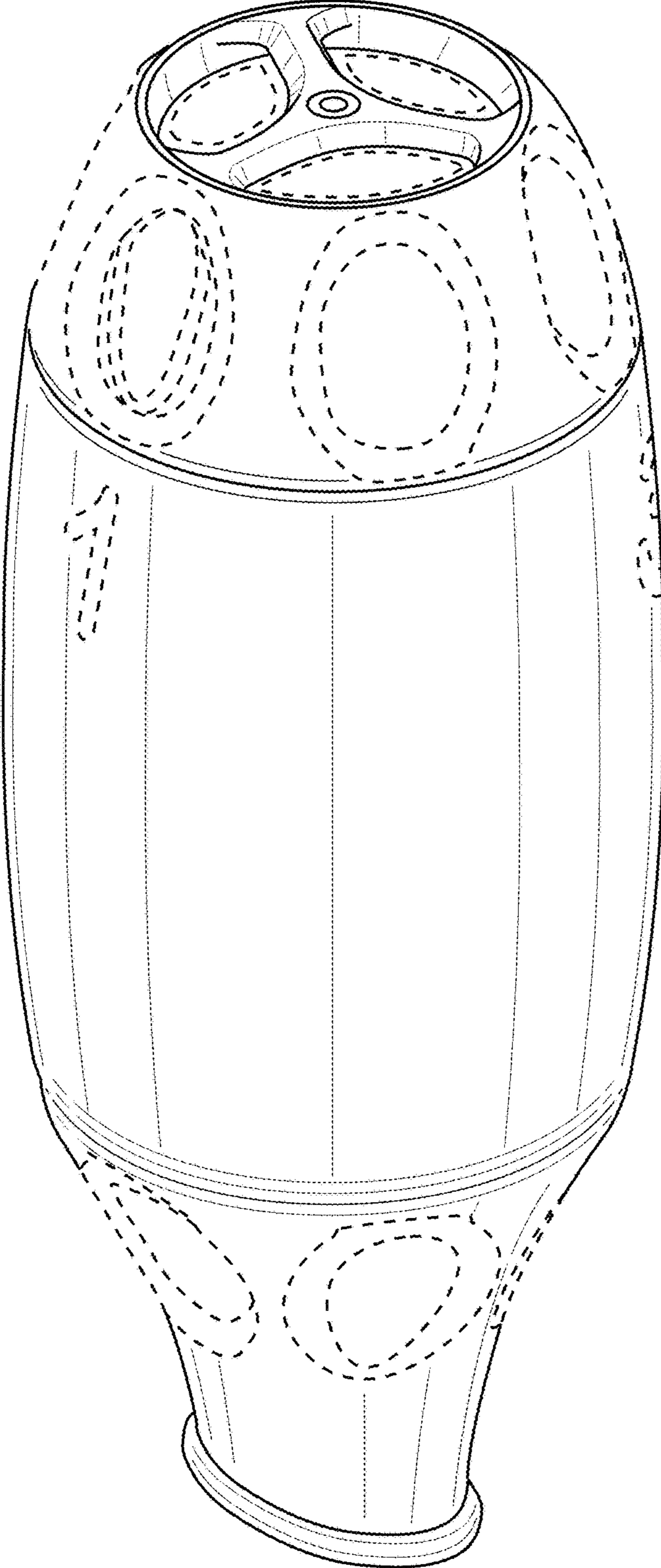

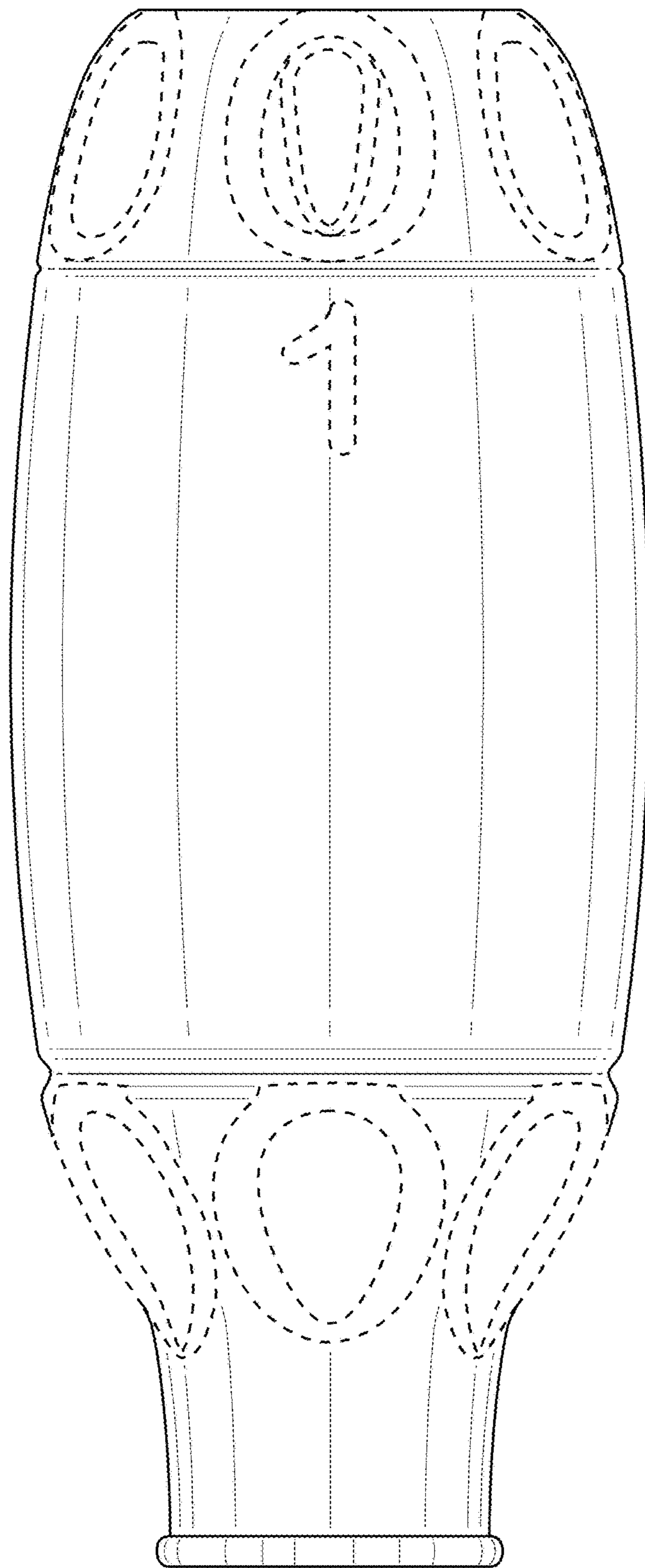

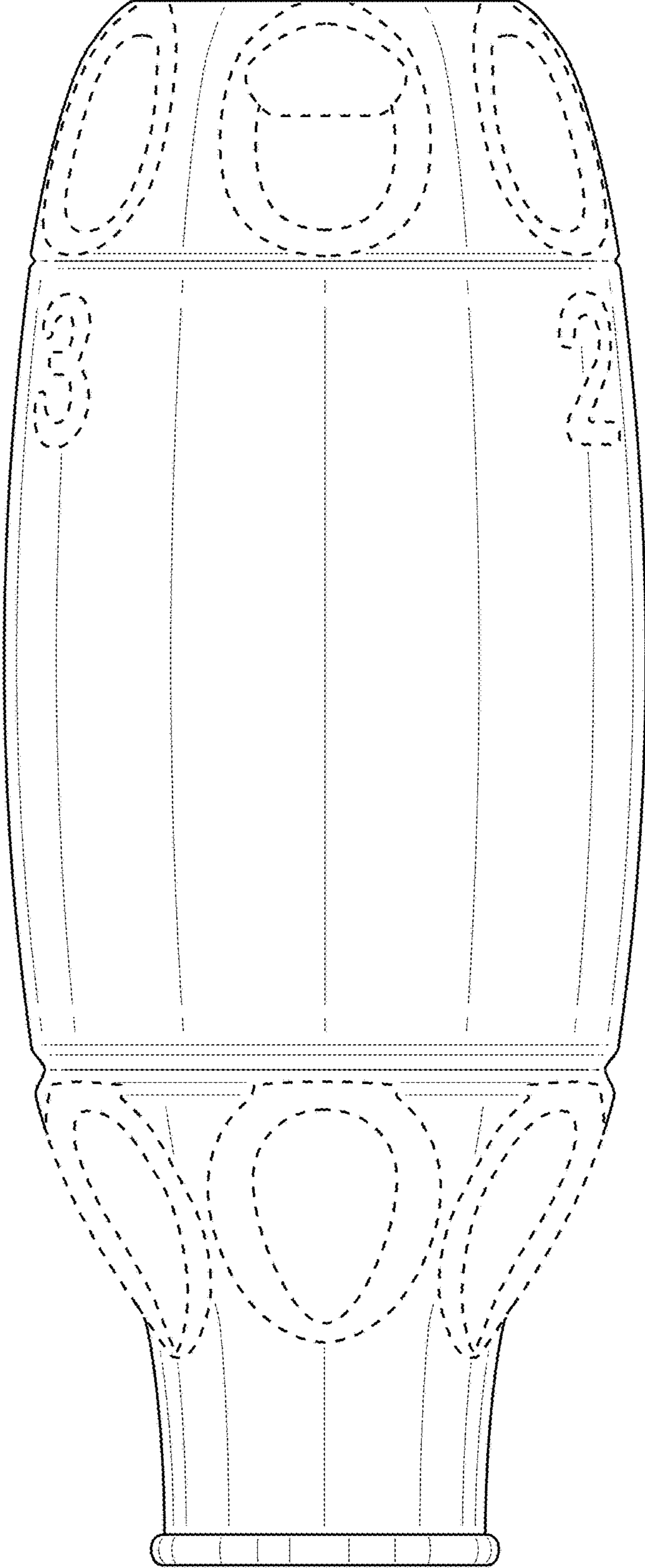

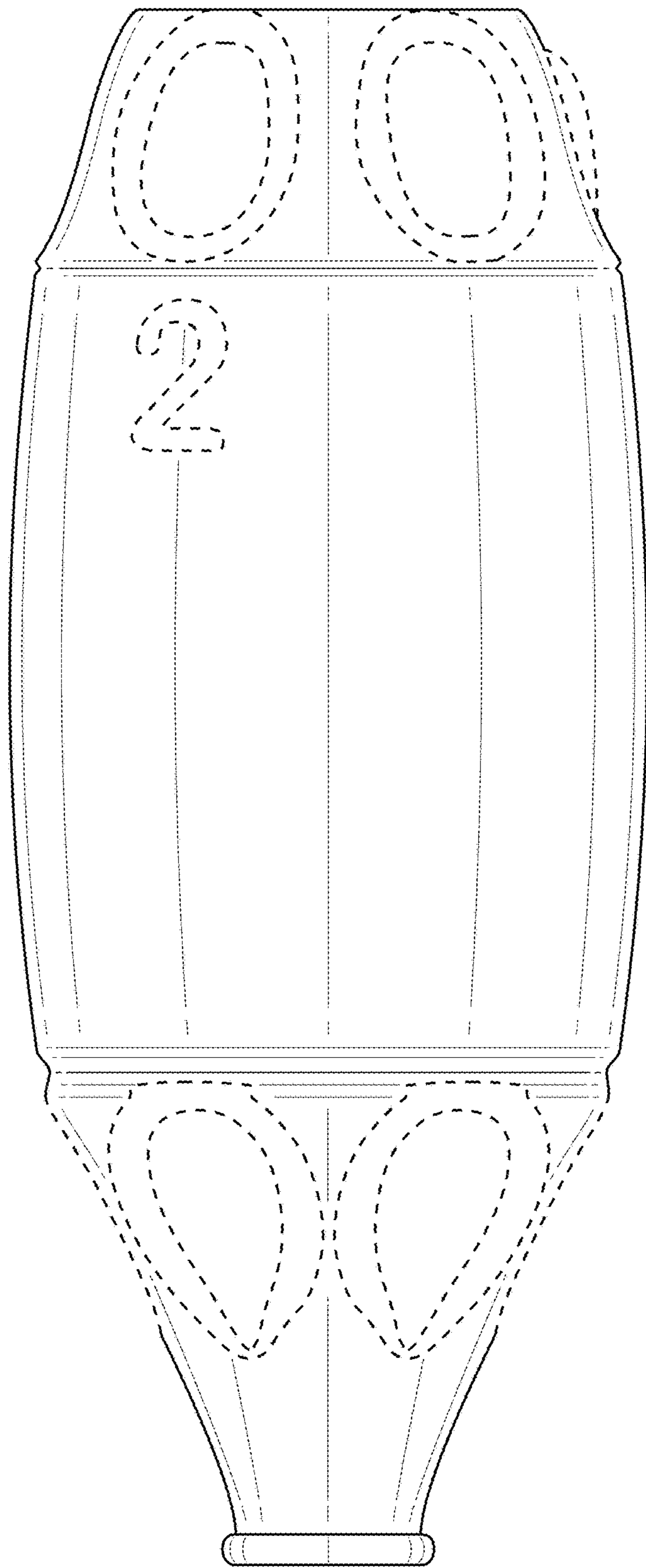

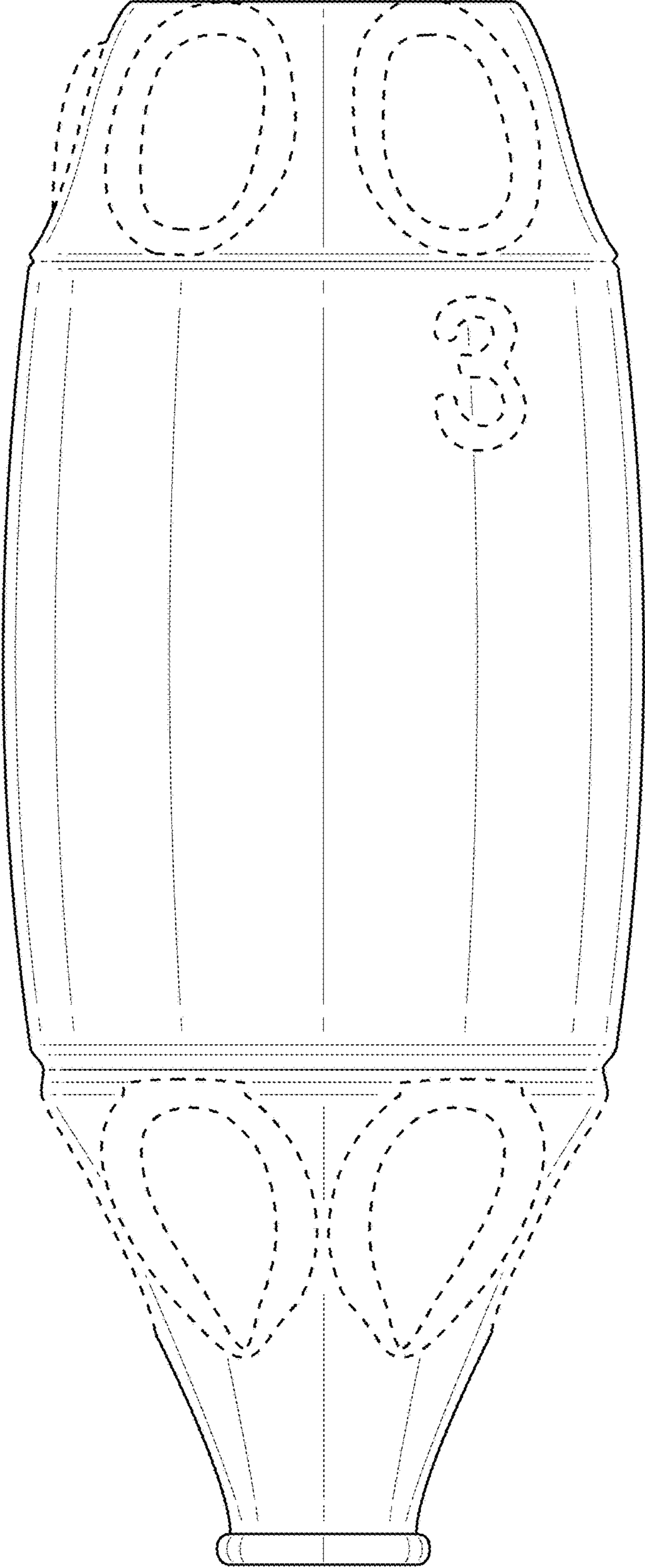

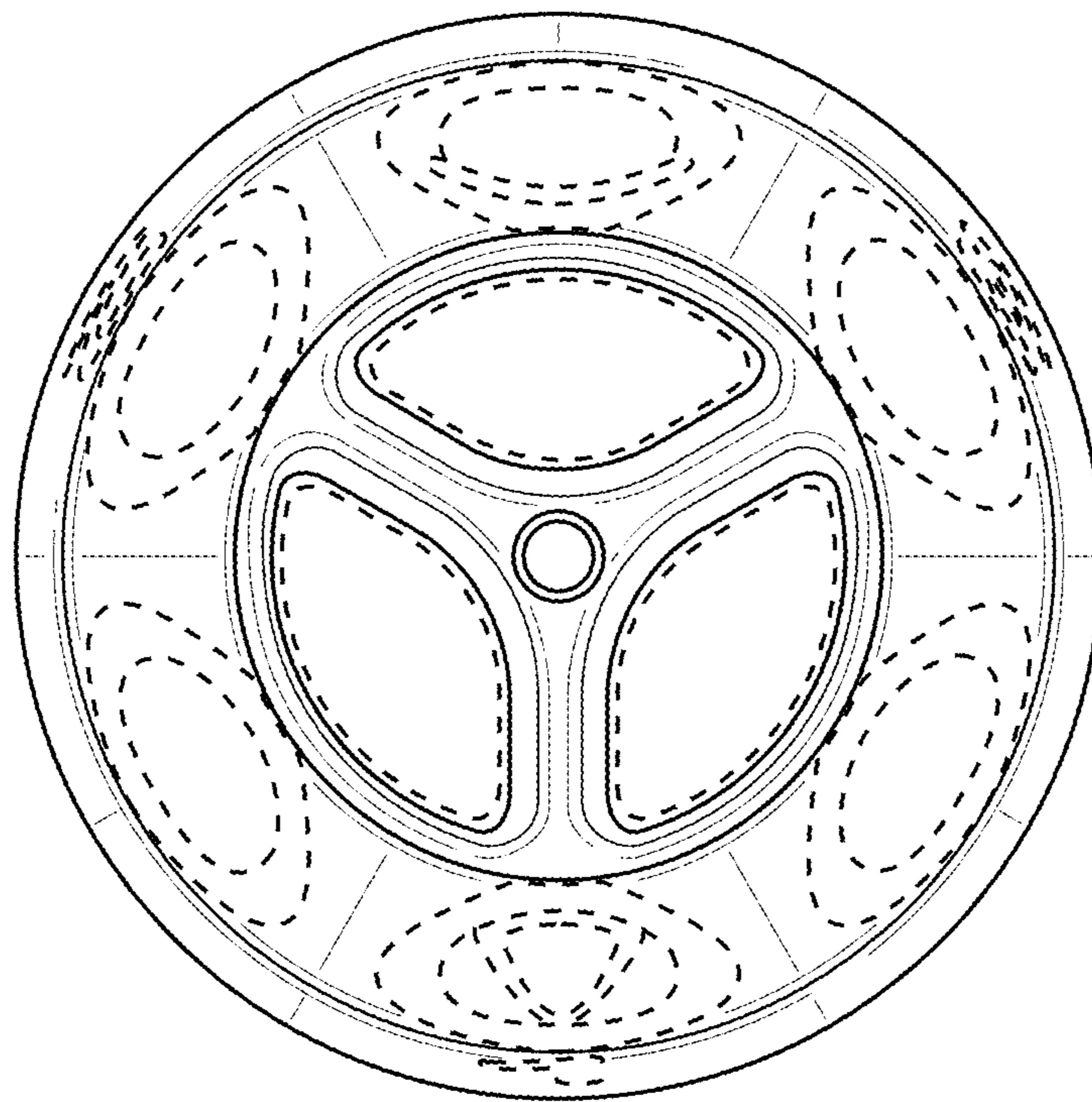

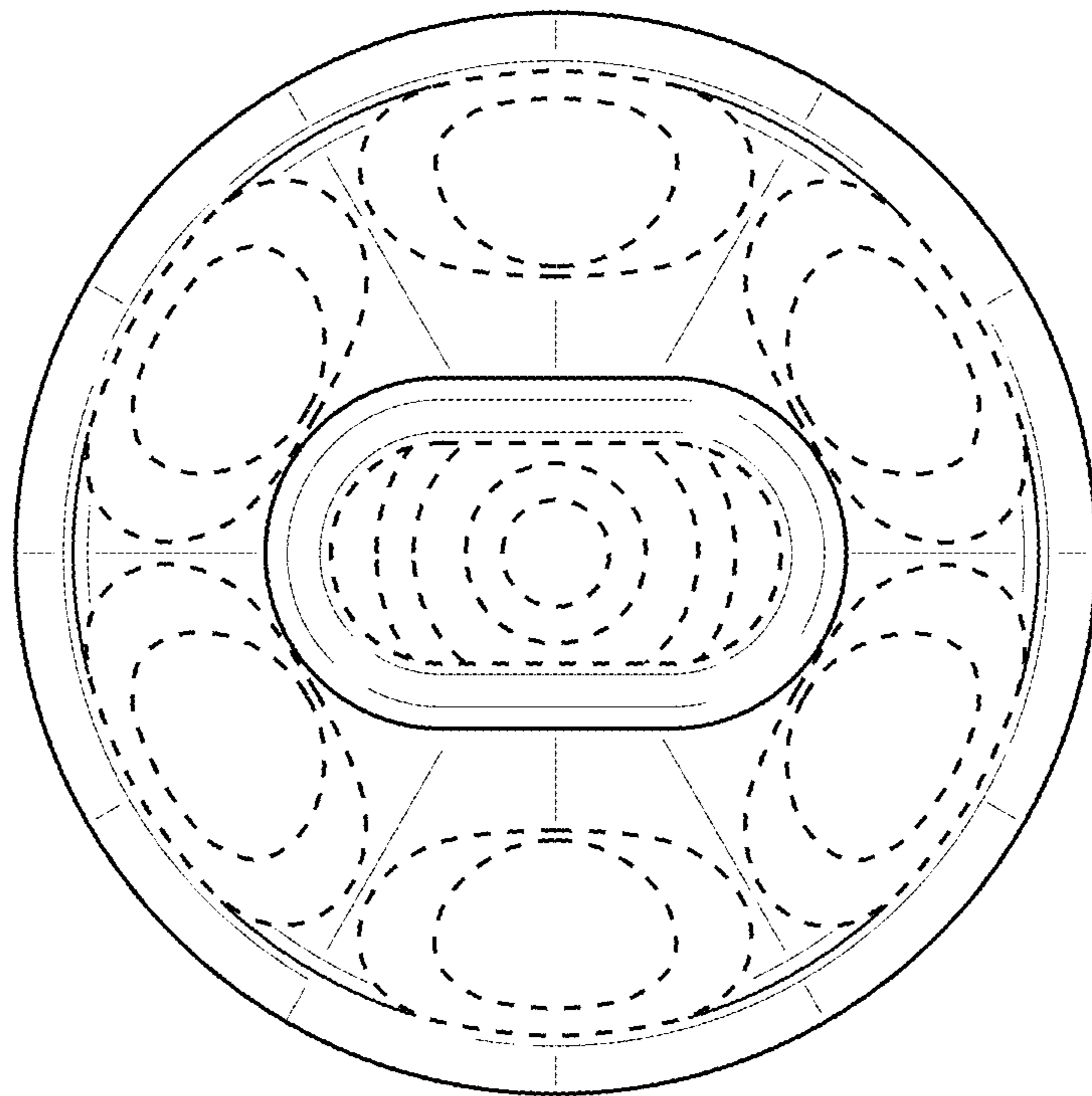
