DESCRIPTION

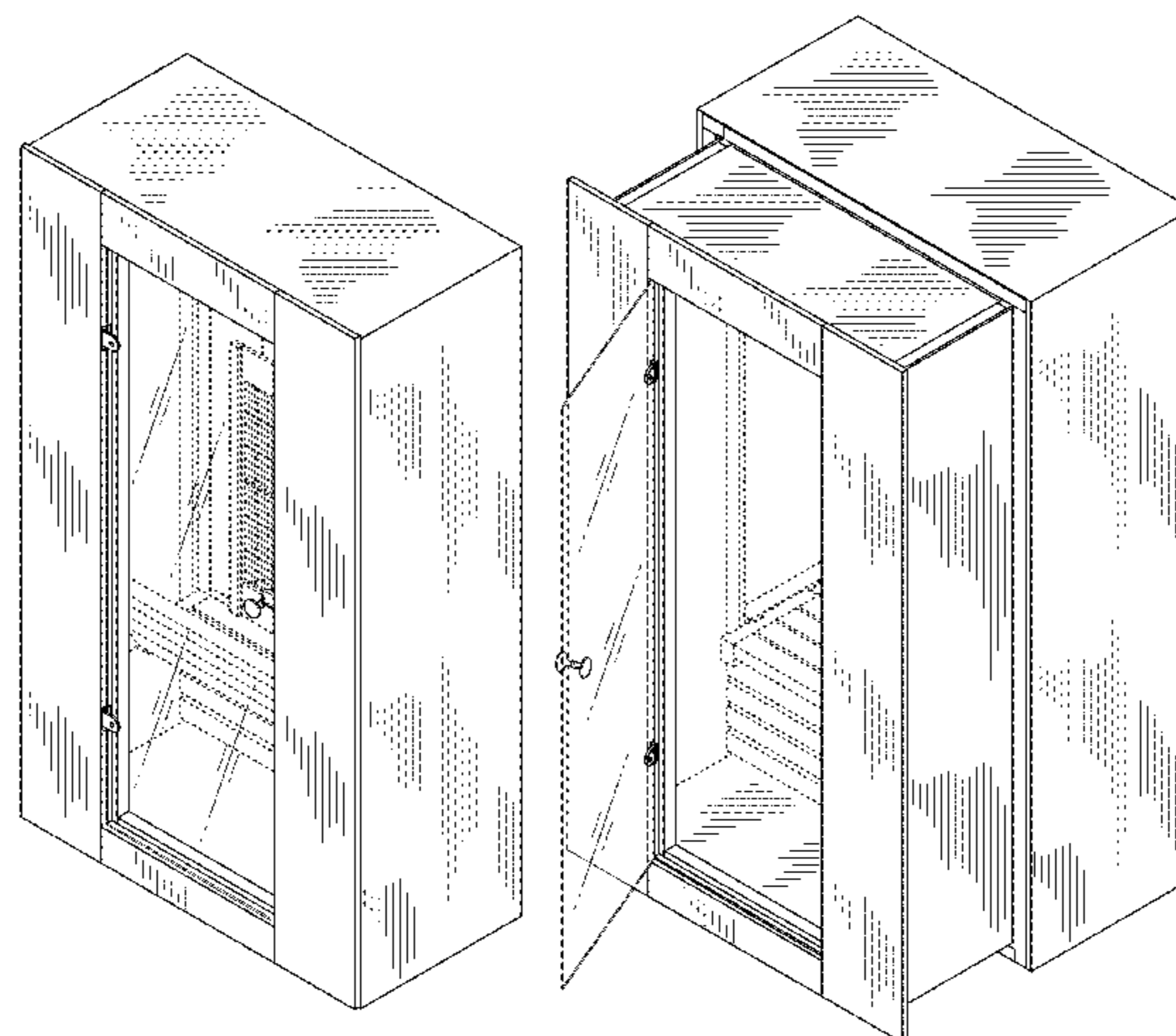


FIG. 22 is a front, left side perspective view of embodiment four, of a foldable sauna, shown in an expanded condition, showing my new design;

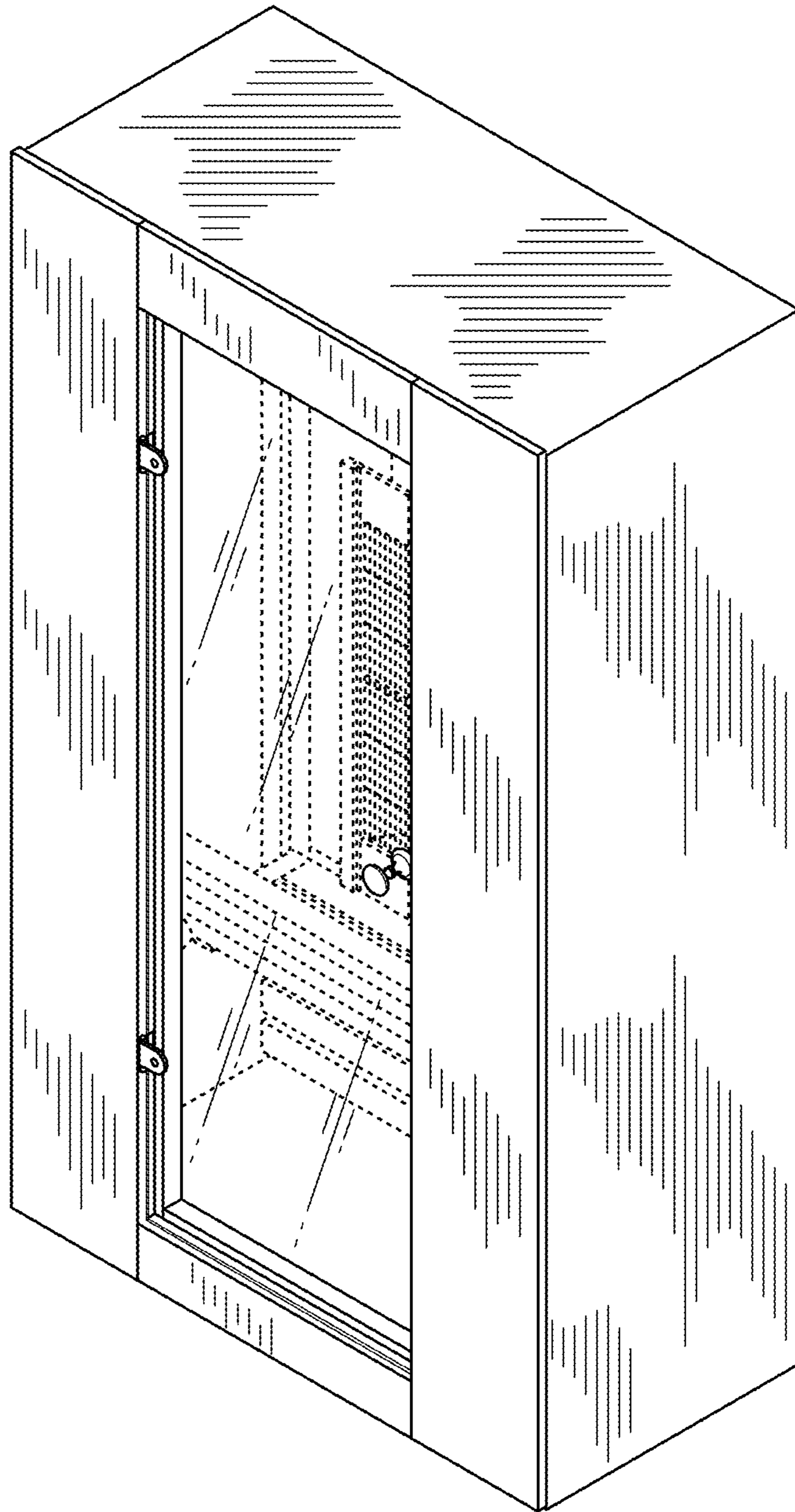

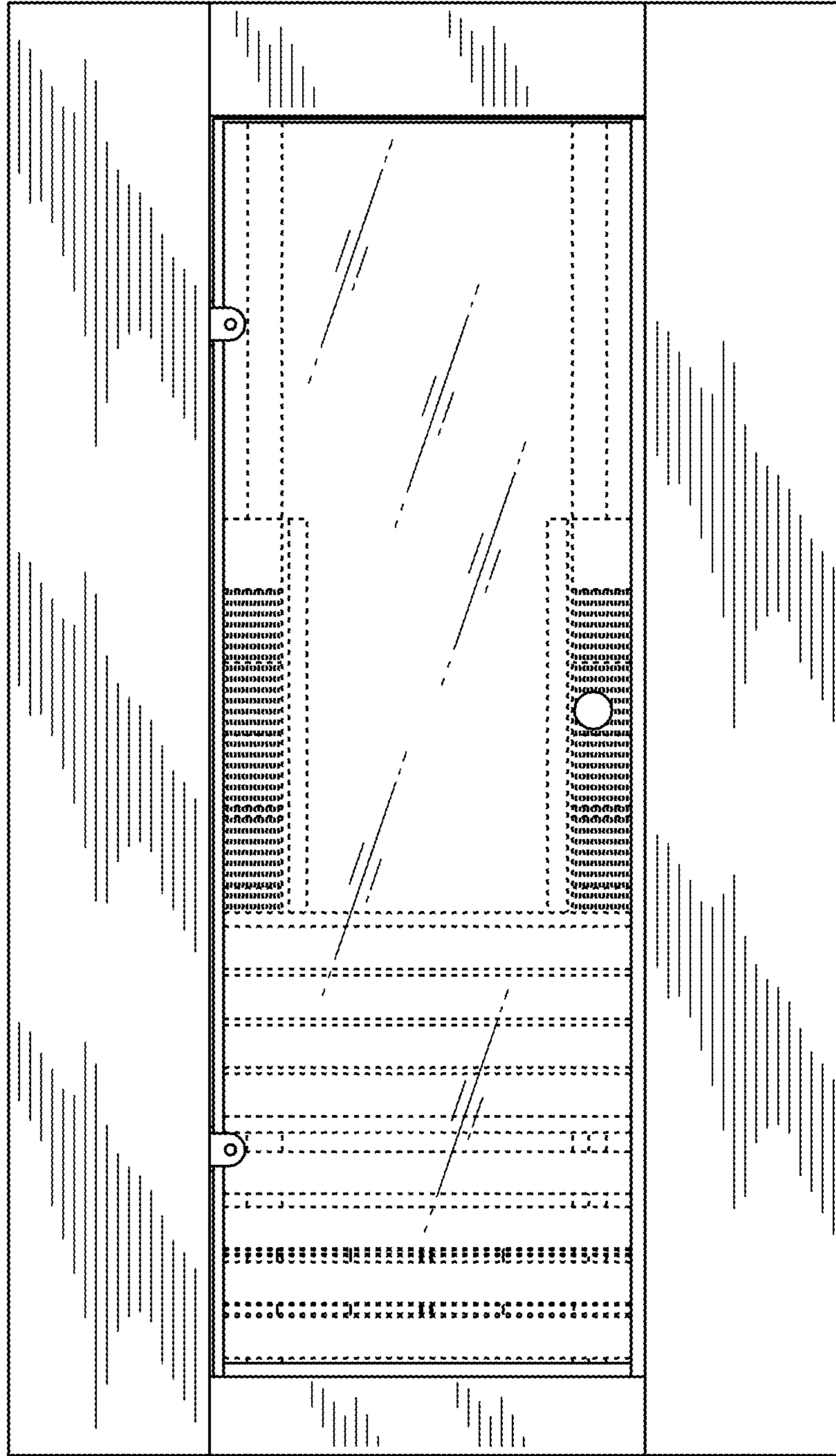

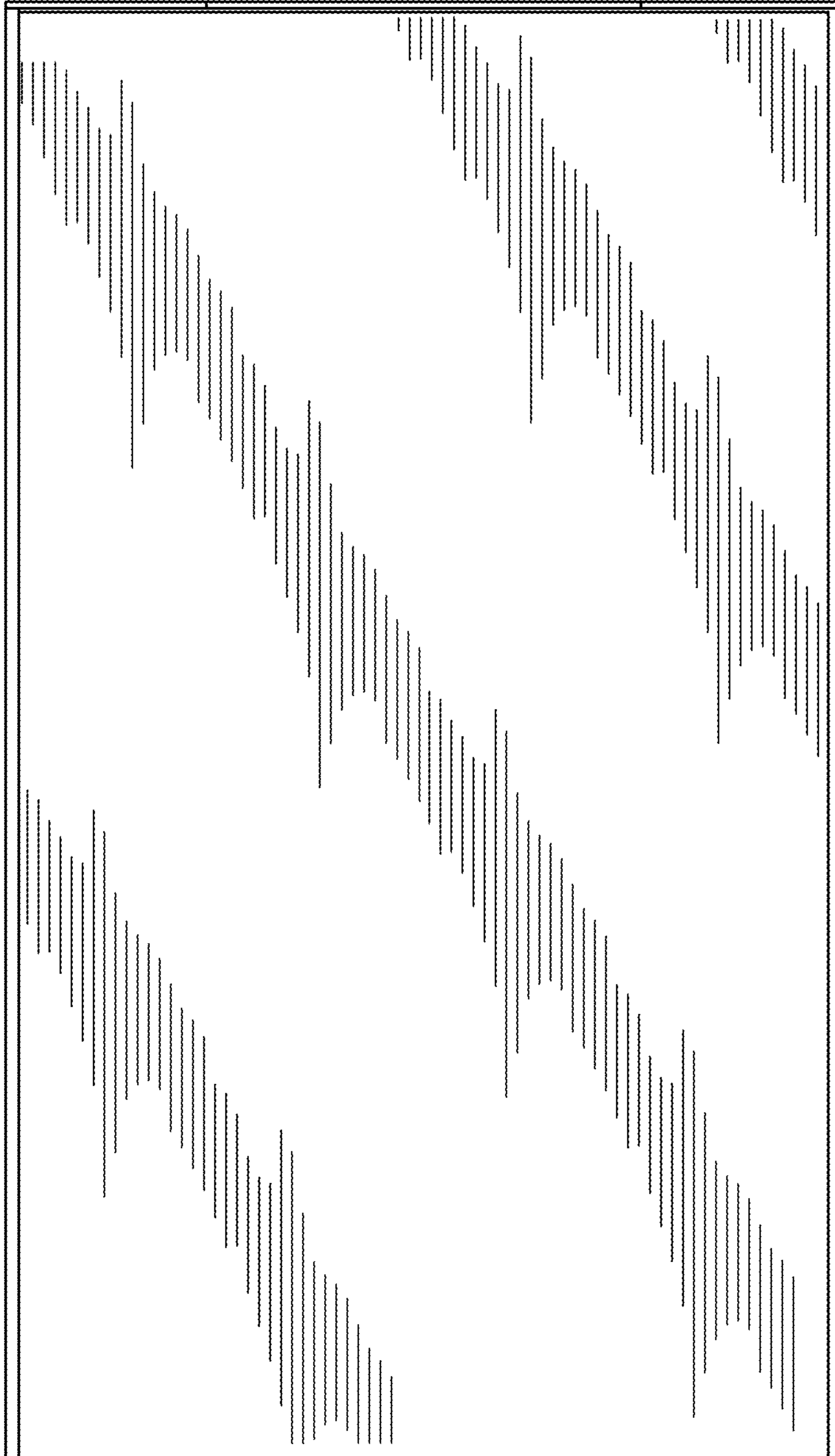

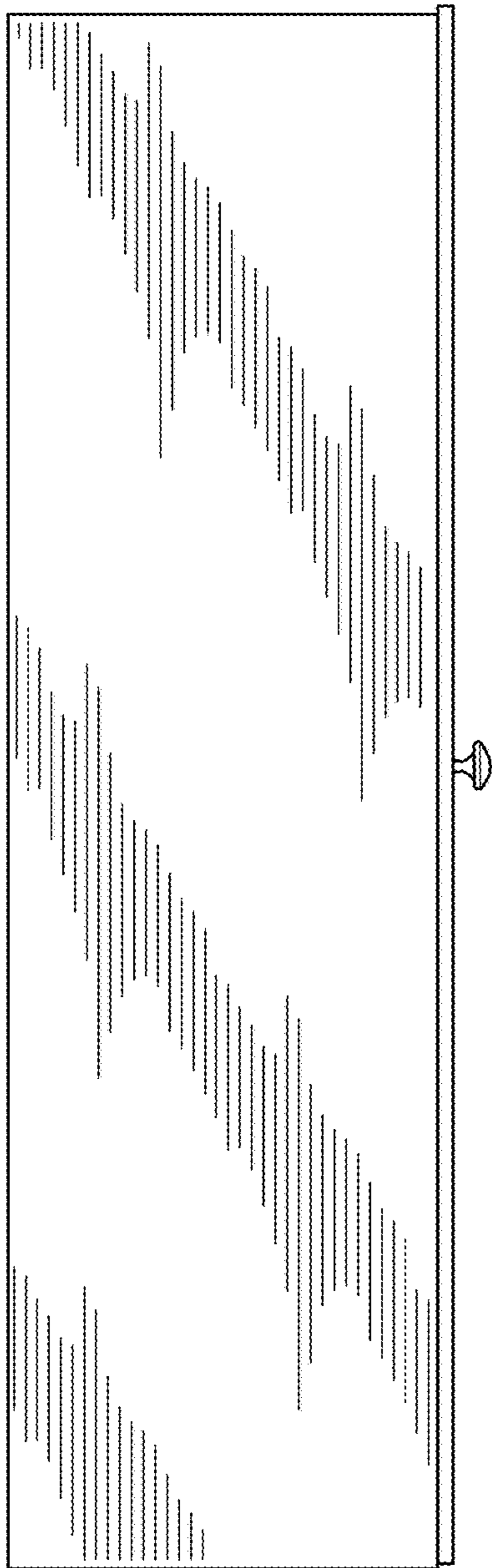

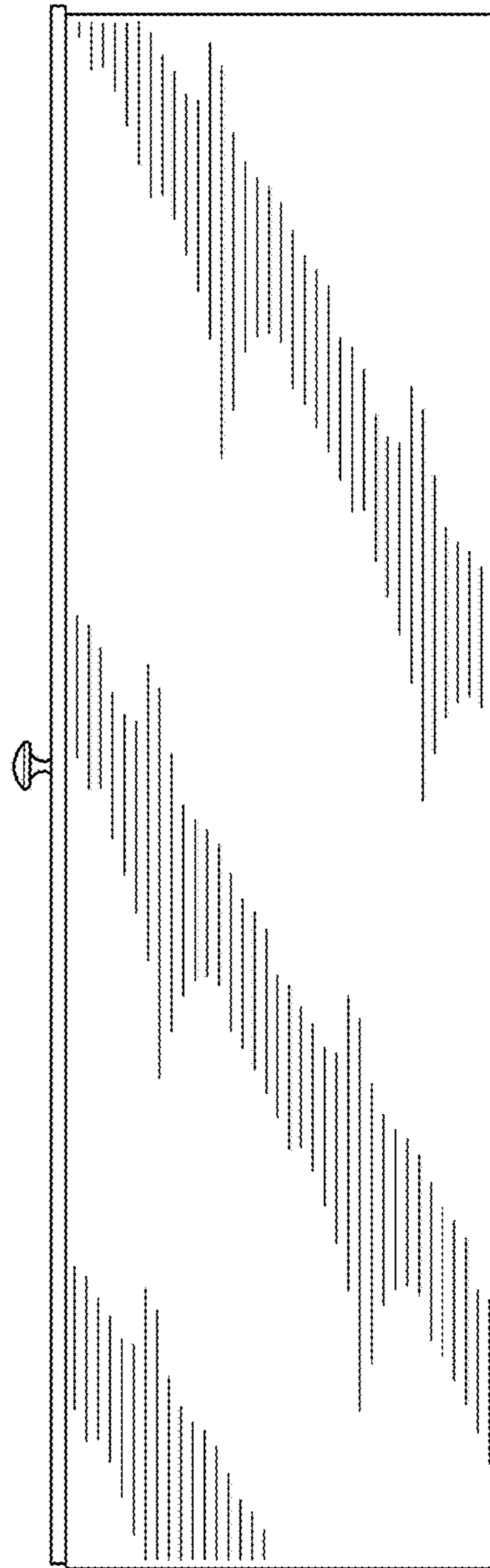

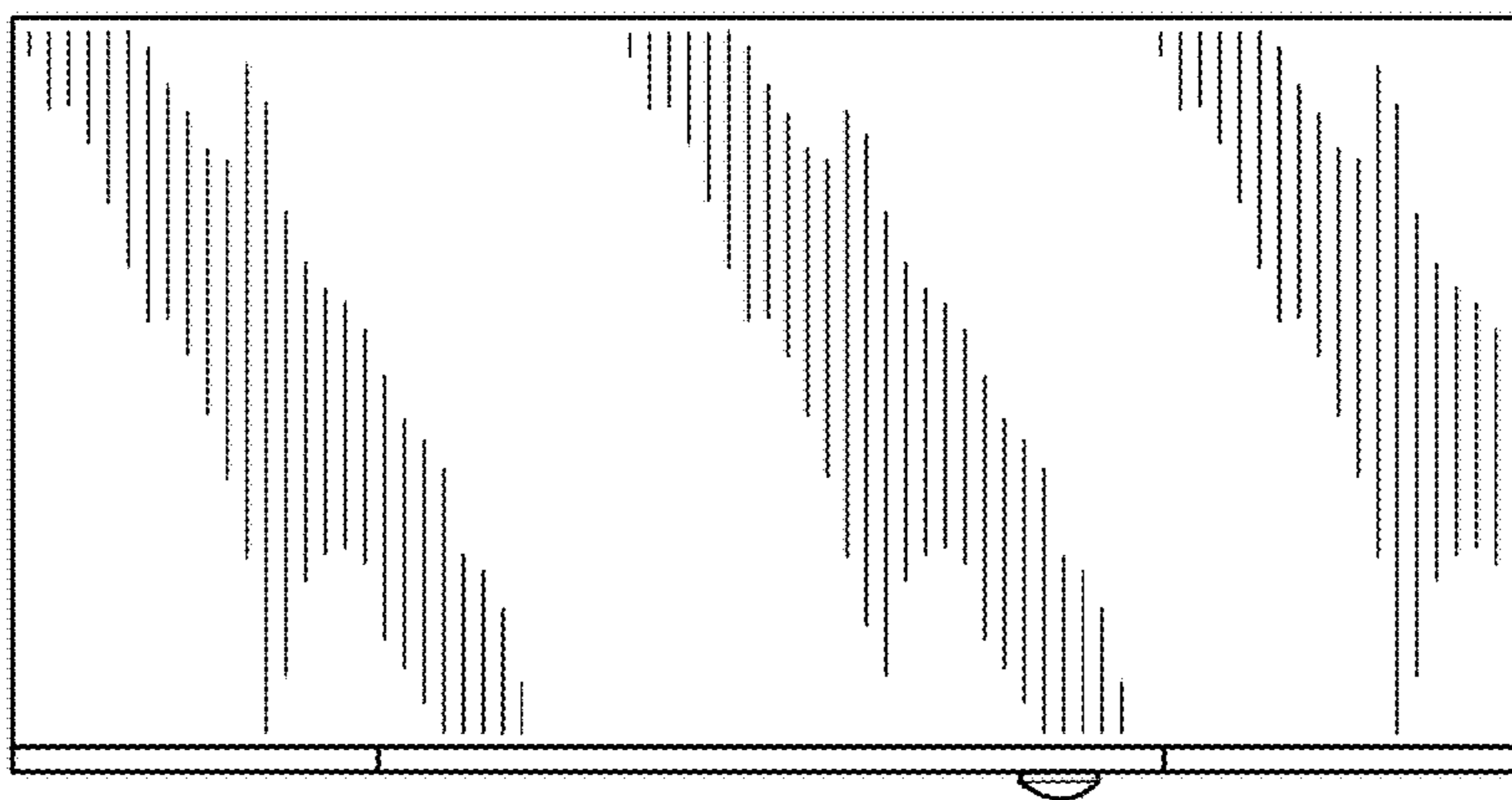

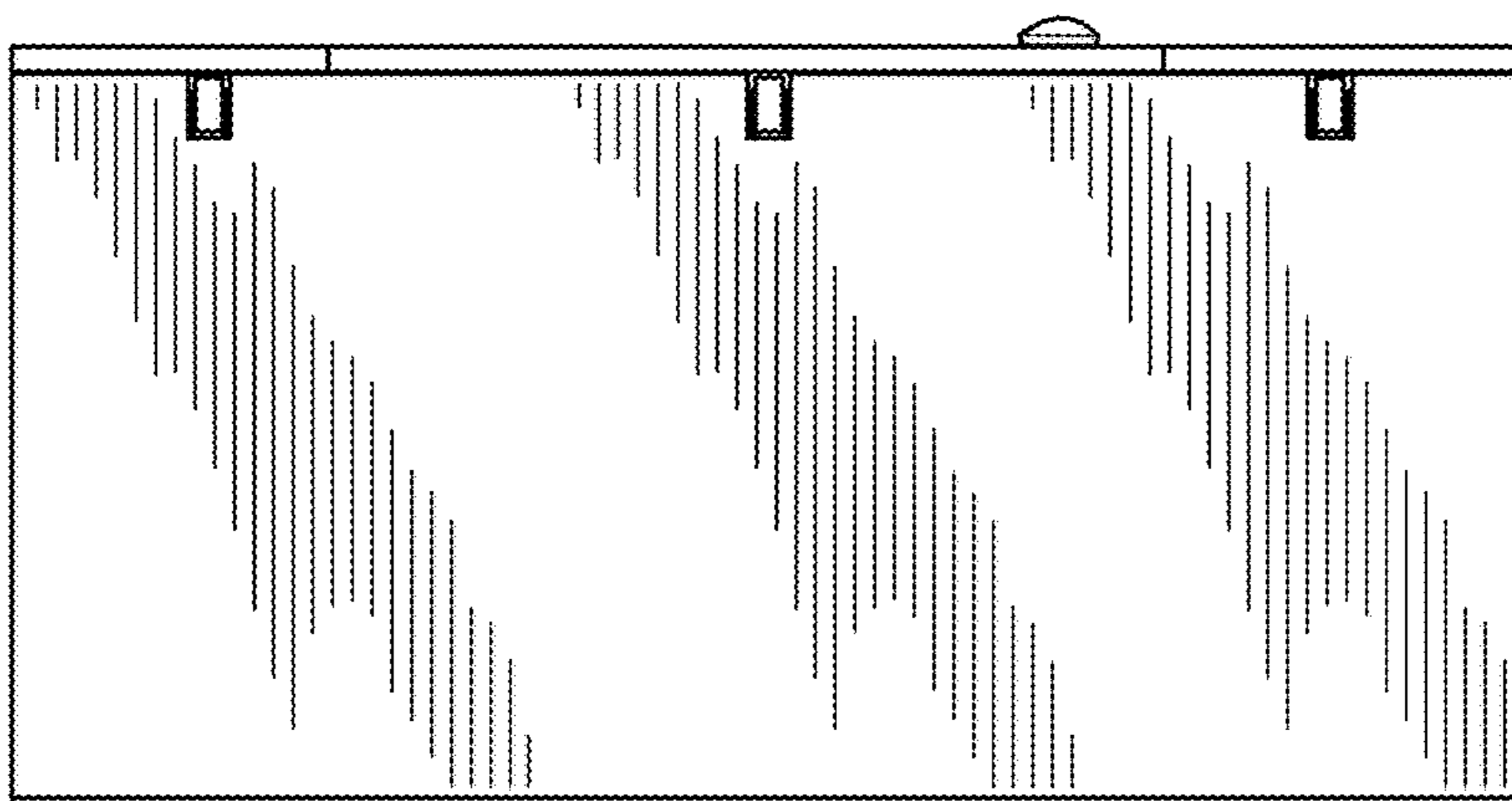

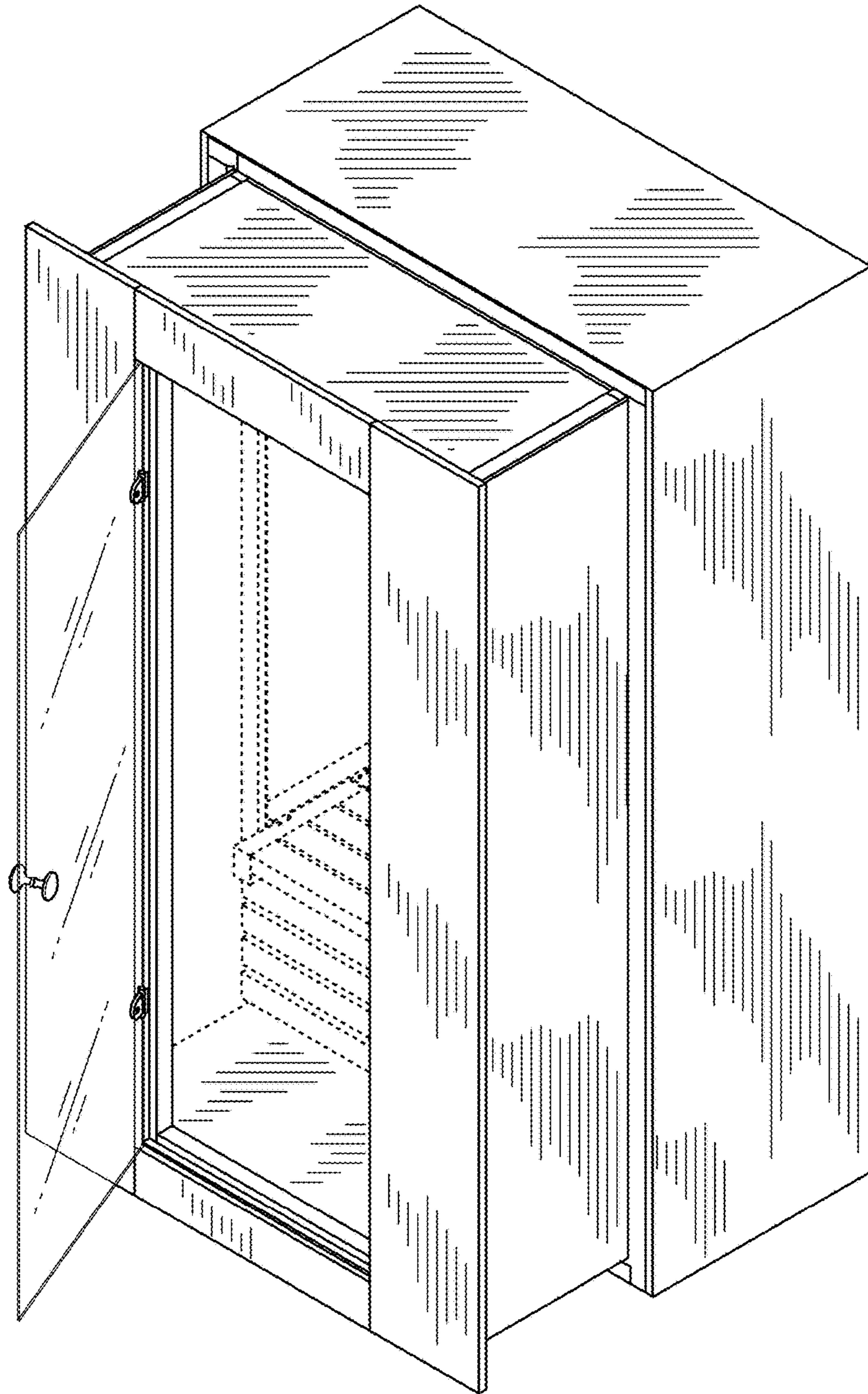

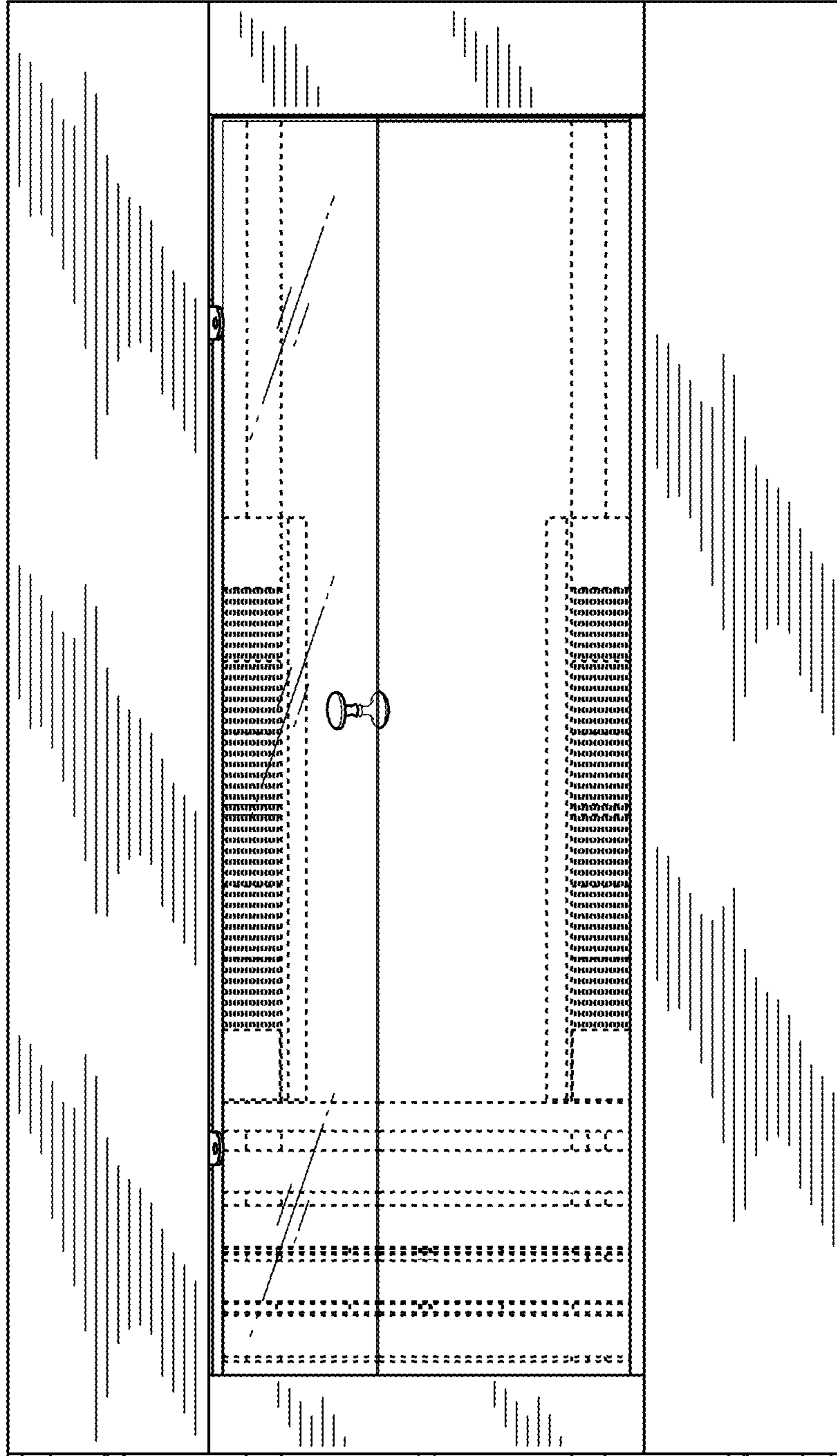

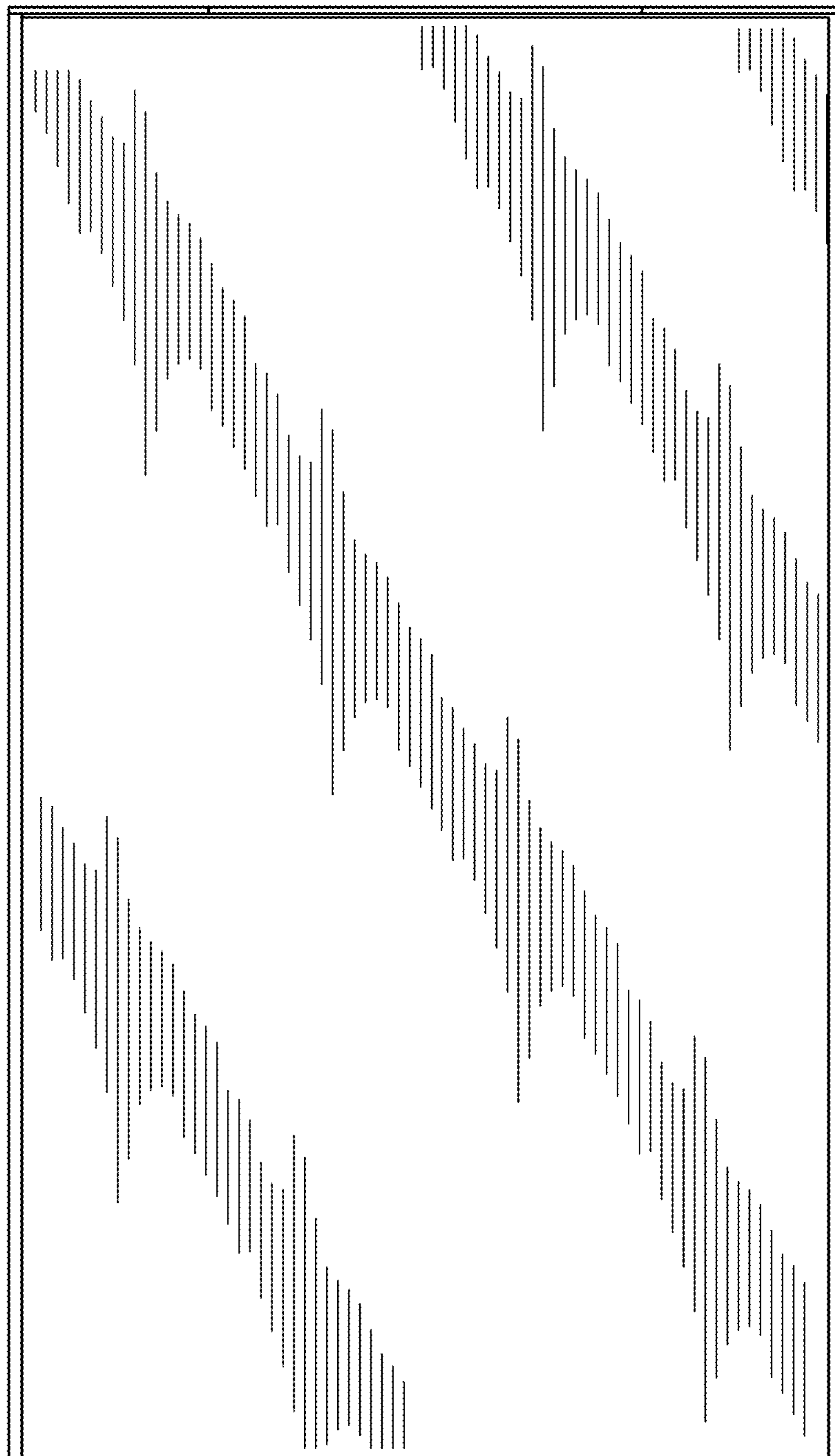

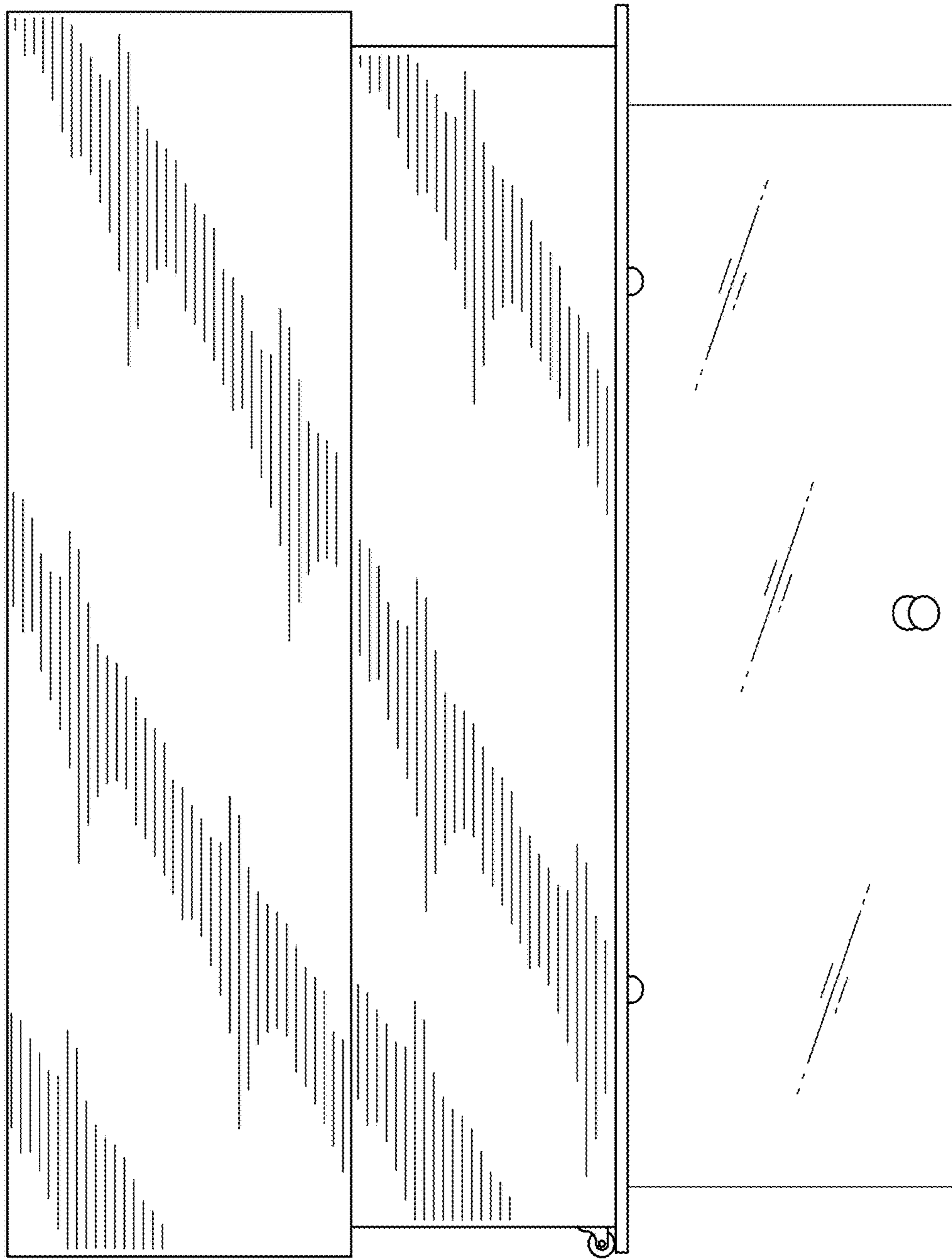

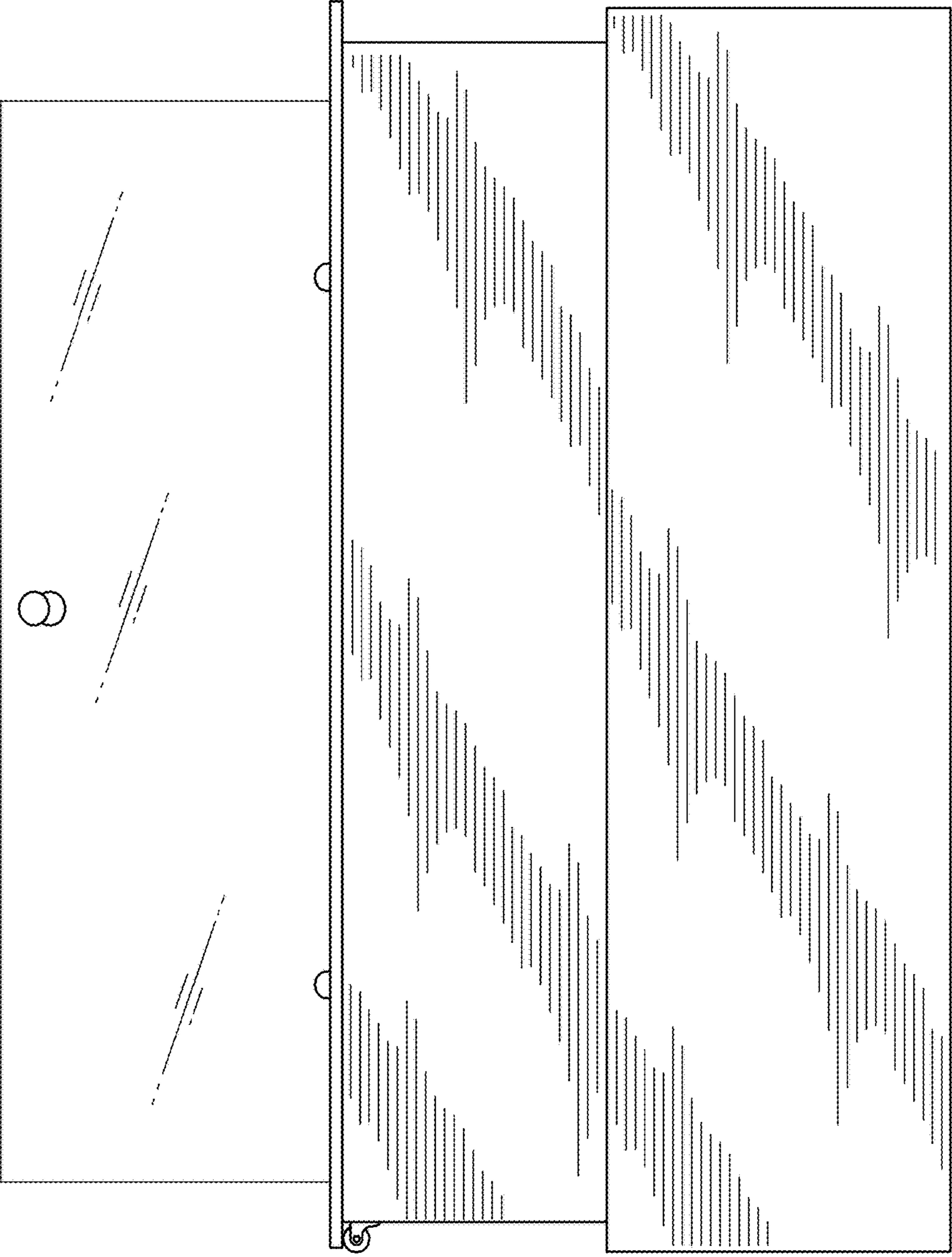

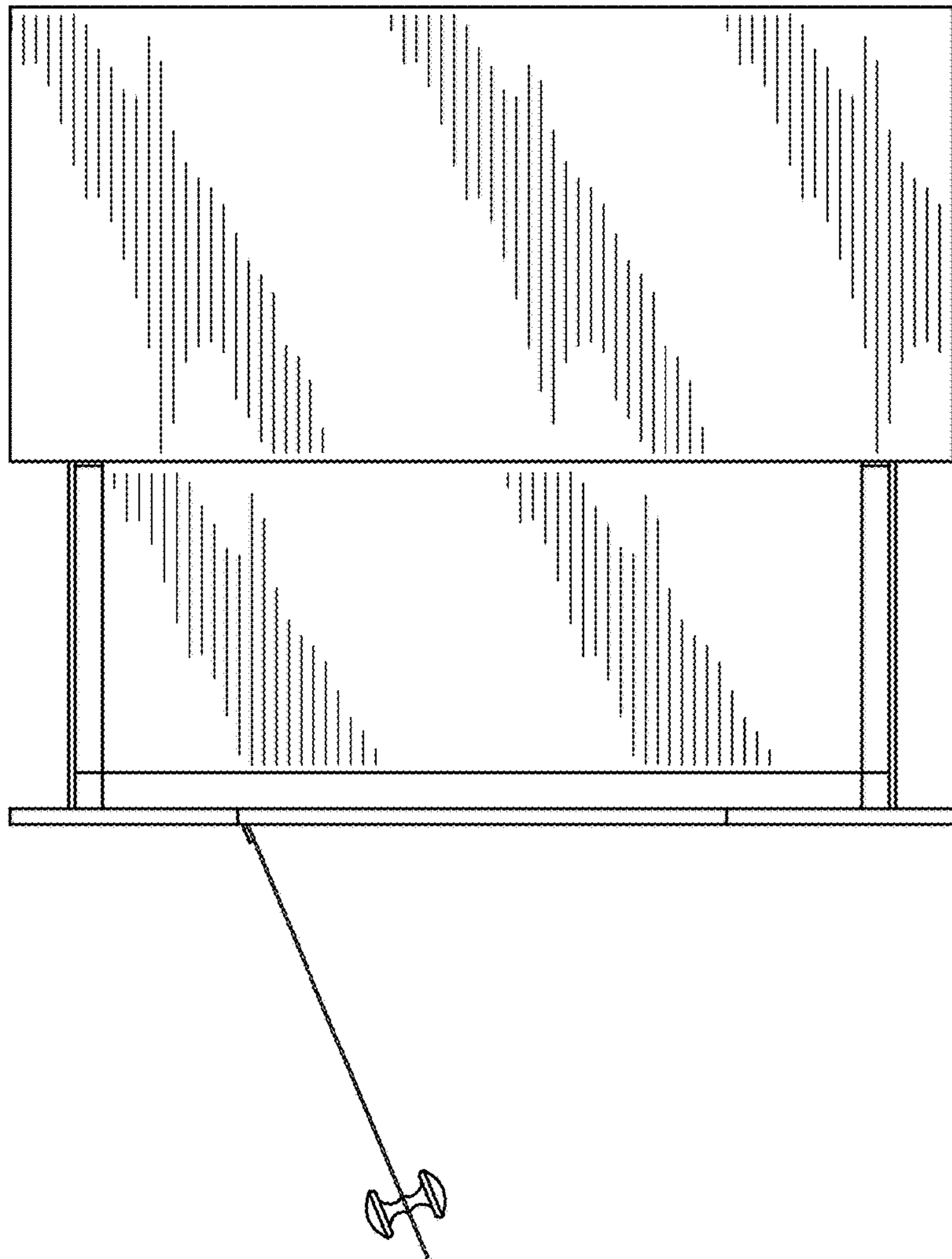

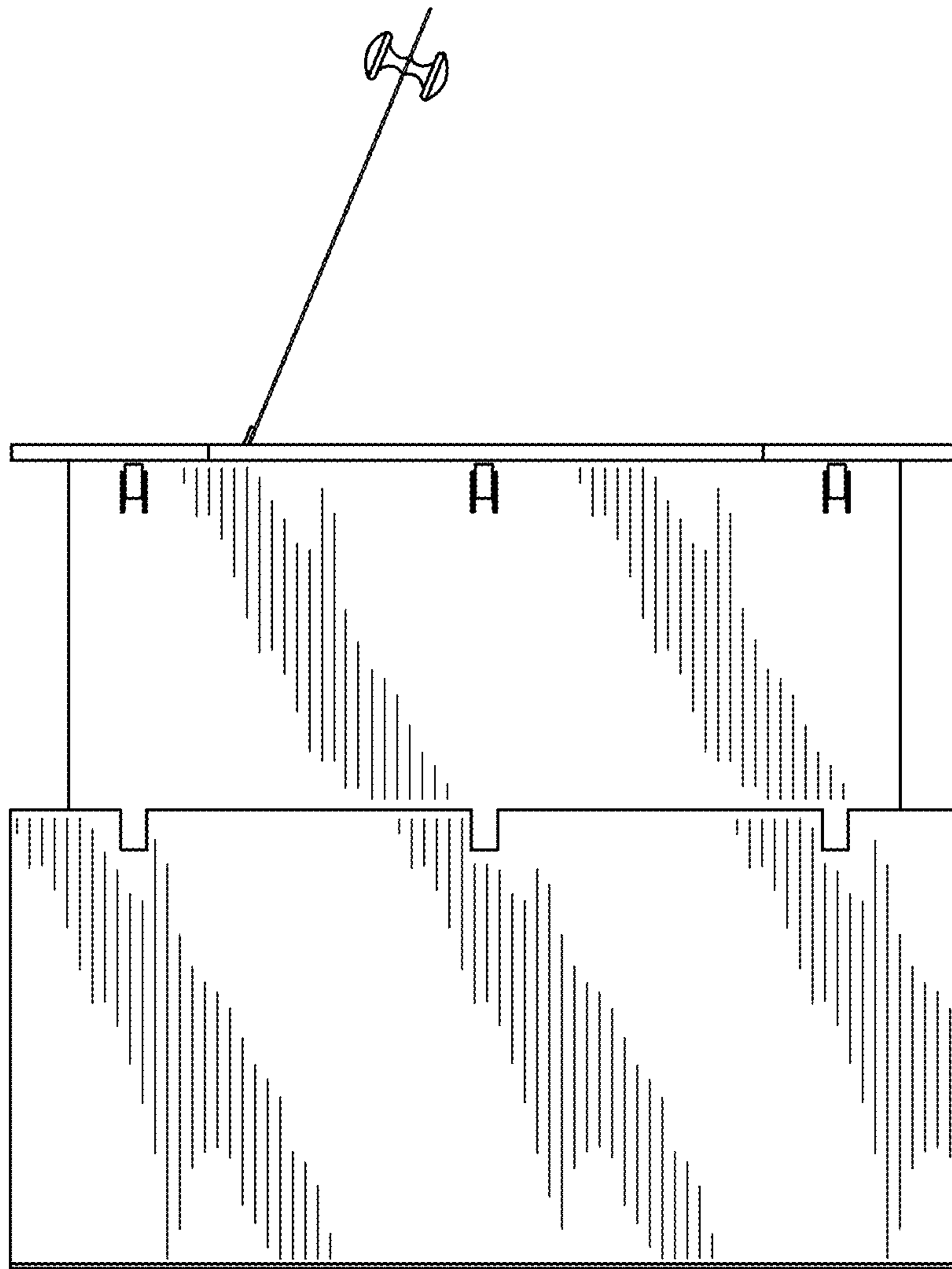

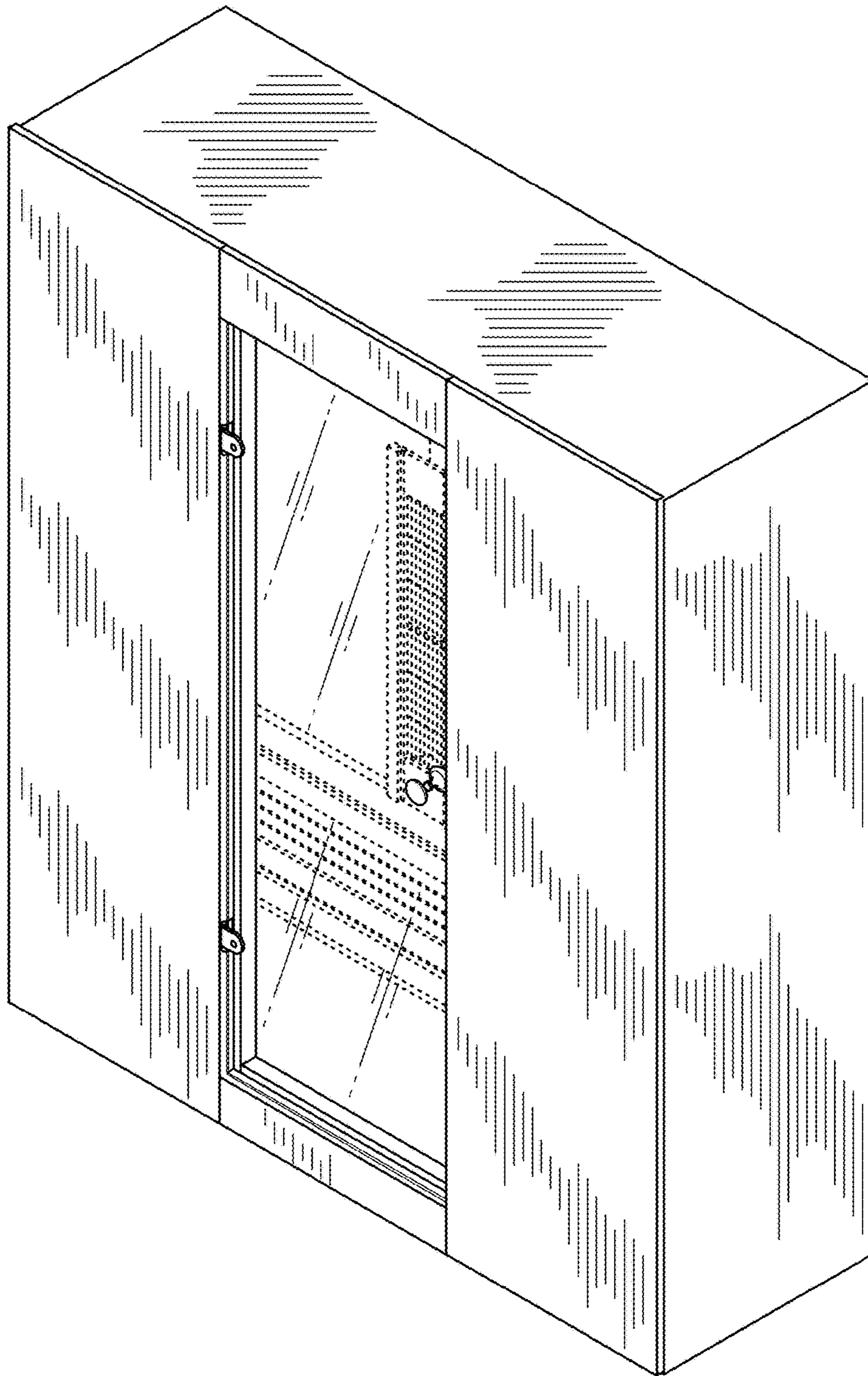

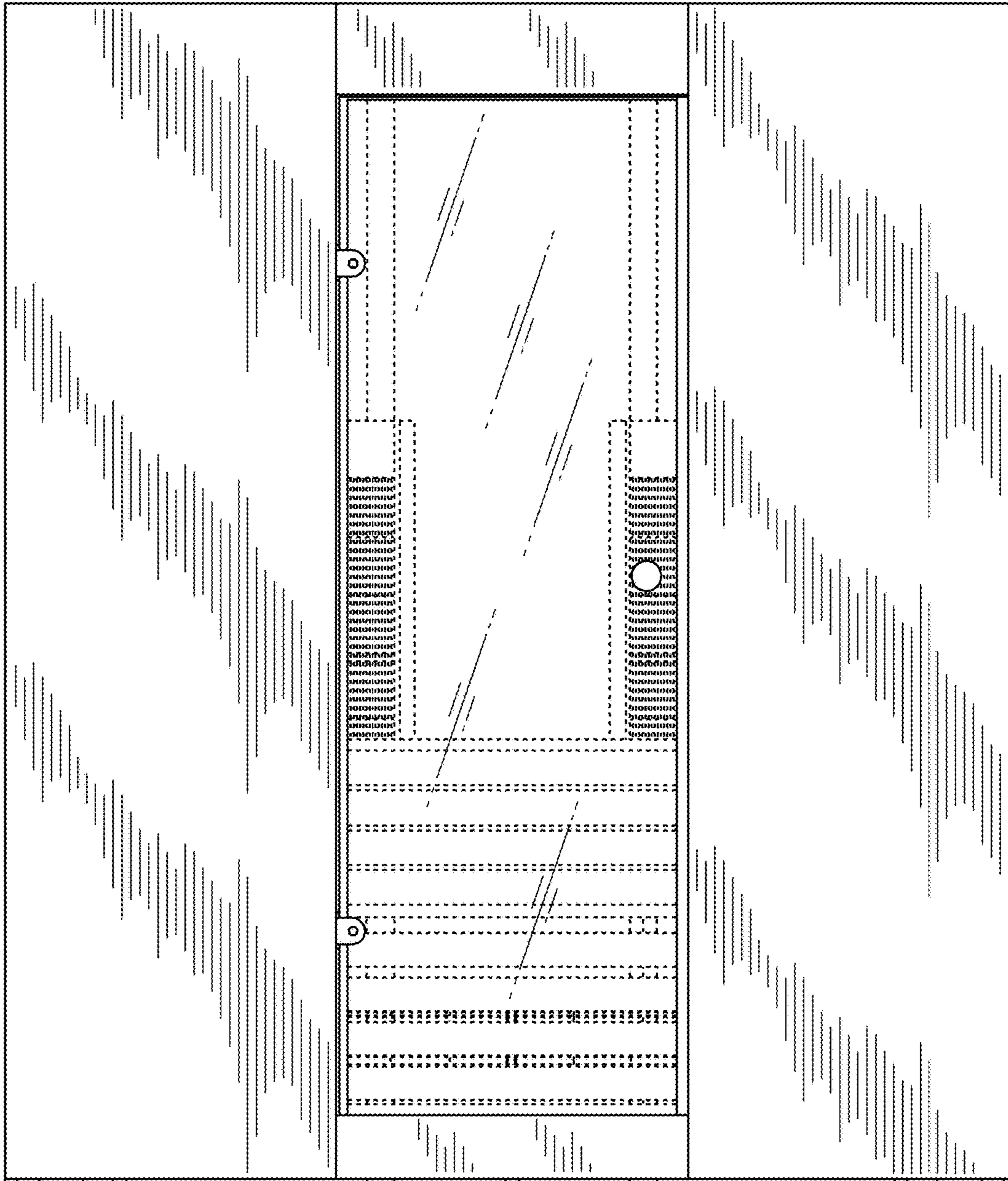

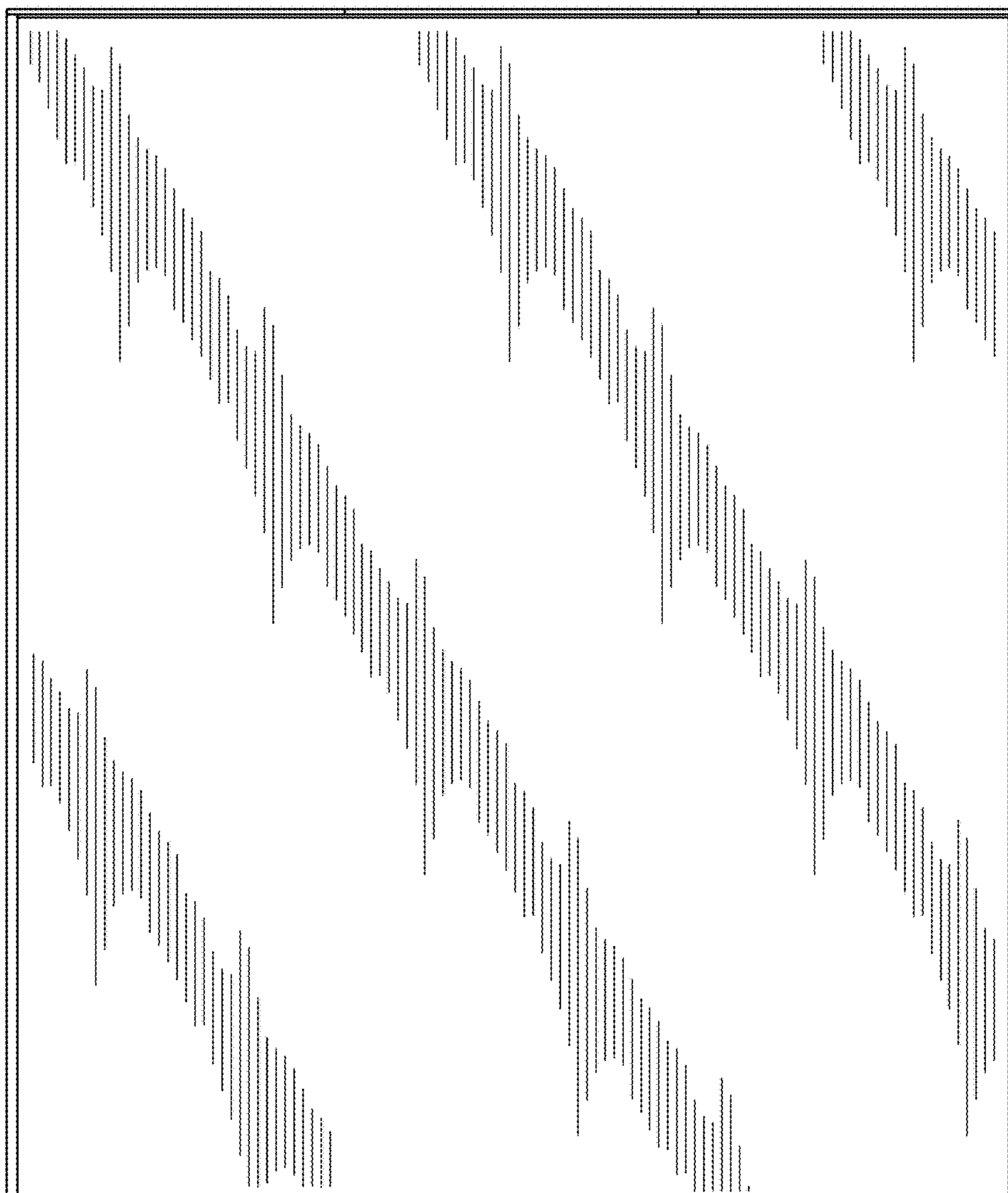

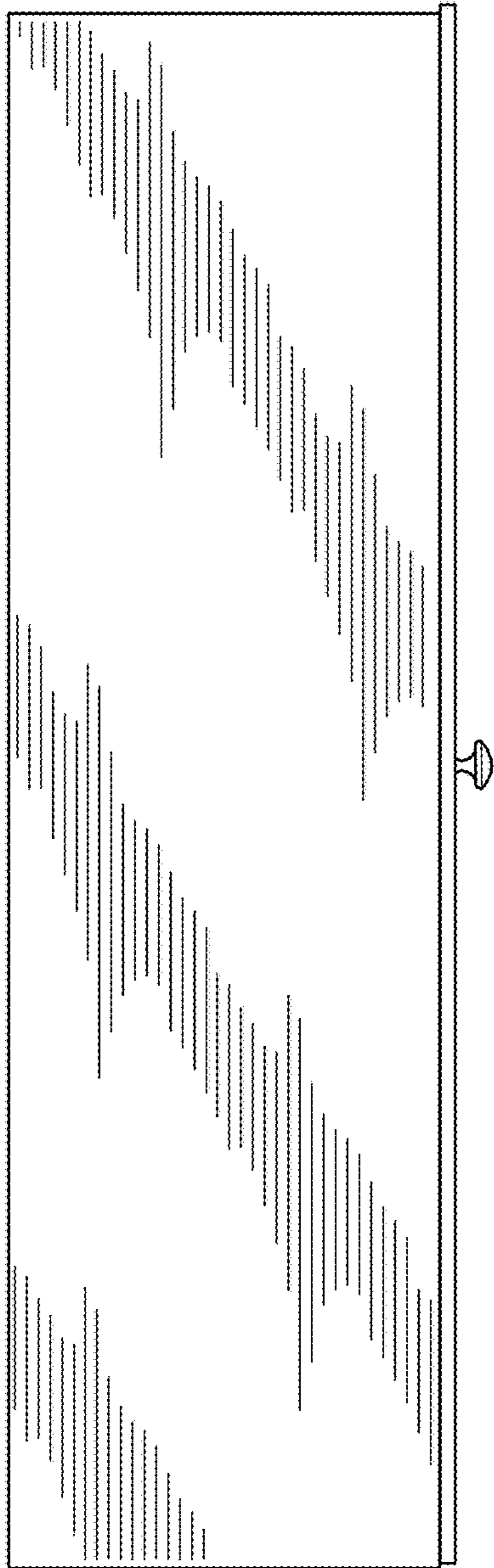

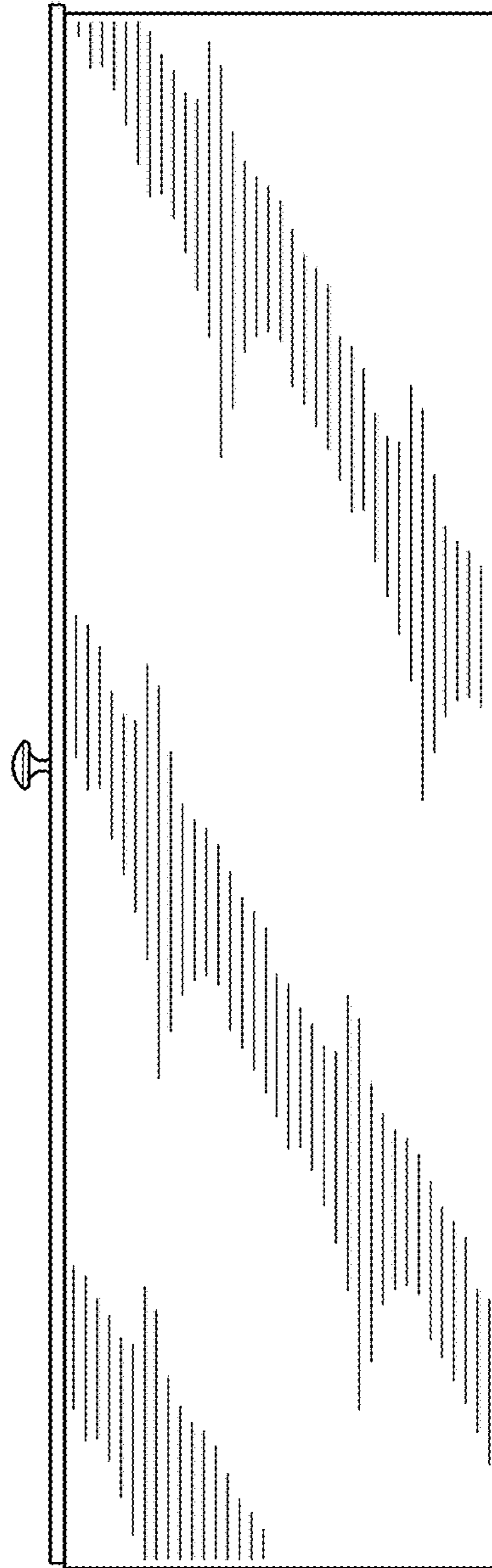

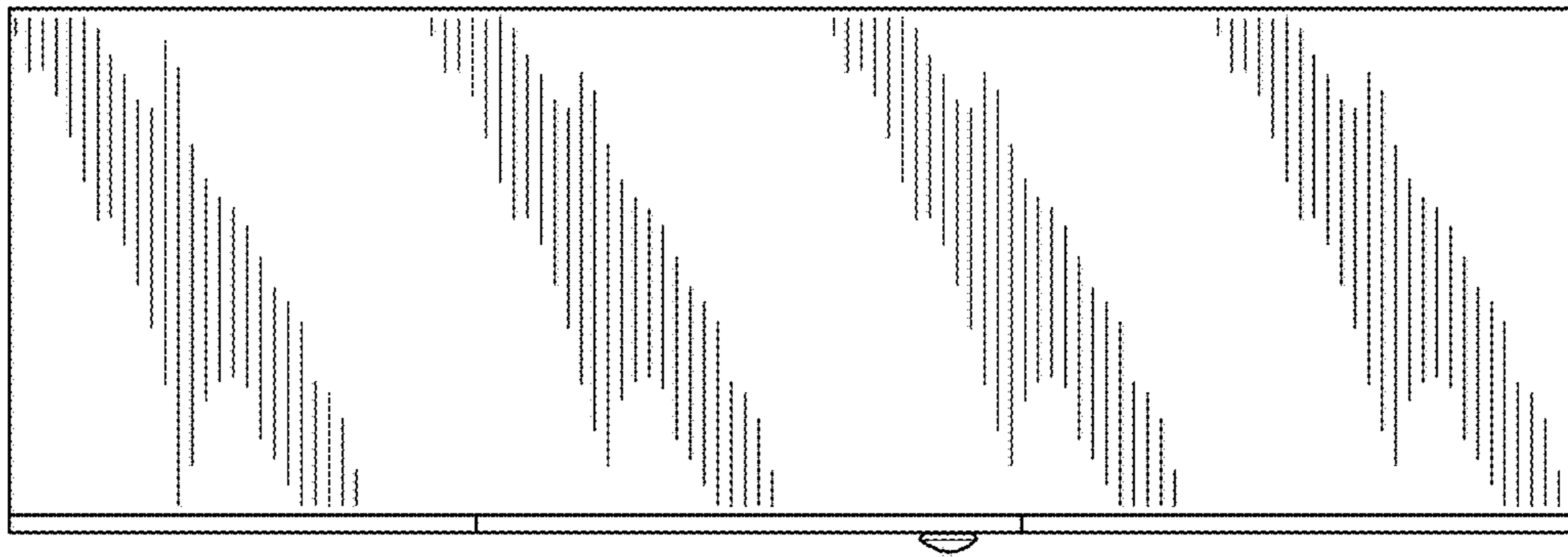

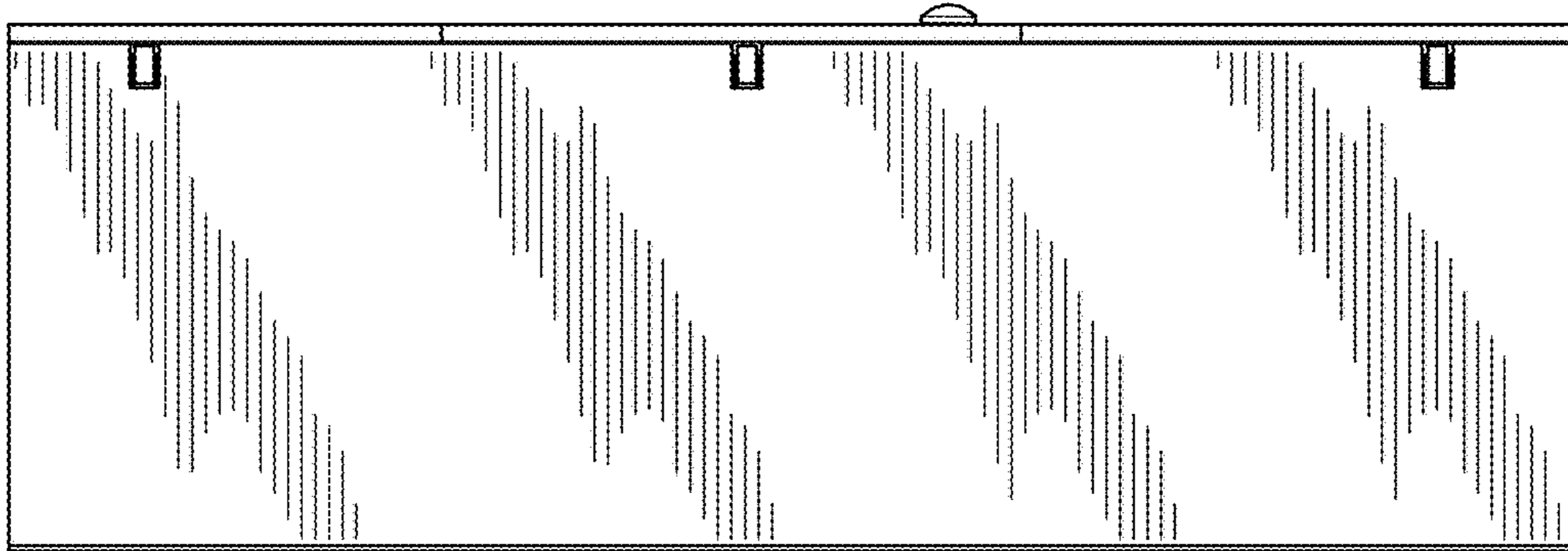

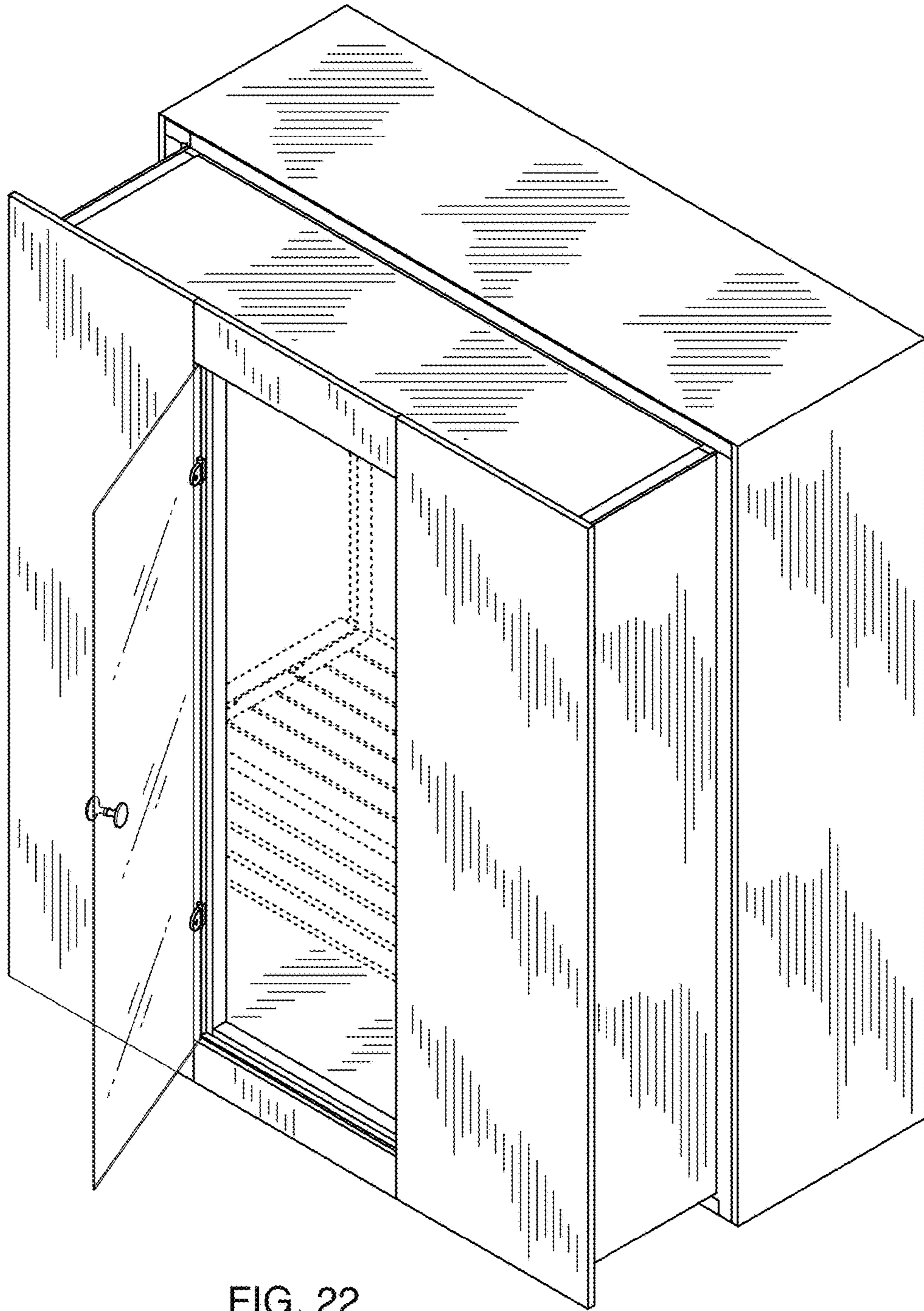

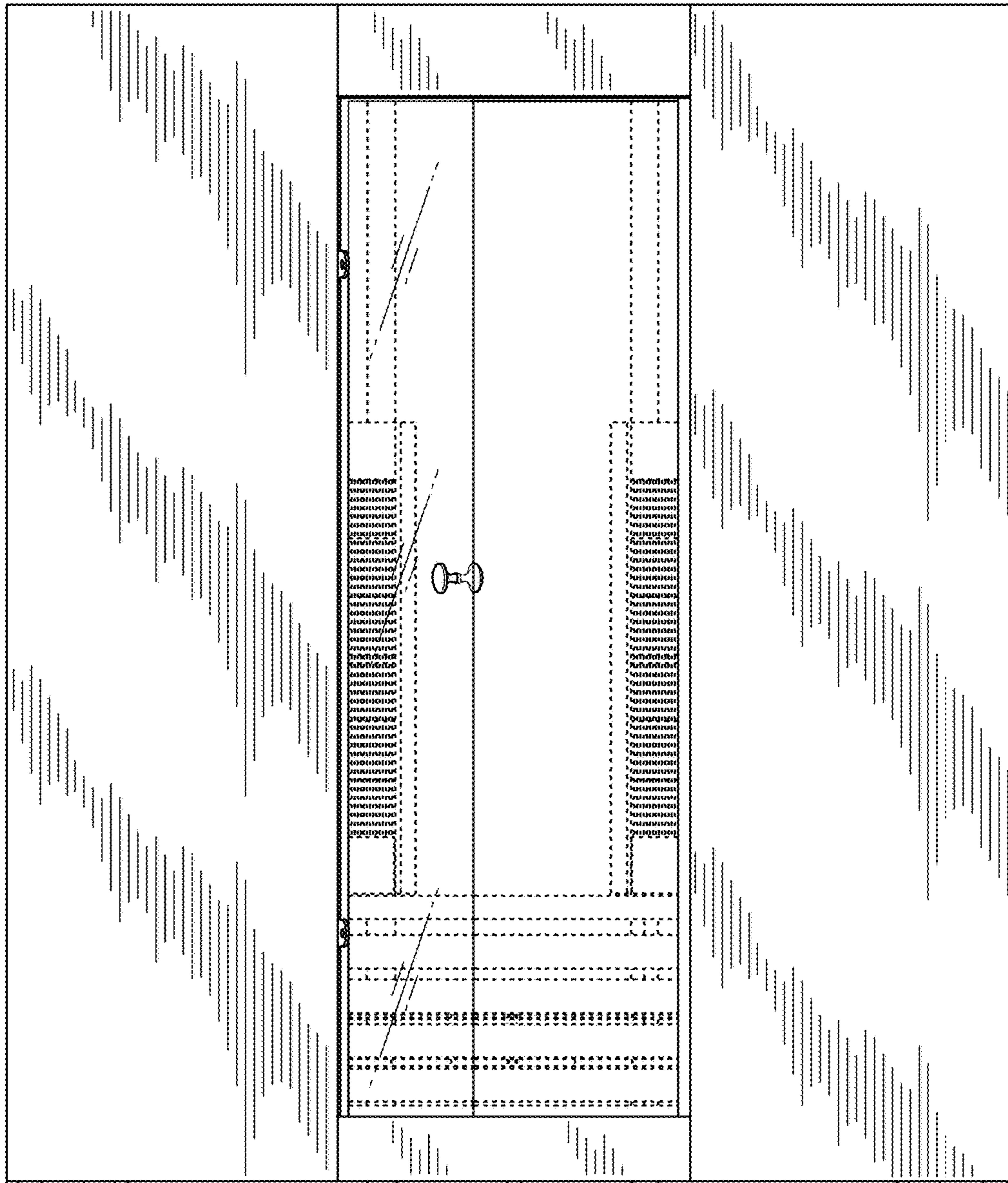

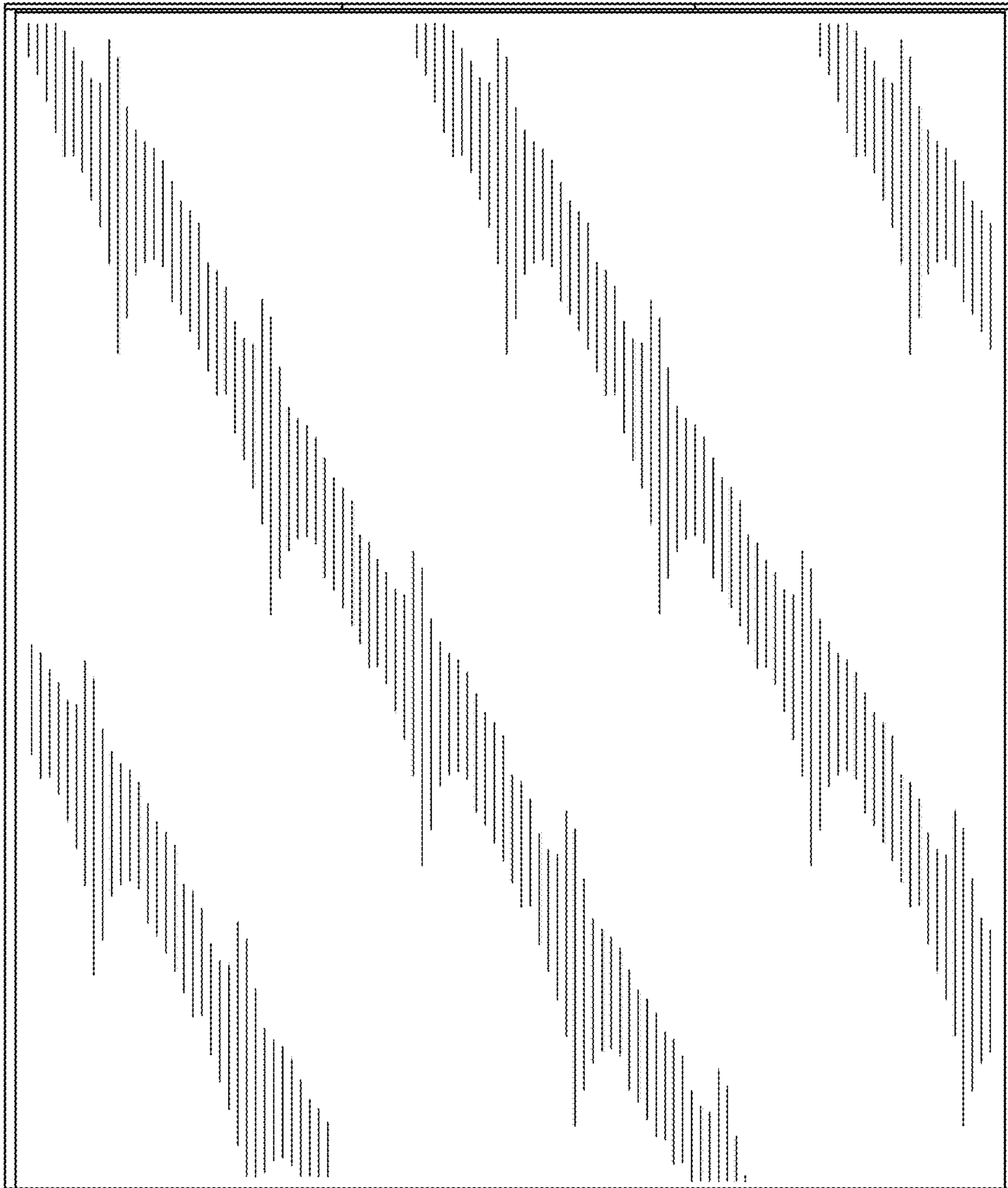

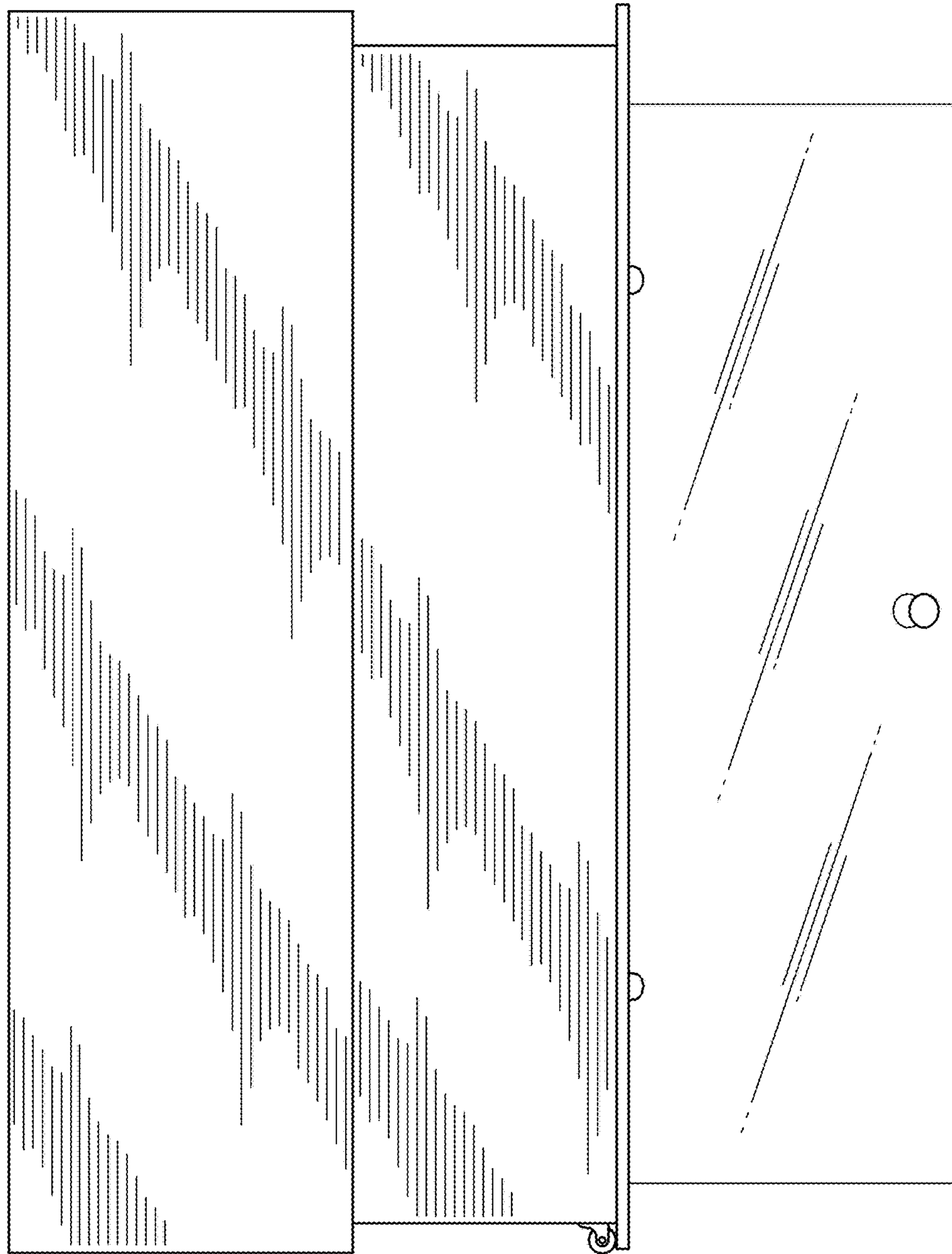

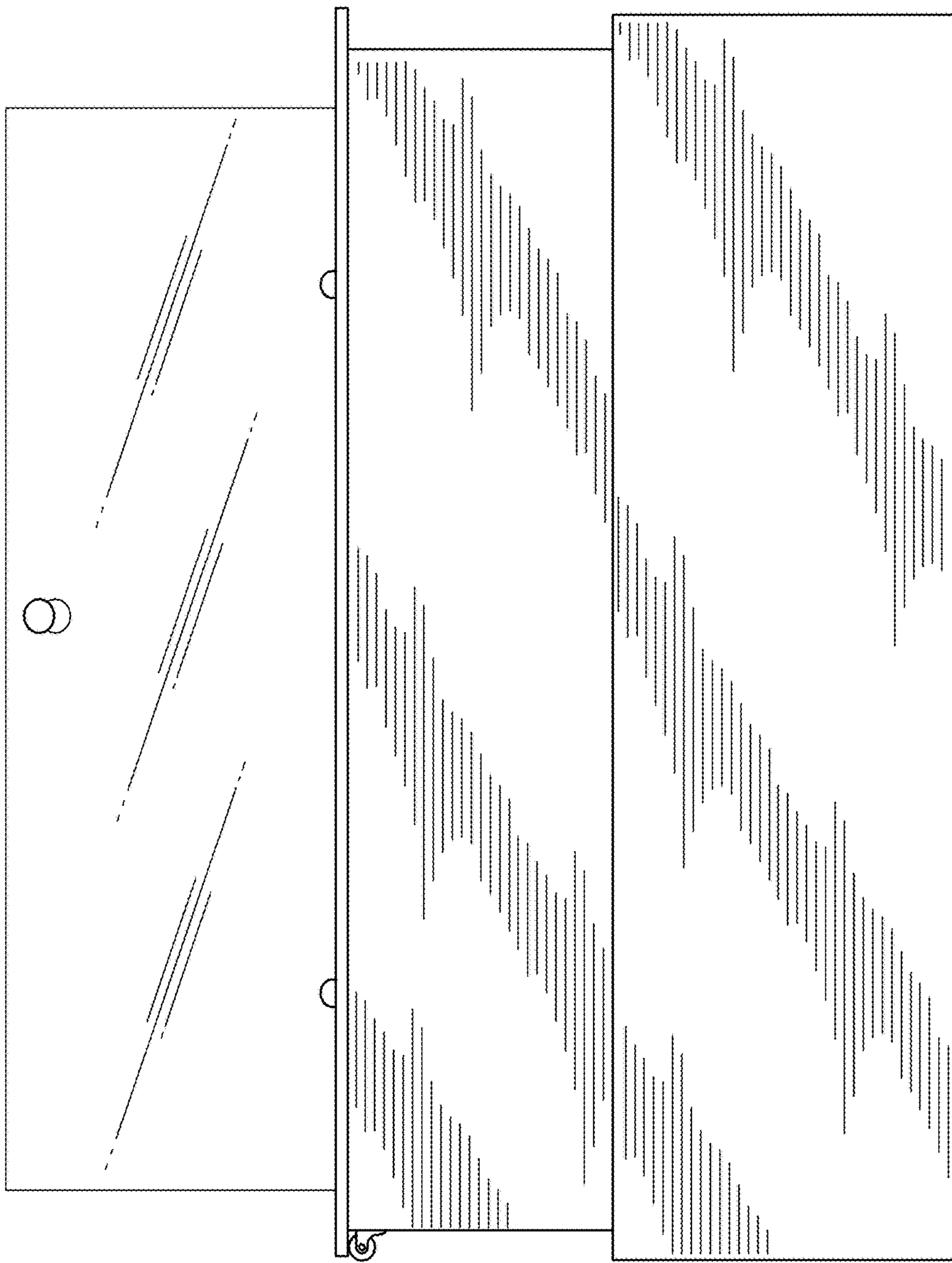

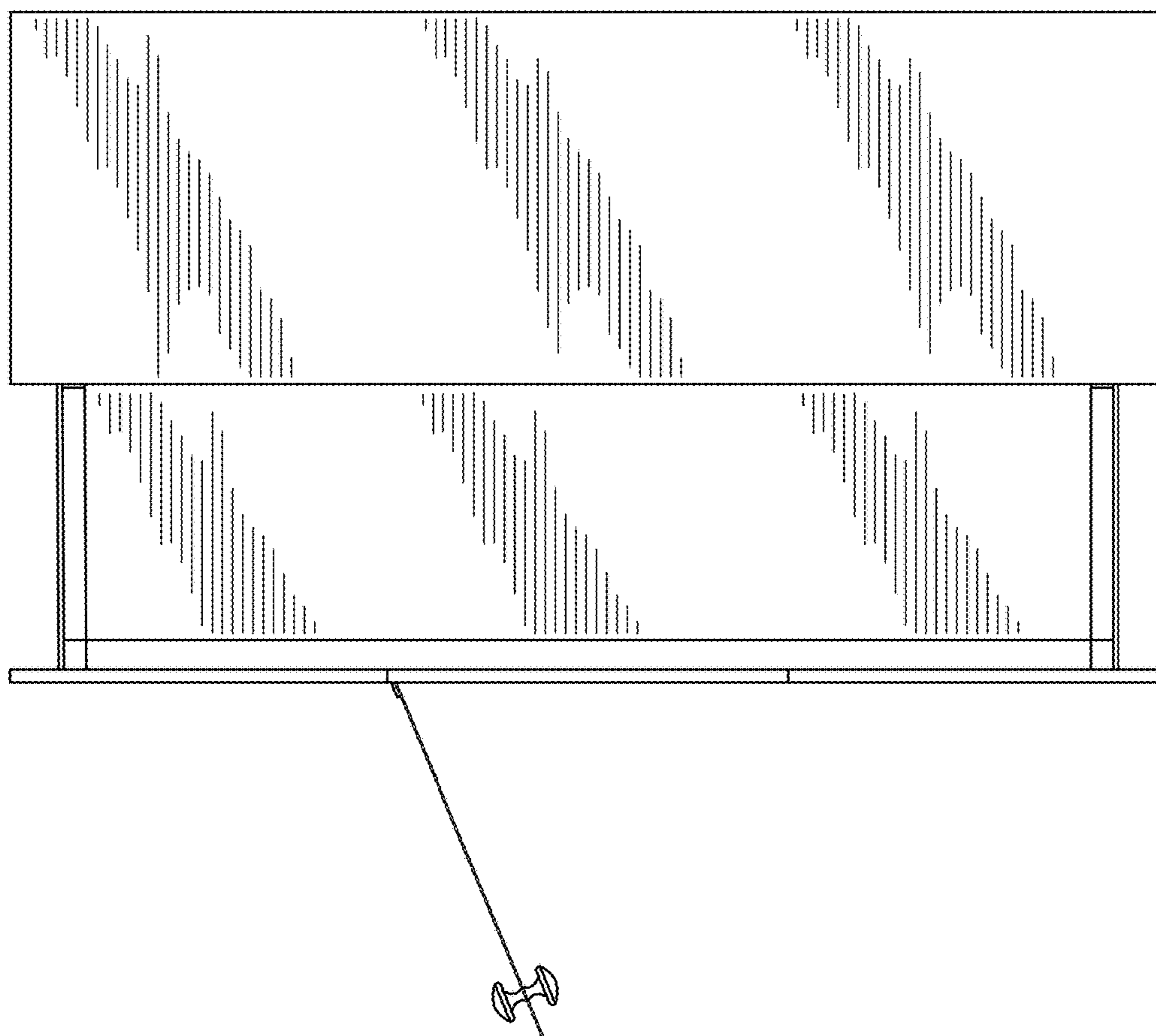

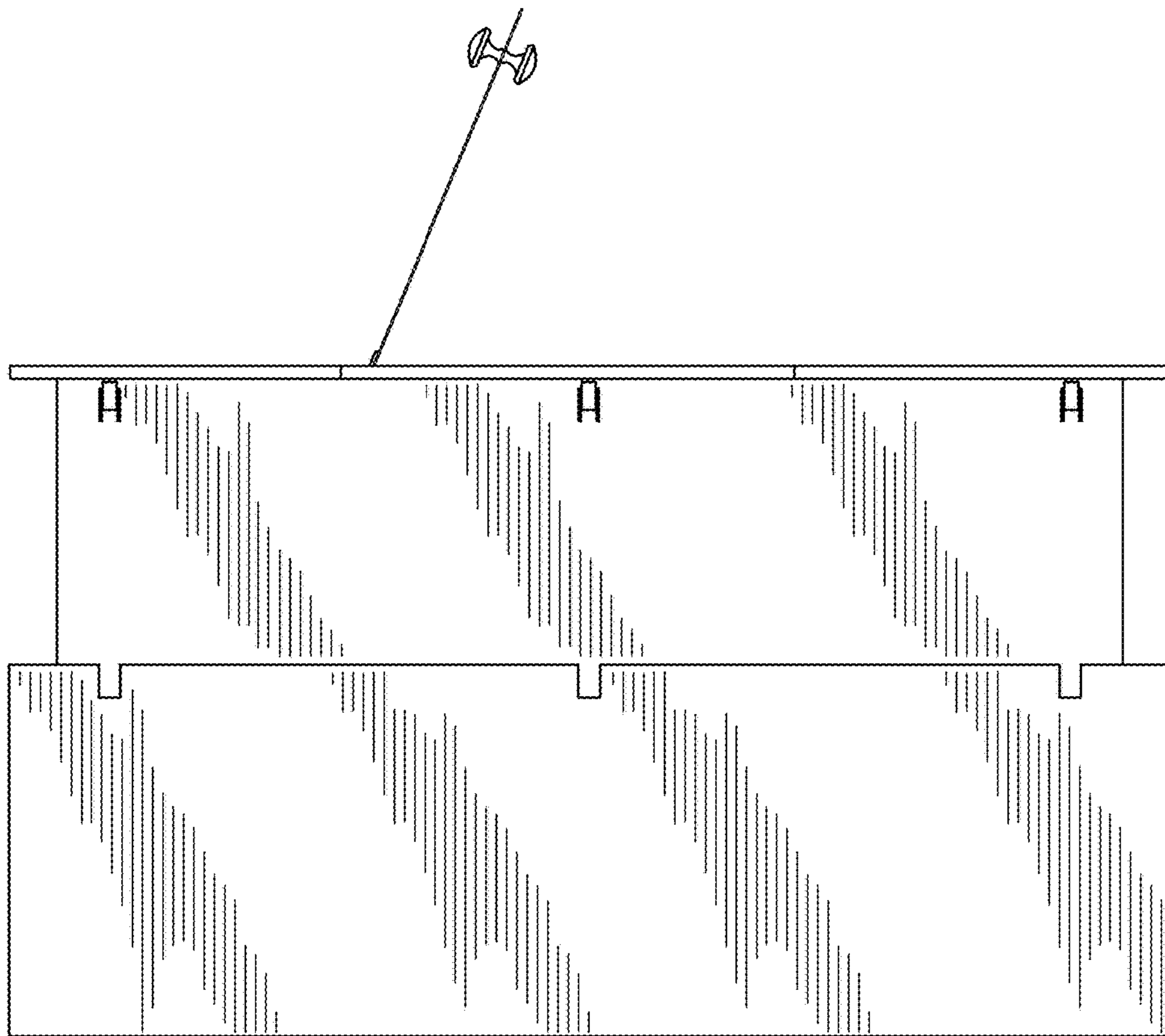
