The ornamental design for a cigarette roller, as shown.

DESCRIPTION

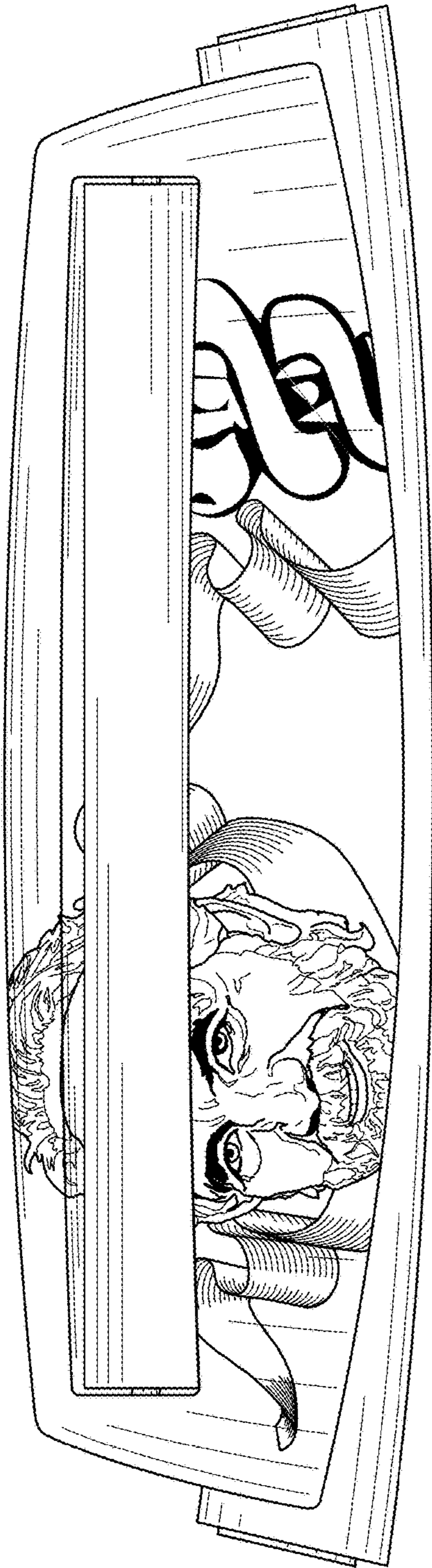

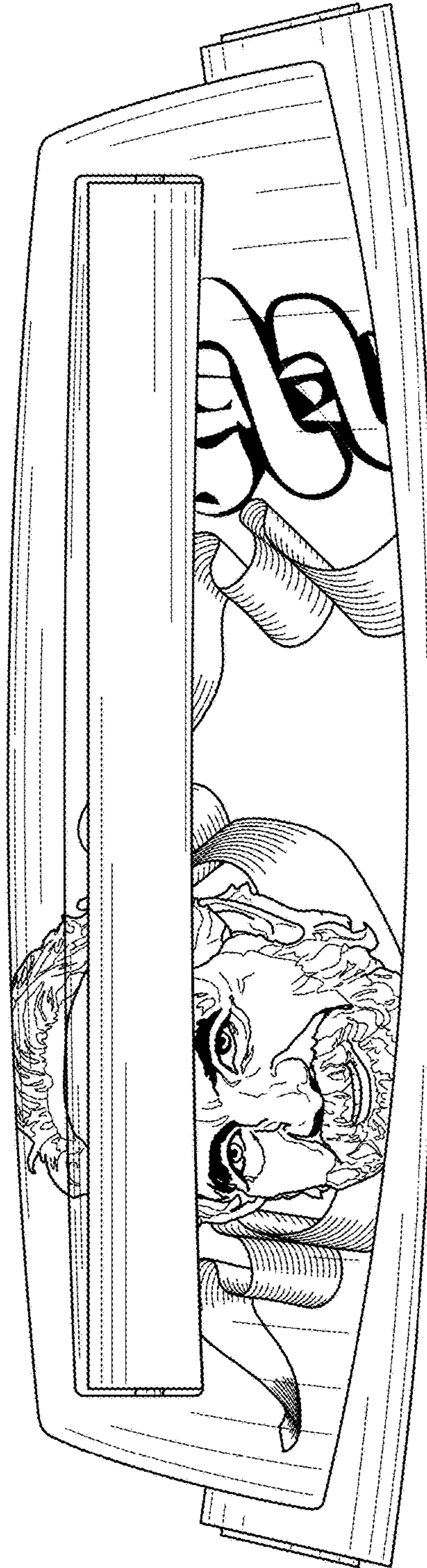

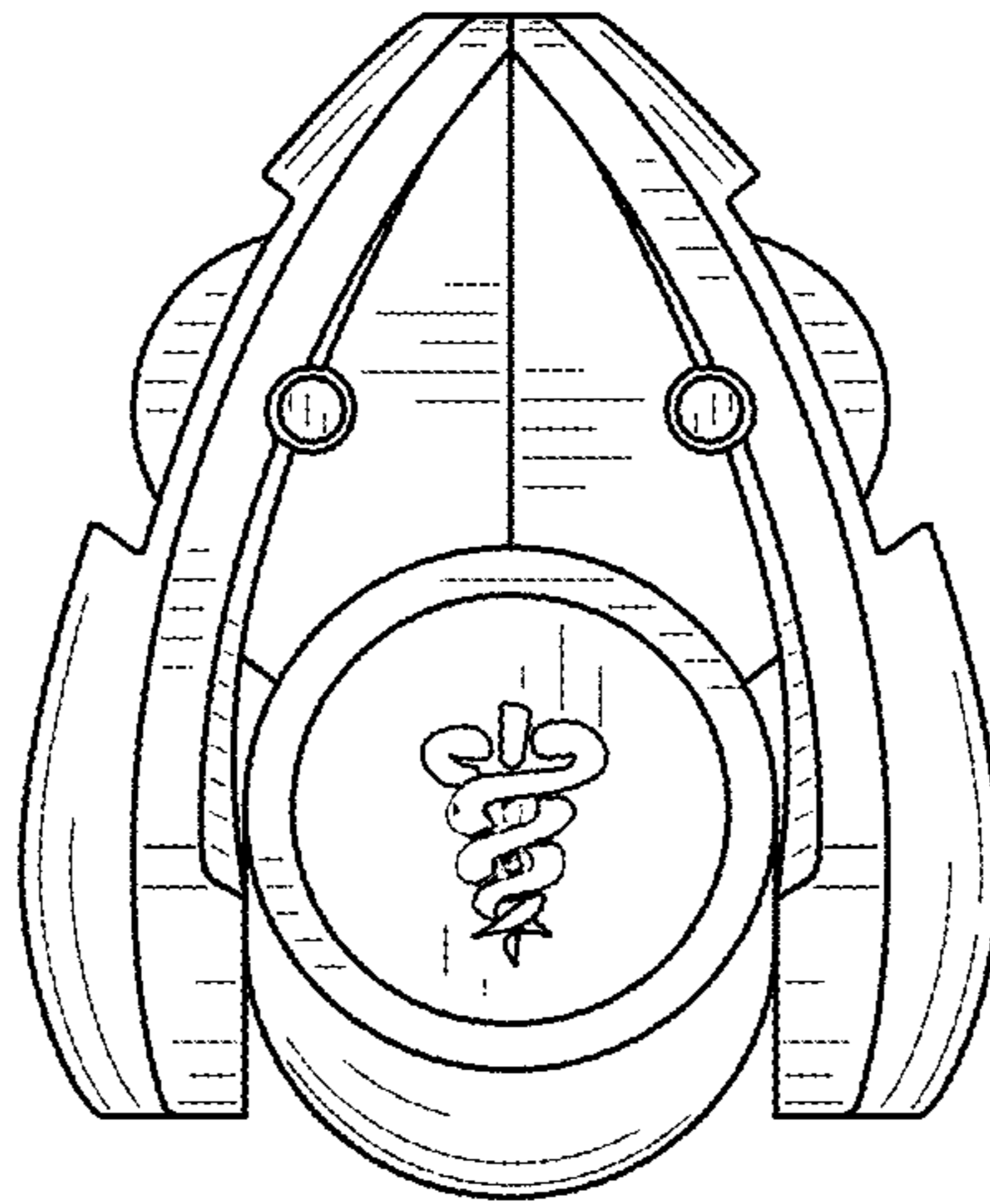

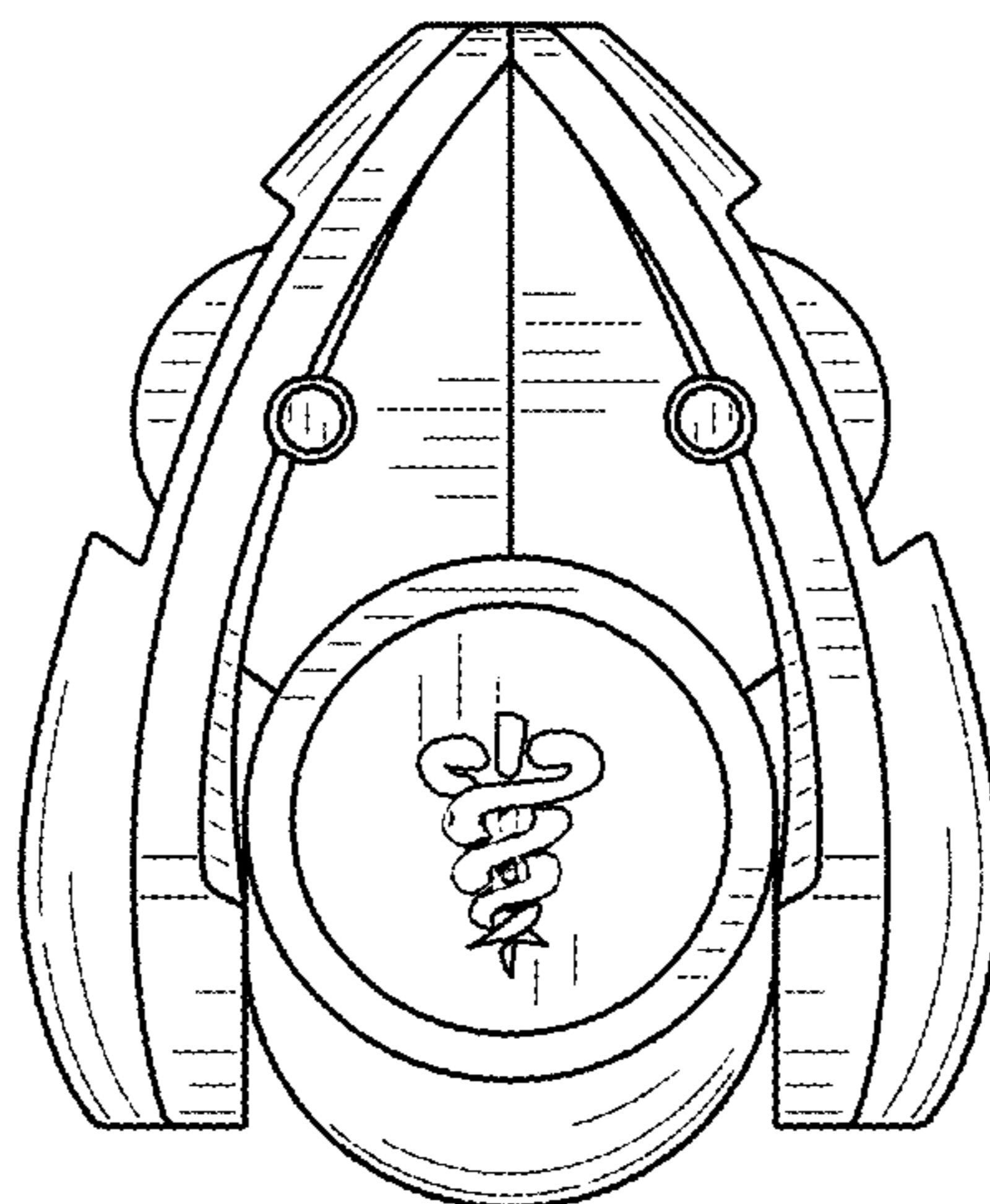

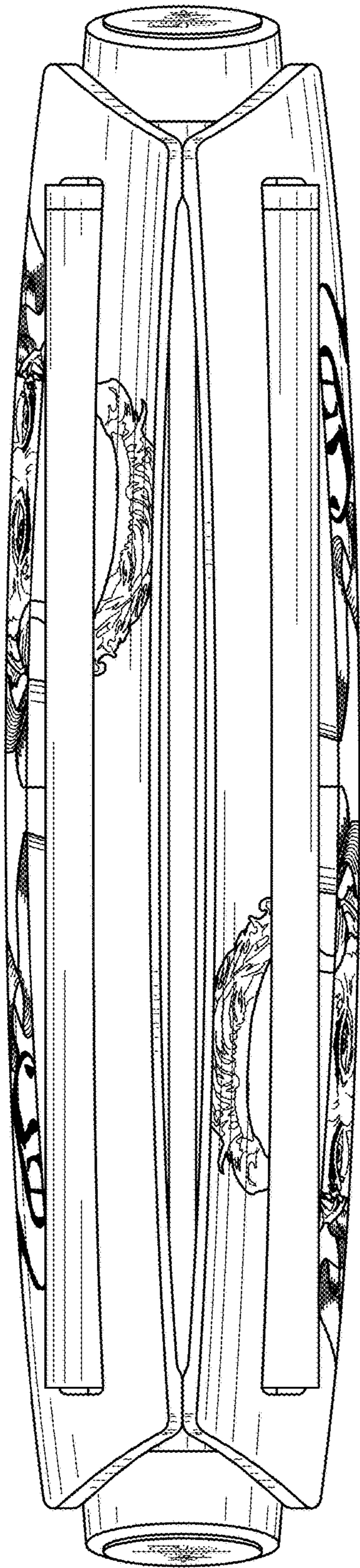

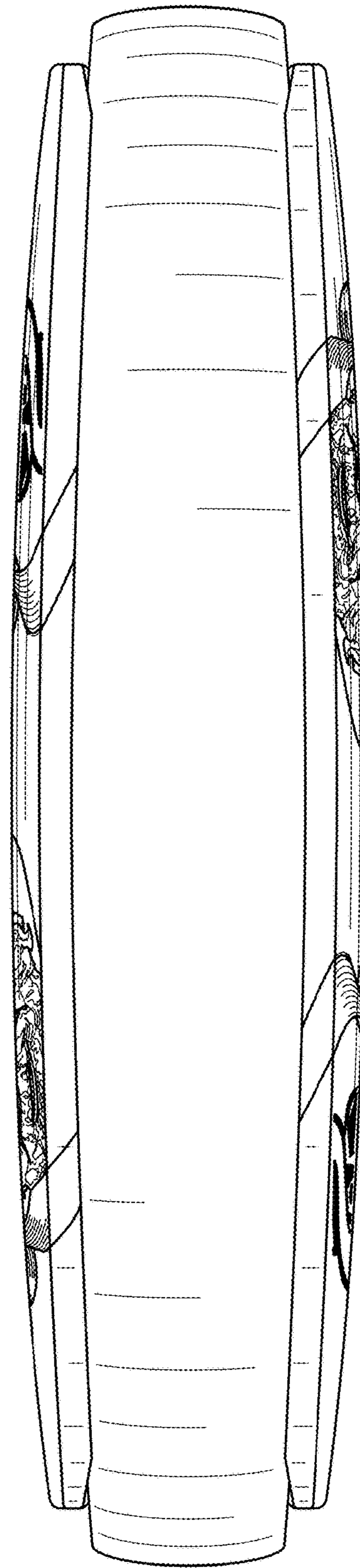

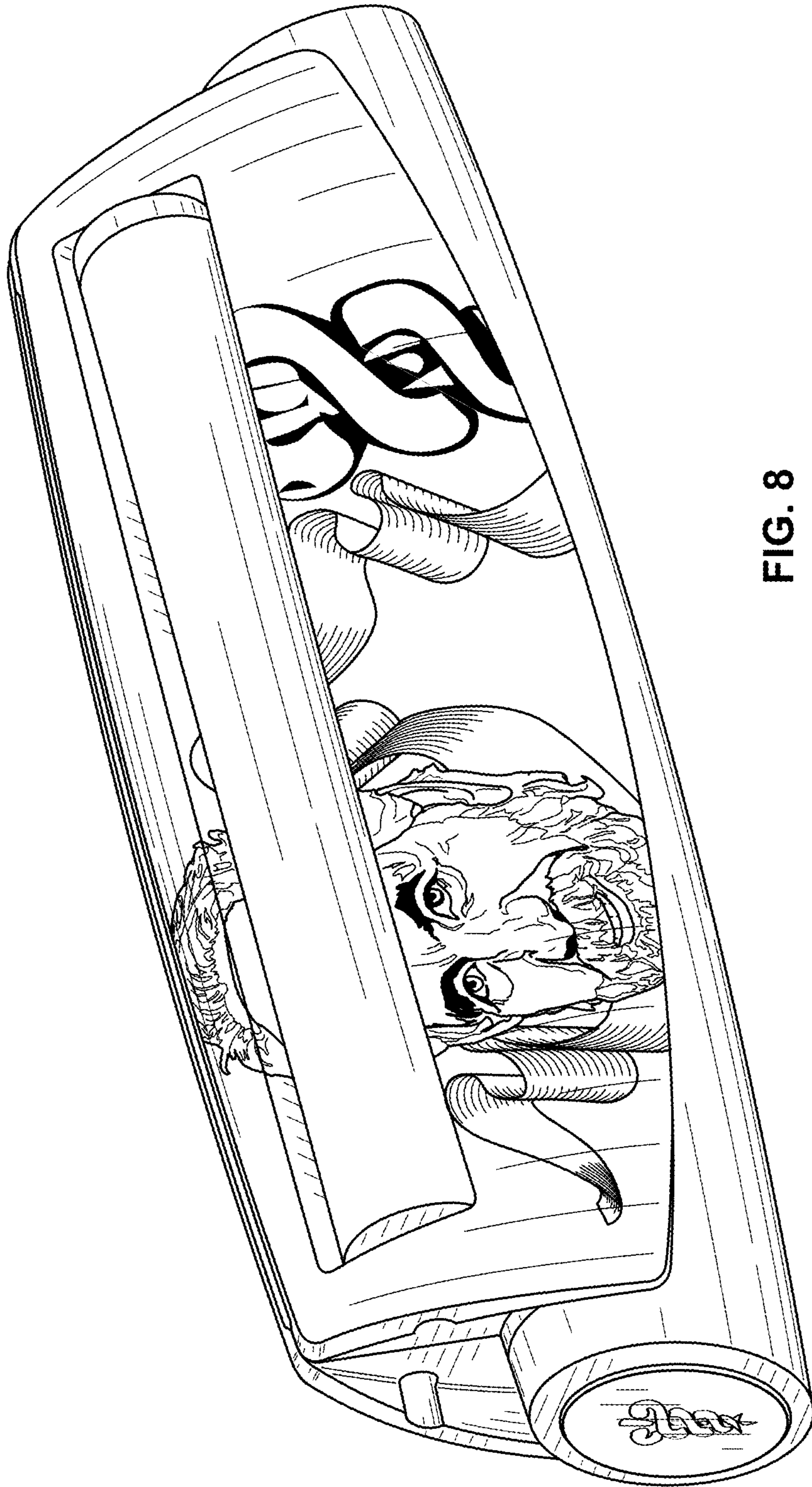

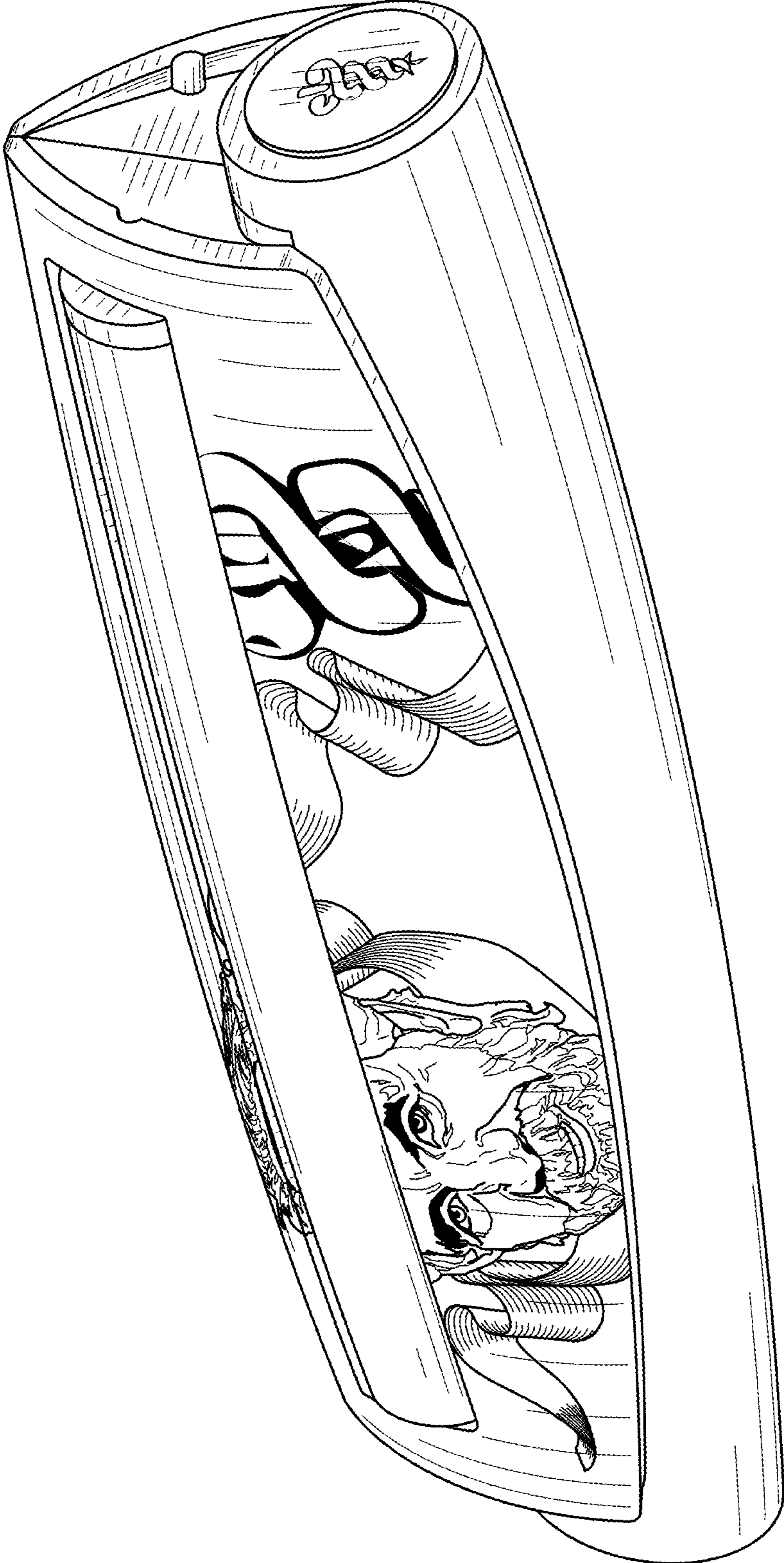

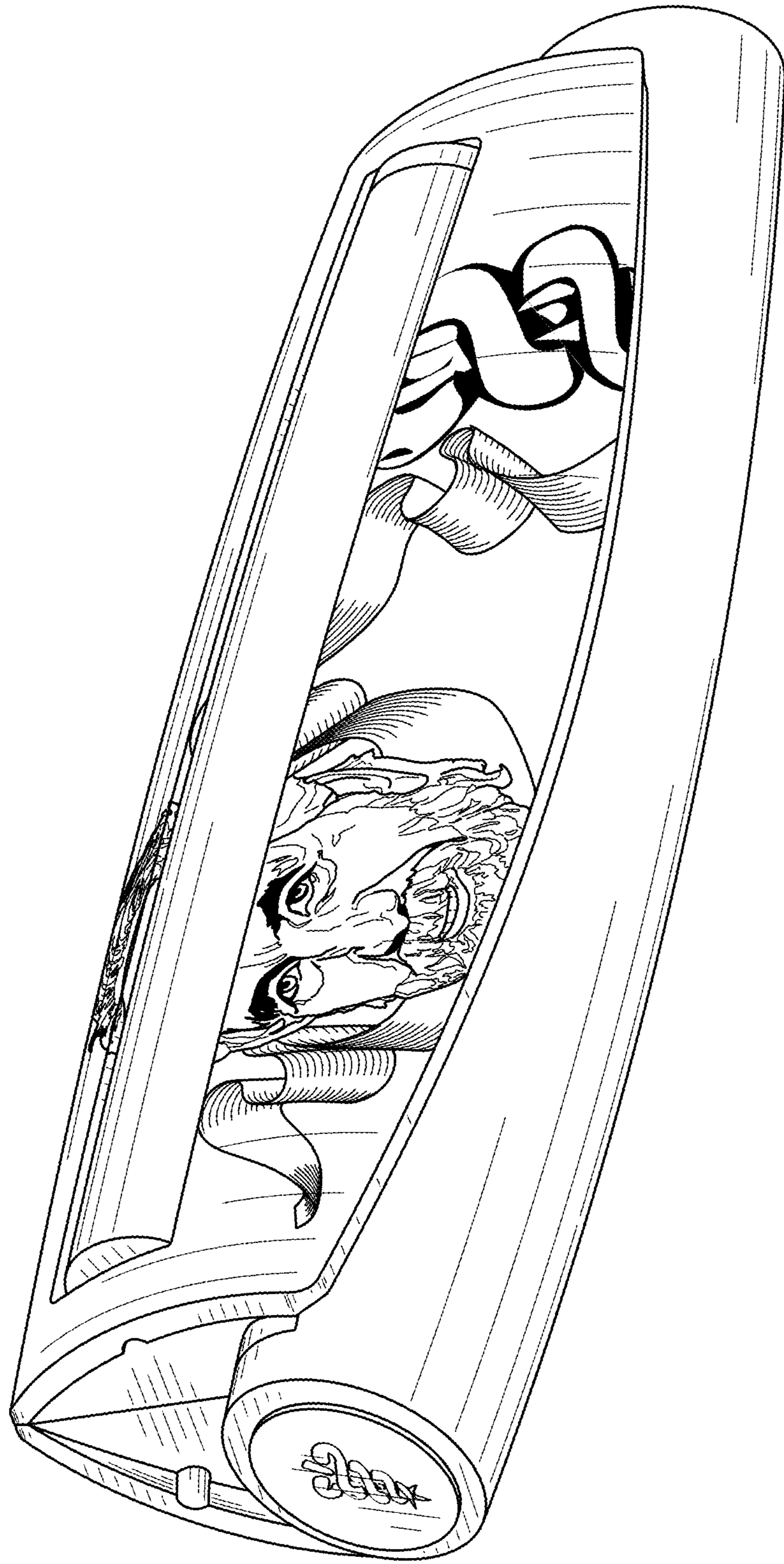

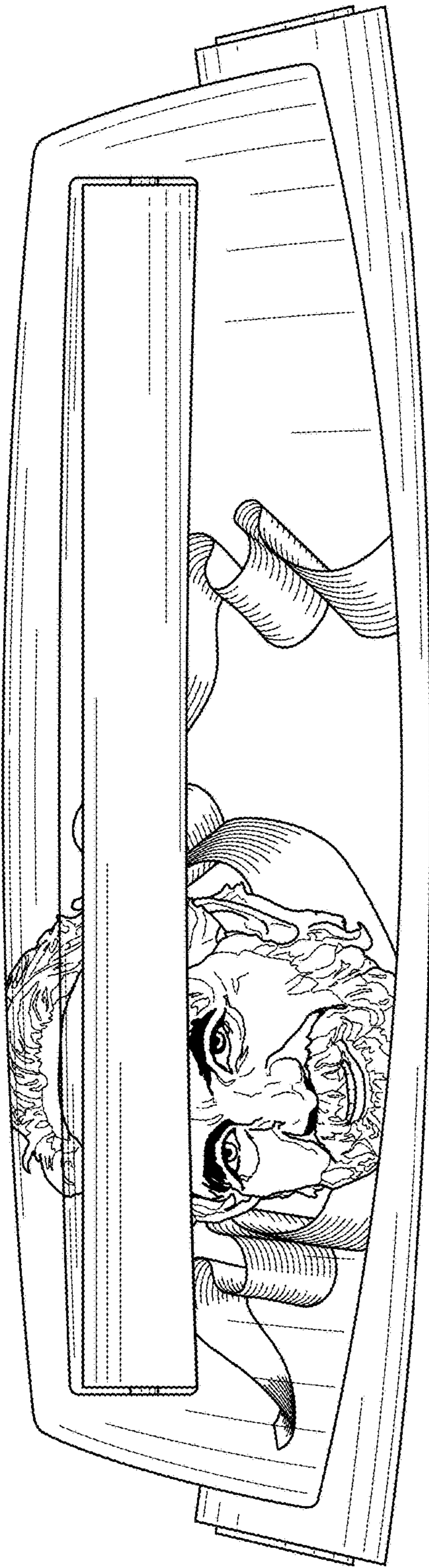

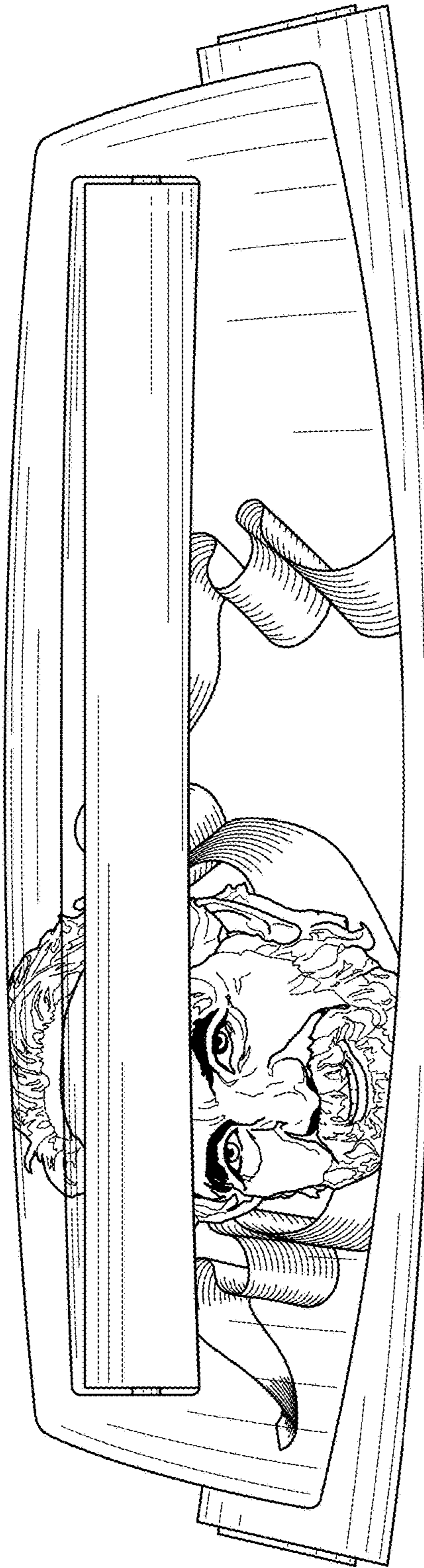

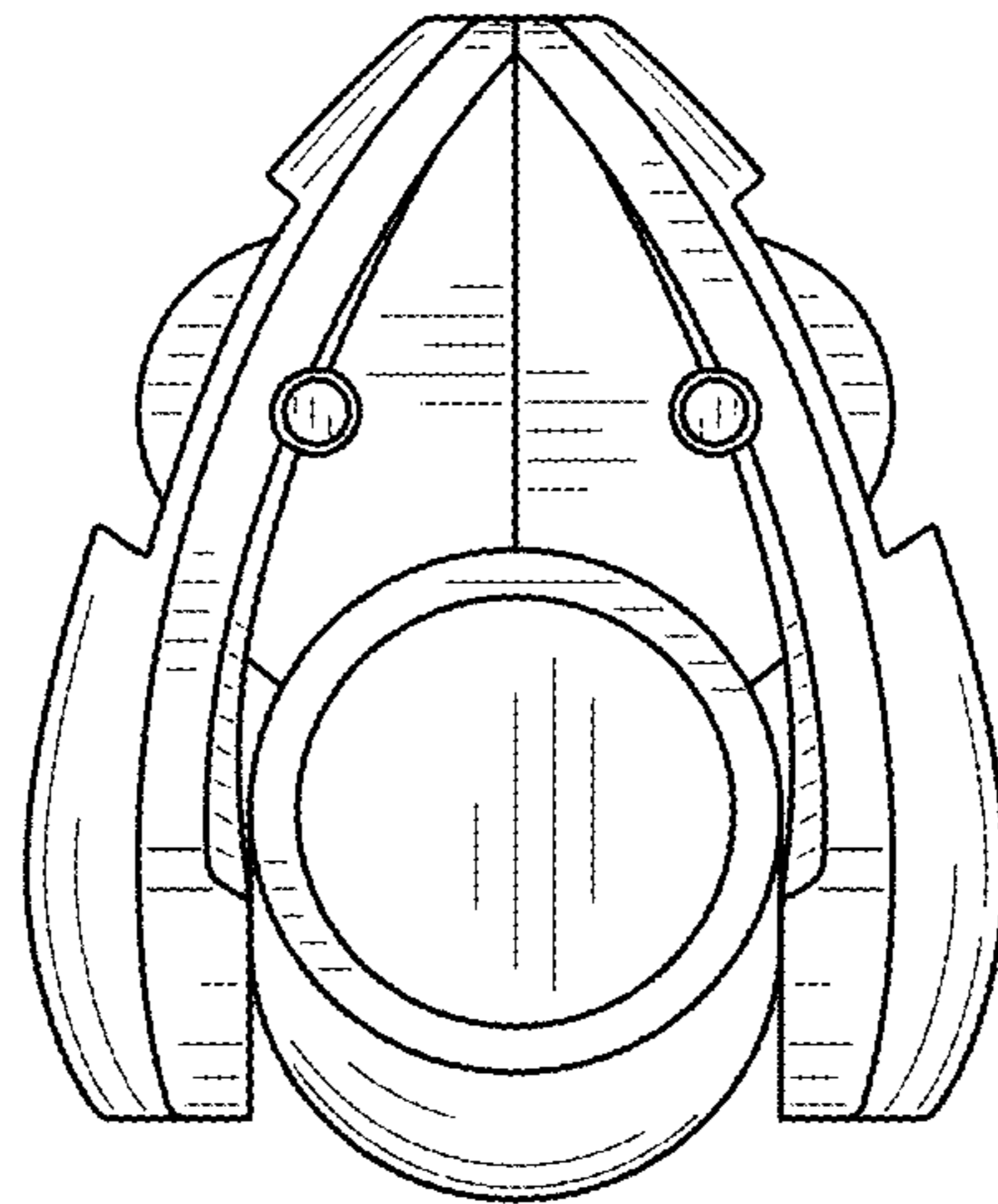

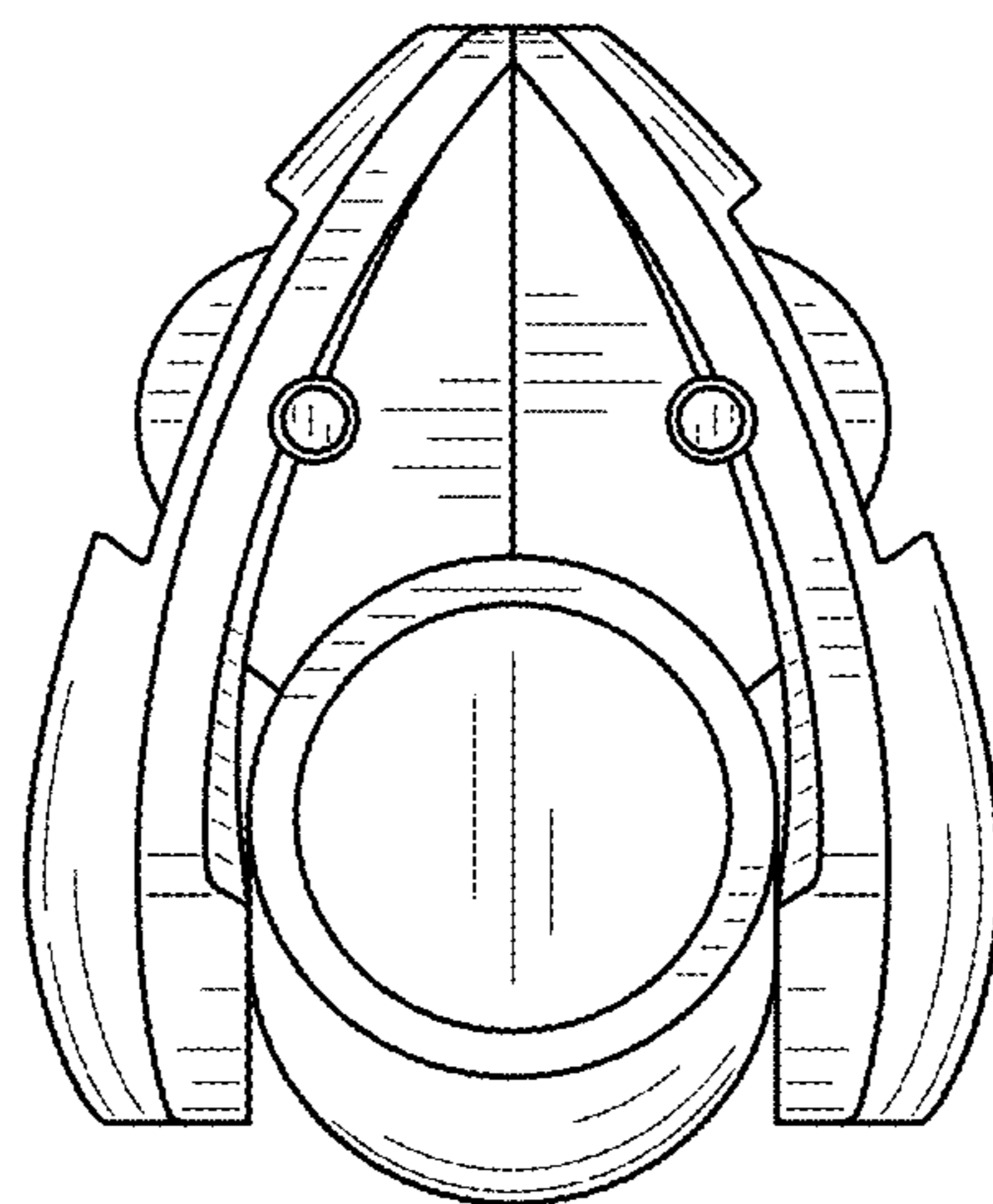

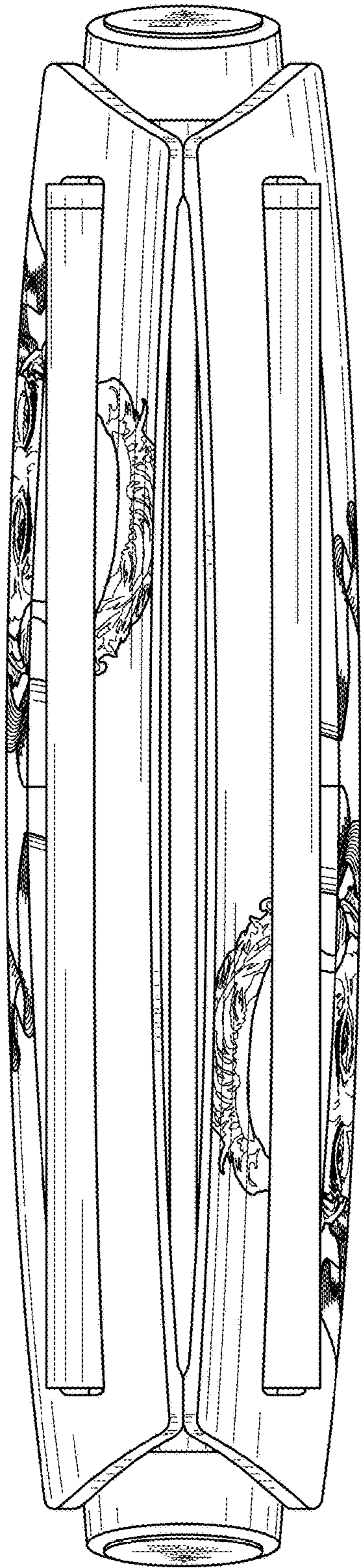

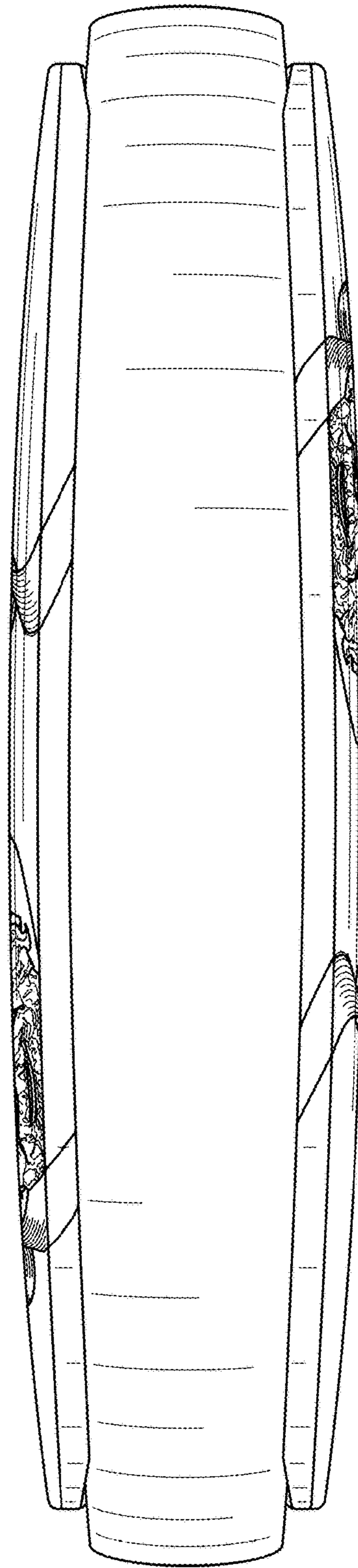

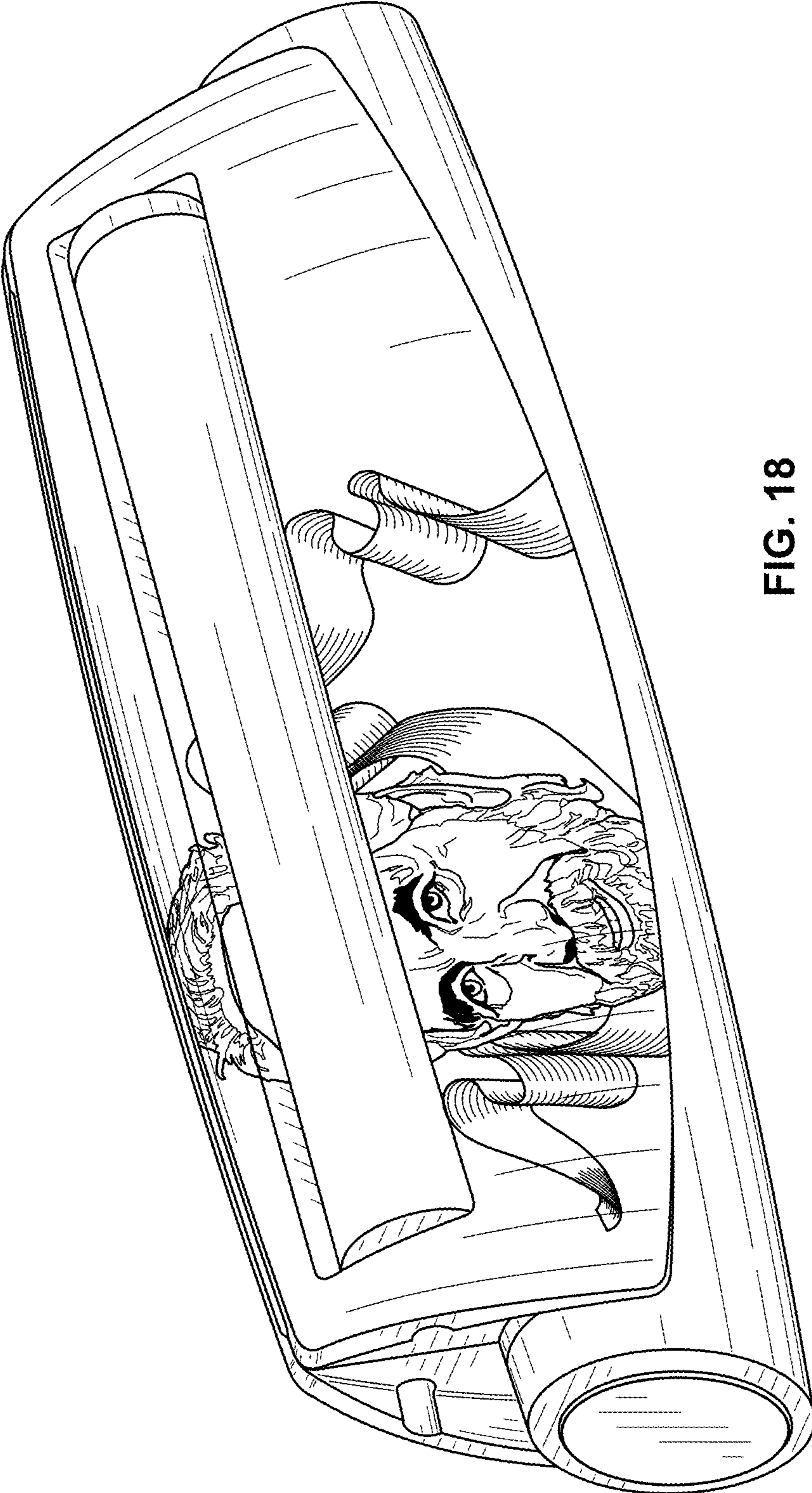

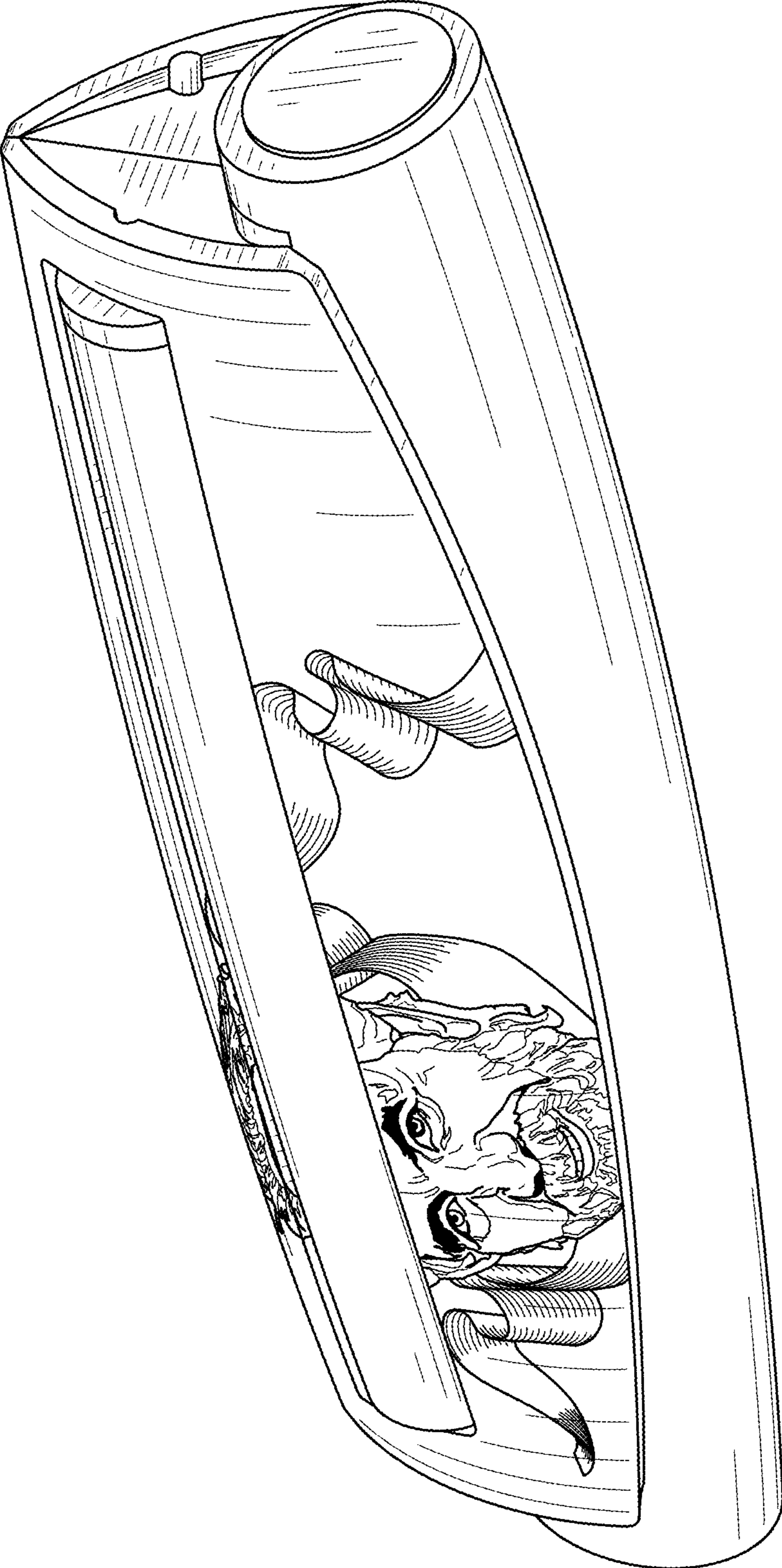

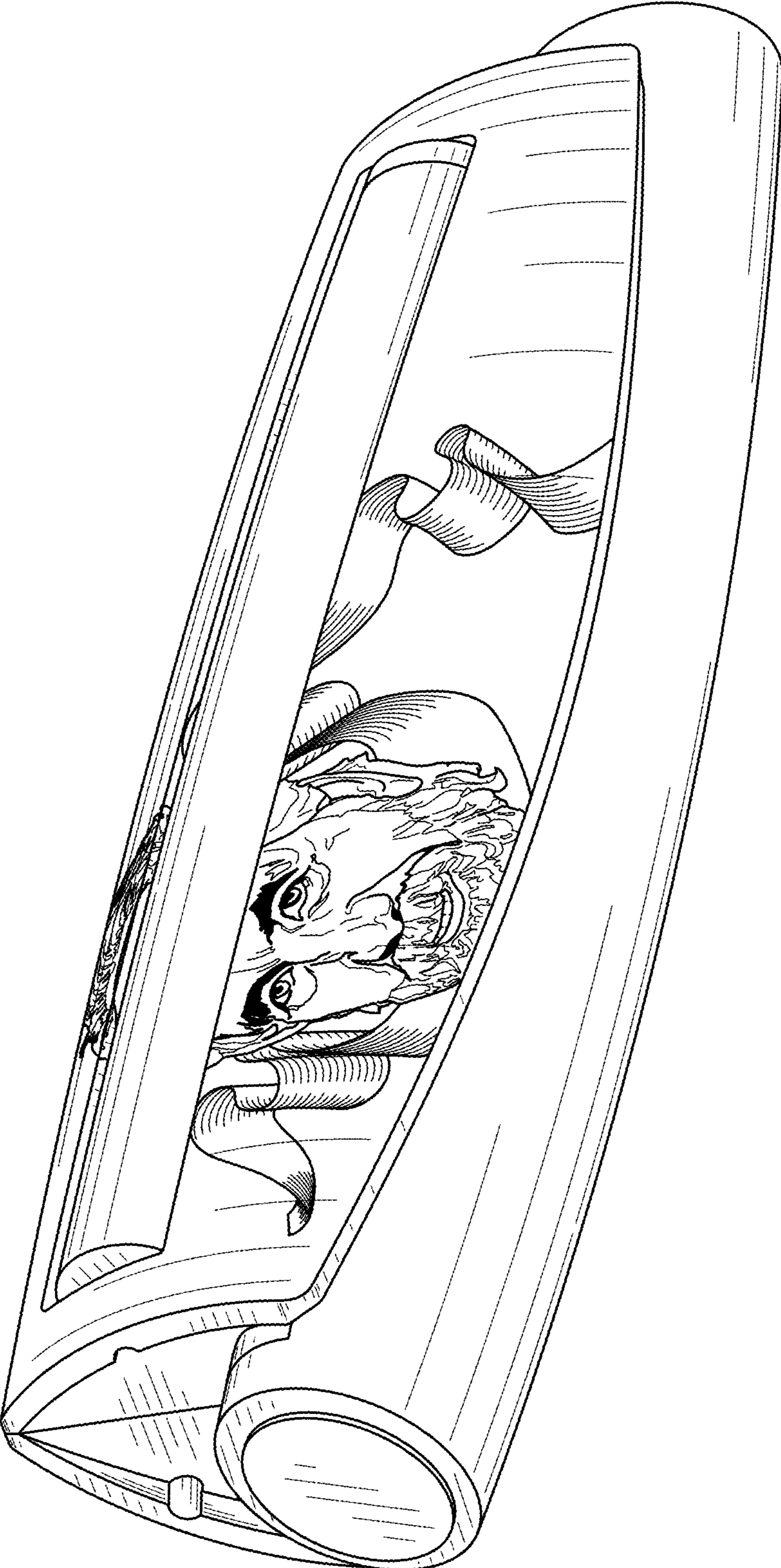
