**DESCRIPTION**

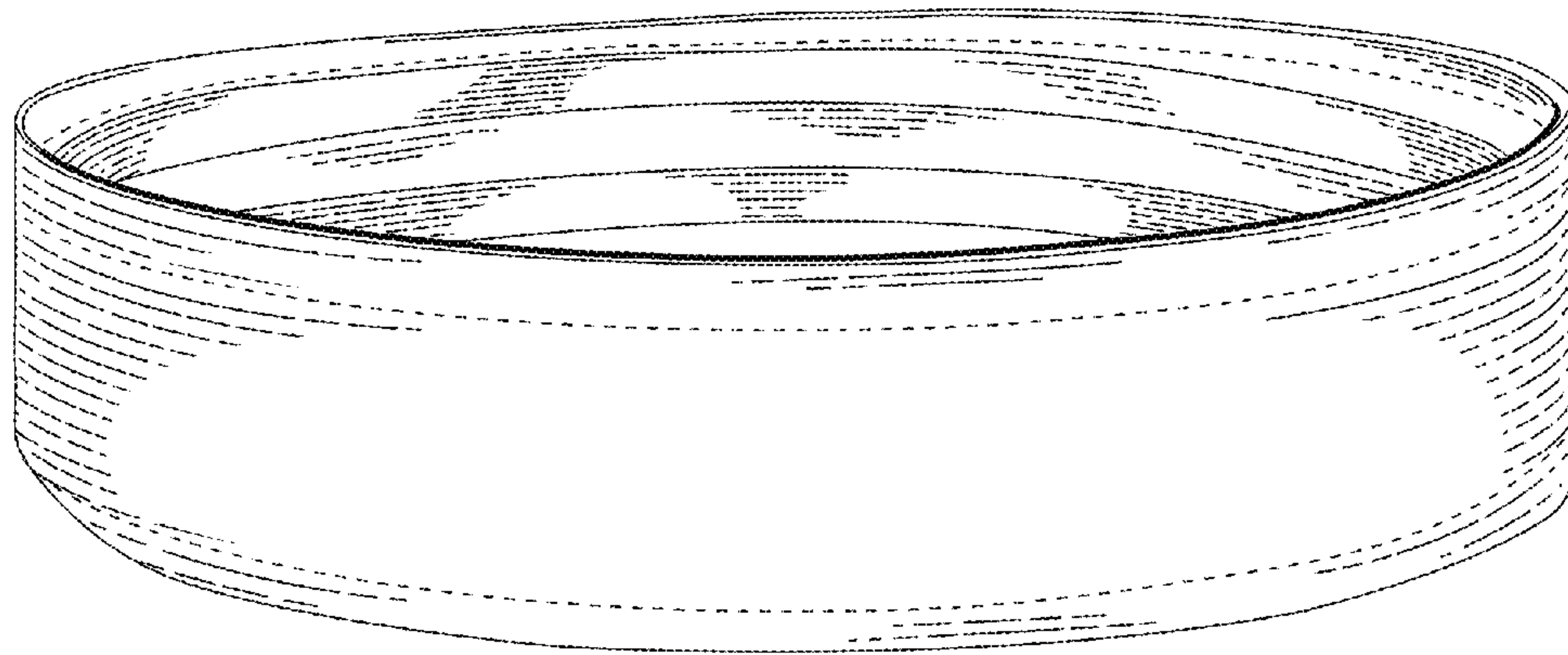
FIG. 1 is a front perspective view of a hairline gripping band;

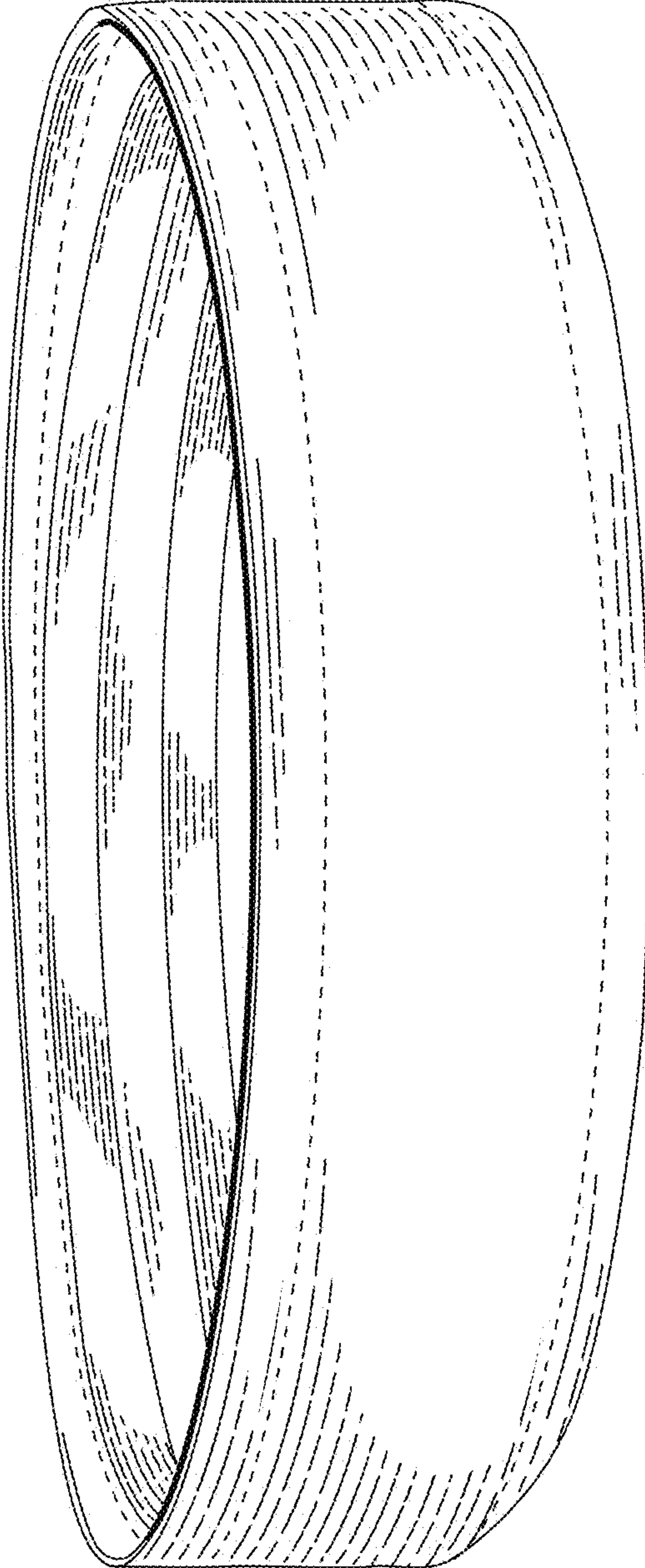

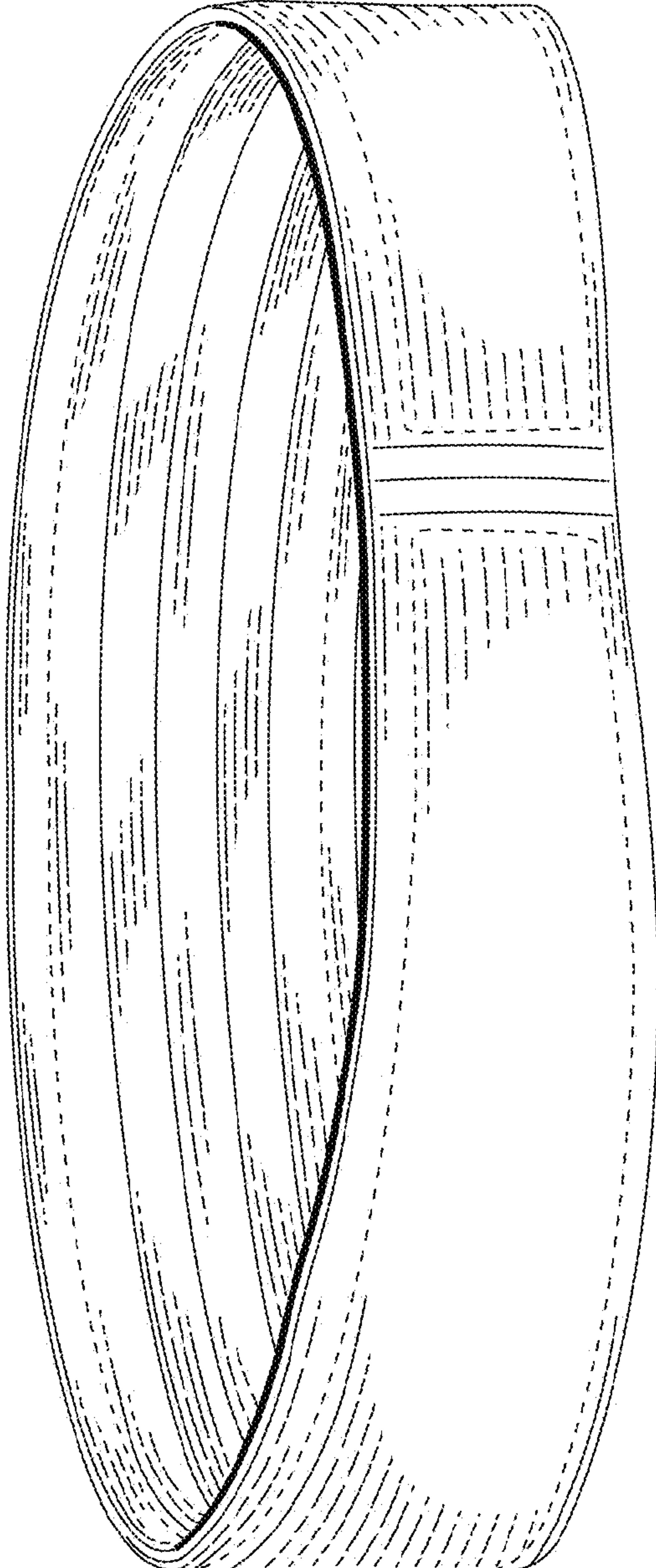

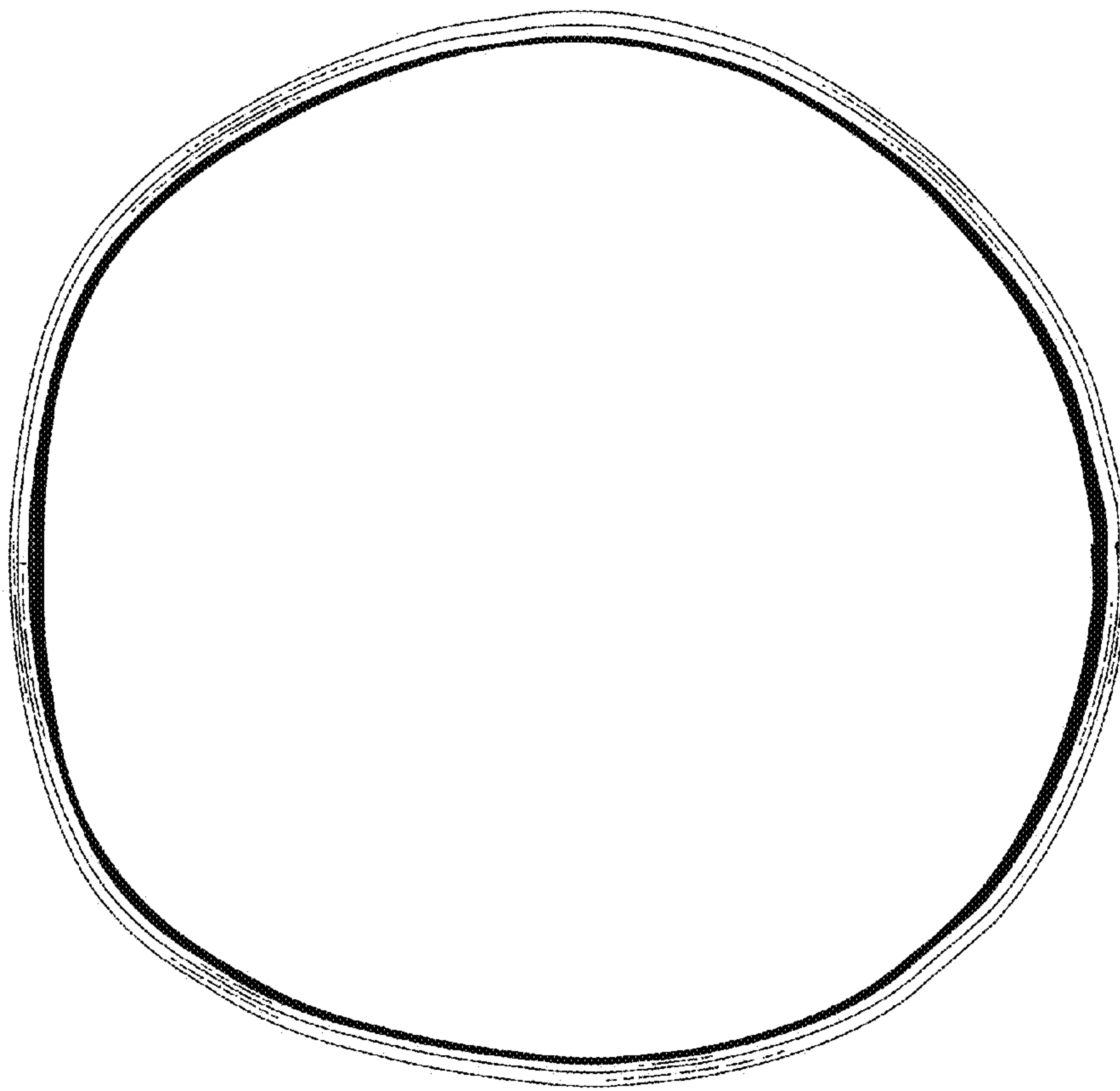

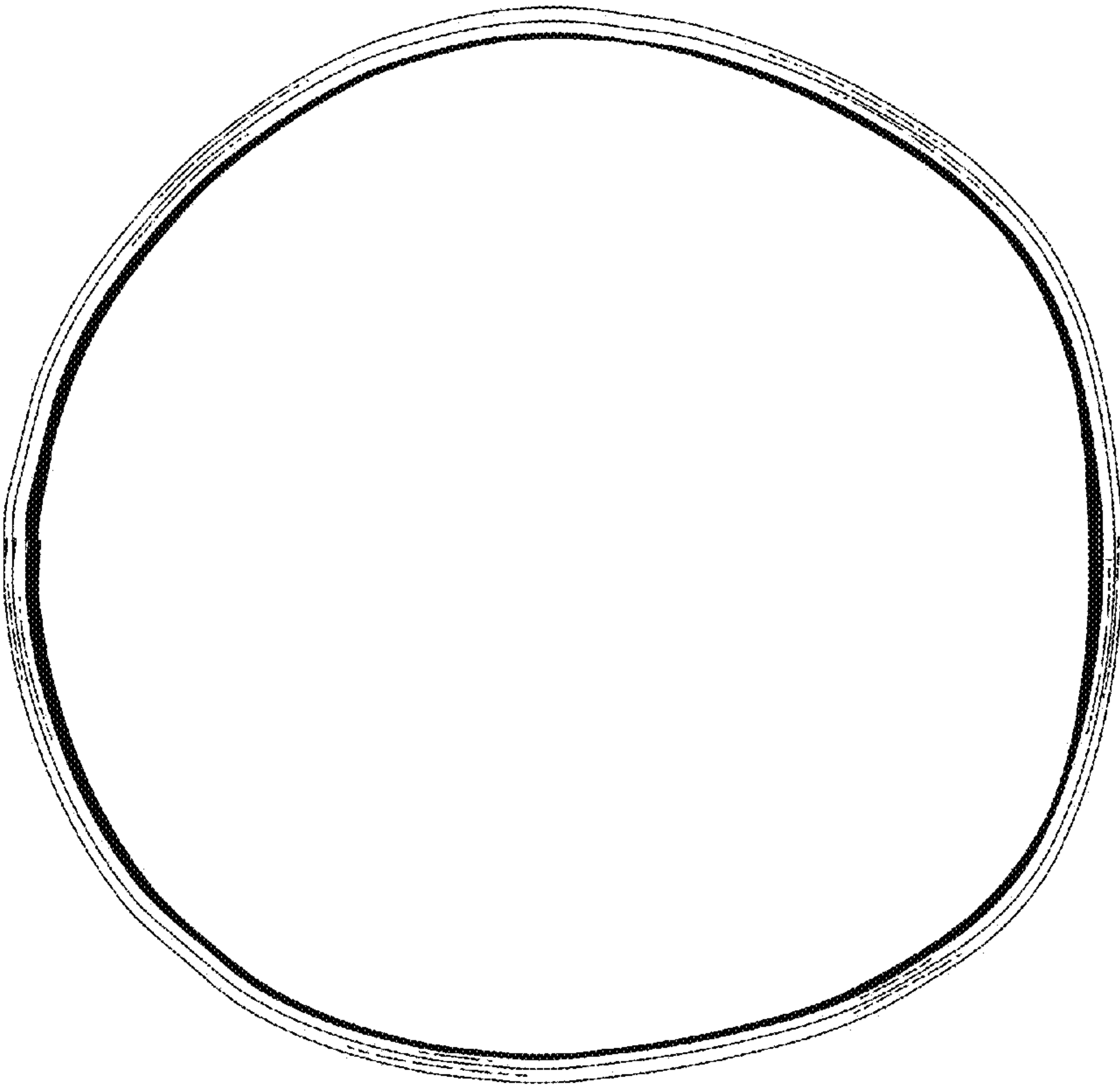

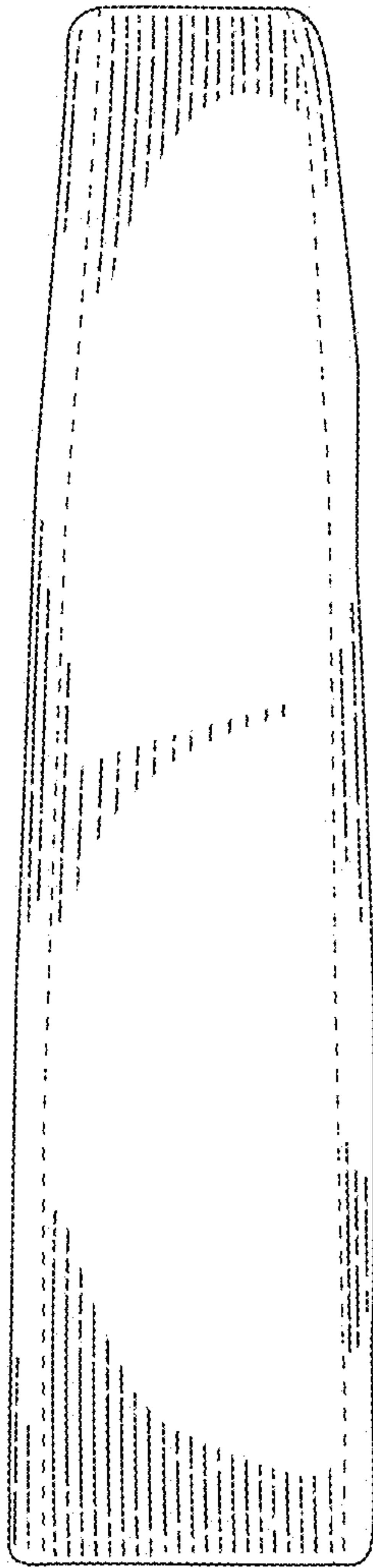

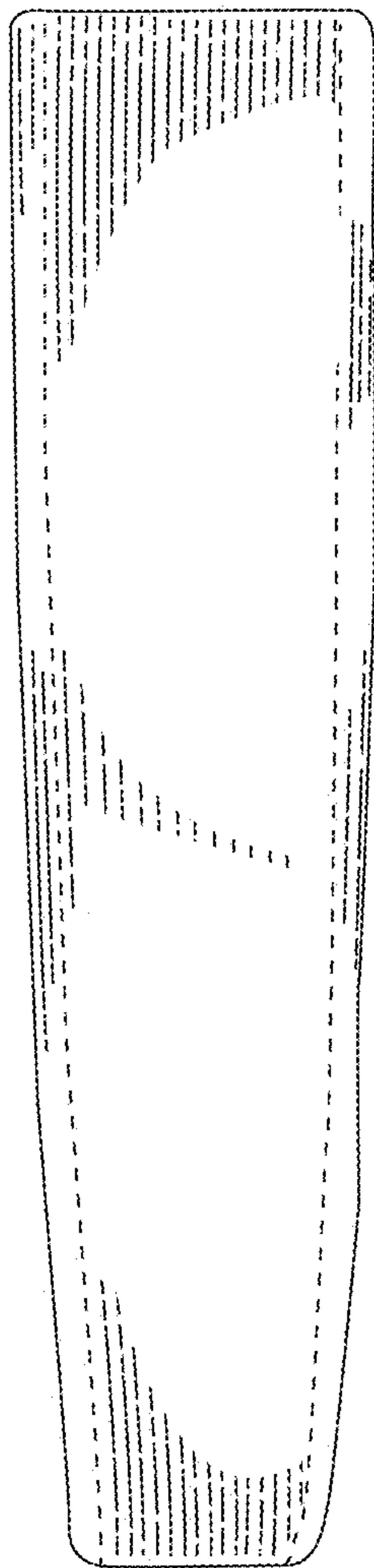

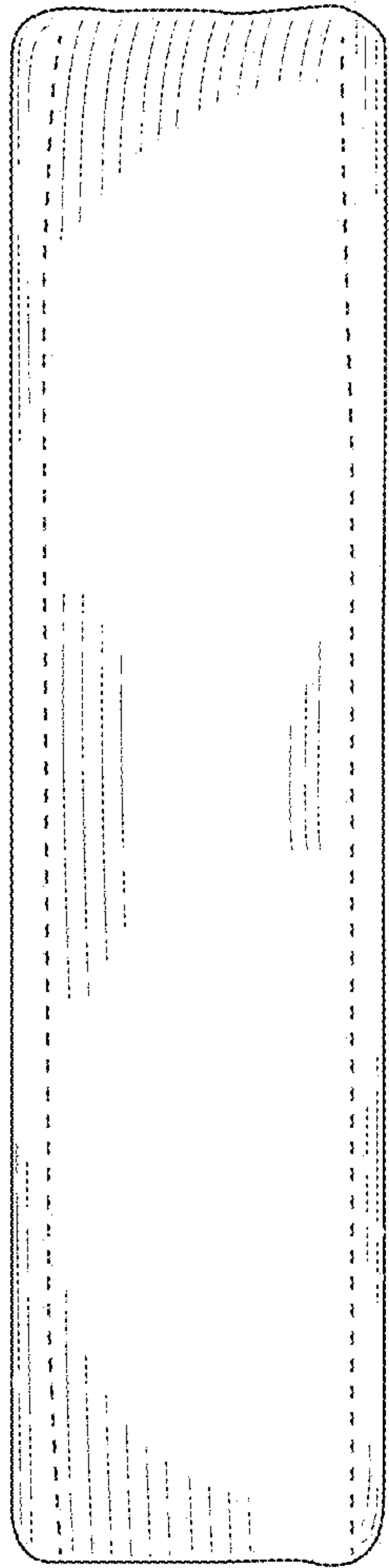

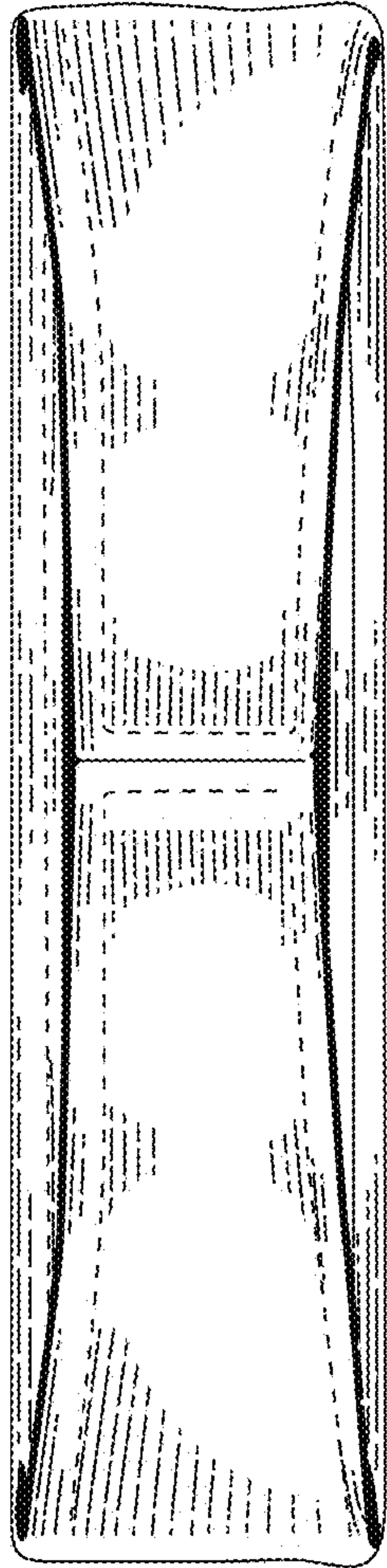
