(57) **CLAIM**

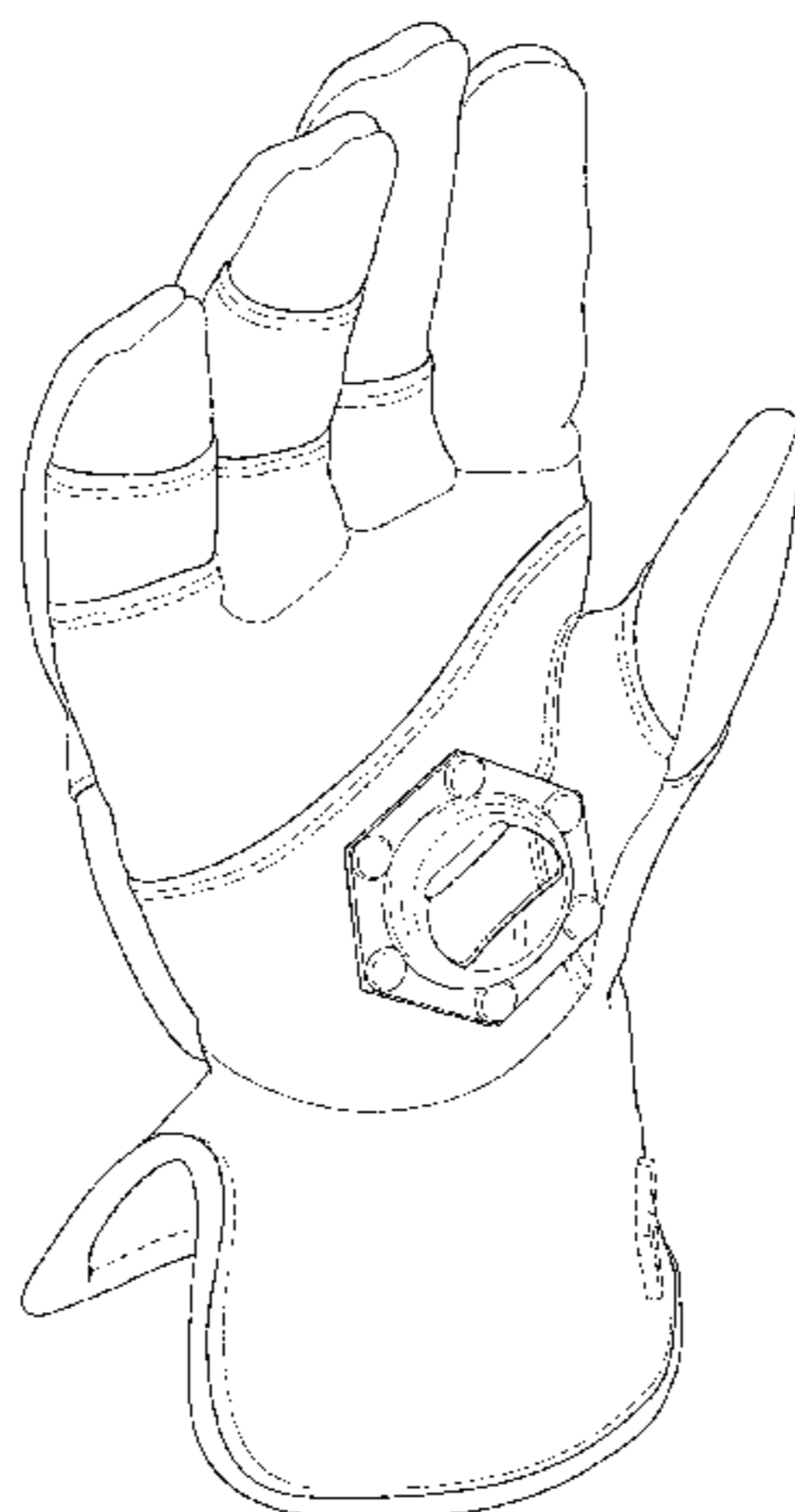
I claim the ornamental design for a glove, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a right handed version of a glove;

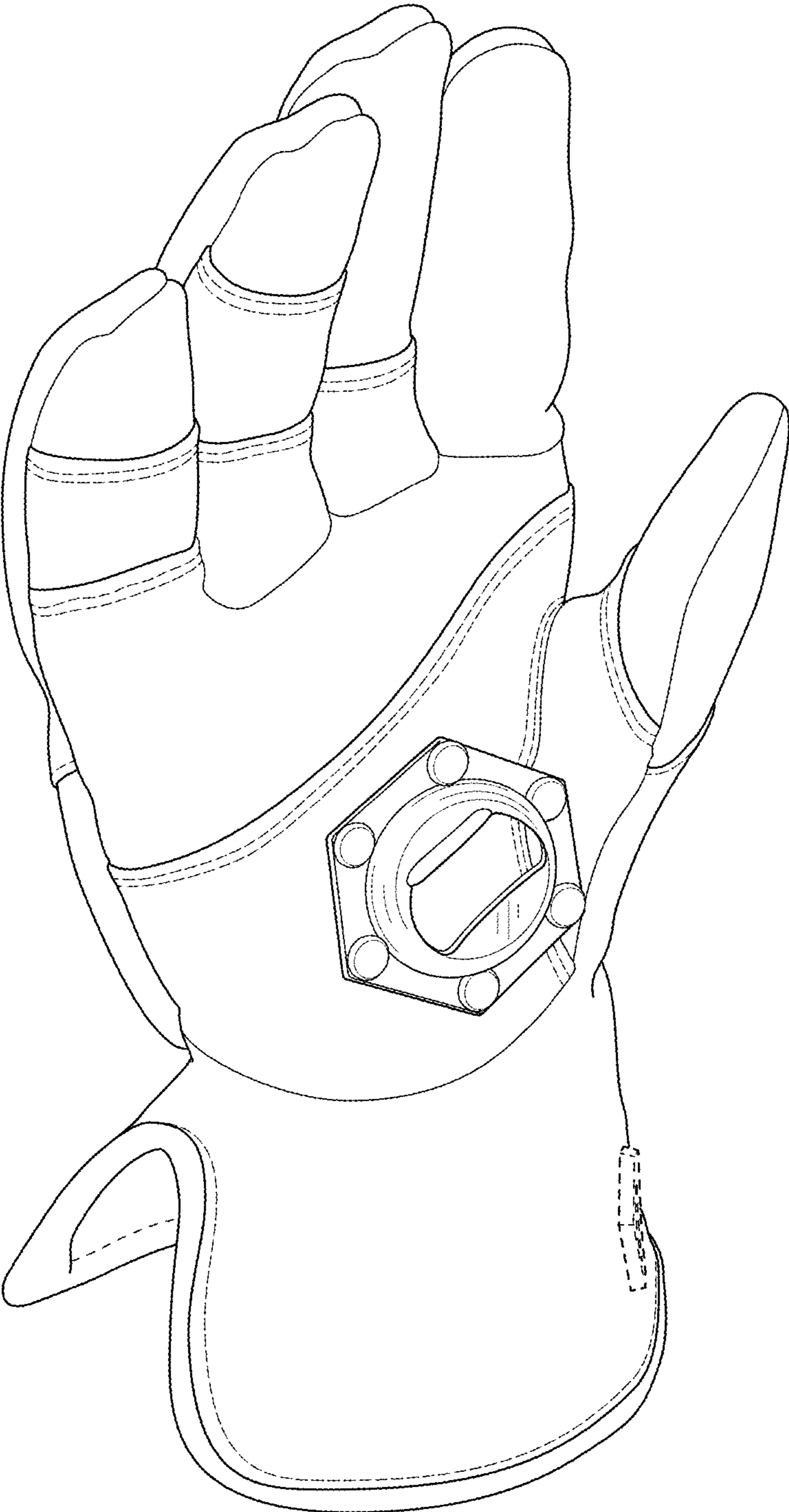

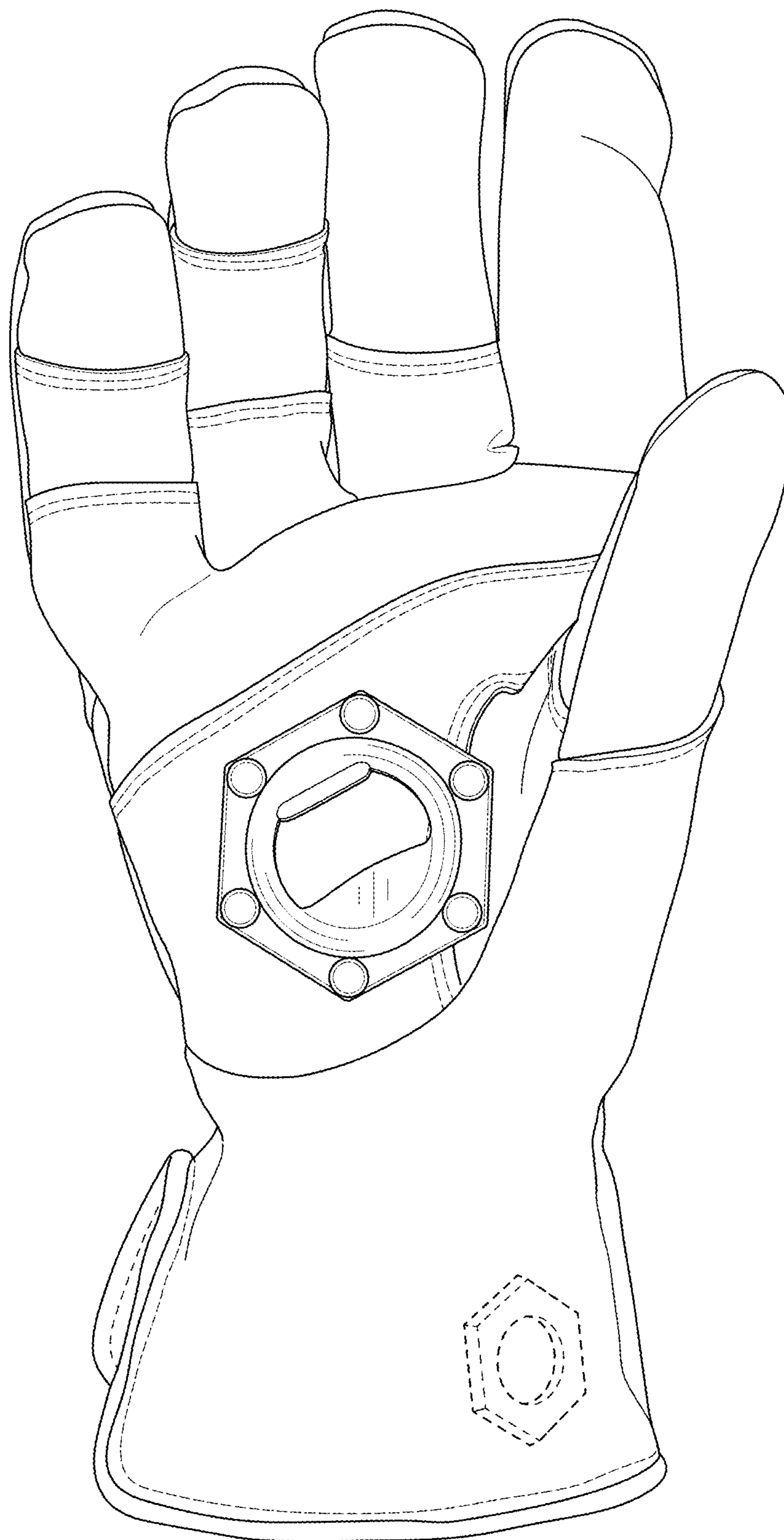

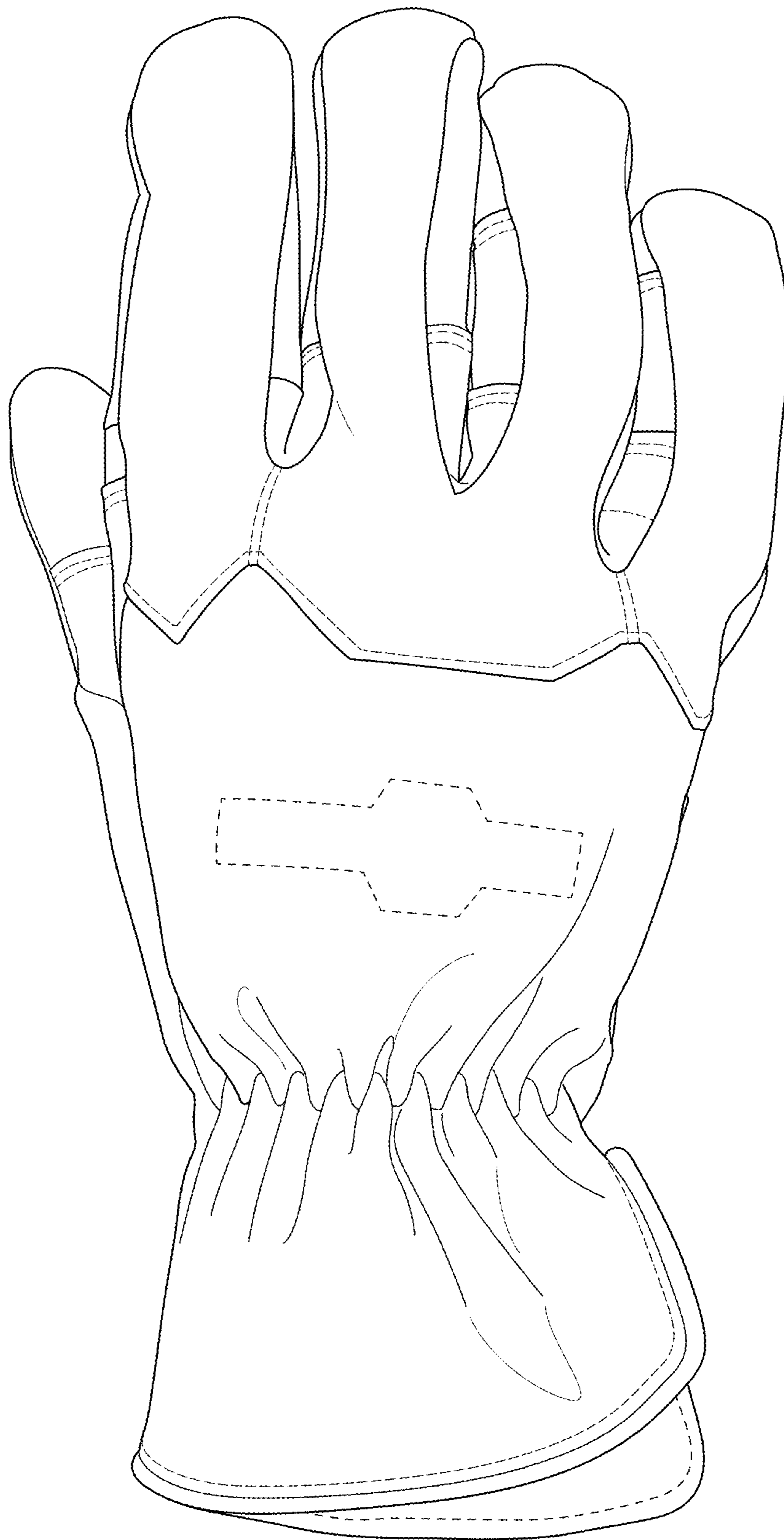

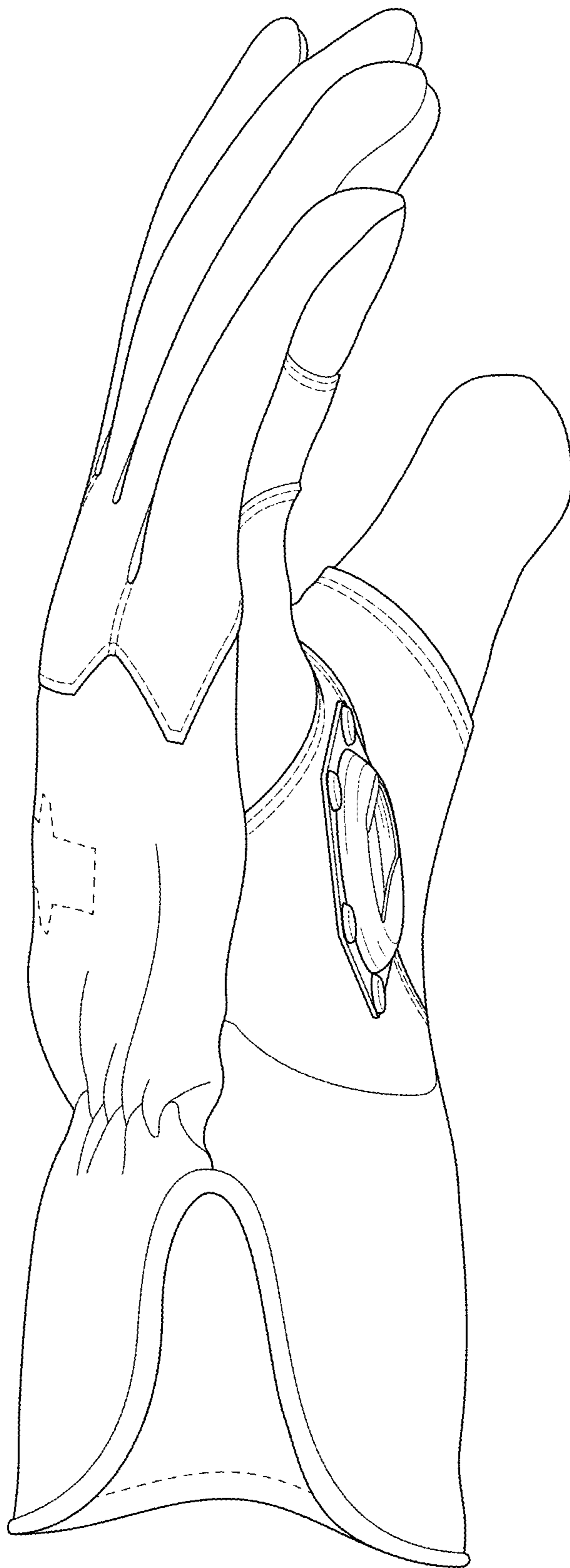

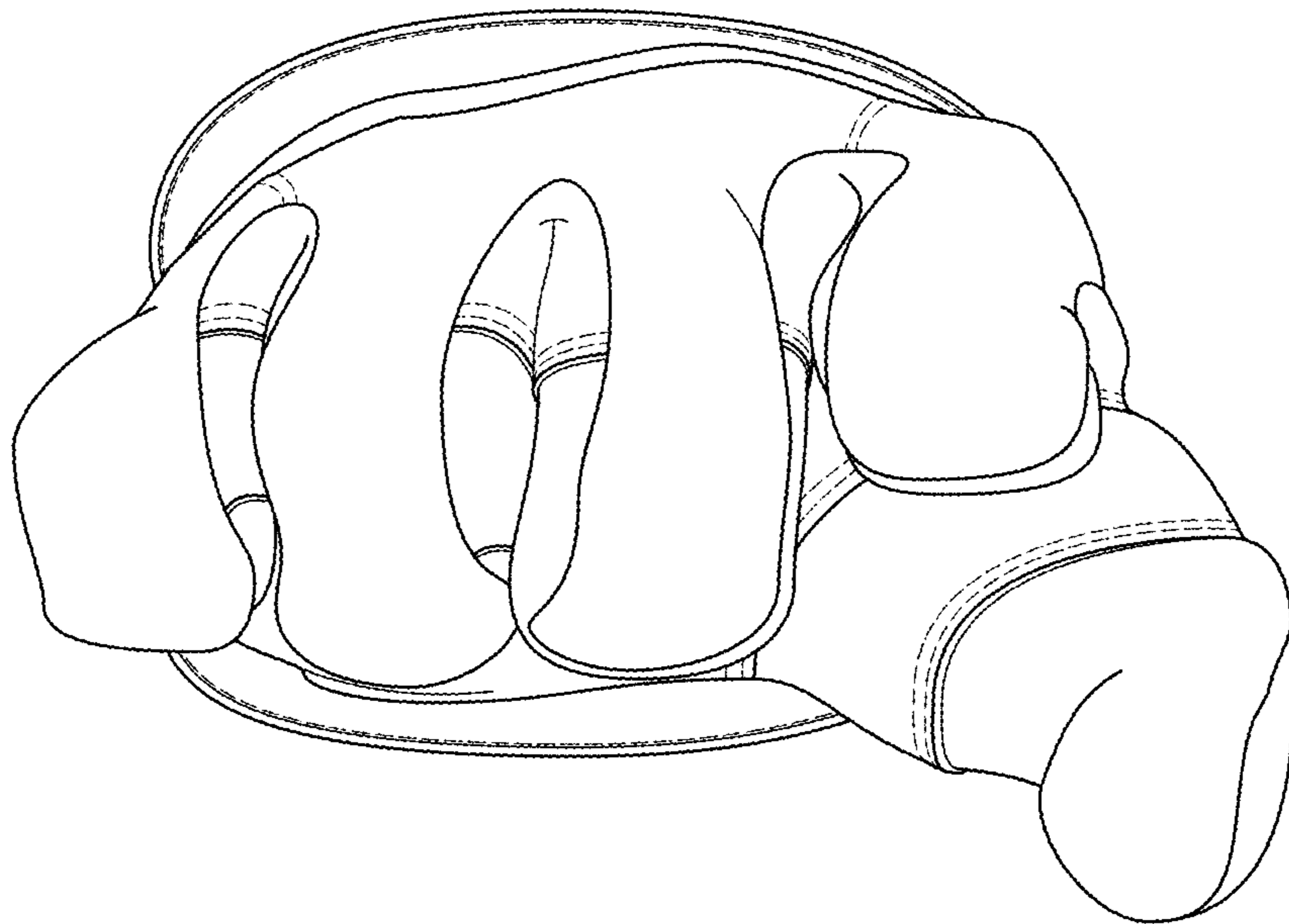

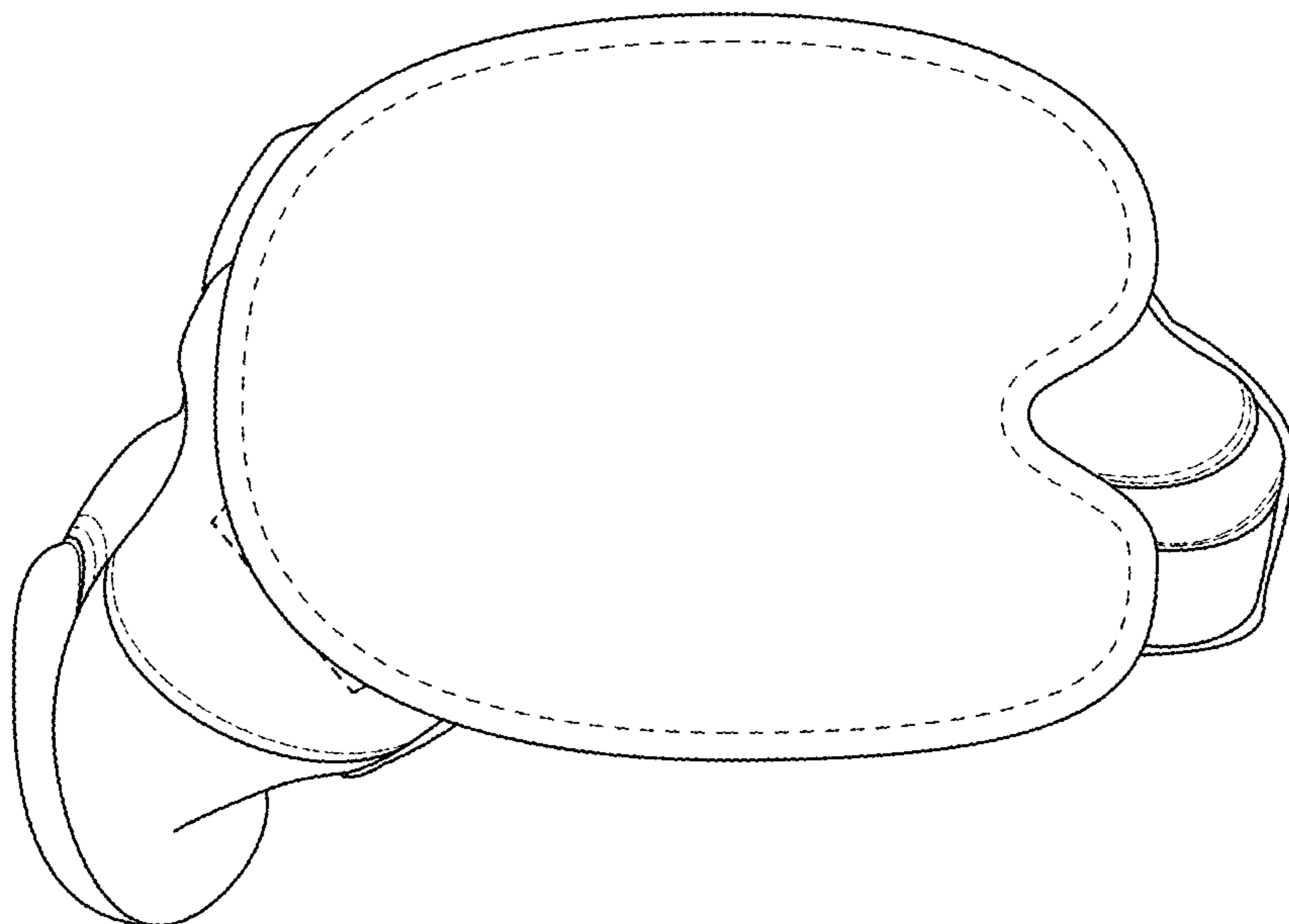

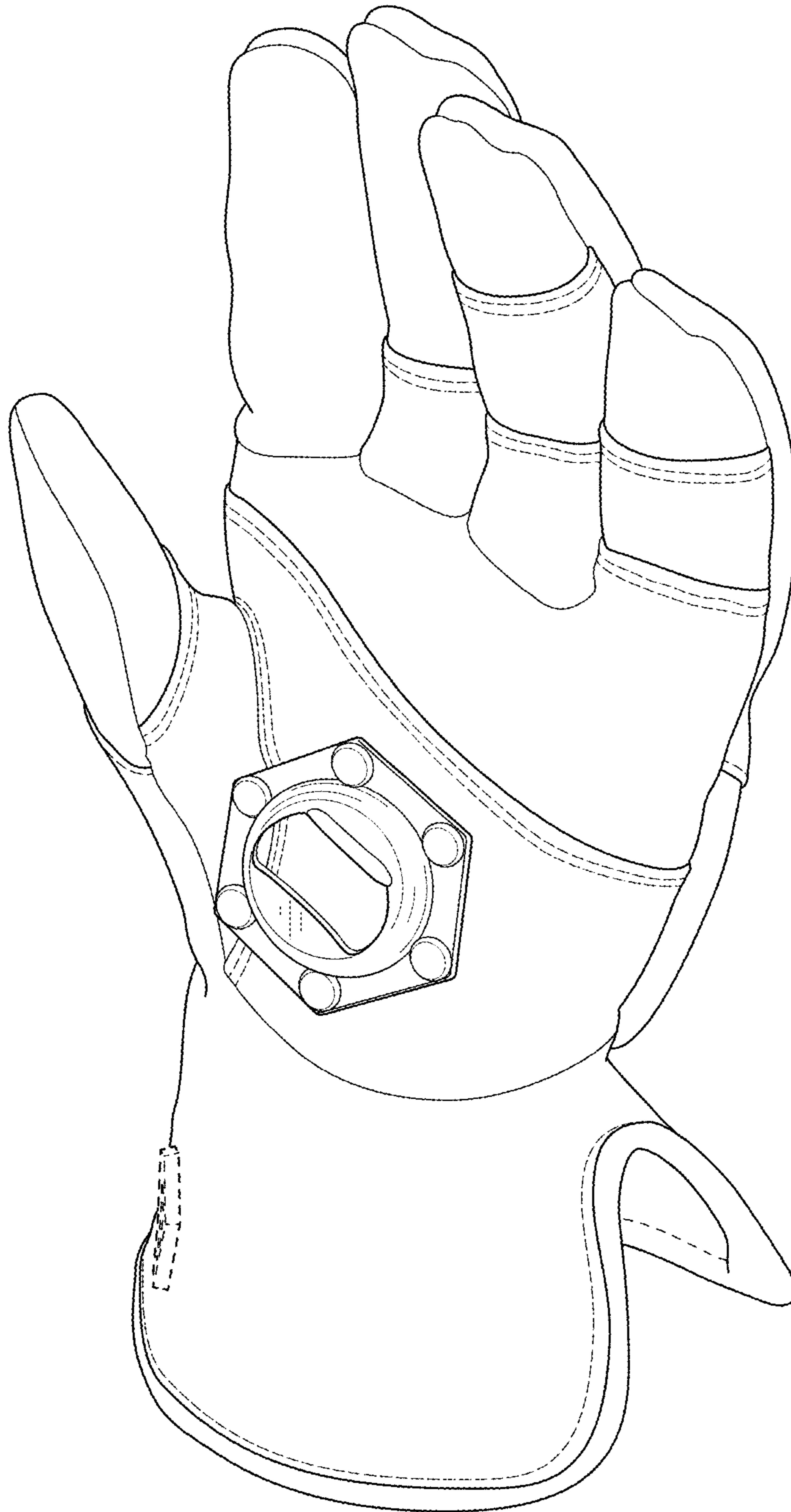

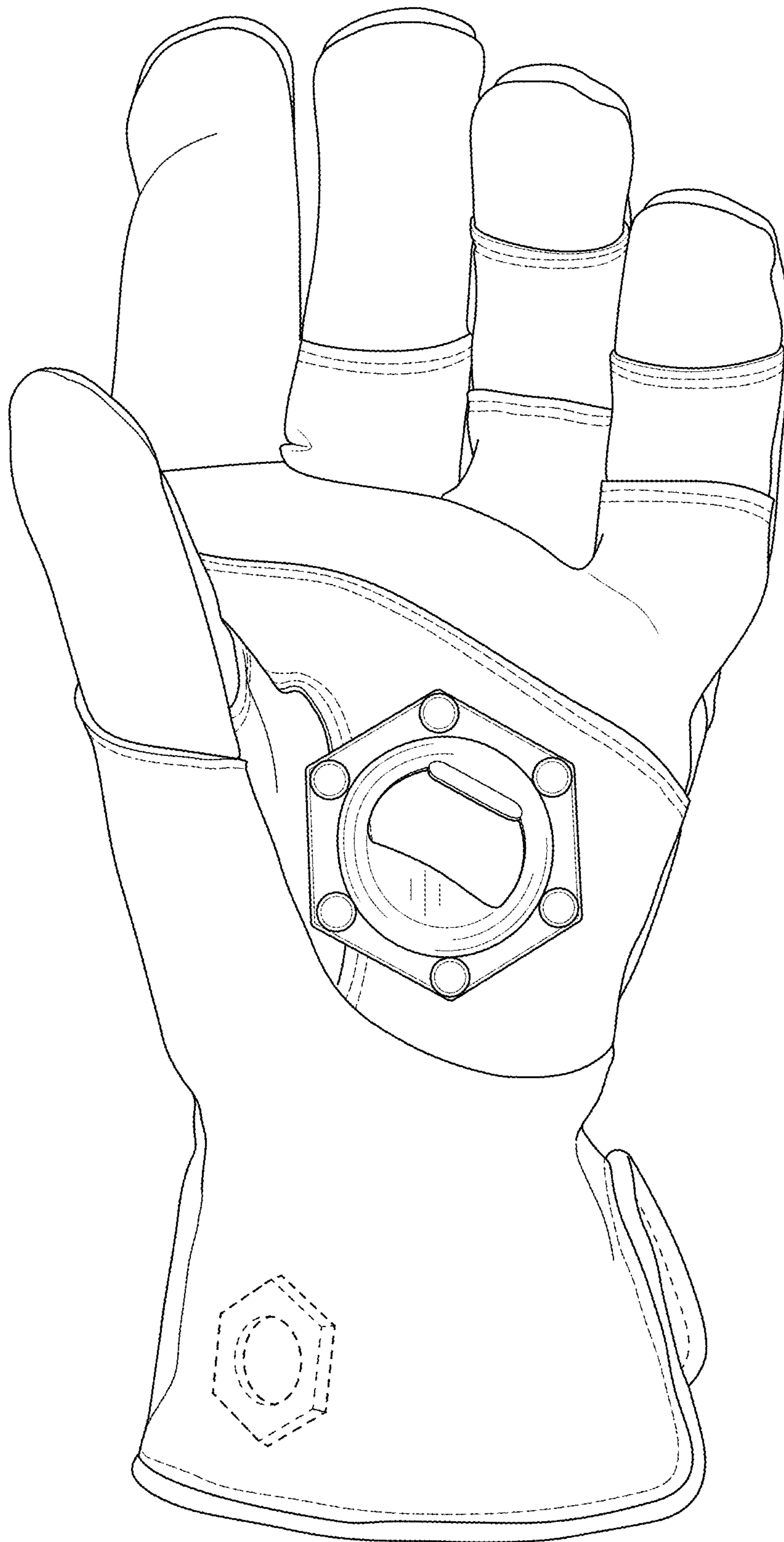

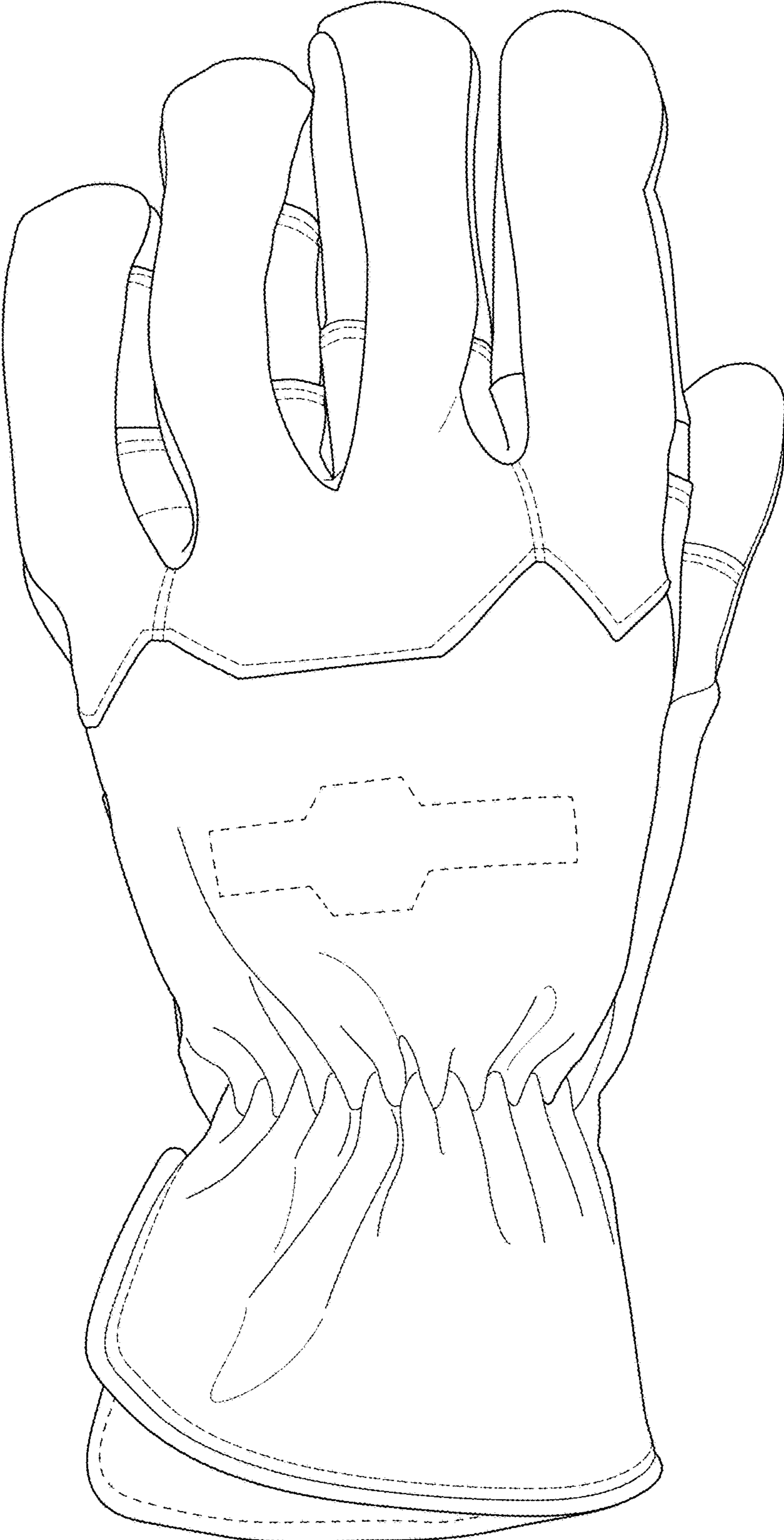

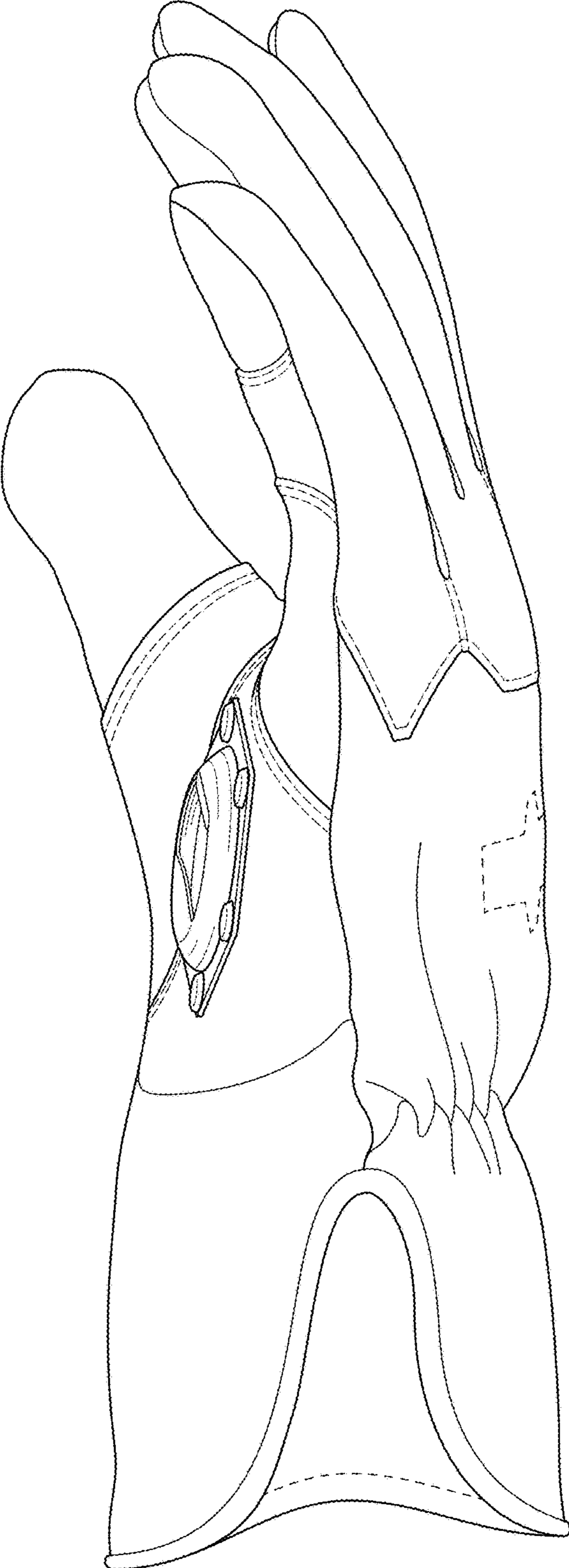

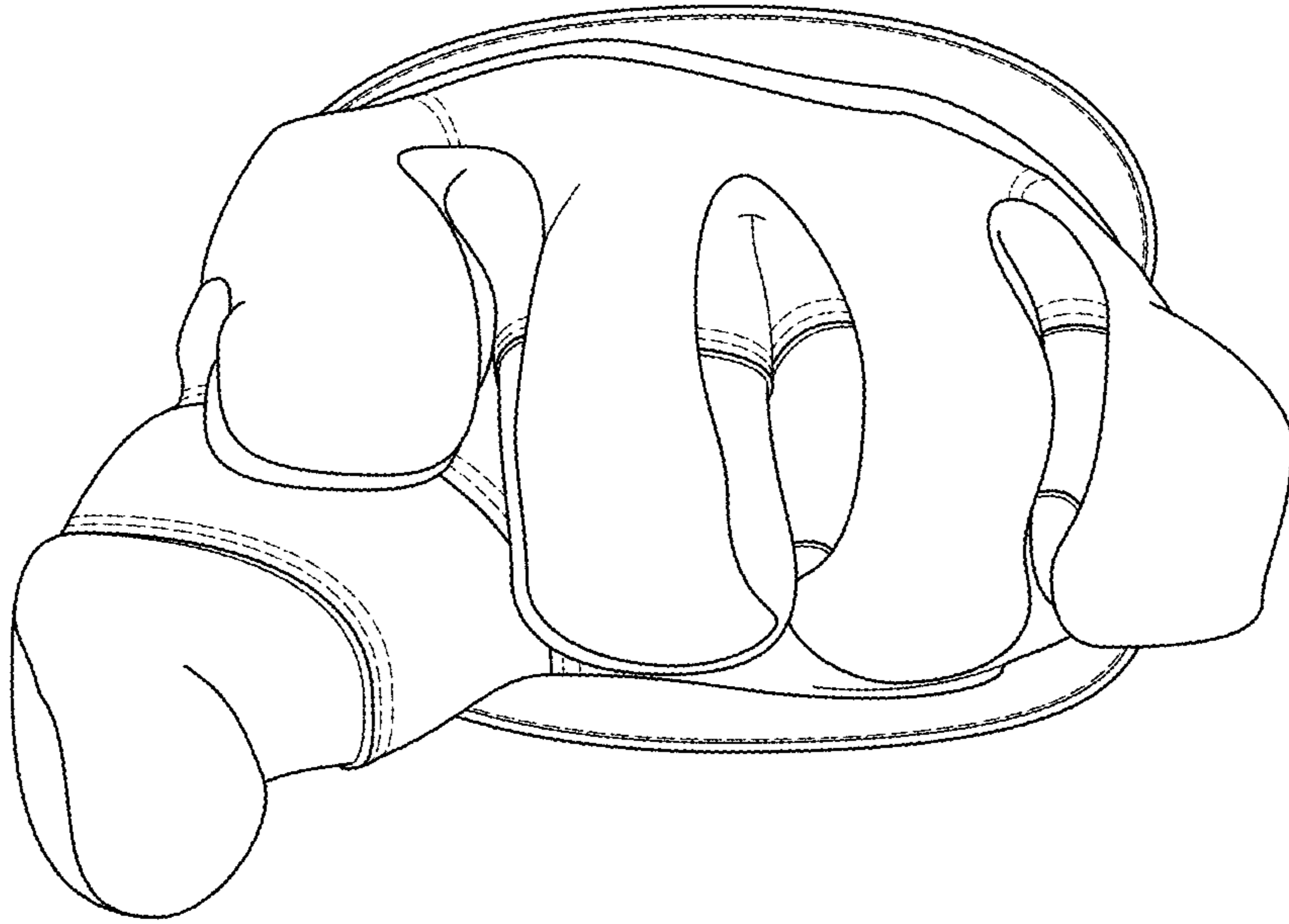

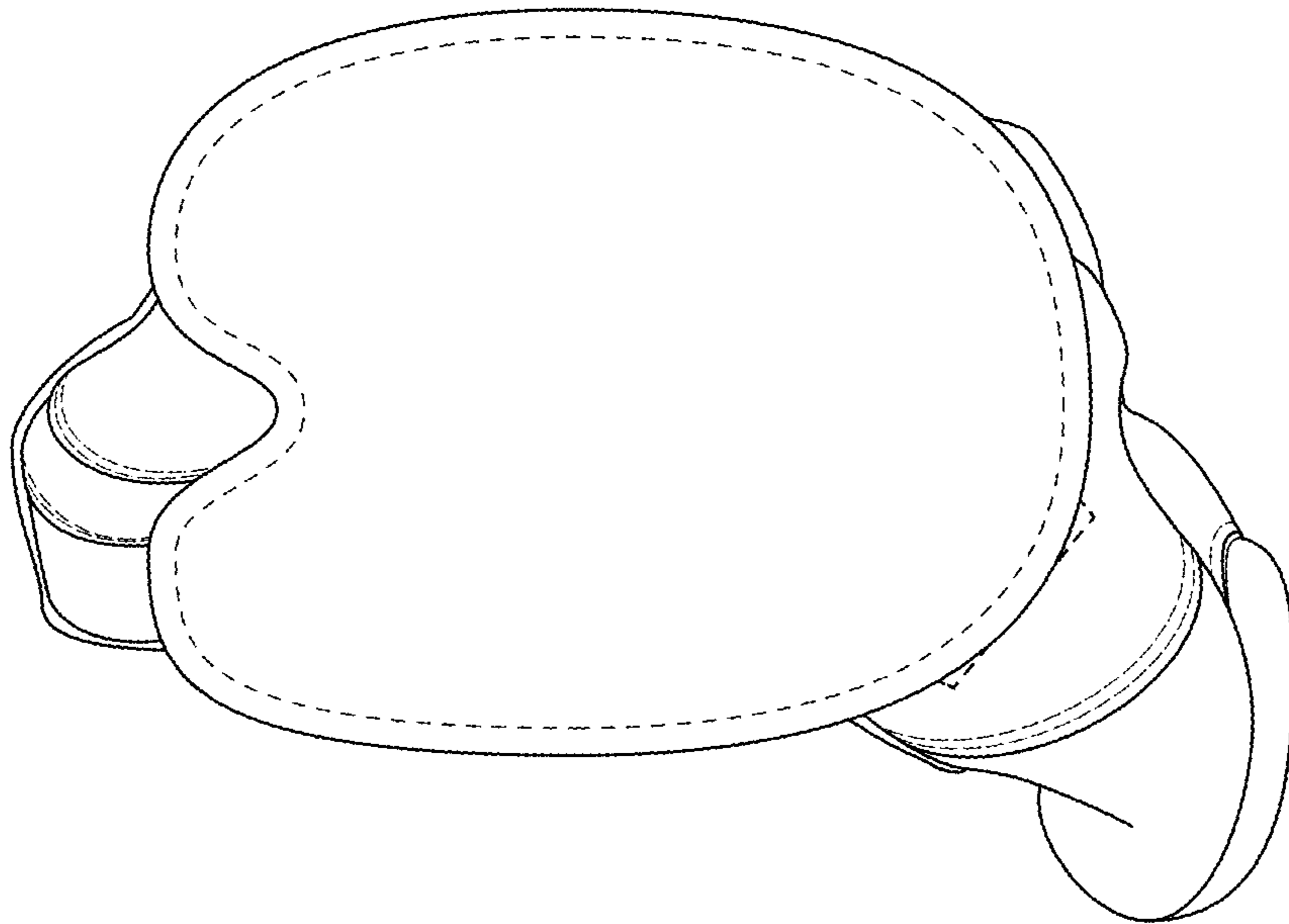
