DESCRIPTION

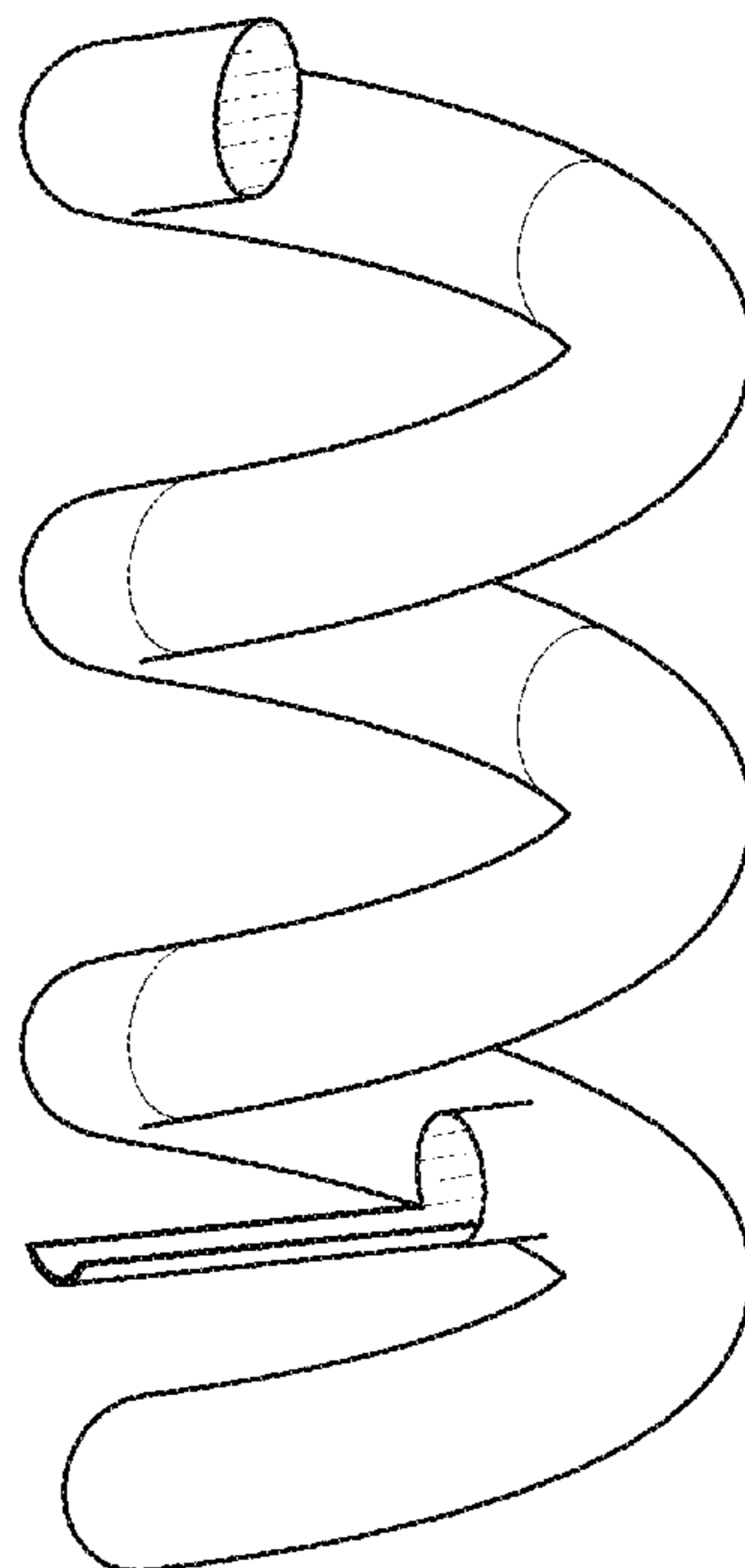
FIG. 1 is a front left isometric view of a emergency escape slide showing my new design;

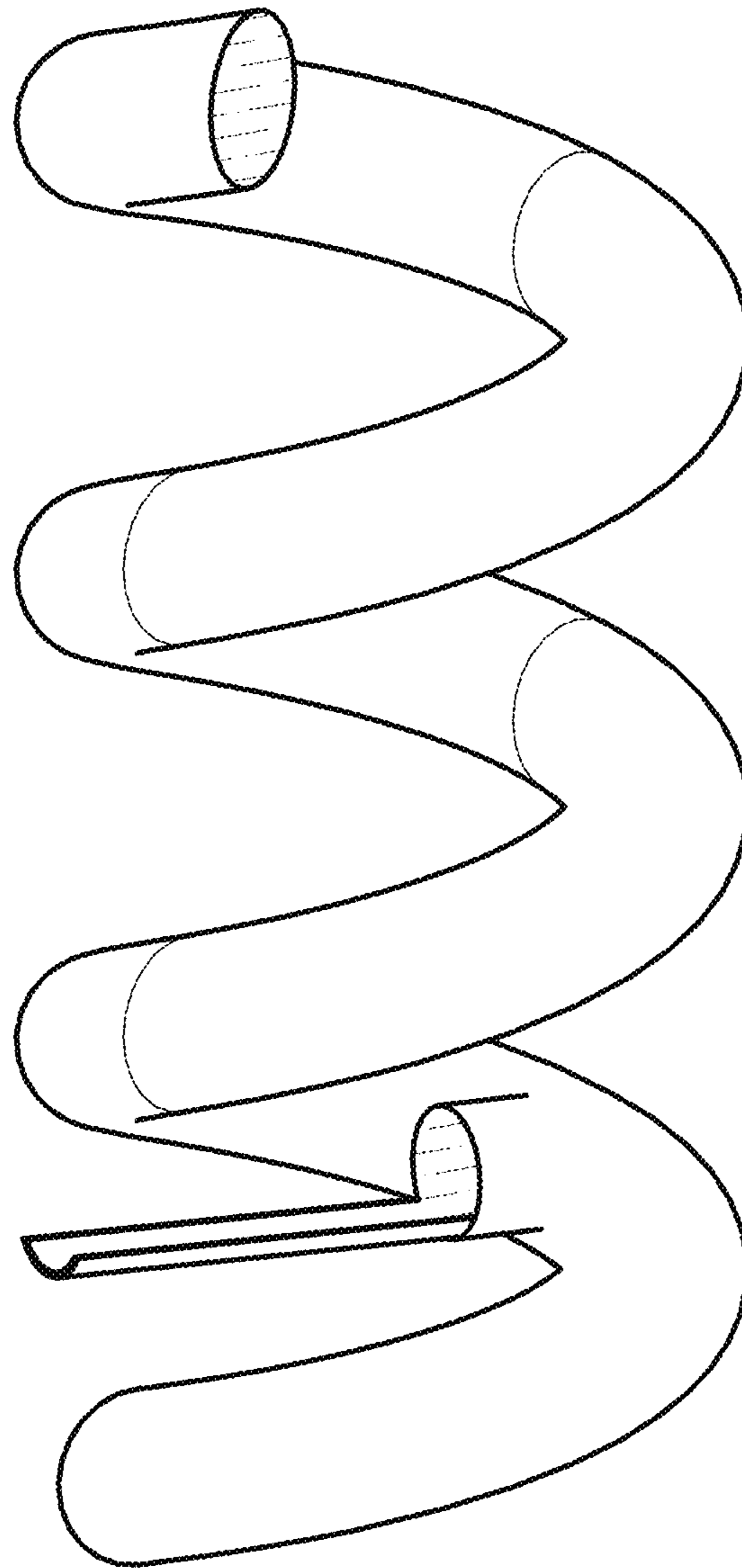

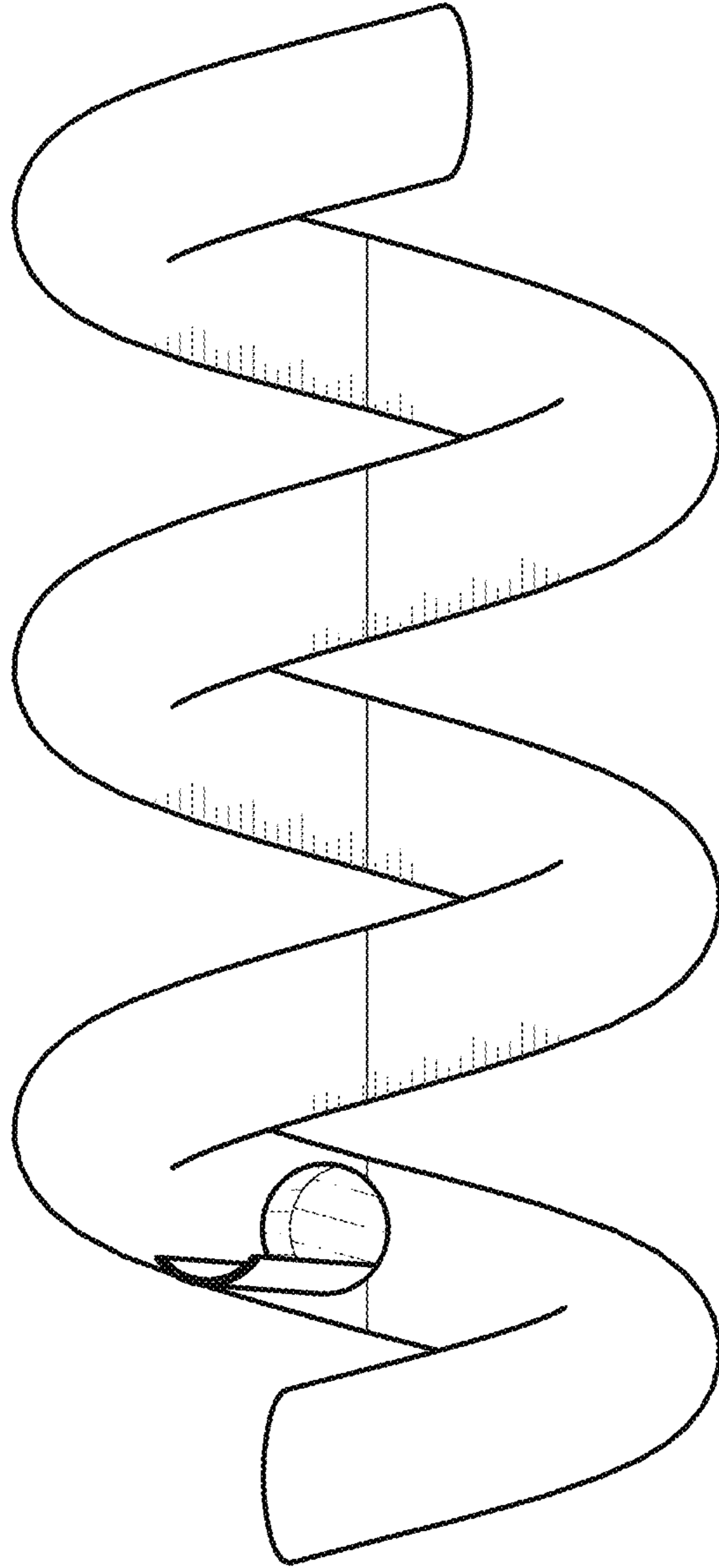

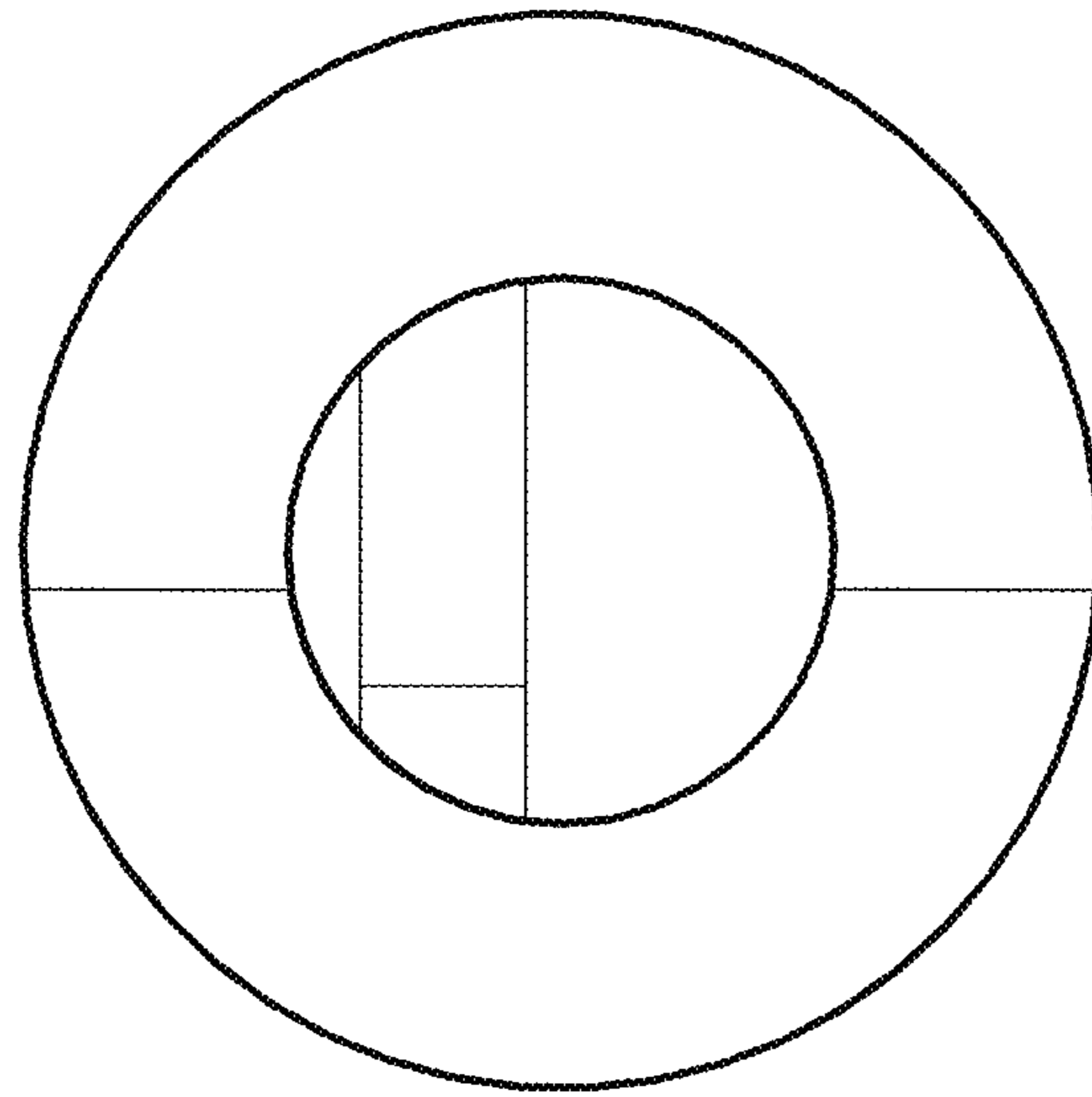

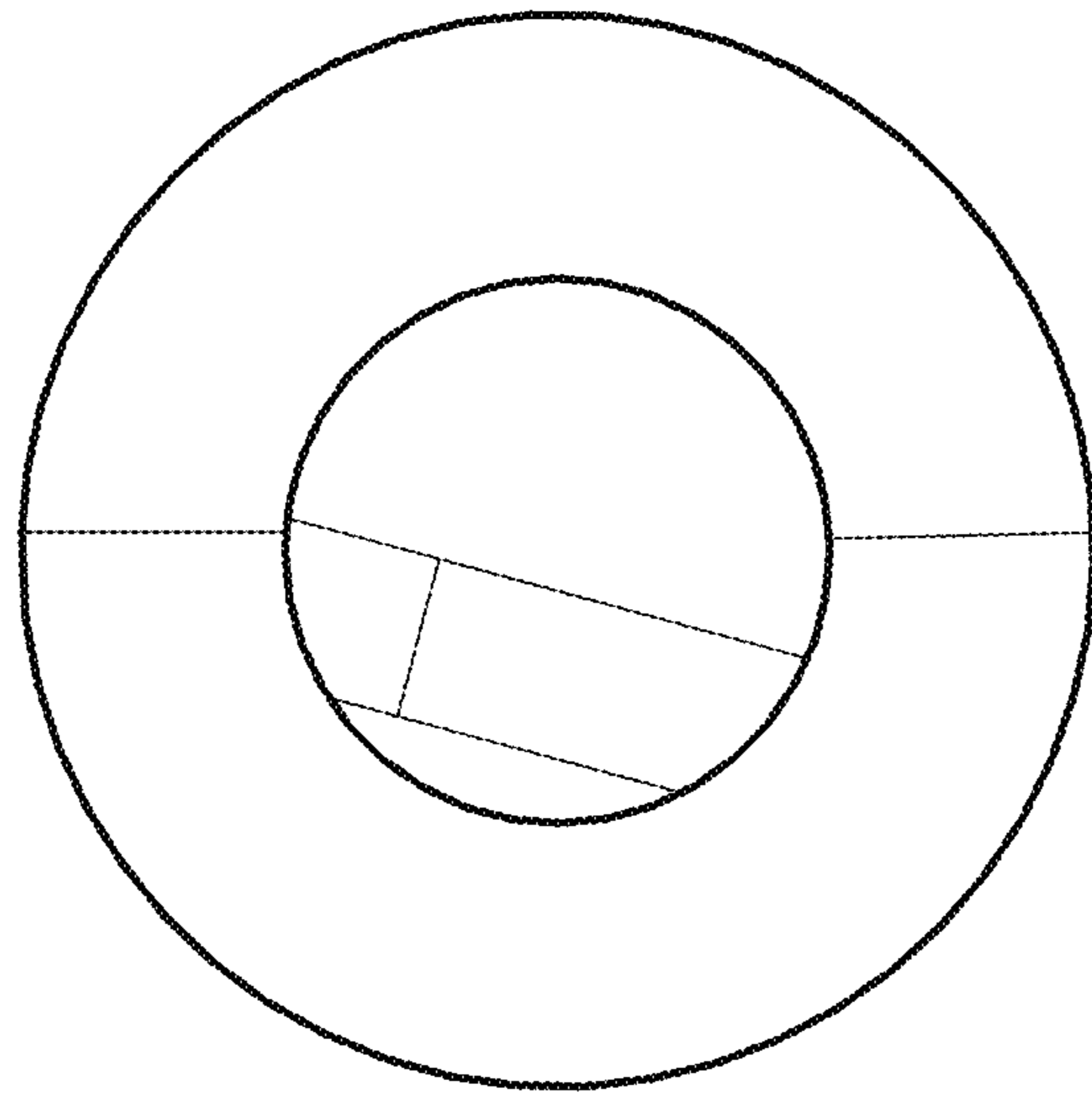

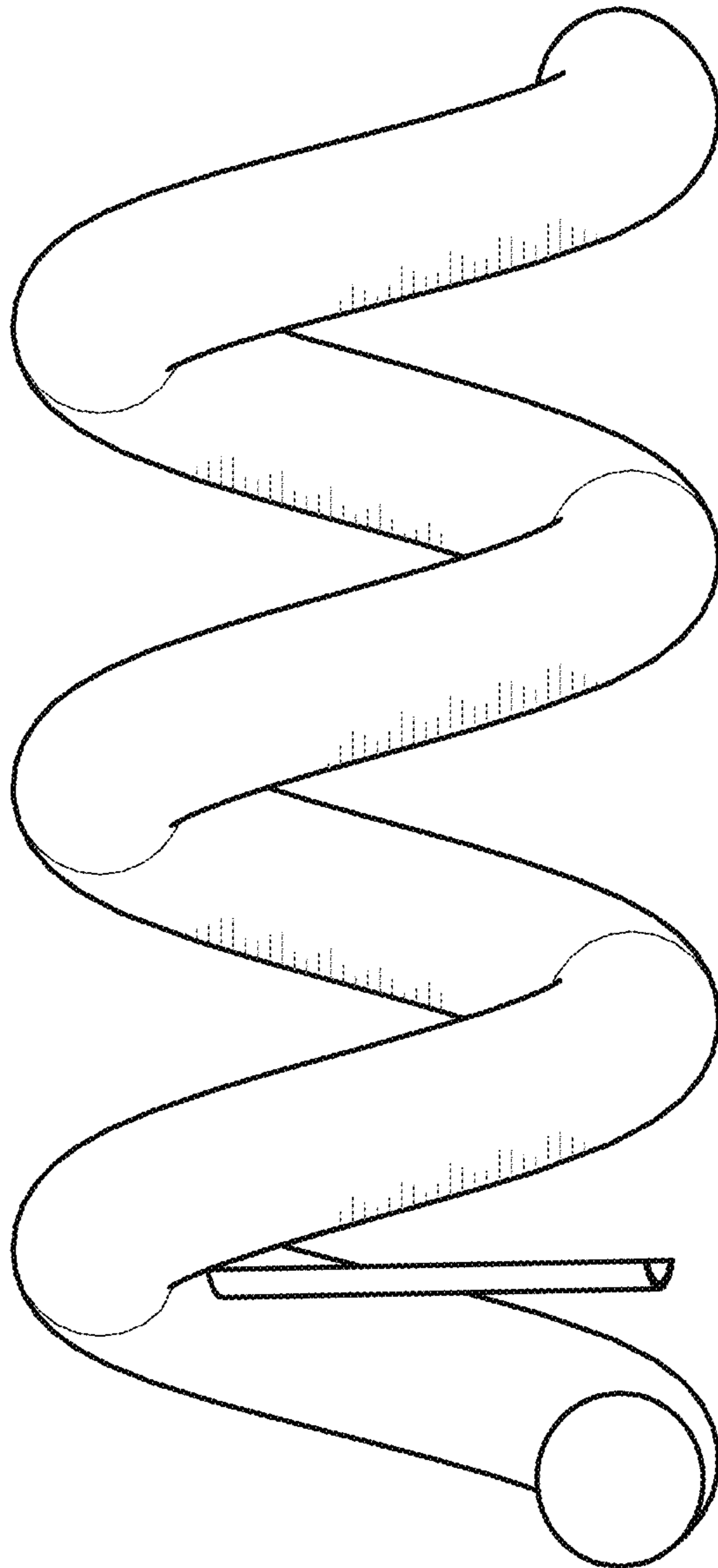

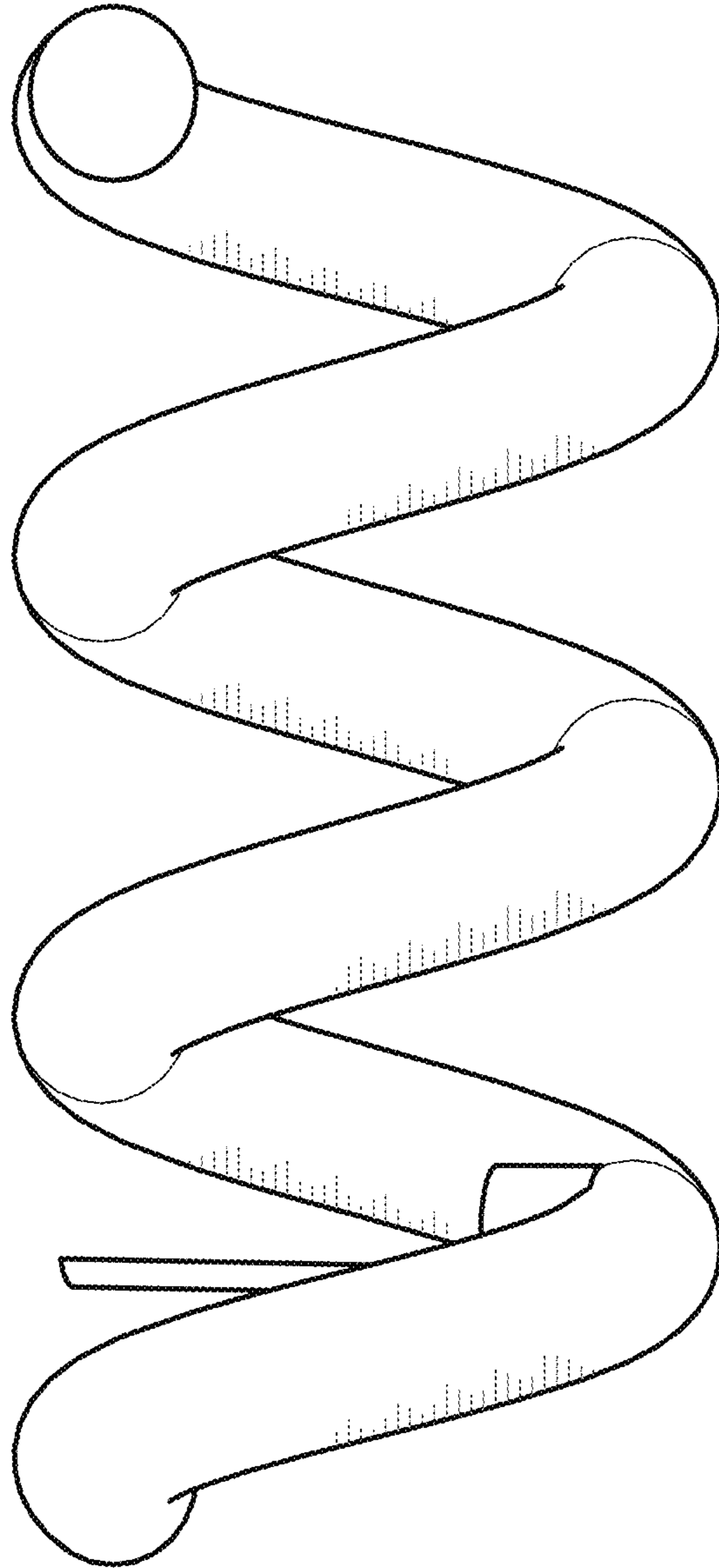

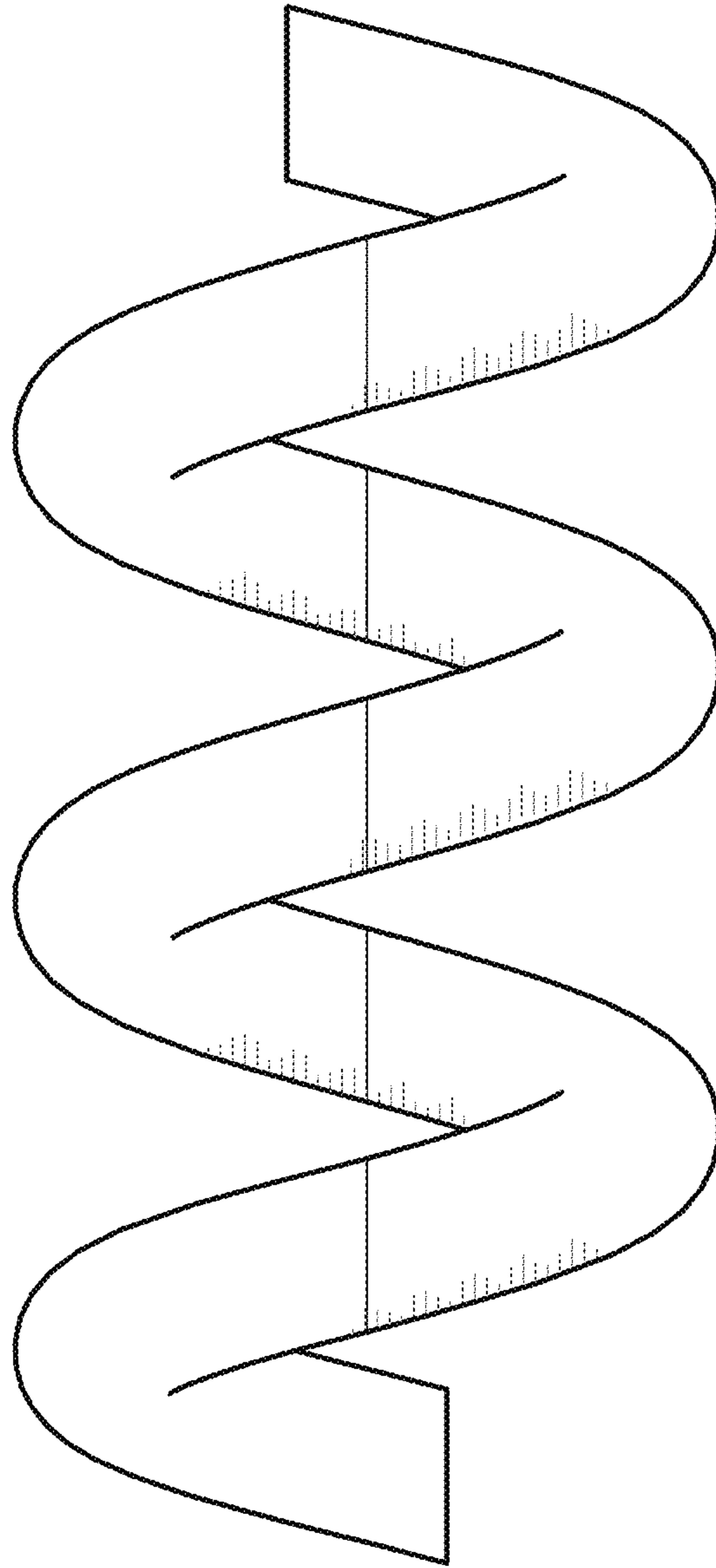
