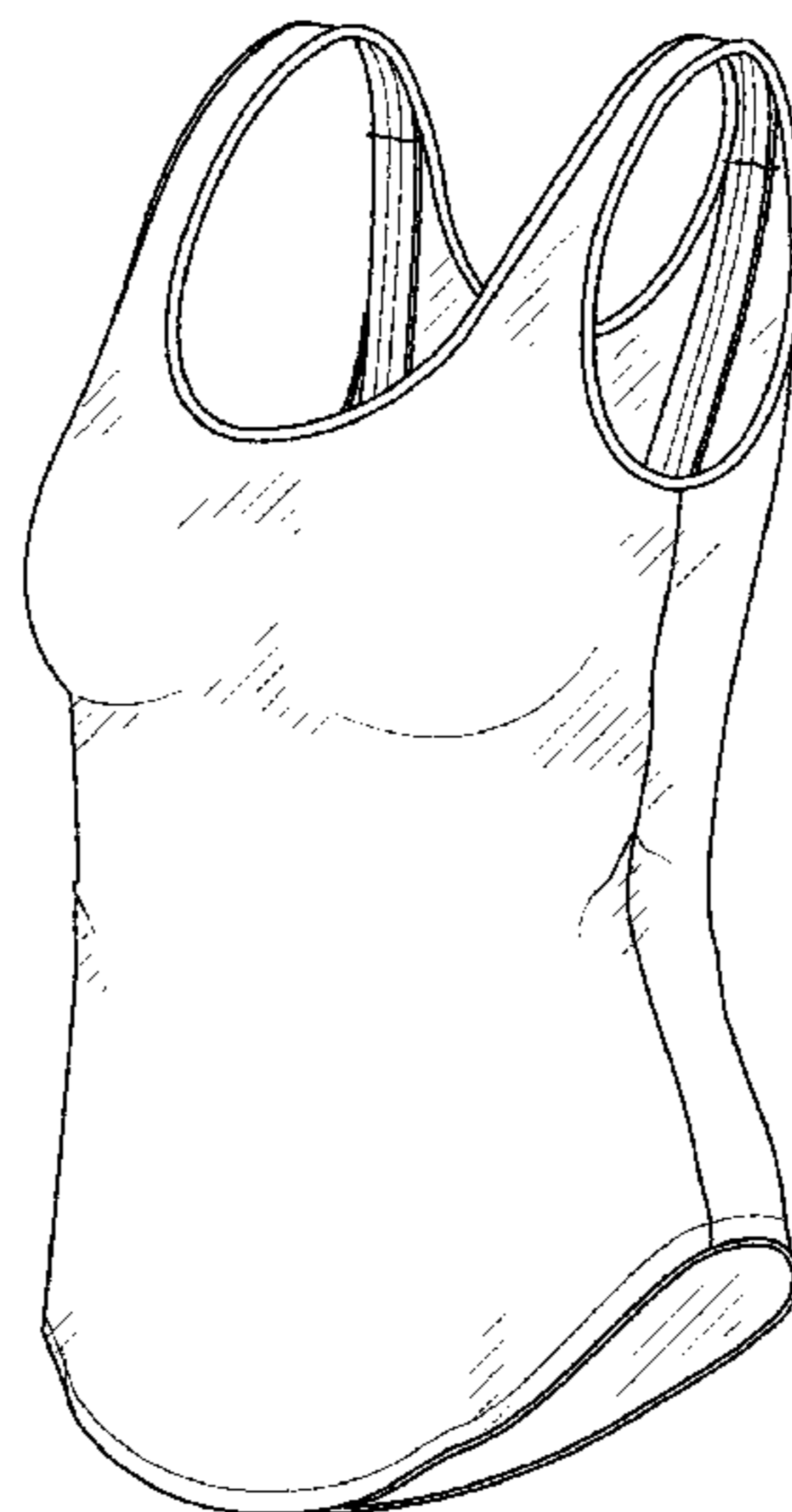
(57) **CLAIM**

We claim the ornamental design for a women's tank top with built-in breast support, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the women's tank top with built-in breast support according to an embodiment of the invention;  
FIG. 2 is a front view of the women's tank top with built-in breast support as shown in FIG. 1;  
FIG. 3 is a back view of the women's tank top with built-in breast support as shown in FIG. 1;  
FIG. 4 is a right side view of the women's tank top with built-in breast support as shown in FIG. 1;  
FIG. 5 is a left side view of the women's tank top with built-in breast support as shown in FIG. 1; FIG. 6 is a top view of the women's tank top with built-in breast support as shown in FIG. 1;  
FIG. 7 is a top inside-out view of the women's tank top with built-in breast support as shown in FIG. 1;  
FIG. 8 is a perspective inside-out view of the women's tank top with built-in breast support as shown in FIG. 1;  
FIG. 9 is a front inside-out view of the women's tank top with built-in breast support as shown in FIG. 1;  
FIG. 10 is a back inside-out view of the women's tank top with built-in breast support as shown in FIG. 1; and,  
FIG. 11 is a perspective view of woman wearing the women's tank top with built-in breast support as shown in FIG. 1. The dashed lines depicting the woman are not included as part of the inventive design.

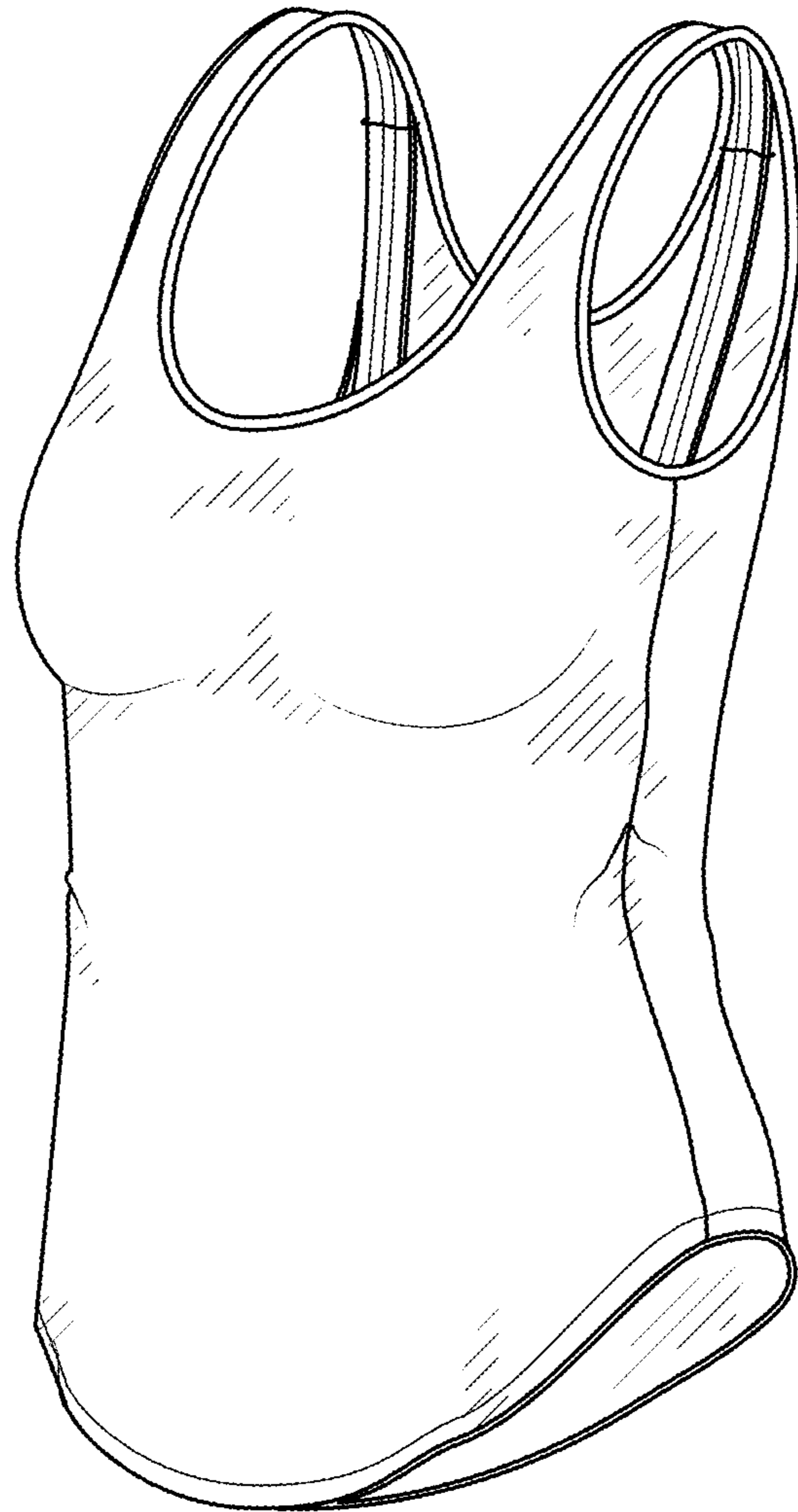

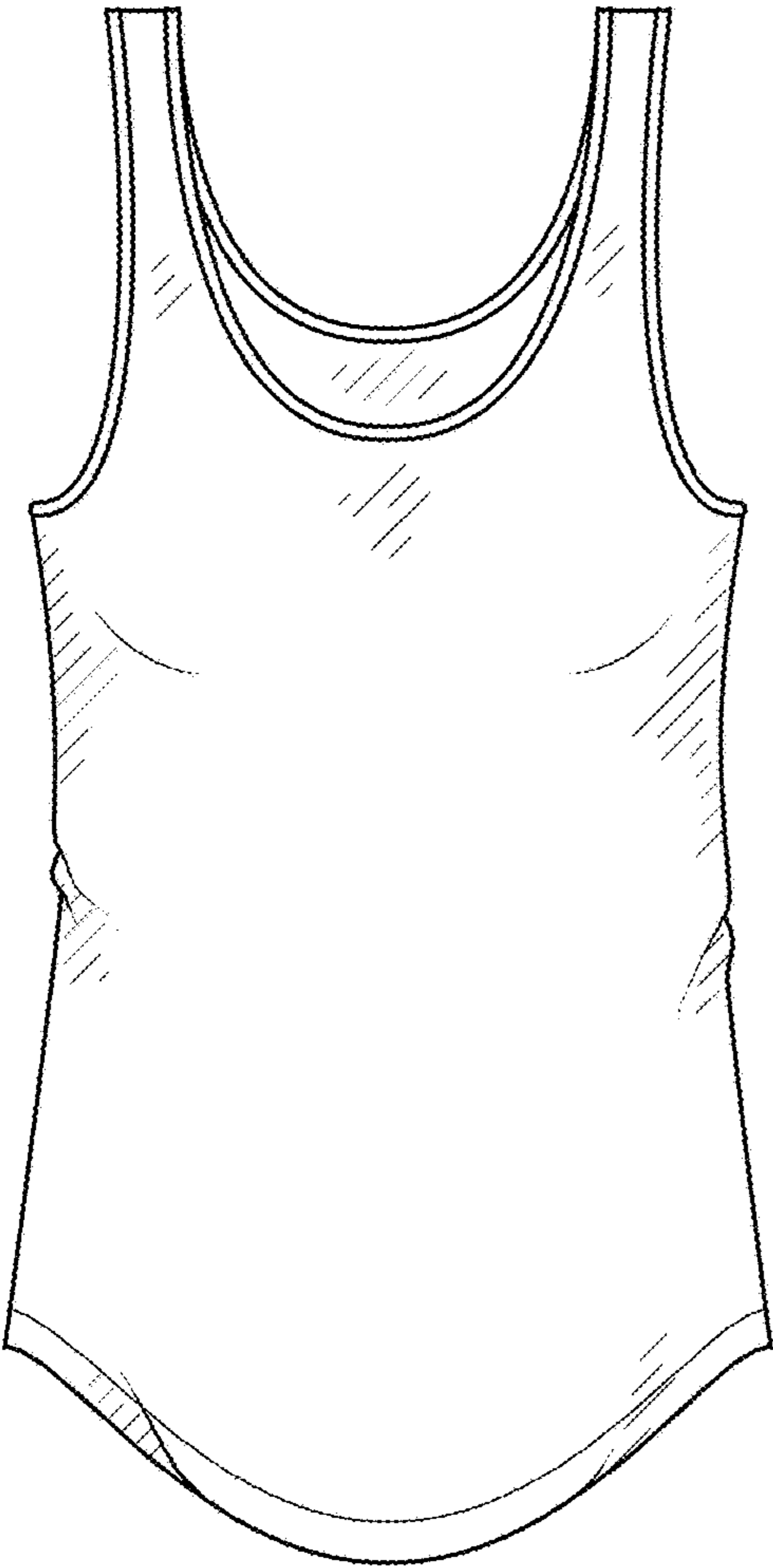

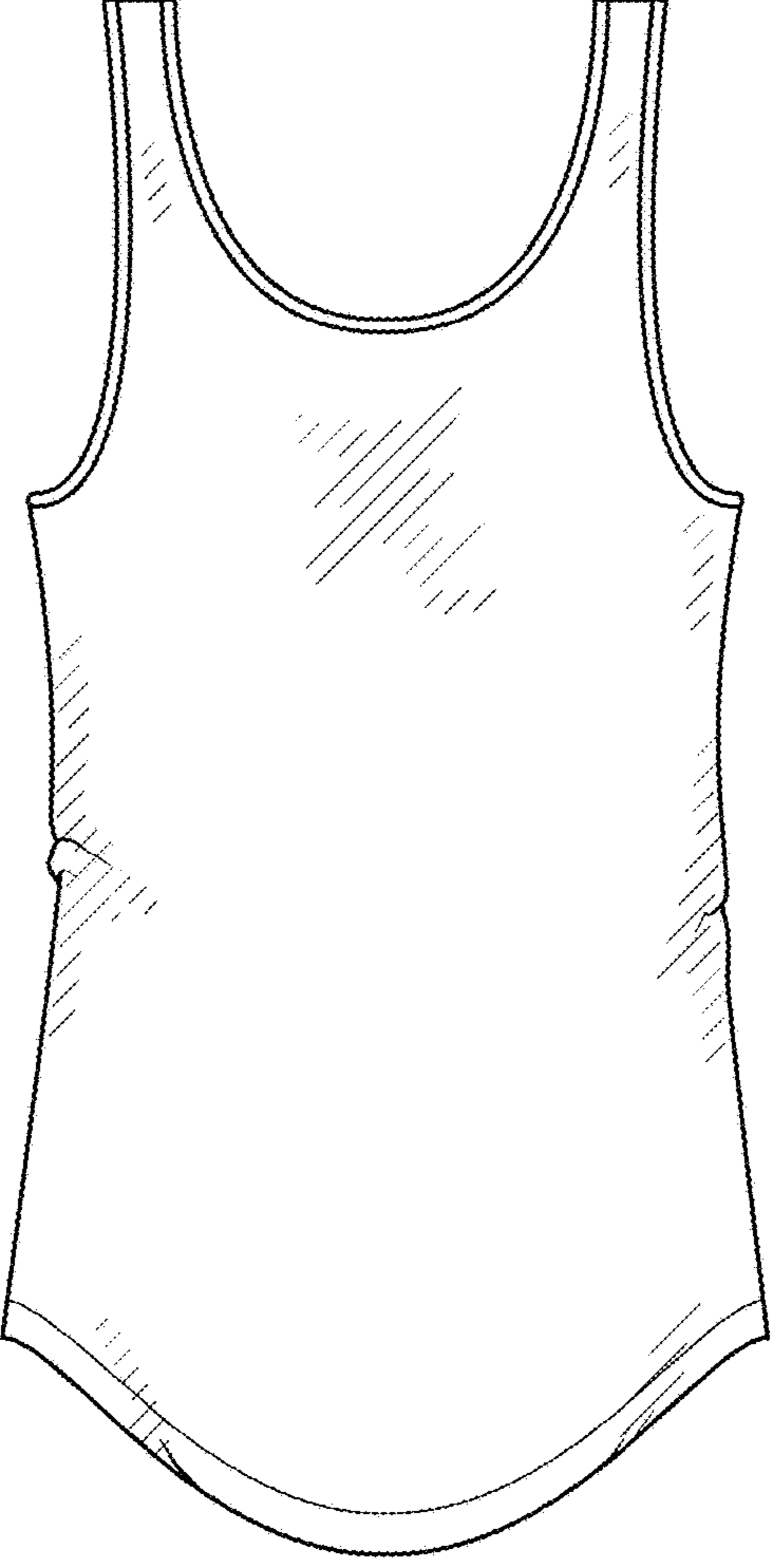

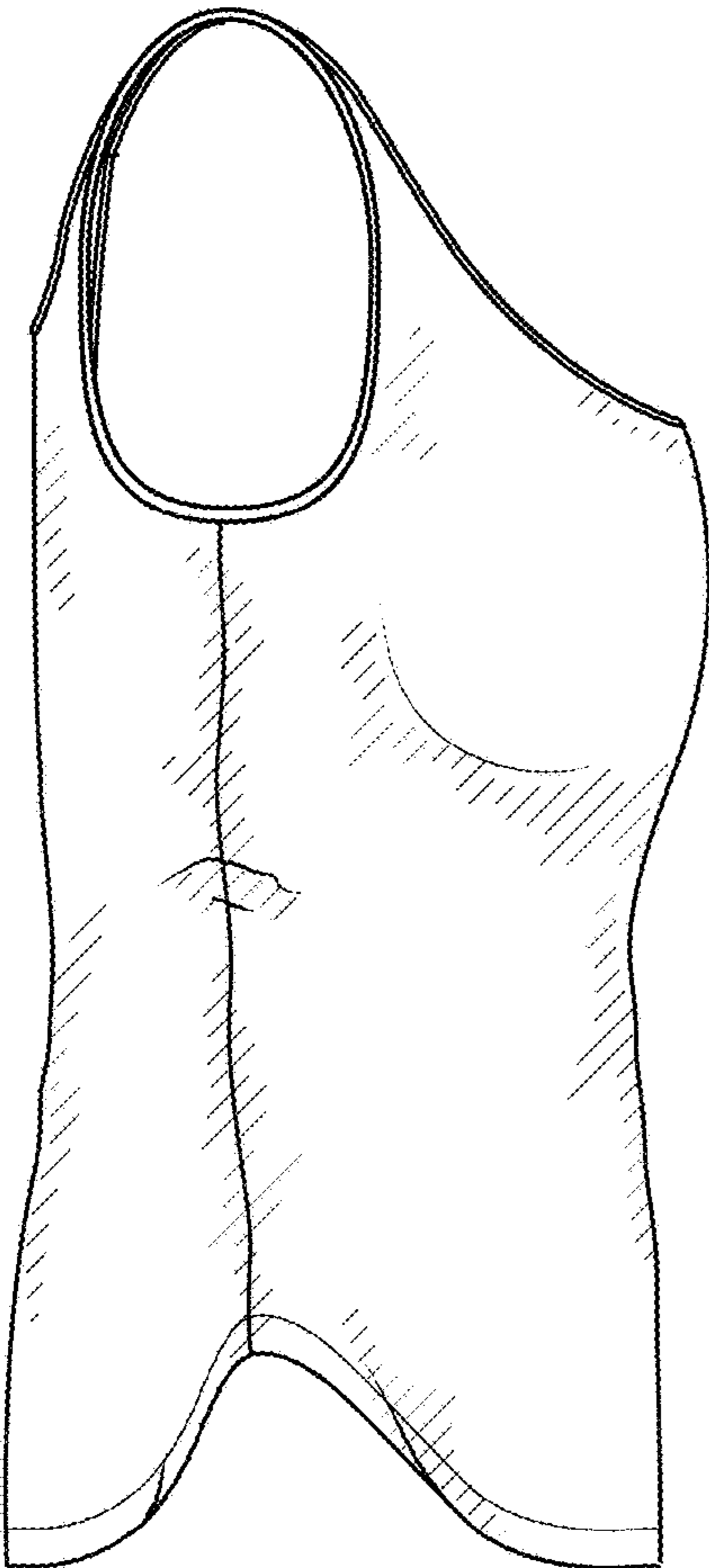

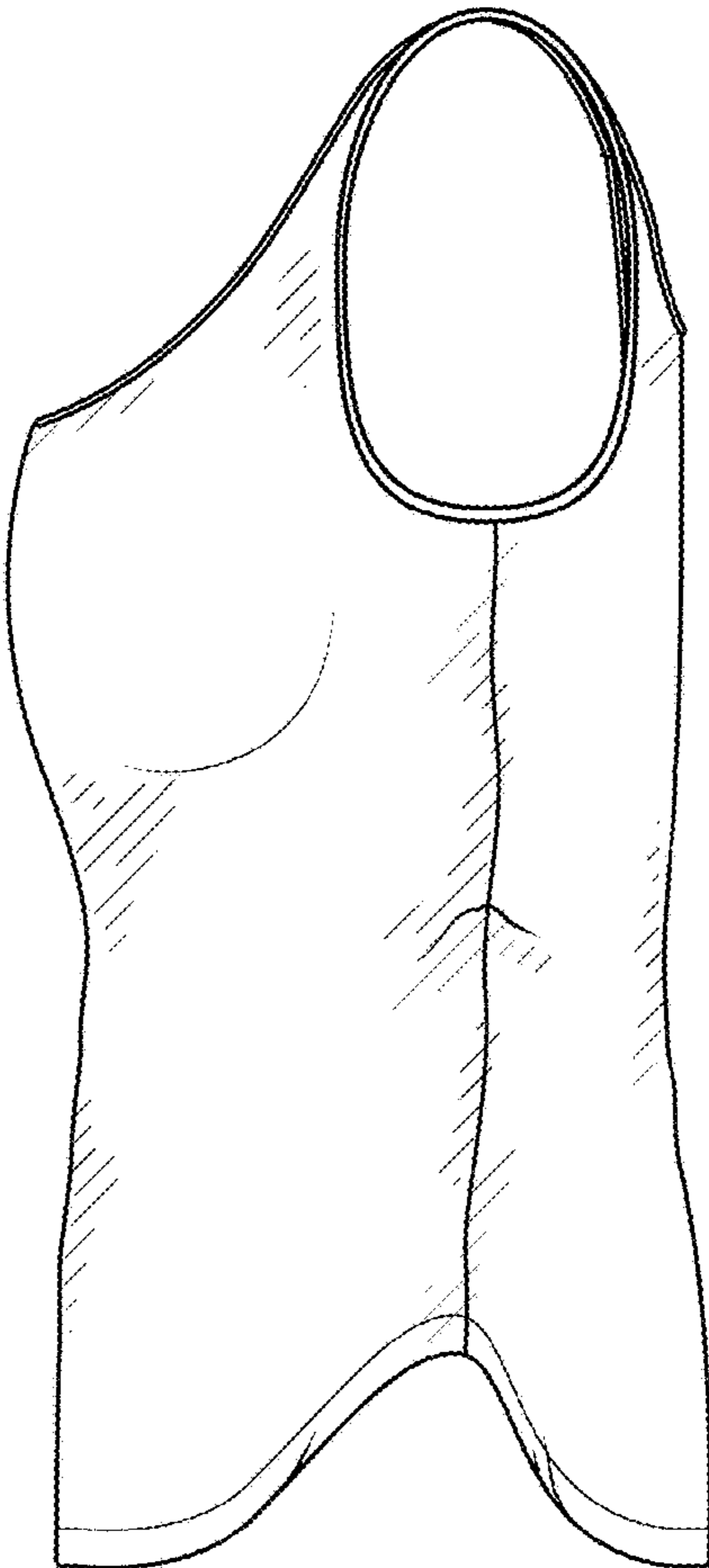

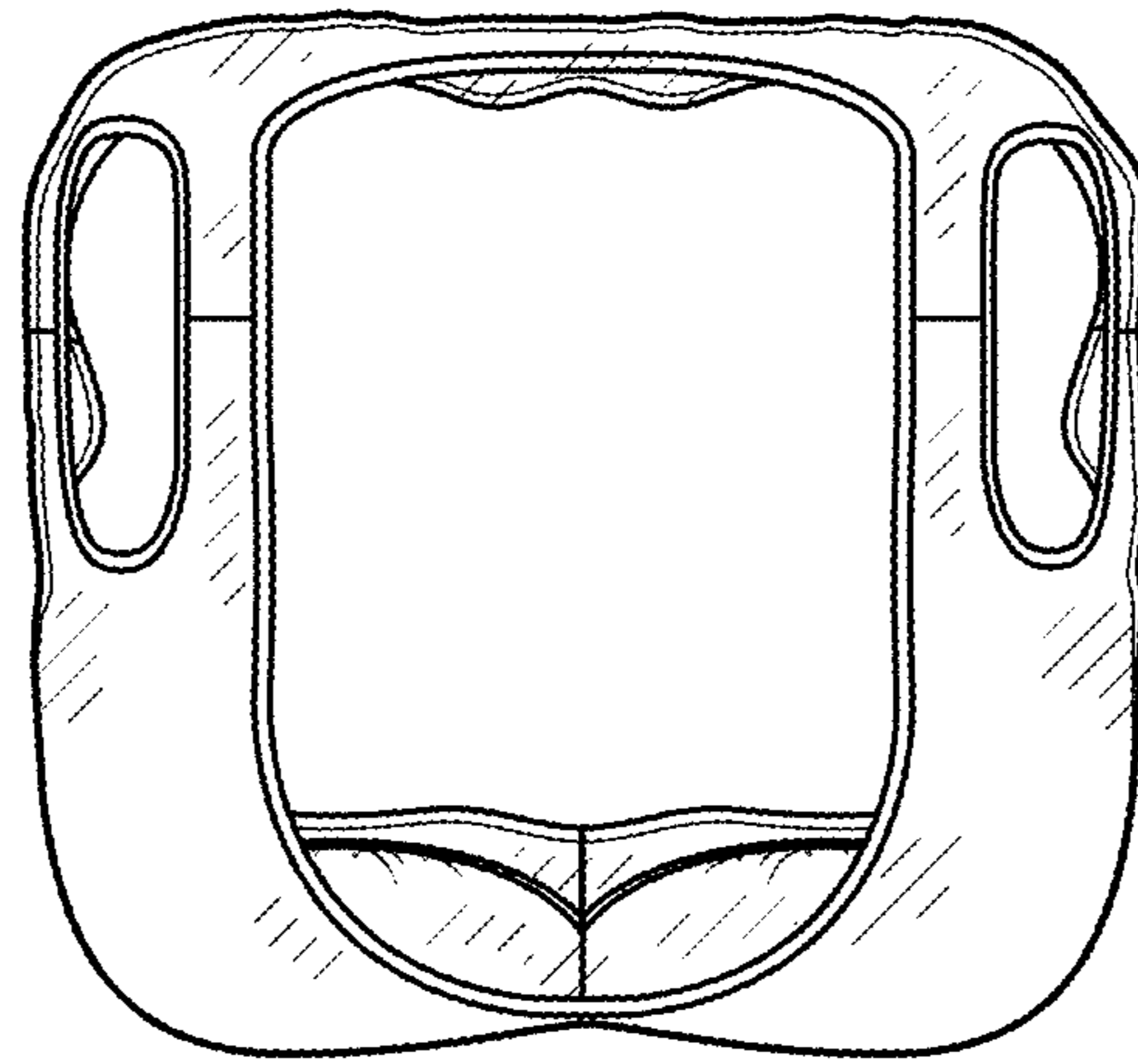

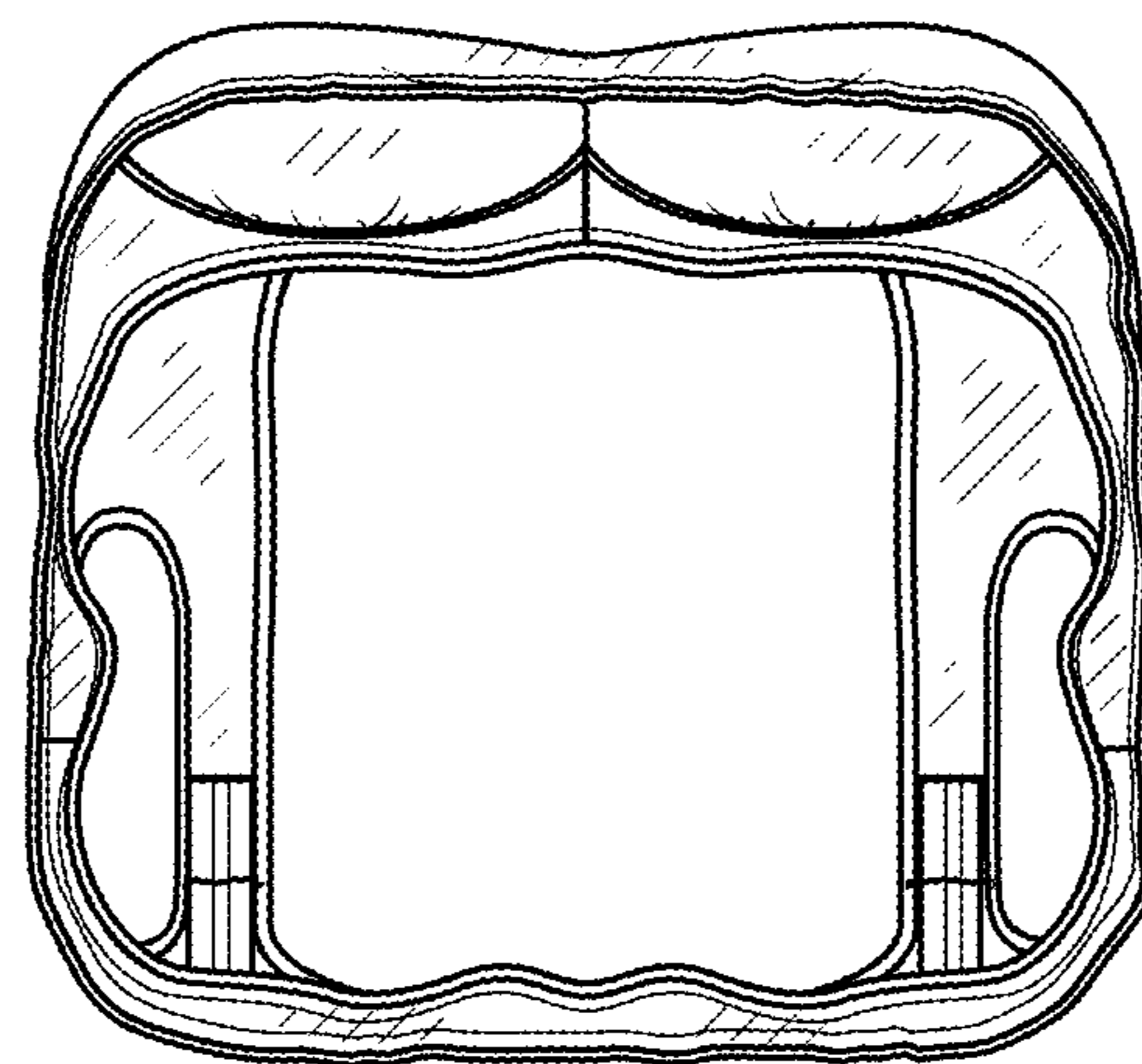

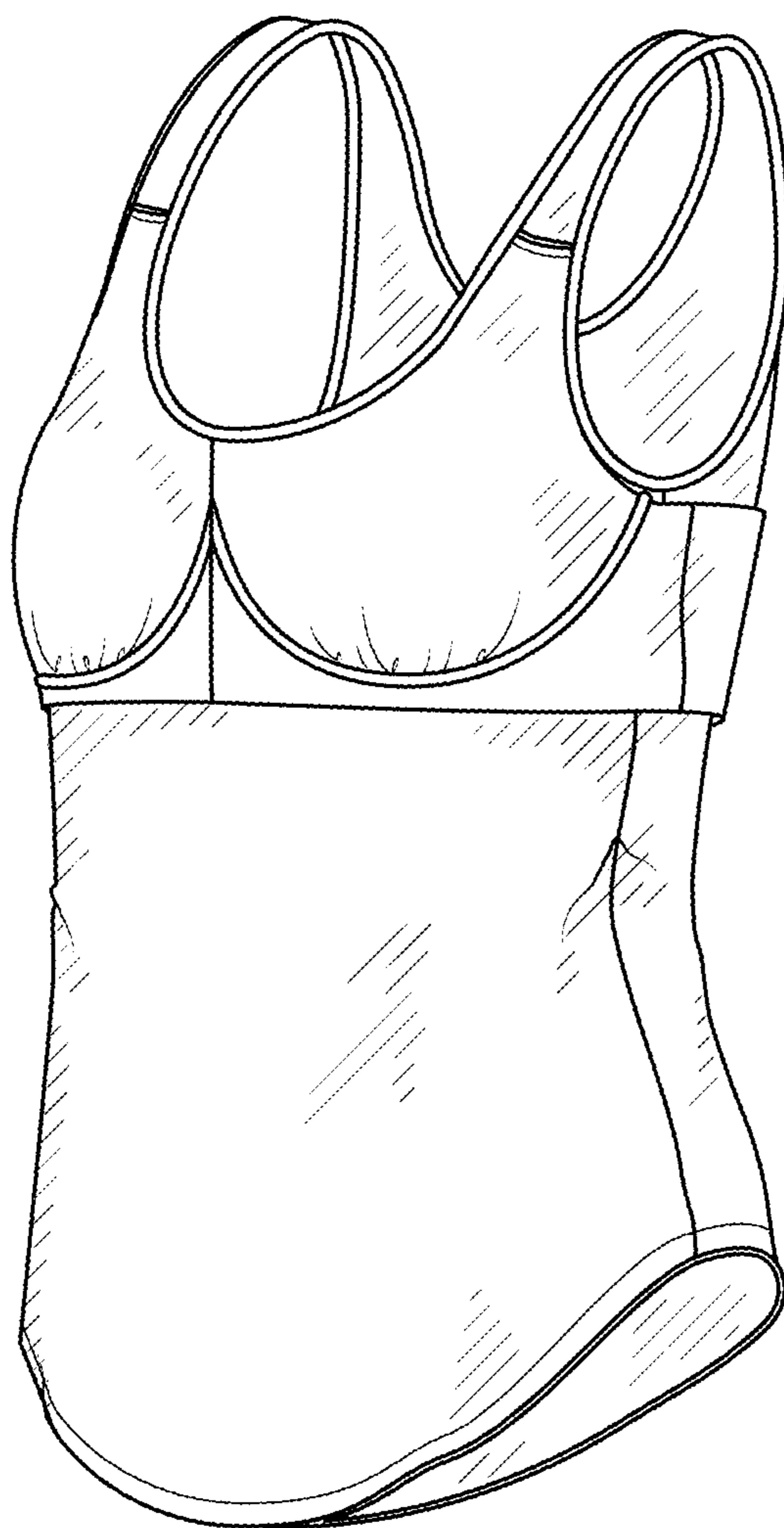

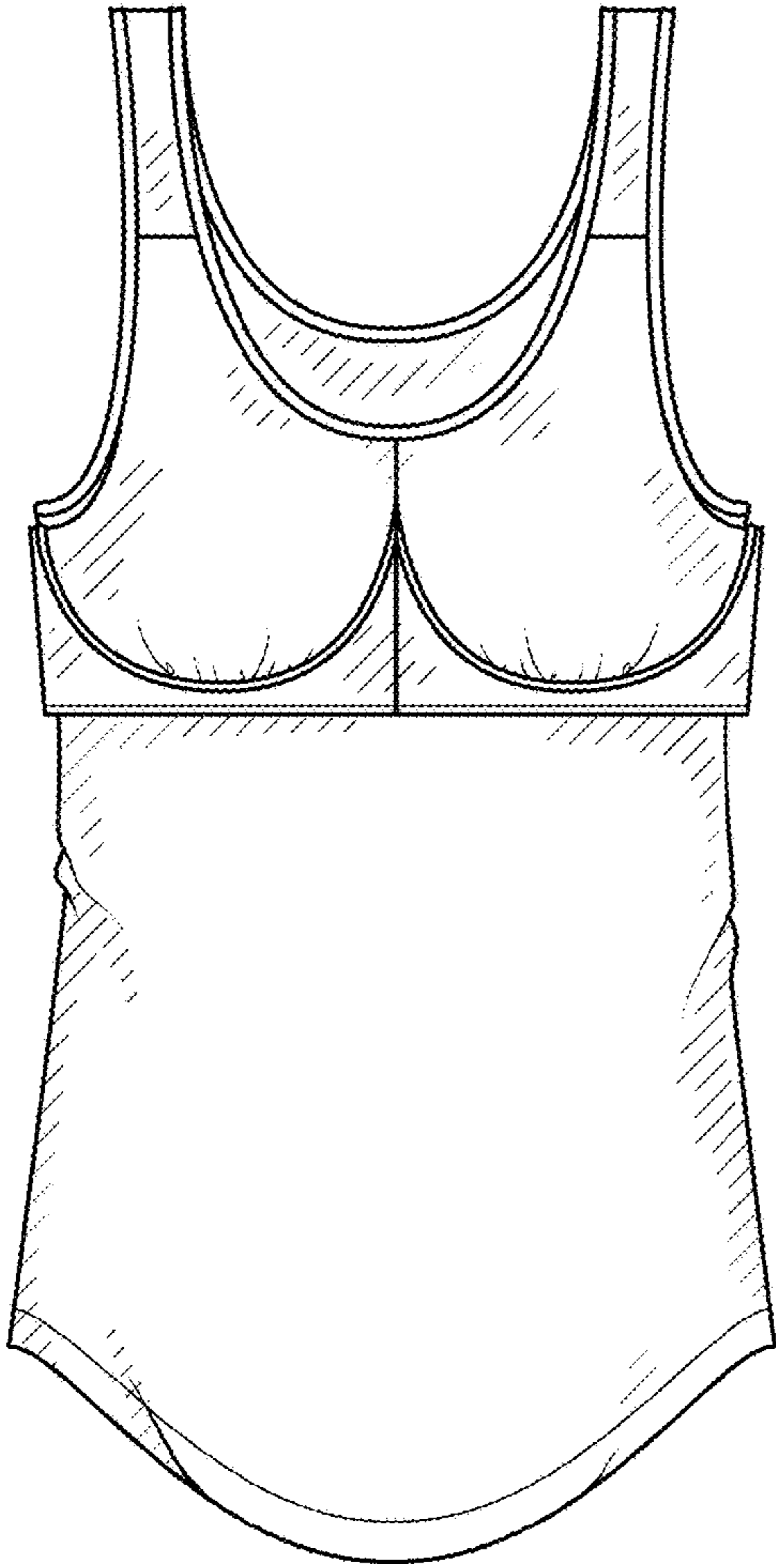

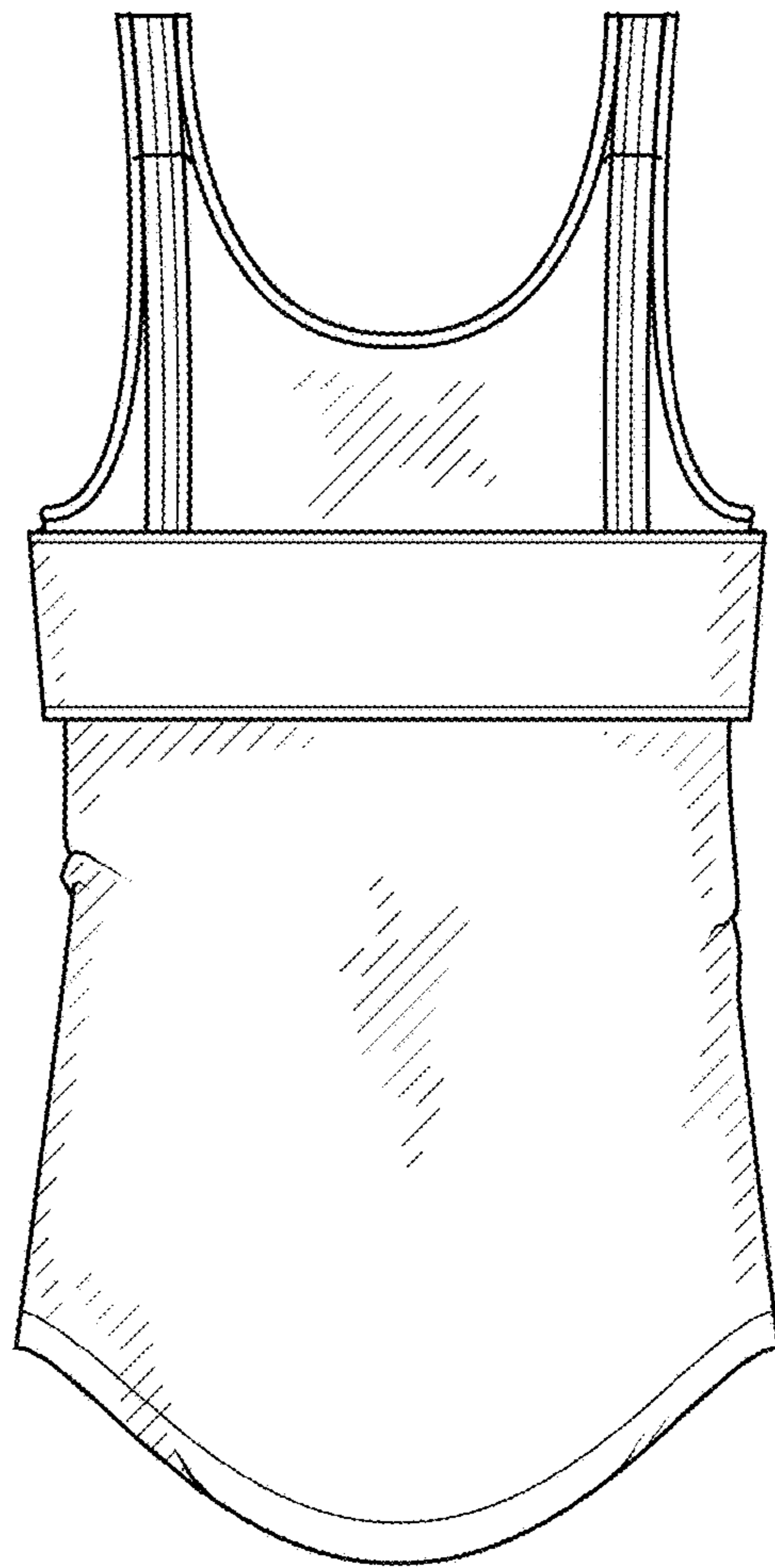

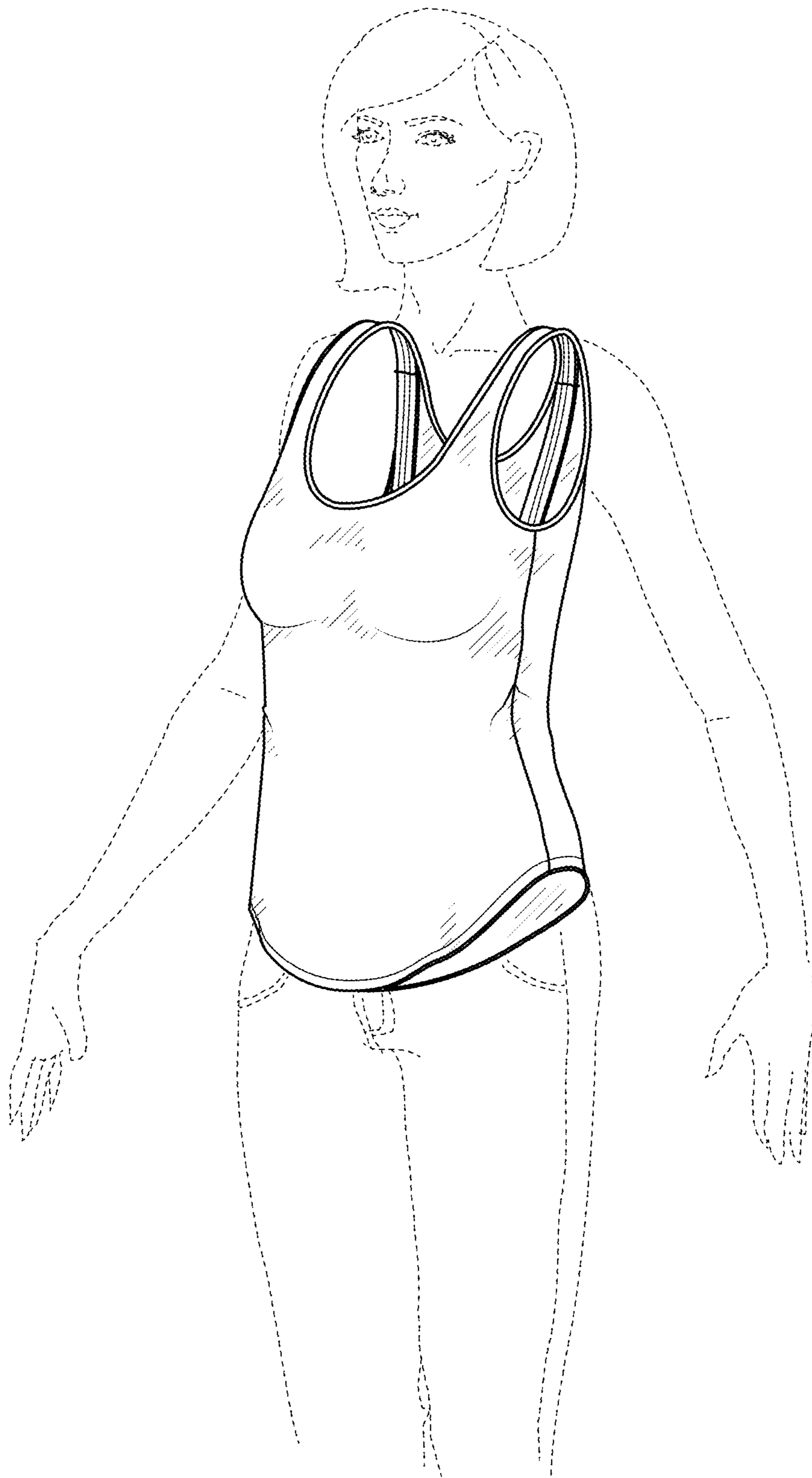
